## **Recommendation**

3. Under no condition that foreigner should refuse to NEC questionnaires.

4. More publicity must be made prior to the next census.
5. Government official must be used during the next census in order to move faster.
6. Anyone refusing to answer the questions must be taking to jail or the Business should be closed down.
7. T-shirt should be provided for NEC workers.
