2002 OWS SUMMARY OF REVISIONS

A. Questionnaire Design / Contents:

- 1. Reduction in paper size, increase in number of pages from 8 to 16
- 2. Part A: General Information
 - a) Splitting of Time-Rate Workers into Full-Time and Part-Time in consideration of NEDA comment;
 - b) Additional category for employment of Working Owners and Unpaid Workers as these are not employees like time-rate and output workers who are paid on basis of time or output;
 - c) Query on market orientation (engaged in export or not) will be limited to manufacturing establishments to focus on establishments engaged in merchandise exports. Establishments engaged in export of non-factor services – difficult to ascertain and confused the non-manufacturing respondents in 1999 round
- 3. In Part C, provision for 7 occupations increased to 10
- 4. Additional section (Part D) on key and representative occupations to validate existing occupational coverage and to provide basis for its expansion in subsequent rounds
- 5. Elaboration of Remarks in Part E to distinguish comments on data provided for the 2002 OWS, on results of the 1997 and 1999 OWS, on improvements on the design/contents of the questionnaire
- 6. Additional section (Part G) on industries with selected occupations to aid field enumerators on the provision of correct occupational sheet to the establishment during delivery of questionnaire.

B. Industries Covered:

The 2002 OWS will cover 58 industries for consistency with those covered in the Labor Cost Survey, another wage survey of the BLES. (Parts A and B)

Part C of the 2002 OWS will cover 43 non-agricultural industries from only 41 industries in 1999 and 1997 due to uniqueness of industries and occupations particularly those in production works.

- Splitting of Manufacture of Rubber and Plastic Products (D 25) into Manufacture of Rubber Products (D251) and Manufacture of Plastic Products (D252);
- Inclusion of other Land Transport (I60 except I6011)

Following is a presentation of inclusion and exclusions from the 2-digit numeric PSIC of some industries. This is for purposes of documentation that was not done in 1997 and 1999 rounds.
