- The employment cut-off was lowered to 16, which is 80% of 20 persons to consider employment outside survey coverage that may only be temporary, i.e. during reference period only.
- For purposes of generating survey estimates and CVs of establishments with union and with CBA, union membership and CBA coverage, the following were done for highlighted cells:
 - D201 and D202: merged into one industry group (D20) because of non-response in size 200 and over and only one respondent in size 100-199 for D202. The resulting cell BUFs were used to estimate for the merged industry.
 - D37 and D39: merged into one industry group (D37/D39) because of zero population/eligible/respondent in size 100-199 and only one (1) population/eligible/respondent-100% retrieval in size 200 and over for D37. The resulting cell BUFs were used to estimate data for the merged industry.
 - K7412 and K7421 : merged into one (1) industry group (K7412/K7421) because of only one (1) respondent in size 100-199 for K7412. The resulting cell BUFs were used to estimate data for the merged industry.
 - K74996 and K74997 : merged into one (1) industry group (K74996/K74997) because of zero population/eligible/respondent in size 100-199 and one (1) respondent for 200 and over for K74997.
 - O92112 and O92 excluding O92112 : merged into one industry group (O92) because of one (1) respondent in size 100-199 for O92112.
- BUF of CET establishment is one (1).

Thus, the 65 industry domains of the survey were reduced to 61.

Table A (Final) reflects the data for collapsed industries. Data in this table are aggregates of the original data of the collapsed industries in Table A (Preliminary) except in some instances for data on estimated population where discrepancy is due to rounding errors.
