Definition of Terms

Anchorage	An area within a harbor with sufficient depth of water for ships to maneuver and anchor.
Area of Occupancy	Refers to the area occupied by the vessel, either berth or anchorage.
Berth	The place assigned to a vessel in a port when lying alongside a pier, quay or wharf where it can load or discharge cargoes.
Freight	Refers to charges on cargoes paid for the transportation of goods from one port / station to another.
Pier / Zone	Refers to the particular zone / pier number where the vessel is assigned to berth / anchor in its port of origin.
Port Management Unit	Refers to the administrative and operational arm in every port district in the Philippines of the Philippine Ports Authority (PPA).
Port / Station of Destination	Refers to the port / station where the cargoes / passengers are destined.
Port / Station of Origin	Refers to the port / station where the cargoes / passengers came from.
Type of Handling	Denotes whether the commodity handled is a dry bulk, liquid bulk, break bulk or containerized.
Value	Represents the peso equivalent of a particular commodity.
Weight	Represents the total volume of a commodity expressed in kilograms.
