Guideline for filling in Daily Consumption Expenditure

1. Please fill in, daily
 - (i) All cash Expenditure incurred by every member of this household on food and non- food items.
 - (ii) All cash expenditure on services purchased by every member of this household such as taxi or bus fare, medical fees, vehicle repairs etc.
 - (iii) Own produce collected from this household's garden or field for consumption.
 - (iv) Payment in kind received by this household.
 - (v) Gifts given away and gifts received by this household.
2.
 - (i) The column for date will be the date the purchase or the transaction is carried out.
 - (ii) Write down the description of the item purchased or given away, received as a gift, own produce, payment in kind received in column 2 headed "Description of item" of the form. Each item however small in value must be written on a separate line. Please avoid the use of general descriptions such as groceries, meat, vegetables, fruits. Write each item as:

Mutton/Fresh/Frozen
Cabbage, Spinach, Lettuce etc.
Apples, Oranges etc.
 - (iii) In column 3 enter quantity corresponding to the unit of measurement recorded in column 4. Please enter quantities in standard units as far as possible. For example, if a tin contains 340 ml which is generally written on the tin itself enter tin (340ml).
 - (iv) In column 4 headed "Unit" write down the unit of measurement of quantity e.g. Liter, Kilogram, Bundle, Part, etc.
 - (v) In column 5 headed "Value" write the value of every item. Value is the amount of money you have paid for each item purchased including Sales Tax. For credit purchases full value of the items should be recorded even though the payment has not been paid in full. Mark such items with the

word “Credit”. In the case of payment in kind received, gifts given away or received write the quantity if value is not known.

- (vi) In columns 6 & 7 enter the codes as explained below at the top the column for Transactions and Purposes.

Transactions

- 1 = bought
- 2 = own produced
- 3 = from own business
- 4 = income
- 5 = gift/transfer received
- 6 = gift/transfer given

Purposes

- 1 = Private
- 2 = Farming
- 3 = Business

An Example

Mr. Jones is the head of the household. He stays with his family in Maseru Central.

On November 1st 2001 Mr. Jones went to Koro-Koro where he bought one sheep for M380.00; 6 cobs of green mealies for M12.00.

On the same day Mrs. Jones purchased 5 bags of 1 kilogram of Tastic Rice for M36.50; Cooking Oil (750ml Bottle) for M8.60; 2 dozen eggs for M16.00; one packet of candles for M4.00 from one supermarket in the city.

The same day Mrs. Jones’s daughter collected one head of pumpkin whose market value was M6.00 and a bundle of carrots whose market price was M3.49 from their garden. She also received one pair of shoes as a gift from her friend and the market price of those shoes was M139.99.
