A Royal decree bearing law No. 67-370 enacted on August 5, 1968 (corresponding to the 10th of Jumada I 1388 of the Hegira) related to statistical surveys

Article 8: Personal data provided in the survey forms containing personal and family information, and professional activities in general shall not be disclosed by the department that received the forms.

Any person who took part in any way in the statistical survey shall be bound to keep the professional secret; otherwise he shall be liable to punishment as stipulated in article 446 of the Criminal Law.

Article 9: Respondents should reply to the statistical questions clearly in the fixed deadlines. Whoever refuses to abide thereby, or purposely gives inexact answers shall be liable to punishment in accordance with the law in effect.
