

Description of Estonian “Household income and expenditure survey” files years 1996-1998

Files are **DBF** files. Databases are separated quarterly. Fields marked with “*” are calculated in data processing, these are not initial data fields and they may be not filled. Household questionnaire was a bit changed in the II quarter 1996. From the year 1997 we use new classification of education and there is a new field in diaries to get information about payments not in cash (with credit card and so on). More precise information is in data description.

You can find income codes in the document **codes98.doc**. Expenditure codes for the years 1996-1997 are in the files (**food9697.doc**, **tax9697.doc**, **cons9697.doc**) and for the data 1998 **code98.doc**. Guideline for the interviewer is in the document **guidelin.doc**. Description of methodology for the years 1996-1998 is in the document **method.doc**. The sample for the first quarter 1996 is a bit different. Then we made sample from all persons, who we in register, but from second quarter 1996 the sample is taken from persons who are 16 or over.

Initial data of housing expenditure can have information in different levels (for example: we have information about all housing expenditure of household and about expenditure to hot water). We use special calculations to find real housing expenditure of household. We can find housing expenditure of household, but in lower levels (hot water, gas, rent) information is underreported.
