 - Door fittings (hinges, handles and locks), fittings for radiators and fireplaces, other metal articles for the house (curtain rails, carpet rods, hooks, etc.) or for the garden (chains, grids, stakes and hoop segments for fencing and bordering),

- 562 Small electric accessories such as power sockets, switches, wiring flex, electric bulbs, fluorescent lighting tubes, torches, flashlights, hand-lamps, electric batteries for general use, bells and alarms. Includes the repair of such articles and charges for the leasing or rental of do-it-yourself machinery and equipment.

- 570 Cleaning washing powder and soaps, shampoos, desiccants, insecticides, distilled water, fungicides

- 571 Other articles for cleaning such as brooms, scrubbing brushes, dustpans and dust brushes, dusters, tea towels, floor cloths, household sponges, scourers, steel wool and chamois leathers and shoe cleaning material. Paper products such as filters, tablecloths and table napkins, kitchen paper, vacuum cleaner bags and cardboard tableware, including aluminum foil and plastic bin liners.

Out-patient services

- 591 This group covers medical, dental and paramedical services delivered to out-patients by medical, dental and paramedical practitioners and auxiliaries. The services may be delivered at home, in individual or group consulting facilities, dispensaries or the out-patient clinics of hospitals and the like, (consulting, analysis laboratories, X-ray centers, first aid, services of the nurses and midwives, physiotherapy, gymnastic, other bath services, dental and denture services, etc).

Repair of such articles

- 985 Retirement homes for elderly persons, residences and schools for disabled persons, rehabilitation centers providing long-term support for patients rather than health care and rehabilitative therapy. Help to maintain elderly and disabled persons at home (home-cleaning services, meal programmes, day-care centers, day-care services and holiday-care services. Wet-nurses, crèches, play schools and other child-minding facilities. Counseling, guidance, arbitration, fostering and adoption services for families.
