 - **Having less than 10 persons engaged**


- Nepali Fiscal Year 2065/66

Listing Operation

- Listing of Small Manufacturing Establishments was conducted throughout the country in the fiscal year 2065/66
- Altogether 32326 small establishments were found under operation during that period

Sample Design

- Design Comprises both complete enumeration and sampling.
- 152 establishments of which frequency under any NSIC at 4 digit level being less than 3 in an ecological development region were selected for complete enumeration
- 3585 stratified samples were selected randomly from remaining 32174 establishments

The Survey was conducted in Establishment Approach. Income and Expenditure of a Establishment was recorded in Sales-Purchase Approach.



 - ❖ rural 62% and urban 38%
- ❖ **Estimated no. of Persons Engaged-122200**
 - ❖ Rural 57% and urban 43%
 - ❖ Paid 55%, Unpaid 45%
 - ❖ Working Proprietors 29 %; Family Members 16%; Paid workers 55%
- ❖ **Share of females in total workers- 18%**
 - ❖ (Working Proprietors 4%, Family Members 7%, Paid Workers 7%)
- ❖ **Estimated no. of Paid Employees – 67376**


- ❑ **Value of Output (in Rs Crore) – 4149**
- ❑ **Value of Input (in Rs Crore) – 3003**
- ❑ **Value Added (in Rs Crore) - 1146**


Percentage Distribution of Number of Establishments by Development Region




Percentage Distribution of Number of Establishments by Development Region in SSME 2057 and SSME 2066





Percentage of Number of Persons Engaged in Small manufacturing Sector in 2066




Percentage Distribution of Paid Employees




Monthly Salary of Paid Employees



Monthly Salary of Paid Employees by Development Regions




Percentage Share of Number of Industries and Value Added by Size of Persons Engaged






Number of Paid Employees per Establishment by size of Persons Engaged



Value Added per Establishment by size of Persons Engaged




Composition of Fuel by Fuel Types in SSME 2057 and SSME 2066





Share of Cost of Fuel Purchased in Value of Input by Development Region







Distribution of Fixed Assets at National Level




Percentage of Total Value of Fixed Assets at the End of The Reference Period






Per Establishment value of fixed assets owned by Small Establishments




Distribution of Per Establishment Fixed Assets (Rs. 707 thousand)




Output-Input Ratios by Geographical Areas in SSME 2066




Value Added Per Establishment by Geographical Areas in SSME 2066




Value Added Per Employees by Geographical Areas in SSME 2066




Number of Establishments by Utilization of Production Capacity




Value Added Per Establishment by Utilization of Production Capacity




Value of Fixed Assets Per Establishment by Utilization of Production Capacity




Paid Employees Per Establishment by Utilization of Production Capacity




Percentage of Small Manufacturing Establishments Which have Invested on Environment Protection




Expenditure of Small Manufacturing Sector on Environment Protection



Problems Faced by Small Manufacturing Sector (Problems of First Priority)




Paid Employees Per Establishment by Problems Faced




Value Added Per Establishment by Problems Faced
