1.0 **Introduction:**

NBS/CBN annual Economy Survey on socio-economic activities in Nigeria had become a regular survey of NBS. The 2007 round is still another series of such collaborative surveys being conducted jointly by NBS, CBN, and NCC every year. It is basically designed to provide some socio-economic indicators needed in the quarterly and annual reports of CBN on socio-economic activities of the country, evaluation of economic performance for the outgoing year and projection of economic thrust on the current year ahead.

This workshop which started on the 15th of January through to 19th January 2008, was organized to review and finalize the survey instruments. From day one to the last day of the workshop participants worked with doggedness and resilient determination to accomplish the task set before them.

The opening speeches delivered by the Project Director, Dr G. O. Adewoye and the head of CBN (Mr. C. M. Okafor) representatives at the meeting spurred the participants into action. The workshop was well attended with time table strictly adhered to. Consequently, every participant at the workshop exhibited tactical discipline and commitment to complete the set targets on schedule.

All technical issues or matters raised during the 5-day workshop, were carefully debated, discussed and all options cross-examined and exhaustive while decisions taken with the consent of all the participants at the workshop.

1.1 **Objective of Review Workshop:**

The workshop was one of the series of workshop arranged to prepare survey instruments in readiness for 2007 survey. The following objectives were set for this workshop, namely:

- (i) To review the survey instrument again and correct all observed defects
- (ii) Review the adequacy of the survey methodology
- (iii) Fill necessary gaps that may exist in the proposed survey modules
- (iv) Ensure completeness of individual questionnaire
- (v) Finalization of questionnaire for final printing

2.0 **Slide Presentation on the experiences of last year survey:**

To share experiences from the last year NBS/CBN/NCC collaborative survey 2006, papers presented on different components of the survey focused basically on identified problems encountered last year and the way forward for the current year.

Opportunities were however, given for comments and intervention from the floor at the end of each paper presented. The list of papers presented during the 5- day workshop centered on:

- i. GHS, data
- ii. Agriculture data
- iii. Establishment data
- iv. SAS
- v. Prices and Trade data
- vi. National account data
- vii. Modern holding data
- viii. Field Services
- ix. ICT
- x. Methodology

These papers were presented by Divisional heads involved in the 2006 NBS/CBN/NCC Collaborative Survey. The excerpts of each paper presented were as follows:

2.1 **GHS Survey: Identified Problems**

- Error in the Questionnaire
- Error from the Field
- Methodological Problems
 - Logistics for Data Collection
 - Method of Processing

Error in GHS Questionnaire

- Incorrect skip instructions
- Incomprehensive Response Options
- Absence of code for tracking efficiency of field/data processing personnel

Error from the Field

- Omission of RIC/EA Code
- Wrong Coding of RIC
- Interchanging RIC with EA Code
- Lots of item non-response (e.g.)
 - Monthly Household Income/Expenditure
 - Daily Income of ICT Operators
 - Income/Profit of Enterprises
 - Weight of child at Birth
 - Average Number of ICT Customer
 - Hours of work per week
 - Occupational/Industry Codes

Major Causes of Problems

- Inadequate time to review the questionnaires before going to press;
- Control mechanism during computer data capturing;
- Verification & validation of data at a place order than where the questionnaires are available.

Solution to Identified Problems

- Errors found in the questionnaire had been compiled and forwarded to ICT Department of NBS for correction;
- Field and data processing personnel should be allocated codes for proper tracking of errors and appropriate sanction;
- Time and timing of the survey programmes should be reviewed.

2.2 Agriculture Survey:

Identified Problems:

- n There are three major problems
 - the one emanating from the inadequacies of the instruments (Holding Questionnaires).
 - the one emanating from the field, this include omission, inconsistency, unreasonable entries and double entries.
 - the one emanating from scanning the questionnaires.
- n **Holding Questionnaire (Highlights)**
 - **Crop**
 - No provision for completion status (i.e Completed, Partly completed, Refusal, Not located or Moved away)
 - Breaking consumption into quarter was also a problem.
 - No provision for number, name, in local units and weight
 - Question which deals with post harvest losses, number, price per local units were not included.
 - Cassava product such as akpu, cassava flour etc were recorded as cassava.
- **Holding Questionnaire (Highlights)**
 - **Livestock/Poultry**
 - No provision for completion status (i.e completed, partly completed, refusal not located or moved away)
 - There is also no provision for name in local unit and weight of input.
 - Questions which deal with stock and changes in stock did not make provision for closing stock.
 - No provision for day-old-chick to be recorded in weight
 - Guinea pig was recorded as one of the species of pig which is incorrect.

Solution:

- n Front cover of the questionnaire should include completion status
- n Number, name in local units and weight should be included.
- n Similarly, number price per local unit should be included.
- n Cassava tuber should be clearly indicated in the questionnaire.
- n Day-old-chick should be recorded in number.
- n Provision for closing stock should be made.
- n Guinea pig should be removed as one of the specie of pigs in the questionnaire and replaced with the four species common to Africa which are Bakosi, Large White, Landrace and Duroc.

- n Computation of depreciation should be left for office use. However information such as cost of purchase of asset, year of purchase and life span of such asset be supplied.
- n Similarly, computation of capacity utilisation should be left for office use with provision made for information such as installed capacity of the asset and how much of such capacity is put to use.
- n Avoid scan able questionnaires.
- n Thorough training at state level.
- n Thorough supervision of field staff in the field.
- n Thorough supervision of data entry.
- n Giving sufficient time for data processing & analysis
- n Holding questionnaires to be separated into crop, livestock, poultry, fishing and forestry.

2.3 **Establishment:**

Identified Problems:

- i) Establishment frame not comprehensive.
- ii) Publicity not adequate on the NBS/CBN Collaborative Survey.
- iii) Questionnaires were badly printed. This year a sample of each questionnaire should be given to subject matter for approval before mass production.
- iv) Data collection was not closely monitored by CBN.
- v) Records of Questionnaire not properly checked and edited before leaving establishments.

Solution:

- Organised private Agencies should be trained by NBS how to fill scanable questionnaire through workshop and seminar.
- Establishment Questionnaires should be on analogue (this year 2008 survey).

2.4 **SAS :**

Identified Problems/Solution:

■ **Training:**

The need to organize good training at the zonal/state in terms of those to be trained – competency, interest in the job, and willingness to learn and take corrections.

Quality of data, and the human capacity building should be paramount in our minds during the TOT.

■ **State Officers, Supervisors and the Enumerators are important in the determination of the quality of data to be collected.**

We should beginning to weigh whether or not out sourcing of staff is good against the idea of having permanent staff.

Even if it is better option have the opinion of people on it.

Along this, our disengaged staff may be a better option.

- **Another problem is, the frames are not static which can lead to wrong application of questionnaires.**

Each subject matter section should identify those to apply its questionnaires on and come up with a frame.

2.5 **Prices and Trade:**

Identified Problems:

- The PPI ought to measure price change in a sample of selected Establishments over time.
- The sample Establishments had been shrinking over the years
- The responding establishments were 94 out of 425 lodged in 2006
- The number that responded were 200 in 2005 and about 500 establishments in 2004
- As noted above 2006 and 2004 responding establishments were virtually not comparable.
- Indices obtained from 2006 survey were therefore employed to move the earlier series
- Poor unit of measure were observed
- Output of the establishments were small and ought not to be in the sample

Solution:

- PPI seemed to require greater attention
- Problems indicated above are inhibiting its development
- We might also be obtaining the data for PPI on quarterly basis which was the original intention

Foreign Trade Survey:

- The survey had never succeeded since the inception of the collaborative project
- The 2006 survey was a dismal failure
- The responding establishments were too few

Solution:

- The Foreign Trade Questionnaire should be separated from the PPI Questionnaire. A good frame should be employed for the Trade Survey

2.6 **National Accounts:**

Identified Problems:

Some of the problems identified from the last NBS/CBN/NCC survey were as follows:

- i) Large vote of Non-response
- ii) Inadequate items of e.g SAS.
- iii) Geographical coverage or sample section.
- iv) Some admin data were not uniquely tailored to facilitate the construction of the National Accounts but rather they were prepared as products of administration for general statistical progress.
- v) Over bloating of some data collected.

Suggested Solutions:

- i) Change the caliber of some staff used
- ii) Improving the quality of the questionnaire
- iii) The supervisors & Monitoring officers must be producers or users of the data improvement on the sampling design e.g. purpose sampling where necessary and resuscitation of the scrutiny sections.

2.7 Modern Holding:**Identified problems**

- i) Non-coverage of big farmers or farms
- ii) In adequacy of frame

Suggested Solutions:

- i) Separation of farmers into crop, livestock, poultry, fishing and forestry before selection.

2.8 Field Services:**Identified Problems:**

Ø For the purpose of this discussion, we should consider one survey year 2006/2007:

1. The questionnaire:

- a) The questionnaires were not sufficiently available for take-off of fieldwork.
- b) There were mix-up, in the printing of the questionnaires for both livestock and fishing.
- c) SAS questionnaires were not legible.

2. Training:

- d) The trainers were NBS staff and staff of other collaborative agencies.
- e) No questionnaires available until the last day.
- f) Duration of training limited.
- g) During data collection effective and adequate supervision was not aggressively pursued.
- h) Data collection period was very compressed.

3. Frame:

- i) Frame was incomplete.
- j) Some contain wrong addresses.
- k) Some were wrongly classified.

4. Funding:

- l) The remuneration of field staff needed to be enhanced to boost the field officers morale

2.9 ICT:

Identified Problems:

1. SAS Questionnaire:

The questionnaires given to us to use in designing the template (Data entry) was different from the one administered in the field most especially the communication questionnaires

- Most of the questionnaires were not completed based on the instruction given. Thereby making entry difficult. Typing on different sheet, based on their own format and report unit of measure was not unique e.g. LGA code and state code. Fiscal operation of state.
- Most retrieved questionnaires were usually Blank all through

2. Agric Questionnaire:

- Holding Questionnaire was not pilot tested before application on the field.
- No training on hand printing for the collaborative survey
- Inconsistencies of the weights/areas (measurements)
- Problems of inputs (seedlings, hours use etc)
- Improper use of Code list
- In adequate time for data processing (Data entering, scanning/verification)
- Needs for training of data processors
- In adequate time for data editing and analysis

2.10 Methodology

Identified Problems:

- In the past surveys, the frames were found to be inadequate:
- Use of 1991 census frame
- In agriculture, some EAs selected for study did not have farming activities therein (NISH)
- Some establishments selected for study were found to be:
- Dead or permanently closed down
- Temporarily closed down
- Some institutions/agencies addresses could not be located
- List of institutions or agencies not exhaustive.

Solution:

- Frame was critical to sample selection and estimation procedure in surveys
- NBS had taken critical look at all problems associated with frame compilation for the NISH, NISE and SAS
- NBS had accessed from NpopC a total of 23,280 EAs of 2006 Housing and Population Census
- A minimum of 30 EAs per LGA and maximum of 40 EAs per LGA in all 774 LGAs in the country
- NBS had embarked on the EA identification and housing units/ household listing exercise in readiness for the next round of NBS/CBN/NCC collaborative survey
- NBS had also compiled a comprehensive frame of 94,000 establishments
- List is currently being updated in the field

3.0 Group Work

On the second day of the workshop, members of the committee were divided into four groups to review survey questionnaires. Guideline for the group work was given as follows:

- (i) To review the questionnaires again based on observation made during paper presentation
- (ii) Fill necessary gaps in any questionnaire
- (iii) Ensure completeness of each survey questionnaire
- (iv) Finalization of questionnaire for presentation
- (v) Present final corrected questionnaires during plenary session.

The table below showed the list of group work and survey instruments to be worked upon.

3.1 Plenary Sessions

On the 3rd day of the workshop, the leaders of each group presented their group work and also highlighted where amendments/corrections had been effected in their questionnaires for the general house to cross examine and approve. The table below shows the format of presentation adopted for each group work.

3.2 Evaluation of Group work:

The committee undertook some far reaching decisions that would enhance the quality of data to be collected in 2007 survey. As a result of the group work, some modules were moved from one platform to another or to be administered separately by another set of enumerators. Those modules to be captured outside the NBS/CBN/NCC collaborative survey, it was stated that such data would be brought into the NBS/CBN/NCC data analysis even though, they were captured separately.

- Mining & Quarry Questionnaire moved from establishment survey to SAS
- Balance of payment module to be removed from the NBS/CBN/NCC 2008 survey
- PP1 should be separated from the Foreign Trade survey and prices staff, should be able to collect the data. Mr. O.F. Nwaboku was charged to make alternative arrangement with NBS.
- Communication module moved from establishment survey to SAS.
- Financial intermediation Questionnaire should be a stand alone and that CBN should supply the information.
- Corporate Financial Questionnaire should not be included in the NBS/CBN/NCC 2008 survey. Rather, it will be captured separately by CBN so as to give room for more details needed by National Accounts.
- Oil and Gas module should be a stand alone-questionnaire. Therefore, NBS and CBN should collect data on Oil and Gas separately.

4.0 **Amended Questionnaires:**

- a) GHS Questionnaire now have interviewer code and supervisor code.
On ICT section: Skip introductions introduced
If No to Q 31 – Q 36 skip to col.42 also if No to Q 58 skip to col.64
If No to col. 64 go to part C
On Electricity Supply Section: Col for hour(s) of electricity supply should be added.
- b) **Agric Questionnaires:**
Response Status with options had been introduced on the identification section for all the agric questionnaires
- c) **Crop Questionnaire:**
 - On section 5, col 7, 8 & 9 had been blocked and indicated for office use, so these cols will not be filled in the field by enumerators
Section 7 had been amended to accommodate wage and salary for everybody engaged in farming in a particular household.
 - Crop codes have been introduced into the questionnaire
 - Section 14: This had been amended to accommodate local unit and converted standard unit in kg.
- d) **Livestock Questionnaire:**
 - Section 13 re-titled Pest and diseases instead of pest
 - Poultry had been disaggregated to indicate the break down of poultry e.g fowl, Guinea fowl etc
- e) **Establishment Questionnaire**
 - Email address had been introduced on all the establishment questionnaires
 - **On Salary & Wage section**
Wages and salary had been separated from other benefits
 - Finance Questionnaire, PP1 Questionnaire used to be an independent Questionnaire before but now fused into Manufacturing Questionnaire
 - **Mining & Quarry Section:**
A column had been created to accommodate old machinery which has not been captured before.
 - **Hotel and Restaurant section 9:** Foreign tourists had been separated from the local tourists,
- f) **SAS Questionnaire**
 - Identification page had been introduced now

Water Board section:

 - A column had been created to capture the total of the previous year.
 - Q 7a and 7b were added into the questionnaire which was not there before.

g) **Sample Design:**

Systematic sampling modified to include stratification and purposive sampling. These 3 sampling techniques will be adopted in this survey as case may be. For instance, stratification and purposive samplings may be adopted for Establishment, Agric and Trade Surveys to direct at big establishments.

5.0 **Action Plan for NBS/CBN 2008 Survey**

- (i) GHS Questionnaire should be digital or scanable
- (ii) Establishment Questionnaire should be on analogue
- (iii) Agric Questionnaire should be on analogue
- (iv) SAS Questionnaire should be on analogue

What informed this decision was that some of the establishments or companies do not know how to fill scanable Questionnaires for now. Until they are knowledgeable with the system we would stick to analogue.

5.1 **Outsourced Staff:**

This will be adopted in this survey but a great deal of care should be taken in the selection. It had given credibility to some of the NBS surveys in recent times. So, the practice should not be discarded.

5.2 **Trade Frame:**

Mr. L.O. Ugwu of Trade Division was charged to compile a comprehensive frame and indicate where the questionnaire will be administered. The compiled frame should be ready during the T.O.T

5.3 **Printing of Survey Questionnaires**

A sample of the final Questionnaire should be given to subject matter to read-proof before printing. Also a sample of a printed Questionnaire should be sent to subject matter and CBN for approval before mass production.

5.4 **Deadline for survey instruments to be completed:** Subject matters were given Tuesday 22nd of January 2008 as deadline to produce a final and clean copy of the questionnaires with them.

5.5 **Final Review of the draft questionnaires:** Wednesday 23 of January 2008 had been fixed for a meeting of Divisional heads with D (CSD) to go through the draft questionnaires again.

5.6 **ICT Department:** charged to redesign SAS Questionnaires, because the current ones are not good enough. Mr. E. O. Ekezie and Mr. Gambo should work together to produce a better Questionnaire for SAS.

5.7 **Survey Manuals:**

Subject matters were charged to write survey manuals in line with the corrected questionnaires.

5.8 **Survey Sample Design:**

Mr. R. A. Sanusi was charged to get the draft of the survey design ready latest on Friday 25th January 2008. He should also send copies of the draft to Mr. C. M. Okafor and G. O. Adewoye each.

5.9 Workshop Report:

The secretariat was charged to produce the workshop report latest on Tuesday 29th January, 2008

6.0 Recommendations:

- CBN representatives at the workshop advised that Agric Division of NBS should revert to their old way of laying yield plot at the beginning of planting season to be able to get the estimated production at the end of the harvest season for a reasonable analysis. This process should start this year 2008, so that the result would be used for next year 2008 NBS/CBN/NCC Survey.
- NBS/CBN/NCC should organize sensitization workshop with establishments supplying data to the NBS/CBN/NCC collaboration survey to enhance the quality of their data.
- That any establishment that refused to give out data should be punished through their Ministers and Presidency as well as through NBS Statistical Act of 2007 and CBN Act No 24 of 1991.
- That National Accounts Division should work closely with all the subject matters to ensure that all that was needed to compute GDP were put in place.
- CBN should take full charge of lodging and retrieval of Establishment survey because they have comparative advantage.

6.1 Closing Remarks:

Mr. C. M. Okafor, who is the head of the CBN team at the workshop happily thanked all the participants for a job well done. He also remarked that the 2007 survey would be better than the previous years because we had started on good foundation with this workshop organized by NBS.

Mr. G. O. Adewoye, made the closing remarks. On behalf of the DG NBS, he sincerely thanked all the participants for their excellent performance. He also added that this was just the beginning of the task ahead.

6.2 Closing Prayer: This was said by Rev. S.T.Y. Kukah while the workshop ended at 8.43pm.
