P R E F A C E

The DEPARTMENT OF LABOUR with the assistance of UNDP / ILO, started conducting the ANNUAL EMPLOYMENT SURVEY in 1971 for the development of Labour Statistics in SRI LANKA. Since then this survey was conducted annually and published the report. The present report " EMPLOYMENT SURVEY 1990 " is the sixteenth report in the series since then. The survey covers establishments having five or more paid employees and engaged in productive, distributive business and commercial activities in both Private and Public sectors. Due to not availability of complete list of business establishments for the whole country, coverage of the survey is far below the real situation.

The survey is conducted by post taking the last working day of the month of June of the corresponding year as the reference period. Factors such as under coverage and high non-response rate are influenced the total figures, but other important characteristics such as changing employment pattern in the economy, distribution of employment among different industries or distribution of female employees in different industries in organize sector are some of the very important finding of the survey.

Planning of this survey, execution and preparation of final statistical tables were carried out by Mrs. D. L. LIYANAGE, Statistical Officer with her staff of the Annual Employment Survey Unit of the Labour Statistics Division of this Department under the direction and guidance of Mr. A. KAHANDA, Labour Statistician. Mr. Kahanda was also responsible for preparation of this final report.

Mr. NIMAL GUNASINGHE, Statistical Officer of the Labour Statistical Division was also associated with this work in addition to his normal work.

The staff of the Data Processing Division of the Department of Census and Statistics was responsible for data processing work.

Finally, I wish to express my appreciation to all the employers who responded to the survey for their co-operation for the successful completion of the survey.

ANNUAL EMPLOYMENT SURVEY - 1990

INTRODUCTION :

The First survey of the Annual Employment Survey series started by the Statistical Division of the Department of Labour in 1971 with the objective of collecting the information on employment by industry and occupation from all the establishments in the country with five or more paid employees in the Private Sector and the manufacturing and services institutions coming under Public Sector. The present report "ANNUAL EMPLOYMENT SURVEY 1990" is the sixteenth report in the series. This survey (postal) has been conducted every year since 1971 and the reference period for the survey continued to be the last working day in the month of June of that year. In 1971 complete list of establishments was collected by the Dept. of CENSUS & STATISTICS along with Pre-listing schedule of the 1971 Census of Population and Housing (F1 - Form). But since then such a complete list of establishments was not collected in one count and therefore the survey frame was not updated properly. This will reflect the survey finding such as very low employment data.

SCOPE AND COVERAGE :

The main objective of the survey was to collect statistical data on employment in organize sector by industry and occupation with a view to build up an Index of Employment and to watch employment trends of the economy. As indicated in previous section coverage of the survey will be all the establishments with five or more paid employees in Private Sector and the manufacturing and services institutions in the Public Sector.

ANALYSIS OF SURVEY RESULTS :

The total number of establishments addressed in 1990 was 9,969 and this shows 12.4 percent increased with compared to previous year number which was 8,868. As shown in Table No. 1 below there are some improvement in survey activity during this period. Survey response rate has increased to 70.9 percent in 1990. The response rate was 58.0 percent in 1988 and 59.0 percent in 1989. As a result of this favourable condition, number of reporting establishments has gone upto 5,247 in 1990 as compared to 3,525 in 1989 and 4,754 in 1988.

As shown in Table No. II below, coverage of establishments as well as employment has increased in 1990 satisfactorily as compared to previous two years. Employment coverage in Private Sector has reached

to 287,624 which was all time high, and this is 37.7 percent of total employment. With the implementation of Government open economic policy and transferring Government business establishment to Private Sector will stronger Private Sector share in economy. Survey result clearly indicate this trend. Proportion employed in Private Sector has increased gradually since 1978, 19.4 percent to 37.7 percent in 1990.

INDEX NUMBER OF EMPLOYMENT :

It is generally accepted that the index number on any field are the best indicator to monitor the trend. This is so, not only the employment field but also applicable to all the sectors of the economy. But due to change of response from the establishments from year to year it is very difficult to obtain a fixed list of establishments continuously.

employment trend from year to year could be studied compairing employment in common establishment between two adjacent years. It has been evident from past records that the better organised establishment with larger work forces continued to responded regularly over the years. Therefore for the computation of the index number of employment, the establishments which responded over two connective years were matched each year. Taking 1971 as base year link relative method has been adopted in computation an Index of Employment for each major industry division. These index numbers were calculated by dividing the current year employment by the corresponding figure for the previous year figure for each major industry division and then linking up by multiplying by the previous year index. This method has been adopted over the years since 1971 upto the present index for 1990.

Table No. III shows the index number of employment by major industry division and sector for the period of 1986 - 1990. As shown in the table over all index numbers for both sectors (Public and Private) combined has increased from 116.9 in 1989 to 117.8 in 1990. This increase was more significant in Private Sector and index has gone up by 2.0 percent from 152.2 percent in 1989 to 155.3 percent in 1990. Industry wise breakdown of the index number shows 5.1 percent increase for both sectors in Transport, Storage and Communication divisions and this changes absorbed entirely to Private Sector. Manufacturing Sector shows 3.2 percent increase for both sectors where as Private Sector shows 3.5 percent increase. Index for Construction sector has declined by 1.0 percent from 1989 to 1990 for both sectors where as Private Sector data shows 8.5 percent increase during this period. A detail look into the index shows over all performance of the Private Sector is very satisfactory with compare to Public Sector data.

Table No. IV gives more detail analysis of the employment trends for the year 1989 and 1990. Taking the establishments which furnished returns for both years (1989 - 1990) this tabulation were made. As shown in the table 0.75 percent employment increase were reported for all economic activities. The figure for the Private Sector was 2.04 percent. As mentioned above the data for the Private Sector are more significant. Most of the industry in Private Sector shows this positive trend, where as in Public Sector majority of industries reported negative trend. In Private Sector industries such as Mining and Quarrying 4.0 percent, Manufacture of Textile Weaving Apparel 2.38 percent, Manufacture of Paper and Paper Products 12.07 percent, etc. are the some of industry shows employment gain.

Table VI gives employment distribution by occupational categories. Percentage distribution of employees by sex and sectors are shown in Table No. VI. It shows that the female participation in organized sector has increased significantly. This increase are more significant in Private Sector with compare to Public Sector. Percentage female employees in Private Sector was 42.2 percent in 1988 and this has gone upto 55.1 percent in 1990. Corresponding figure for Public Sector was 41.6 percent and 37.7 percent respectively.

Number and percentage distribution of women employees to total employees (men and women) by major division of Industry and by major Occupation categories are shown in text Table VIII, IX and X. As shown in Table VIII, number and percentage of women employees in Manufacturing sector has increased significantly from 1988, 45.2 percent to 53.3 percent in 1990. Number also gone up from 81,039 in 1988 to 126,249 in 1990. This is mainly due to employment increases in Textile and Garment trades. Also these female employment increases are shown in Construction, Wholesale & Retail, Finance, Insurance, Real Estate & Business Services and Personal Services.

Table IX gives further breakdown of female employees distribution by major occupational categories. As seen on this table almost all the occupational categories, proportion of female employed has increased. Professional, Technical & Related category has increased from 20.1 percent in 1988 to 25.3 percent in 1990. Also skilled and semi-skilled category has increased from 37.6 percent in 1988 to 48.2 percent in 1990. During this period female employment coverage of the survey has gone up by 10.7 percent.

Table X gives number and percentage of women employees by major industry and occupational categories. This table shows total employees and the percentage female employees for each cross classification group. According to this table under the Manufacturing industry, out of total employees in skilled and semi-skilled occupational categories, 60.5 percent are female. Under the industry group Construction, 66.2 percent Un-skilled workers are female.
