

## HIES 1990-91, 1992-93, 1993-94 and 1996-97

### Description of data set:

Data for these years have been subdivided into the three main sections including Main, Farm and Nonfarm directories. The main file covers information contained in the main questionnaire while, other two files provide information on the basis of HIES's Agriculture and Non-Farm Establishment Sheets. Maximum effort has been made to keep the data in a simple format for analysis. For example, to find the overall literacy rate in 1996/97, just go to HIES9697\spssdata\main\sec-2.sav and take the frequency of the variable S2q7 which has been labeled literacy. Similarly, to derive household wheat consumption in 1993/94, go to HIES1993/94\spssdata\main\sec-3-food.sav, select item (labeled by commodity code) 3001 and 3002, HHOCODE (Household ID code) as break variable and quint (quantity consumed) as aggregate variable.
