

I. Objectives

This survey was designed to achieve the following objectives:

- Assist the World Bank in gaining a better understanding of how stakeholders in Botswana perceive the Bank;
- Obtain systematic feedback from stakeholders in Botswana regarding:
 - Their views regarding the general environment in Botswana;
 - Their overall attitudes toward the World Bank in Botswana;
 - Overall impressions of the World Bank's effectiveness and results, knowledge work and activities, and communication and information sharing in Botswana;
 - Perceptions of the World Bank's future role in Botswana.
- Use data to help inform Botswana country team's strategy.

II. Methodology

From May to June 2013, 300 stakeholders of the World Bank in Botswana were invited to provide their opinions on the Bank's assistance to the country by participating in a country survey. Participants in the survey were drawn from employees of the Office of the President, Prime Minister; office of ministers; ministries, ministerial departments, or implementation agencies; consultants/ contractors working on World Bank-supported projects/programs; project management units (PMUs) overseeing implementation of a project; local government officials or staff; and respondents from bilateral and multilateral agencies; private sector organizations; financial sector and private banks; NGOs; CBOs; the media; independent government institutions; trade unions; faith-based groups; academia/research institutes/think tanks; and other organizations. A total of 241 stakeholders participated in the survey (80% response rate).

Respondents received questionnaires via courier and email and returned them accordingly. Respondents were asked about: general issues facing Botswana; their overall attitudes toward the Bank; the World Bank's effectiveness and results; the Bank's knowledge work and activities; working with the World Bank; the Bank's future role in Botswana; and the Bank's communication and information sharing in Botswana.

Every country that engages in the Country Survey must include specific indicator questions that will be aggregated for the World Bank's annual Corporate Scorecard. These questions are identified throughout the survey report.

- A. General Issues Facing Botswana: Respondents were asked to indicate whether Botswana is headed in the right direction, what they thought were the top three most important development priorities in the country, which areas would contribute most to reducing poverty and generating economic growth in Botswana.
- B. Overall Attitudes toward the World Bank: Respondents were asked to rate their familiarity with the World Bank, the Bank's effectiveness in Botswana, staff preparedness to help Botswana solve its development challenges, their agreement with various statements regarding the Bank's work, and the extent to which the Bank is an effective development partner. Respondents were asked to indicate the Bank's greatest values, greatest weaknesses, the most effective instruments in helping reduce poverty in Botswana, with which stakeholder groups the Bank should collaborate more, in which sectoral areas the Bank should focus most resources, to what extent the Bank should seek to influence the global development agenda, and to what reasons respondents attributed failed/slow reform efforts.


II. Methodology (continued)

- C. World Bank Effectiveness and Results: Respondents were asked to rate the extent to which the Bank's work helps achieve development results, the extent to which the Bank meets Botswana's needs for knowledge services and financial instruments, and the Bank's level of effectiveness across twenty eight development areas, such as job creation/employment, poverty reduction, education, health, and public sector governance/reform.
- D. The World Bank's Knowledge: Respondents were asked to indicate the areas on which the Bank should focus its research efforts and to rate the effectiveness and quality of the Bank's knowledge work and activities, including how significant of a contribution it makes to development results and its technical quality. Respondents were asked to also indicate to what extent they believe that Botswana received value for money from the Bank's fee-based products/services.
- E. Working with the World Bank: Respondents were asked to rate their level of agreement with a series of statements regarding working with the Bank, such as the World Bank's "Safeguard Policy" requirements being reasonable, the Bank imposing reasonable conditions on its lending, disbursing funds promptly, increasing Botswana's institutional capacity, and providing effective implementation support.
- F. The Future Role of the World Bank in Botswana: Respondents were asked to rate how significant a role the Bank should play in Botswana in the near future and to indicate what the Bank should do to make itself of greater value. They were asked to indicate where greater support from the Bank would be most valuable in regard to economic diversification, social protection, natural resource management, information and communication technology, transport infrastructure, and public sector reform. Respondents were also asked to indicate the areas in which Botswana would benefit most from the Bank play a leading role, the areas where Botswana should receive little to no resources from the Bank, and areas that should be left to the Government to manage without the Bank's support.
- G. Communication and Information Sharing: Respondents were asked to indicate how they get information about economic and social development issues, how they prefer to receive information from the Bank, and their usage and evaluation of the Bank's websites. Respondents were asked about their awareness of the Bank's Access to Information policy, past information requests from the Bank, and their level of agreement that they use more data from the World Bank as a result of the Bank's Open Data policy. Respondents were also asked about their level of agreement that they know how to find information from the Bank, that the Bank's websites are easy to navigate and useful, and that the Bank is responsive to information requests. Respondents were also asked to indicate whether they primarily use the Bank's country website or the Bank's main website, which Internet connection they primarily use when visiting a Bank website, and whether they use/have used the Public Information Centers in Botswana.
- H. Background Information: Respondents were asked to indicate their current position, specialization, whether they professionally collaborate with the World Bank, their exposure to the Bank in Botswana, and their geographic location.

III. Demographics of the Sample

Current Position


- For further analyses, respondents from the Office of President, Prime Minister and the Office of Minister were combined; respondents from PMUs were combined with consultants/contractors working on Bank projects; respondents from bilateral agencies were combined with respondents from multilateral agencies; respondents from private sector organizations were combined with respondents from financial sector/private banks; respondents from NGOs, CBOs, trade unions, and faith-based groups were combined into the “CSO” category; few respondents from local governments and other organizations were combined into the “Other” category. There were no respondents from the office of a parliamentarian, private foundations, or the judiciary branch.

Area of Primary Specialization




“Please identify the primary specialization of your work.” (Respondents chose from a list.)

- Nearly all respondents indicated that they were from Gaborone. Because of the small number of respondents from other regions of the country, statistical comparisons across geographic locations were not possible.




“Which best represents your geographic location?”
(Respondents chose from a list.)



"Currently, do you professionally collaborate/work with the World Bank in your country?"




"Which of the following describes most of your exposure to the World Bank in Botswana? (Choose no more than TWO)" (Respondents chose from a list. Responses combined.)

Familiarity with the World Bank

- Respondents across all stakeholder groups had statistically similar level of familiarity with the World Bank.
- Respondents' ratings of familiarity with the Bank were significantly, strongly correlated with their perceptions of the Bank's overall effectiveness in Botswana, and significantly, moderately correlated with the Bank's perceived relevance to Botswana's development, and the Bank's perceived ability to help achieve development results in Botswana.




"How familiar are you with the work of the World Bank in Botswana?"


Headed in the Right Direction

- A majority of respondents from the Office of President/Prime Minister/Minister, bilateral/multilateral agencies, and CSOs, and employees of ministries/ministerial departments/implementation agencies indicated that Botswana was headed in the right direction, whereas most the respondents from the media, academia/research institutes/think tanks, PMUs and consultants/contractors working on bank-supported projects held an opposite view. Respondents from these stakeholder groups were significantly *more* likely to indicate that Botswana was headed in the wrong direction or they were not sure whether Botswana was headed in the right or wrong direction.


Development Priority


What Would Contribute Most to Reducing Poverty


What Would Contribute Most to Generating Economic Growth

Where the World Bank Should Focus its Resources








"To what extent does the World Bank's work help to achieve development results in Botswana?"




Greatest Value


Greatest Weakness


Attributing Slow or Failed Reform Efforts

- There were significant stakeholder group differences in their ratings of the Bank’s effectiveness in “anti corruption,” “law and justice,” and “health.” For the most part, respondents from PMUs and consultants/contractors working on Bank projects gave the highest ratings, whereas respondents from academia/research institutes/think tanks tended to give significantly *lower* ratings.

VI. Sectoral Effectiveness (continued)

Drivers of Effectiveness

To determine the key drivers of respondents' ratings of the Bank's overall effectiveness and ratings of its ability to help achieve development results in Botswana, bivariate correlational analyses were conducted using respondents' ratings of the forty-one specific areas of effectiveness.

Correlational analyses, however, are not able to tell us exactly what is causing respondents' ratings of the Bank's overall effectiveness or ratings of its ability to help achieve development results. Rather, these analyses tell us that as ratings of effectiveness in one area increase, respondents' ratings of the Bank's overall effectiveness increase, or as ratings of effectiveness in one area increase, ratings of the Bank's ability to help achieve development results increase. Thus, it can be inferred that respondents' perceptions of effectiveness in one specific area are related to, or drive, respondents' perceptions of the Bank's overall effectiveness or perceptions of the Bank's ability to help achieve development results.


- **Overall Effectiveness:** Those specific areas with the highest Pearson Product-Moment correlations were determined to be the most closely related to perceptions of the Bank's overall effectiveness, suggesting that ratings of effectiveness in those specific areas are drivers of perceptions of the Bank's overall effectiveness in Botswana. The areas determined to be key drivers from these analyses were:
 - The Bank's effectiveness at health;
 - The Bank's effectiveness at information and communications technology;
 - The Bank's effectiveness at gender;
 - The Bank's effectiveness at foreign direct investment; and
 - The Bank's effectiveness at communication/non-communicable diseases.

- **Achieving Development Results:** Those specific areas with the highest Pearson Product-Moment correlations were determined to be the most closely related to perceptions of the Bank's ability to help achieve development results in Botswana, suggesting that ratings of effectiveness in those specific areas are drivers of perceptions of the Bank's ability to help achieve development results. The areas determined to be key drivers from these analyses were:
 - The Bank's effectiveness at basic infrastructure;
 - The Bank's effectiveness at communicable/non-communicable diseases;
 - The Bank's effectiveness at information and communications technology;
 - The Bank's effectiveness at transport; and
 - The Bank's effectiveness at health.

VII. How the World Bank Operates

The World Bank's Work in Botswana

- Respondents across all stakeholder groups gave statistically similar ratings for these three statements, including the indicator questions that “the World Bank’s work is aligned with what I consider the development priorities for Botswana,” and “overall the World Bank currently plays a relevant role in development in Botswana.”




"To what extent do you agree with the following statements about the World Bank's work in Botswana?" (1-"Strongly disagree", 10-"Strongly agree")

Overall Perceptions

- Respondents from PMUs, consultants/contractors working on Bank projects gave the highest ratings for the statements that “the World Bank disburses funds promptly,” “the World Bank effectively monitors and evaluates the projects and programs it supports,” and “the World Bank’s ‘Safeguard Policy’ requirements are reasonable,” whereas respondents from independent government institutions and academia/research institutes/think tanks gave significantly *lower* ratings.
- Respondents across all stakeholder groups gave statistically similar ratings for the indicator statement that “where country systems are adequate, the World Bank makes appropriate use of them”.




"To what extent do you agree/disagree with the following statements?"

The World Bank as an Effective Development Partner

- Respondents from PMUs and consultants/contractors working on Bank projects had the highest ratings for the Bank's "staff accessibility," "straightforwardness and honesty," and "collaboration with groups outside of the Government" as an effective development partner, whereas respondents from academia/research institutes/think tanks tended to give significantly *lower* ratings.
- Respondents across stakeholder groups gave statistically similar ratings for the following indicator qualities of the Bank, including the Bank's "collaboration with the government", "with other donors", and Bank's "responsiveness" and "openness."




"To what extent is the World Bank an effective development partner in Botswana?"

VIII. World Bank Knowledge and Instruments

Frequency of Use

- There were some interesting stakeholder group differences in their usage of the World Bank's knowledge work and activities.
 - Respondents from the media, PMUs, and consultants/contractors working on Bank projects indicated that they consulted World Bank knowledge work and activities either weekly or monthly, whereas more than half of the respondents from the private sector/financial sector/private banks, CSOs, and academia/research institutes/think tanks indicated they either rarely or never consulted the Bank's knowledge work and activities.




"How frequently do you consult World Bank knowledge work and activities in the work you do?"








"In Botswana, how effective do you believe the World Bank's knowledge work and activities:"


"In Botswana, to what extent do you believe that the World Bank's knowledge work and activities:"




"Overall, how significant a contribution do you believe the World Bank's knowledge work and activities make to development results in your country?"



Value of the World Bank's Fee-based Products/Services




"To what extent do you believe that Botswana received value for money from the World Bank's products/services that were paid for on a fee for service basis?"




“Which World Bank instruments do you believe are the MOST effective in reducing poverty in Botswana? (Choose no more than TWO)”




"The World Bank's financial instruments meet the needs of Botswana"



















"Which TWO areas below would benefit most from the World Bank playing a leading role among international partners in Botswana?" (Respondents chose from a list. Responses combined.)


Areas Where the Bank Should Offer Little or No Resources


Areas that should be Left to the Government without the Bank's Support






Information Sources

"Are you aware of the World Bank's Access to Information Policy under which the Bank will now disclose any information in its possession that is not on a list of exceptions?"


- Respondents from the media were most likely to indicate that they had requested information from the World Bank on its activities in the past year, whereas respondent from the private sector/financial sector/private banks, PMUs, consultants/contractors working on Bank projects were significantly *less* likely to have requested information from the Bank.

Percentage of Respondents (N=34)




Access to Information (continued)




"Please rate how much you agree with the following statements"

Internet Access





"Do you have access to the Internet?"







