I. Objectives

This survey was designed to achieve the following objectives:

- Assist the World Bank in gaining a better understanding of how stakeholders in Guinea perceive the Bank;
- Obtain systematic feedback from stakeholders in Guinea regarding:
 - Their views regarding the general environment in Guinea;
 - Their overall attitudes toward the World Bank in Guinea;
 - Overall impressions of the World Bank's effectiveness and results, knowledge and research, and communication and information sharing in Guinea; and
 - Perceptions of the World Bank's future role in Guinea.
- Use data to help inform the Guinea country team's strategy.

II. Methodology

In February 2013, 513 stakeholders of the World Bank in Guinea were invited to provide their opinions on the Bank's assistance to the country by participating in a country survey. Participants in the survey were drawn from among the office of the President; the office of the Prime Minister; the office of a Minister; the office of a Parliamentarian; employees of a ministry, ministerial department, or implementation agency; consultants/contractors working on World Bank-supported projects/programs; project management units (PMUs) overseeing implementation of a project; local government officials or staff; bilateral and multilateral agencies; private sector organizations; private foundations; the financial sector/private banks; NGOs; community-based organizations (CBOs); the media; independent government institutions; trade unions; faith-based groups; academia/research institutes/think tanks; and the judiciary branch. A total of 383 stakeholders participated in the country survey (75% response rate).

Respondents received questionnaires via courier, email or face to face and returned them accordingly. Respondents were asked about: general issues facing Guinea; their overall attitudes toward the Bank; the World Bank's effectiveness and results; the Bank's knowledge; working with the World Bank; the Bank's future role in Guinea; and the Bank's communication and information sharing in Guinea.

Every country that engages in the Country Survey must include specific indicator questions that will be aggregated for the World Bank's annual Corporate Scorecard. These questions are identified throughout the survey report.

- A. General Issues Facing Guinea: Respondents were asked to indicate whether Guinea is headed in the right direction, what they thought were the top three most important development priorities, and which areas of development would contribute most to reducing poverty and generating economic growth in Guinea.


II. Methodology (continued)

- B. Overall Attitudes toward the World Bank: Respondents were asked to rate their familiarity with the World Bank, the Bank's effectiveness in Guinea, Bank staff preparedness to help Guinea solve its development challenges, their agreement with various statements regarding the Bank's work, and the extent to which the Bank is an effective development partner. Respondents were also asked to indicate the sectoral areas on which it would be most productive for the Bank to focus its resources, the Bank's greatest values and greatest weaknesses in its work, the most effective instruments in helping to reduce poverty in Guinea, with which stakeholder groups the Bank should collaborate more, and to what reasons respondents attributed failed or slow reform efforts.
- C. World Bank Effectiveness and Results: Respondents were asked to rate the extent to which the Bank's work helps achieve development results in Guinea, the extent to which the Bank meets Guinea's needs for knowledge services and financial instruments, and the Bank's level of effectiveness across thirty six development areas, such as poverty reduction, agricultural development, transport, education and communicable/non-communicable diseases.
- D. The World Bank's Knowledge: Respondents were asked to indicate how frequently they consult Bank knowledge work and activities, the areas on which the Bank should focus its research efforts, and to rate the effectiveness and quality of the Bank's knowledge work and activities, including how significant of a contribution they make to development results in Guinea and its technical quality.
- E. Working with the World Bank: Respondents were asked to rate their level of agreement with a series of statements regarding working with the Bank, such as the World Bank's "Safeguard Policy" requirements being reasonable, the Bank imposing reasonable conditions on its lending, disbursing funds promptly, increasing Guinea's institutional capacity, providing effective implementation support, and the World Bank is adequately staffed in Guinea.
- F. The Future Role of the World Bank in Guinea: Respondents were asked to rate how significant a role the Bank should play in Guinea's development in the near future and to indicate what the Bank should do to make itself of greater value in Guinea.
- G. Communication and Information Sharing: Respondents were asked to indicate how they get information about economic and social development issues, how they prefer to receive information from the Bank, and their usage and evaluation of the Bank's websites. Respondents were asked about their awareness of the Bank's Access to Information policy, past information requests from the Bank, and their level of agreement that they use more data from the World Bank as a result of the Bank's Open Data policy. Respondents were also asked about their level of agreement that they know how to find information from the Bank and that the Bank is responsive to their information requests.
- H. Background Information: Respondents were asked to indicate their current position, specialization, whether they professionally collaborate with the World Bank, their exposure to the Bank in Guinea, and their geographic location.

Current Position


- For further analyses, the small number of respondents from the office of a Minister were combined with those from the office of the President/Prime Minister, consultants/contractors working on Bank-supported projects were combined with those from PMUs, respondents from multilateral agencies were combined with those from bilateral agencies, respondents from the financial sector/private banks were combined with those from the private sector, respondents from private foundations, CBOs, NGOs, trade unions, and faith-based groups were combined into a “CSO” category, and the few academic respondents, respondents from the office of a parliamentarian, the judiciary branch, and independent government institutions were included in the “Other” category.




"Please identify the primary specialization of your work." (Respondents chose from a list.)




“Which best represents your geographic location?” (Respondents chose from a list.)



"Currently, do you professionally collaborate/work with the World Bank in your country?"




"Which of the following describes most of your exposure to the World Bank in Guinea? (Choose no more than TWO)" (Respondents chose from a list. Responses combined.)

Familiarity with the World Bank

- Respondents across all stakeholder groups had statistically similar level of familiarity with the World Bank.
- Respondents from Mid-Guinea and Upper Guinea indicated the highest levels of familiarity with the Bank, whereas respondents from Forested Guinea indicated significantly lower levels.
- It should be noted that respondents' ratings of familiarity with the Bank were significantly, strongly correlated with their perceptions of the Bank's overall effectiveness in Guinea, and significantly, moderately correlated with the Bank's ability to help achieve development results, and the Bank's relevance to Guinea's development.




"How familiar are you with the work of the World Bank in Guinea, on a ten point scale?"

Headed in the Right Direction


- When asked whether Guinea was headed in the right or wrong direction, 71% of respondents indicated that Guinea was headed in the right direction.
- A majority of respondents from most stakeholder groups indicated that Guinea was headed in the right direction, except respondents from the private sector/financial sector/private banks who were more likely to say that they were not sure whether Guinea was headed in the right or wrong direction.


Development Priority


What Would Contribute Most to Reducing Poverty


What Would Contribute Most to Stimulating Economic Growth and Diversification



- Respondents across all stakeholder groups and geographic locations gave statistically similar ratings for the World Bank’s overall effectiveness in Guinea.






"To what extent does the World Bank's work help to achieve development results in Guinea, on a ten point scale?" (1-"To no degree at all", 10-"To a very significant degree")




Greatest Value


Greatest Weakness


Attributing Slow or Failed Reform Efforts

Specific Areas of Effectiveness

- There were significant stakeholder group differences in their ratings of the Bank's effectiveness across many of these thirty-six development areas. For the most part, respondents from CSOs tended to have the highest ratings for the Bank's effectiveness across these areas, whereas respondents from the private sector/financial sector/private banks tended to have significantly lower ratings. (See the Appendix for full details.) Those areas with significant stakeholder differences were:
 - Information and communications technology
 - Basic infrastructure
 - Local governance and institutions
 - Job creation/employment
 - Rural development
 - Social protection
 - Natural resource management

- There were significant differences between geographic locations across eleven of these thirty-six areas. In almost all eleven instances, respondents from Maritime Guinea had significantly lower ratings for the Bank's effectiveness across these areas than respondents from other locations. Those areas with significant differences were:
 - Basic infrastructure
 - Communicable/non-communicable diseases
 - Water and sanitation
 - Trade and exports
 - Economic growth and diversification
 - Energy
 - Health
 - Rural development
 - Education
 - Social protection
 - Agricultural development

VI. Sectoral Effectiveness (continued)

Drivers of Effectiveness

To determine the key drivers of respondents' ratings of the Bank's overall effectiveness and ratings of its ability to help achieve development results in Guinea, bivariate correlational analyses were conducted using respondents' ratings of the thirty six specific areas of effectiveness.

Correlational analyses, however, are not able to tell us exactly what is causing respondents' ratings of the Bank's overall effectiveness or ratings of its ability to help achieve development results. Rather, these analyses tell us that as ratings of effectiveness in one area increase, respondents' ratings of the Bank's overall effectiveness increase, or as ratings of effectiveness in one area increase, ratings of the Bank's ability to help achieve development results increase. Thus, it can be inferred that respondents' perceptions of effectiveness in one specific area are related to, or drive, respondents' perceptions of the Bank's overall effectiveness or perceptions of the Bank's ability to help achieve development results.


- Overall Effectiveness: Those specific areas with the highest Pearson Product-Moment correlations were determined to be the most closely related to perceptions of the Bank's overall effectiveness, suggesting that ratings of effectiveness in those specific areas are drivers of perceptions of the Bank's overall effectiveness in Guinea. The areas determined to be key drivers from these analyses were:
 - Law and justice;
 - Poverty reduction;
 - Health;
 - Domestic private sector development; and
 - Anti corruption.

- Achieving Development Results: Those specific areas with the highest Pearson Product-Moment correlations were determined to be the most closely related to perceptions of the Bank's ability to help achieve development results in Guinea, suggesting that ratings of effectiveness in those specific areas are drivers of perceptions of the Bank's ability to help achieve development results. The areas determined to be key drivers from these analyses were:
 - Poverty reduction;
 - Rural development;
 - Economic growth and diversification;
 - Anti corruption; and
 - Agricultural development.

VII. World Bank Knowledge and Instruments

Knowledge: Frequency of Use

- There are some interesting stakeholder group differences in their usage of the World Bank's knowledge work and activities.
 - Consultants on Bank-supported projects and respondents from PMUs and the media indicated that they consult the World Bank knowledge work and activities the most frequently, from a few times a year to weekly.
 - Employees of ministries/ministerial departments/implementation agencies and respondents from the private sector/financial sector/private banks indicated that they consult the World Bank knowledge work and activities much less frequently, from never to a few times a year.




"How frequently do you consult World Bank knowledge work and activities in the work you do?"

Knowledge: Meeting Guinea' Knowledge Needs (Indicator Question)


- Respondents across all stakeholder groups had statistically similar levels of agreement that the World Bank meets Guinea' needs for knowledge services.
- Respondents from Upper Guinea had the highest levels of agreement that the Bank meets Guinea's needs for knowledge services, whereas respondents from Maritime Guinea had significantly lower levels of agreement.




“When thinking about the development challenges in Guinea, where do you believe it would be most valuable for the World Bank to focus its knowledge work and activities in the next few years?

Knowledge: Effectiveness

- Respondents across all stakeholder groups gave statistically similar ratings for the effectiveness of the World Bank's knowledge work and activities at all of these aspects.
- There were significant differences between geographic locations. Respondents from Forested Guinea gave significantly higher ratings for the effectiveness of the Bank's knowledge work and activities at providing support for program implementation than respondents from other geographic areas in Guinea.




"In Guinea, how effective do you believe the World Bank's knowledge work and activities are at"

- Respondents across all stakeholder groups gave statistically similar ratings for all of these qualities of the World Bank's knowledge work and activities.
- There were significant differences between geographic locations in the respondents' ratings across many aspects of the Bank's knowledge work and activities (see the Appendix for full details). For the indicator question, respondents across all geographic locations gave statistically similar ratings.




"In Guinea, to what extent do you believe that the World Bank's knowledge work and activities:"

- Respondents across all stakeholder groups gave statistically similar ratings for the significance of the contribution that the World Bank's knowledge work and activities make to development results in Guinea.
- Respondents from Forested Guinea had the highest ratings for the significance of the contribution that the World Bank's knowledge work and activities make to the development results in Guinea, whereas respondents from Mid-Guinea had significantly lower ratings.




“Overall, how significant a contribution do you believe the World Bank's knowledge work and activities make to development results in your country, on a ten point scale?


- Respondents across all stakeholder groups gave statistically similar ratings for the technical quality of the World Bank's knowledge work and activities.
- Respondents from Forested Guinea had the highest ratings for the technical quality of the World Bank's knowledge work and activities, whereas respondents from Mid-Guinea had significantly lower ratings.



- Respondents across all stakeholder groups and geographic locations had statistically similar levels of agreement on whether the Bank's financial instruments meet the needs of Guinea.




The World Bank's Work in Guinea

- Respondents across all stakeholder groups had statistically similar levels of agreement on the World Bank's work in Guinea in the following aspects.
- There were significant differences between geographic locations in the respondents' levels of agreement regarding two aspects of the Bank's work in Guinea: The World Bank supporting realistic programs/strategies and playing a relevant role in development in the country. Respondents from Upper Guinea tended to have the highest levels of agreement with these statements, whereas respondents from Mid-Guinea tended to have significant lower levels of agreement.

Building/Strengthening Country Systems in Guinea



Overall Perceptions

- There were significant stakeholder group differences in the respondents' levels of agreement that the World Bank ensures consistency and continuity through staff changes. Employees of the local governments, ministries/ministerial departments/implementation agencies and CSOs had the highest levels of agreement, whereas the consultants working on Bank-supported projects, PMUs, and respondents from the private sector/financial sector/private banks tended to have significant lower levels of agreement.
- There were significant differences between geographic locations in the respondents' levels of agreement across many aspects of how the Bank operates (see the Appendix for full details). For the indicator question, respondents across all geographic locations had statistically similar levels of agreement.




"To what extent do you agree/disagree with the following statements, on a ten point scale?"


The World Bank as an Effective Development Partner

- There were significant stakeholder group differences in their ratings for the World Bank's "collaboration with the government" as an effective development partner in the country. Employees of ministries/ministerial departments/implementation agencies and local governments, and respondents from the CSOs tended to give the highest ratings, whereas respondents from the media tended to give significantly lower ratings.
- There were significant differences between geographic locations in their ratings across two of these aspects of the World Bank being an effective development partner (see the Appendix for full details). For the indicator questions, respondents across all geographic locations had statistically similar ratings.

 (1-"To no degree at all", 10-"To a very significant degree") *Indicator question


The World Bank is Adequately Staffed in Guinea



"To what extent do you believe the World Bank is adequately staffed in Guinea, on a ten point scale?" (1-"To no degree at all", 10-"To a very significant degree")








The World Bank Playing a Leading Role among International Partners in Guinea


Guinea Benefiting from Other Donors




“Which THREE areas below would benefit most from other donors playing a leading role among international partners in Guinea?”


“How do you get most of your information about economic and social development issues in Guinea? (Choose no more than TWO)” (Respondents chose from a list. Responses combined.)



“Are you aware of the World Bank’s Access to Information Policy under which the Bank will now disclose any information in its possession that is not on a list of exceptions?”








Internet Access

- Respondents from the local governments were significantly *less* likely to have access to the Internet compared to respondents from other stakeholder groups.



- PMUs/consultants/contractors on Bank-supported projects, respondents from bilateral/multilateral agencies and the private sector/financial sector/private banks tended to use high speed Internet connections, whereas employees from ministries/ministerial departments/implementation agencies and local governments tended to use dial-up Internet connections.





“Which Internet connection do you use primarily when visiting a World Bank website?”


Website Usage





