





I. Objectives

This survey was designed to achieve the following objectives:

- Assist the World Bank in gaining a better understanding of how stakeholders in India perceive the Bank;
- Obtain systematic feedback from stakeholders in India regarding:
 - Their views regarding the general environment in India;
 - Their overall attitudes toward the World Bank in India;
 - Overall impressions of the World Bank's effectiveness and results, knowledge and research, and communication and information sharing in India; and
 - Perceptions of the World Bank's future role in India.
- Use data to help inform the India country team's strategy.

II. Methodology

In May thru July 2012, 1,445 stakeholders of the World Bank in India were invited to provide their opinions on the Bank's assistance to the country by participating in a country survey. Participants in the survey were drawn from among the office of the President or Prime Minister; the office of a Minister; the office of a Parliamentarian; employees of a ministry, ministerial department, or implementation agency; consultants/contractors working on World Bank-supported projects/programs; project management units (PMUs) overseeing implementation of a project; local government officials or staff; bilateral agencies; multilateral agencies; private sector organizations; private foundations; the financial sector/private banks; NGOs; community-based organizations (CBOs); the media; independent government institutions; trade unions; faith-based groups; academia/research institutes/think tanks; and the judiciary branch. A total of 260 stakeholders participated in the country survey (18%).

Respondents received questionnaires via courier, post, or email and returned it accordingly, or completed questionnaires with a representative of the fielding agency. Respondents were asked about: general issues facing India, their overall attitudes toward the Bank; the World Bank's effectiveness and results; the Bank's knowledge; working with the World Bank; the Bank's future role in India, and the Bank's communication and information sharing in India.

Every country that engages in the Country Survey must include specific indicator questions that will be aggregated for the Bank's annual Corporate Scorecard. These questions are identified throughout the survey report.

- A. General Issues facing India: Respondents were asked to indicate which areas would contribute most to reducing poverty and generating economic growth in India.


- B. Overall Attitudes toward the World Bank: Respondents were asked to rate their familiarity with the World Bank, the Bank's effectiveness in India, Bank staff preparedness, the extent to which the Bank should seek to influence the global development agenda, their agreement with various statements regarding the Bank's work, and the extent to which the Bank is an effective development partner. Respondents were also asked to indicate the sectoral areas on which it would be most productive for the Bank to focus its resources, what they think is the Bank's priority in India, the Bank's greatest values and greatest weaknesses in its work, the most and least effective instruments in helping to reduce poverty in India, and with which groups the Bank should work more in India.
- C. World Bank Effectiveness and Results: Respondents were asked to rate the extent to which the Bank's work helps achieve sustainable development results in India, the extent to which the Bank meets India's need for knowledge services and financial instruments, and the Bank's level of effectiveness across eighteen development areas, such as economic growth and urban development.
- D. The World Bank's Knowledge: Respondents were asked to indicate how frequently they consult Bank knowledge/research, the areas on which the Bank should focus its research efforts, and to rate the effectiveness and quality of the Bank's knowledge/research, including how significant of a contribution it makes to development results, its technical quality, and the Bank's effectiveness at providing linkage to non-Bank expertise.
- E. Working with the World Bank: Respondents were asked to rate their level of agreement with a series of statements regarding working with the Bank, such as the World Bank's "Safeguard Policy" requirements being reasonable and the Bank disbursing funds promptly.
- F. The Future Role of the World Bank in India: Respondents were asked to rate how significant a role the Bank should play in India's development in the near future and to indicate what the Bank should do to make itself of greater value in India and at what level of Government the World Bank should engage more actively in India.
- G. Communication and Information Sharing: Respondents were asked to indicate where they get information about economic and social development issues, how they prefer to receive information from the Bank, their access to the Internet, and their usage and evaluation of the Bank's website and PICs. Respondents were asked about their awareness of the Bank's Access to Information policy, past information requests from the Bank, and their level of agreement that they use more data from the World Bank as a result of the Bank's Open Data policy. Respondents were also asked their level of agreement that they know how to find information from the Bank and that the Bank is responsive to information requests.
- H. Background Information: Respondents were asked to indicate their current position, specialization, whether they professionally collaborate with the World Bank, their exposure to the Bank in India, and their geographic location.

In addition, when possible, responses from respondents completing this year's country survey were compared to responses from the 581 respondents (58% response rate) who completed the country survey in FY 2004. Notations and/or charts are included when these comparisons were possible.


Current Position

- For further analyses, the small number of consultants working on Bank-supported projects were combined with respondents from PMUs, respondents from private foundations and CBOs were combined with those from NGOs, respondents from multilateral agencies were combined with those from bilateral agencies, respondents from the financial sector/private banks were combined with those from the private sector, and the few respondents from the office of the President/Prime Minister, the office of a Minister, the office of a Parliamentarian, independent government institutions, and the judiciary branch were included in the “Other” category.


Area of Primary Specialization

Geographic Location







Familiarity with the World Bank

- Across all respondents, familiarity with the Bank received a mean rating of 6.8, this was significantly higher than the mean rating received in the FY '04 country survey (6.3).
 - Respondents across all stakeholder groups and geographic locations had statistically similar levels of familiarity with the Bank.
 - It should be noted that respondents' ratings of familiarity with the Bank were significantly correlated with their perceptions of the Bank's overall effectiveness in India, the Bank's ability to help achieve sustainable development results, and the Bank's relevance to India's development.






What would contribute most to economic growth




Perceived World Bank Priorities

The World Bank's Overall Effectiveness (*Indicator Question*)


- Across all respondents, ratings of the World Bank's overall effectiveness in India received a mean rating of 6.1; this was significantly higher than the mean overall effectiveness rating received in the FY '04 country survey (5.8).
 - Respondents from Assam and Himachal Pradesh gave the highest ratings for the Bank's overall effectiveness in India whereas respondents from Andhra Pradesh gave significantly lower ratings.
 - Respondents across all stakeholder groups had statistically similar ratings for the Bank's overall effectiveness in India.


- Respondents across all stakeholder groups and geographic locations gave statistically similar ratings for the World Bank helping to achieve sustainable development results in India.

Staff Preparedness


- Respondents from the private sector/financial sector/private banks gave the highest ratings for the extent to which the Bank's staff is well prepared to help India solve its most complicated development challenges whereas respondents from the media gave significantly lower ratings.

Greatest Value


- Over two-thirds of all respondents in the FY '04 country survey indicated that providing loans to finance development projects was the greatest value of the Bank (68%).

Greatest Weakness


- Respondents in the FY '04 country survey indicated that the Bank's greatest weaknesses were imposing technocratic solutions without regard to political realities (24%), not considering alternative policy options (21%), and being too bureaucratic in its operational policies and procedures (20%).

Specific Areas of Effectiveness


- Consultants on Bank-supported projects/PMUs had the highest ratings for the Bank's effectiveness at poverty reduction, health, rural development/agriculture development/food security, and governance/anti-corruption/law and justice whereas respondents from private foundations/NGOs/CBOs had significantly lower ratings for the Bank's effectiveness in these areas. Respondents across all stakeholder groups had statistically similar ratings for the Banks effectiveness in the other areas of development.

- Respondents in this year's country survey gave significantly *lower* ratings for the Bank's effectiveness in energy, economic growth, and private sector development compared to respondents in the FY '04 country survey.

Drivers of Effectiveness


To determine the key drivers of respondents' ratings of the Bank's overall effectiveness and ratings of its ability to help achieve sustainable development results in India, bivariate correlational analyses were conducted using respondents' ratings of the eighteen specific areas of effectiveness.

Correlational analyses, however, are not able to tell us exactly what is causing respondents' ratings of the Bank's overall effectiveness or ratings of its ability to help achieve sustainable development results. Rather, these analyses tell us that as ratings of effectiveness in one area increase, respondents' ratings of the Bank's overall effectiveness increase, or as ratings of effectiveness in one area increase, ratings of the Bank's ability to help achieve sustainable development results increase. Thus, it can be inferred that respondents' perceptions of effectiveness in one specific area are related to, or drive, respondents' perceptions of the Bank's overall effectiveness or perceptions of the Bank's ability to help achieve sustainable development results.

- **Overall Effectiveness:** Those specific areas with the highest Pearson Product-Moment correlations were determined to be the most closely related to perceptions of the Bank's overall effectiveness, suggesting that ratings of effectiveness in those specific areas are drivers of perceptions of the Bank's overall effectiveness in India. The areas determined to be key drivers from these analyses were:
 - The Bank's effectiveness at environment;
 - The Bank's effectiveness at poverty reduction;
 - The Bank's effectiveness at urban development; and
 - The Bank's effectiveness at health.
 - Of note, the areas determined to be key drivers of the Bank's overall effectiveness in the FY '04 country survey were:
 - The Bank's effectiveness in helping to reduce poverty;
 - The Bank's effectiveness in helping to bring about economic growth;
 - The Bank's effectiveness in empowering communities to access basic services in rural areas; and
 - The Bank's effectiveness in improving access of the poor to health services.
- **Achieving Sustainable Development Results:** Those specific areas with the highest Pearson Product-Moment correlations were determined to be the most closely related to perceptions of the Bank's ability to help achieve sustainable development results in India, suggesting that ratings of effectiveness in those specific areas are drivers of perceptions of the Bank's ability to help achieve sustainable development results. The areas determined to be key drivers from these analyses were:
 - The Bank's effectiveness at environment; and
 - The Bank's effectiveness at rural development/ agricultural development/ food security.


Knowledge: Frequency of Use


Knowledge: Meeting India's Knowledge Needs (*Indicator Question*)


Knowledge: Focusing Bank Research

Knowledge: Effectiveness


- Respondents from academia/research institutes had the highest ratings for the effectiveness of the Bank's knowledge and research to raise awareness of a particular topic whereas respondents from the media had significantly lower ratings.
- Consultants on Bank-supported projects/PMUs and respondents from academia/research institutes had the highest ratings for the effectiveness of the Bank's knowledge and research to enhance knowledge and/or skills whereas respondents from private foundations/NGOs/CBOs had significantly lower ratings.
- Consultants on Bank-supported projects/PMUs and respondents from academia/research institutes had the highest ratings for the effectiveness of the Bank's knowledge and research to contribute to good policy making whereas respondents from the media had significantly lower ratings.
- Consultants on Bank-supported projects/PMUs had the highest ratings for the effectiveness of the Bank's knowledge and research to provide support for program implementation whereas respondents from private foundations/NGOs/CBOs and the media had significantly lower ratings.


- Respondents in this year's country survey had significantly *lower* ratings for the extent to which the Bank's knowledge is adaptable to India's challenges compared to respondents from the FY '04 country survey (6.1).
- Respondents from academia/research institutes had the highest ratings that the Bank's knowledge and research is timely whereas respondents from the media had significantly lower ratings.
- Respondents from academia/research institutes had the highest ratings that the Bank's knowledge and research is accessible whereas respondents from the media, private foundations/NGOs/CBOs, and other organizations had significantly lower ratings.
- Respondents from academia/research institutes had the highest ratings that the Bank's knowledge/research is a source of relevant information on global good practices whereas respondents from private foundations/NGOs/CBOs had significantly lower ratings.
- Consultants on Bank-supported projects/PMUs had the highest ratings that the Bank's knowledge and research is adequately disseminated whereas respondents from private foundations/NGOs/CBOs and the media had significantly lower ratings.
- Consultants on Bank-supported projects/PMUs and respondents from bilateral or multilateral agencies had the highest ratings that the Bank's knowledge and research is adaptable to India's specific challenges whereas respondents from private foundations/NGOs/CBOs and the media had significantly lower ratings.


- Respondents across all stakeholder groups and geographic locations had statistically similar ratings for the significance of the contribution that the World Bank's knowledge and research make to development results in India.


Knowledge: Technical Quality (*Indicator Question*)

- Respondents across all stakeholder groups and geographic locations had statistically similar ratings for the technical quality of the World Bank's knowledge and research.



Knowledge: Linkage to Non-Bank Expertise




Instruments: Most Effective


Instruments: Least Effective

The World Bank's Work in India


- Respondents in this year's country survey had statistically similar levels of agreement regarding these aspects of the Bank's work in India compared to respondents from the FY '04 country survey.
- Respondents from Assam had the highest levels of agreement that the World Bank's work is aligned with what I consider the development priorities for India, that the World Bank supports programs and strategies that are realistic for India, and that the World Bank treats clients and stakeholders in India whereas respondents from Andhra Pradesh had significantly lower levels of agreement.
- Respondents across all stakeholder groups had statistically similar levels of agreement regarding these aspects of the Bank's work in India.

Overall Perceptions


- Respondents in this year's country survey had significantly *lower* levels of agreement that working with the World Bank increases India's institutional capacity compared to respondents from the FY '04 country survey (6.9). Respondents in both country surveys, however, had statistically similar levels of agreement that the Bank effectively monitors and evaluates its projects/programs and that the World Bank imposes reasonable conditions on its lending.
- Consultants on Bank-supported projects/PMUs had the highest levels of agreement that the World Bank disburses funds promptly and that the World Bank's teams and visits are well coordinated whereas respondents from bilateral or multilateral agencies had significantly lower levels of agreement.


The World Bank as an Effective Development Partner

- Respondents in this year's country survey had significantly *lower* ratings for the Bank's staff accessibility, but statistically similar ratings for the Bank's straightforwardness and honesty compared to respondents from the FY '04 survey (6.2 and 6.6, respectively).
- Consultants on Bank-supported projects/PMUs and respondents from private/financial sector/private banks had the highest ratings regarding the accessibility of the Bank's staff and the Bank being inclusive whereas respondents from bilateral or multilateral agencies and private foundations/NGOs/CBOs had significantly lower ratings.
- Consultants on Bank-supported projects/PMUs had the highest ratings regarding the Bank's openness whereas respondents from bilateral or multilateral agencies had significantly lower ratings.
- Consultants on Bank-supported projects/PMUs and respondents from private/financial sector/private banks had the highest ratings regarding the Bank's straightforwardness and honesty whereas respondents from bilateral or multilateral agencies had significantly lower ratings.
- Employees of ministries and respondents from private/financial sector/private banks and academia/research institutes had the highest ratings regarding the Bank's collaboration with other donors whereas consultants on Bank-supported projects/PMUs and respondents from bilateral or multilateral agencies had significantly lower ratings.



Role Significance






Collaborating in India


Collaborating with Government in India


Influencing the Global Development Agenda







Access to Information








Internet Access



Website Usage


- Respondents in this year's country survey were significantly *more* likely to have used the Bank's website compared to respondents from the FY '04 country survey.


Website Usage

- Respondents in this year's country survey were significantly *more* likely to have used the Bank's main website compared to respondents from the FY '04 country survey.




Website Evaluation




