Codes are following:

1. In this household

For the respondents who have codes 2,3,4 and 5 the interview is over.

2. In the question number 17 from the April 2008 – which is number 18 in April 2010- code number 10 is removed (Person that has permanently left the household).

3. In the question which was 48 in April 2008 and in April 2010 is number 49 (What rights you are entitle to at your work) there are some new codes.
