No one, except those who have organized the research, will see your answers. For this reason we ask that you yourself seal the completed questionnaire in the envelope.

If you don't want to answer a question, just skip it. However, your truthful participation will help researchers understand better how dangerous is the extent of AIDS in our country, how informed people are about sexually transmitted diseases, and what they think and say about this problem.

In order to fill out the questionnaire correctly, we ask you to read all questions carefully and completely. The questionnaire is different from previous ones because you fill it out yourself, in the presence of the interviewer. After each question there is a list of possible answers. Choose the answer reflecting your opinion and circle the number that corresponds to your answer. If the directions say you can give several answers, choose as many as you think are necessary.

If you don't know which answer to choose, or it is difficult to answer the question, circle code 7 or 97—"Difficult to answer."

If from the various proposed answers you choose, for example, "yes," then circle the number "1." For example:
