Description of Variables

1. *Series Number* This is a Stats SA code that identifies the series being processed. The series number for the mortality data set is 0309.
2. *Batch/Bundle Number* A unique number allocated to each batch of forms. Number of the physical batch that contains the source document. The number is written at Stats SA for administrative purpose. In the 1996 data set, the batch numbers range from 1 to 3880.
3. *Province of Residence* This is the province of usual residence of the deceased. The codes allocated to the provinces are as follows:
 - 01 - Western Cape
 - 02 - Eastern Cape
 - 03 - Northern Cape
 - 04 - Free State
 - 05 - KwaZulu-Natal
 - 06 - North West
 - 07 - Gauteng
 - 08 - Mpumalanga
 - 09 - Northern Province
 - 98 - Foreign
 - 99 - Unspecified
4. *Place of Residence* This is the place of usual residence of the deceased. This is a seven-digit code. The first two represent the statistical region, the third and fourth indicate the magisterial/census district within the statistical region. The fifth and sixth indicate the city or town or non-urban area within the magisterial/census district and the seventh digit is a check digit. The detailed code list for all the districts in the RSA can be found in the following publication: *Standard Code List of Areas (Twelfth edition)*, CSS Report No. 09-09-03 (1994).

5. *Province of Death* This is the province of death of the deceased. The provinces are coded as follows:
 - 01 - Western Cape
 - 02 - Eastern Cape
 - 03 - Northern Cape
 - 04 - Free State
 - 05 - KwaZulu-Natal
 - 06 - North West
 - 07 - Gauteng
 - 08 - Mpumalanga
 - 09 - Northern Province

6. *Place of Death* This is the place in which the death occurred. The complete code consists of seven digits: the first two represent the statistical region, the third and fourth indicate the magisterial /census district within the statistical region, the fifth and sixth indicate the city or town or non-urban area within the magisterial/census district and the seventh digit is a check digit. The detailed code list for all the districts in the RSA can be found in the following publication: *Standard Code List of Areas (Twelfth edition)*, CSS Report No. 09-09-03 (1994).

7. *Processing Year* This is a four-digit code that represents the year for which the death registration form was captured at Stats SA.
8. *Processing Month* This refers to the month in which the forms were received from the Department of Home Affairs. The months are numbered consecutively from 01 to 12 with January coded as 01 and December coded as 12. Forms that come after December are all added to the December process month until the decision is made to close for that registration year.
9. *Sequence Number* The sequence number of the each record/form within a batch. This number is automatically generated by the program during data capture and is used for administrative purposes. In the 1996 data set, the numbers ranged from 1 to 340.
10. *Birth Day* Day of birth of the deceased.
11. *Birth Month* Month of birth of the deceased. The months are numbered consecutively from 01 to 12 with January coded as 01 and December coded as 12.
12. *Birth Year* Year of birth of the deceased expressed as a four-digit figure. For example, 1994,1995, etc.
13. *Death Day* Day of death of deceased. The numbers range from 1 to 31.
14. *Death Month* Month of death of the deceased. The months are numbered consecutively from 01 to 12 with January coded as 01 and December coded as 12.
15. *Death Year* Year of death of the deceased expressed as a four-digit-figure. For example, 1994, 1995, etc.

- 16. Age in days* Age of the deceased at death. Depending on the number of days in that month, the valid values for this field is always one day short of that total number of days within that month. For example, January has 31 days; the valid values for age in days for January can only be 01-30 days.
- 17. Age in months* Age of the deceased at death in months. Age in months can be 01-11.
- 18. Age in years* Age of the deceased at death (in years). Age ranges from 1 to 130.
- Note** Age is a derived variable. It is calculated in completed years for those aged more than 11 months and older, in completed months for those older 30 days but less than 12 months, in completed days for those aged less than one month but older than 23 hours and in hours for those less than 24 hours.
- 19. Gender* The sex of the deceased
 1 - Male
 2 - Female
 3 - Unspecified
- 20. Population Group** Population group of the deceased. As this variable is not currently used, only '9' has been placed in this field.
- 21. Marital Status* The marital status of the deceased at time of death.
 1 - Never married
 2 - Married
 3 - Living as married
 4 - Widow/Widower
 5 - Married by Religious Law
 6 - Divorced
 7 - Married by Customary Law
 9 - Unspecified

22. Occupation

Usual occupation of the deceased at time of death. The coding is based on the 1968 International Standard Classification of Occupations (ISCO). Also published by the CSS under the title, Standard Classification of Occupation, No. 09-90-01. The ISCO codes are grouped into the following major categories:

23. Cause of Death (ICD-9)

This is the cause of death for the deceased. The coding is based on the ninth version of the International Classification of Disease (ICD- 9) as published in *Manual of the International Classification of Diseases, Injuries and Causes of Death*. An abridged version is also published by the CSS under the title, *Statistical Classification of Diseases, Injuries and Causes of Death (No. 07-03-15)*. The ICD-9 codes are grouped into the following major categories:

24. *Nature of Injury (ICD-9)*

Refers to the nature of the external cause of death. The following codes (based on ICD-9 groupings) are

25. Cause of Death (ICD10)

The disease or injury that initiated the events that resulted in death. This variable is coded according to ICD-10. The ICD10 chapters are given electronically in the CD. A hard copy of the abridged manual is also available from the Stats SA offices.

26. *Nature of Injury (ICD10)*

The Injury Associated with the underlying cause of death. The code have been derived from ICD10 codes by the data capture team as follows:

27. *Death Certificate*

This refers to whether the death was certified by a Doctor or not.
1 - Doctor

2 – Other

28. *Institution* This refers to the place of death
1 - Hospital/ Clinic/ Maternity home
2 - Not in hospital

29. *Registration year* Refers to the year in which the death was reported or registered at the Department of Home Affairs

Other variables that are not part of the data set but can be derived from the placename code

1. *Type of residence* The type of residence describes whether the deceased resided in urban or non-urban residence. A deceased resident is defined as urban if the digit number 5 and 6 of the placename code are '99'. The user should be careful not to include foreign magisterial districts as urban districts. The code for foreign districts should be specified as excluded from the type of residence variable '9999990'. When extracting the cases for non-urban the code for foreign should be explicitly excluded. It is also important to take out the unspecified deaths coded '0000000'. The exclusion of foreign and unspecified districts should be done first before the data is separated into urban and non-urban.

2. *Magisterial district of Residence* This is the magisterial district of usual place of residence of the deceased. The magisterial district code is derived from the placename code by taking the first 4 digits. The full set of magisterial codes is provided electronically.
