I. Objectives

This survey was designed to assist the World Bank Group (WBG) in gaining a better understanding of how stakeholders in China perceive the WBG. The survey explored:

- *General Issues Facing China*
- *Overall Attitudes toward the World Bank Group*
- *World Bank Group's Effectiveness and Results*
- *The World Bank Group's Knowledge Work and Activities*
- *Working with the World Bank Group*
- *The Future Role of the World Bank Group in China*
- *Communication and Information Sharing*
- *Background Information*

II. Methodology

From May to July 2015, 570 stakeholders of the WBG in China were invited to provide their opinions on the WBG's work in the country by participating in a country opinion survey. Participants were drawn from ministries/ministerial departments; local governments, Project Management Units (PMUs) at both the central and local levels; the Central Bank; financial sector/banks; private sector organizations; NGOs; the regulatory agency; state-owned enterprises; bilateral/multilateral agencies; consultants/contractors working on WBG-supported projects/ programs; the media; academia/research institutes/think tanks; and other organizations. A total of 184 stakeholders participated in the survey (32% response rate).

Some respondents received and returned the questionnaires via courier. Some others completed the questionnaires online. Respondents were asked about: general issues facing China; their overall attitudes toward the WBG; the WBG's effectiveness and results; the WBG's knowledge work and activities; working with the WBG; the WBG's future role in China; and the WBG's communication and information sharing.

Every country that engages in the Country Opinion Survey must include specific indicator questions that will be aggregated for the World Bank Group's annual Corporate Scorecard. These questions are identified throughout the survey report.

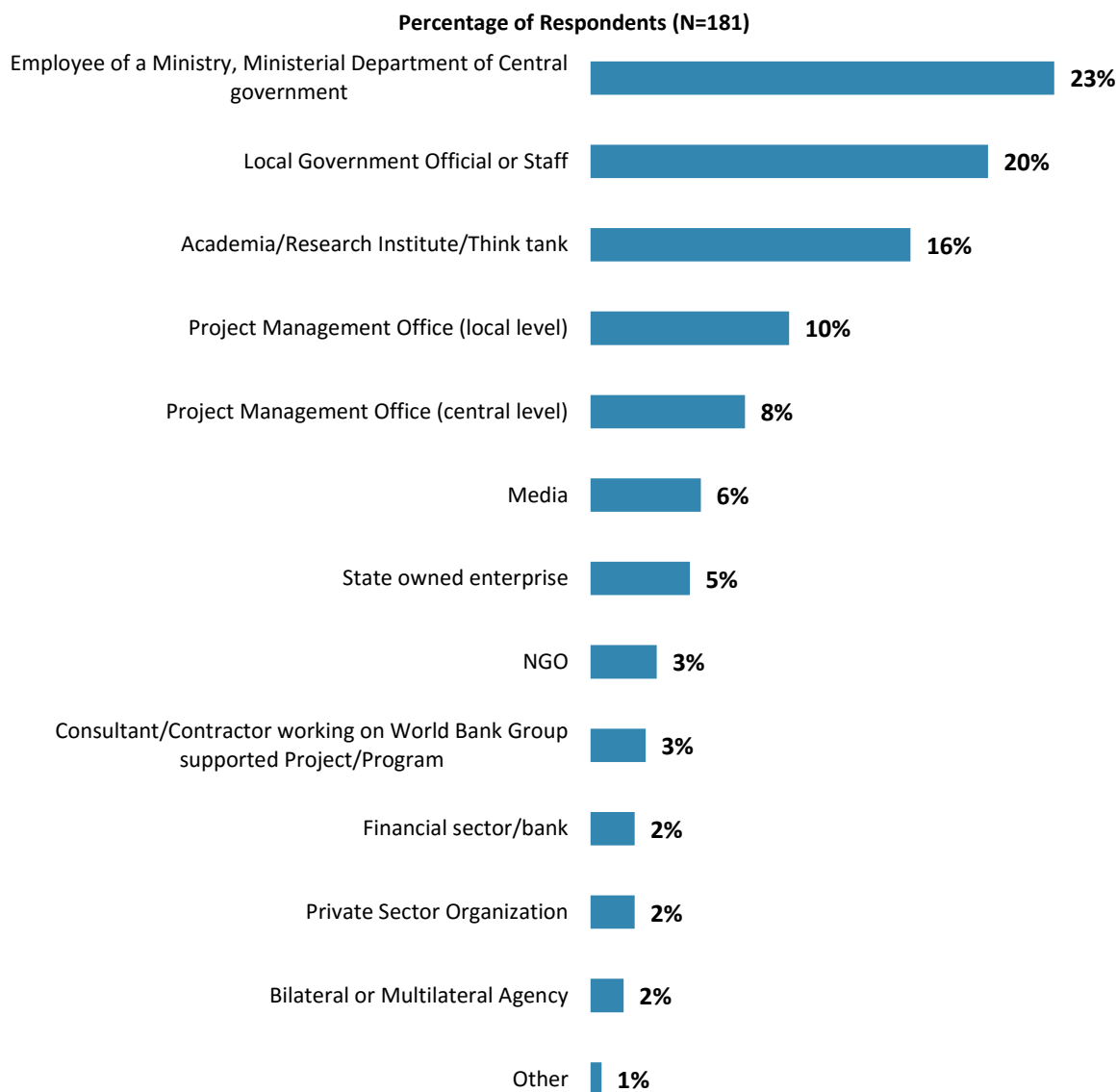
The results in this year's Country Survey were compared to those in the Country Survey conducted in FY'12 (response rate is 40%, N=207). Data were weighted to reach the same stakeholder composition in two years, which allows for year comparisons. Stakeholder groups which were not present in both fiscal years were not included in the comparison. As a result, means of the FY'15 data and the total number of respondents in both years are slightly different from those of the original data reported in appendices A, B, C, D, and F. III. Demographics of the Sample

Current Position

- For further analyses, respondents from ministries/ ministerial departments/implementation agencies, PMUs at the central and local levels, and consultants working on WBG projects were combined. Few respondents from the financial sector, banks, private sector organizations, NGOs, state-owned enterprises, bilateral/multilateral agencies were included in the “Other” category. There were no respondents from the Central Bank or the regulatory agency.

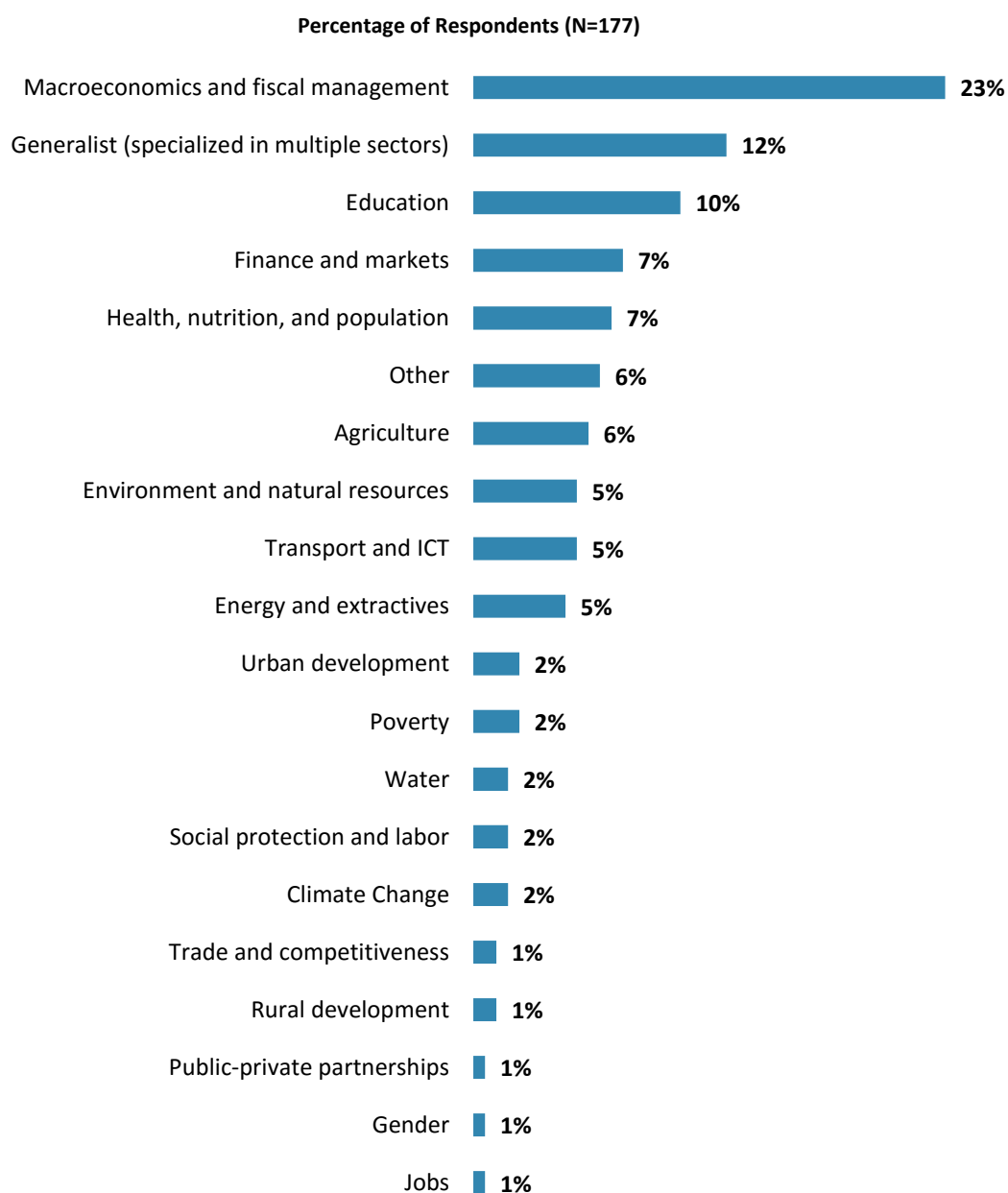


“Which of the following best describes your current position?” (Respondents chose from a list.)

Area of Primary Specialization



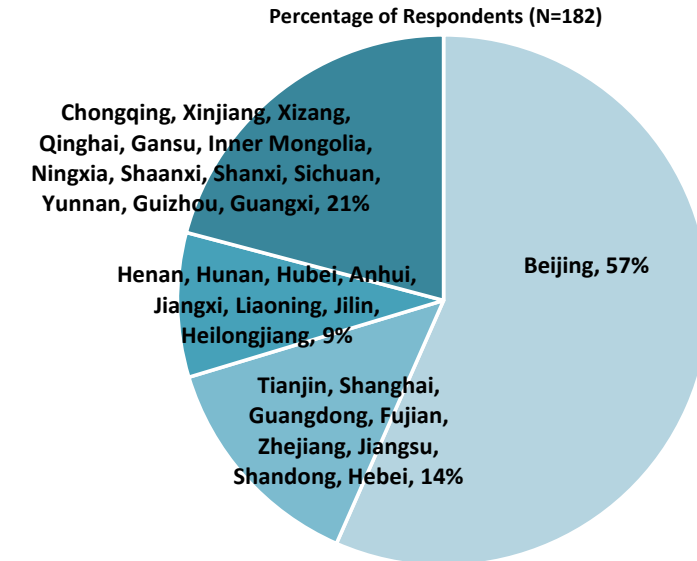

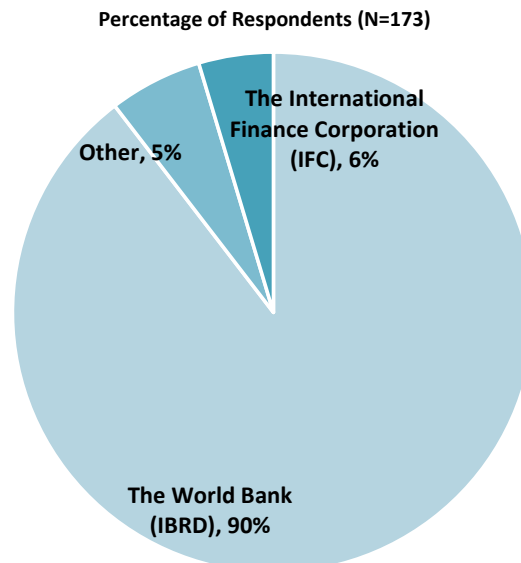
Geographic locations

Exposure to Agencies within the World Bank Group

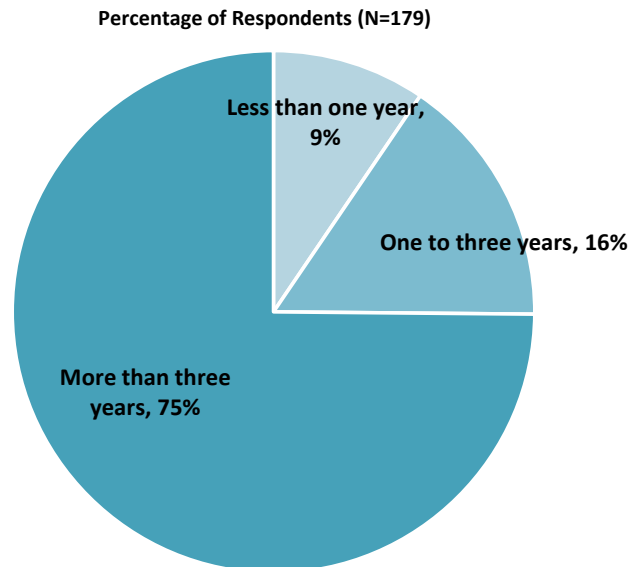


"Which of the following agencies of the World Bank Group do you primarily engage with in China?"

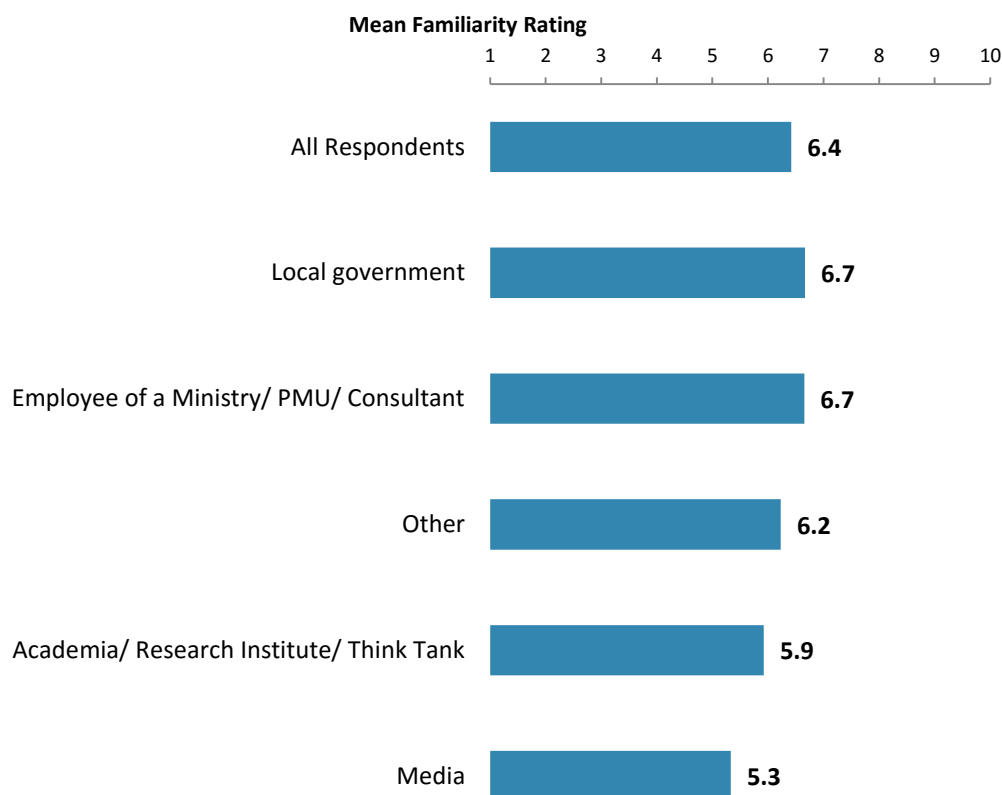
"How long have you been involved in (or a close observer of) the World Bank Group's activities?"

Familiarity with the World Bank Group

- **Year comparison:** Respondents in this year's country survey (weighted mean in FY'15 = 6.4) had significantly lower levels of familiarity with the WBG compared to respondents in the FY12 country survey (weighted mean in FY'12 = 7.0)¹.
- Respondents' levels of familiarity with the WBG were significantly, strongly correlated with their ratings of the WBG's overall effectiveness in China, and significantly, moderately correlated with the extent to which the WBG plays a relevant role in development and its work helps to achieve development results in China.



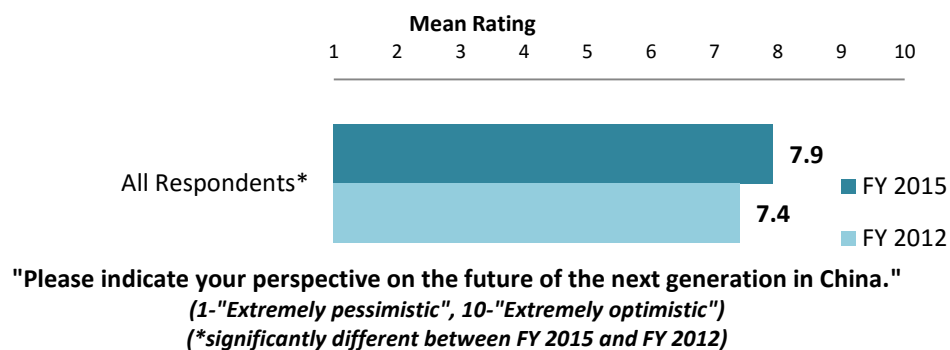
"How familiar are you with the work of the World Bank Group in China?"

Future of the Next Generation in China²



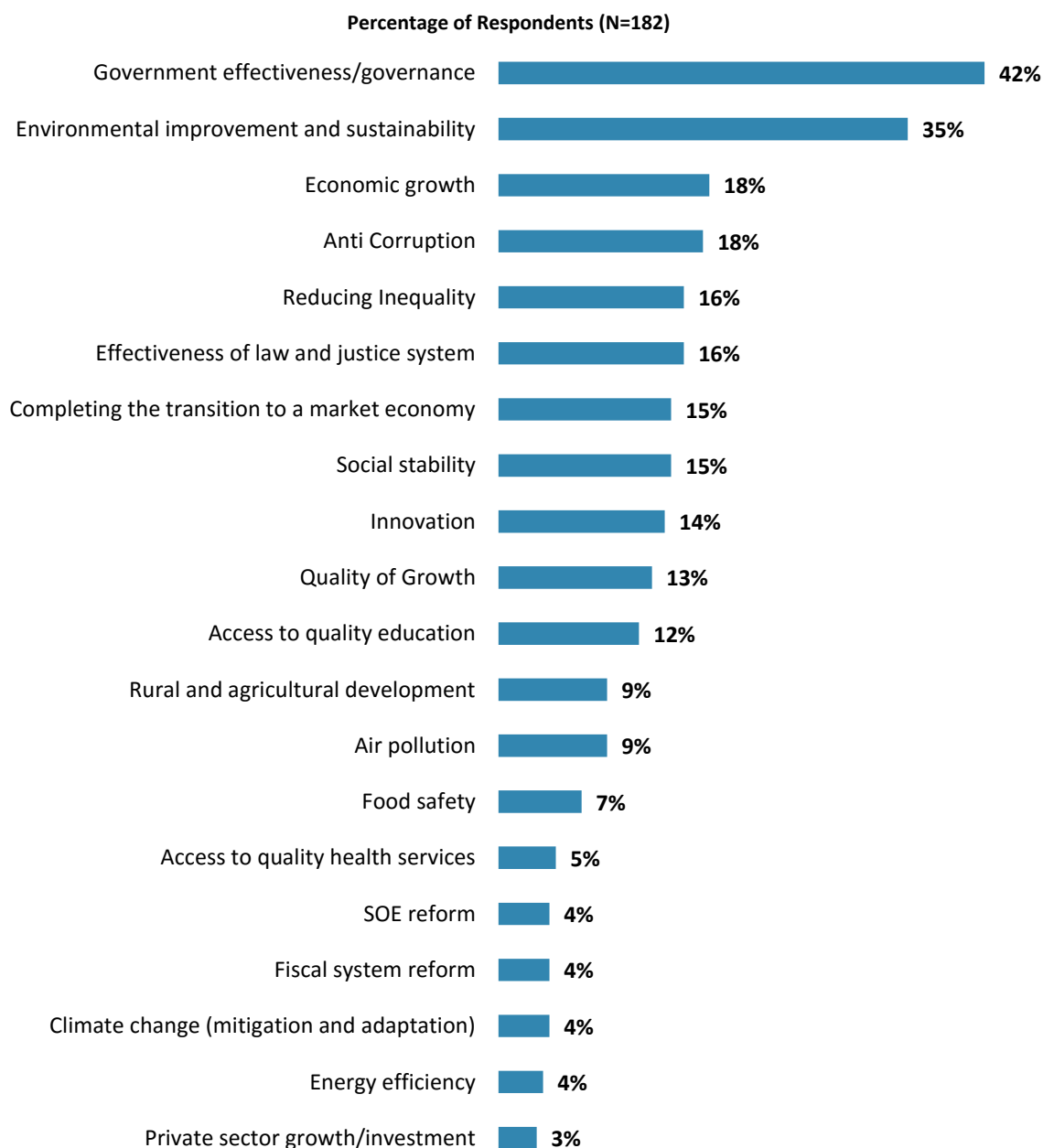

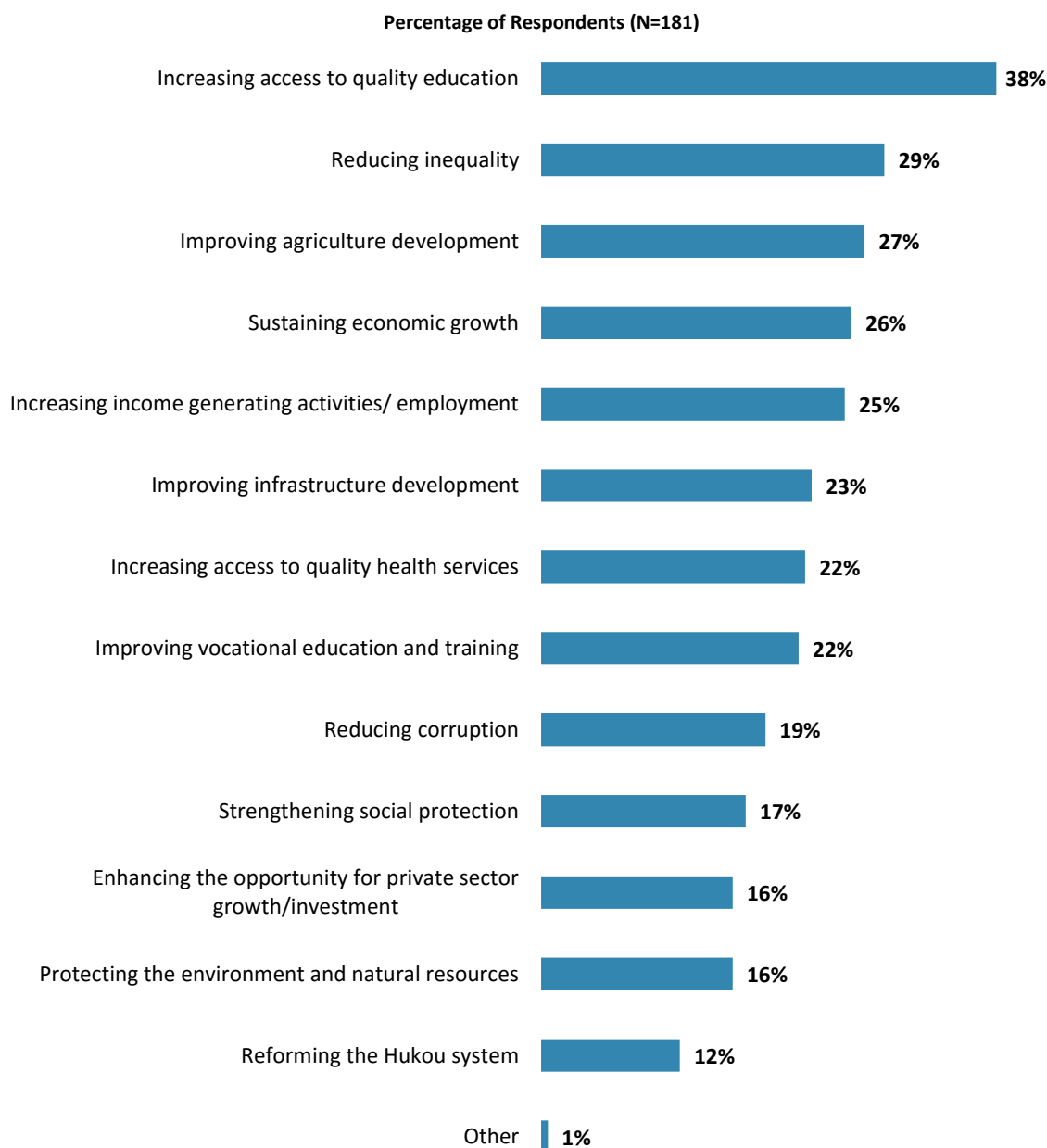
"Listed below are a number of development priorities in China. Please identify which of the following you consider the most important development priorities in China. (Choose no more than THREE)"

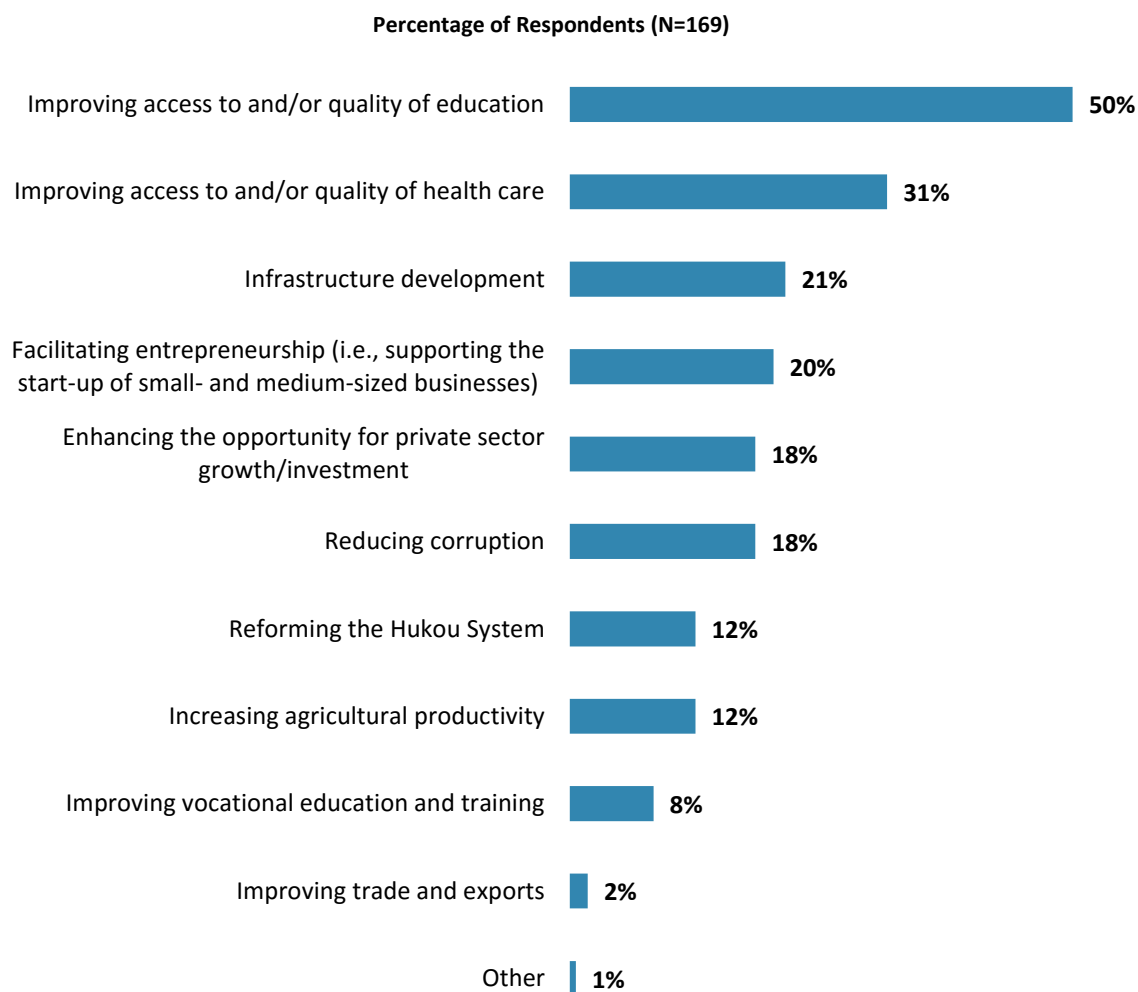

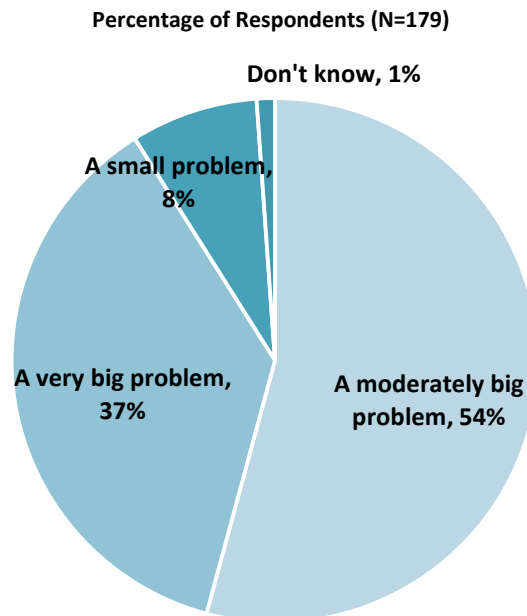

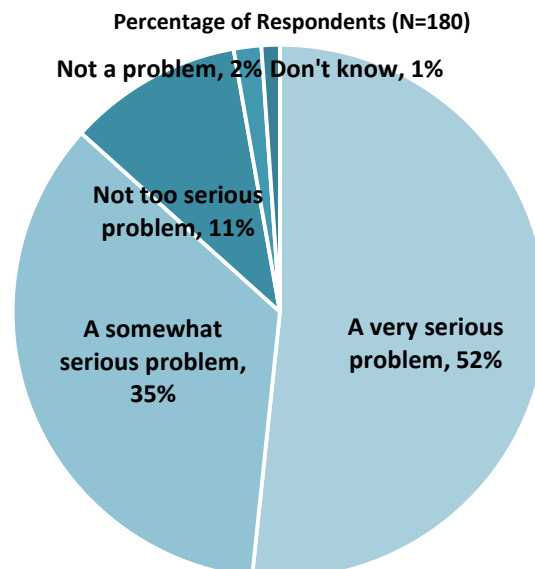

Views on Climate Change



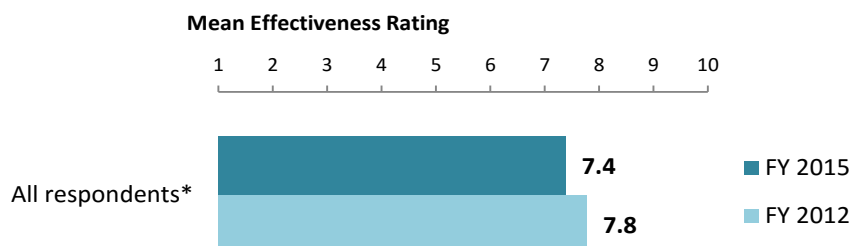

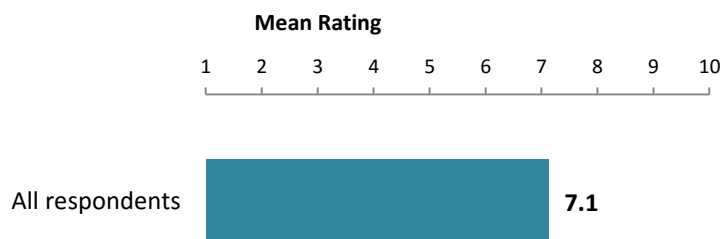

The World Bank Group's Overall Effectiveness³ (Indicator Question)



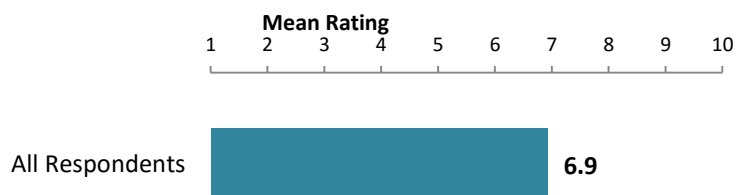
"Overall, please rate your impression of the World Bank Group's effectiveness in China."

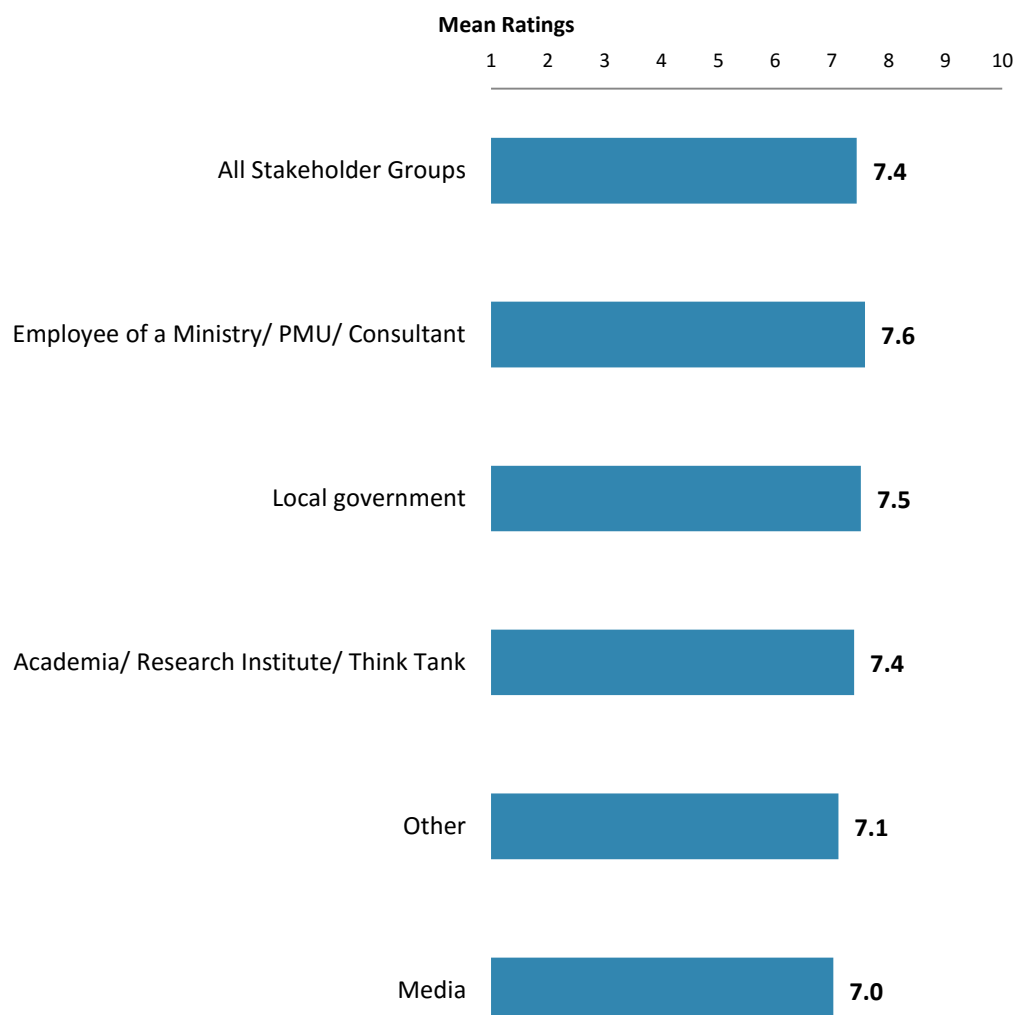

Mean Ratings for All Indicator Questions by Stakeholder Groups on a Scale from 1 to 10

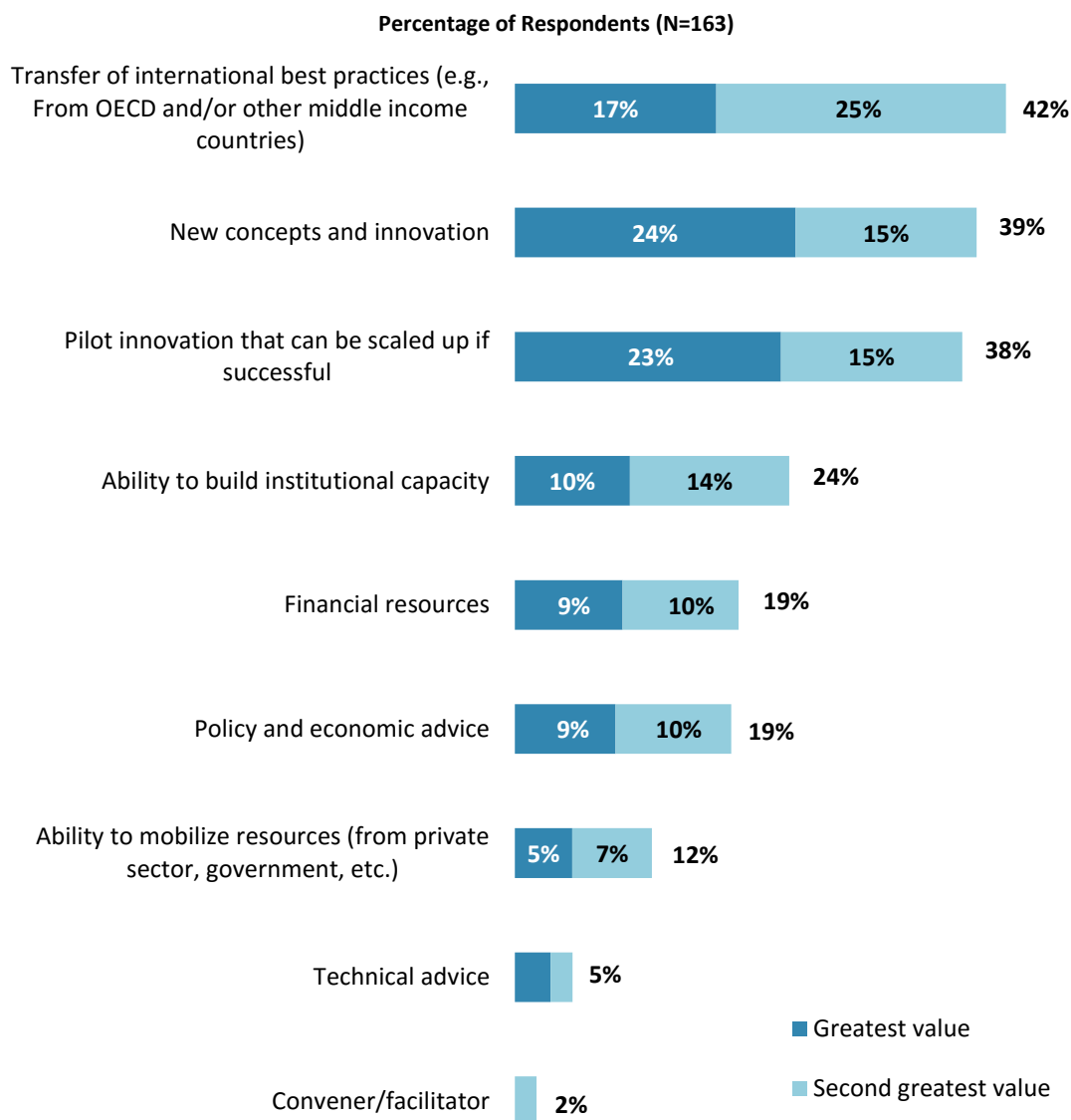

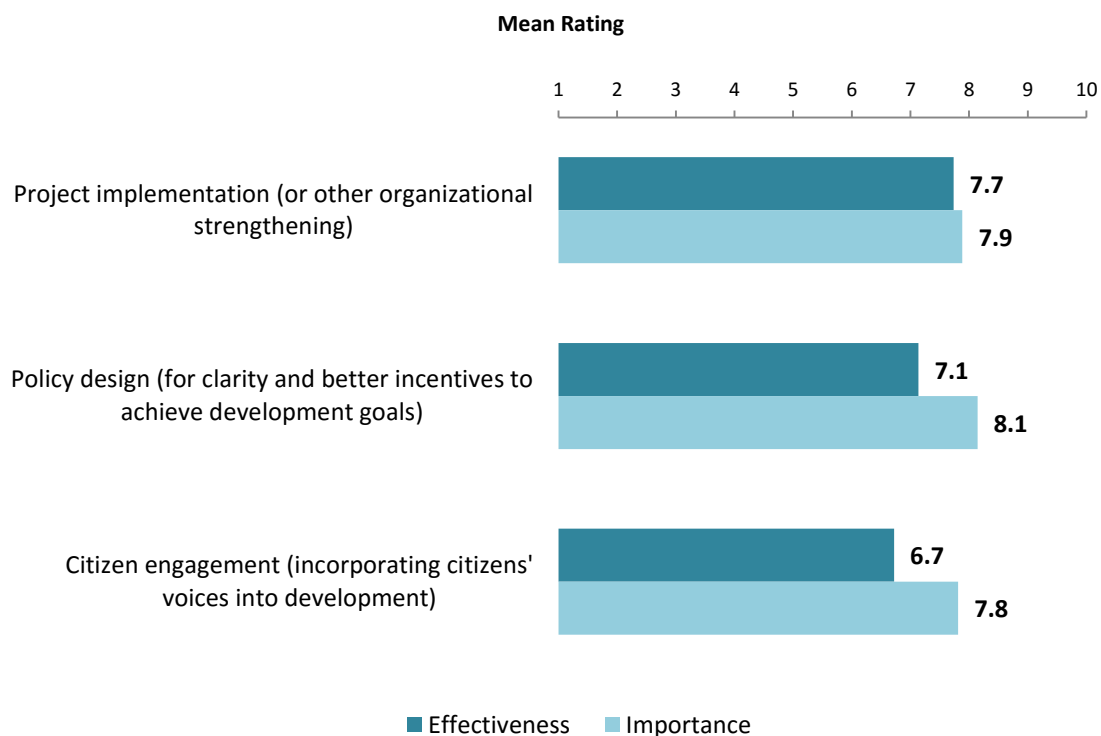


"When thinking about the World Bank Group's role, which activity do you believe is of greatest VALUE and which activity is of second greatest value in China?"

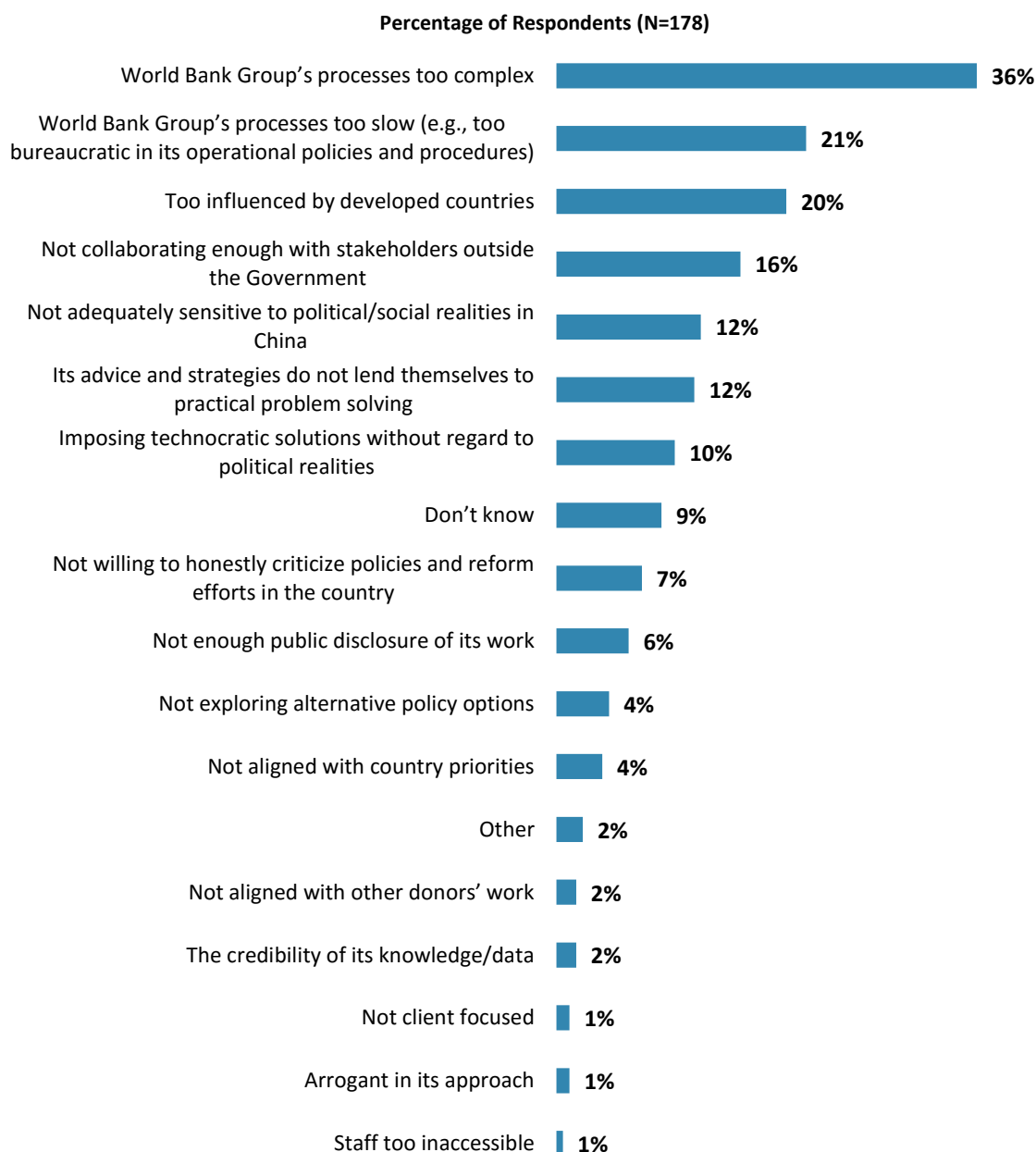

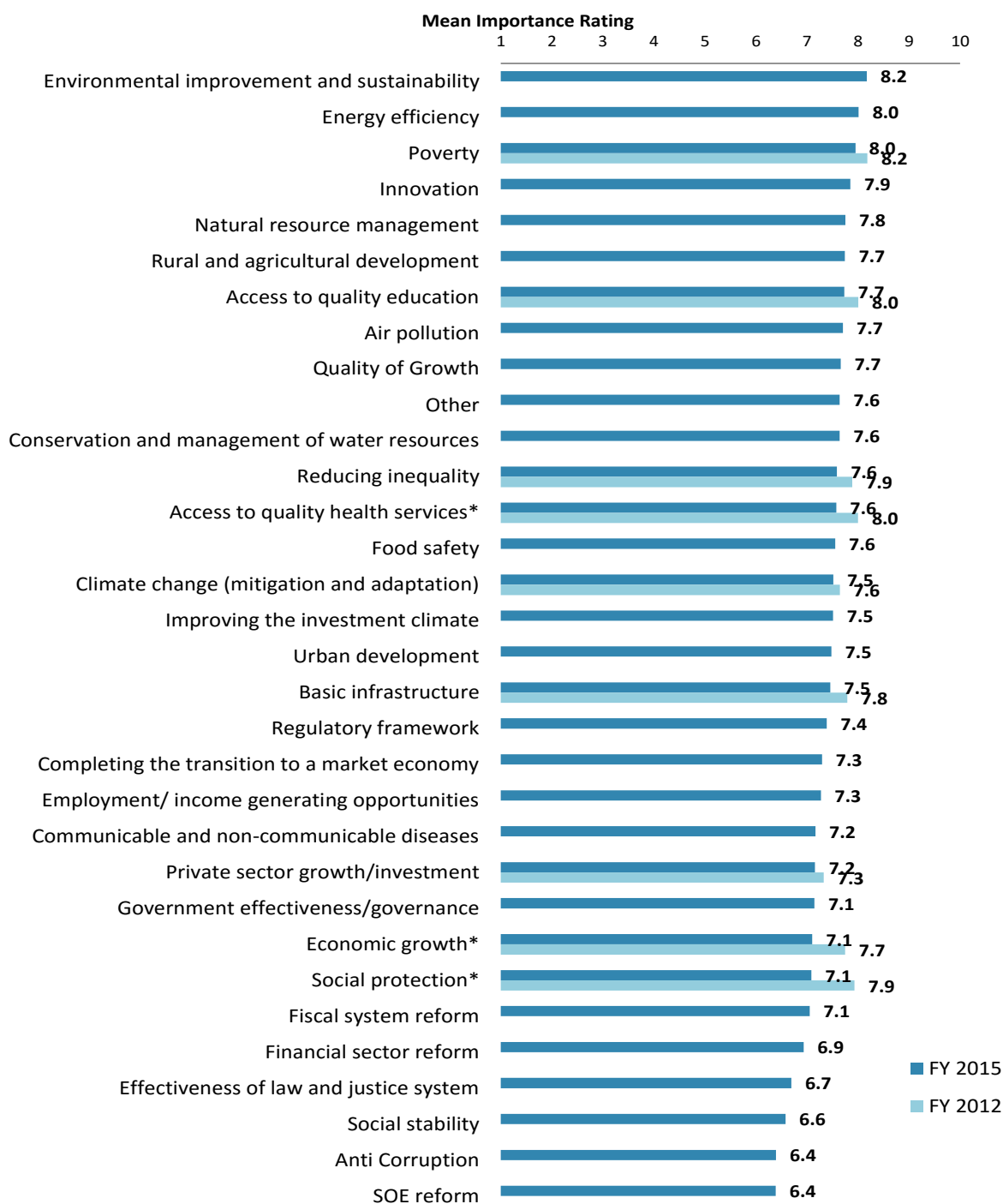

Importance of WBG's Support in Sectoral Areas: Year Comparison⁵



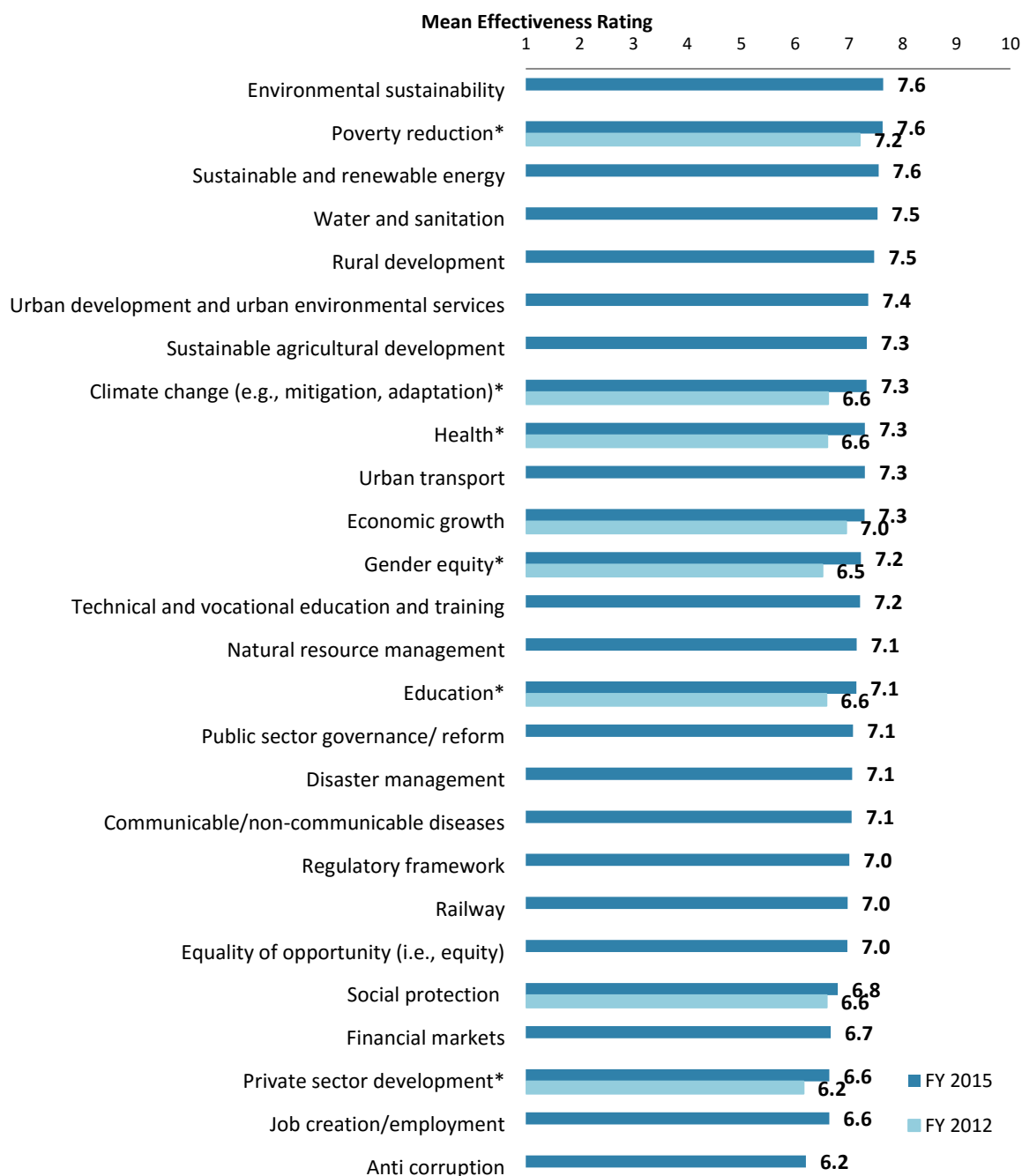

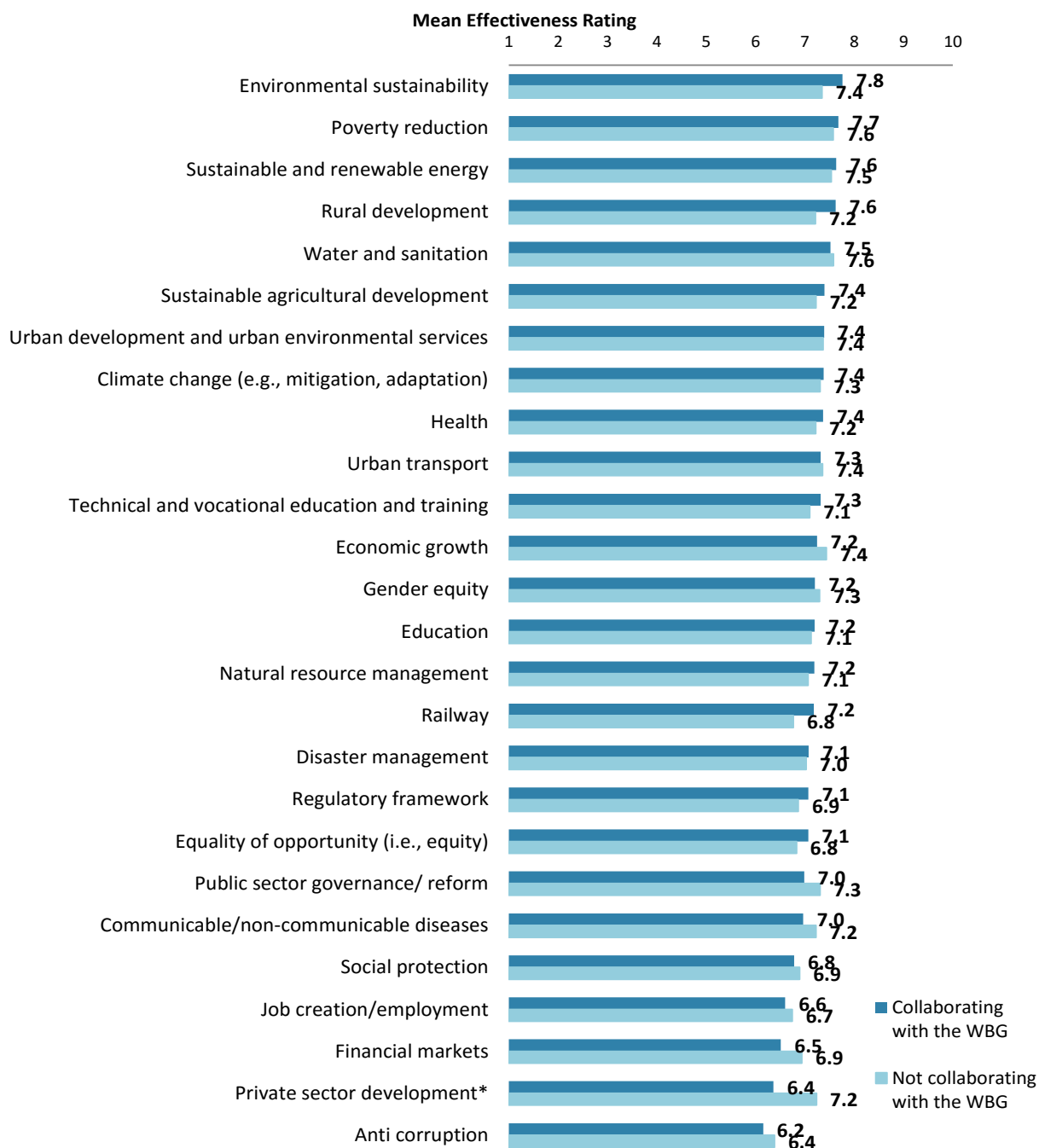

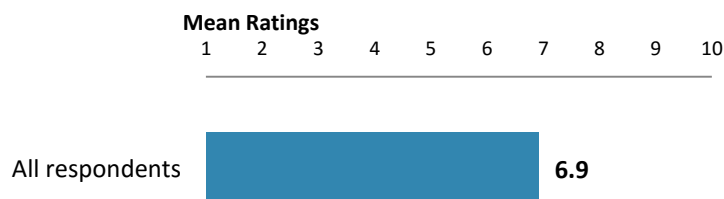

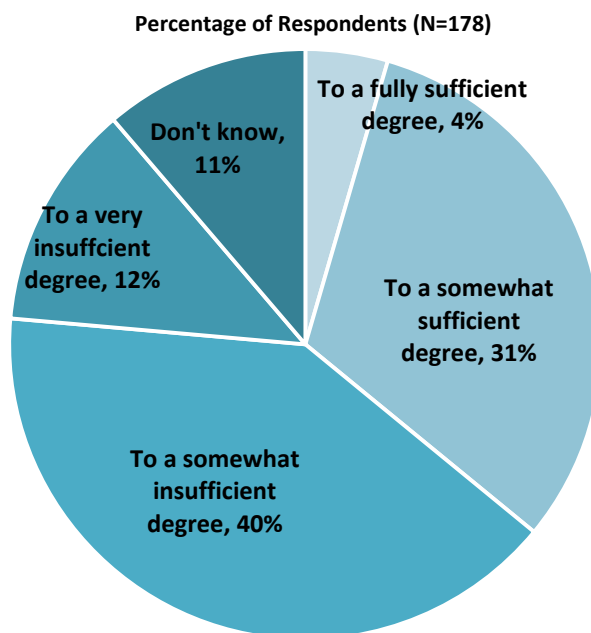

Drivers of Effectiveness

To determine the key drivers of respondents' ratings of the World Bank Group's overall effectiveness and ratings of its ability to help achieve development results in China, bivariate correlational analyses were conducted using respondents' ratings of the twenty six specific areas of effectiveness.

Correlational analyses, however, are not able to tell us exactly what is causing respondents' ratings of the World Bank Group's overall effectiveness or ratings of its ability to help achieve development results. Rather, these analyses tell us that as ratings of effectiveness in one area increase, respondents' ratings of the WBG's overall effectiveness increase, or as ratings of effectiveness in one area increase, ratings of the WBG's ability to help achieve development results increase. Thus, it can be inferred that respondents' perceptions of effectiveness in one specific area are related to, or drive, respondents' perceptions of the WBG's overall effectiveness or perceptions of the WBG's ability to help achieve development results.

- Overall Effectiveness: Those specific areas with the highest Pearson Product-Moment correlations were determined to be the most closely related to perceptions of the WBG's overall effectiveness, suggesting that ratings of effectiveness in those specific areas are drivers of perceptions of the WBG's overall effectiveness in China. The areas determined to be key drivers from these analyses were:
 - The WBG's effectiveness at regulatory framework;
 - The WBG's effectiveness at railway;
 - The WBG's effectiveness at communicable/non-communicable diseases; and
 - The WBG's effectiveness at environmental sustainability.
- Achieving Development Results: Those specific areas with the highest Pearson Product-Moment correlations were determined to be the most closely related to perceptions of the WBG's ability to help achieve development results in China, suggesting that ratings of effectiveness in those specific areas are drivers of perceptions of the WBG's ability to help achieve development results. The areas determined to be key drivers from these analyses were:
 - The WBG's effectiveness at job creation/employment;
 - The WBG's effectiveness at communicable/non-communicable diseases;
 - The WBG's effectiveness at health; and
 - The WBG's effectiveness at social protection.

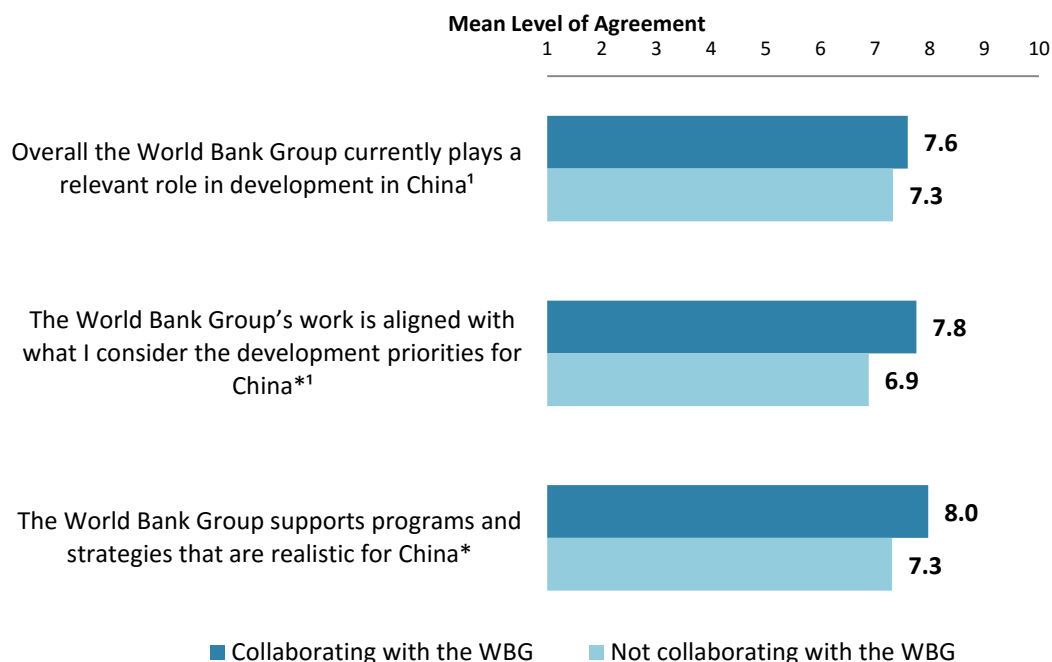

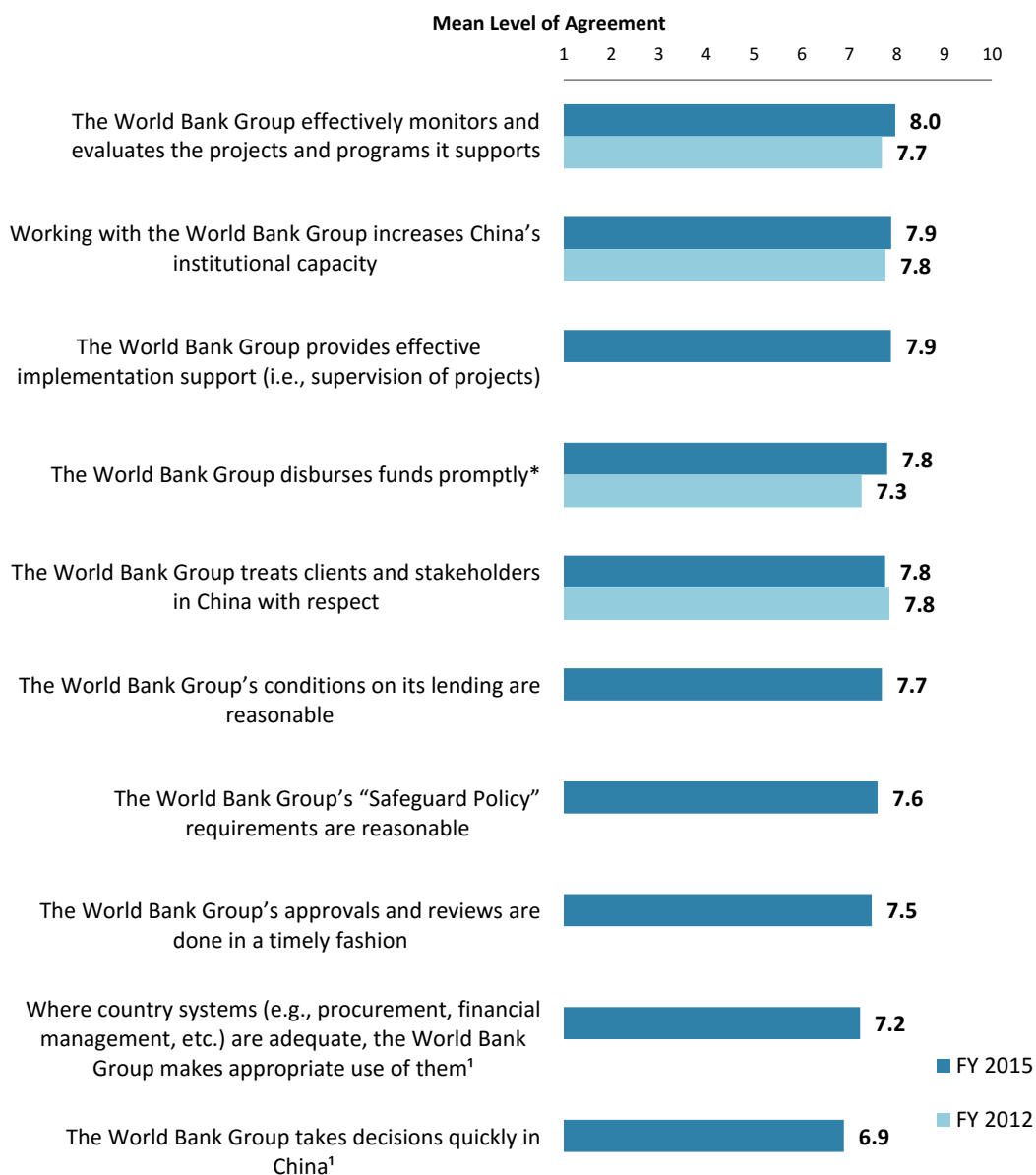

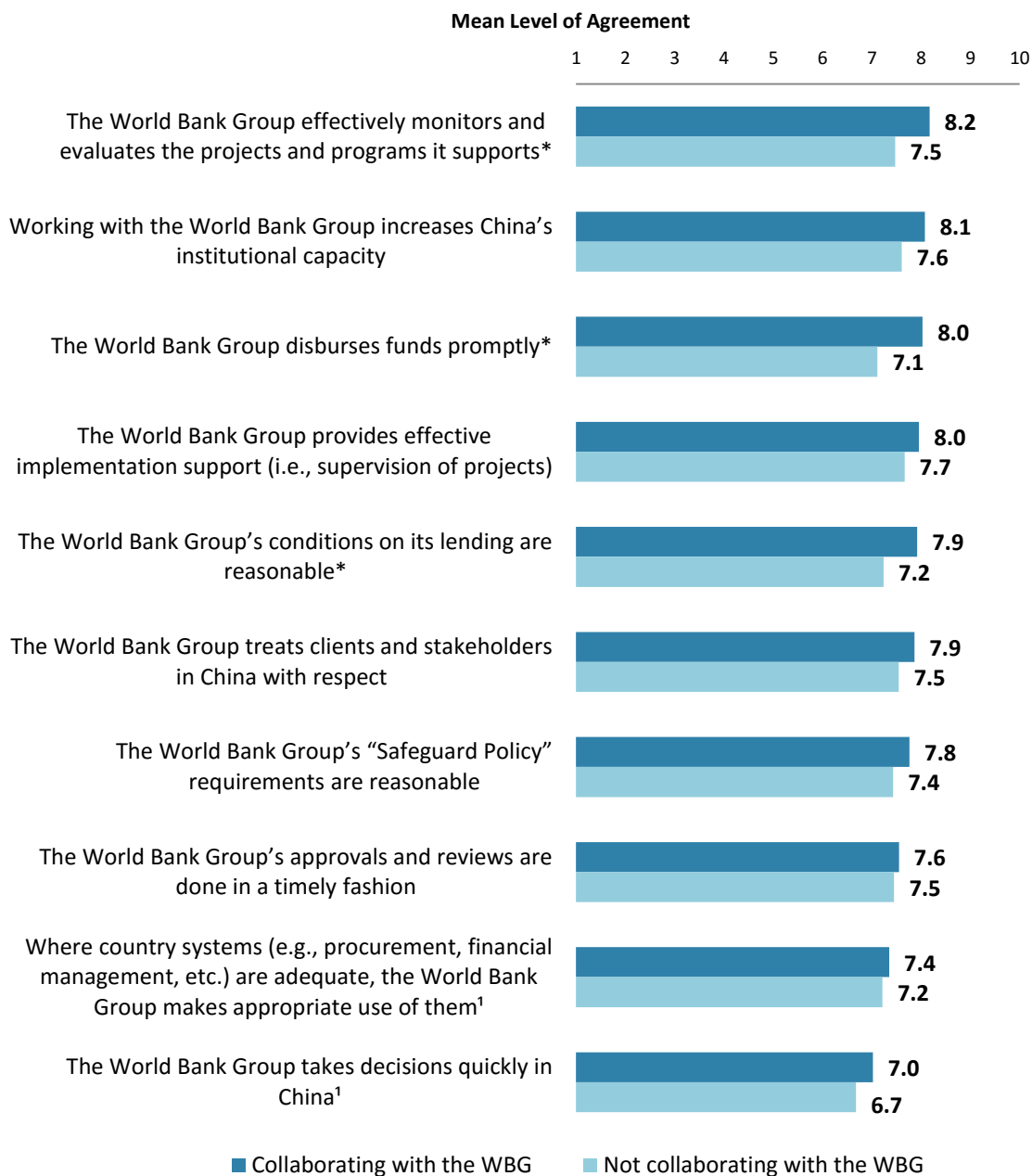
"To what extent do you agree/disagree with the following statements?"

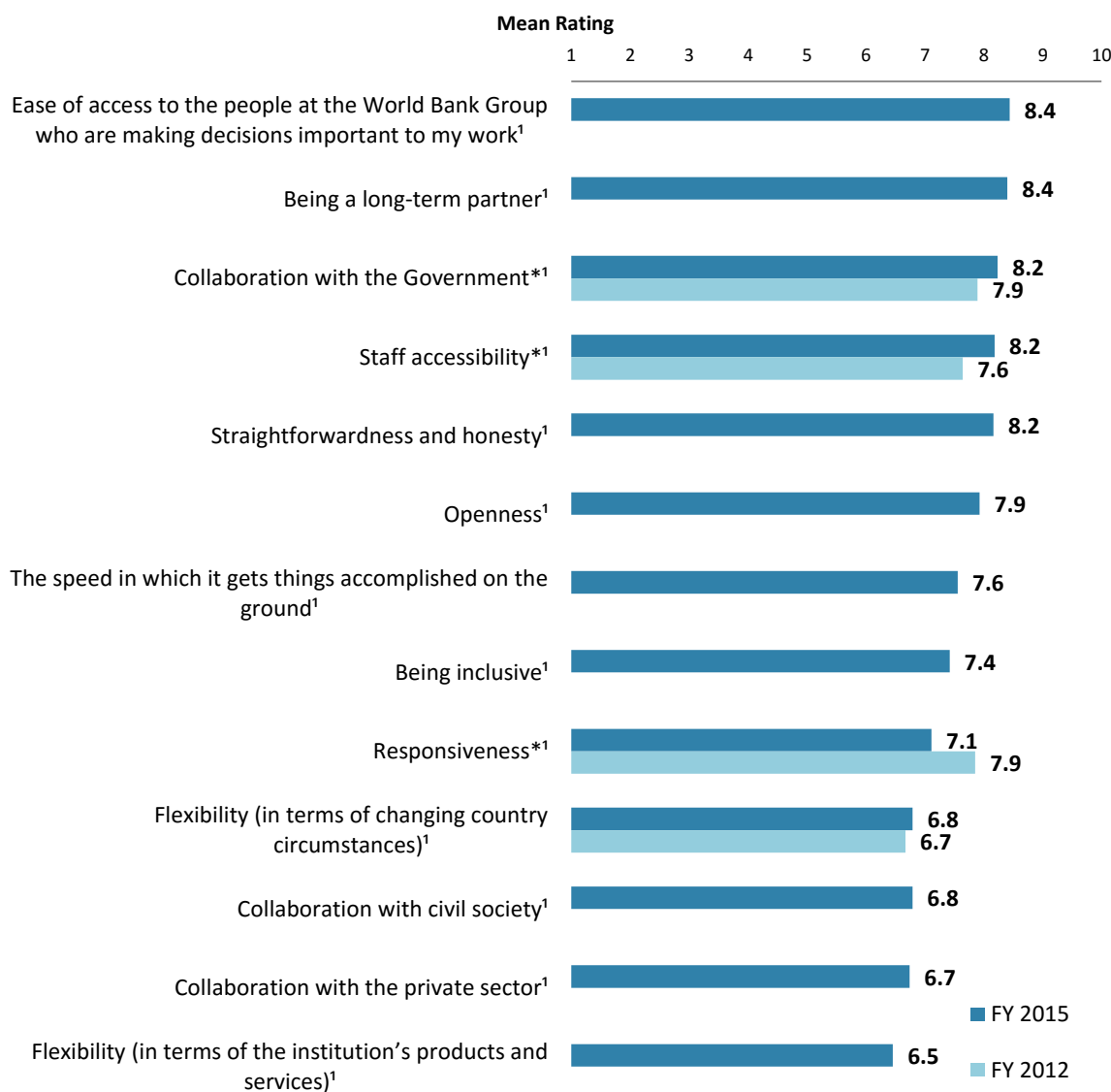

However, this year's respondents gave significantly lower ratings for the WBG's "*responsiveness*" than respondents in the FY'12.

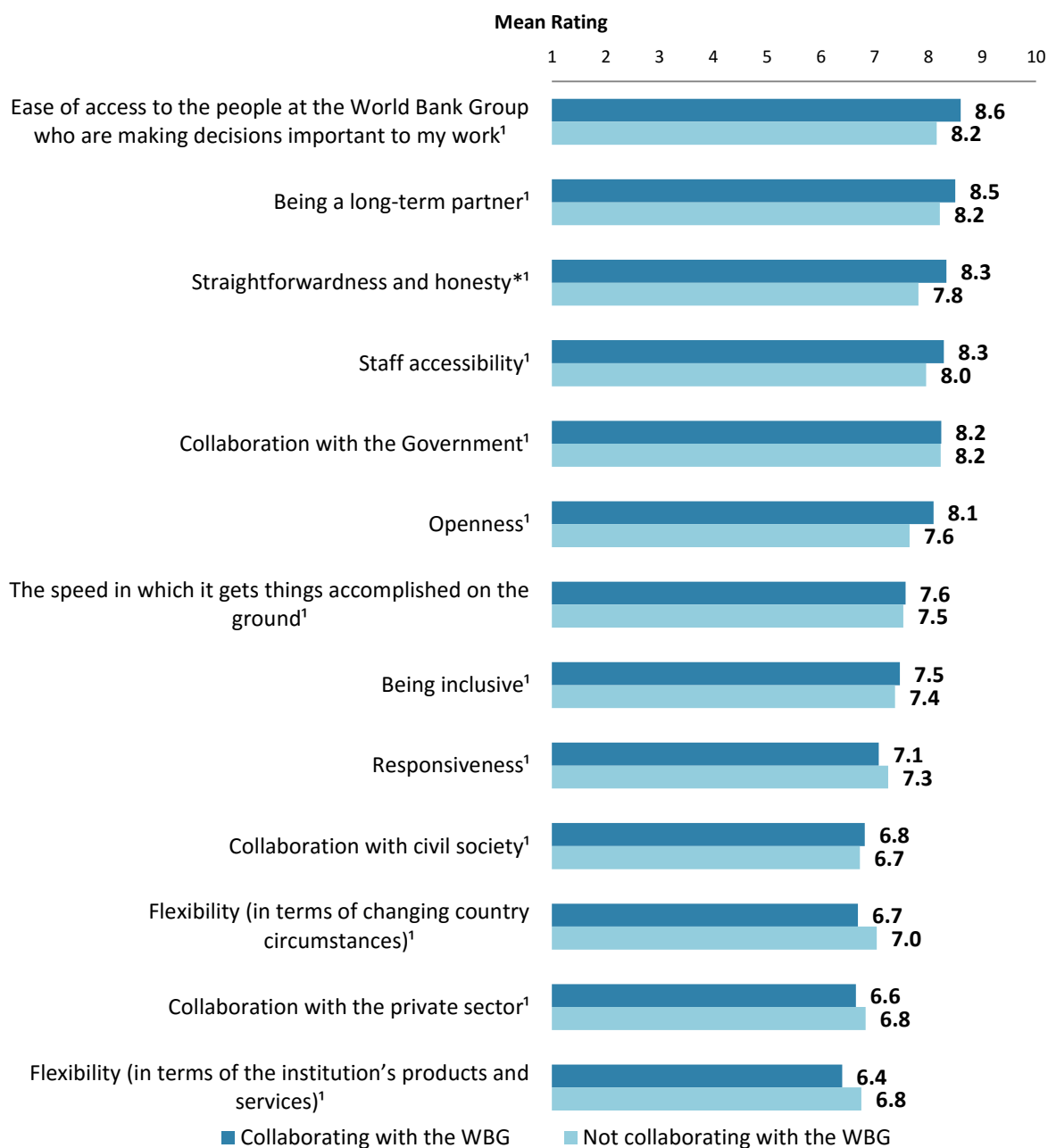

"To what extent is the World Bank Group an effective development partner in China, in terms of each of the following?" (1-"To no degree at all", 10-"To a very significant degree")

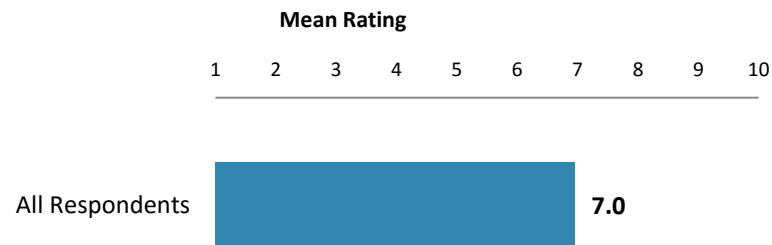

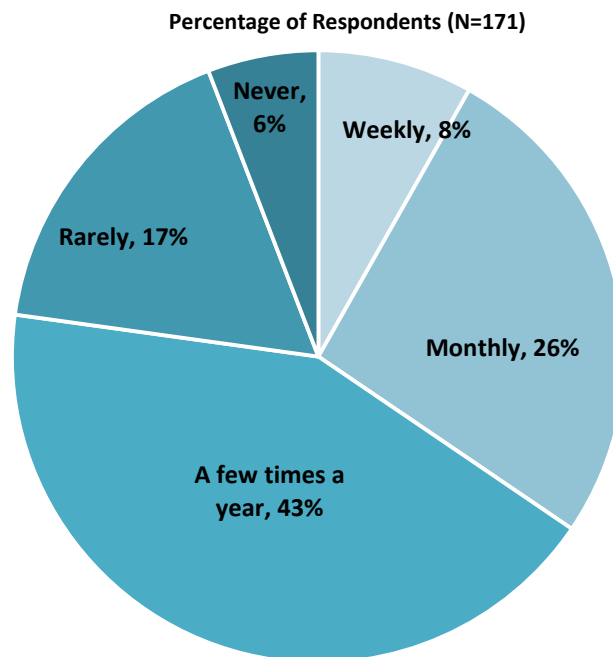


"To what extent do you believe the World Bank Group measures and corrects its work in real time in China?" (1-"To no degree at all", 10-"To a very significant degree")

Frequency of Consulting WBG Knowledge Work and Activities

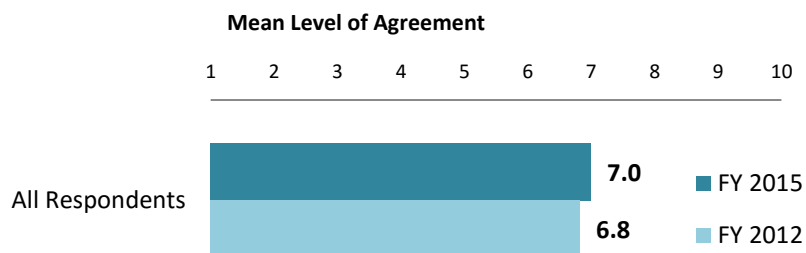


"How frequently do you consult World Bank Group's knowledge work and activities in the work you do?" (Respondents chose from a list.)



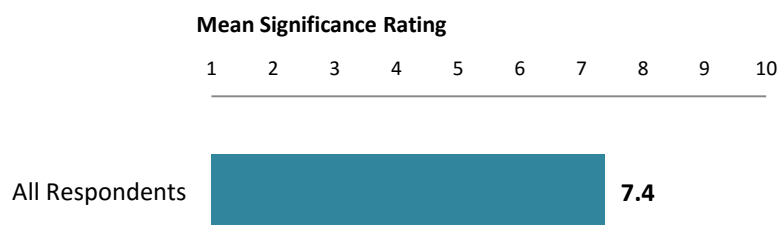

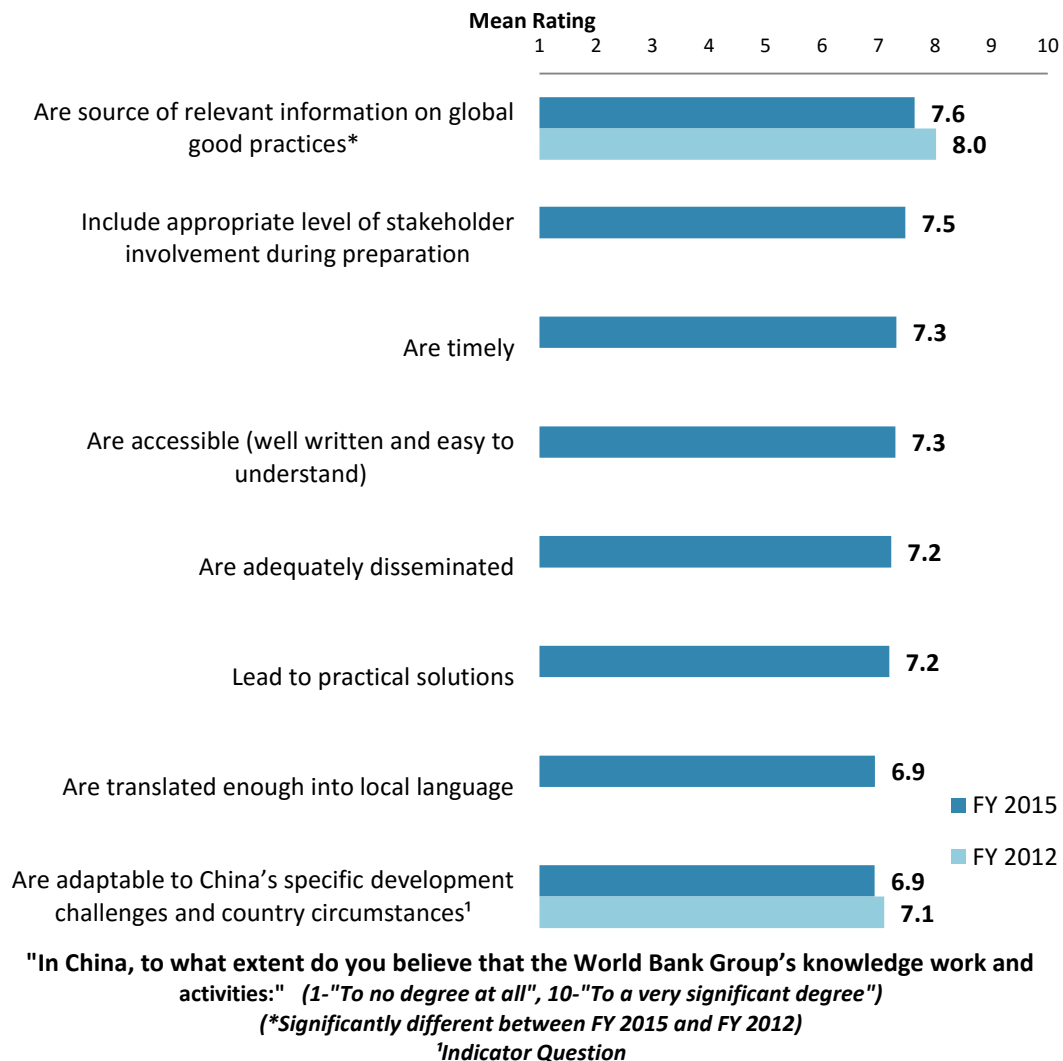

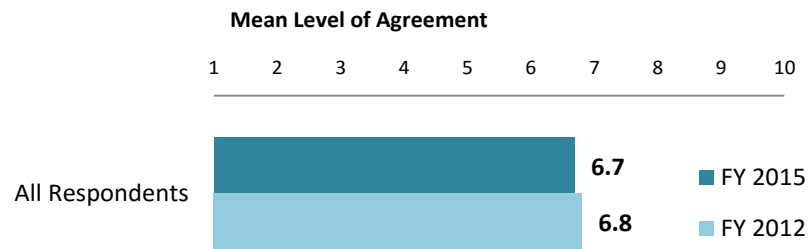

Meeting China's Needs for Financial Instruments¹³ (*Indicator Question*)



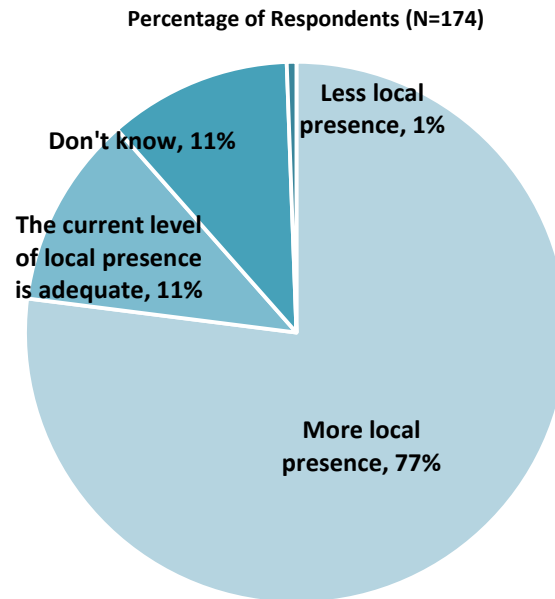
"The World Bank Group's financial instruments meet the needs of China.

The World Bank Group's Local Presence in China



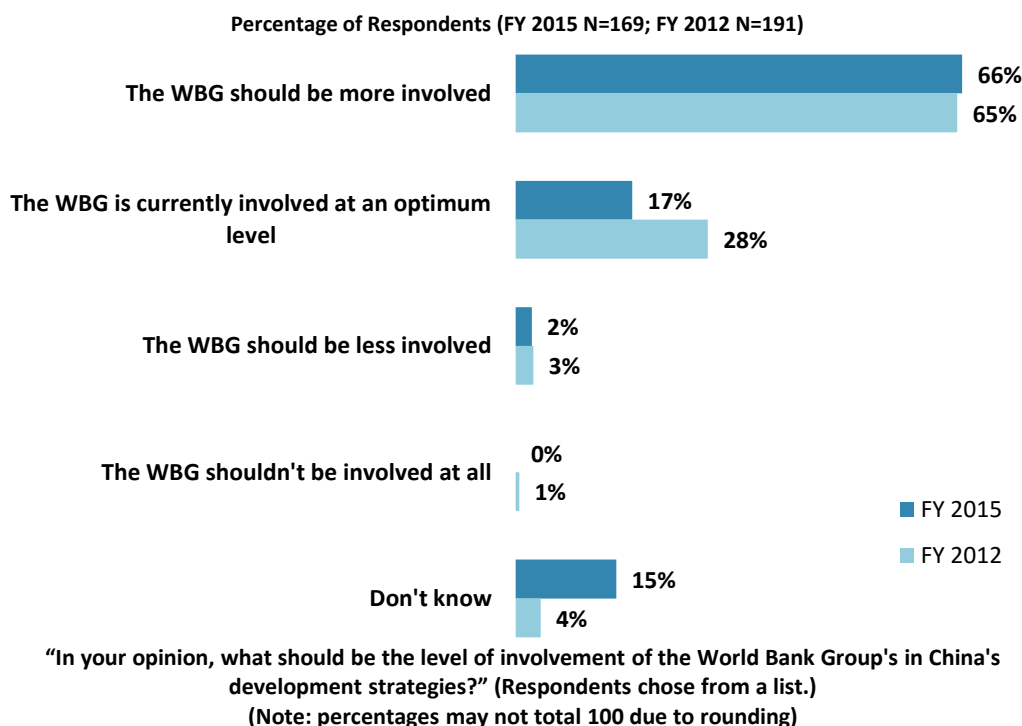
"To be a more effective development partner in China, do you believe that the World Bank Group should have...?" (Respondents chose from a list.)



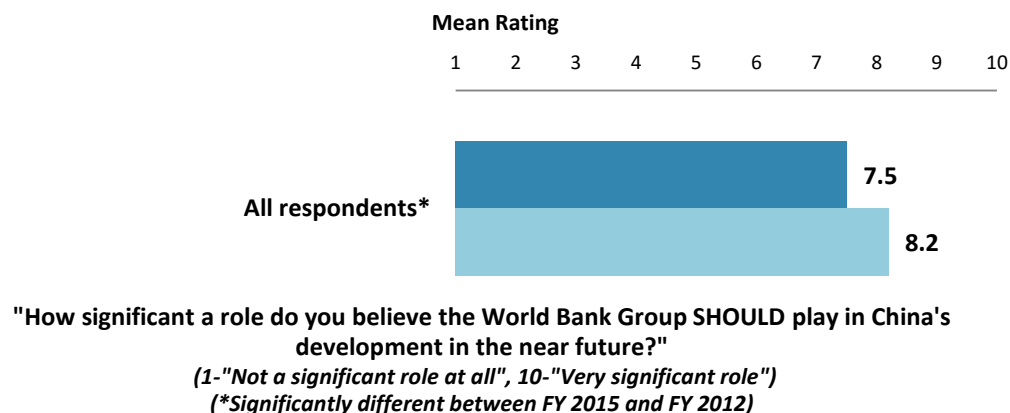

The World Bank Group's Role in China's Development in the Next Five Years

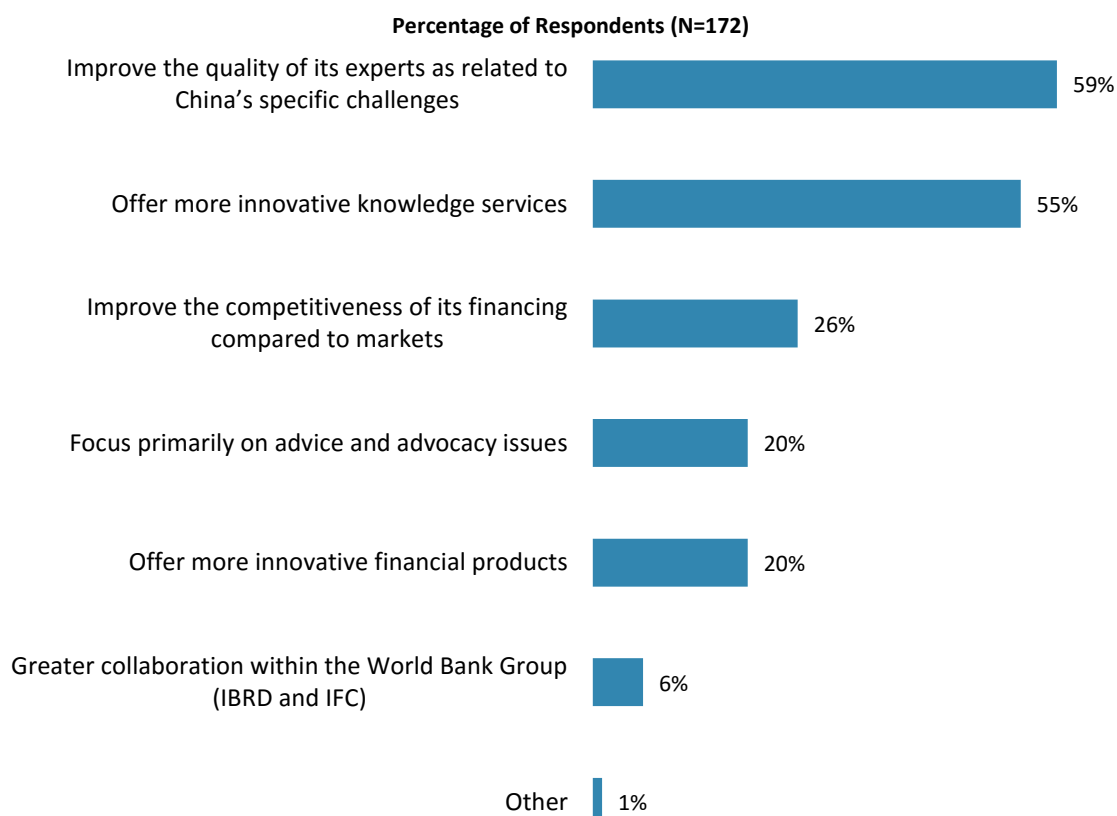

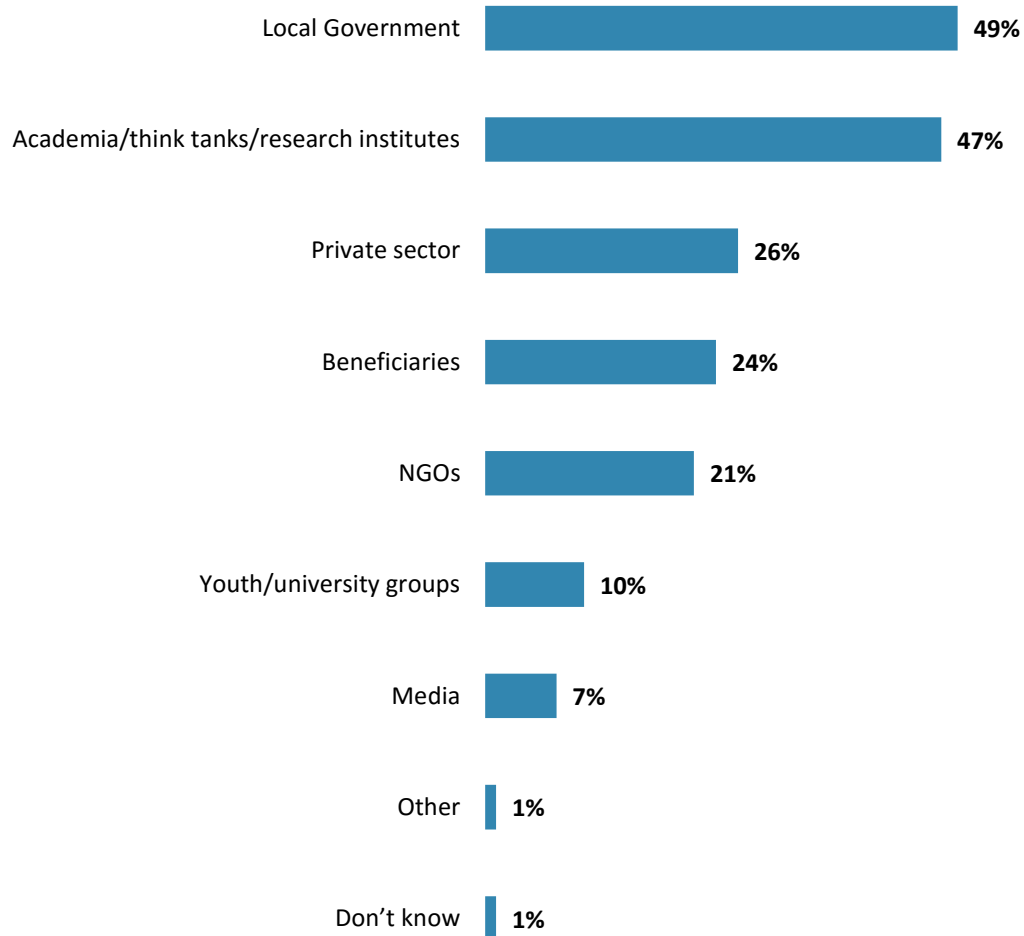

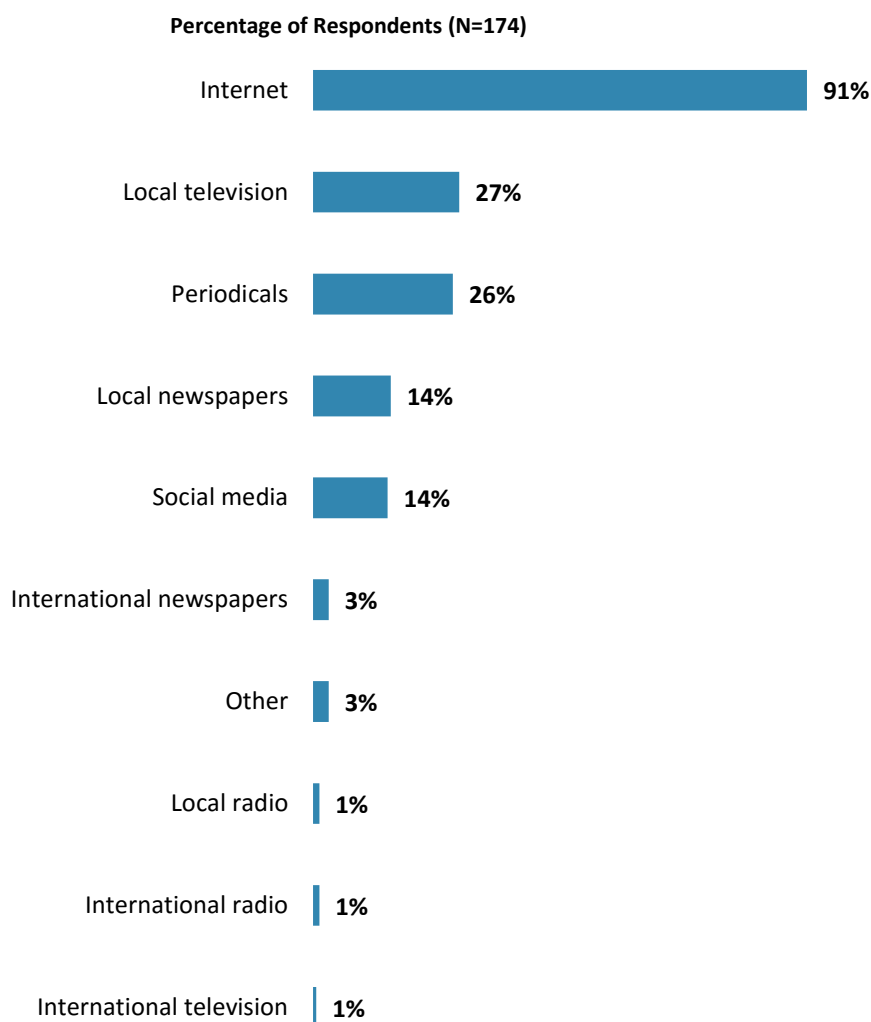

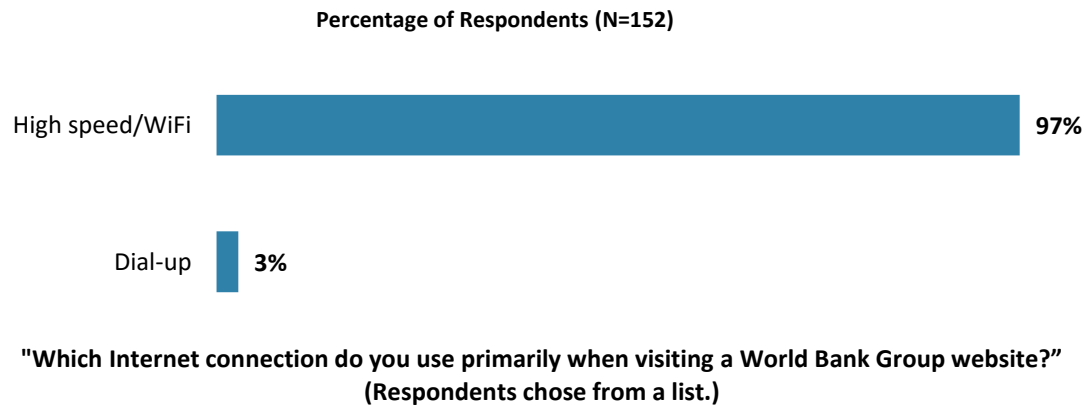
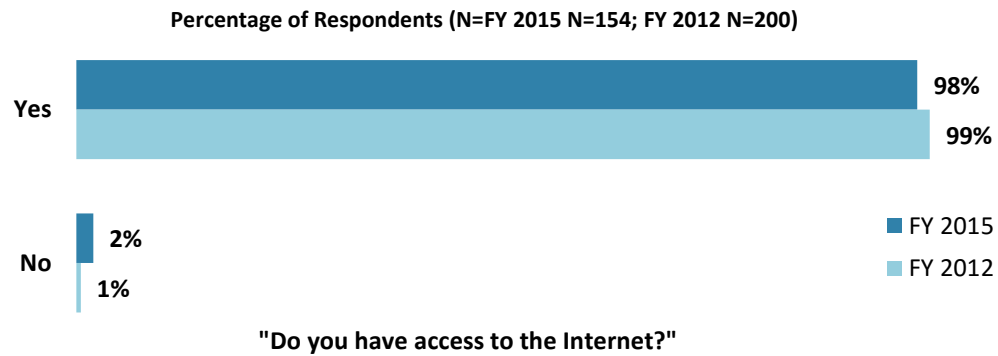

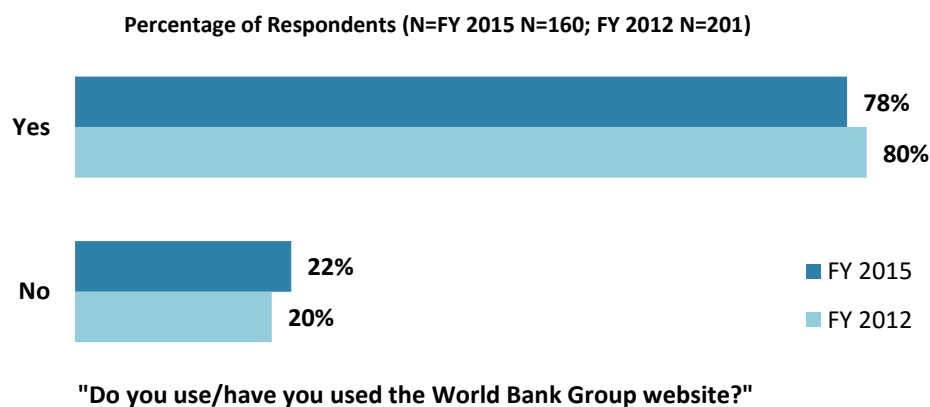

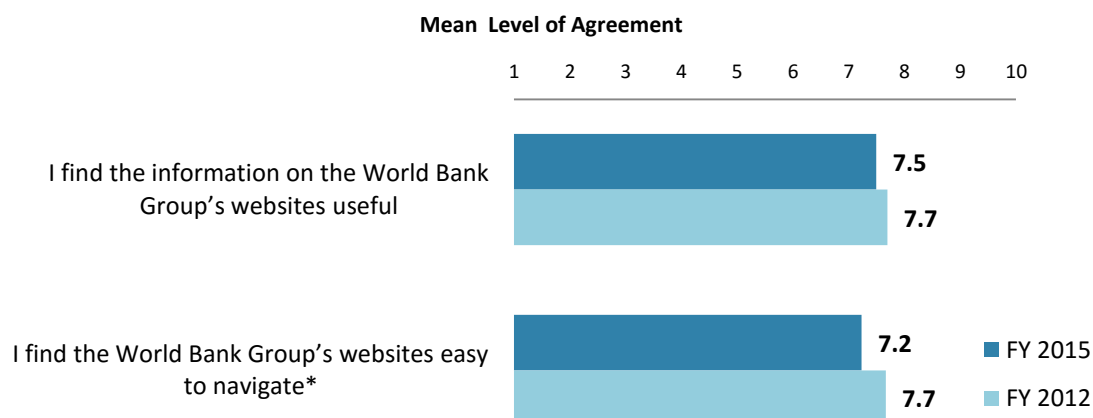

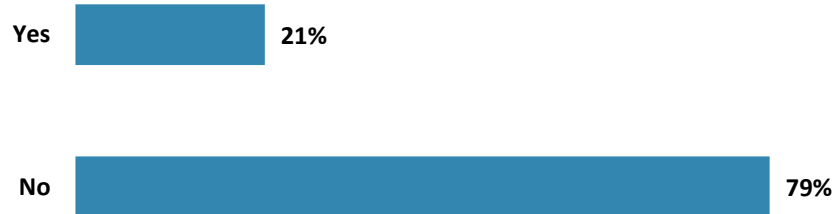

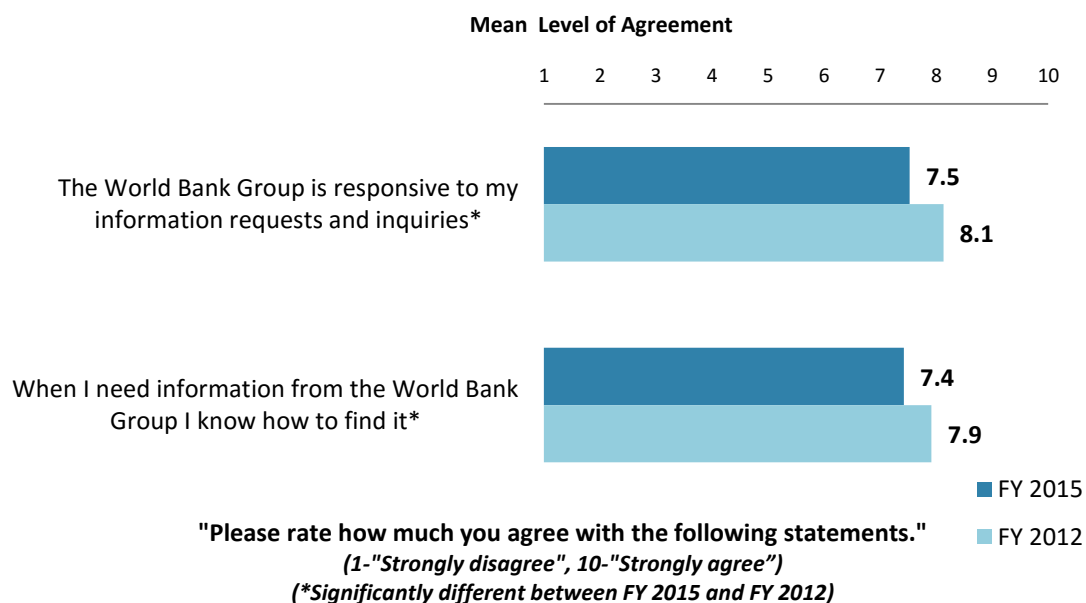
