I. Objectives

This survey was designed to assist the World Bank Group (WBG) in gaining a better understanding of how stakeholders in the Kyrgyz Republic perceive the WBG. The survey explored:

- *General Issues Facing the Kyrgyz Republic*
- *Overall Attitudes toward the World Bank Group*
- *World Bank Group's Effectiveness and Results*
- *The World Bank Group's Knowledge Work and Activities*
- *Working with the World Bank Group*
- *The Future Role of the World Bank Group in the Kyrgyz Republic*
- *Communication and Information Sharing*
- *Background Information*

II. Methodology

From March to May 2016, 479 stakeholders of the WBG in the Kyrgyz Republic were invited to provide their opinions on the WBG's work in the country by participating in a Country Opinion Survey. Participants were drawn from the office of the President/Prime Minister, office of a Minister, office of a Parliamentarian, employees of ministries/ministerial departments/implementation agencies, Project Management Units (PMUs) overseeing implementation of WBG projects or consultants/contractors working on WBG-supported projects/programs, local government office or staff, bilateral/multilateral agencies, private sector organizations, private foundations, the financial sector/private banks, NGOs/community-based organizations (CBOs), the media, independent government institutions, trade unions, faith-based groups, youth groups, academia/research institutes/think tanks, and the judiciary branch.

A total of 322 stakeholders participated in the survey (67% response rate). Respondents either received an invitation to complete the questionnaire via email or completed the questionnaire with a representative from the fielding agency.

Every country that engages in the Country Opinion Survey must include specific indicator questions that will be aggregated for the WBG's annual Corporate Scorecard. These questions are identified throughout the survey report.

The results of this year's Country Survey were compared to those in the Country Survey conducted in FY '13 (response rate was 55%, N = 166). The data were weighted to reach similar stakeholder compositions across the two survey years, allowing for more statistically reliable comparisons. Also, stakeholders who identified themselves as "Other" in the stakeholder category options were not included in these comparisons. As a result, mean ratings, percentages of respondents, and the total number of respondents in both years are slightly different from those of the original data reported in the FY '13 COS report and the non-weighted data presented in this report. III. Demographics of the Sample

Current Position

- For all further analyses, the small number of respondents from the office of a Minister were combined with those from the office of the President/Prime Minister. The few respondents from private foundations, youth groups, and trade unions were included in the “Other” category.

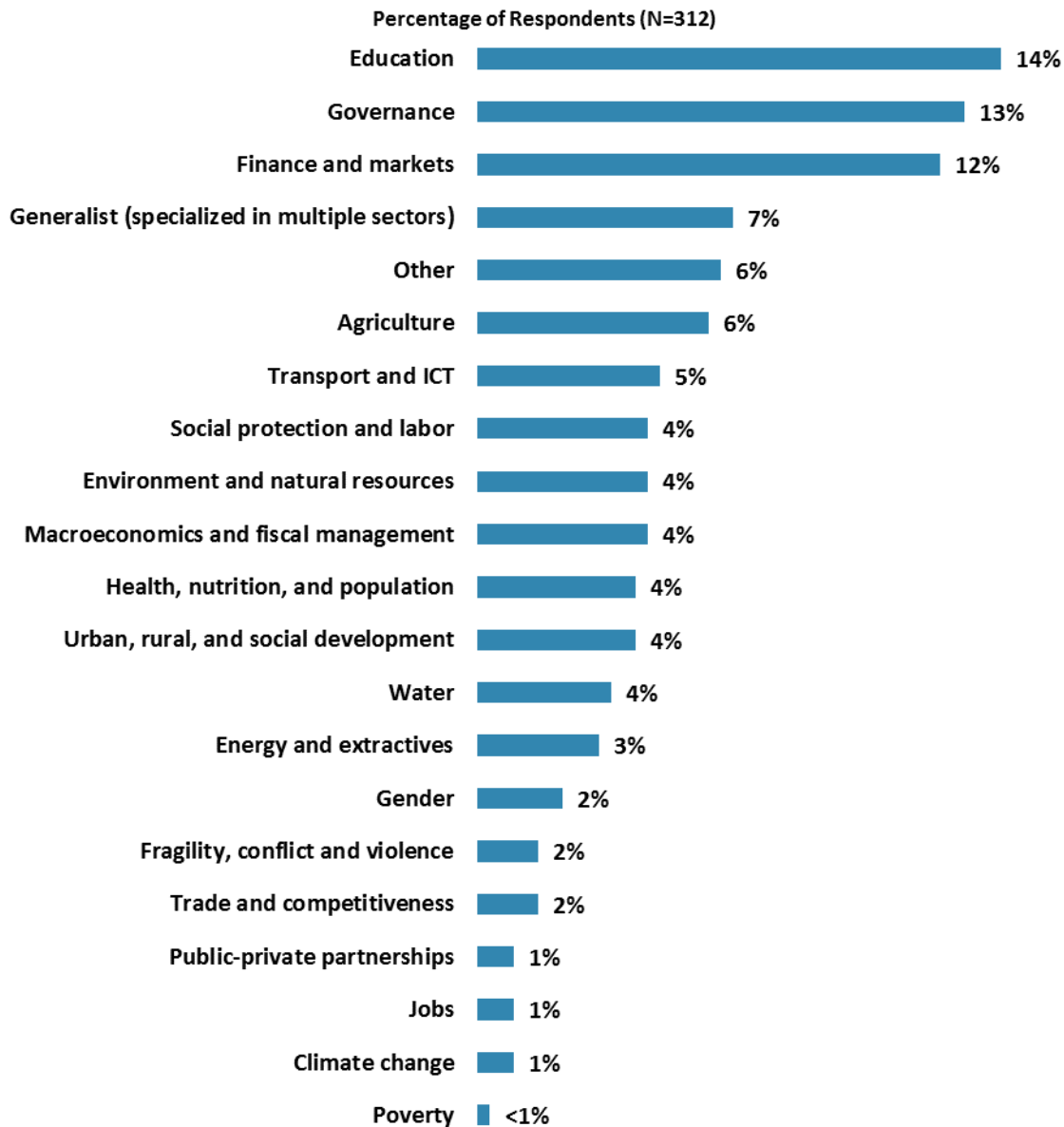


“Which of the following best describes your current position? (Select only ONE response)”

Area of Primary Specialization



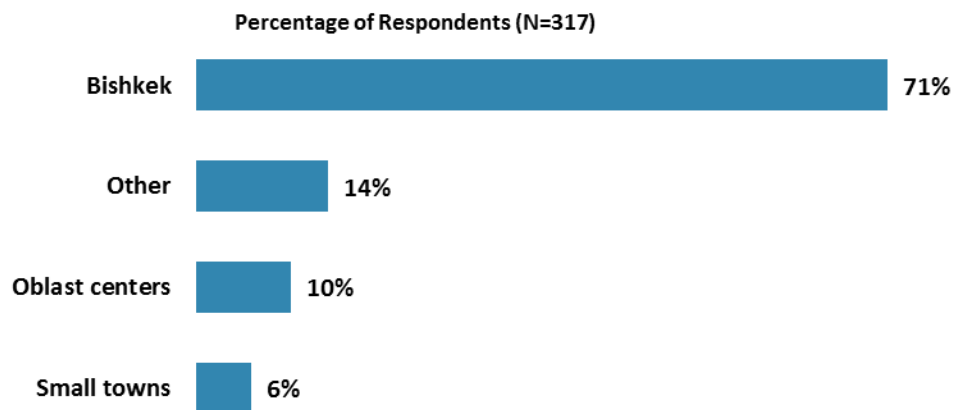

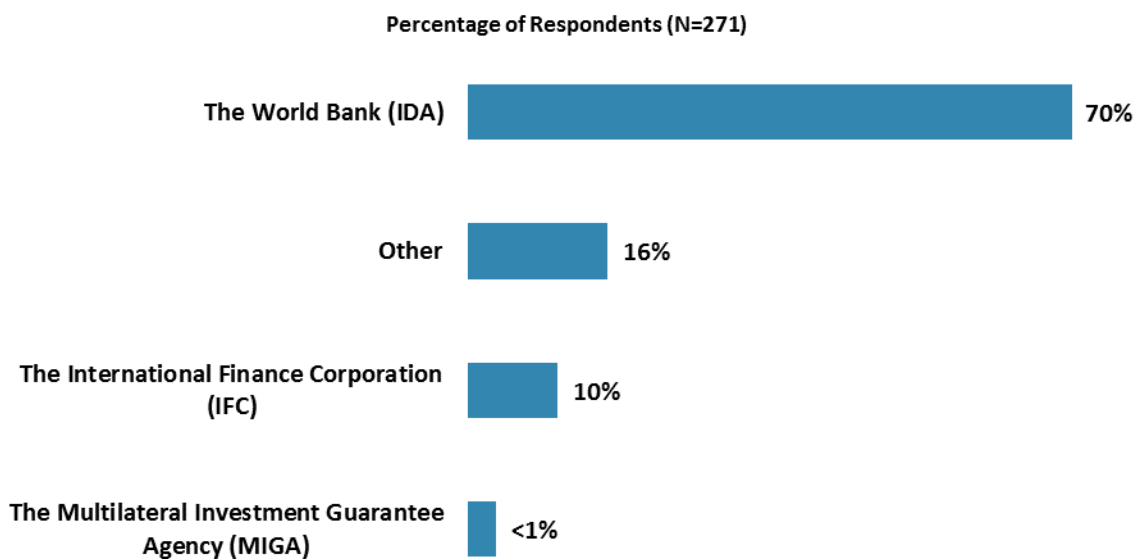
Geographic Locations

Exposure to Agencies within the World Bank Group



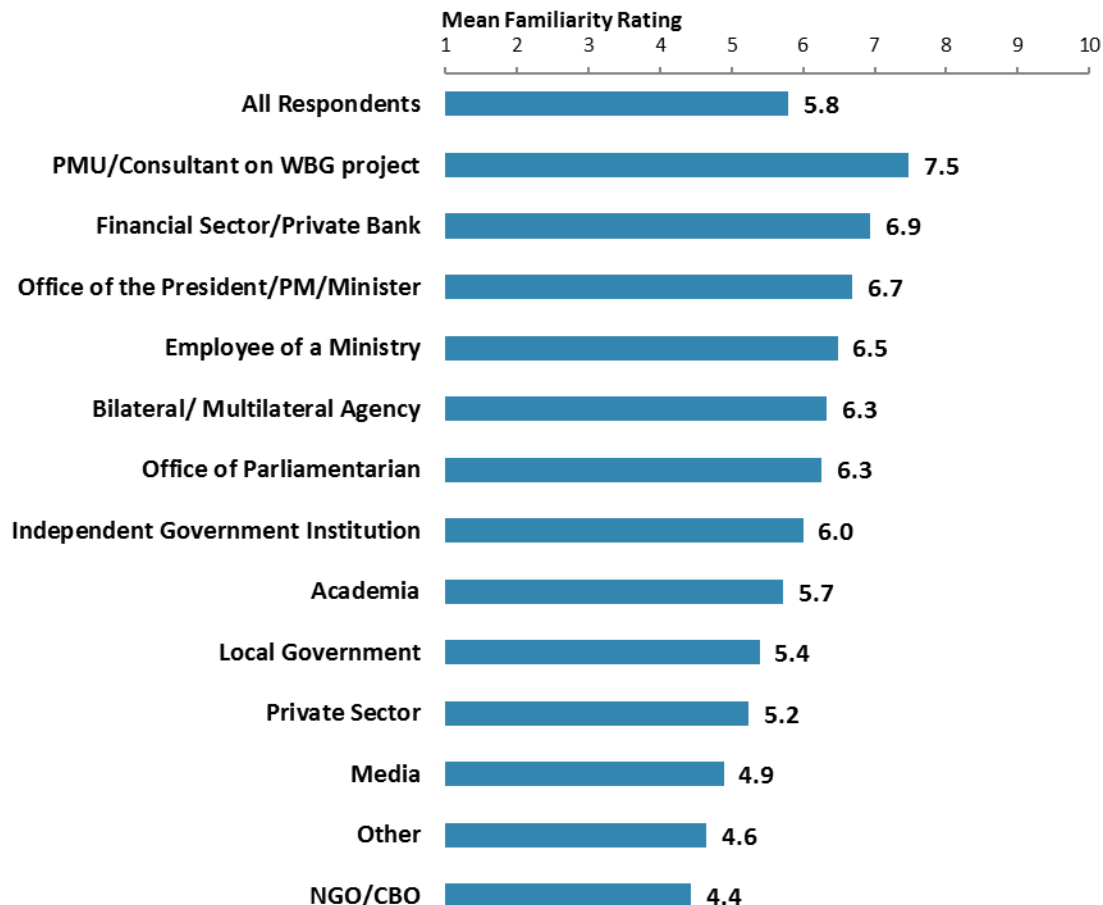
“Which of the following agencies of the World Bank Group do you primarily engage with in the Kyrgyz Republic? (Select only ONE response)” (Respondents choose from a list)



III. Demographics of the Sample (continued)

Familiarity with the World Bank Group

- **Year comparison:** Respondents in this year's Country Survey indicated significantly lower levels of familiarity with the WBG compared to respondents from the FY '13 Country Survey (weighted mean in FY '16 = 5.7; weighted mean in FY '13 = 6.2)¹.
- **Collaboration:** Respondents who collaborate with the WBG gave significantly higher ratings of familiarity with the WBG (mean rating = 6.8) than respondents who do not collaborate with the WBG (mean rating = 4.9).
- **Impact of Familiarity:** Respondents' ratings of familiarity with the WBG were strongly, significantly correlated with their ratings of the WBG's overall effectiveness in the Kyrgyz Republic, and moderately, significantly correlated with their ratings of the extent to which the WBG's work helps to achieve development results and the extent to which the WBG plays a relevant role in development in the Kyrgyz Republic.

(1 - "Not familiar at all", 10 - "Extremely familiar")

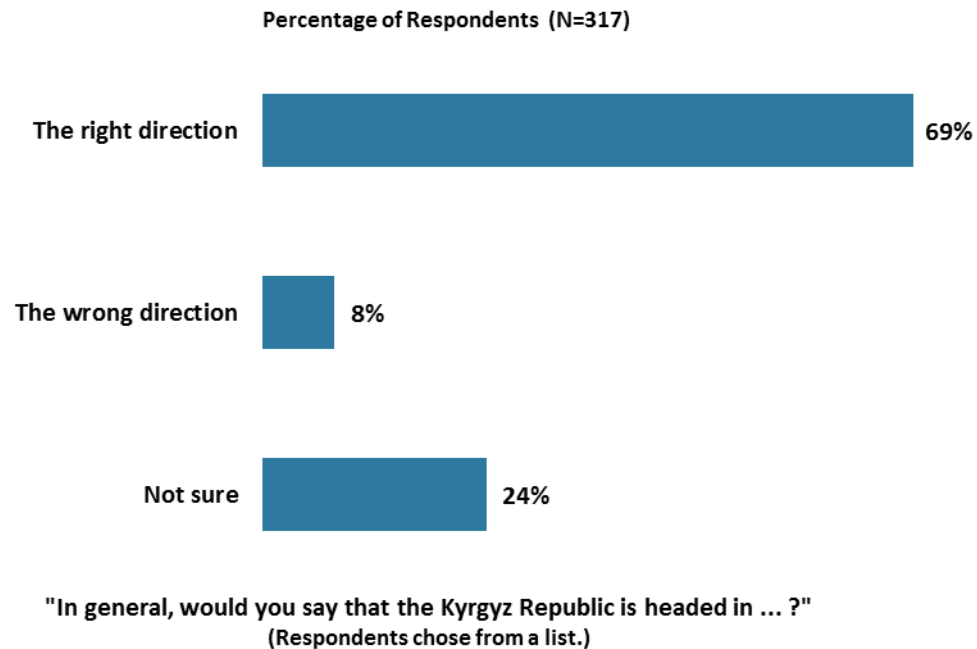

IV. General Issues Facing the Kyrgyz Republic

Headed in the Right Direction

- **Year comparison:** Respondents in the FY '13 Country Survey were asked to indicate where the Kyrgyz Republic's economy was headed, and a plurality indicated it was headed in the right direction (percentage of respondents = 45%); however, more than a third of the FY '13 respondents indicated that they were not sure (34%).

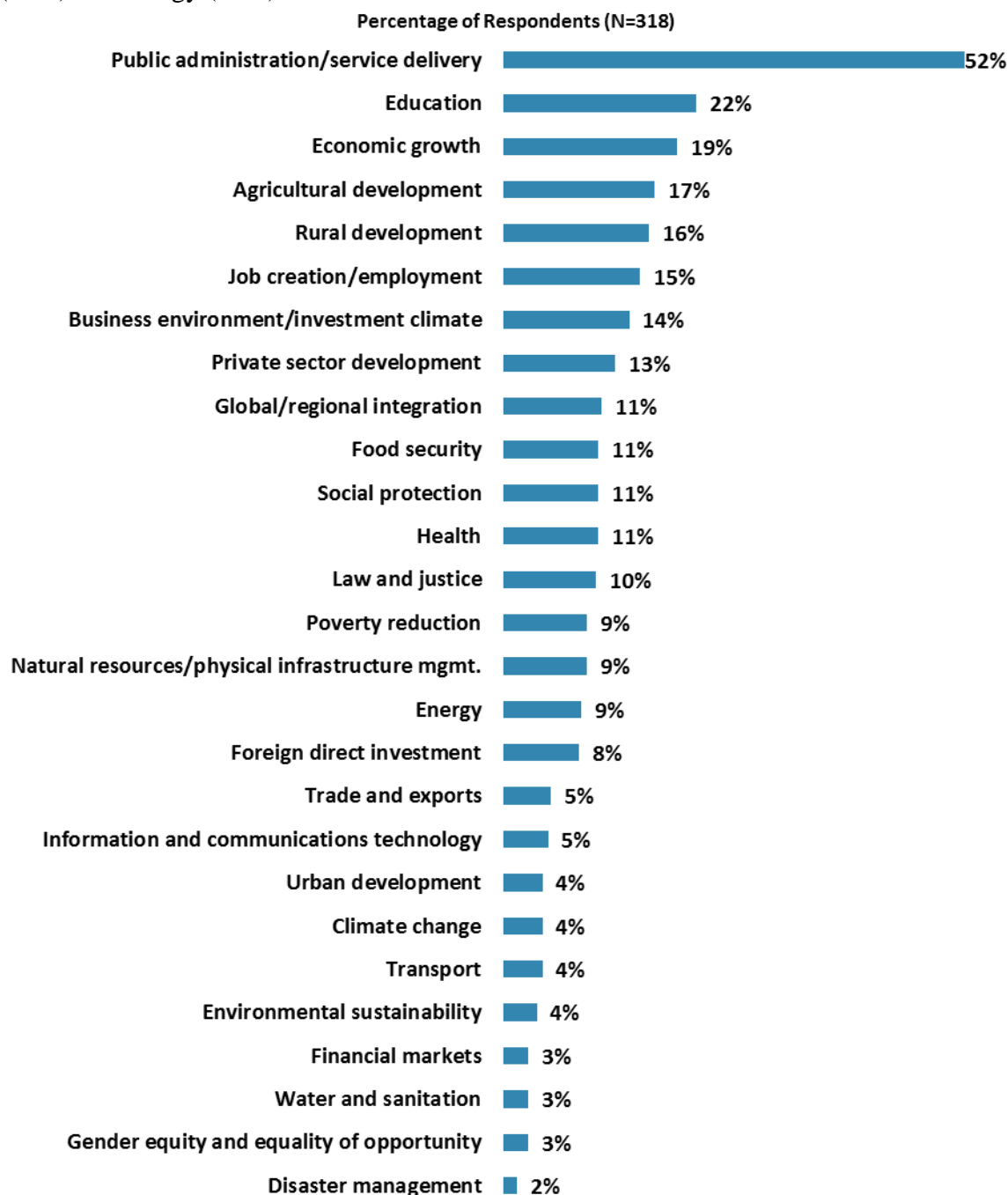

Development Priority

- **Year comparison:** Respondents in the FY '13 Country Survey indicated that the most important development priorities in the Kyrgyz Republic were public sector governance/reform (percentage of respondents = 38%) and anti-corruption (35%), followed by education (28%) and energy (21%).



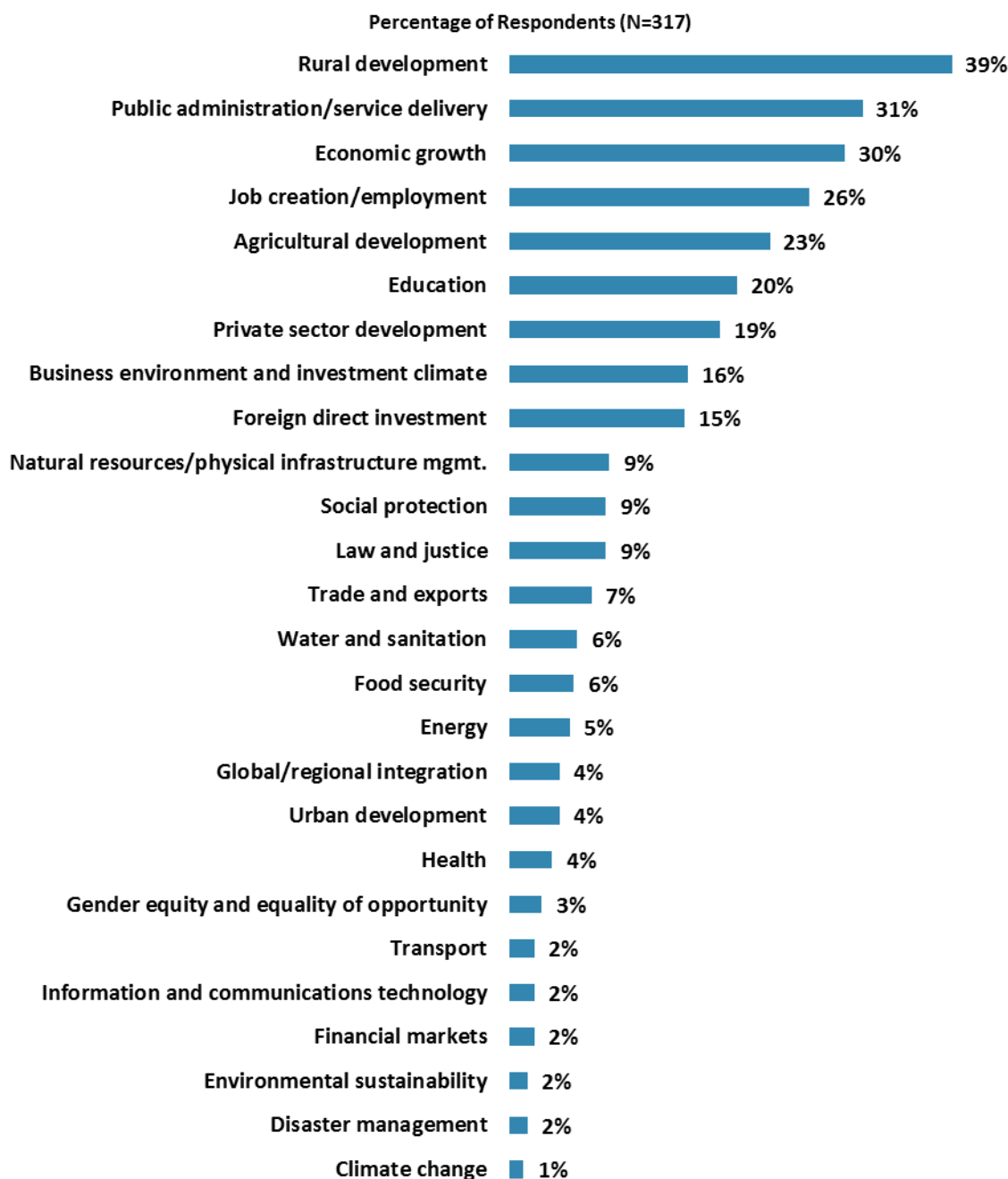

Factors Contributing to Poverty Reduction

- **Year comparison:** Respondents in the FY '13 Country Survey indicated that the areas that would contribute most to poverty reduction in the Kyrgyz Republic were economic growth (percentage of respondents = 40%), job creation/employment (35%), and rural development (32%), followed by anti-corruption (23%) and agricultural development (20%).

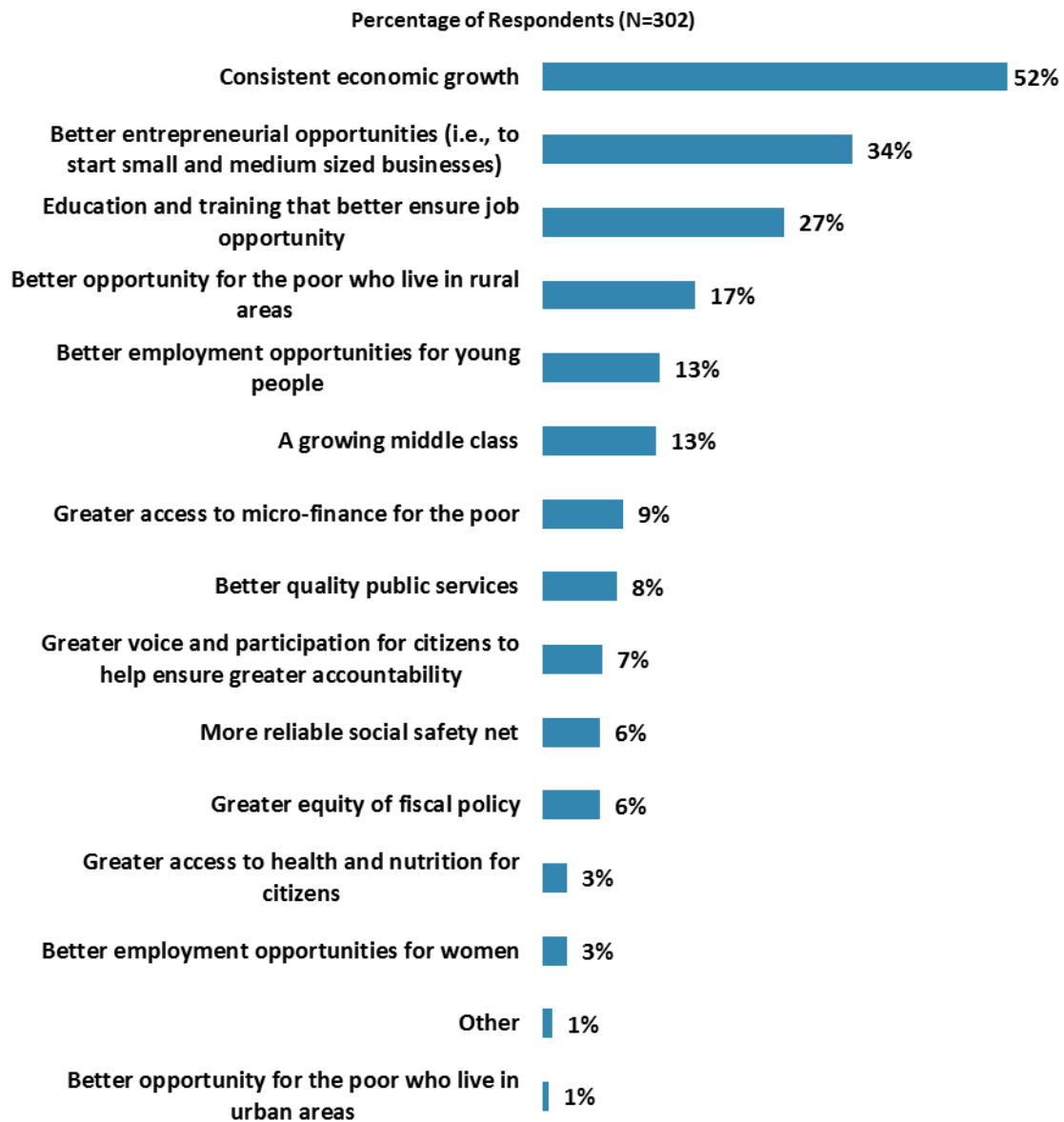

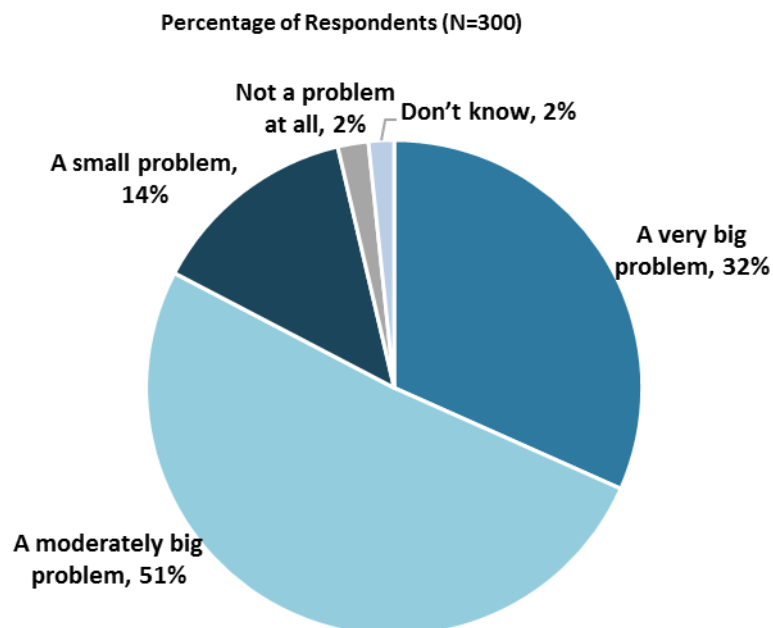

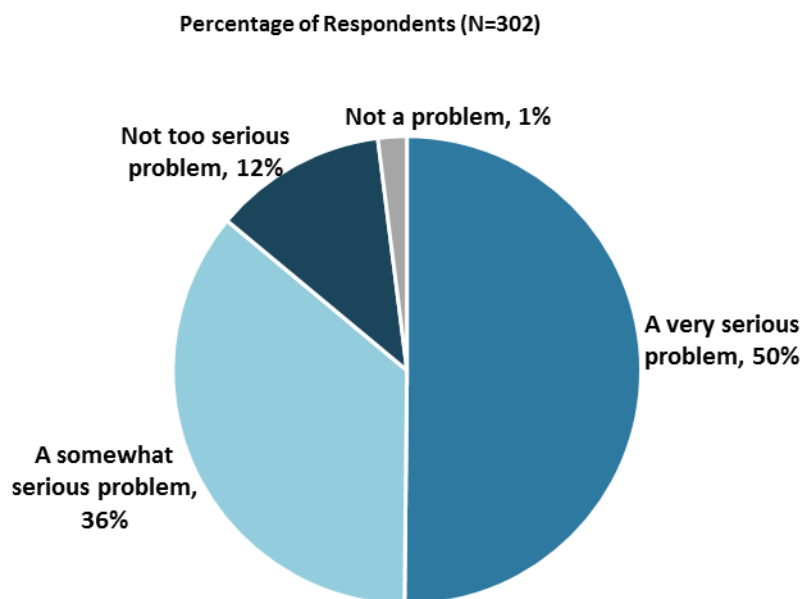

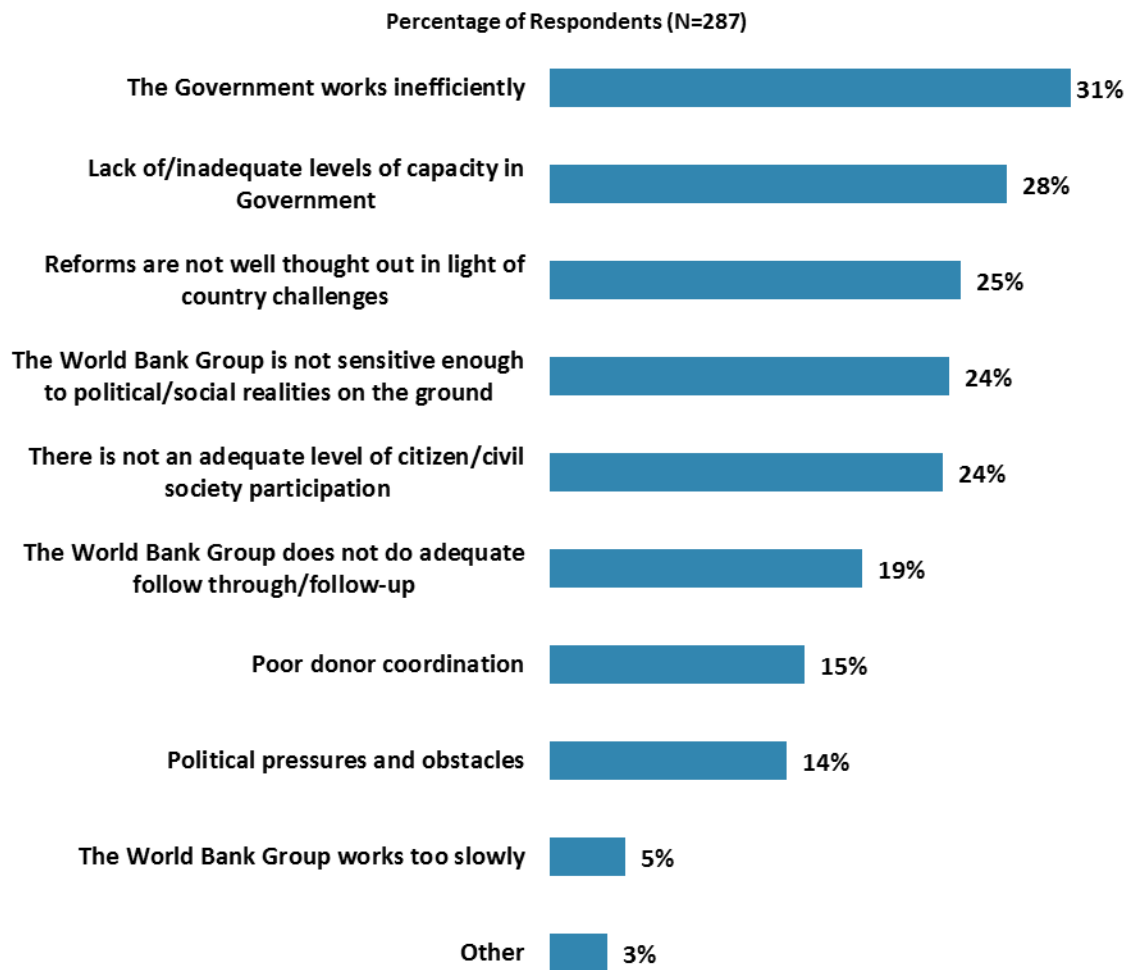

V. Overall Attitudes toward the World Bank Group

Attributing Failed/Slow Reform Efforts

- **Year comparison:** Respondents in the FY '13 Country Survey indicated that they most often attributed failed or slow WBG assisted reform efforts to the government working inefficiently (percentage of respondents = 39%), followed by the World Bank not being sensitive enough to political/social realities on the ground (26%), an inadequate level of civil society participation (24%), lack of/inadequate levels of capacity in Government (23%), and reforms not being well thought out in light of country challenges (23%).

As noted in the “Methodology” section, the indicator questions referred to throughout the survey report are questions that are asked in every country that engages in the Country Opinion Survey. These will be aggregated for the World Bank Group’s annual Corporate Scorecard.

The World Bank Group’s Overall Effectiveness (Indicator Question)

- **Year comparison:** Respondents in this year’s Country Survey had statistically similar ratings for the WBG’s overall effectiveness in the Kyrgyz Republic (weighted mean = 6.3) compared to respondents from the FY ’13 Country Survey (weighted mean = 6.1)².
- **Stakeholders:** Respondents from the office of the President/Prime Minister/Minister and PMUs/Consultants on WBG-supported projects gave the highest ratings for the WBG’s overall effectiveness whereas respondents from the financial sector/private banks and NGOs/CBOs gave significantly lower ratings.
- **Collaboration:** Respondents who are collaborating with the WBG gave significantly higher ratings for the WBG’s overall effectiveness in the Kyrgyz Republic (mean rating = 7.0) compared to respondents who are not collaborating (mean rating = 5.7).

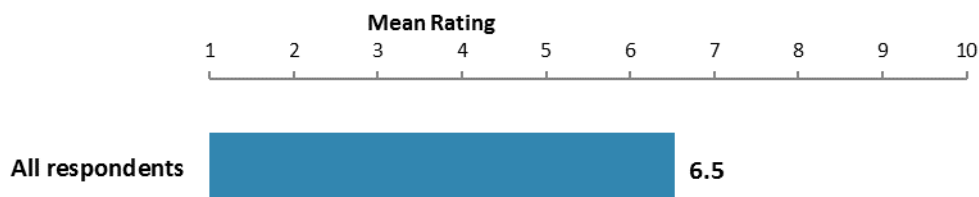

Achieving Development Results (*Indicator Question*)

- **Year comparison:** Respondents in this year's Country Survey gave significantly higher ratings for the extent to which the WBG achieves development results (weighted mean = 6.5) compared to respondents from the FY '13 Country Survey (weighted mean = 6.1)³.
- **Stakeholders:** Respondents from PMUs/Consultants on WBG-supported projects and local government gave the highest ratings for the extent to which the WBG achieves development results whereas respondents from the financial sector/private banks, the media, NGOs/CBOs, and bilateral/multilateral agencies gave significantly lower ratings.
- **Locations:** Respondents from Other Areas gave significantly higher ratings for the WBG's overall effectiveness in the Kyrgyz Republic (mean rating = 7.0) compared to respondents from Bishkek (mean rating = 6.3).
- **Collaboration:** Respondents who are collaborating with the WBG gave significantly higher ratings for the extent to which the WBG achieves development results (mean rating = 7.0) compared to respondents who are not collaborating (mean rating = 6.1).

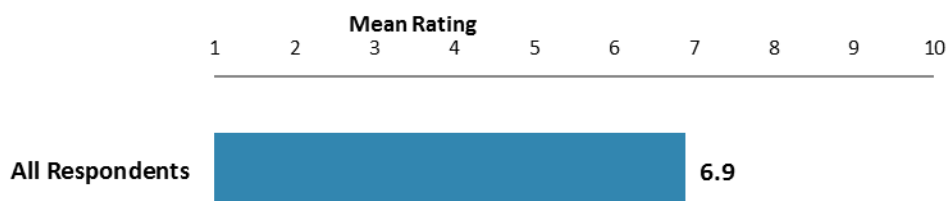

WBG Staff Preparedness

- **Year comparison:** Respondents in this year's Country Survey gave statistically similar ratings for the WBG's staff being well prepared (weighted mean = 6.8) compared to respondents from the FY '13 Country Survey (weighted mean = 6.6)⁴.
- **Collaboration:** Respondents who are collaborating with the WBG gave significantly higher ratings for the WBG's staff preparedness (mean rating = 7.4) compared to respondents who are not collaborating (mean rating = 6.3).

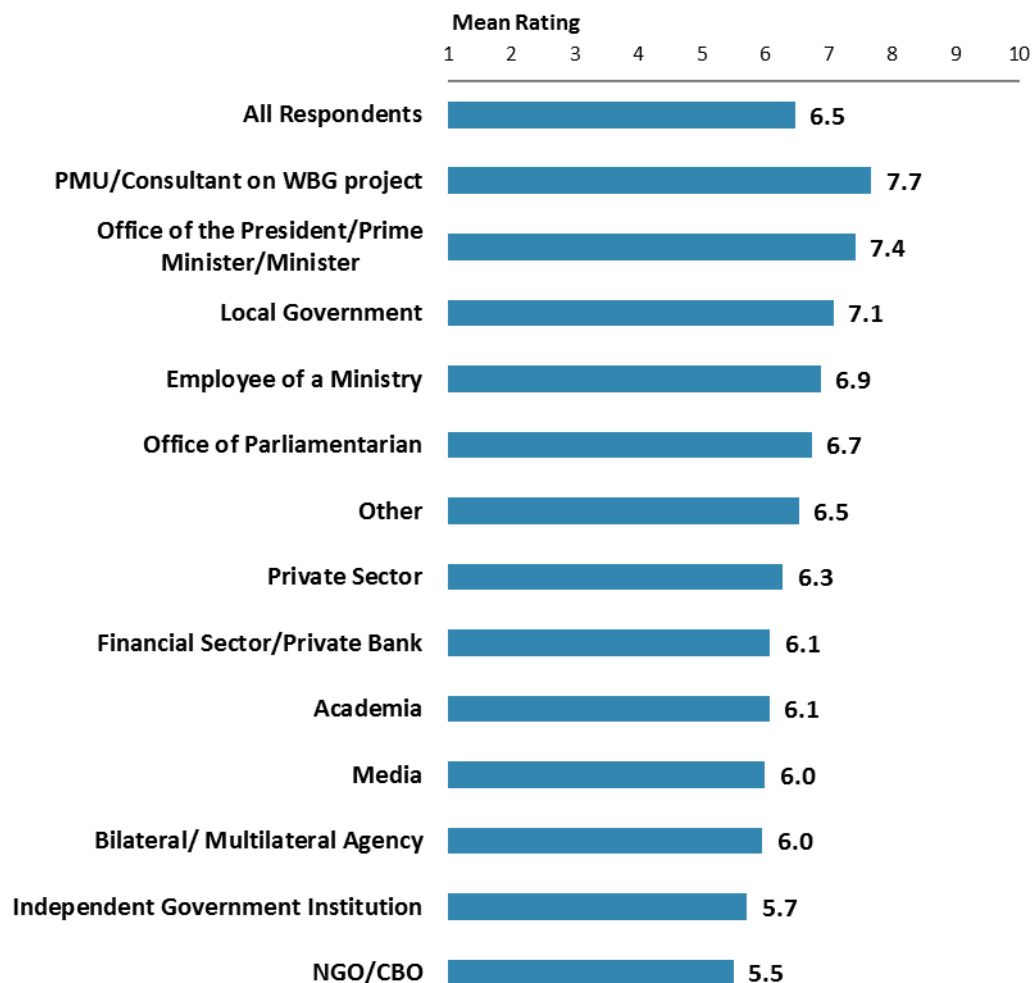

Overall Ratings for Indicator Questions by Stakeholder Groups

- **Stakeholders:** Respondents from PMUs/Consultants on WBG-supported projects had the highest mean ratings for the aggregated responses to the twenty-seven COS indicator questions whereas respondents from independent government institutions and NGOs/CBOs had significantly lower mean ratings. Responses for individual indicator questions by stakeholder groups can be found in Appendix B (see page 65).
- **Collaboration:** Respondents who collaborate with the WBG had a significantly higher mean rating for the aggregated responses to the twenty-seven COS indicator questions (mean rating = 7.1) compared to respondents who do not collaborate with the WBG (mean rating = 5.9). Responses for individual indicator questions by exposure to the WBG can be found in Appendix F (see page 102).



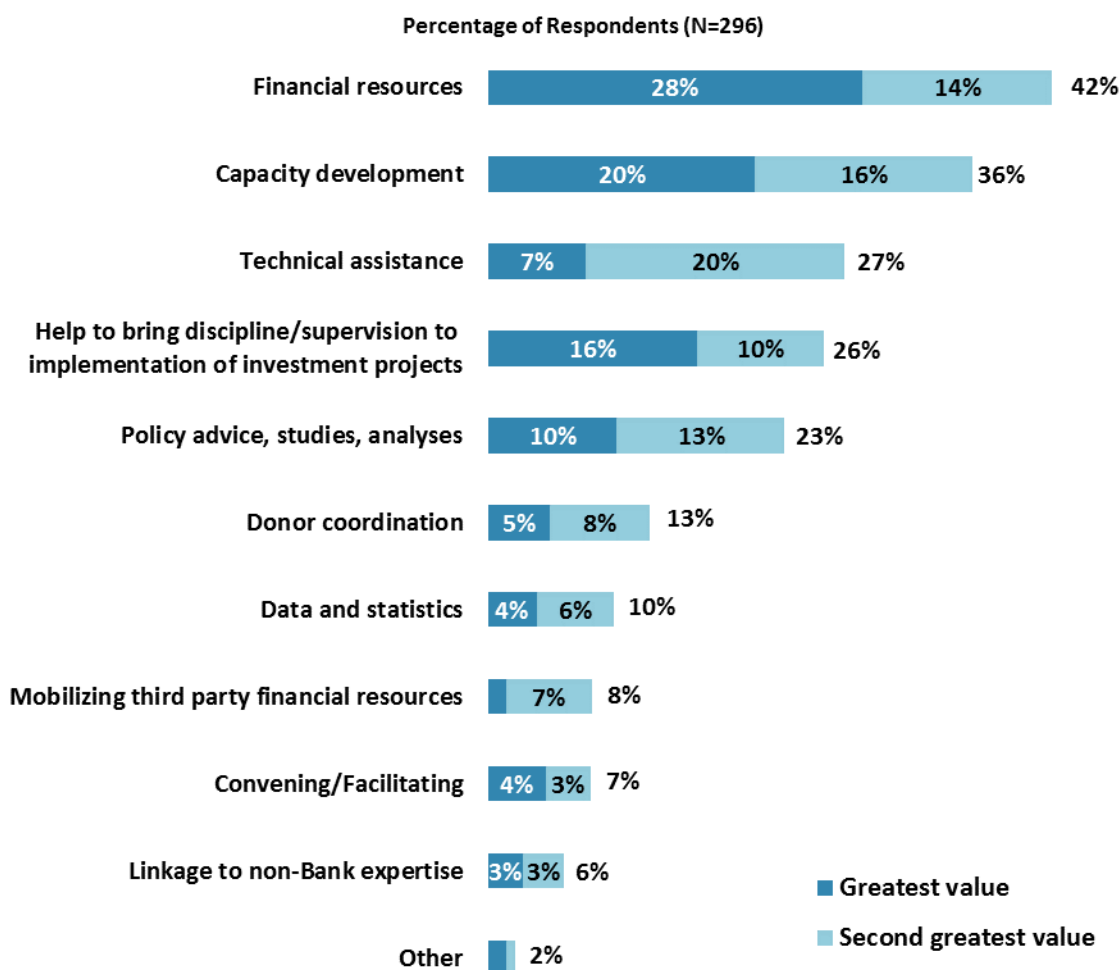
Mean Ratings for All Indicator Questions by Stakeholder Groups on a Scale from 1 to 10

Greatest Value

- **Year comparison:** The vast majority of respondents in the FY '13 Country Survey indicated that the WBG's greatest value to the Kyrgyz Republic was its financial resources for investment lending (percentage of respondents = 71%), followed by its financial resources for policy based lending/budget support to the Government (30%), training/capacity building (28%), and technical assistance (24%).



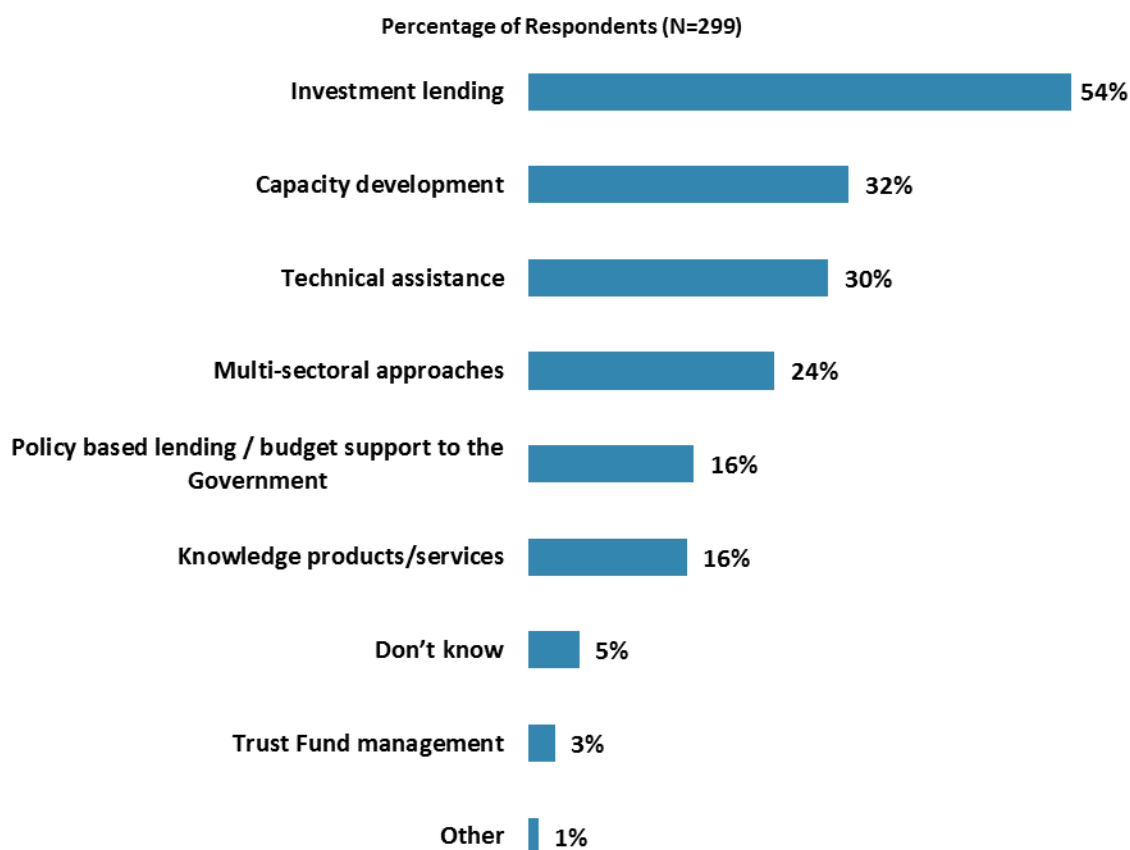

Effectiveness of WBG's Instruments in Reducing Poverty

- **Year comparison:** Respondents in the FY '13 Country Survey indicated that the WBG's most effective instrument at reducing poverty in the Kyrgyz Republic was its investment lending (percentage of respondents = 68%), followed by its capacity development (45%) and technical assistance (33%).



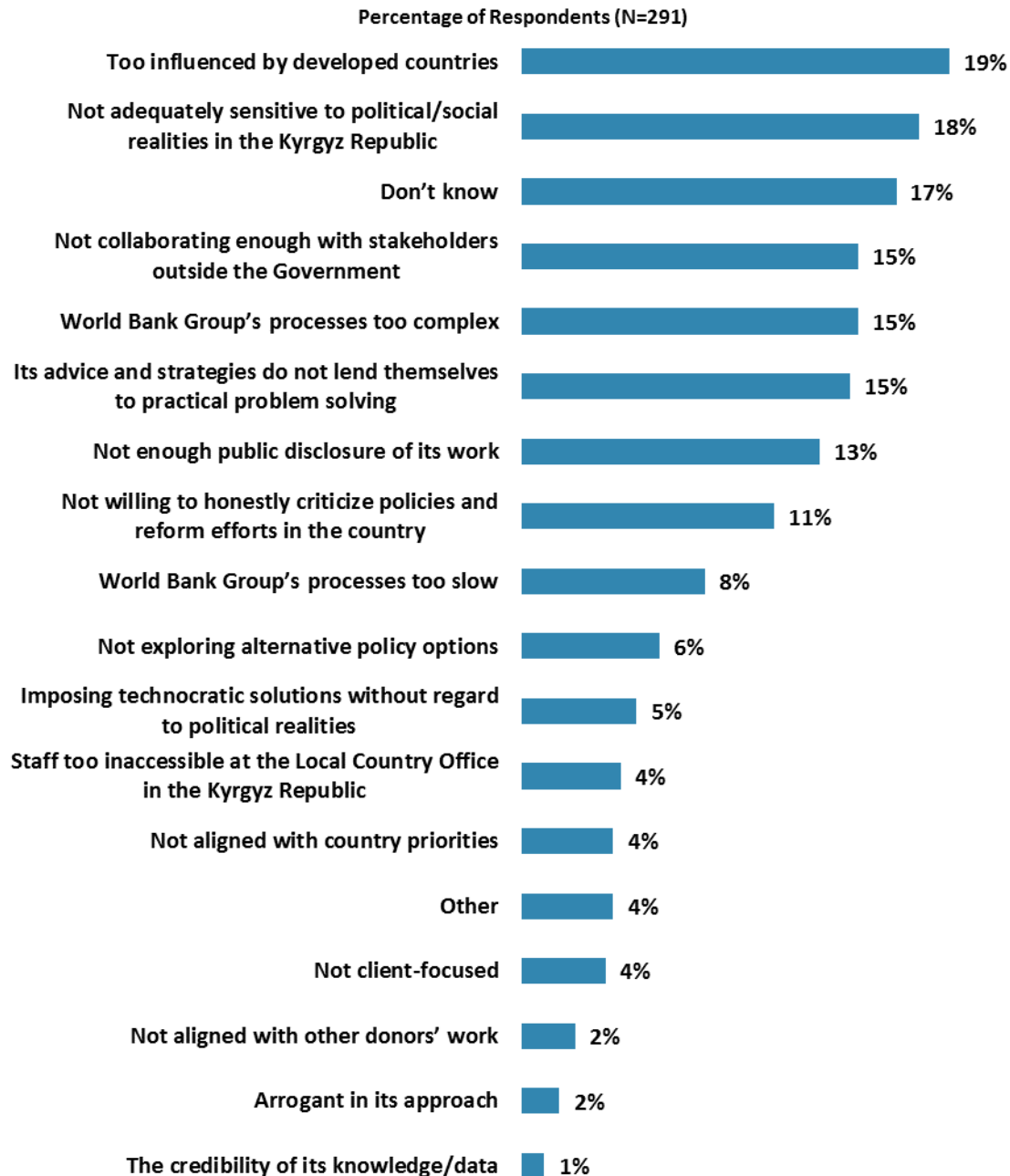
"Which World Bank Group's instruments do you believe are the MOST effective in reducing poverty in the Kyrgyz Republic? (Choose not more than TWO)"

V. Overall Attitudes toward the World Bank Group (continued)

Greatest Weakness

- **Year comparison:** Respondents in the FY '13 Country Survey indicated that the WBG's greatest weakness in its work in the Kyrgyz Republic was not enough public disclosure of its work (percentage of respondents = 34%), followed by not being adequately sensitive to political/social realities (19%), its processes being too slow and complex (18%), not collaborating enough with non-state actors (17%), and its staff being too inaccessible (15%).

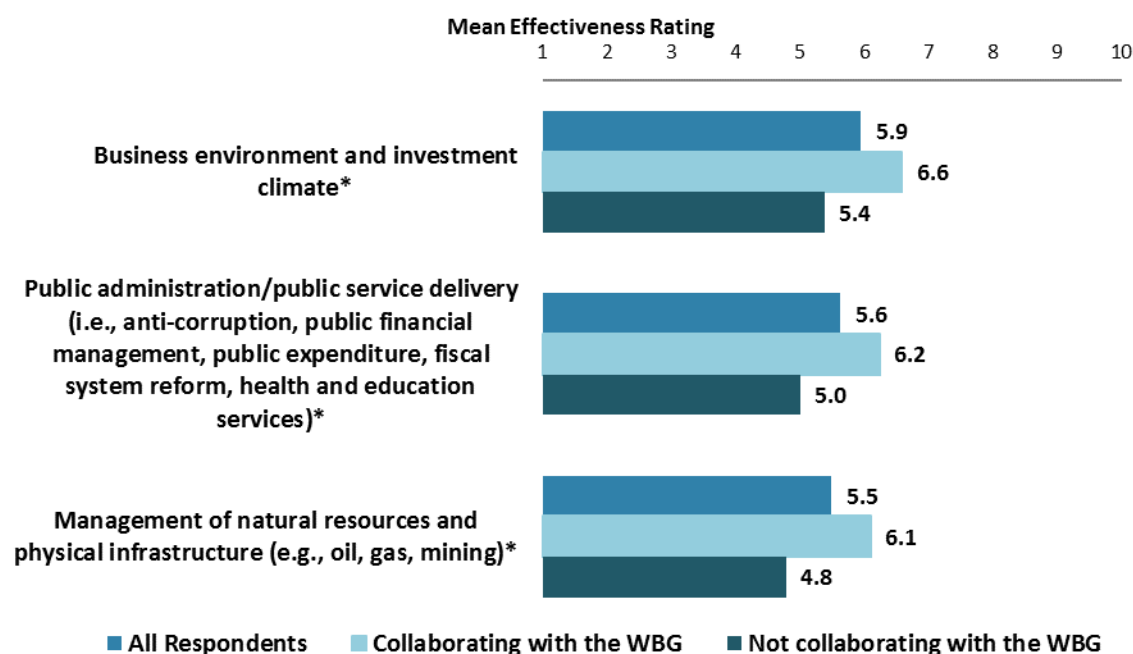

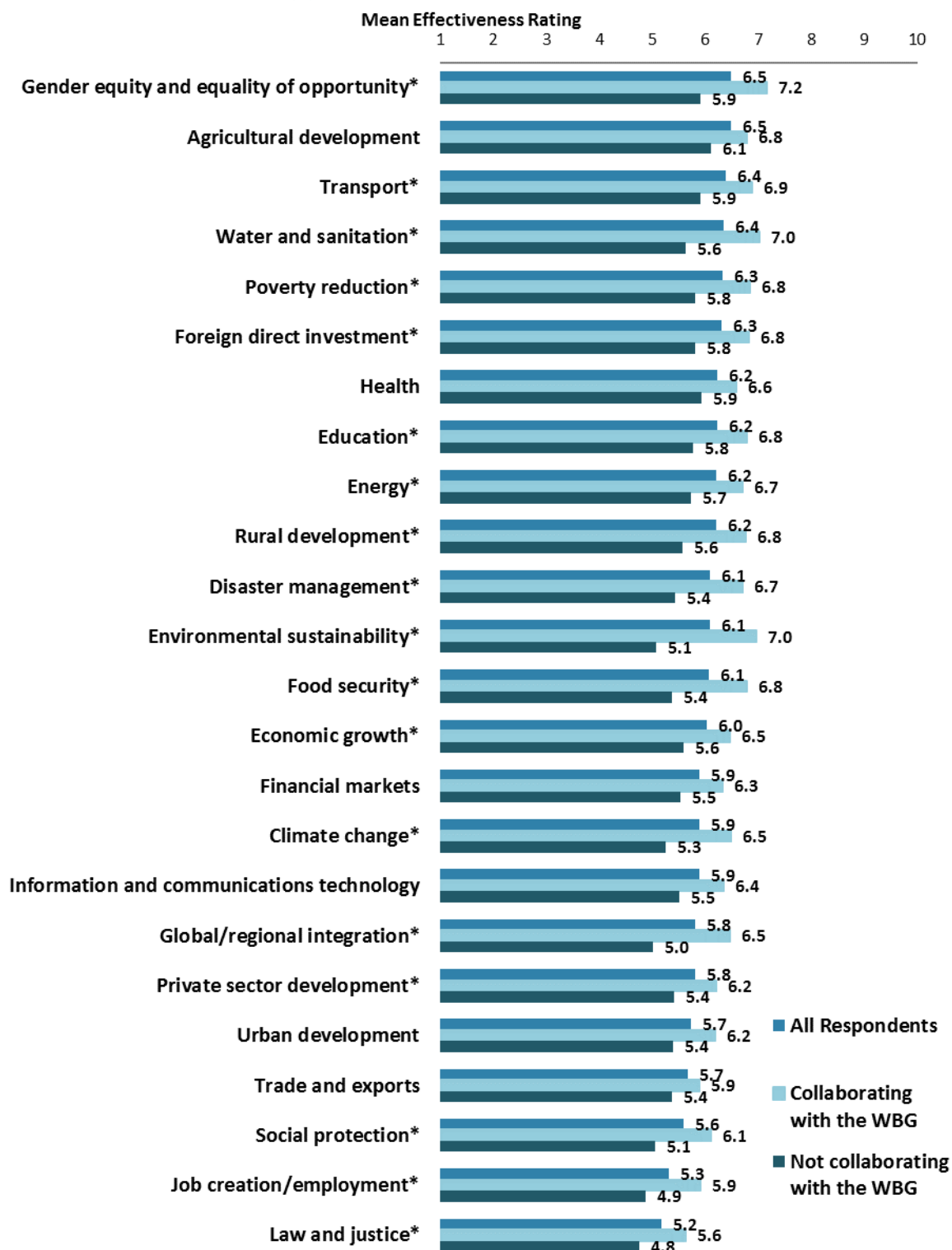

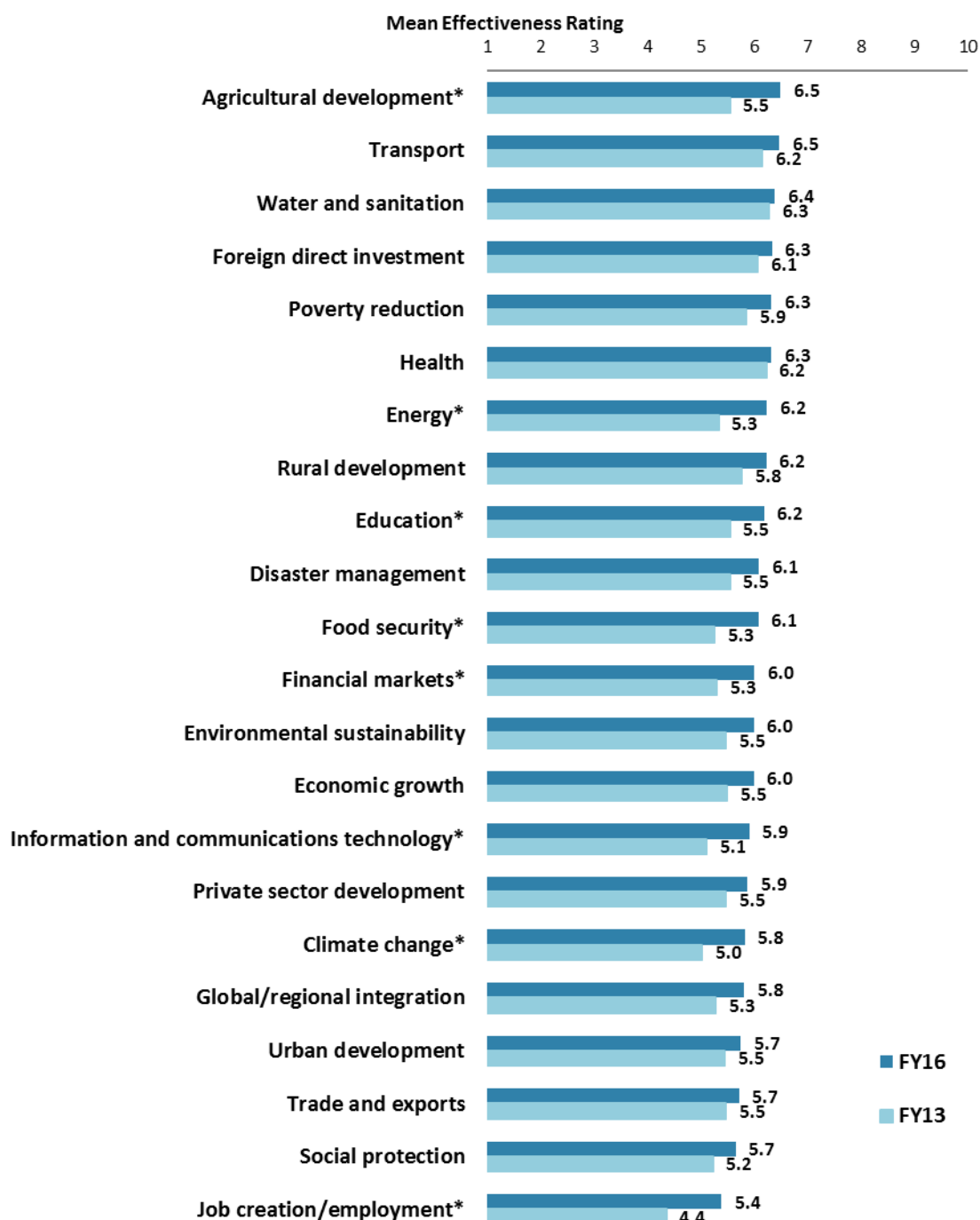


"Please rate the EFFECTIVENESS of the World Bank Group's work in the following areas of development." (1-"Not effective at all", 10-"Very effective")

Effectiveness of WBG's Support in Sectoral Areas: Year Comparison⁶



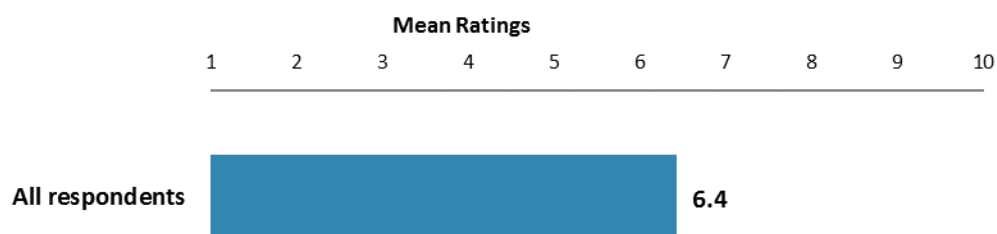

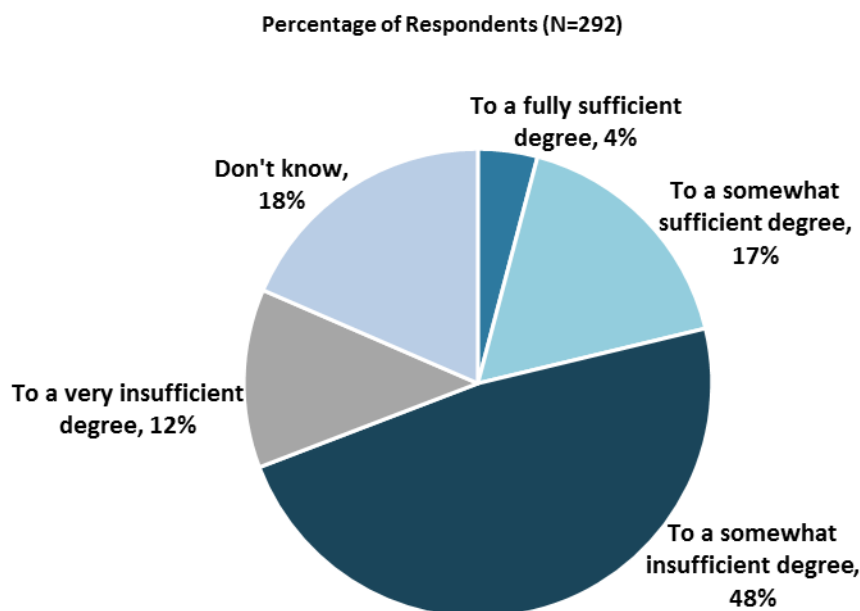

Drivers of Effectiveness

To determine the key drivers of respondents' ratings of the World Bank Group's overall effectiveness and ratings of its ability to help achieve development results in the Kyrgyz Republic, bivariate correlational analyses were conducted using respondents' ratings of the twenty-seven specific areas of effectiveness.

Correlational analyses, however, are not able to tell us exactly what is causing respondents' ratings of the World Bank Group's overall effectiveness or ratings of its ability to help achieve development results. Rather, these analyses tell us that as ratings of effectiveness in one area increase, respondents' ratings of the WBG's overall effectiveness increase, or as ratings of effectiveness in one area increase, ratings of the WBG's ability to help achieve development results increase. Thus, it can be inferred that respondents' perceptions of effectiveness in one specific area are related to, or drive, respondents' perceptions of the WBG's overall effectiveness or perceptions of the WBG's ability to help achieve development results.

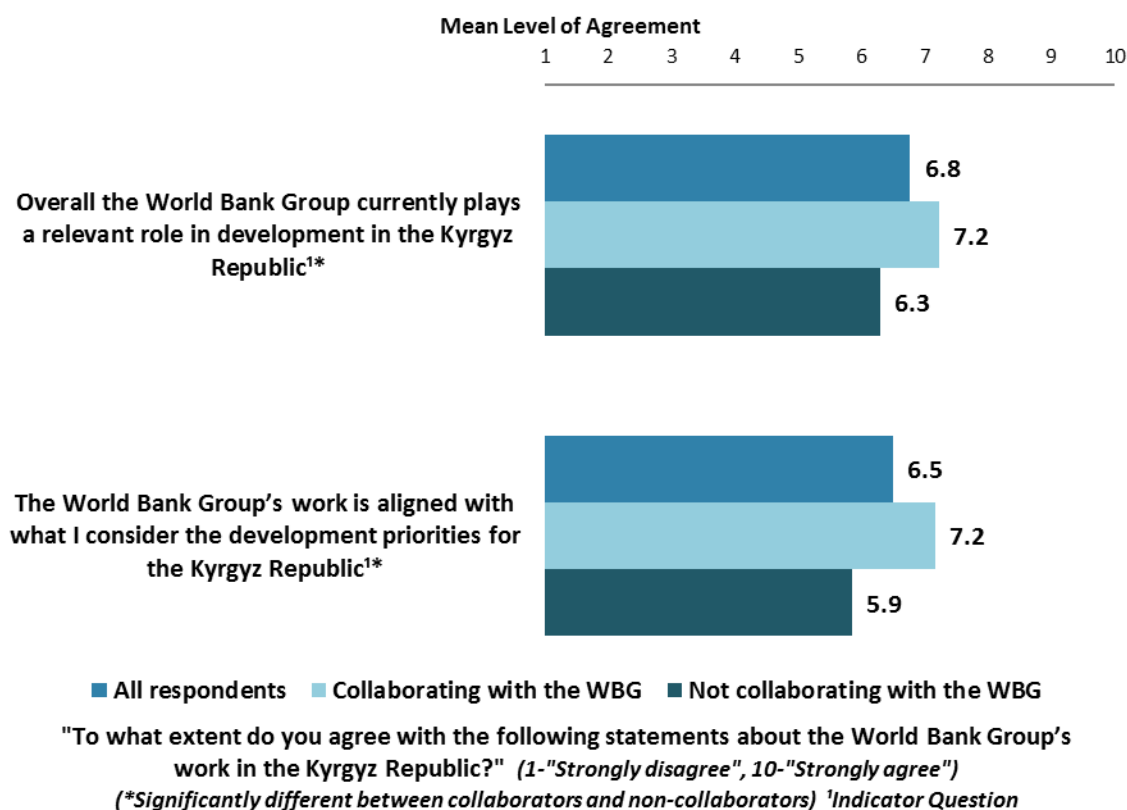
- Overall Effectiveness: Those specific areas with the highest Pearson Product-Moment correlations were determined to be the most closely related to perceptions of the WBG's overall effectiveness, suggesting that ratings of effectiveness in those specific areas are drivers of perceptions of the WBG's overall effectiveness in the Kyrgyz Republic. The areas determined to be key drivers from these analyses were:
 - The WBG's effectiveness at economic growth;
 - The WBG's effectiveness at education;
 - The WBG's effectiveness at food security;
 - The WBG's effectiveness at information and communications technology;
 - The WBG's effectiveness at public administration and public service delivery;
 - The WBG's effectiveness at environmental sustainability; and
 - The WBG's effectiveness at poverty reduction.
- Achieving Development Results: Those specific areas with the highest Pearson Product-Moment correlations were determined to be the most closely related to perceptions of the WBG's ability to help achieve development results in the Kyrgyz Republic, suggesting that ratings of effectiveness in those specific areas are drivers of perceptions of the WBG's ability to help achieve development results. The areas determined to be key drivers from these analyses were:
 - The WBG's effectiveness at poverty reduction;
 - The WBG's effectiveness at business environment and investment climate;
 - The WBG's effectiveness at private sector development;
 - The WBG's effectiveness at public administration and public service delivery;
 - The WBG's effectiveness at law and justice; and
 - The WBG's effectiveness at food security.



VII. How the World Bank Group Operates

The World Bank Group's Work in the Kyrgyz Republic

- **Year comparison:** Respondents in this year's Country Survey had statistically similar levels of agreement that *"Overall the World Bank Group currently plays a relevant role in development in the Kyrgyz Republic"* (weighted mean rating = 6.7) and that *"The WBG's work is aligned with what I consider the development priorities for the Kyrgyz Republic"* (weighted mean rating = 6.4) compared to respondents from the FY '13 Country Survey (mean ratings = 6.7 and 6.0, respectively)⁷.



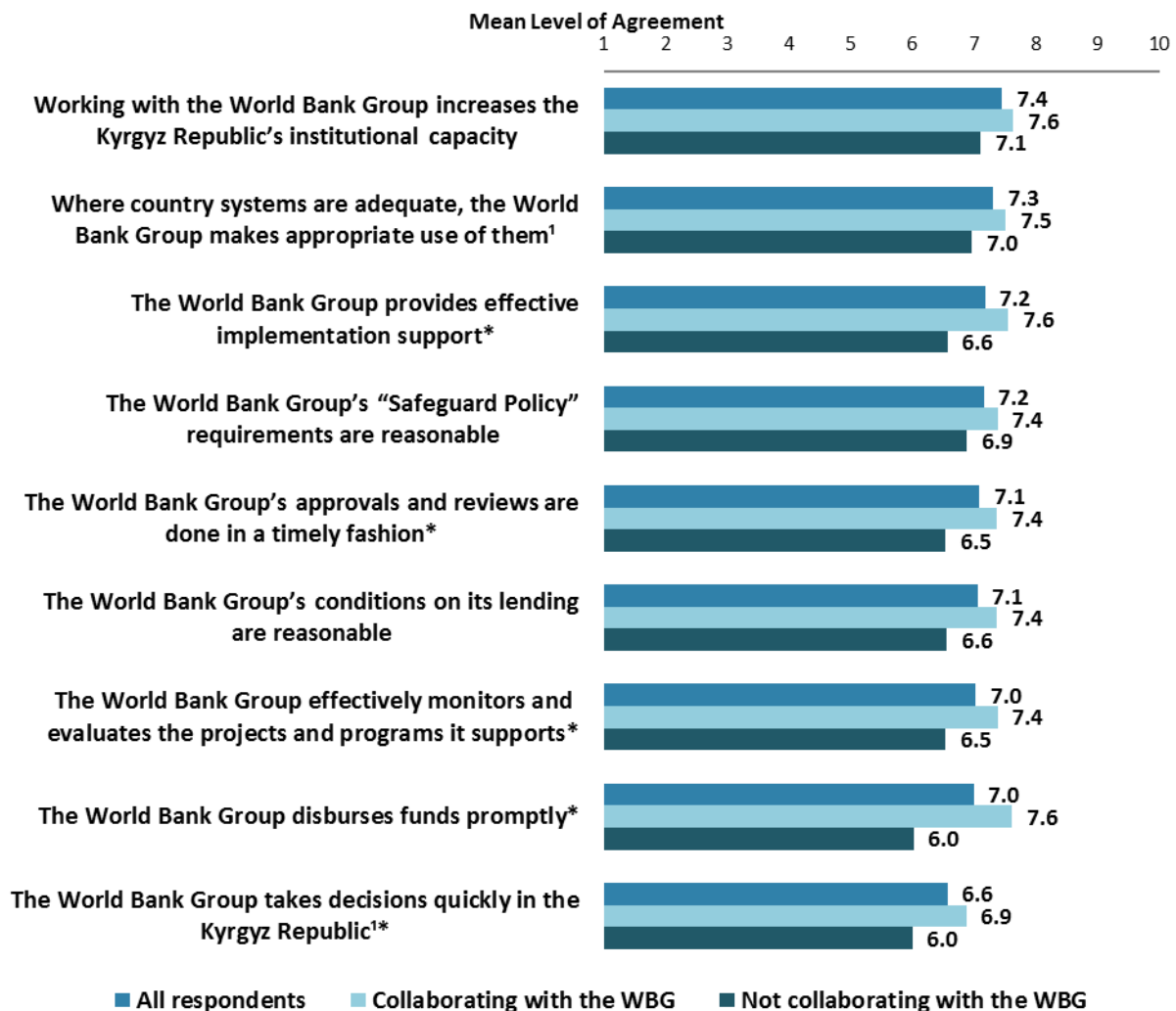

Overall Perceptions

- **Stakeholders:** There were significant stakeholder group differences across several of these aspects of how the WBG operates in the Kyrgyz Republic. For the most part, respondents from PMUs/Consultants on WBG-supported projects and other organizations tended to have the highest levels of agreement whereas respondents from bilateral/multilateral agencies tended to have significantly lower levels of agreement (refer to Appendix B, page 65, for a complete breakdown).
- **Location:** Respondents from Other Areas had significantly higher levels of agreement that *"The World Bank Group takes decisions quickly in the Kyrgyz Republic"* (mean rating = 7.3) compared to respondents from Bishkek (mean rating = 6.2).



"To what extent do you agree/disagree with the following statements?"

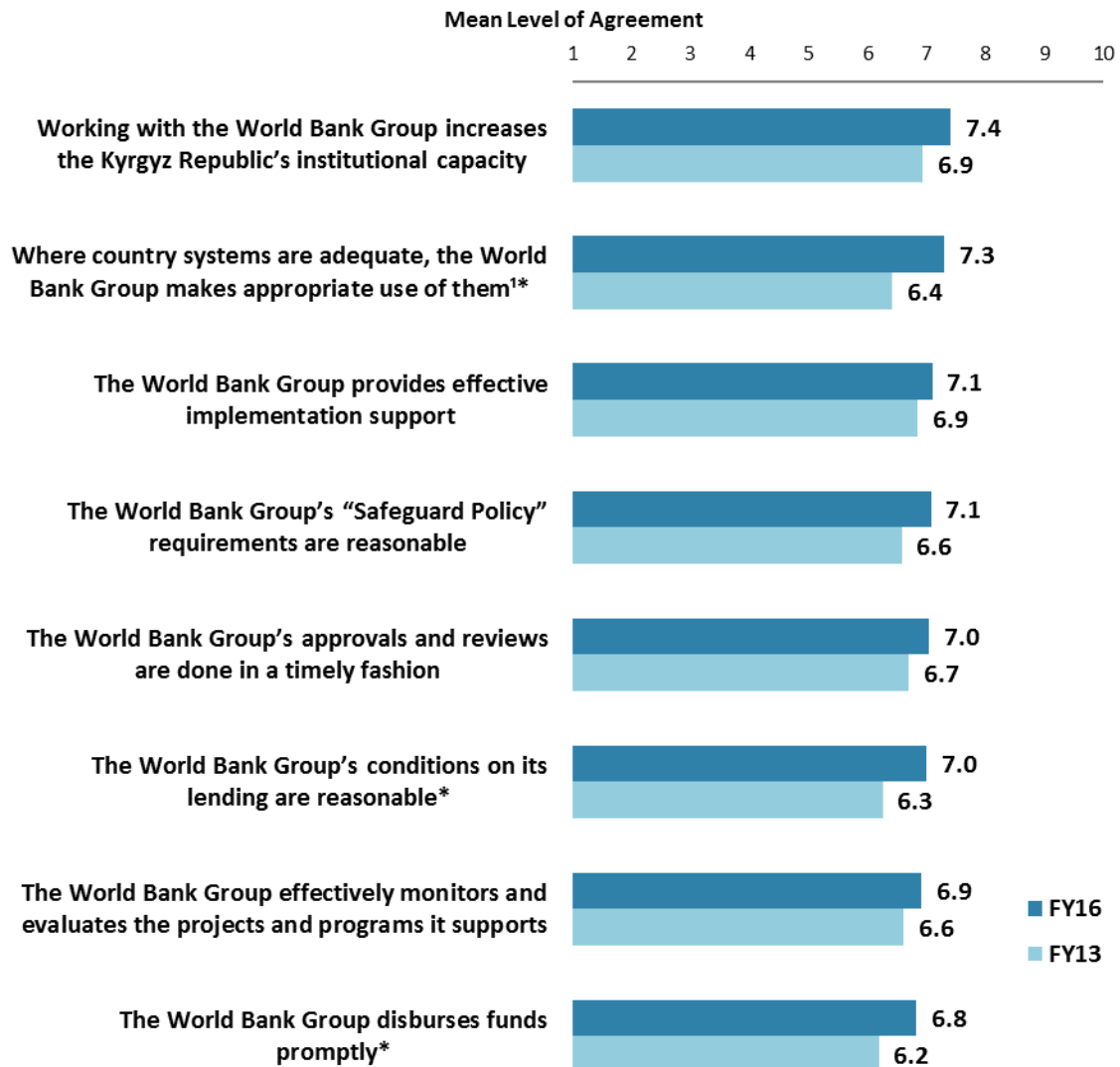

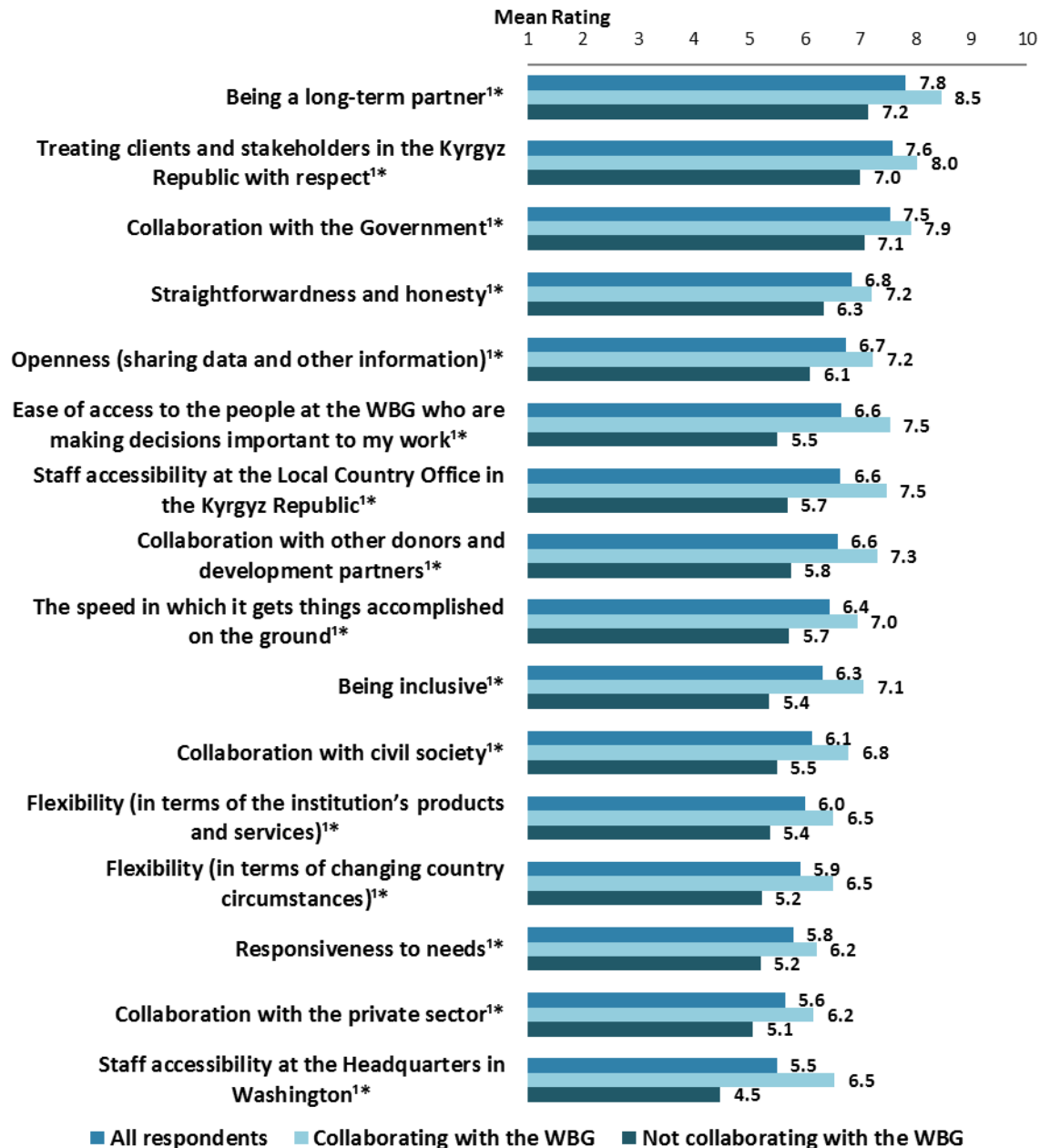

The WBG as an Effective Development Partner

- **Stakeholders:** There were significant stakeholder group differences across several of these aspects of how the WBG operates in the Kyrgyz Republic (see Appendix B, page 65). For the most part, respondents from PMUs/Consultants on WBG-supported projects tended to have the highest ratings whereas respondents from bilateral or multilateral agencies, NGOs/CBOs, and academia tended to have significantly lower ratings.

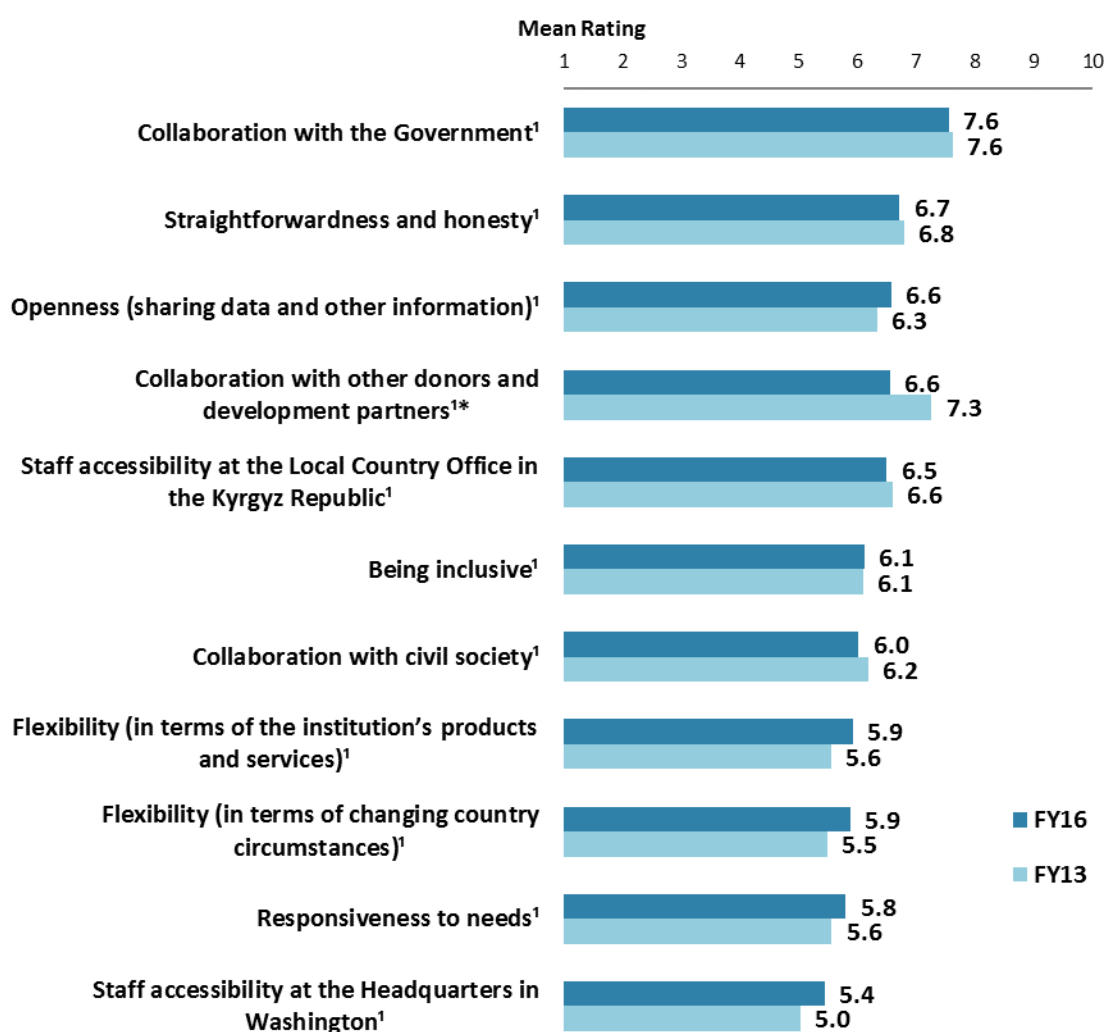

- **Locations:** Respondents from Other Areas had significantly higher ratings for “*Responsiveness to needs*” (mean rating = 6.6), “*Flexibility (in terms of the institution’s products and services)*” (mean rating = 6.7), “*Flexibility (in terms of changing country circumstances)*” (mean rating = 6.7), and “*The speed in which it gets things accomplished on the ground*” (mean rating = 7.3) compared to respondents from Bishkek (mean ratings = 5.5, 5.8, 5.6, and 6.1, respectively).

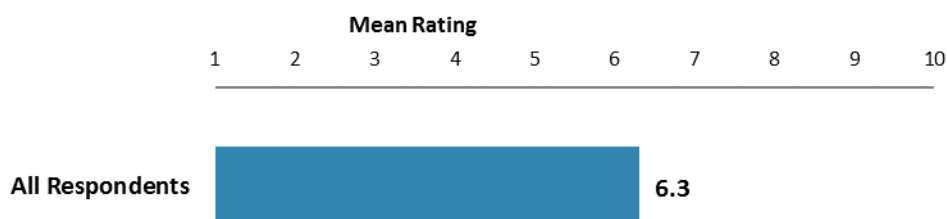

- **Stakeholders:** Respondents from the office of the President/Prime Minister/Minister and PMUs/Consultants on WBG-supported projects gave the highest ratings for the extent to which the WBG measures and corrects its work in real time in the Kyrgyz Republic whereas respondents from independent government institutions gave significantly lower ratings.
- **Collaboration:** Respondents who collaborate with the WBG gave significantly higher ratings for the extent to which the WBG measures and corrects its work in real time (mean rating = 6.8) compared to respondents who do not collaborate with the WBG (mean rating = 5.7).



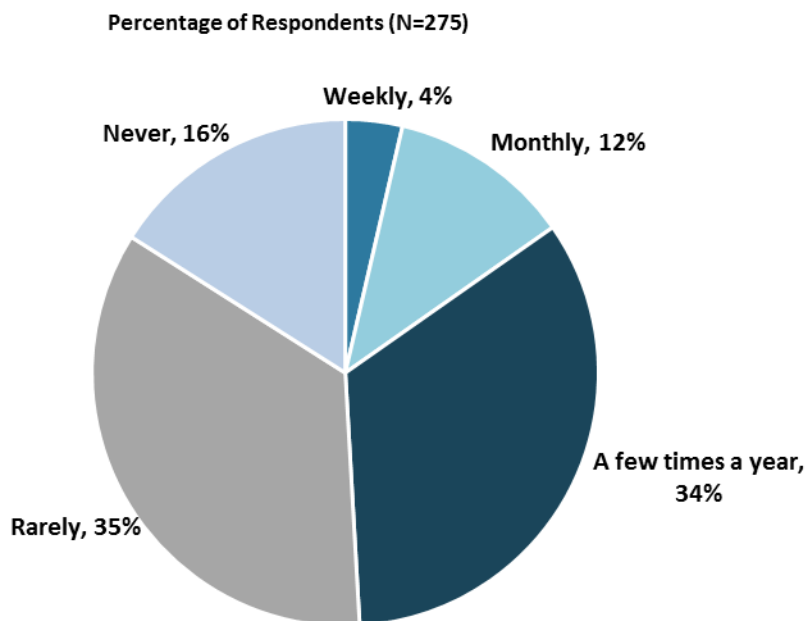

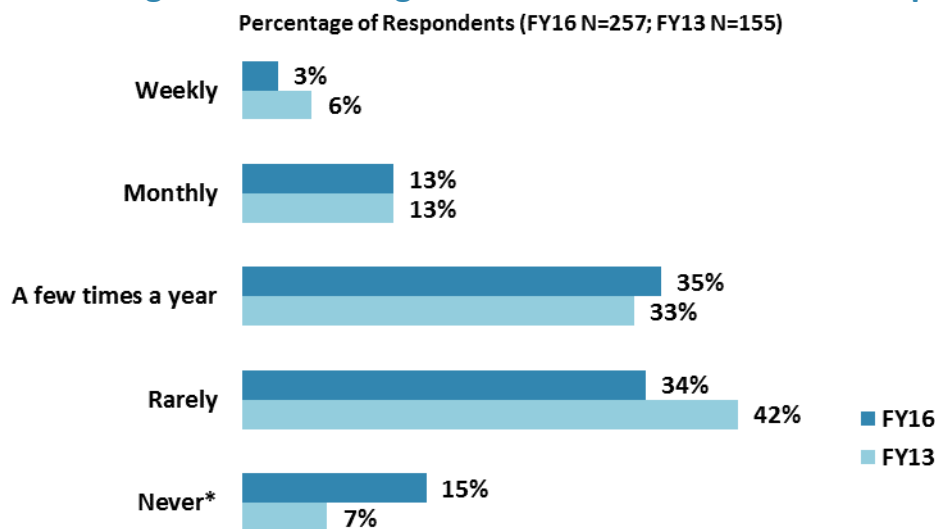
Frequency of Consulting WBG Knowledge Work and Activities

- **Stakeholders:** Respondents from PMUs/Consultants on WBG-supported projects indicated the most frequent usage of the WBG's knowledge work (percentage of respondents = 38% weekly/monthly) whereas respondents from the private sector and other organizations indicated significantly less frequent usage (81% and 80% rarely/never, respectively).

"How frequently do you consult World Bank Group knowledge work and activities in the work you do?" (Respondents chose from a list.) *Significantly different between FY16 and FY13

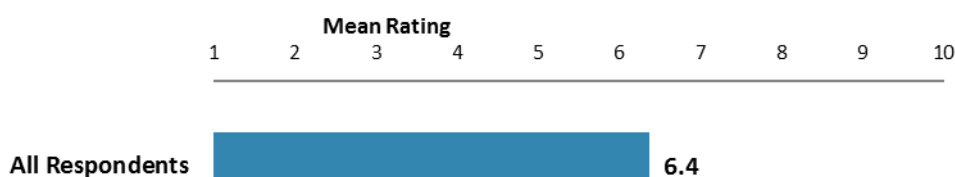

Meeting the Kyrgyz Republic's Knowledge Needs (*Indicator Question*)

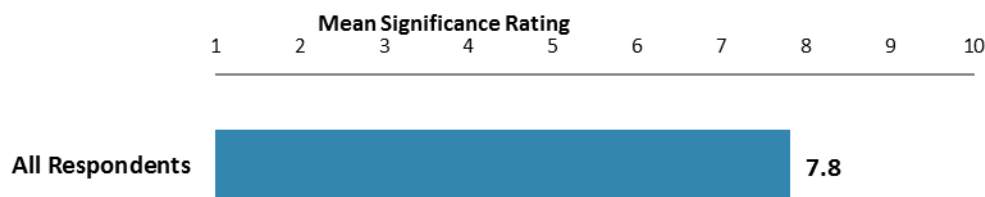
- **Year comparison:** Respondents in this year's Country Survey had statistically similar levels of agreement that the WBG meets the Kyrgyz Republic's needs for knowledge services (weighted mean = 6.4) compared to respondents from the FY '13 Country Survey (weighted mean = 6.4)¹¹.
- **Collaboration:** Respondents who are collaborating with the WBG had significantly higher levels of agreement that the WBG meets the Kyrgyz Republic's needs for knowledge services (mean rating = 7.0) compared to respondents who are not collaborating with the WBG (mean rating = 5.8).

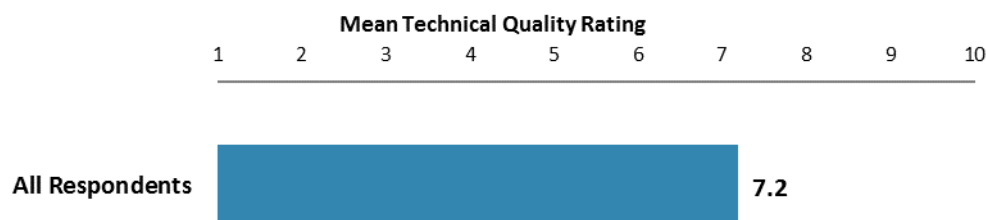

- **Year comparison:** Respondents in this year's Country Survey gave statistically similar ratings for the technical quality of the WBG's knowledge work and activities (weighted mean = 7.2) compared to respondents from the FY '13 Country Survey (weighted mean = 7.0)¹²
- **Stakeholders:** Respondents from PMUs/Consultants on WBG-supported projects, the private sector, and other organizations gave the highest ratings for the technical quality of the WBG's knowledge work and activities whereas employees of ministries and respondents from NGOs/CBOs, the financial sector/private banks, the media, academia, and independent government institutions gave significantly lower ratings.
- **Collaboration:** Respondents who are collaborating with the WBG gave significantly higher ratings for the technical quality of the WBG's knowledge work and activities (mean rating = 7.6) compared to respondents who are not collaborating with the WBG (mean rating = 6.8).



"Overall, how would you rate the technical quality of the World Bank Group's knowledge work and activities?" (1-"Very low technical quality", 10-"Very high technical quality")

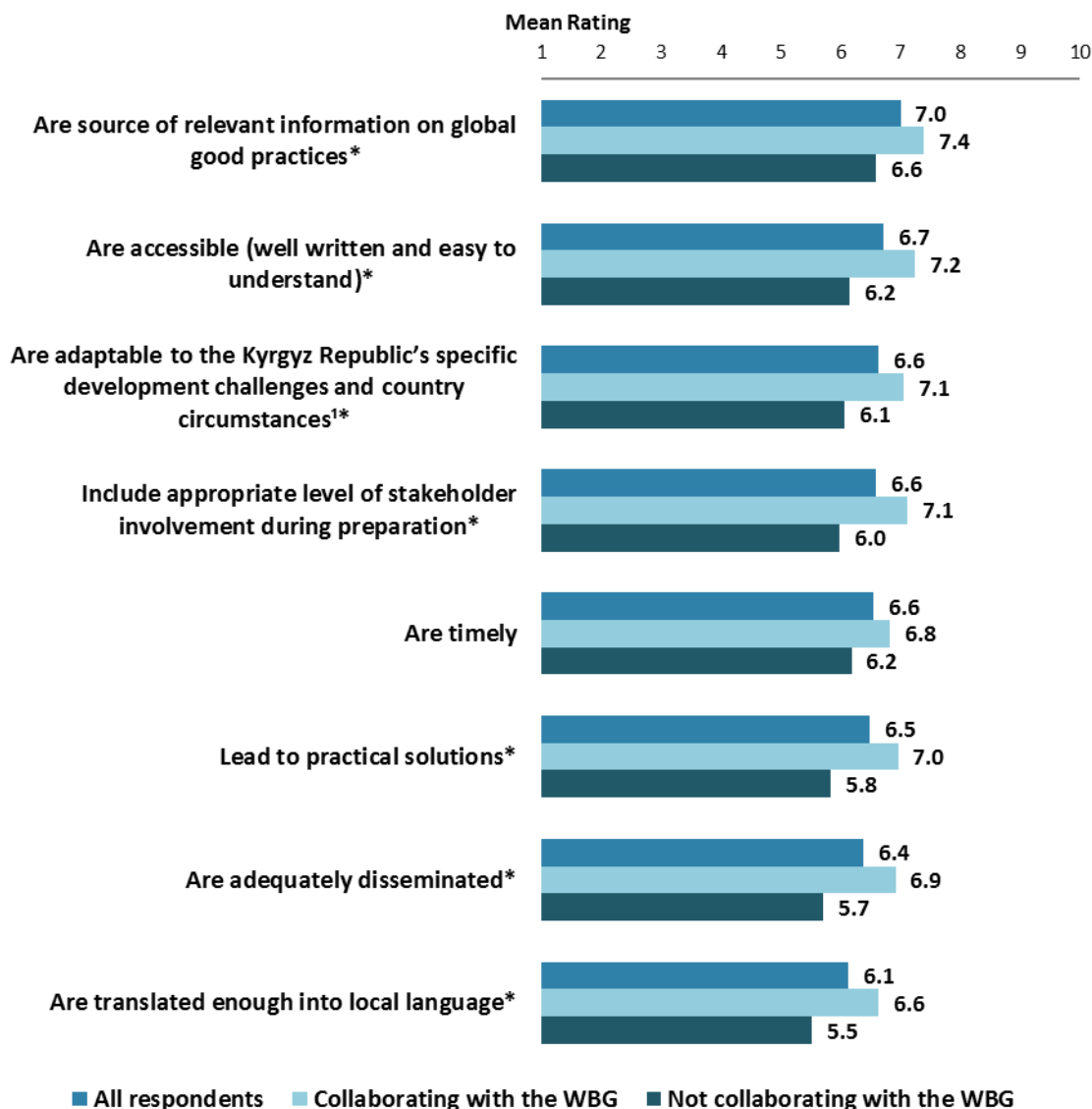

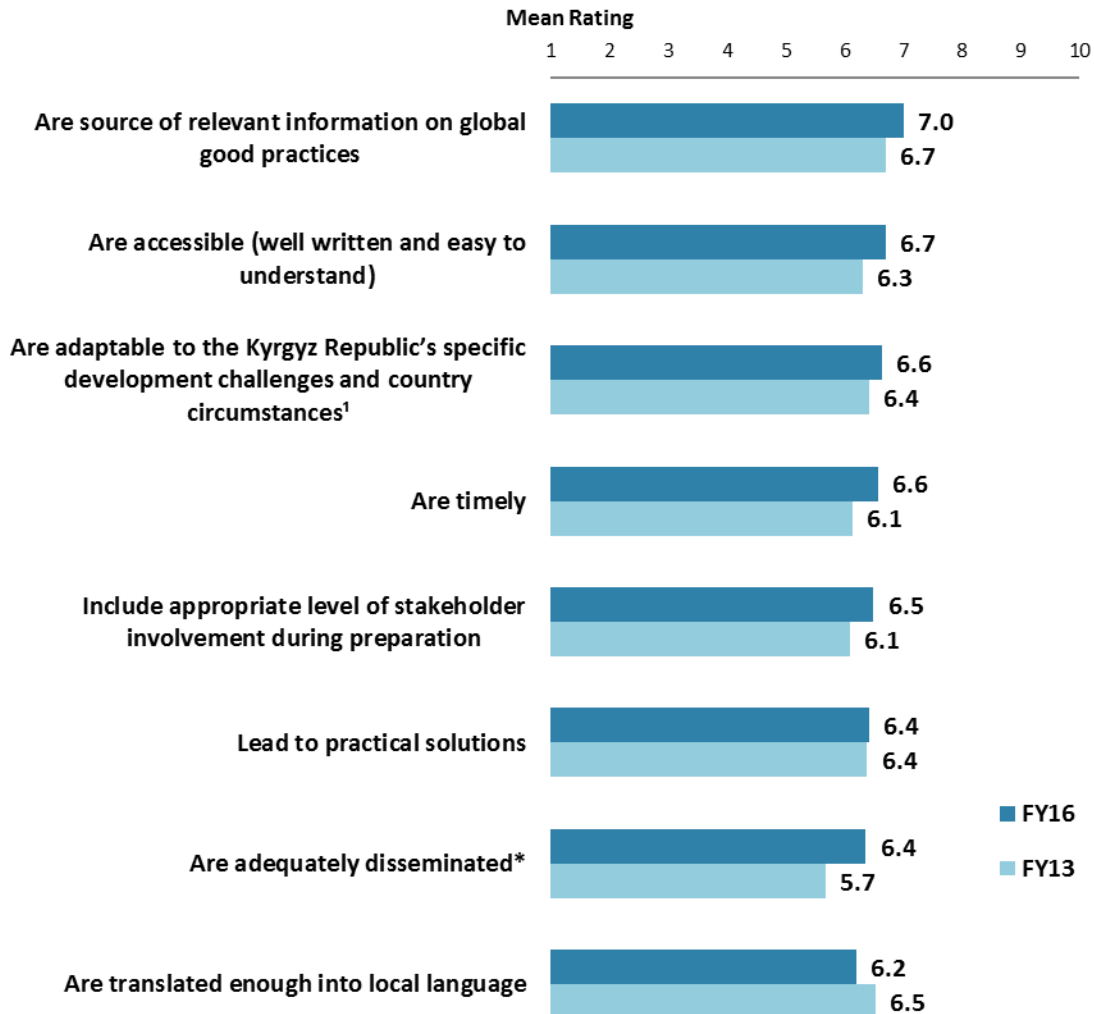

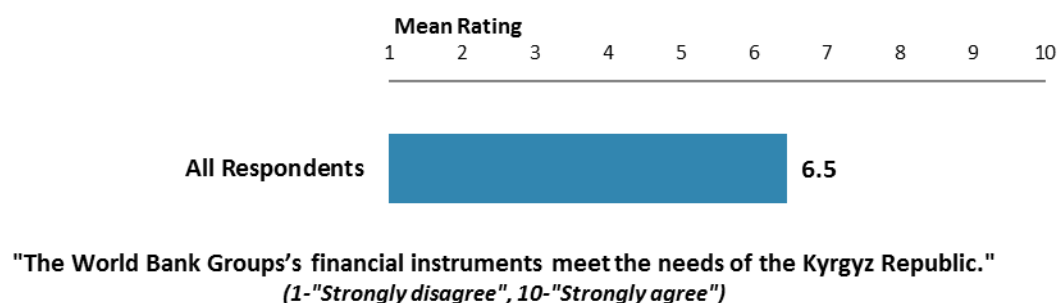

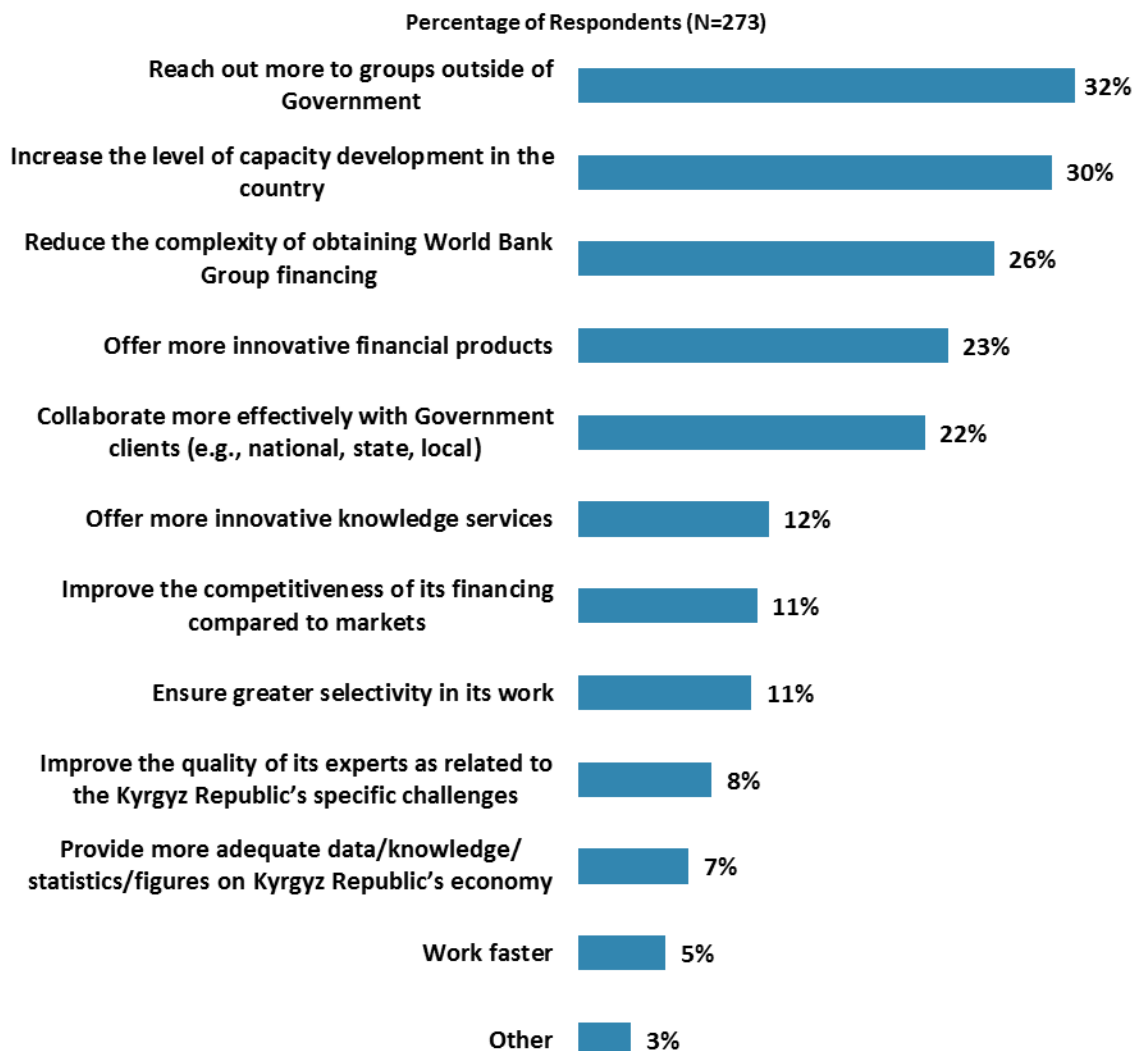

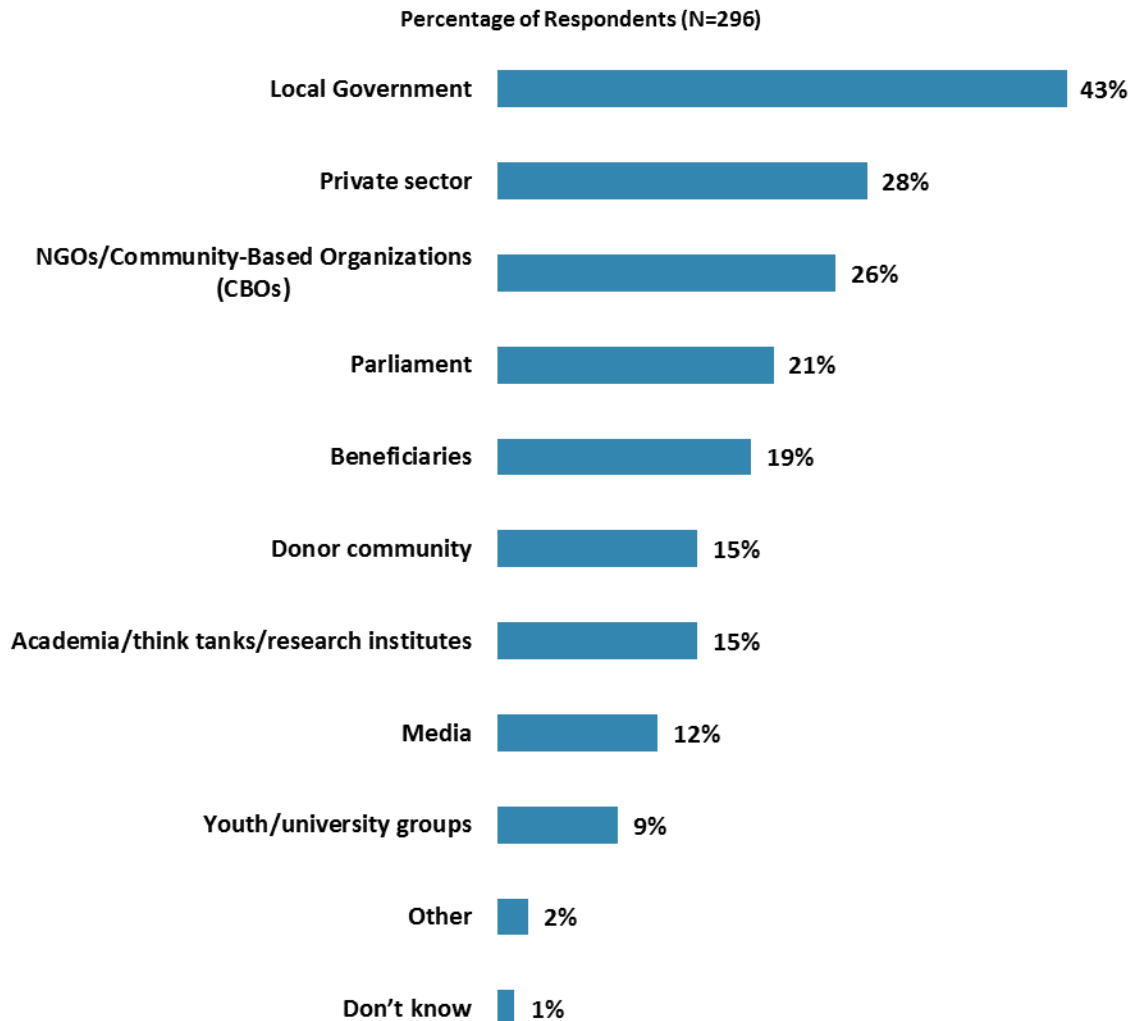

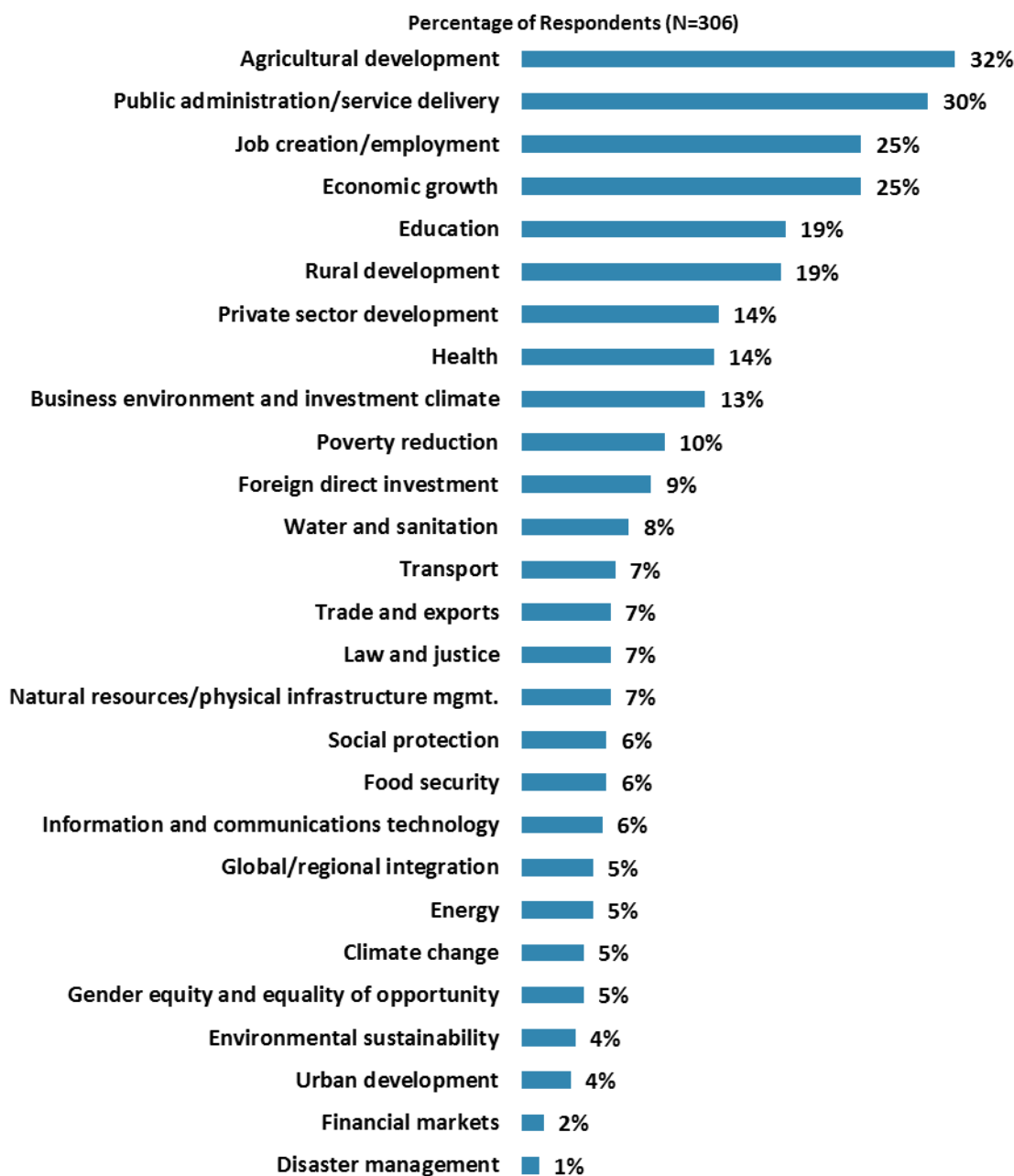

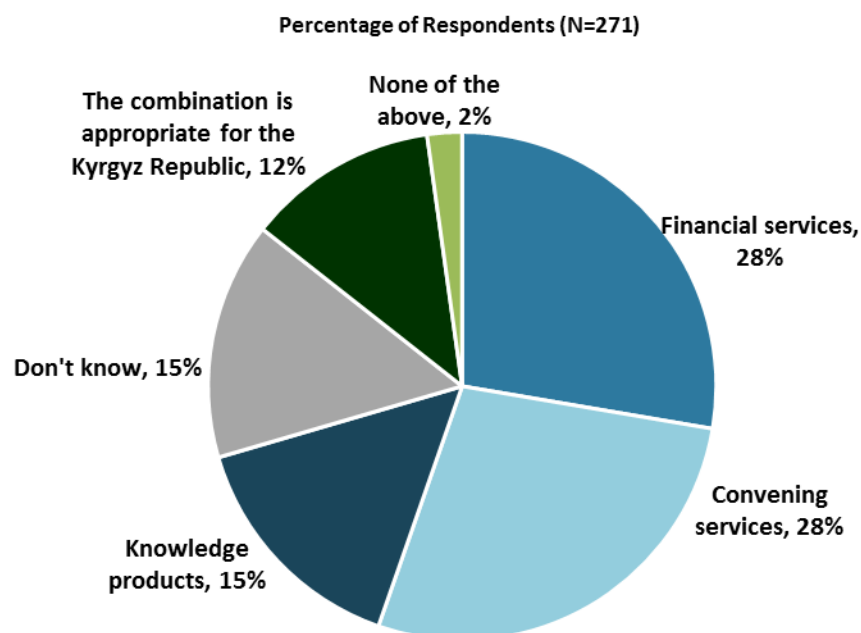

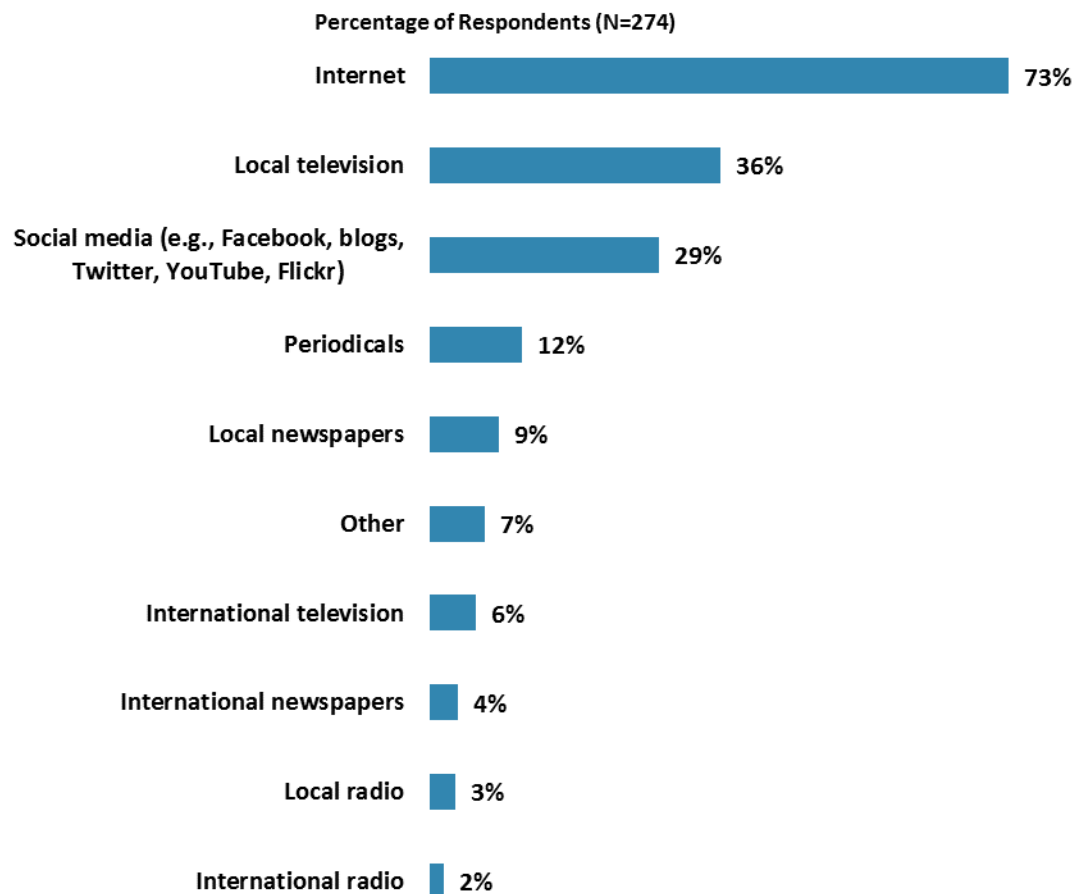

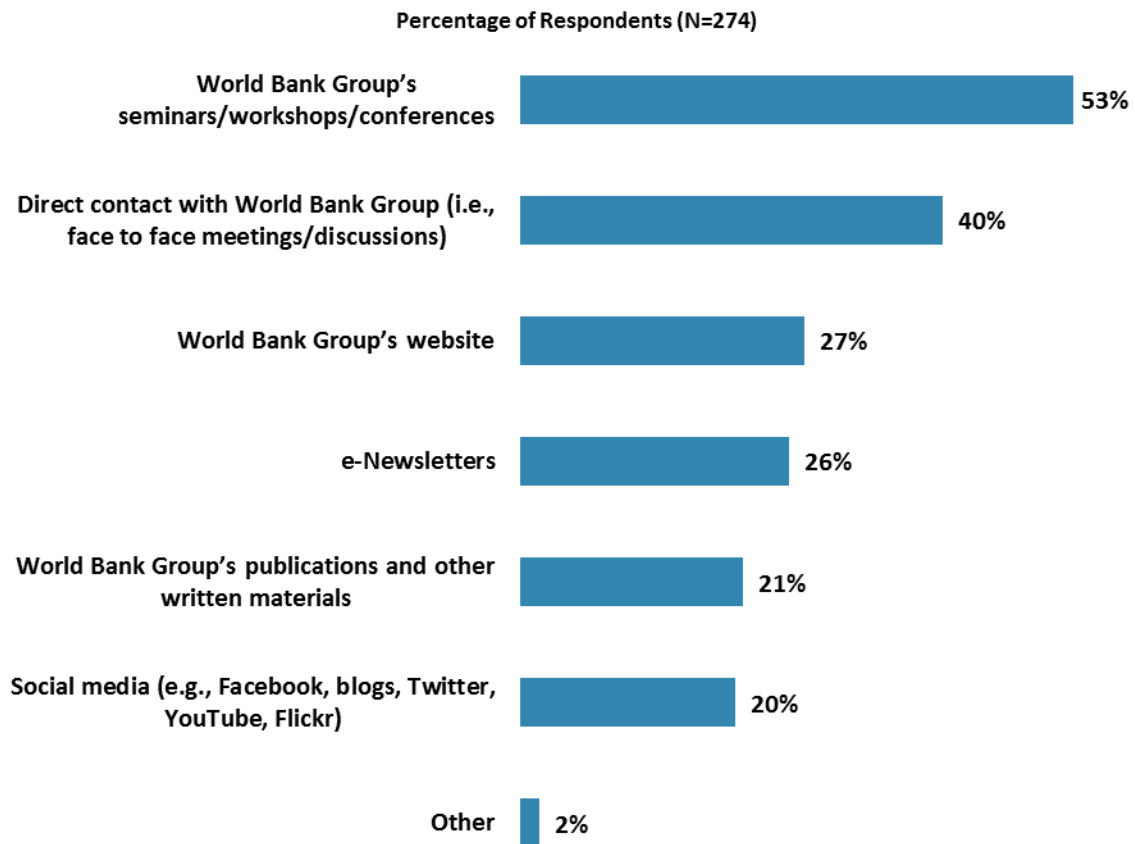

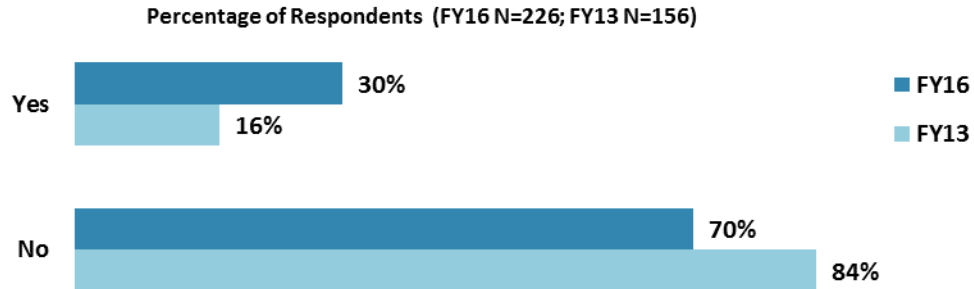


"How would you prefer to receive information from the World Bank Group?
(Choose no more than TWO)" (Respondents chose from a list. Responses combined.)

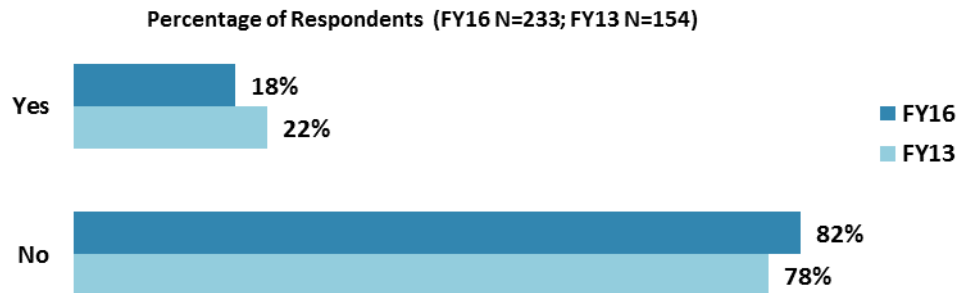

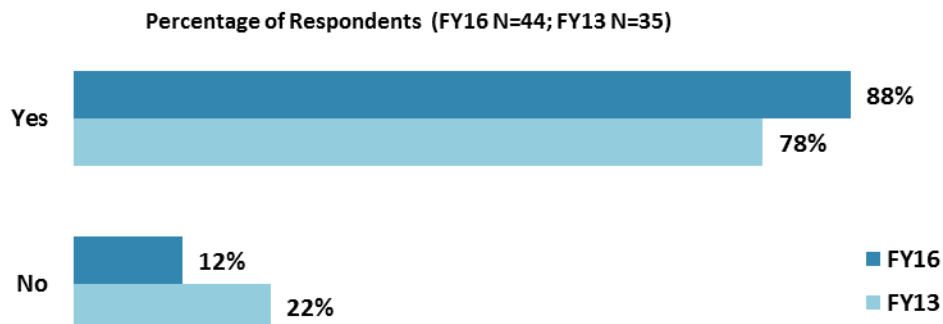

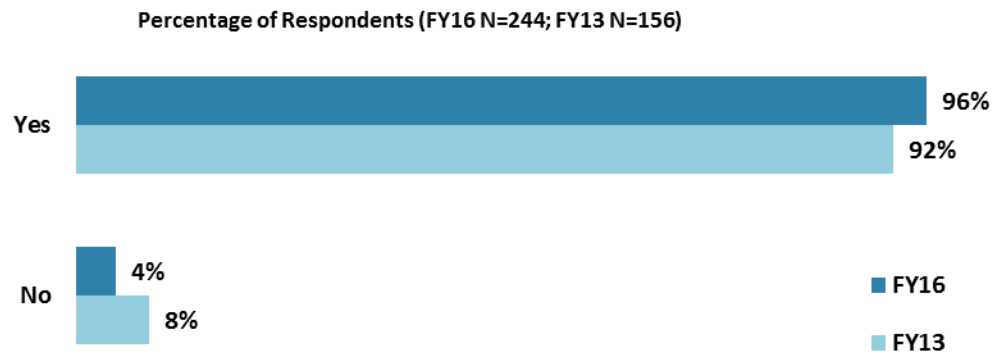


"Were you able to obtain this information?"

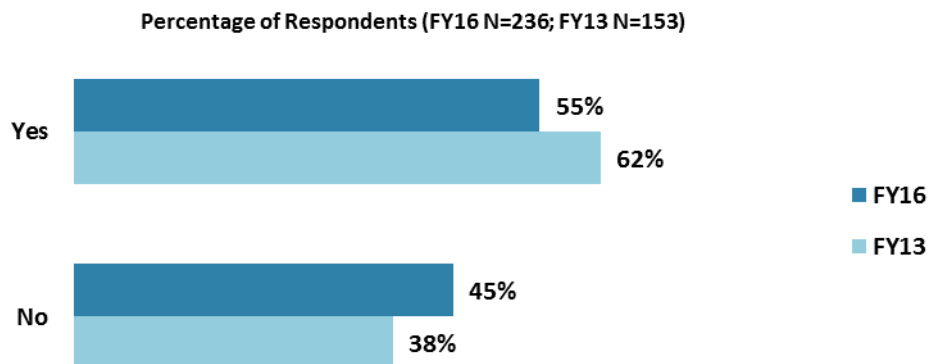

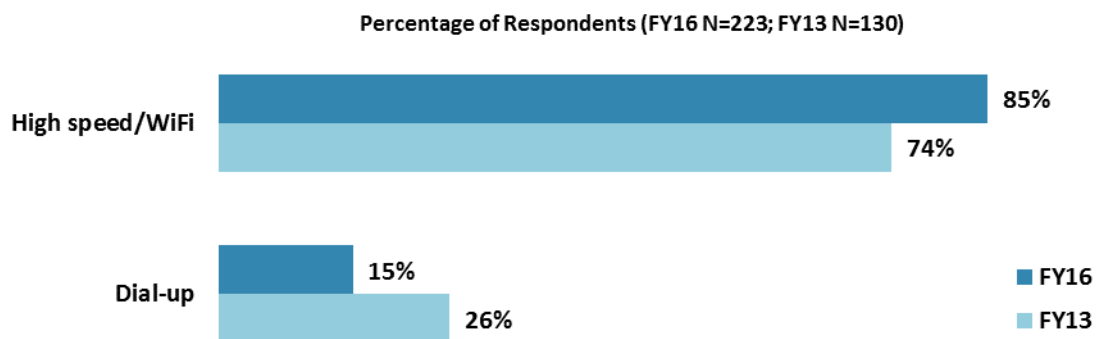
"Do you have access to the Internet?"

WBG Website Internet Access

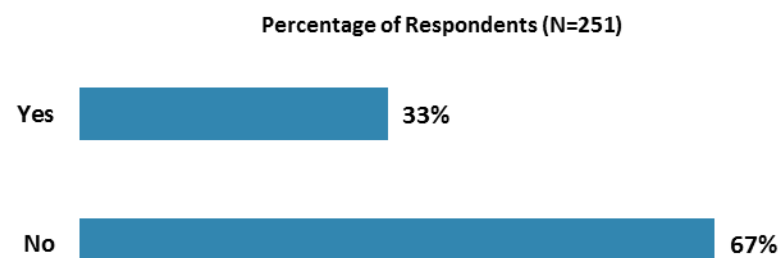


"Which Internet connection do you use primarily when visiting a World Bank Group website?"
