I. Objectives

This survey was designed to assist the World Bank Group (WBG) in gaining a better understanding of how stakeholders in Jamaica perceive the WBG. The survey explored:

- *General Issues Facing Jamaica*
- *Overall Attitudes toward the World Bank Group*
- *World Bank Group's Effectiveness and Results*
- *The World Bank Group's Knowledge Work and Activities*
- *Working with the World Bank Group*
- *The Future Role of the World Bank Group in Jamaica*
- *Communication and Information Sharing*
- *Background Information*

II. Methodology

From June to September 2016, 244 stakeholders of the WBG in Jamaica were invited to provide their opinions on the WBG's work in the country by participating in a country opinion survey. Participants were drawn from the Office of the President, Prime Minister; office of a minister; office of a parliamentarian; ministries/ministerial departments/implementation agencies; Project Management Units (PMUs) overseeing implementation of WBG projects; consultants/contractors working on WBG-supported projects/programs; local governments; bilateral/multilateral agencies; private sector organizations; private foundations; the financial sector/private banks; NGOs/community based organizations; the media; independent government institutions; trade unions; faith-based groups; youth groups; academia/research institutes/think tanks; the judiciary branch; and other organizations. A total of 91 stakeholders participated in the survey (37% response rate).

Some respondents received and returned the questionnaires via courier. Others responded to the survey on the independent online platform, Qualtrics. Respondents were asked about: general issues facing Jamaica; their overall attitudes toward the WBG; the WBG's effectiveness and results; the WBG's knowledge work and activities; working with the WBG; the WBG's future role in Jamaica; and the WBG's communication and information sharing.

Every country that engages in the Country Opinion Survey (COS) must include specific indicator questions that will be aggregated for the World Bank Group's annual Corporate Scorecard. These questions are identified throughout the survey report.

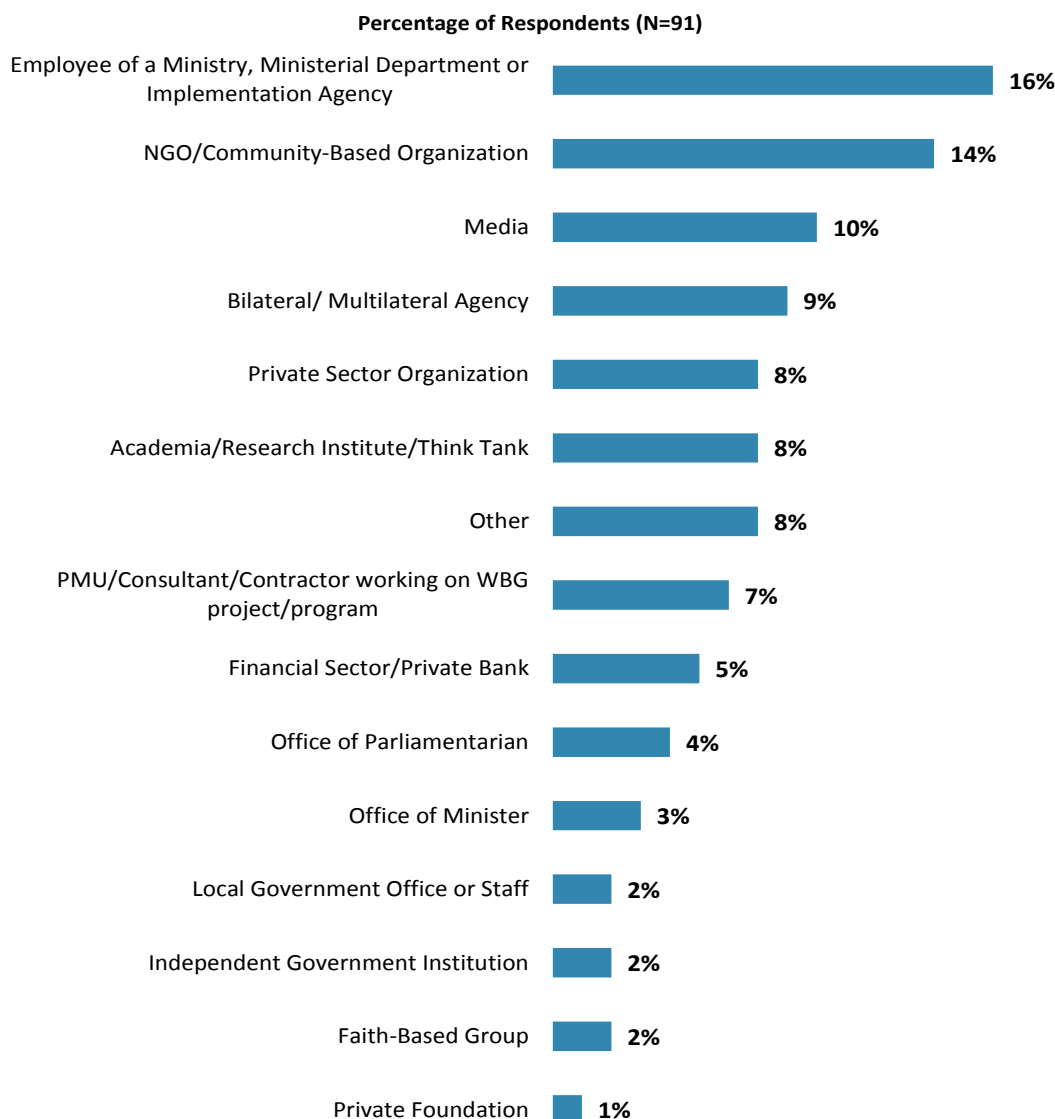
The results in this year's Country Survey were compared to those in the Country Survey conducted in FY'13 (response rate was 68%, N=108). Data were weighted to reach the same stakeholder composition in two years, which allows for year comparisons. Stakeholder groups which were not present in both fiscal years were not included in the comparison. Respondents who belonged to the "other" stakeholder category were not included either. As a result, mean ratings, percentages of respondents, and the total number of respondents in both years are slightly different from those of the original data reported in the FY'13 COS report and the non-weighted data presented in appendices A, B, C, and E. III. Demographics of the Sample

Current Position

- For further analyses, employees from a ministry were combined with consultants working on WBG projects, and respondents from PMUs; respondents from the financial sector/private banks were combined with those from private sector organizations; respondents from NGOs/community based organizations, private foundations, and faith based groups were combined in the “CSO” category; and the small number of respondents from the office of a minister, office of a parliamentarian, local governments, independent government institutions, and other organizations were included in the “Other” category. There were no respondents from the office of the President/Prime Minister, trade unions, youth groups, or the judiciary branch.

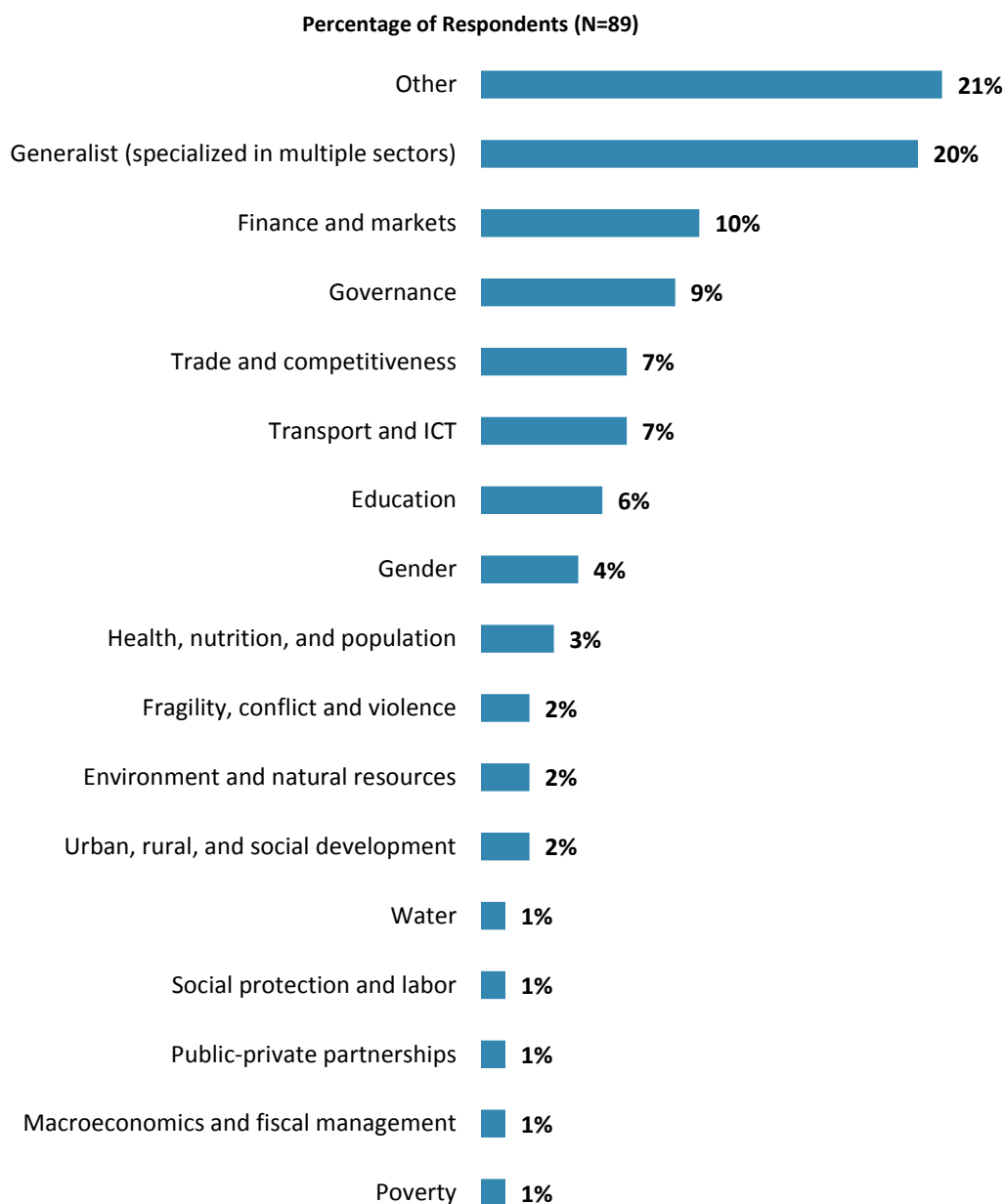


“Which of the following best describes your current position?” (Respondents chose from a list.)

Area of Primary Specialization

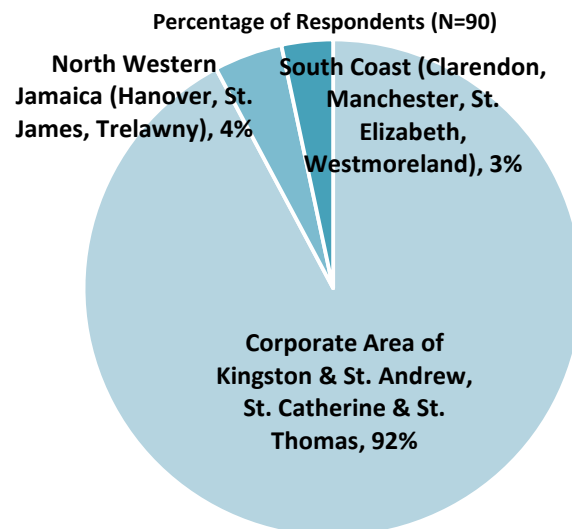


“Please identify the primary specialization of your work.” (Respondents chose from a list.)



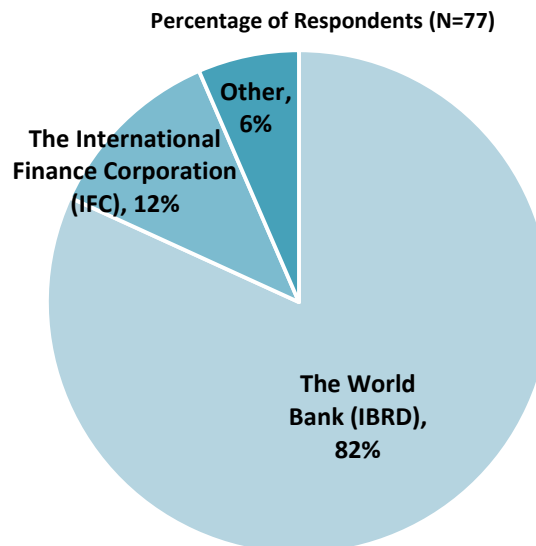

Exposure to Agencies within the World Bank Group



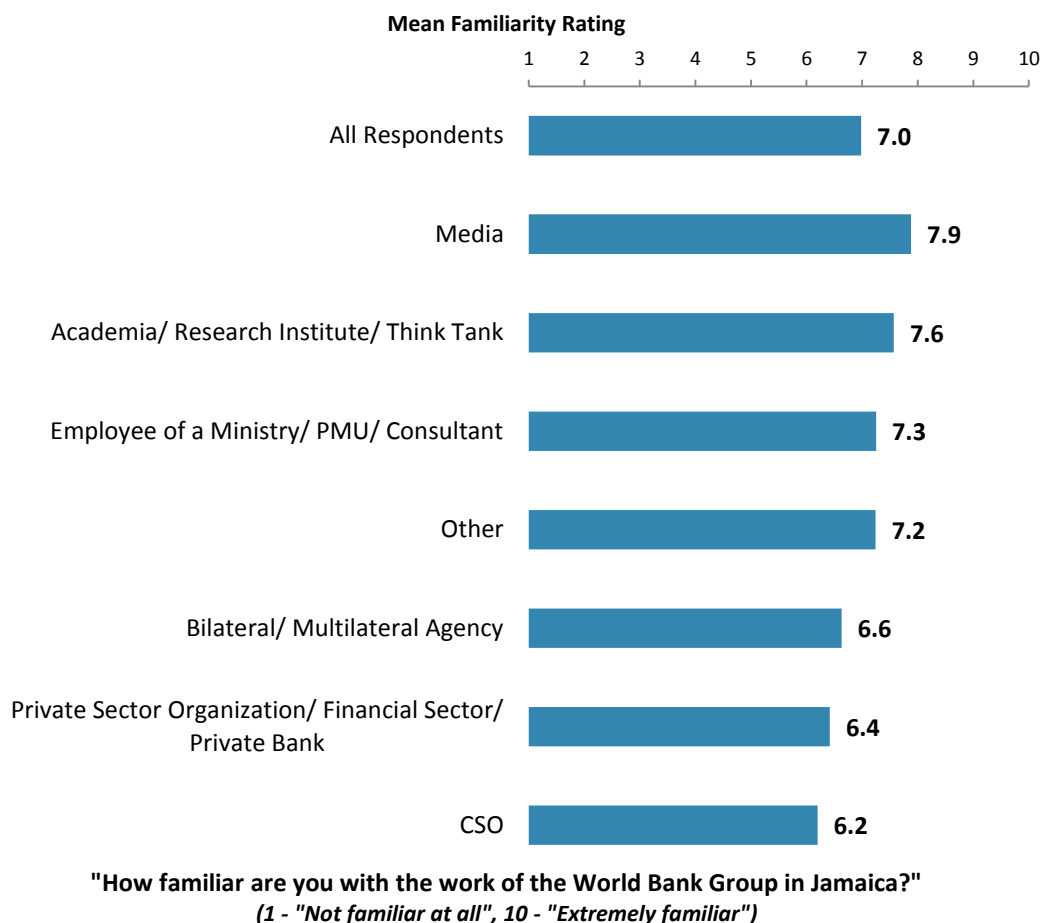

Familiarity with the World Bank Group

- **Year comparison:** Respondents in this year's country survey had significantly lower levels of familiarity with the WBG than the respondents in the FY'13 survey (weighted mean in FY'16 = 7.0; weighted mean in FY'13 = 8.3)¹.
- Respondents' levels of familiarity with the WBG were significantly, strongly correlated with their ratings of the WBG's overall effectiveness in Jamaica, and the extent to which the WBG plays a relevant role in development in Jamaica, and significantly, moderately correlated with the extent to which the WBG helps to achieve development results in the country.



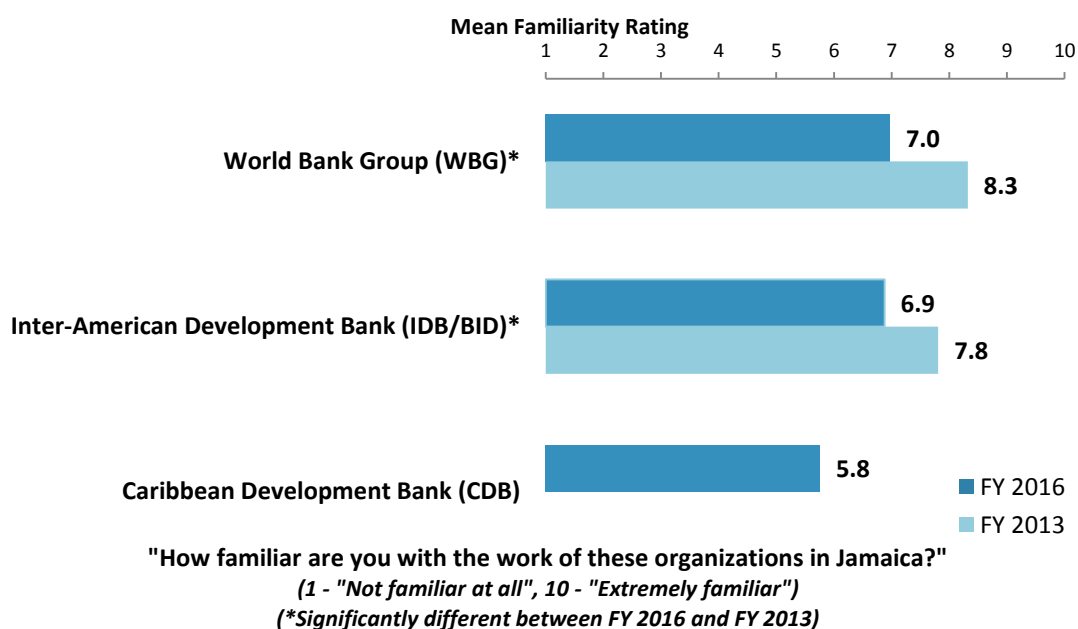

III. Demographics of the Sample (continued)

Familiarity with the World Bank Group and Other Development Banks²

- **Year comparison:** Stakeholders in FY'16 have significantly lower levels of familiarity with the World Bank Group and the Inter-American Development Bank than respondents in the FY'13 survey.
- This year's stakeholders in Jamaica were significantly more familiar with the WBG than the Caribbean Development Bank. They have statistically similar levels of familiarity with the WBG and IDB.



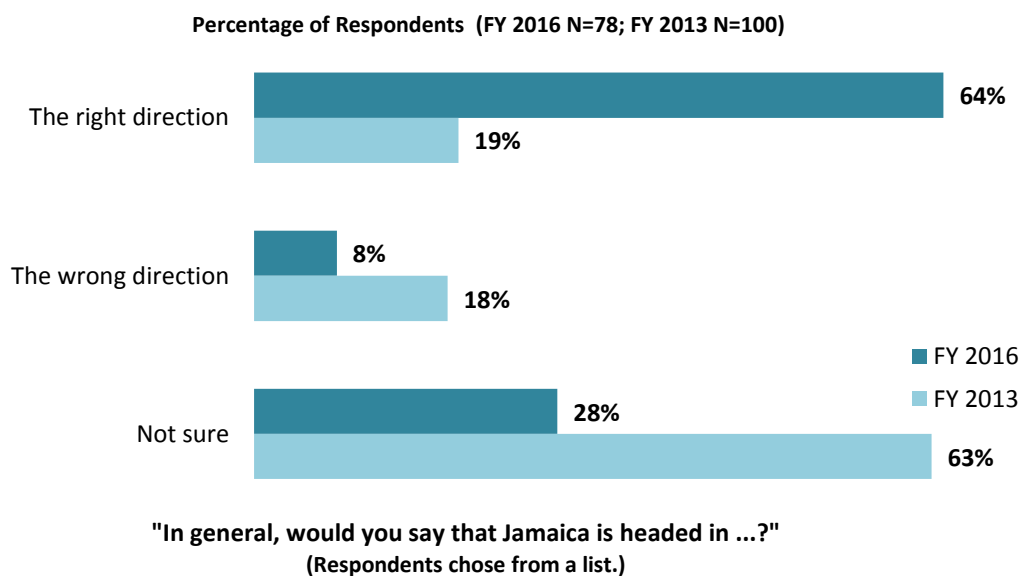

- **Year comparison:** This year's respondents were significantly more likely to believe that Jamaica is headed in the right direction compared to respondents in the FY'13 Country Survey.



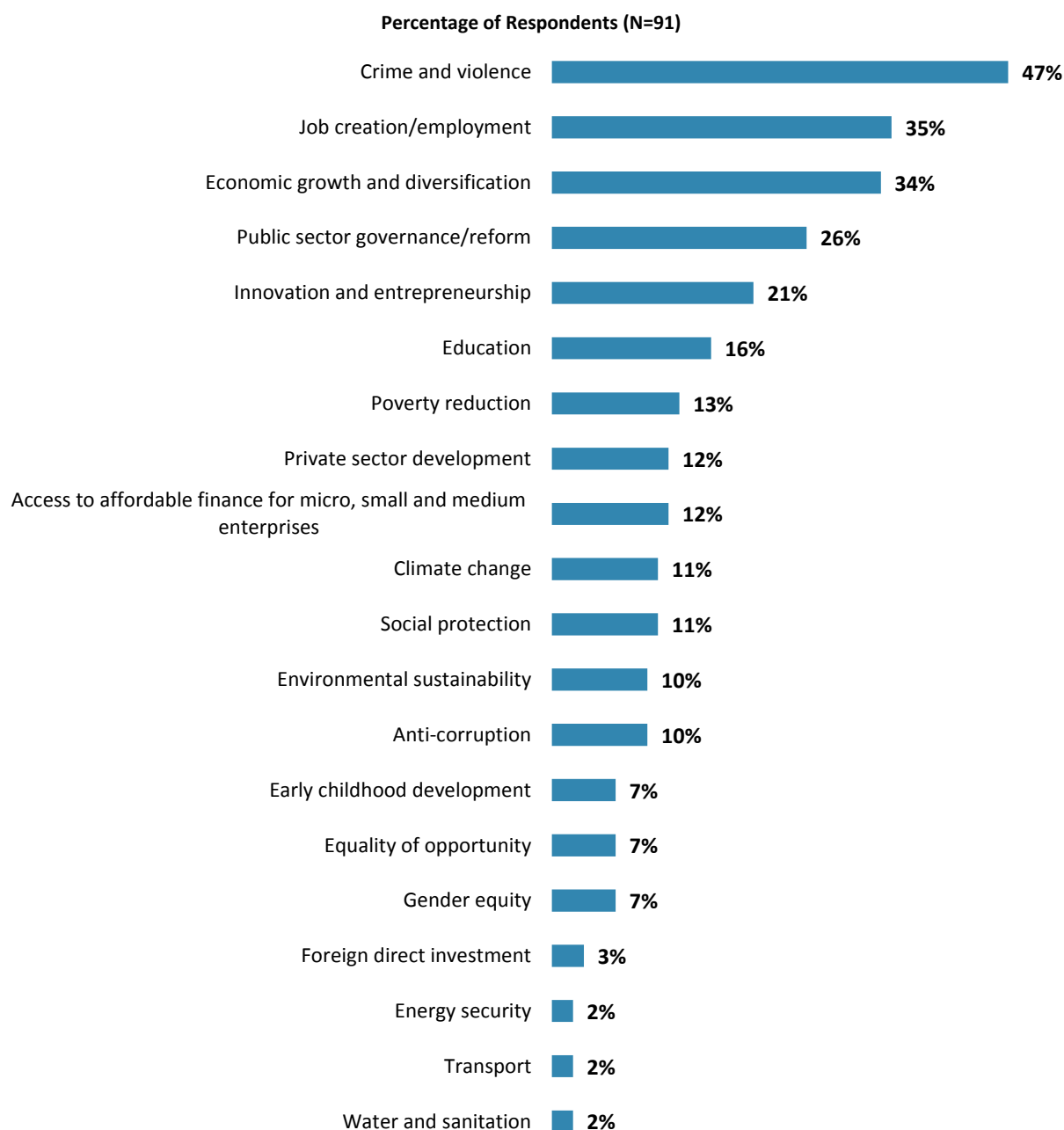

Development Priority

- **Year comparison:** Respondents in the previous FY'13 Country Survey indicated that the most important development priorities in Jamaica were “*job creation/employment/entrepreneurship*” (61%) and “*education and skills development*” (53%).



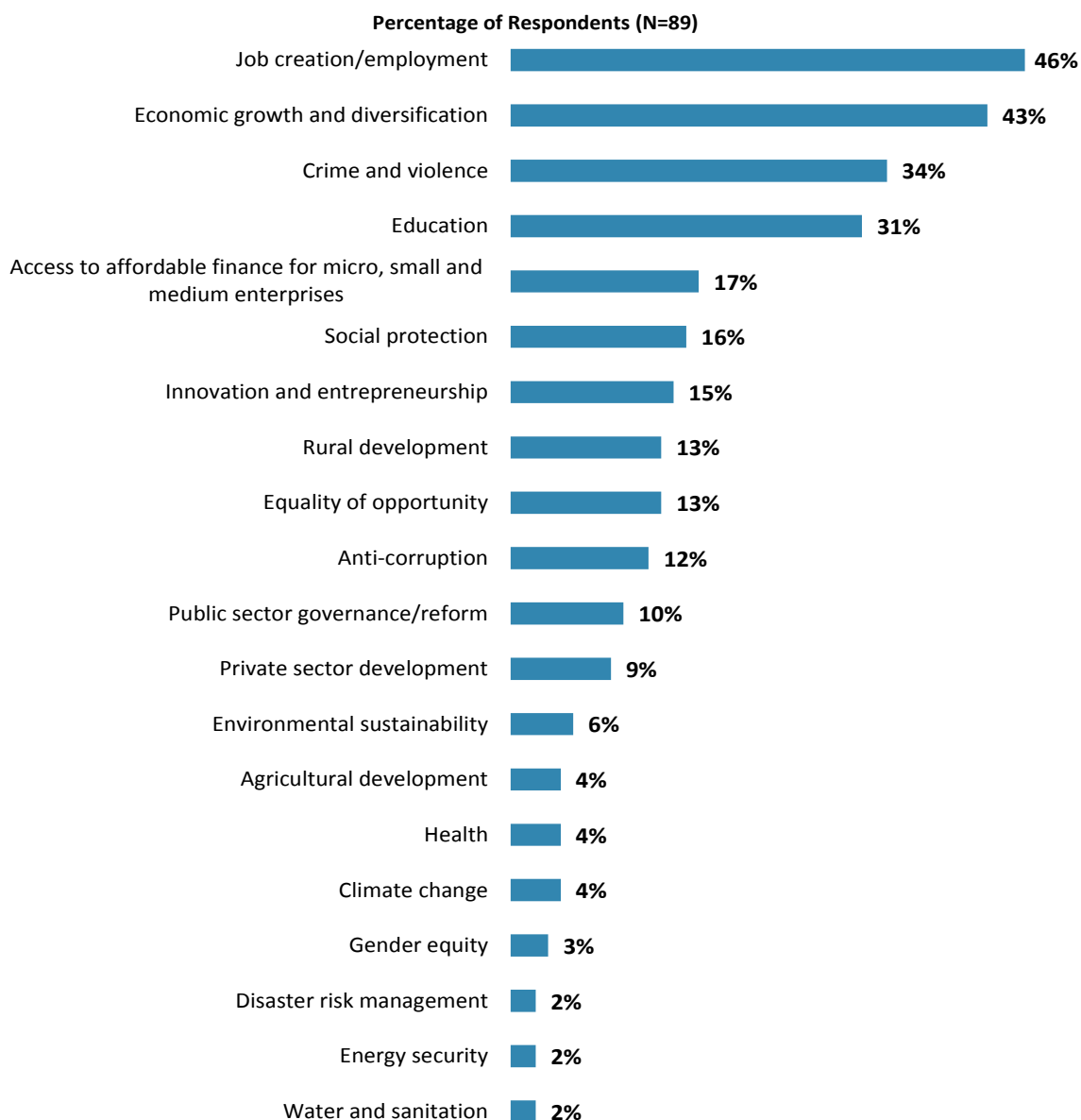
"Listed below are a number of development priorities in Jamaica. Please identify which of the following you consider the most important development priorities in Jamaica. (Choose no more than THREE)"

What Would Contribute Most to Reducing Poverty

- **Year comparison:** In the previous FY'13 Country Survey, respondents indicated that the greatest contributors to poverty reduction in Jamaica were “*job creation/employment/entrepreneurship*” (76%), “*education and skills development*” (61%), and “*equality of opportunity*” (38%).

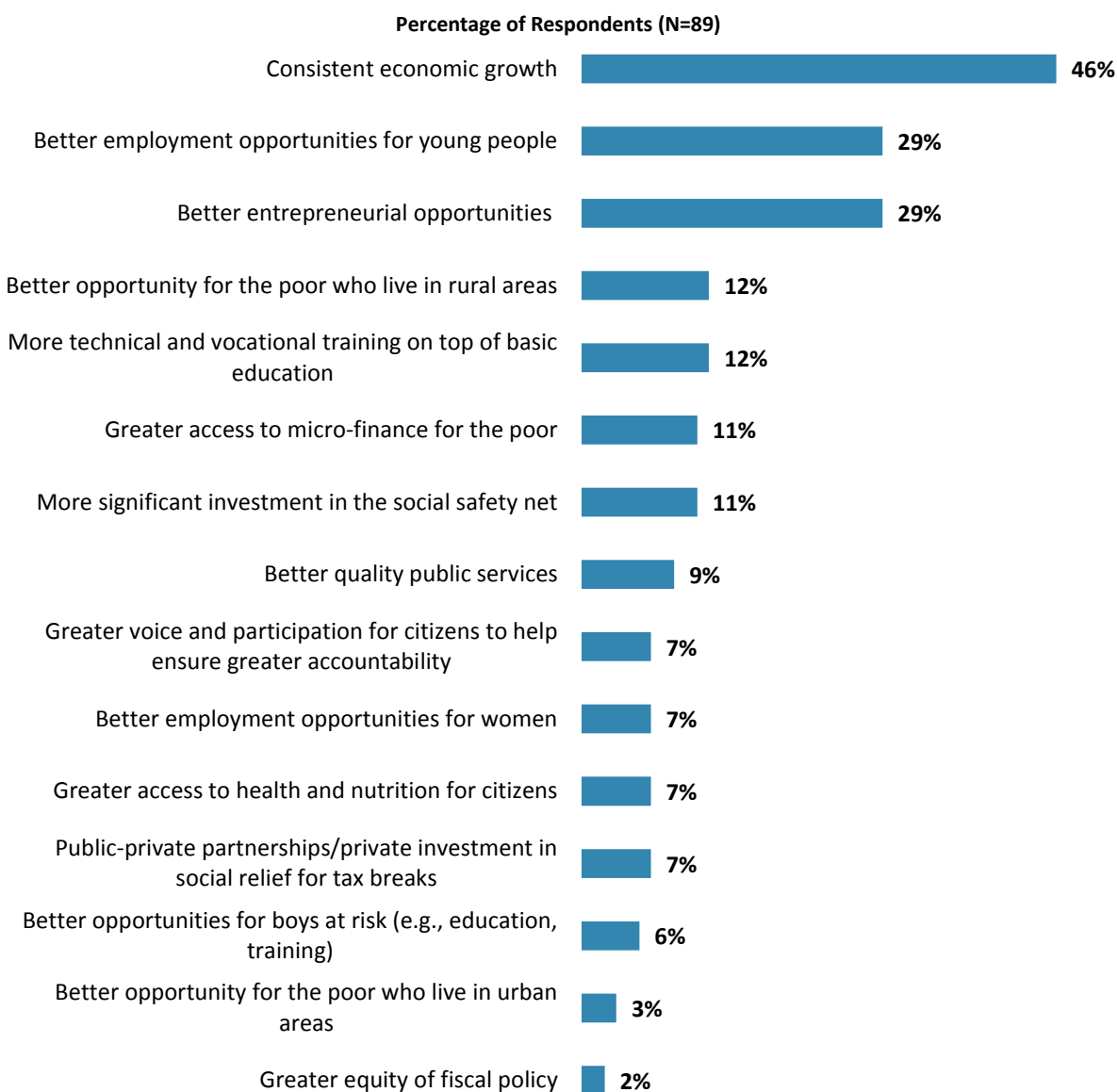

Factors Contributing to “Shared Prosperity”

- **Year comparison:** In the previous FY’13 Country Survey, respondents indicated that shared prosperity in Jamaica would be best illustrated by “*better entrepreneurial opportunities*” (49%) and “*greater voice and participation for citizens to help ensure greater accountability*” (42%).



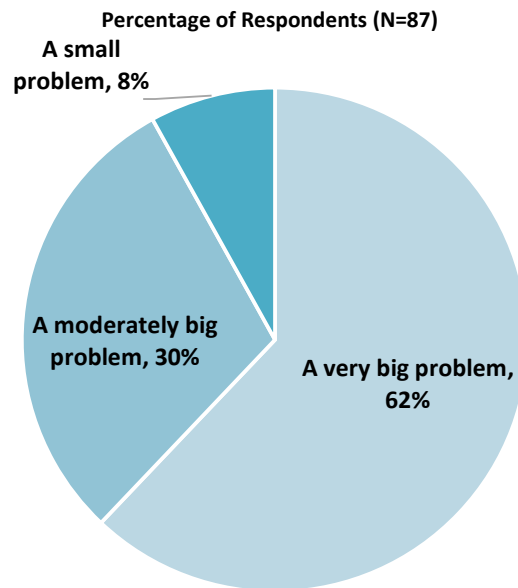

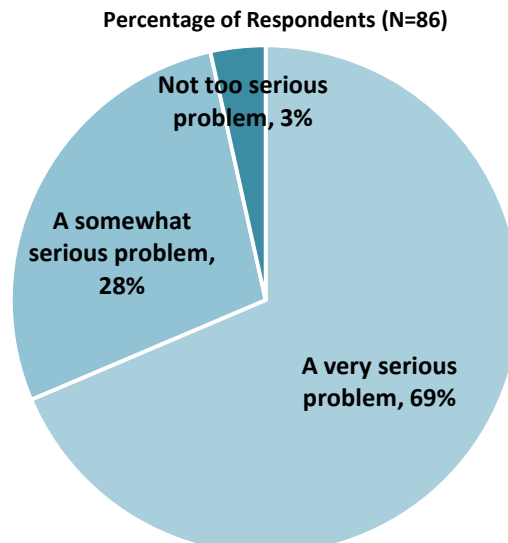

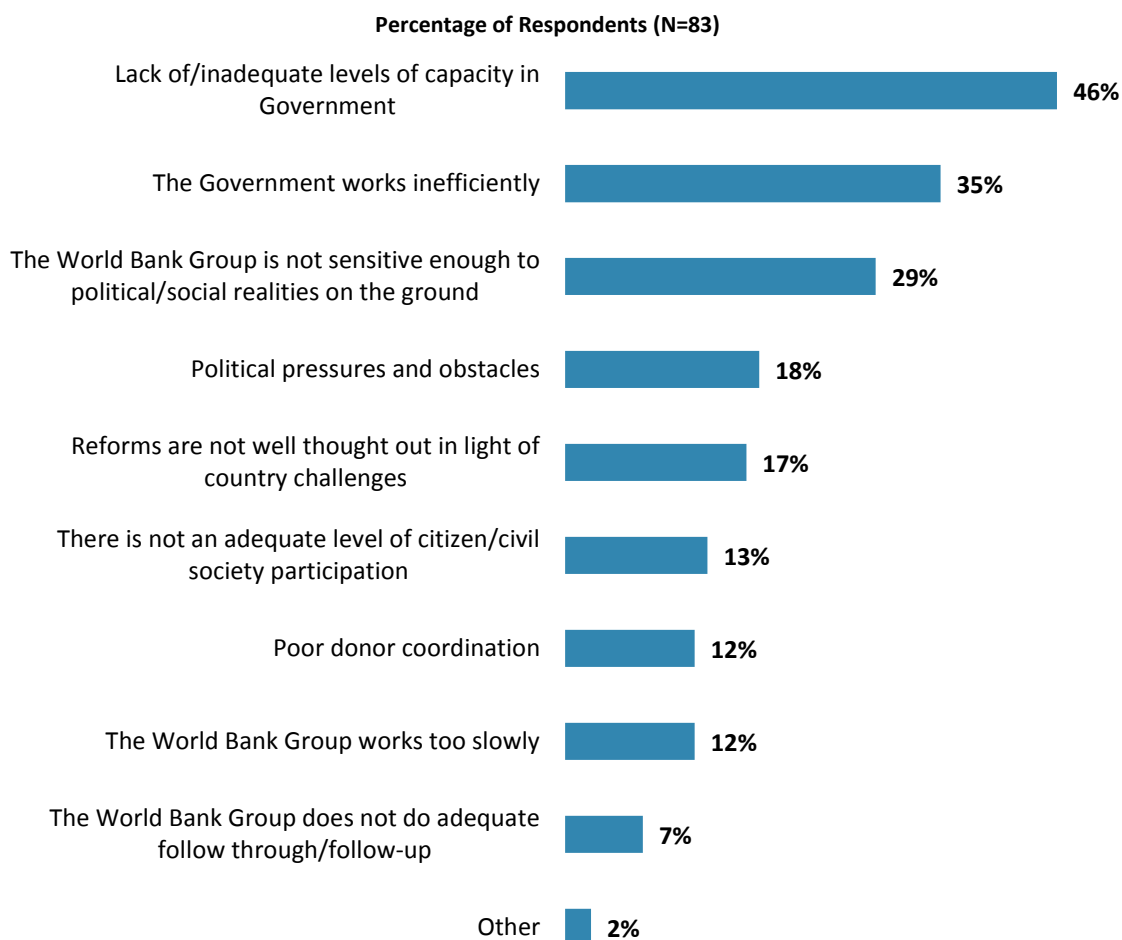

V. Overall Attitudes toward the World Bank Group

Attributing Failed/Slow Reform Efforts

- **Year comparison:** Respondents in the previous FY'13 Country Survey most often attributed failed or slow World Bank assisted reform efforts to that *"the World Bank is not sensitive enough to political/social realities on the ground"* (53%) and that *"there is not an adequate level of citizen/civil society participation"* (47%).

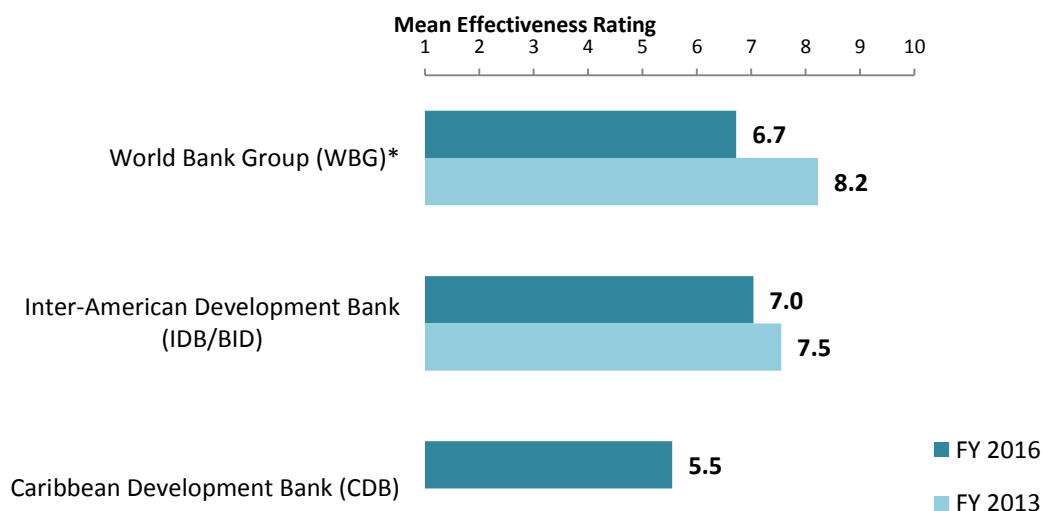

As noted in the “Methodology” section, the indicator questions referred to throughout the survey report are questions that are asked in every country that engages in the Country Opinion Survey. These will be aggregated for the World Bank Group’s annual Corporate Scorecard.

The Effectiveness of the World Bank Group and Other Development Banks⁴ (Indicator Question)

- **Year comparison:** This year’s respondents gave significantly lower ratings for the effectiveness of the WBG than the respondents in FY13. Respondents in the FY’13 and FY’16 Country Surveys gave statistically similar ratings for the effectiveness of the IDB.
- In FY16, stakeholders gave significantly higher ratings for the WBG’s effectiveness than the effectiveness of the Caribbean Development Bank, and statistically similar ratings for the effectiveness of the Inter-American Development Bank.



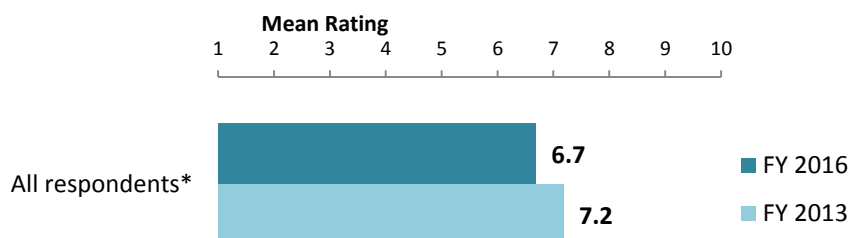
"Overall, please rate your impression of the World Bank Group's effectiveness in Jamaica."

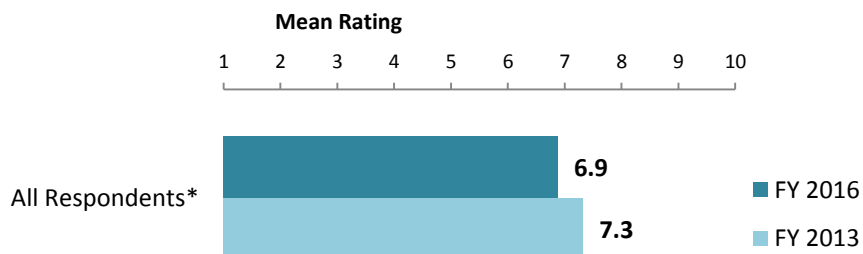

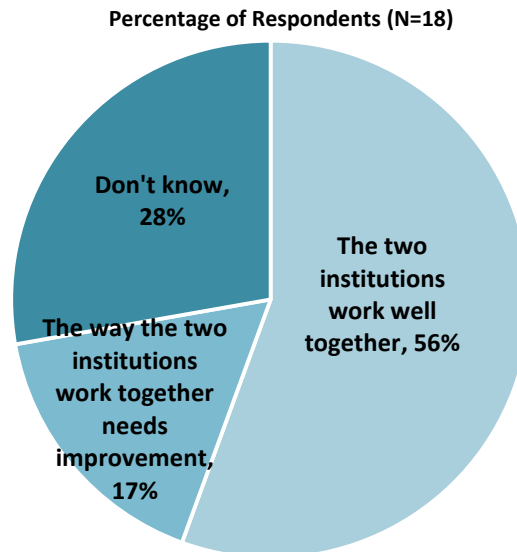

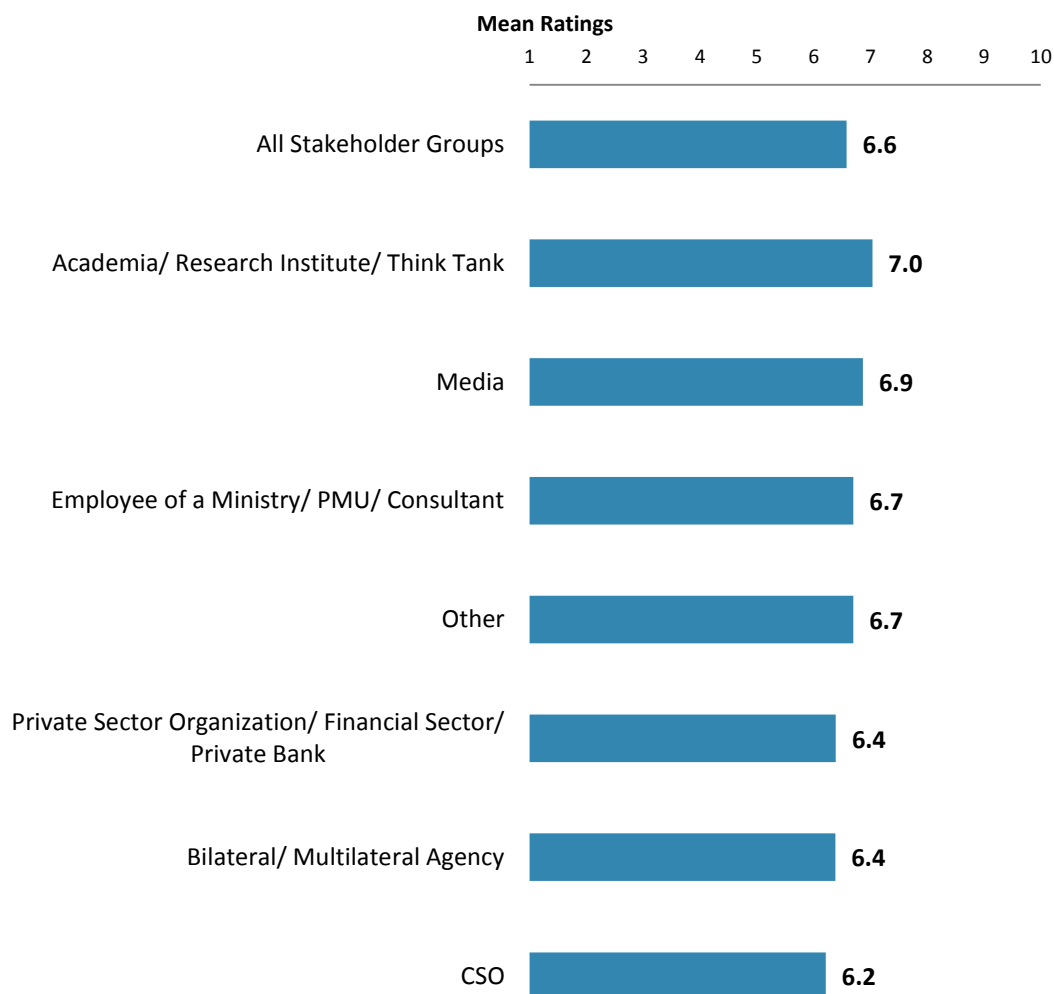

Overall Ratings for Indicator Questions by Stakeholder Groups

- **Stakeholder groups:** Respondents across stakeholders gave statistically similar aggregated mean ratings for the twenty six COS indicator questions. Responses for individual indicator questions by stakeholder groups can be found in Appendix B (see page 58).
- **Collaboration:** Respondents who collaborate with the WBG gave significantly higher overall mean ratings for the twenty six indicator questions than respondents who do not work with the WBG (aggregated means are 6.9 and 6.0 respectively).



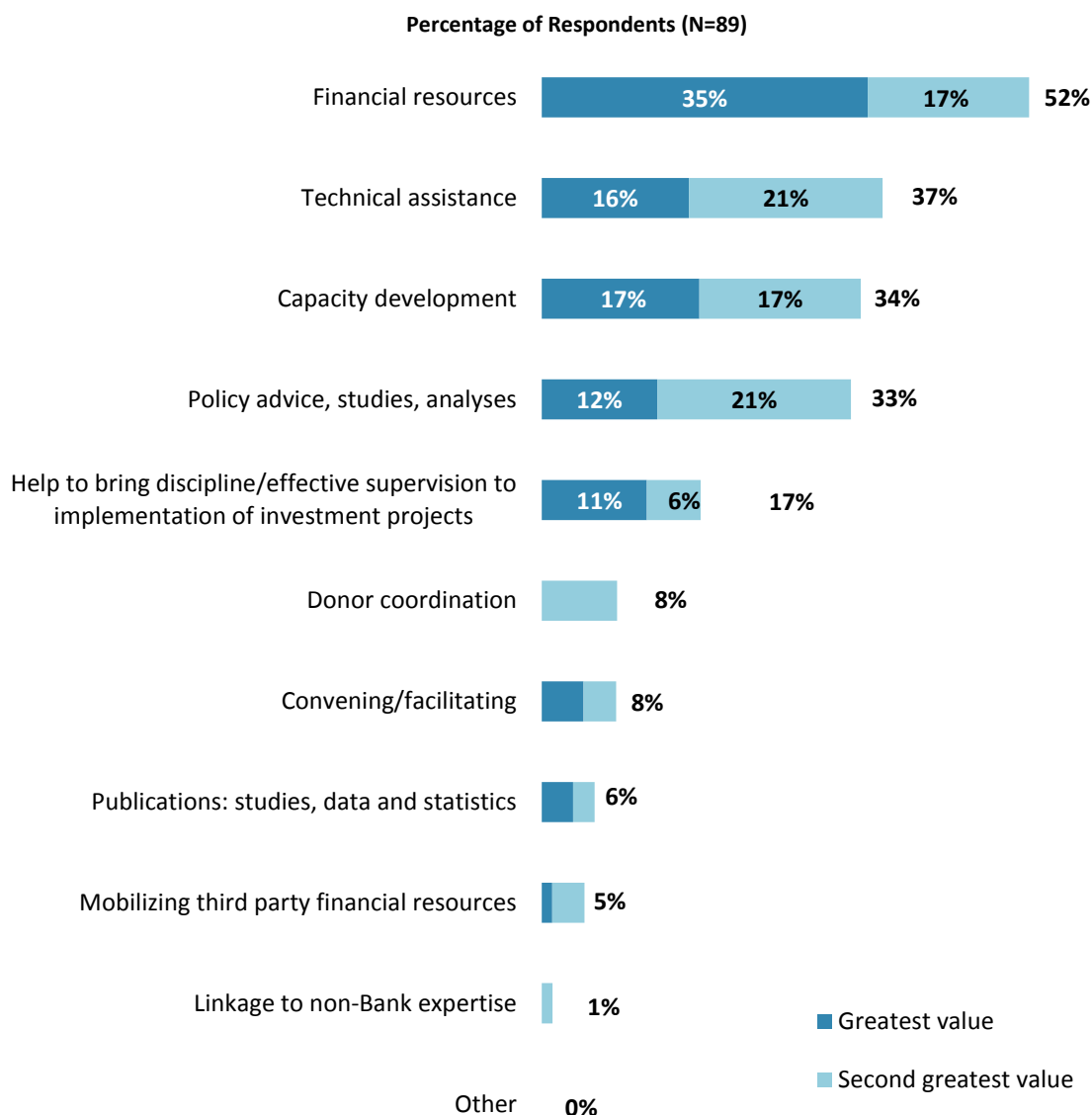
Mean Ratings for All Indicator Questions by Stakeholder Groups on a Scale from 1 to 10

Greatest Value

- **Year comparison:** Respondents in the previous FY'13 Country Survey indicated that the World Bank's greatest value to Jamaica were its "*financial resources: investment lending*" (50%) and "*technical assistance*" (50%).



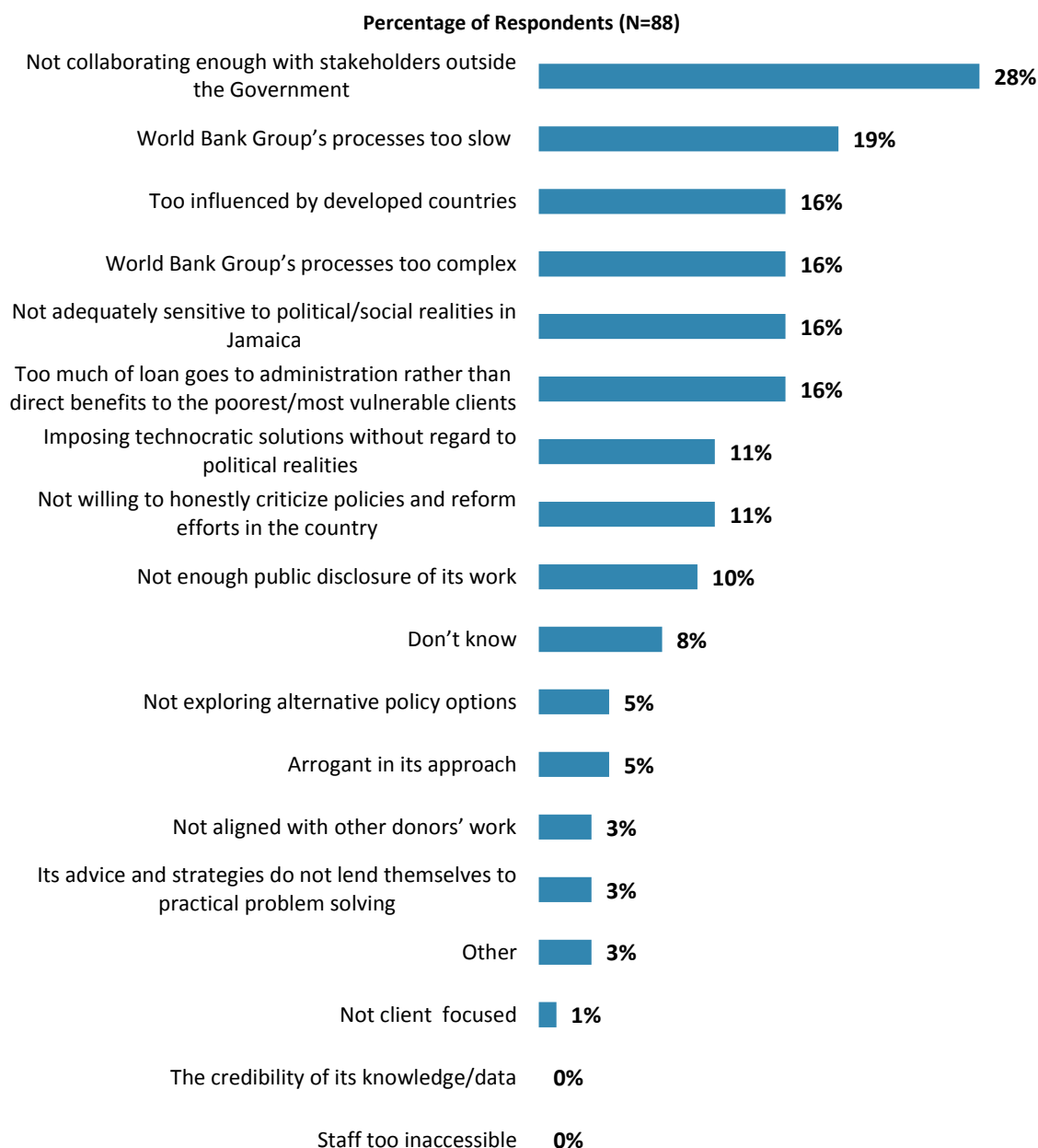
"When thinking about the World Bank Group's role, which activity do you believe is of greatest VALUE and which activity is of second greatest value in Jamaica?"

Greatest Weakness

- **Year comparison:** Respondents in the previous FY'13 Country Survey indicated that the World Bank's greatest weakness in its work in Jamaica were "*the World Bank being too bureaucratic in its operational policies and procedures*" (37%) and "*the WB being not adequately sensitive to political/social realities in Jamaica*" (30%).

VI. Sectoral Effectiveness (continued)

Drivers of Effectiveness

To determine the key drivers of respondents' ratings of the World Bank Group's overall effectiveness and ratings of its ability to help achieve development results in Jamaica, bivariate correlational analyses were conducted using respondents' ratings of the twenty nine specific areas of effectiveness.

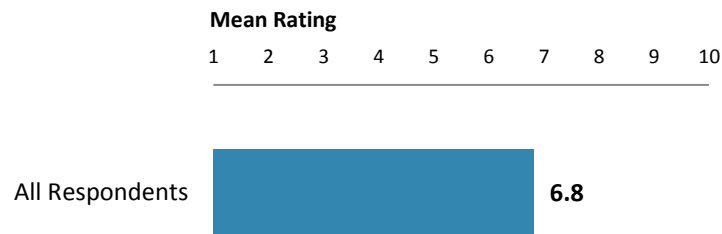
Correlational analyses, however, are not able to tell us exactly what is causing respondents' ratings of the World Bank Group's overall effectiveness or ratings of its ability to help achieve development results. Rather, these analyses tell us that as ratings of effectiveness in one area increase, respondents' ratings of the WBG's overall effectiveness increase, or as ratings of effectiveness in one area increase, ratings of the WBG's ability to help achieve development results increase. Thus, it can be inferred that respondents' perceptions of effectiveness in one specific area are related to, or drive, respondents' perceptions of the WBG's overall effectiveness or perceptions of the WBG's ability to help achieve development results.

- Overall Effectiveness: Those specific areas with the highest Pearson Product-Moment correlations were determined to be the most closely related to perceptions of the WBG's overall effectiveness, suggesting that ratings of effectiveness in those specific areas are drivers of perceptions of the WBG's overall effectiveness in Jamaica. The areas determined to be key drivers from these analyses were:
 - The WBG's effectiveness at transport;
 - The WBG's effectiveness at access to affordable finance for micro, small, and medium enterprises; and
 - The WBG's effectiveness at water and sanitation.
- Achieving Development Results: Those specific areas with the highest Pearson Product-Moment correlations were determined to be the most closely related to perceptions of the WBG's ability to help achieve development results in Jamaica, suggesting that ratings of effectiveness in those specific areas are drivers of perceptions of the WBG's ability to help achieve development results. The area determined to be key driver from these analyses was:
 - The WBG's effectiveness at education;
 - The WBG's effectiveness at private sector development; and
 - The WBG's effectiveness at early childhood development.



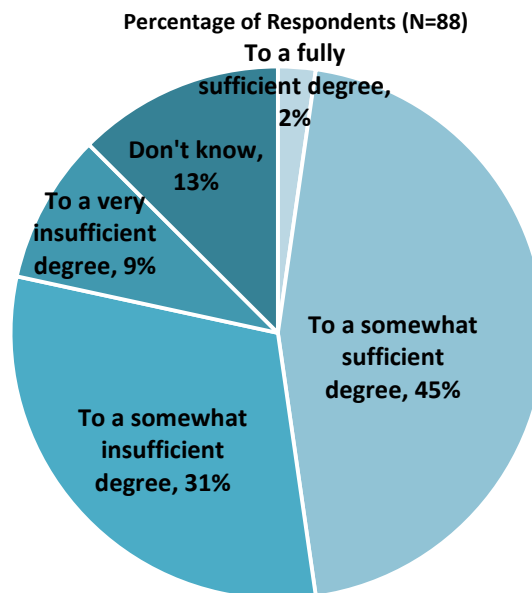

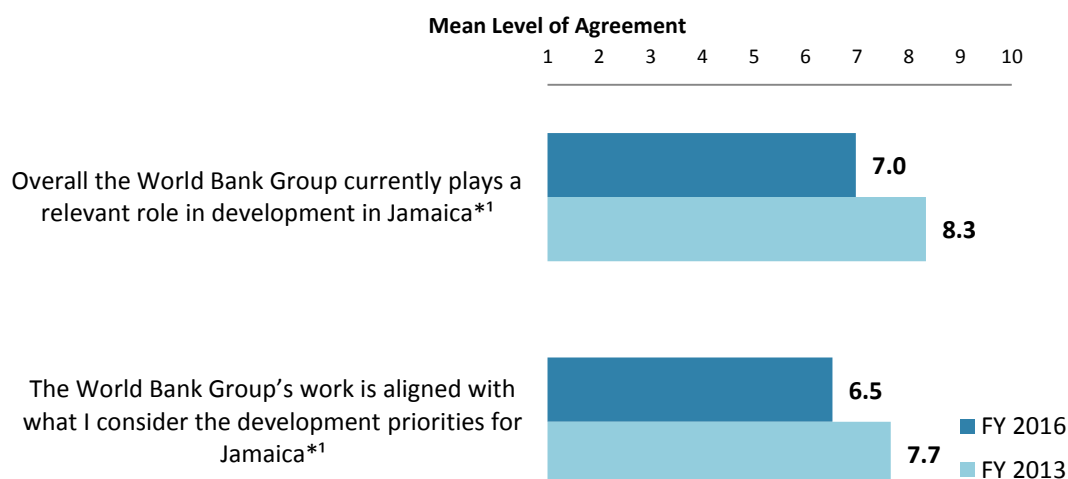


"To what extent do you believe that the World Bank Group's work and support help the poorest in Jamaica?" (Respondents chose from a list.)

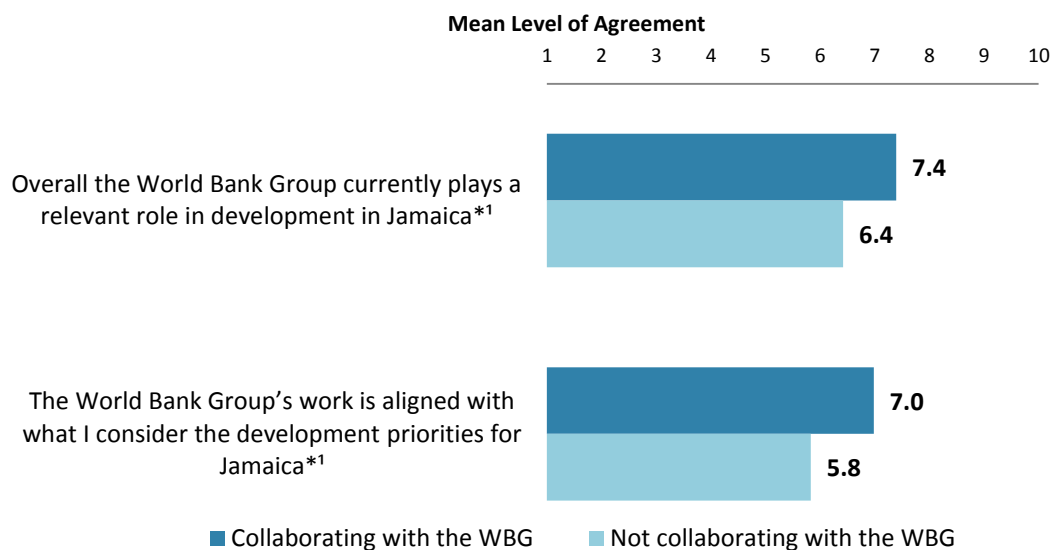


"To what extent do you agree with the following statements about the World Bank Group's work in Jamaica?" (1-"Strongly disagree", 10-"Strongly agree")

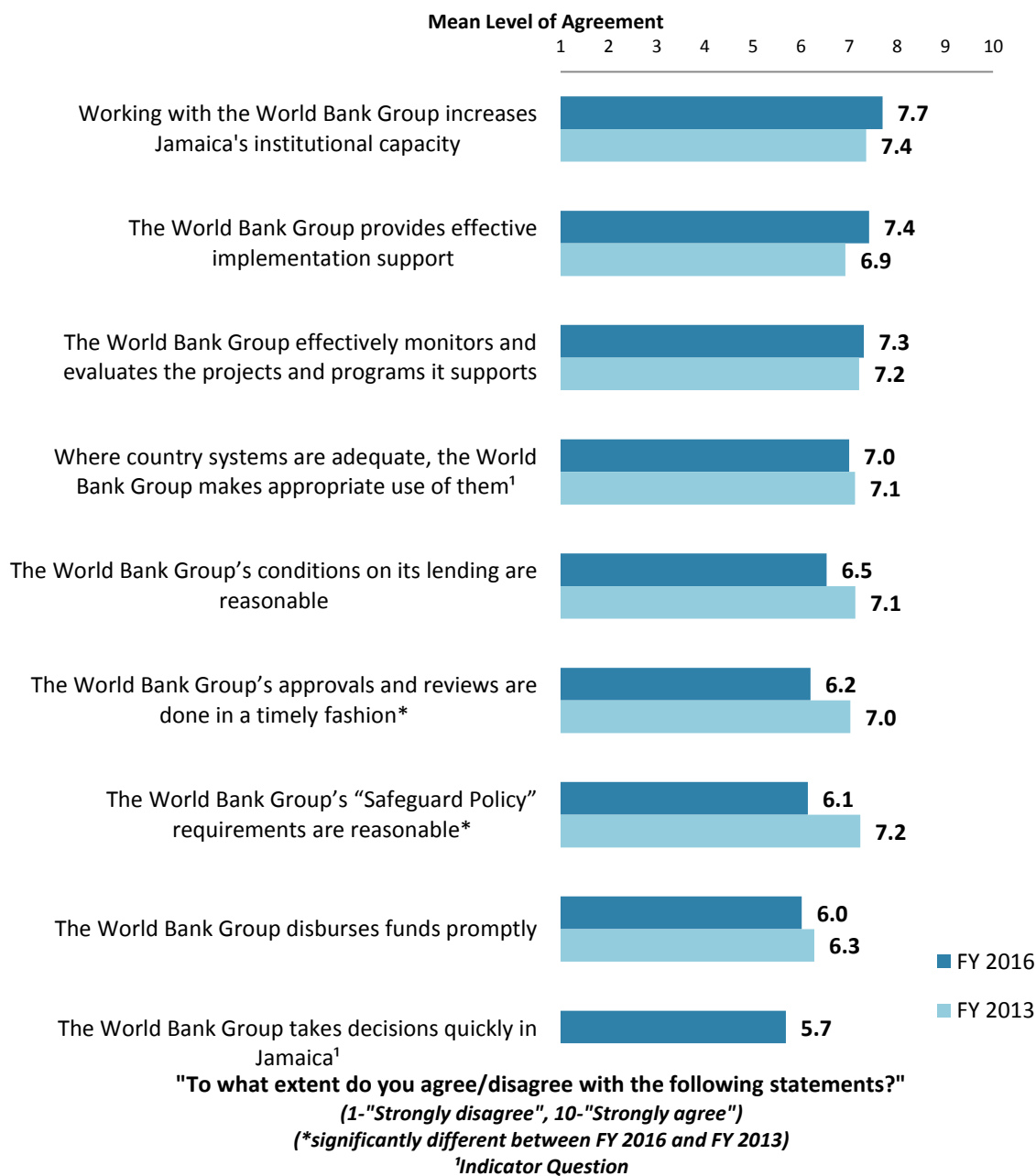

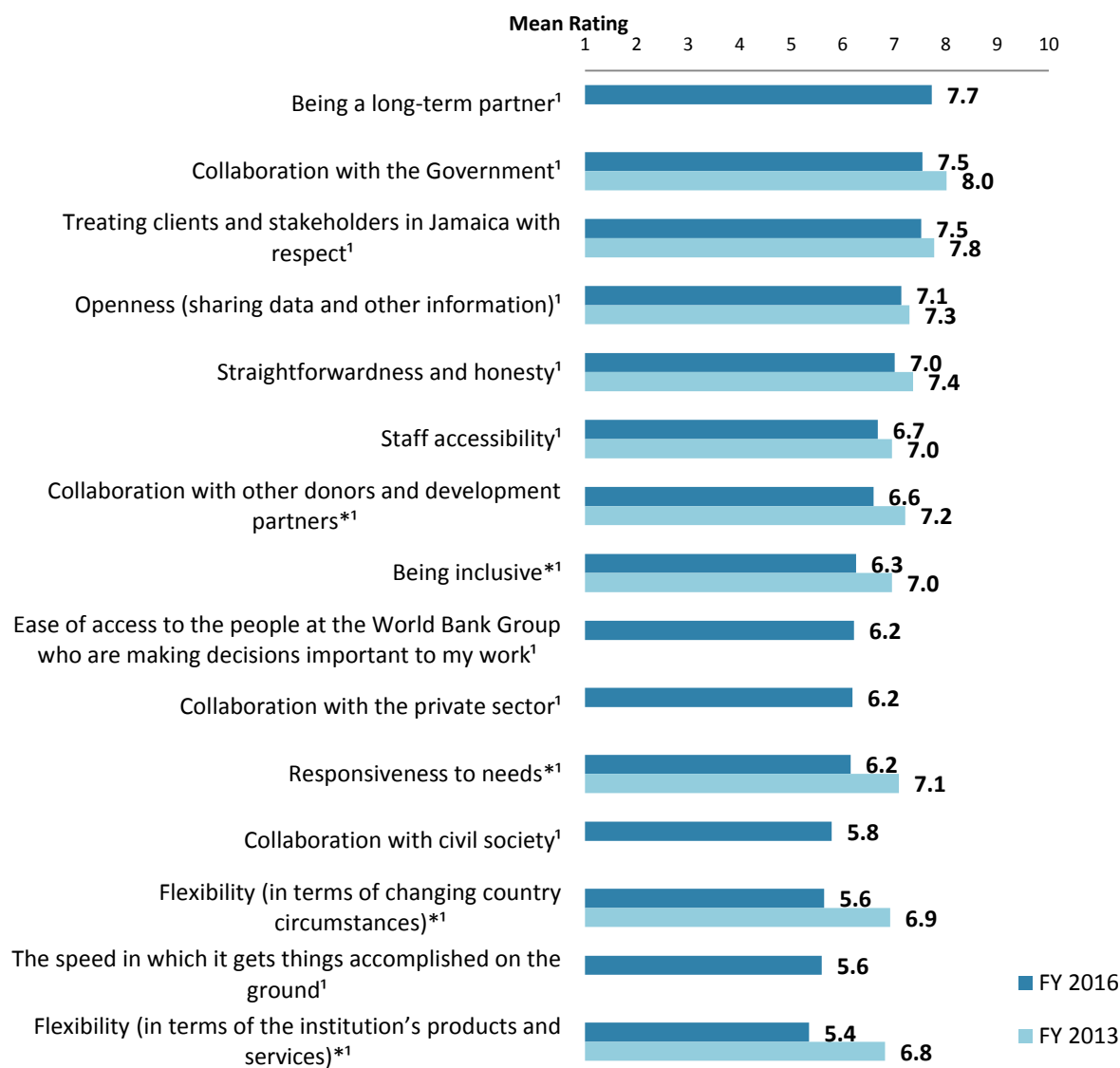

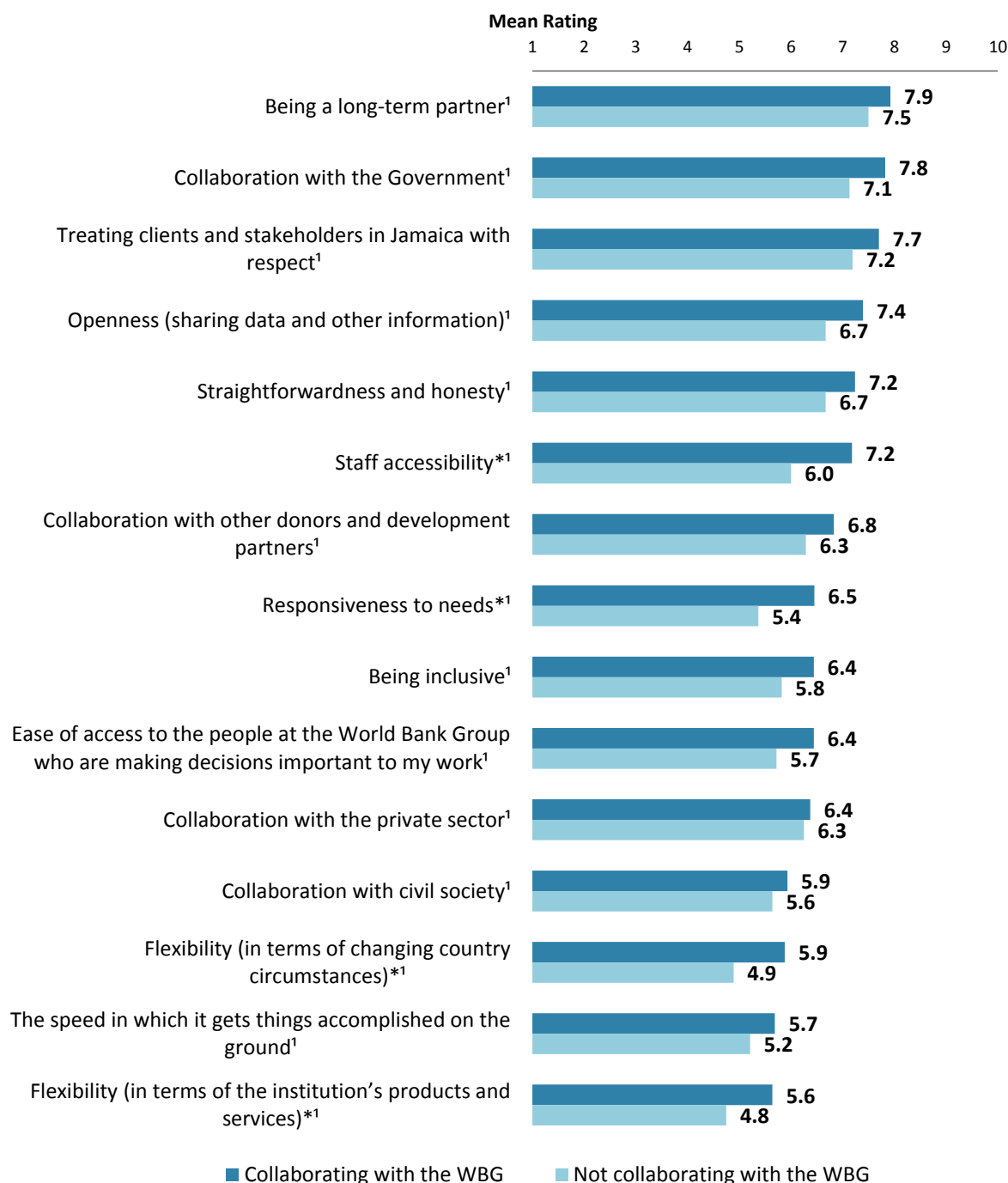

"To what extent is the World Bank Group an effective development partner in Jamaica, in terms of each of the following?" (1-"To no degree at all", 10-"To a very significant degree")

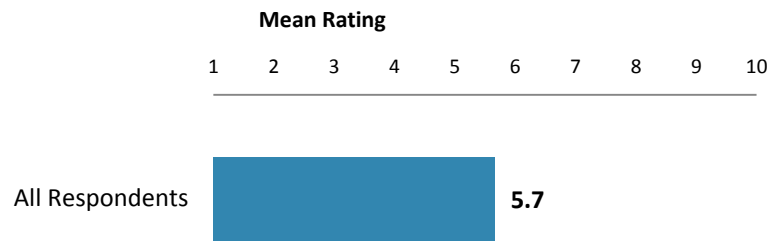

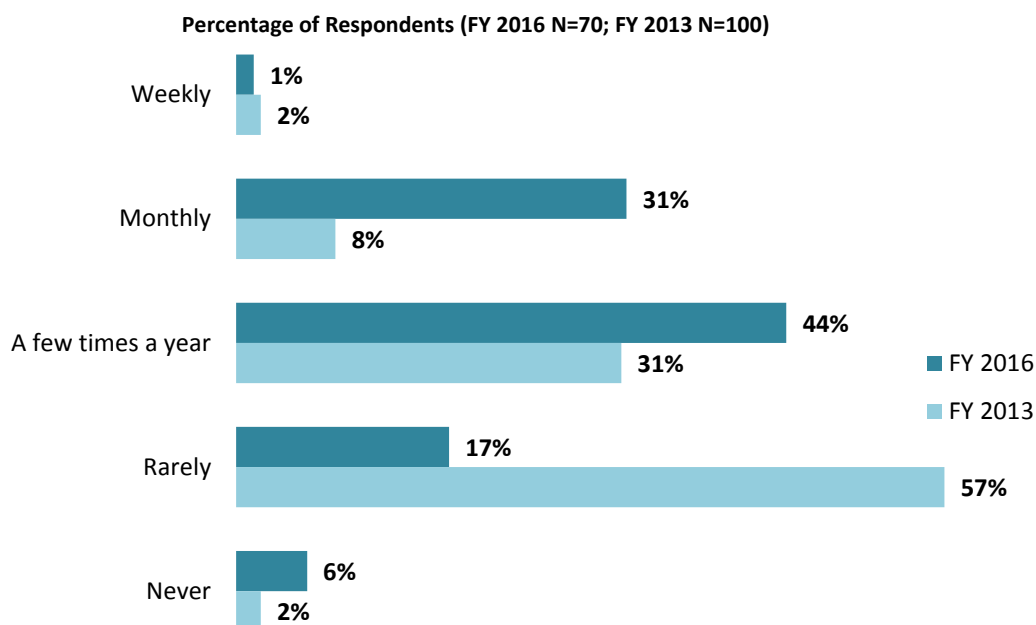
"To what extent do you believe the World Bank Group measures and corrects its work in real time in Jamaica?" (1-"To no degree at all", 10-"To a very significant degree")

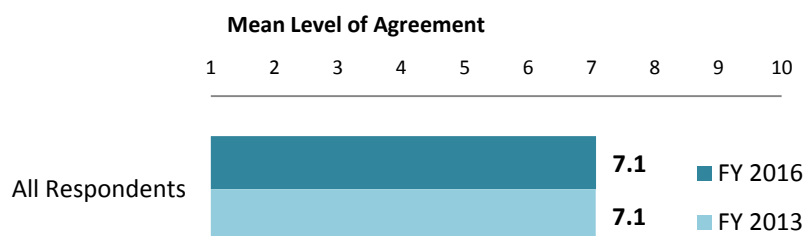

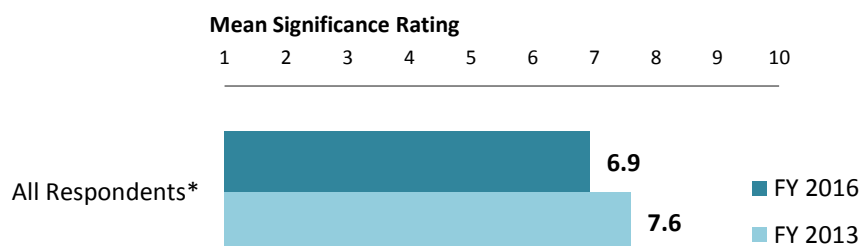

Meeting Jamaica's Knowledge Needs¹² (Indicator Question)



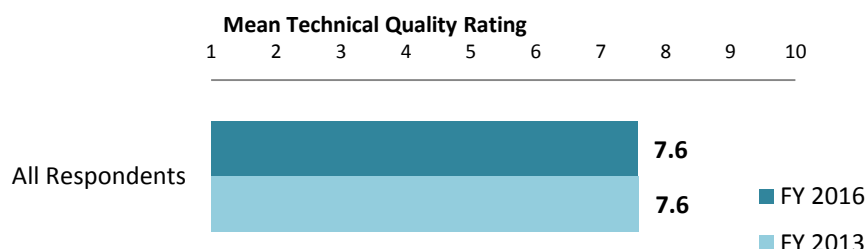

Technical Quality of the WBG's Knowledge Work and Activities (Indicator Question)



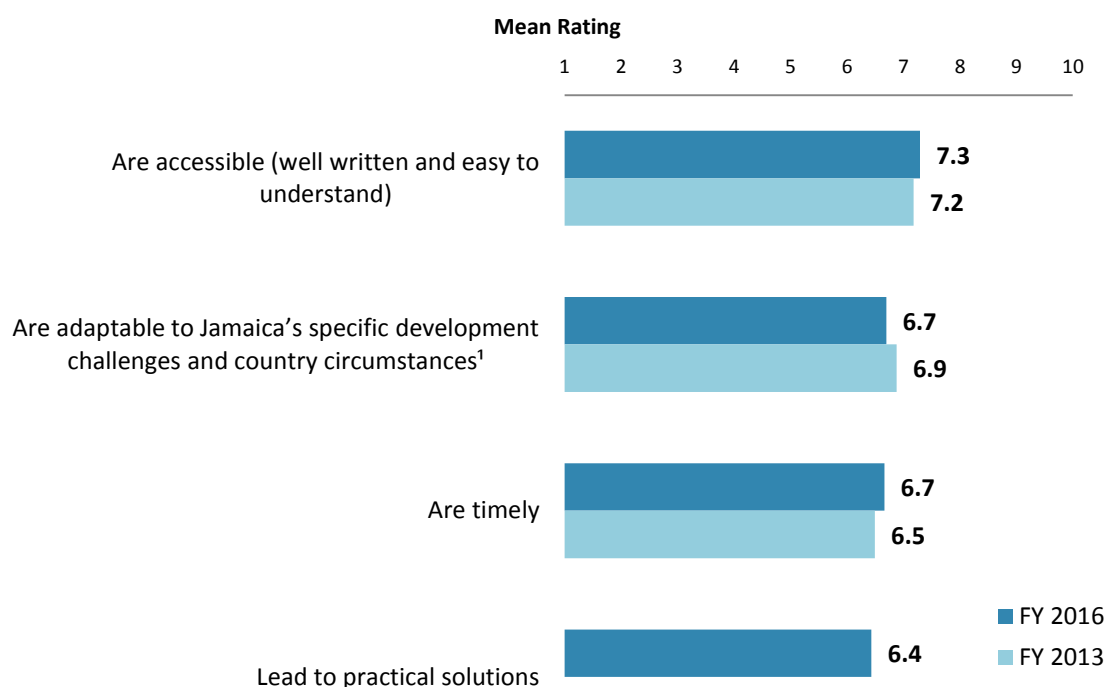

"In Jamaica, to what extent do you believe that the World Bank Group's knowledge work and activities:" (1-"To no degree at all", 10-"To a very significant degree")

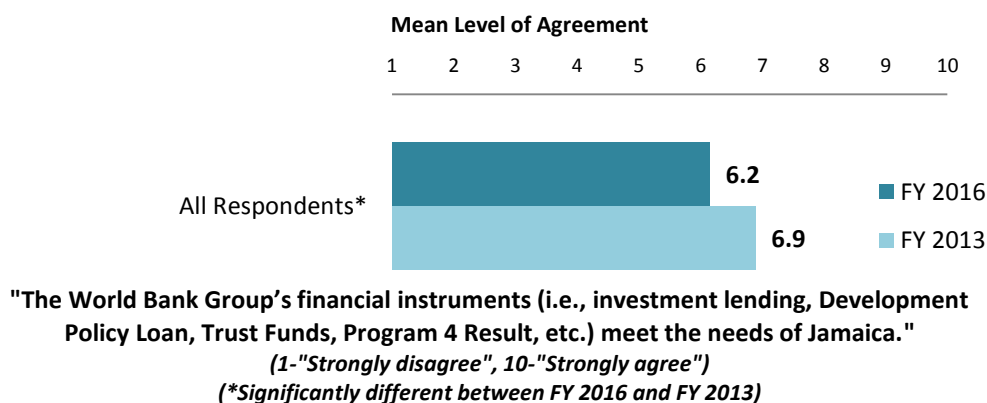

Meeting Jamaica's Needs for Financial Instruments¹⁴ (*Indicator Question*)



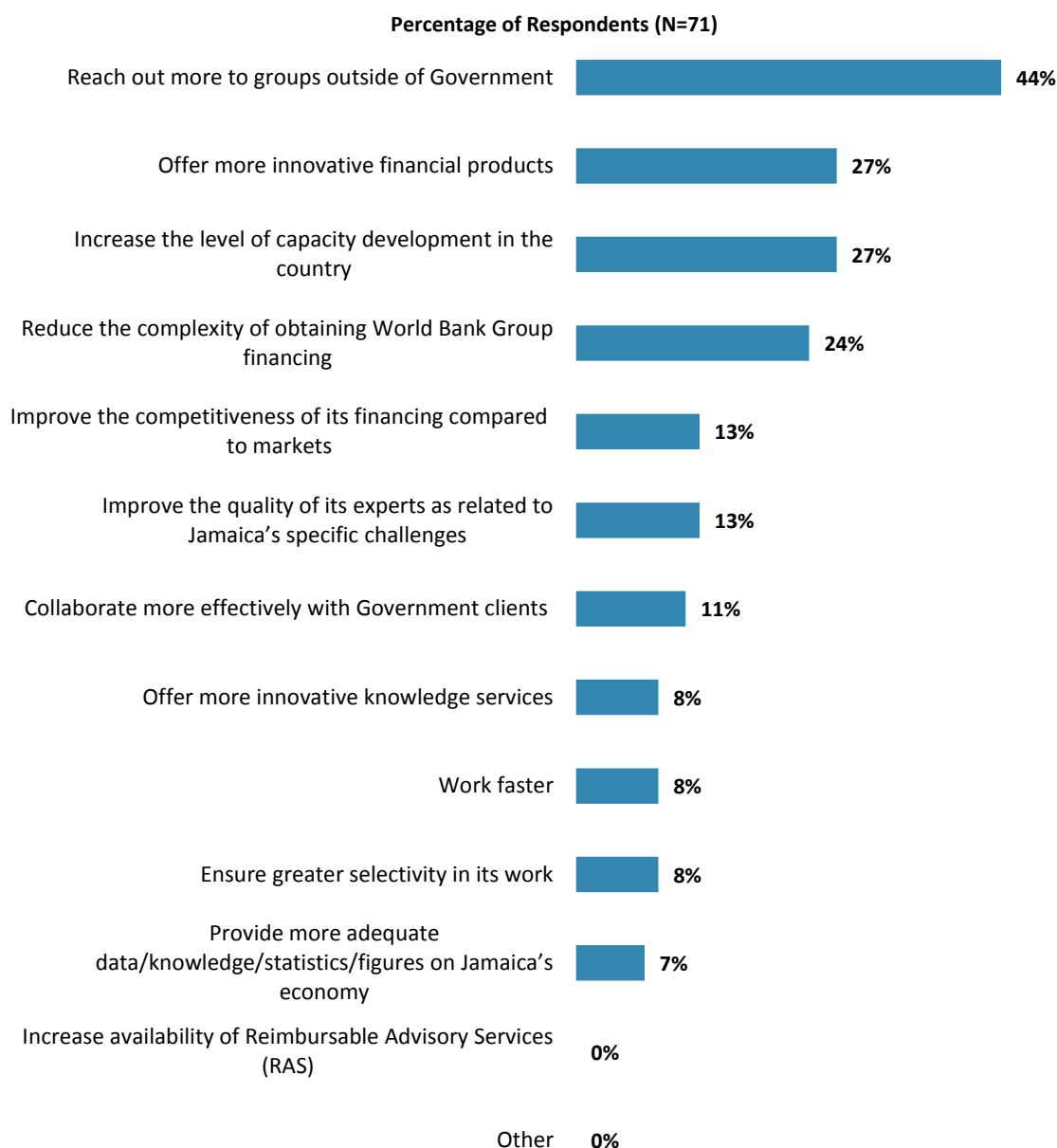

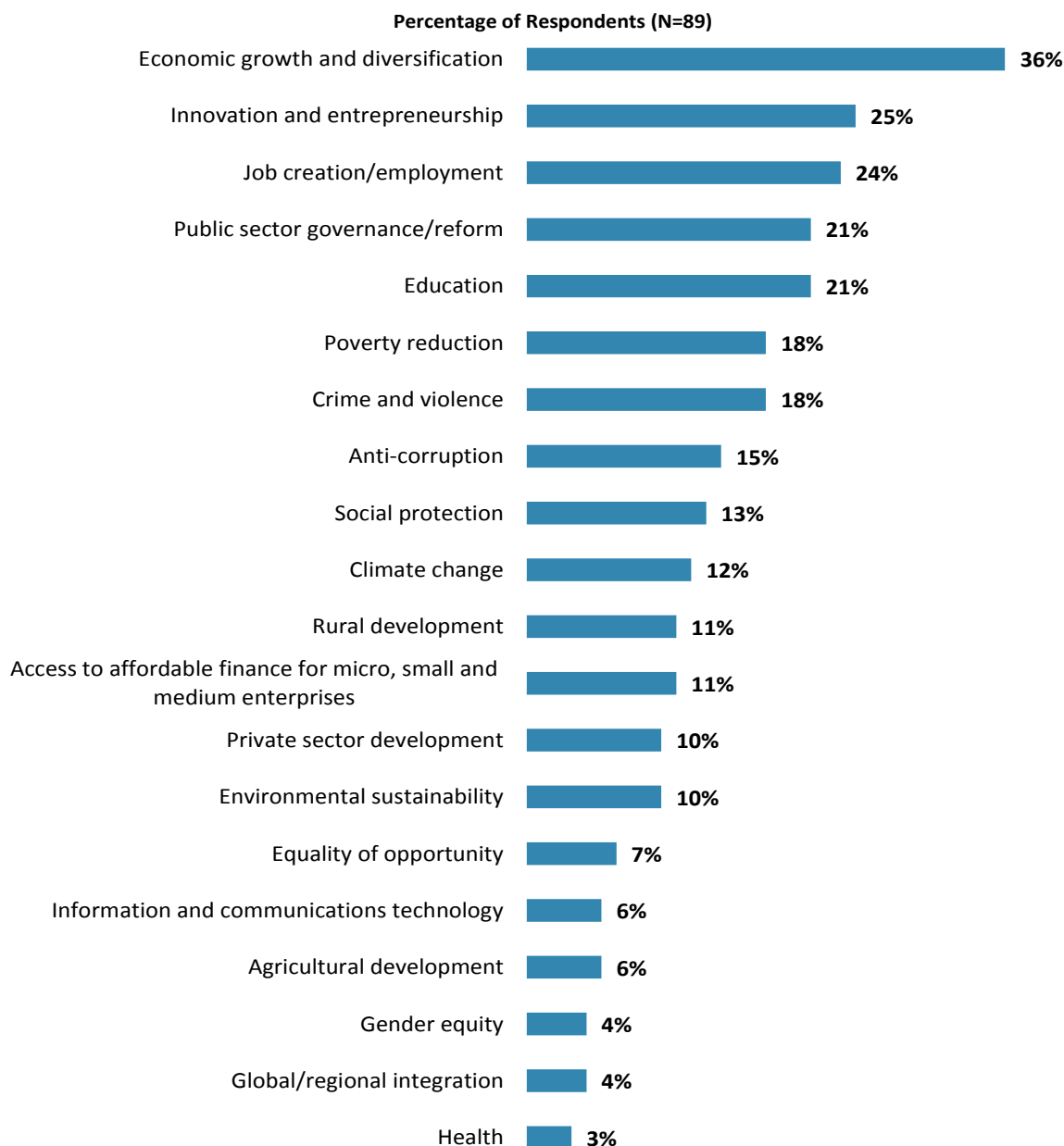

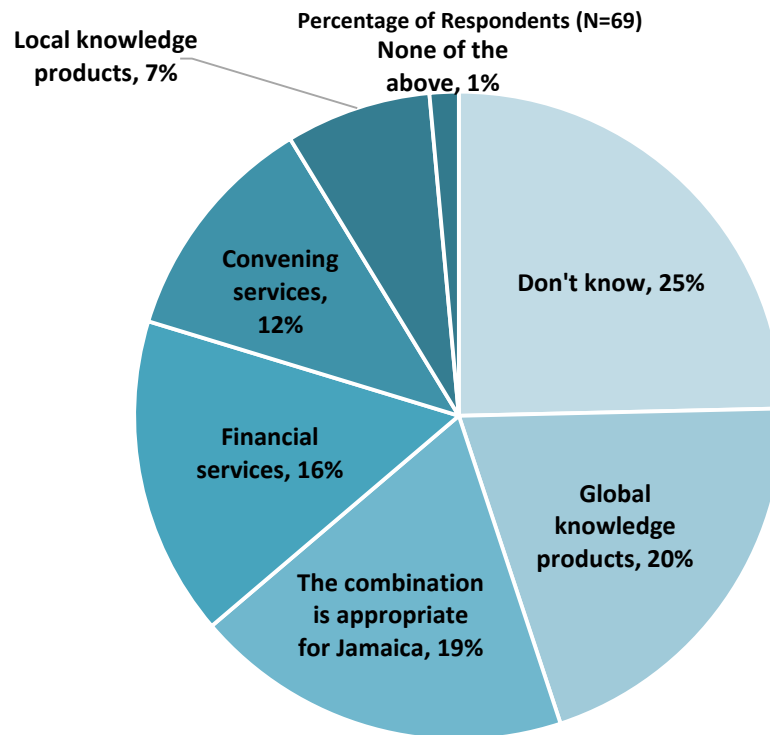

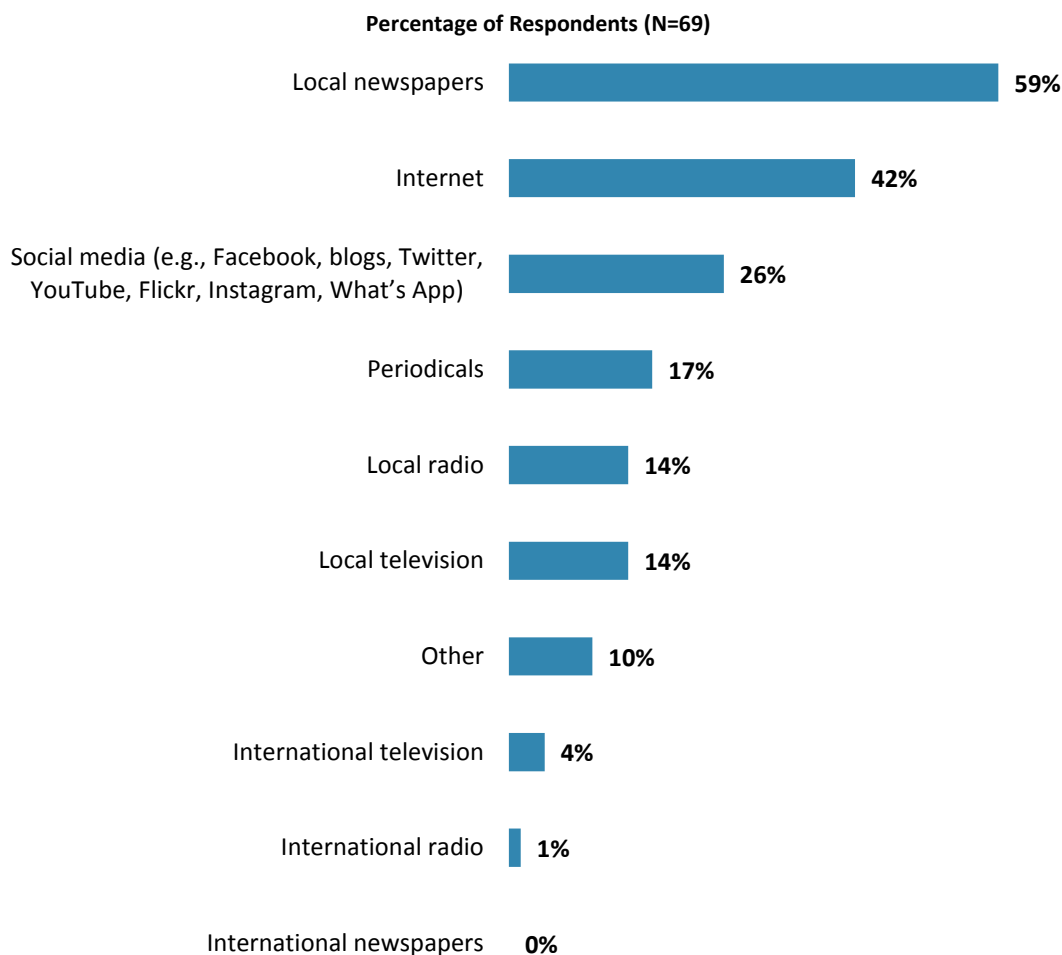

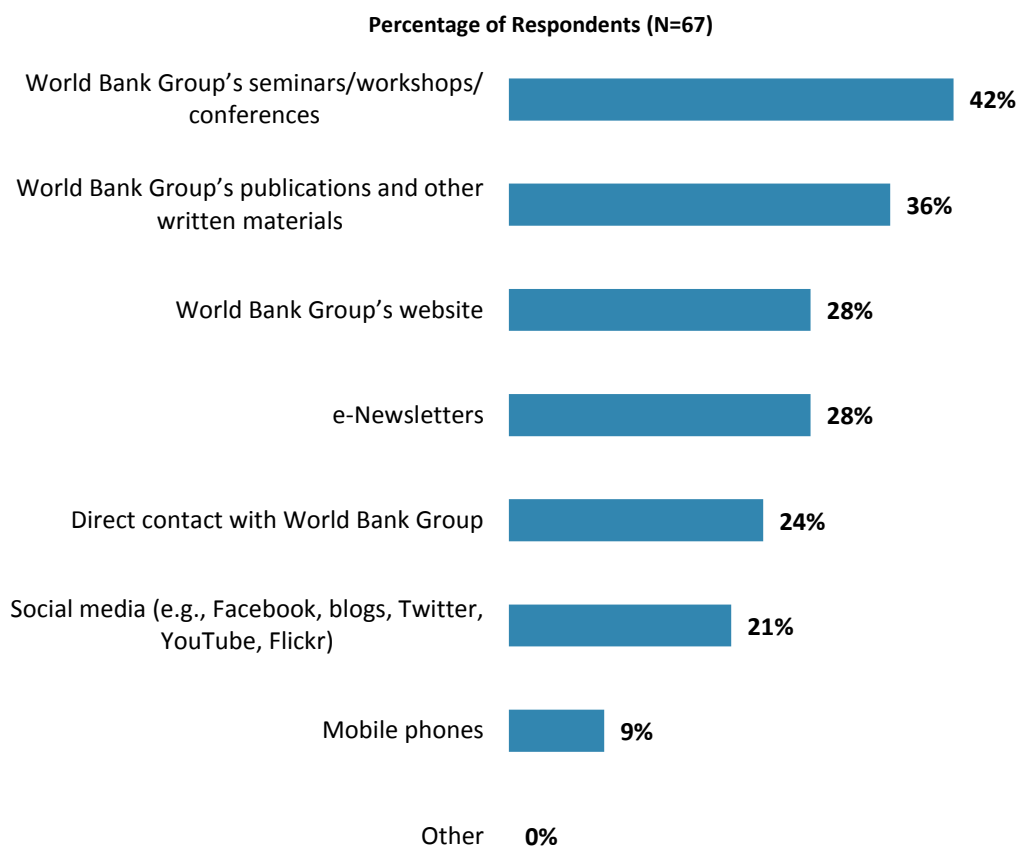
"How do you get most of your information about economic and social development issues in Jamaica? (Choose no more than TWO)" (Respondents chose from a list. Responses combined.)

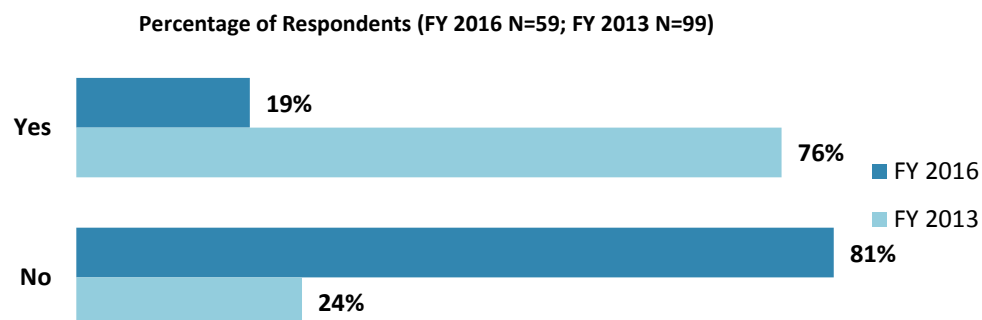
**"How would you prefer to receive information from the World Bank Group?

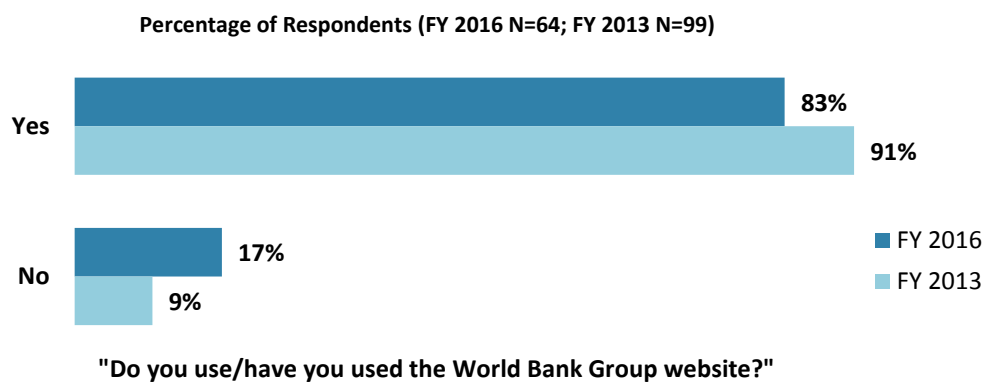
"Are you aware of the World Bank Group's Access to Information Policy under which the WBG will now disclose any information in its possession that is not on a list of exceptions?"

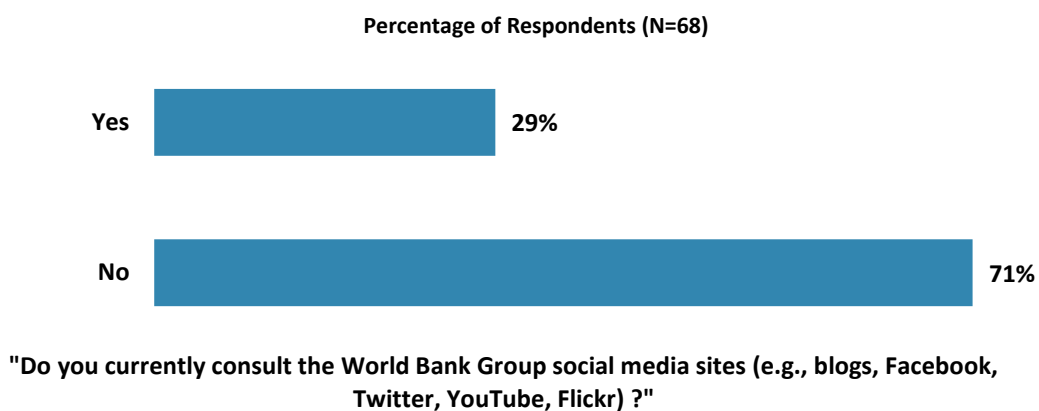
