DATA FILES

Data are available in STATA (8.0) format. Data and electronic documentation are available on the MXFLS website.

Data is contained in folders, one for each household book. There are 11 folders. The folder names were assigned by the book prefix followed by the correspondent book initials. For example, in the Household Economy Book, section Rural income is in ii_inr.

The modules names were assigned by using the book initials prefix followed by the section denomination. For example, the section that corresponds to the cover of the Household economy is denominated ii_portad.

This book, Household Economy, has 11 sections and 15 modules. The modules are the following ones:
