

Instruction for Household

What is recorded in the Self-consumption Dairy?

Estimated values and quantities of used/consumed products that you produced by yourself are recorded unlike the Purchase Dairy where expenditures for purchased products are recorded.

Quantities and estimated values of products from your garden, orchard, farm, and apiary as well as products collected in the nature and etc. which you used/consumed in your household or that you gave as a gift.

How to record?

There are two columns for each week, one for values in BAM and the other one for the quantity in kg (unless otherwise indicated). Pay attention that the column for recording quantities is expressed in kilograms, liters, etc. If consumed quantities are smaller than the units of measurement listed in the Self-consumption Dairy, decimal amounts are recorded for consumed quantities, e.g. 500 g = 0,5 kg; 50 g = 0,05 kg; 5 g = 0,005 kg (it's rounded to 0,01 kg), 250 ml = 0,25 l etc.

What to record in the column for BAM?

Value of products by prices from nearby stores, e.g. if you consumed two liters of milk, in the column for BAM you will record BAM 3,00 (under assumption that a liter of milk in a nearby store costs BAM 1,50).

What is not recorded in the Self-Consumption Dairy?

Products purchased in stores or markets are not recorded in this diary nor products processed from them (*aivar*, jam, compote).

Products obtained from own production which were not consumed during 14 days of keeping Self-consumption dairy must not be recorded.

How to record correctly?

It is recommended that the data in the Self-Consumption Dairy are recorded by a household member who knows best the consumption (a housewife, etc.) or a person who keeps the Dairy.

Consumption of products has to be recorded at the end of the seventh day for the previous week.

If you cannot find the consumed product among products listed in the Self-consumption Dairy, record the type, value and quantity of the consumed product in the column "OTHERS (specify)".

If during a week there was no self-consumption, record in the provided column "There was no consumption".

Data secrecy is guaranteed by the Law on Statistics of BiH (Official Gazette of Bosnia and Herzegovina, 26/04 and 42/04), the Law on Statistics in the Federation of Bosnia and Herzegovina (Official Gazette of the Federation BiH, 63/03 and 09/09), the Law on Statistics of the Republika Srpska (Official Gazette of the Republika Srpska, 85/03) and the Law on Personal Data Protection (Official Gazette of Bosnia and Herzegovina, 49/06). All participants of the survey are obliged to comply with the rules of keeping secrets and interviewers are obliged to emphasize this to respondents.
