Explanation:

- Variable BIRIMNO is a key variable, which links all data sets (e.g. Consumption, Household and Individual) with each other and helps in interrelating existing variables in other data sets.
- Each household is assigned a unique number which is a consecutive number in a range starting from 1600001 to 1615552.
- The method “non-response correction” has been used instead of substitution of sample households since 2009. If the household survey is can not be carried out due to such reasons as refuse the interview, being not at home, inability to obtain sufficient and accurate answers, inability to complete the survey, the bulletin no of that survey which was not completed does not appear.

Explanation:

- Variable specifies the type of acquisition of the consumption expenditure item.
- Purchase code (1) is used for recording all goods and services that a household buys against cash payment.
- The code for products produced by the household for its own consumption (2) shows value of the products consumed during the survey month or allocated to be consumed in the household and given as gift or an aid to other households in the reference month. Products produced and stocked by the household for its own consumption in previous months and consumed in the reference month is also included under this variable.
- Households' consumption of the goods and services produced or sold in the work place of the household members who are currently working is accepted as consumption from income in-kind. The allowances of food, clothing, transportation etc. provided for a member who is a paid employee is accepted as the consumption from the in-kind income of the employee, whereas if the household member working at his own place or working as an employer brings some of the products that he/she produces or sells at his work place to home for consumption purposes, this is accepted as income in kind of members who work as an entrepreneur.
- Code 5 covers the value of goods and services that are purchased by the members of the household to be given (as gift or allowance) to the private persons or bodies during the survey month.
- In-kind incomes as those received from leasing of any property that a household owns were coded as (7).
