**INSTRUCTIONS ON HOW TO COMPLETE THE QUESTIONNAIRE**

- ✓ Enter date in PD01
- ✓ PD02 is for official use
- ✓ PD03 enter unique description of item
- ✓ PD04 and PD05 enter the quantity and unit of the purchased item
- ✓ PD06 convert non standard units in PD05 to standard units using weighing scales or the measuring cylinder
- ✓ PD07 enter the total cost of item purchased
- ✓ PD08 enter where the item was purchased from

Record the item as many times as it is purchased i.e. if an item is purchased 3 times in a day then enter 3 times.  
At the bottom of the page enter the number of items recorded. E.g. if you recorded bread twice and sweet potatoes once, then the total number of items recorded is 3.  
The recorder should also ask other members of the household what item they purchased and also record them in the diary.  
Please make sure all items that were purchased by household members are recorded no matter how small or big they are.  
Also these items should be for household consumption not for trade.  
Among items that tend to be under reported includes alcoholic drinks, sweets, chocolate, onions, tomatoes, and spices.  
This is mainly because they are either purchased individually or only in very small quantities.
