I. Objectives

This survey was designed to assist the World Bank Group (WBG) in gaining a better understanding of how stakeholders in Botswana perceive the WBG. The survey explored:

- *General Issues Facing Botswana*
- *Overall Attitudes toward the World Bank Group*
- *World Bank Group's Effectiveness and Results*
- *The World Bank Group's Knowledge Work and Activities*
- *Working with the World Bank Group*
- *The Future Role of the World Bank Group in Botswana*
- *Communication and Information Sharing*
- *Background Information*

II. Methodology

From January to April 2019, 343 stakeholders of the WBG in Botswana were invited to provide their opinions on the WBG's work in the country by participating in a Country Opinion Survey. Participants were drawn from the Office of the President, office of a Minister; office of a Parliamentarian; ministries/ministerial departments/implementation agencies; Project Management Units (PMUs) overseeing implementation of WBG projects; consultants/contractors working on WBG-supported projects/programs; bilateral and multilateral agencies; embassies; private sector organizations; the financial sector/private banks; private foundations; NGOs and community-based organizations; the media; independent government institutions; trade unions; faith-based groups; youth groups; academia/research institutes/think tanks; judiciary branch; and other organizations.

A total of 303 stakeholders participated in the survey (88% response rate). Respondents completed the questionnaire with a representative from the local fielding agency, or they received the questionnaire via email and returned it accordingly.

Every country that engages in the Country Opinion Survey (COS) must include specific indicator questions that will be aggregated for the World Bank Group's annual Corporate Scorecard. These questions are identified throughout the survey report.

The results in this year's Country Survey were compared to those in the Country Survey conducted in FY'16 (response rate was 85%, N=256). Data were weighted to reach the same stakeholder composition in two years, which allows for year comparisons. Stakeholder groups which were not present in both fiscal years were not included in the comparison. Respondents who belonged to the "other" stakeholder category were not included either. As a result, mean ratings, percentages of respondents, and the total number of respondents in both years are slightly different from those of the original data reported in the FY'16 COS report and the non-weighted data presented in appendices A, B, C, D and F. For the weighted stakeholder breakdown and year comparison results, please refer to Appendix E (page 77).




“Which of the following best describes your current position?”

Area of Primary Specialization






Geographic Locations

Exposure to Agencies within the World Bank Group




"Which of the following agencies of the World Bank Group do you primarily collaborate/

Familiarity with the World Bank Group

- **Year comparison:** Respondents in this year's Country Survey and the FY'16 Country Survey had statistically similar levels of familiarity with the WBG (weighted mean in FY'19 = 4.8; weighted mean in FY'16 = 5.1)².
- **Impact of familiarity:** Respondents' ratings of familiarity with the WBG were strongly significantly correlated with their ratings for the WBG's overall effectiveness in Botswana, and with their agreement that the WBG plays a relevant role in Botswana's development, and moderately significantly correlated with their ratings of the extent to which the WBG's work helps to achieve development results in Botswana.




"How familiar are you with the work of the World Bank Group in Botswana?"



Perceptions of Economic Opportunity




"Do you think that economic opportunity for citizens in Botswana is ... ?"

Perceptions of Improvement and Decline in Specific Areas

















Attributions for Slow/Failed Reform Efforts




"When economic and/or social reform efforts fail or are slow to take place in Botswana, which of the following would you attribute this to? (Choose no more than TWO)"







- **Stakeholder groups:** Respondents from ministries, PMU, consultants on WBG projects, and respondents from the “Other” category had the highest mean ratings for the aggregated responses to the twenty-eight COS indicator questions, whereas respondents from the private sector/financial sector/private banks, and CSOs had significantly lower mean ratings. 
Mean Ratings for All Indicator Questions by Stakeholder Groups on a Scale from 1 to 10


"When thinking about the World Bank Group's role, which activity do you believe is of greatest VALUE and which activity is of second greatest value in Botswana?"




"Which of the following do you identify as the World Bank Group's greatest WEAKNESSES in its work in Botswana? (Choose no more than TWO)"

Effectiveness of WBG's Support in Sectoral Areas: Year Comparison⁵









The WBG's Human Capital Investment




"From your perspective, which of the following best describes the World Bank Group's current emphasis on investing in human capital (e.g., education, health, social protection)?"



The World Bank Group's Work in Botswana: Collaboration








"To what extent do you agree/disagree with the following statements?"




"To what extent is the World Bank Group an effective development partner in Botswana, in terms of each of the following?" (1-"To no degree at all", 10-"To a very significant degree")

Frequency of Consulting WBG Knowledge Work and Activities




"How frequently do you consult World Bank Group's knowledge work and activities in the work you do?"



Meeting Botswana’s Knowledge Needs¹¹ (Indicator Question)












"Which of the following SHOULD the World Bank Group do to make itself of greater value in Botswana? (Choose no more than TWO)"


"In addition to the regular relations with the national government, which TWO of the following groups should the World Bank Group collaborate with more in your country? (Choose no more than TWO)"






"How do you get most of your information about economic and social development issues in Botswana? (Choose no more than TWO)"




**"How would you prefer to receive information from the World Bank Group?



WBG Interaction Frequency




"How frequently do you interact with the World Bank Group now in Botswana?"
