

DEAR RESPONDENT!

My name is _____. I am representing the National Statistics Committee of the Kyrgyz Republic that does the Kyrgyz household survey. The purpose of the survey is to gain an insight into the standards of living of the population, as well as assist the Government of the Kyrgyz Republic to develop and implement proper measures to ensure social protection of the population.

Our conversation is strictly confidential, which means that the whole scope of information provided by you will only be used and presented to governmental organizations in a generalized format.

You will be asked a series of questions regarding your daily expenditures for, and consumption of, food products during the two weeks covered by the survey.

Please be assured that you will be paid some compensation for the time spent on keeping this diary.

DEAR OWNERS!

Please, keep this diary carefully and accurately for fourteen (14) days according to the days specified on the cover
(periods covered by the diary to be recorded by the interviewer)

The diary is to be kept by the household member with all or most of the household money concentrated in his/her hands, or by a the person who keeps the house and knows about expenditures of the other family members.

You are expected to write down in your diary any expenditures for, and consumption of, food products, beverages (both alcoholic and nonalcoholic) and tobacco products only. Make sure you include any products purchased, produced by your household, or received by your household as a gift or payment for work done for anybody else. The last page of the diary provides approximate list of products. Any expenditure for purchase of nonfood products should also be included in a different form (Questionnaire #5) of your diary.

This diary will help the interviewer considerably reduce the time required for interviewing your household.

Before you proceed to the keeping of your diary, please do:

Learn main rules of keeping the diary

The diary consists of three sections.

DIARY KEEPING INSTRUCTIONS

1. Fill in the sections 1 and 3 of the diary only, on a daily basis; please, remember to include expenditures for purchase of food products, drinks and tobacco products for consumption both at home and outdoor.
2. The interviewer will fill in the Section 2 of the diary him/herself based on interview.
3. It would be helpful if you make entries immediately upon coming home from a grocery store or market; make entries every day to make sure that nothing is missed.
4. Specify the date of purchase, as it will help avoid duplications in your records.
5. The records must be as accurate and specific as possible (abbreviations are allowed):

Instead of writing “meat” in general, specify: “beef fillet”, “smoked mutton ribs”, “pork” etc.

Instead of writing “cheese”, specify the sort of cheese: sausage cheese, hard cheese, club cheese etc. Instead of writing “bread”, specify: rye bread, white bread etc. Instead of writing “fish”, specify: “salt herring”, “smoked capelin”, “fresh pike perch” etc.

Instead of writing “cereals”, specify: “buckwheat”, “oat-flakes” etc. Instead of writing “wurst”, specify: “smoked sausage”, “frankfurters” etc. Instead of writing “butter”, specify: “dairy butter”, “refined sunflower oil” etc. Instead of writing “milk”, specify: “pasteurized milk”, “fresh (cow's) milk”, “condensed milk” etc.

6. If you purchase preserved (tinned) food products, please write down net weight in grams or kilograms, as indicated on the package.

7. Consumption of homemade canned/tinned products may be specified in kg/grams or liters/ml.

8. For goods sold in pieces (eggs and tobacco products (1 pack = 20 pcs.) please specify the number of pieces purchased.

9. Consumption of vegetable oils, alcoholic beverages and soft drinks, milk and other liquid milk products must be specified in liters/ml.


10. If you buy something on credit, please specify the weight and cost of the purchase.

11. Please, try to fill in all of the diary columns, except for the codes.

SECTION 1
«Purchase of food products, drinks and tobacco products»

For Section 1, you are expected to make entries of food products, alcoholic and nonalcoholic drinks and tobacco products only purchased during the period of fourteen (14) days covered by the survey. The interviewer will write down about consumption of these and other products from other sources in Section 2. Anything consumed outdoor must be specified by the household in Section 3.

SECTION 2
«Consumption of food products, drinks and tobacco products»

The INTERVIEWER fills in this Section 2 him/herself based on results of a household interview.

In this section, the interviewer will write down types and amount of food products consumed by household members during the period covered by the diary, whether purchased before or during that period, as well as products produced (processed) or harvested from a personal subsidiary plot, and products received as a gift.

INSTRUCTION FOR THE INTERVIEWER: read out the whole list of food products to household members and mark amount of each product consumed during the two-week period under survey. If household members have consumed products that are not specified in the list, ask them to specify the types of products consumed and write down the type and amount of each such product in the empty rows of the table.

Since only one source may be specified for each particular product, you should specify the same product separately for each source (i.e. in a corresponding row, as well as in empty rows).


