HOW TO FILL IN THE DIARY

DEAR RESPONDENT,

Please be guided by the instructions of the interviewer and the rules below when you fill in the Diary.

☞ THE HOUSEHOLD DIARY IS FILLED IN EVERY DAY

Starting from the 16th day and until the end of the month, you should record only EXPENDITURES ON NON-FOOD PRODUCTS, SERVICES AND OTHER PAYMENTS (pages 10-25).

☞ EACH PURCHASE SHOULD BE RECORDED IN THE RESPECTIVE SECTION

All purchases and payments made within 15 days, except for utility bills should be recorded in the respective section of each day on a separate page (pages 10-25).

UTILITY BILLS should be registered in a separate Section IV (page 8) with indication of the amount for each type of services.

FOOD PRODUCTS FOR CURRENT CONSUMPTION FROM PRIVATE SUBSIDIARY FARMING, AS WELL AS STOCKS AND RECEIVED FREE-OF-CHARGE should be registered on a daily basis in Section V (pages 26-27).

☞ IT IS NECESSARY TO RECORD ALL THE PURCHASES AND PAYMENTS MADE DURING THE SURVEYED MONTH by all members of the household, including by third persons at the request and for the account of this household.

☞ EACH PURCHASE OR PAYMENT IS RECORDED IN A SEPARATE LINE

☞ GOODS AND PRODUCTS SHOULD BE RECORDED AS DETAILED AS POSSIBLE

To summarize the received information each good is coded, therefore we request you to describe each purchase or service as detailed as possible (see examples below).

☞ AMOUNT, COST AND PURPOSE OF PURCHASE SHOULD BE RECORDED FOR EVERY GOOD

☞ INCOME SHOULD BE RECORDED FOR EVERY MEMBER OF THE HOUSEHOLD AND AS DETAILED AS POSSIBLE TO ENSURE PROPER CODING BY THE INTERVIEWER

All income received by the household during the surveyed month, EXCEPT FOR THE INCOME FROM THE SALE OF AGRICULTURAL PRODUCTS AND INCOME FROM ABROAD, should be recorded in Section I (page 5) with the indication of the name of the household member.

REMITTANCES FROM ABROAD should be registered in Section I.I (page 5).

INCOME FROM THE SALE OF AGRICULTURAL PRODUCTS AND OTHER INCOME FROM INDIVIDUAL AGRICULTURAL ACTIVITY, AS WELL AS EXPENDITURES RELATED WITH AGRICULTURAL ACTIVITY are recorded in Sections B II (page 6), II.I (page 7), and III (page 7) of the Diary of daily records.

WHAT SHOULD NOT BE RECORDED IN THE DIARY OF THE HOUSEHOLD

☞ PURCHASES MADE AT THE REQUEST OF ANOTHER HOUSEHOLD FOR ITS ACCOUNT

☞ GOODS RECEIVED FREE OF CHARGE AND DONATED TO ANOTHER HOUSEHOLD

Example of how Section I “Cash income of all members of the household” should be filled in.

The household consists of 5 persons: Valera (husband), Elena (wife), Nikolay (son), Natalia (daughter) and Maria (grandmother).

At the beginning of the month, there were 150.0 MDL from the previous month. This amount should be recorded in the line “Cash balance as of beginning of the month”.

Valera works as an engineer and received salary in the amount of 3800.0 MDL. In addition, he sold an old TV set for 460.0 MDL.

Elena works as a nursery teacher, but she is on maternity leave taking care of daughter Natalia and receives childcare allowance in the amount of 600.0 MDL. During her free time, Elena knits on order and during the surveyed month, she made a sweater for which she received 400.0 MDL.

Grandmother Maria is a pensioner and she receives monthly pension in the amount of 900.0 MDL. In addition, she received 40 kg of corn for some occasional work, the value of which is 80 MDL.

Nikolay is a student and receives a scholarship in the amount of 550.0 MDL; he also works as an operator in an internet-café and received salary in the amount of 700.0 MDL.
