## Executive Summary

PCBS is pleased to release the main findings of the Economic Survey Series for the year 2008. As in the previous rounds, this release covers the main economic activities practiced in the Palestinian Territory, including: Industry, Construction, Internal trade, Transport and Communications, and Services activities.

During the year 2008 in the Palestinian Territory, the number of enterprises in economic activities was 97,242 enterprises, This number was distributed as follows:

• Industrial activities	14,539
• Construction activities	526
• Internal trade activities	57,987
• Services activities	23,050
• Transport, storage and communications activities	1,140

In the year 2008, the number of persons engaged in economic activities was 258,021 workers, This number was distributed as follows:

• Industrial activities	59,641
• Construction activities	4,354
• Internal trade activities	112,107
• Services activities	73,427
• Transport, storage and communications activities	8,492

On the other hand, the main findings of the surveys show that the value of the output was US\$ 5,199.1 million. This value was distributed as follows:

• Industrial activities	2,056.2
• Construction activities	164.7
• Internal trade activities	1,343.8
• Services activities	895.2
• Transport, storage and communications activities	739.2

Regarding to the other economic indicators, the survey results indicate that the gross value added amounted to US\$ 3,384.1 million. This value was distributed as follows:

• Industrial activities	968.4
• Construction activities	51.2
• Internal trade activities	1,052.3
• Services activities	659.0
• Transport, storage and communications activities	653.2

## Chapter One

### Introduction

National statistical offices in most countries place heavy emphasis on constructing sound databases for all activities within economic activities. PCBS initiated the economic surveys series in the reference year 1994. These series include surveys on the industry, services, internal trade, construction-contractors, and transport and storage sectors. The sampling frame for the different economic surveys was based on the findings of the Establishment Census 2007 conducted by PCBS.

#### 1.1 Objectives

The objectives of the survey were to obtain data on:

1. Number of enterprises and persons engaged in economic activities by activity.
2. Value of output, intermediate consumption and stocks.
3. Value added components.
4. Payments and transfers.
5. Assets and capital formation.
6. Contribution of the surveyed activities to the GDP and other national accounts variables.

#### 1.2 Report Structure

The report is divided into five chapters as follows:

- **Chapter One:** Comprises an introduction to the economic survey including survey program, objectives, and report structure.
- **Chapter Two:** Defines the main concepts and terms used in the report with a brief description for each of them.
- **Chapter Three:** Presents the most prominent findings of the economics survey.
- **Chapter Four:** Presents the methodology of the fieldwork in terms of questionnaire, sample, fieldwork data collection activities, and office operations. In addition, it discusses data processing and tabulation.
- **Chapter Five:** Addresses the quality of the data and findings through discussing the main remarks on the fieldwork as well as comments and remarks on the tables.
- **Statistical Tables:** All tables included in this report represent three levels: the Palestinian Territory, the West Bank, and Gaza Strip.



## Chapter Two

### Concepts and Definitions

This chapter presents the definitions of the concepts used in the preparation of the survey tools on which data collection and processing are based. These concepts and their definitions are based on international recommendations in the fields of economic statistics and national accounts while taking into account the particular aspects of the Palestinian Territory.

#### **Statistical Unit**

It is an economic entity that is capable, in its own right, of owning assets, incurring liabilities and engaging in economic activities and in transactions with other entities.

#### **Persons Engaged**

Males and females working in the enterprise including owners, self-employed, unpaid family members, or waged workers who receive their compensations in cash or in kind during a specific reference period. However, this term does not include trainees or those on assignments outside the enterprises or in long unpaid leaves.

#### **Output**

It is the value of the final products of goods and services produced by a certain establishment which is used by other units for self-consumed or for the purposes of self gross fixed capital formation. Production includes two categories: Final products and the so-called (under operating products). Production can be classified as follows: Market outputs, Outputs of private account. and other non-market outputs

#### **Intermediate Consumption**

It is the value of the goods and services consumed as inputs, used up or transformed during the production process. It is measured during a specific period in time in a way similar to measuring production. Intermediate consumption is estimated by purchase price, which is defined as the producers' price plus transportation and wholesale and retail trade margins. The value of the gross intermediate consumption on the level of the total economy is the same whether calculated by purchase or producers' price. However, on the detailed level, the two evaluations vary.

#### **Value Added**

Value added is a central concept of production and refers to the generated value of any unit that carries out any productive activity. Gross value added is defined as the value of gross production less the value of intermediate consumption.

#### **Compensations of Employees**

Compensation of employees is the total remuneration, in cash or in kind, including social security contributions, payable by an enterprise to an employee in return for work done by the latter.

#### **Taxes on Product**

Those are taxes that are compulsory cash or in kind payments payable by producers to the general government. it consist of taxes on products payable on goods and services at production, sale, or exchange and other taxes payable on production by resident producers as a result of carrying out the production process.



**Assets**

It is tangible or intangible (computer software, artistic original) that comes as an output of the production process .It is used frequently or continuously in other production process for more than one year period.

**Depreciation**

It is the value of the assets which can be reproduced and depreciated during the year, depreciation is calculated on the current substitutive value.

**Operating surplus**

Value added minus (compensation of employees plus net taxes on production minus subsidies and custom fees plus depreciation).

**Gross Fixed Capital Formation**

It is the value of what producers own less what they spend on new and used capital goods.

**Main Economic Activity**

Is the main work of the enterprise based on the (ISIC, rev3) and that contribute by the large proportion of the value added, whenever more than one activity exist in the enterprise.

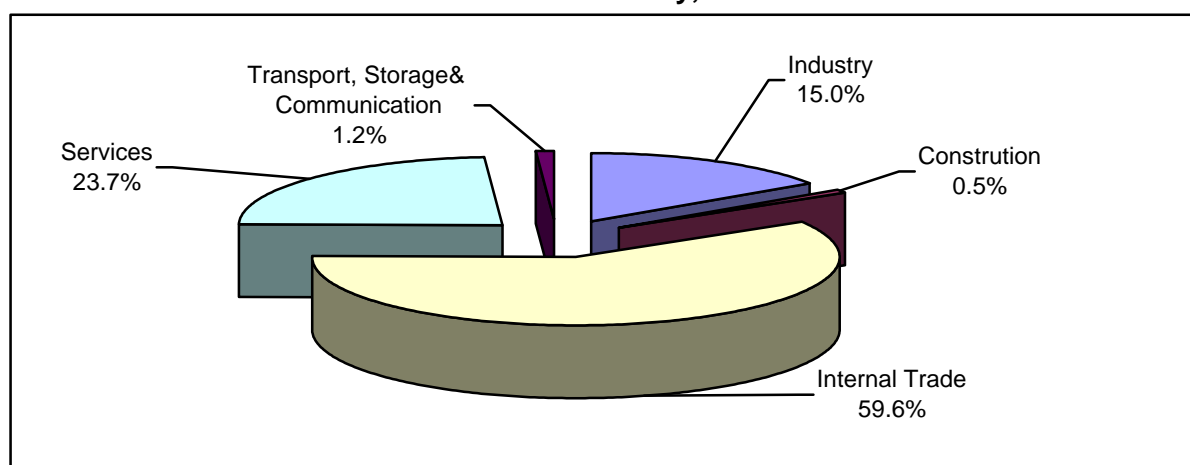
## Main Findings

The prominent findings of the Economic Surveys for 2008 in Palestinian Territory are as follows:

### 3.1 Number of Enterprises:

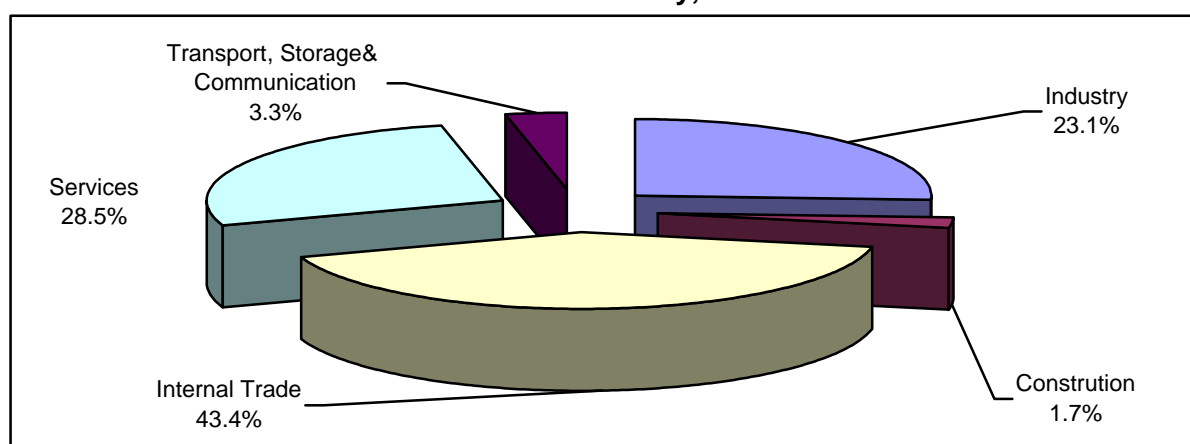
**Figure (1): Percentage Distribution of Enterprises in the Palestinian Territory by Economic Activity, 2008**

The surveys' results show that there were 97,242 operating enterprises during 2008 in the activities covered, in the Palestinian economy. This number was distributed as follows: industrial activities, 15.0%, construction activities, 0.5%, internal trade activities, 59.6%, services activities, 23.7%, and transport, storage and communications activities, 1.2%. Figure (1) shows these results:

### 3.2 Number of Persons Engaged:

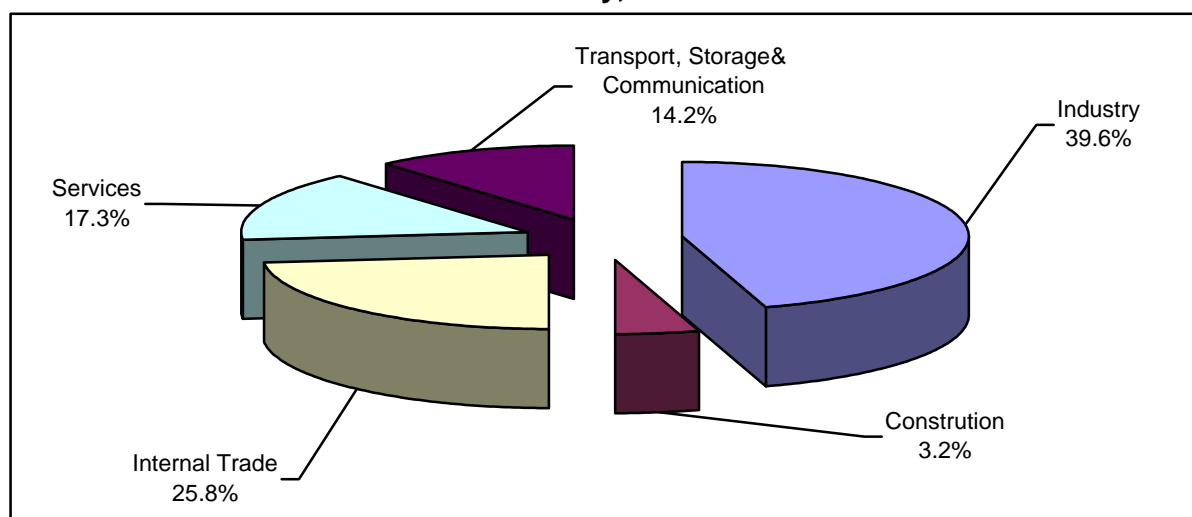
**Figure (2): Percentage Distribution of Persons Engaged in the Palestinian Territory by Economic Activity, 2008**

The number of persons engaged in all covered economic activities is 258,021 workers. This number was distributed as follows: industrial activity, 23.1%; construction activities, 1.7%; internal trade activities, 43.4%; services activities, 28.5%; and transport, storage and communications activities, 3.3%. Figure (2) shows these results:

### 3.3 Output:

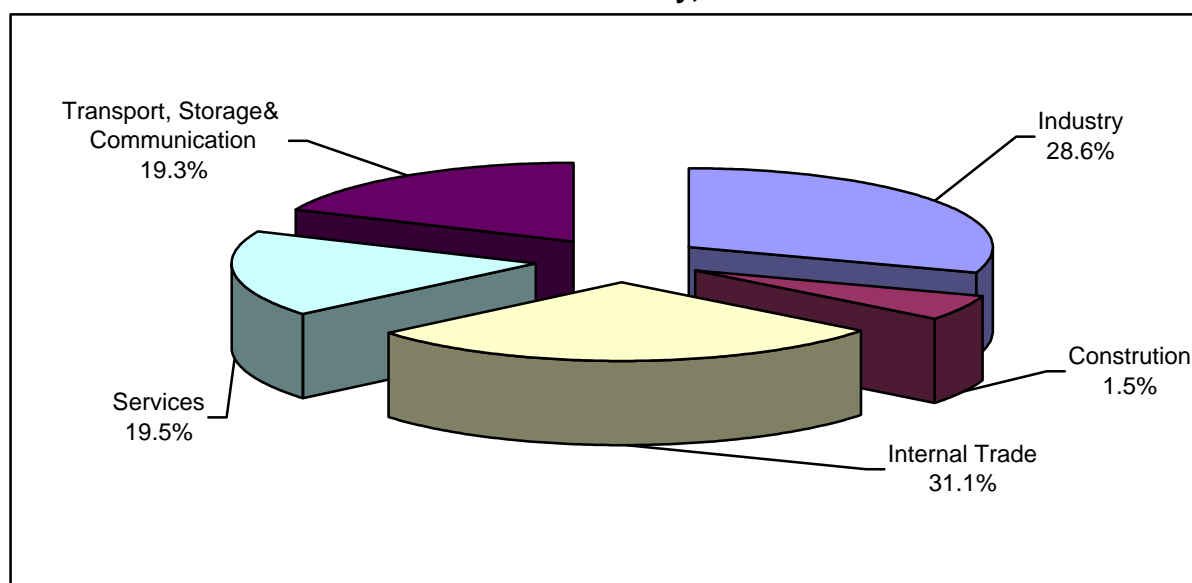
**Figure (3): Percentage Distribution of Output in the Palestinian Territory by Economic Activity, 2008**

The results indicate that the value of output in the Palestinian Territory was US\$ 5,199.1 million. This value was distributed by economic activity as follows: industrial activities, 39.6%; construction activities, 3.2%; internal trade activities 25.8%; services activities, 17.2%; and transport, storage and communications activities, 14.2%. Figure (3) represents results by economic activity:

### 3.6 Value Added:

The surveys' results indicate that the value added in the Palestinian Territory was US\$ 3,384.1 million. This value was distributed by economic activity as follows: industrial activities, 28.6%; constructions activities, 1.5%; internal trade activities, 31.1%; services activities, 19.5%; and transport, storage and communications activities, 19.3%. Figure (4) shows results by economic activity:

## Methodology

### 4.1 Questionnaire:

All of the economic surveys series use the same questionnaire except for a few special characteristics for each survey. The design of the 2008 questionnaire takes into account the major economic variables pertaining to the examined phenomenon, and the needs of compiling the National Accounts for Palestine.

In the Gaza Strip and because of political conditions, there was a very brief model of the questionnaire, so as to collect basic data required for national accounts and without any details.

### 4.2 Coverage and Sampling:

#### 4.2.1 Coverage:

The fourteen rounds of the Economic Survey Series were executed depending on the Establishment Census 2007. The economic surveys series covers activities in accordance with (ISIC-3):

- Industry: (C, D, E)
- Construction: (F)
- Internal Trade: (G)
- Services: (H, K, M, N, O)
- Transport, Storage and Communication: (I)

#### 4.2.2 Sample Design:

The sample of the economic surveys series is a single-stage stratified random-systematic sample in which the enterprise constitutes the primary sampling unit (PSU). Three levels of strata were used to draw up an efficient representative sample (i.e., economic activity, size of employment and geographical levels). The sample size amounted to (9,555) enterprises out of the (101,990) enterprises comprising the survey frame.

#### 4.2.3 The Implementation Stage:

This phase includes fieldwork operations, data processing and tabulation:

- Fieldwork operations: They are initiated after the training and recruitment of qualified interviewers, who are responsible for data collection from the field.
- Data processing and tabulation: This part includes:
  - Developing a data entry program and training of operators
  - Organizing data entry processes
  - Post-data entry editing
  - Tabulation



## Chapter Five

### Data Quality

#### 5.1 Accuracy of the Data:

##### 5.1.1. Statistical Errors:

The findings of the survey are affected by statistical errors due to using a sampling in conducting the survey for the units of the target population. This increases the chances of having variances from the actual values we expect to obtain from the data had we conducted the survey using comprehensive enumeration. The variance of the key goods in the survey was computed and dissemination was carried out on the level of the Palestinian Territory for reasons related to sample design and computation of the variance of the different indicators.

The preceding table shows the variation of the most distinct variables, where it indicates institutions with activities that have been drawn from the sample for the rest of the Palestinian Territory, which is the activities of industry, internal trade and services. Construction activities and transport, storage and communications have no variation because of a comprehensive survey.

### **5.1.2. Non-Statistical Errors**

These types of errors could appear on one or on all of the survey stages that include data collection and data entry:

#### **Response rate values:**

- Sample size was 9,663 enterprises (including economic activity change) in the Palestinian Territory:
- Non-response cases: 1359
- Over coverage cases: 419
- Net sample:  $9,663 - 419 = 9,244$
- Response rate: 85.3%
- Non-response rate: 14.7%

Response errors: these types of errors are related to, responders, fieldworkers, and data entry personnel. To avoid mistakes and reduce the impact there has been a series of actions that would enhance the accuracy of the data through a process of data collection from the field and data processing.

### **5.2 Comparability:**

Published data in this report are compared with previous because using the same survey tools, and the data are internationally comparable, because they are adopted in a system of National Accounts 1993 (SNA93), and ISIC-3 of economic activities.

### **5.3 Data Quality Control:**

#### **5.3.1. Fieldwork**

- A specialized fieldwork team with economic background was selected; the team was trained theoretically and practically on the survey questionnaire.
- The main fieldwork team was selected according to the training course.
- Field work visits were made by both fieldwork and project management staff for monitoring and following up data collection process and progress of work. There was an average of two visits for each governorate. About 95% of completed questionnaires was reviewed and corrected if needed; comments and notes were directed to the team accordingly.
- Different levels of supervision and monitoring took place according to the following division:
  - Fieldworkers
  - Fieldworkers supervisors
  - Fieldwork coordinator. (Each has responsibilities in monitoring )
- Project management received a daily progress report about completeness and response.
- A refresher training course was conducted during the stage of data collection for emphasizing the main issues of training and answering questions of fieldworkers about issues faced in the field.
- Some institutions were visited by the researchers again to confirm the accuracy of the data that was given to researchers and that was called the interview. These institutions were selected randomly by withdrawing a random sample of 10% of the original sample of the survey, and then the data were compared with data from series surveys.

### **5.3.2 Data Processing:**

For insuring quality and consistency of data, a set of measures was taken into account for strengthening accuracy of data as follows:

- Preparing a data entry program before data collection for checking readiness of the program for data entry.
- A set of validation rules were applied on the program for checking consistency of data.
- Efficiency of the program was checked through pre-testing by entering a few questionnaires, including incorrect information, for checking its efficiency in capturing these information.
- Well-trained data keyers were selected and trained for the main data entry.
- Weekly data files were received by project management for checking accuracy and consistency; notes of correction are provided for data entry management for correction.

### **5.4 Notes on Data:**

1. Differences of results of certain indicators that can be noticed are due to approximation.
2. Note that there are some economic activities to reduce second ISIC has been collecting data with the previous activity, due to maintain the confidentiality of data provided by the law of statistics for 2000.
3. Financial data was collected by NIS, US \$ and JD, but it was converted and published in US \$.
4. There are some zero values due to either such values are low, or unavailable in some enterprises of the selected sample, so its not necessarily to be a zero value for all of them.
