HOW TO KEEP THE LOG BOOK

Household members should keep the Log Book for recording purchases of non-food commodities and received services during 3 months.

Interviewer collects Log Book after completion after three months (clarifying any notes if necessary).

The periods for Log Book keeping should be indicated by the interviewer at the Log Book cover page (monthly for the whole quarter).

Log Book includes 4 Sections:

Section 1- Purchase of outer clothing, underclothes, head-dresses, foot-wear, fabric, leather haberdashery, and other types of industrial manufactured non-food consumer goods (overcoat, dresses, bags, suitcases, shoes, all kinds of fabric, table-cloths, clothes accessories, and other.);

Section 2- Purchase of radio equipment, recreation staffs, means of transport, electrical household appliances, furniture and furnishing, jewellery, cooking battery, household goods, agricultural machinery and equipment, and other non-food consumer goods (a television-set, combine, car, clock (watch), electric fan, couch, tableware (service) and other staffs for household needs);

Section 3 – Purchase of construction materials, sanitary appliances, and other non-food goods (brick, lime, paint, lavatory pans, bathes, sinks, glass materials and other.);

Section 4 – Expenditures on service payment (housing and communal services: electricity, gas, education, telephone, television, internet, the services of bath-houses, laundries, repair and making goods and other.)

Purchase of food staffs is not taken into account in the Log-book. To keep the log-book, the following rules should be observed:

- Please record all the expenses as you have incurred them. Don't postpone till the end of the month
- Only expenditures for **private consumption** should be taken into account; production expenditures should not be recorded. For example, do not include expenditure on farm production or for a household business.
- When you record your expenses, please indicate the date of the purchase. This will help to avoid duplications of your records.
- When filling in the Log Book please look through every Section so that you don't forget to record all purchased commodities and paid services.
- Your records should be as precise and detailed as possible.
- Please try to fill in all the columns of the Log Book except for codes.

If filling in the columns for additional commodity description causes difficulties, you can leave this information to be recorded by the interviewer. The most important for us is that you should not forget to record the fact of purchasing the commodity or receiving the service and their costs.

- When you buy commodities or receive services on credit or on trust, please record their full cost.
- Any consumer commodities or services that have been gifted to any member of your household are not recorded in the Log Book.
- When keeping a Log Book you can check with the List of Non-Food Consumer Commodities and Services provided at the end of Journal and please look at the example.
