## I. Objectives

This survey was designed to assist the World Bank Group (WBG) in gaining a better understanding of how stakeholders in Poland perceive the WBG. The survey explored:

- *Overall Context*
- *Overall Attitudes toward the World Bank Group*
- *World Bank Group's Work and Engagement on the Ground*
- *World Bank Group's Support in Development Areas*
- *World Bank Group's Knowledge Work and Activities*
- *The Future Role of the World Bank Group in Poland*
- *Communication and Information Sharing*
- *Background Information*

## II. Methodology

From March to April 2021, 446 stakeholders of the WBG in Poland were invited to provide their opinions on the WBG's work in the country by participating in a Country Opinion Survey. Participants were drawn from the Office of the President, Prime Minister; office of a minister; office of a parliamentarian; ministries/ministerial departments/implementation agencies; Project Management Units (PMUs) overseeing implementation of WBG projects; consultants/contractors working on WBG-supported projects/programs; local governments; independent government institutions; the judicial system; state-owned enterprises; bilateral and multilateral agencies; private sector organizations; the financial sector/private banks; private foundations; NGOs and community based organizations; trade unions; faith-based groups; youth groups; academia/research institutes/think tanks; the media; and other organizations.

A total of 83 stakeholders participated in the survey (19% response rate). Respondents completed the questionnaire online.

Every country that engages in the Country Opinion Survey (COS) must include specific indicator questions that will be aggregated for the World Bank Group's annual Corporate Scorecard. These questions are identified throughout the survey report.

The results in this year's Country Survey were compared to those in the Country Survey conducted in FY'17 (response rate was 26%, N=109). Data were weighted to reach the same stakeholder composition in two years, which allows for year comparisons. Stakeholder groups which were not present in both fiscal years were not included in the comparison. Respondents who belonged to the "other" stakeholder category were not included either. As a result, mean ratings, percentages of respondents, and the total number of respondents in both years are slightly different from those of the original data reported in the FY'17 COS report and the non-weighted data presented in appendices A, B, C and E. For the weighted stakeholder breakdown and year comparison results, please refer to Appendix D (page 73).

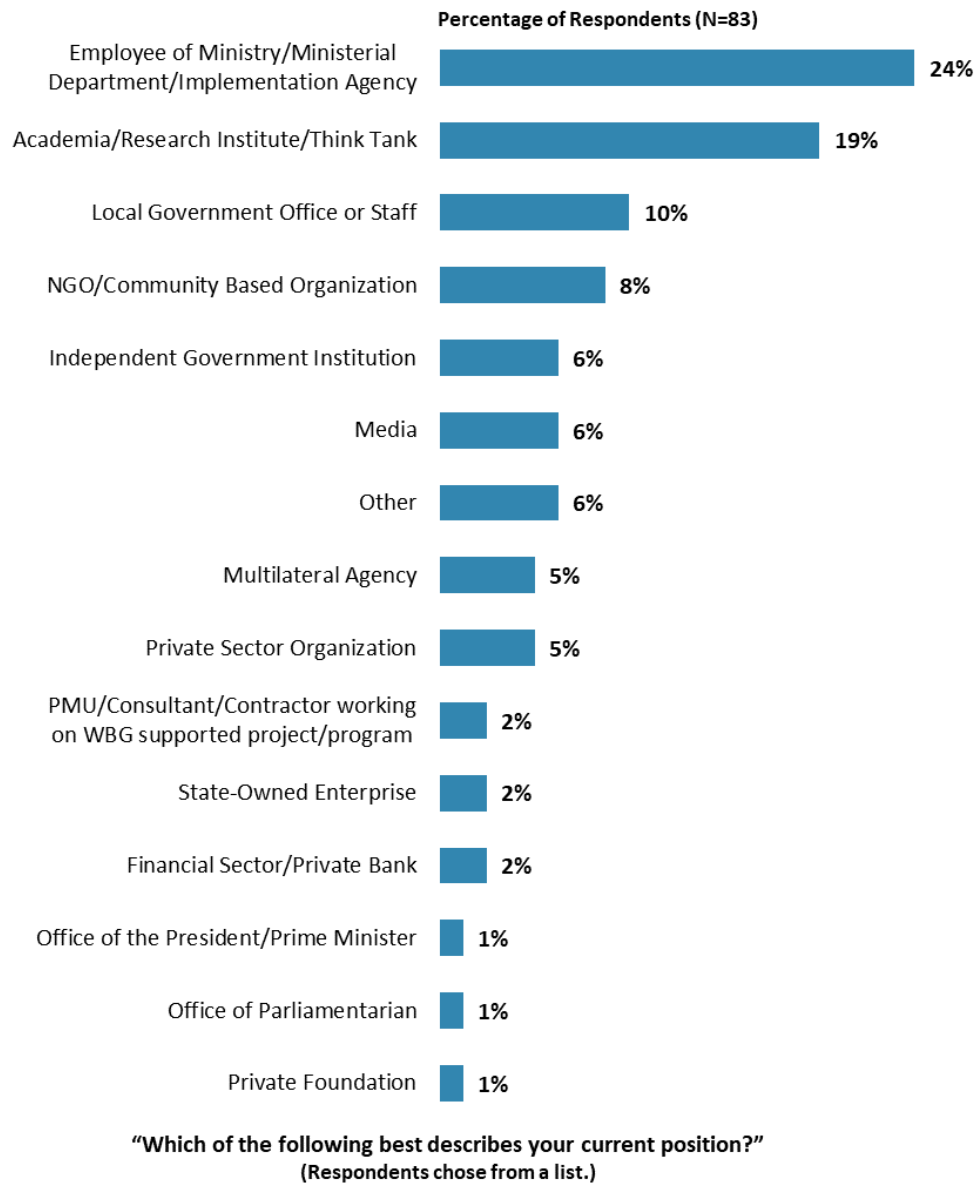

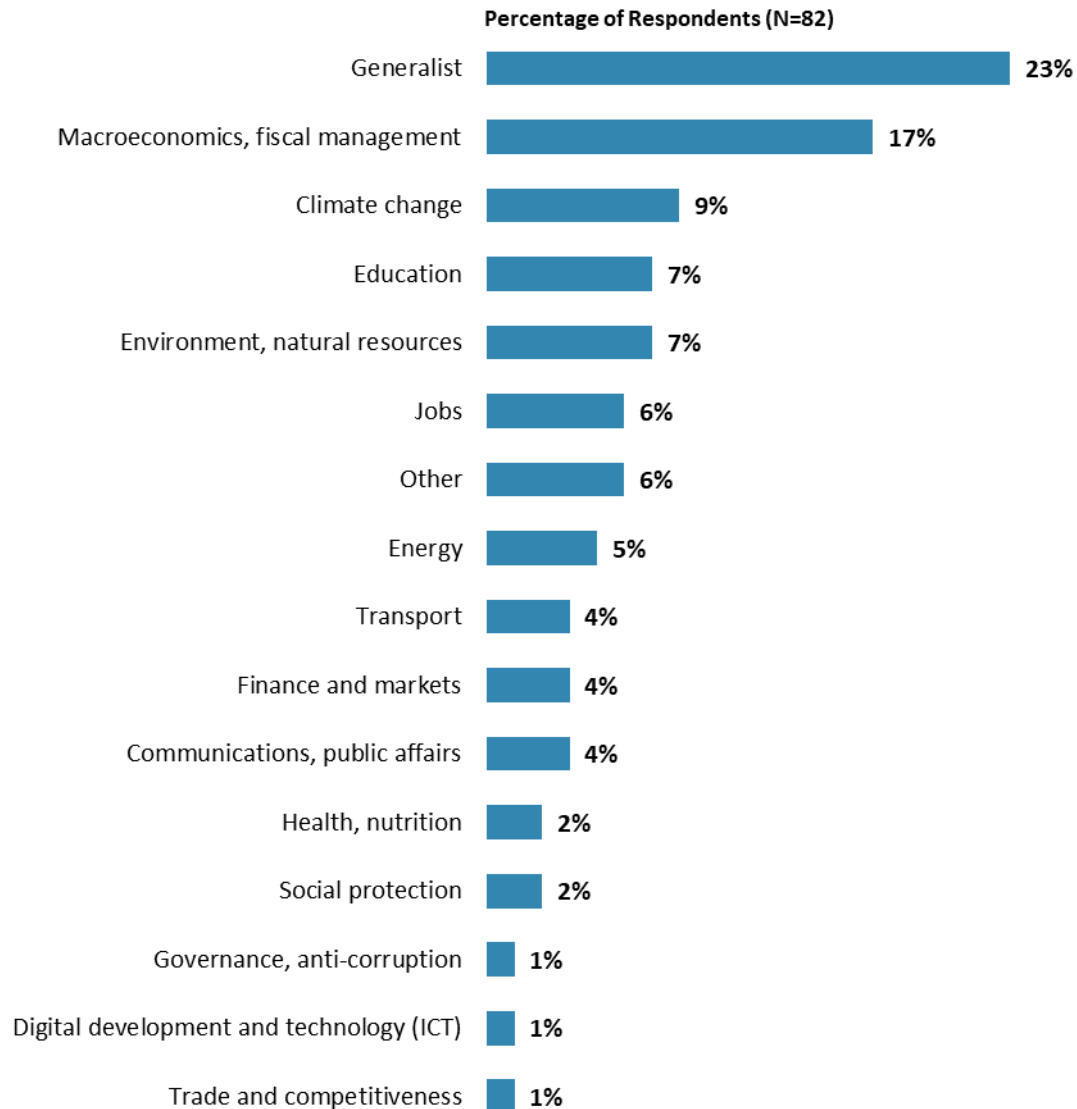

The small number of the respondents from the office of the President/Prime Minister, office of a parliamentarian, and from state-owned enterprises were included in the "Other" category. There were no respondents from the office of a minister, from the judicial system, bilateral agencies, trade unions, faith-based groups, and from youth groups.

#### Area of Primary Specialization



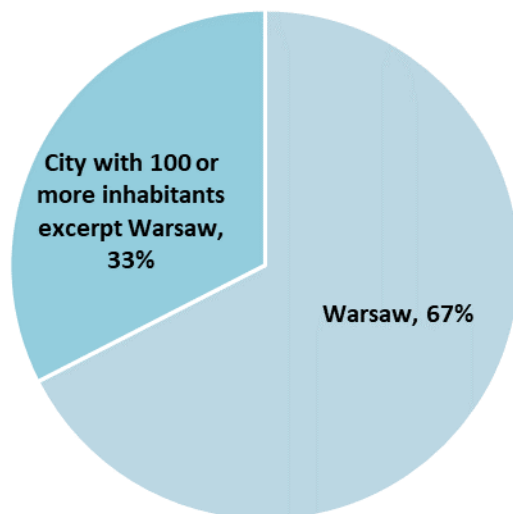

Percentage of Respondents (N=83)

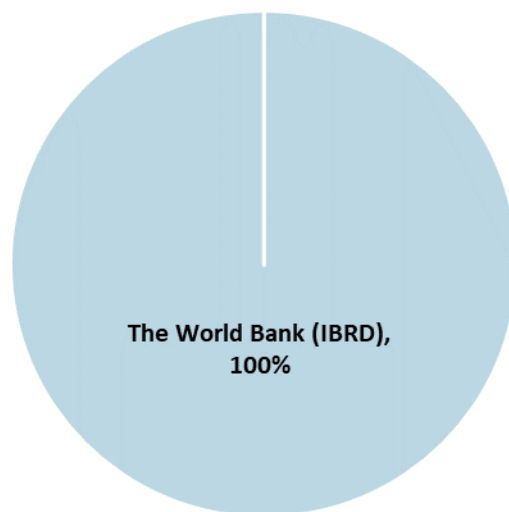


"Which best represents your geographic location?"

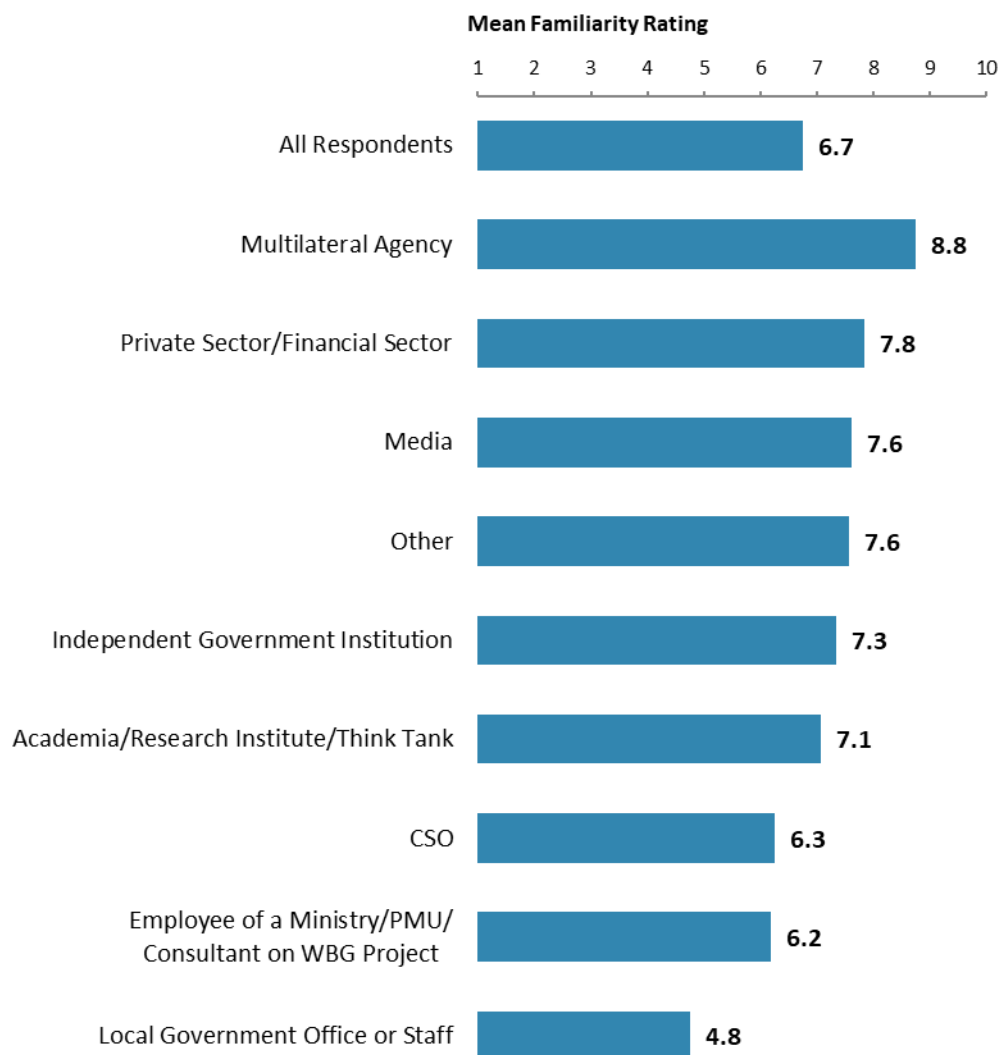

- **Year comparison:** Respondents in this year's Country Survey had statistically similar levels of familiarity with the WBG compared to respondents in the FY'17 Country Survey (weighted mean in FY'21 = 6.7; weighted mean in FY'17 = 6.3)<sup>2</sup>.

(1-"Not familiar at all", 10-"Extremely familiar")

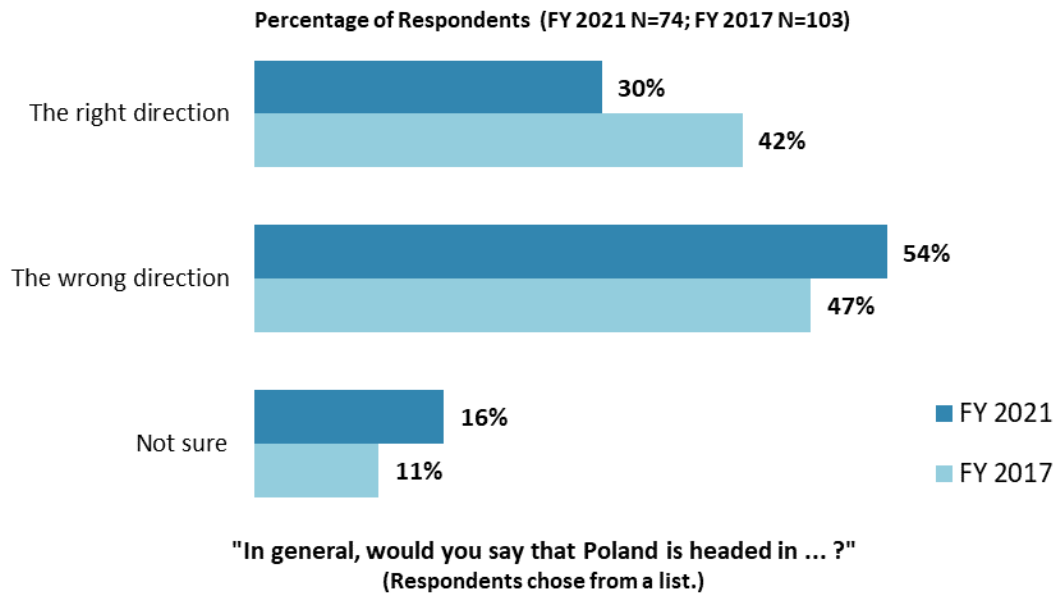

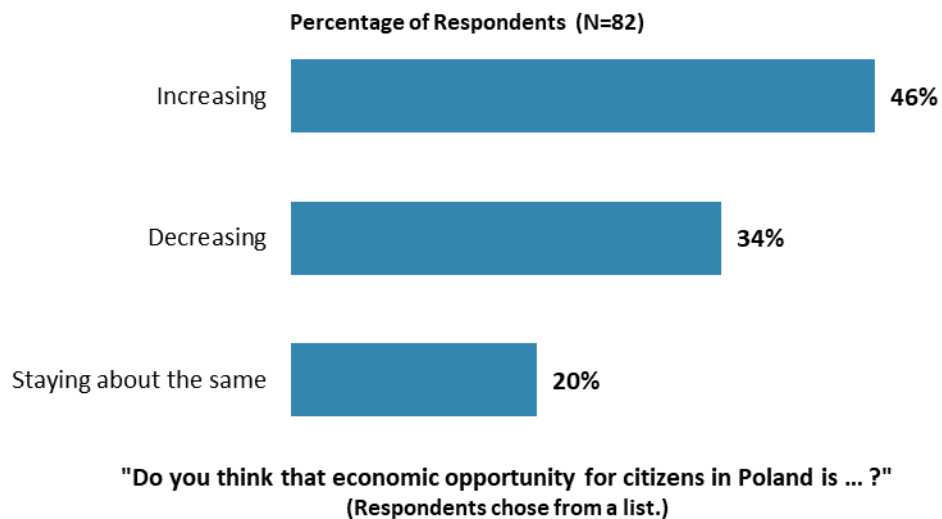

### Perceptions of Economic Opportunity



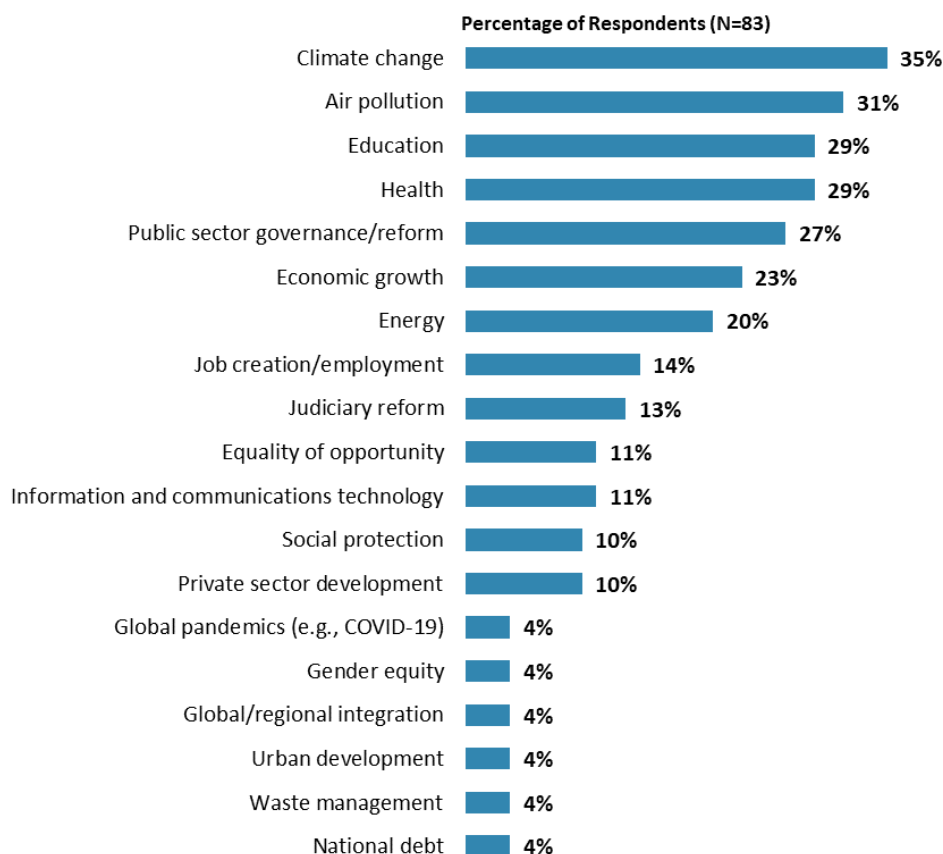

## IV. Overall Context (continued)

### Development Priority

- **Year comparison:** Respondents in the previous FY'17 Country Survey indicated that the most important development priorities in Poland were “*public sector governance/reform*” (53%), “*economic growth*” (44%), “*social protection*” (24%), “*education*” (19%), and “*job creation/employment*” (16%). This year, “*climate change*” and “*air pollution*” emerged as top development priorities, with significant increases compared to FY17 (10% and 7% respectively in FY17). “*Health*” also gained in priority, with twice as many respondents selecting it this year compared to FY17 (13%).
- **Specialization:** Respondents who identified their primary specialization of work as “*environment, natural resources*” or “*climate change*” (combined - 16% of the sample) were significantly *more* likely to indicate that “*climate change*” was the most important development priority in Poland, compared to the rest of the respondents (environment/climate change specialists = 62%; others = 30%).<sup>4</sup>

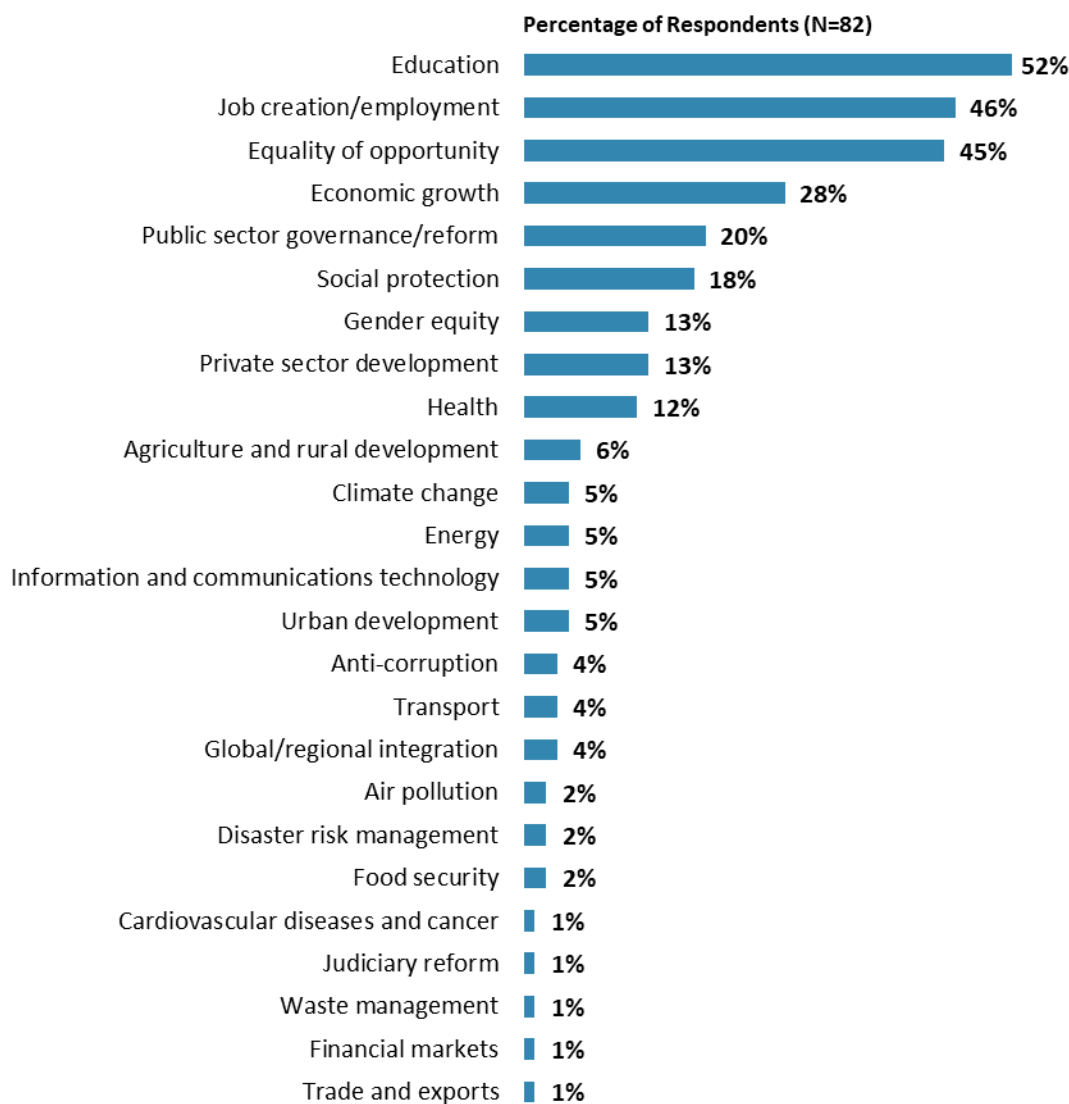

- **Year comparison:** Respondents in the previous FY'17 Country Survey indicated that the biggest contributors to poverty reduction in Poland were “*economic growth*” (61%), “*job creation/employment*” (42%), “*equality of opportunity*” (41%), “*social protection*” (31%), and “*education*” (30%).

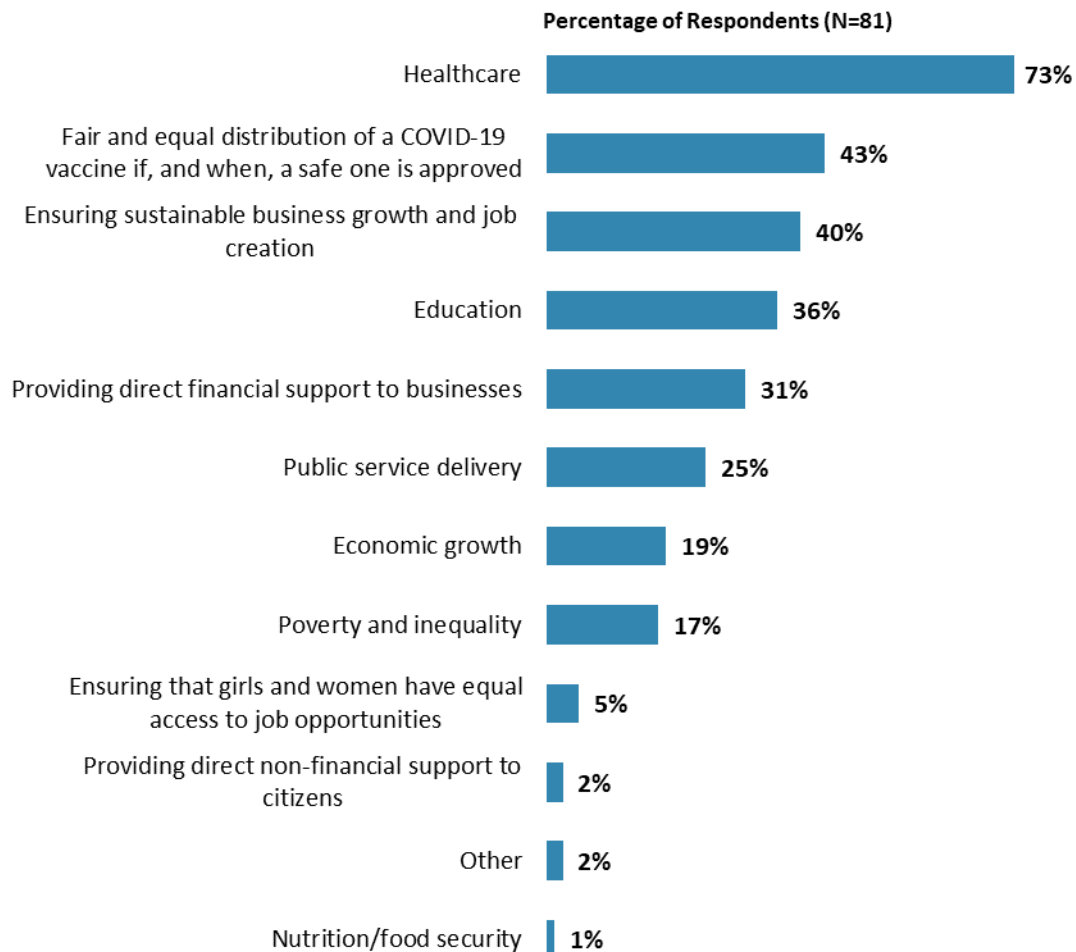

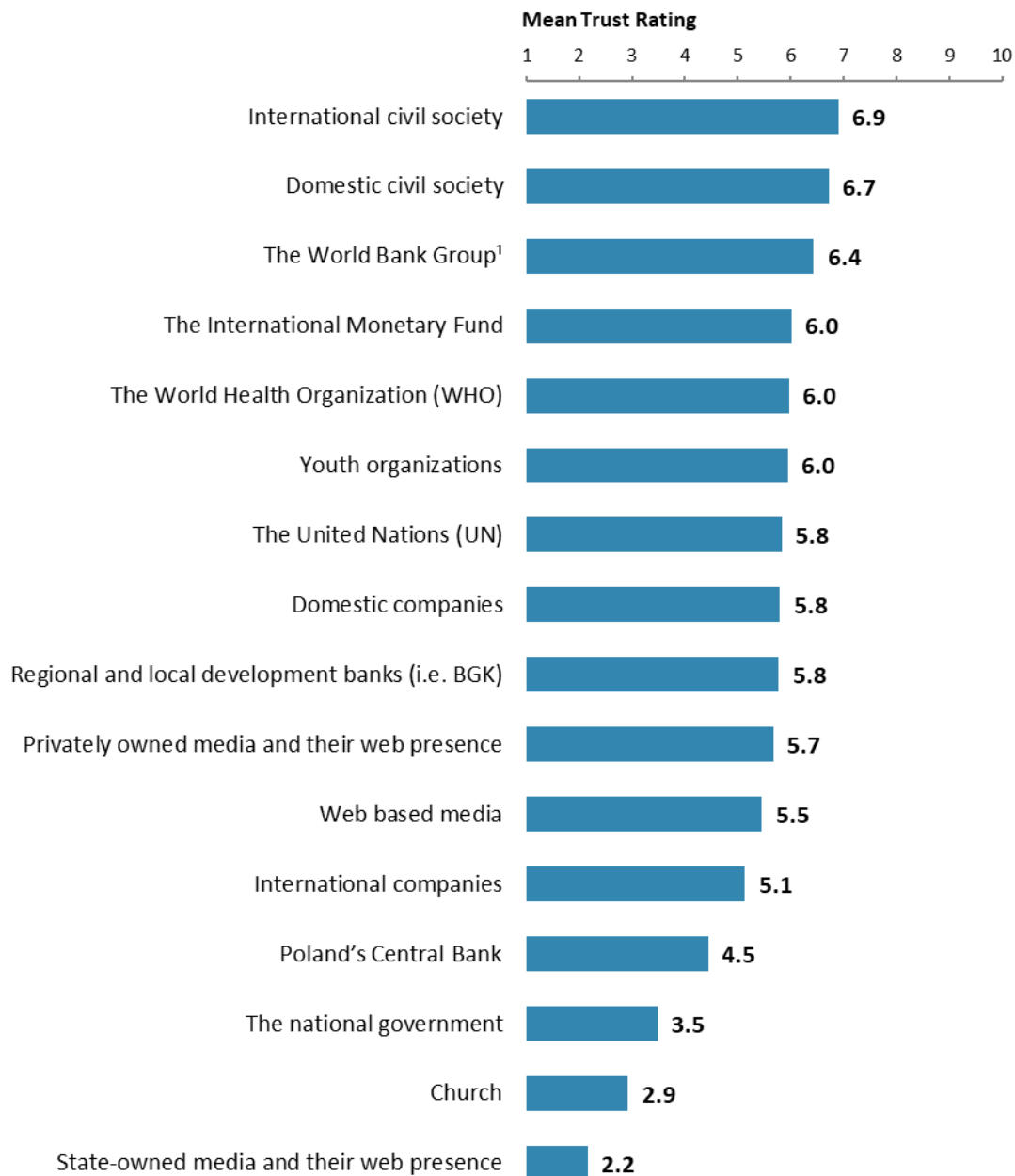

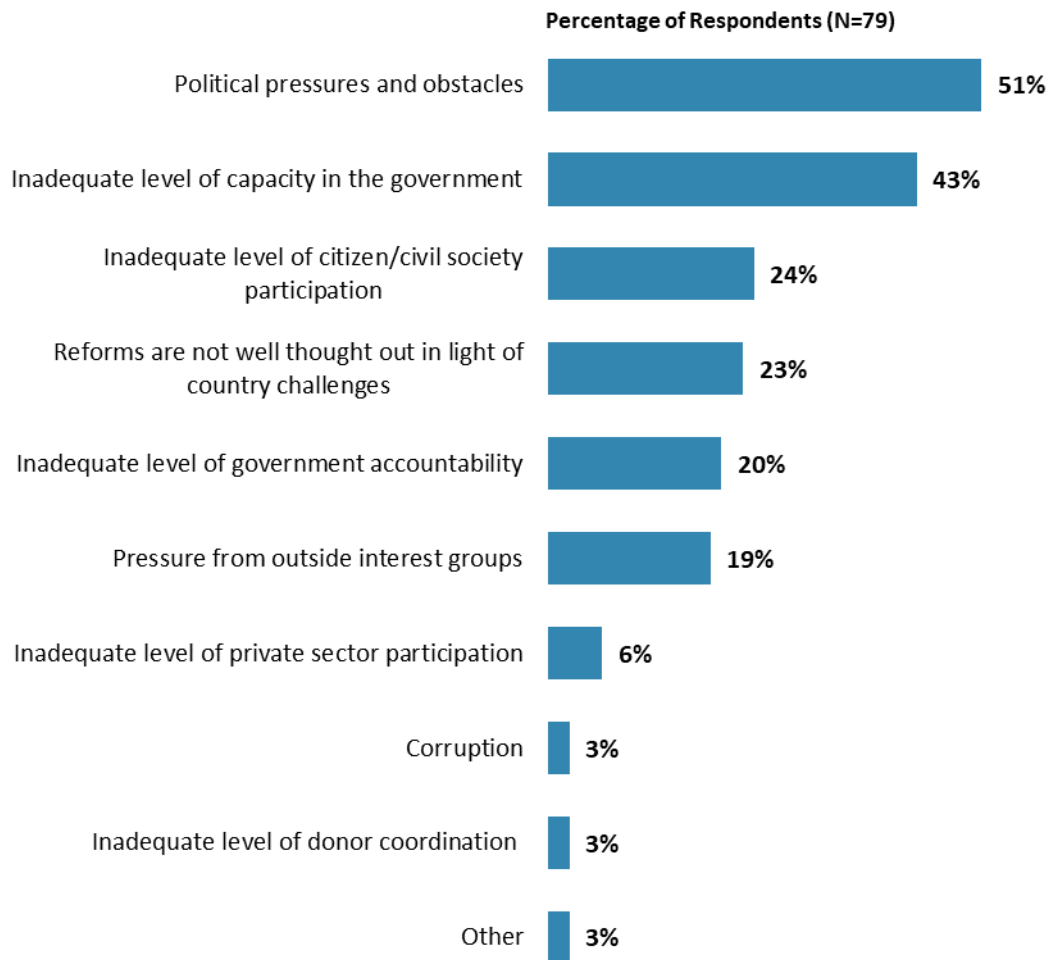

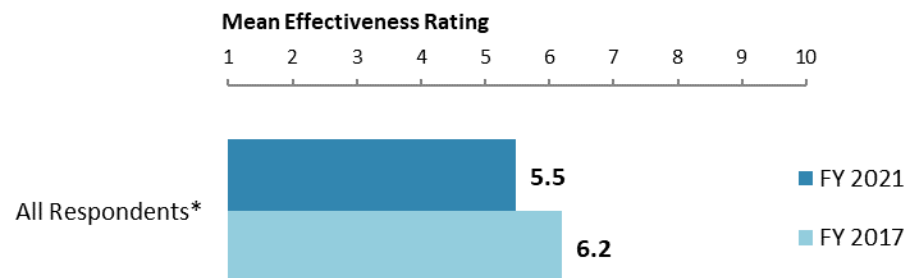


**"When economic and/or social reform efforts fail or are slow to take place in Poland, which of the following would you attribute this to? (Choose no more than TWO)"**

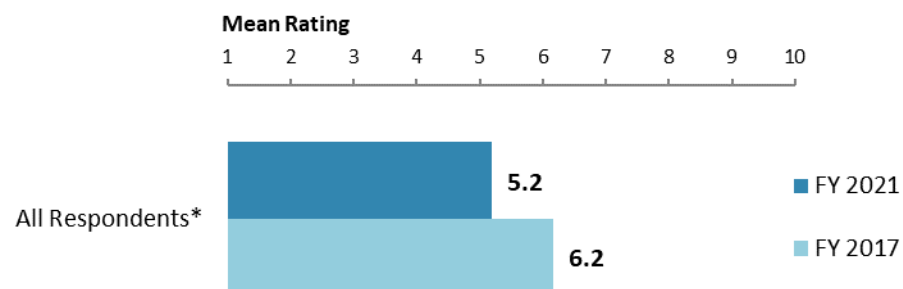

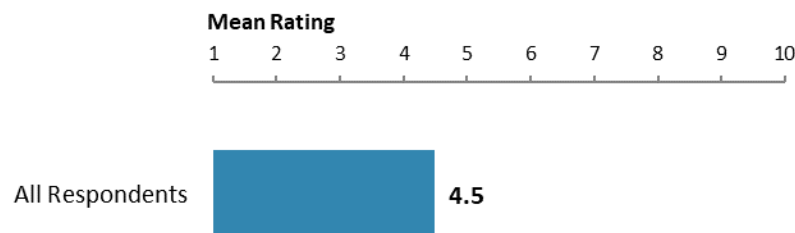

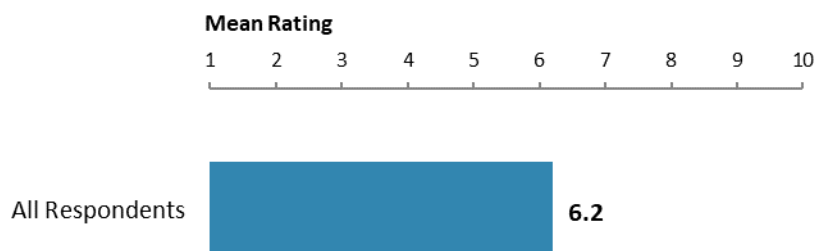

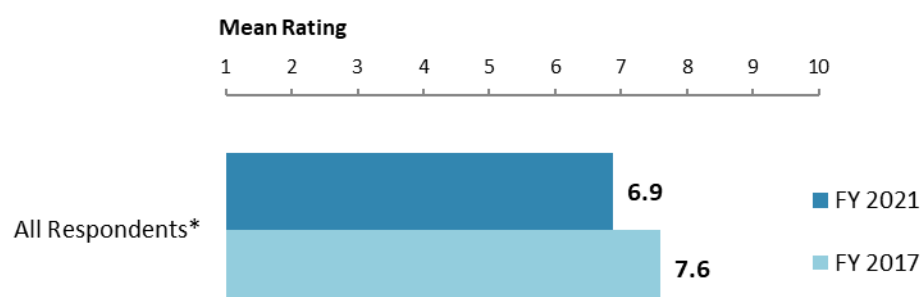
### WBG Staffing in Poland

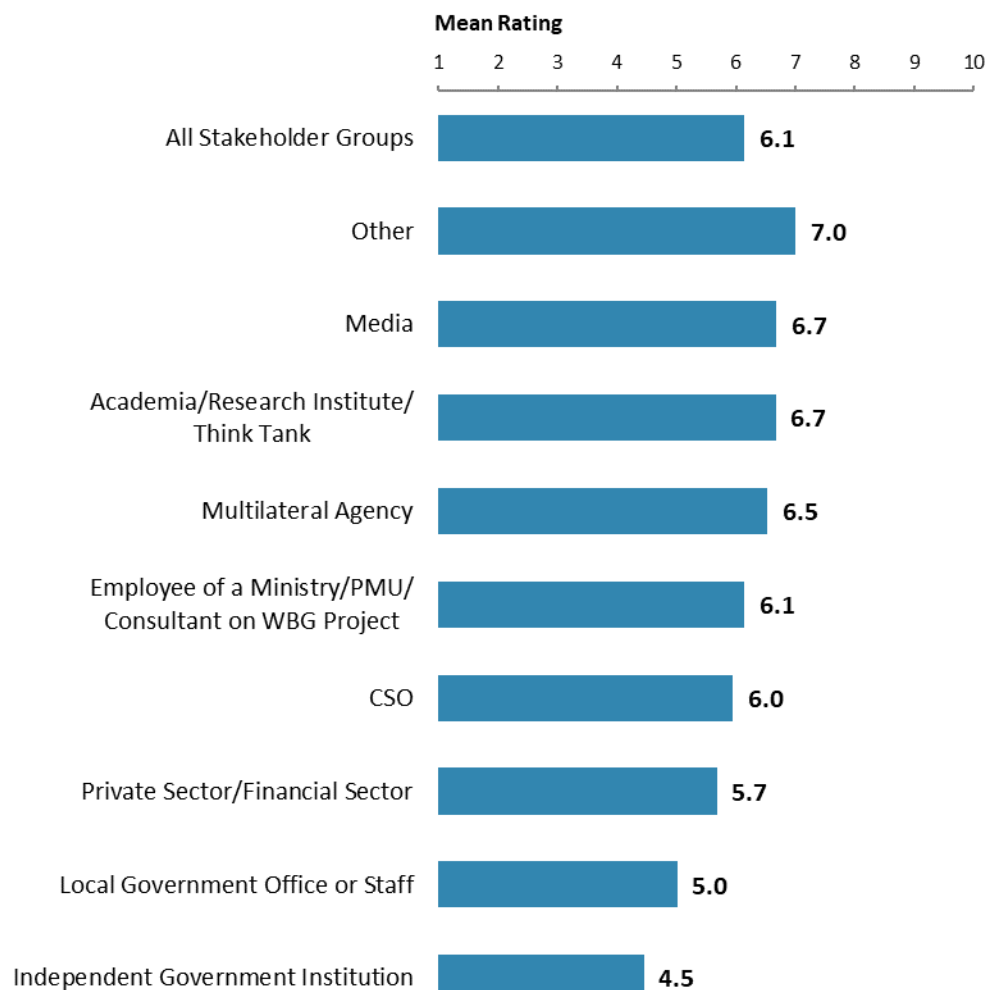

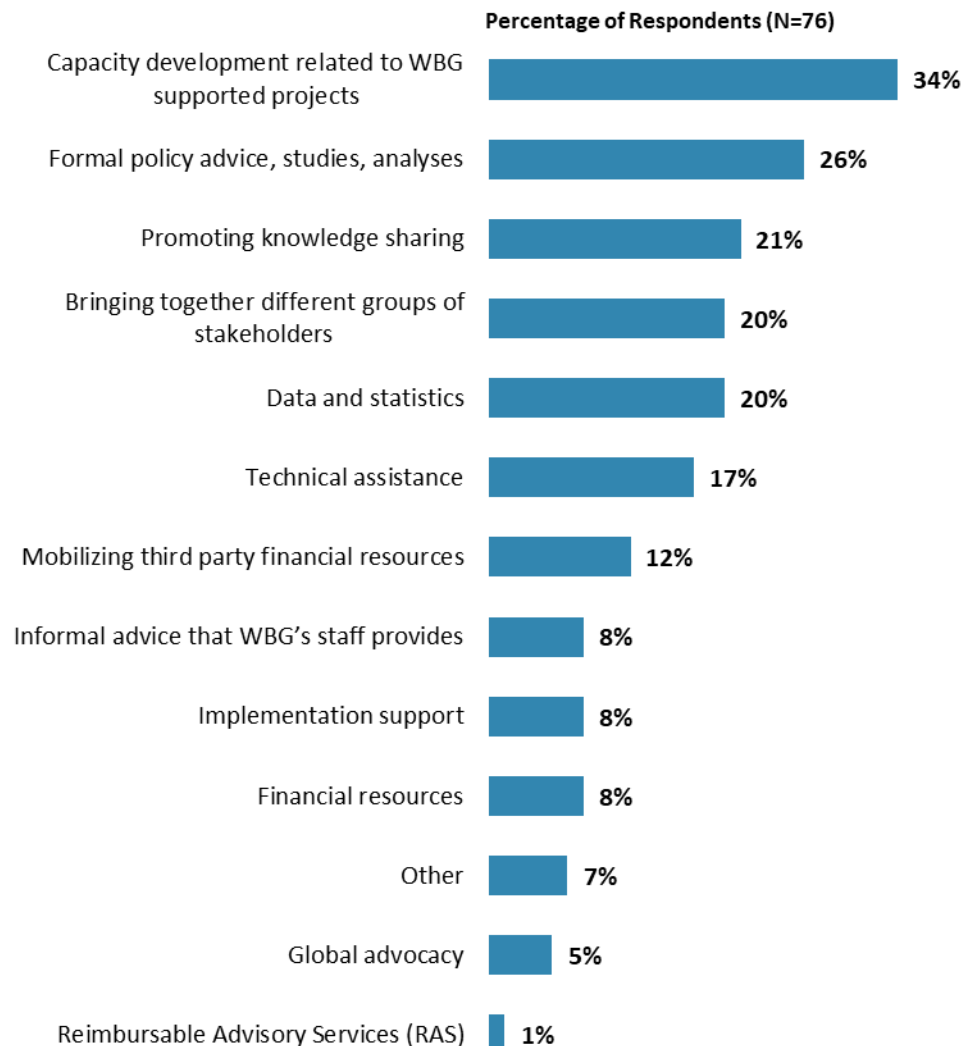
Mean Ratings for All Indicator Questions by Stakeholder Groups on a Scale from 1 to 10

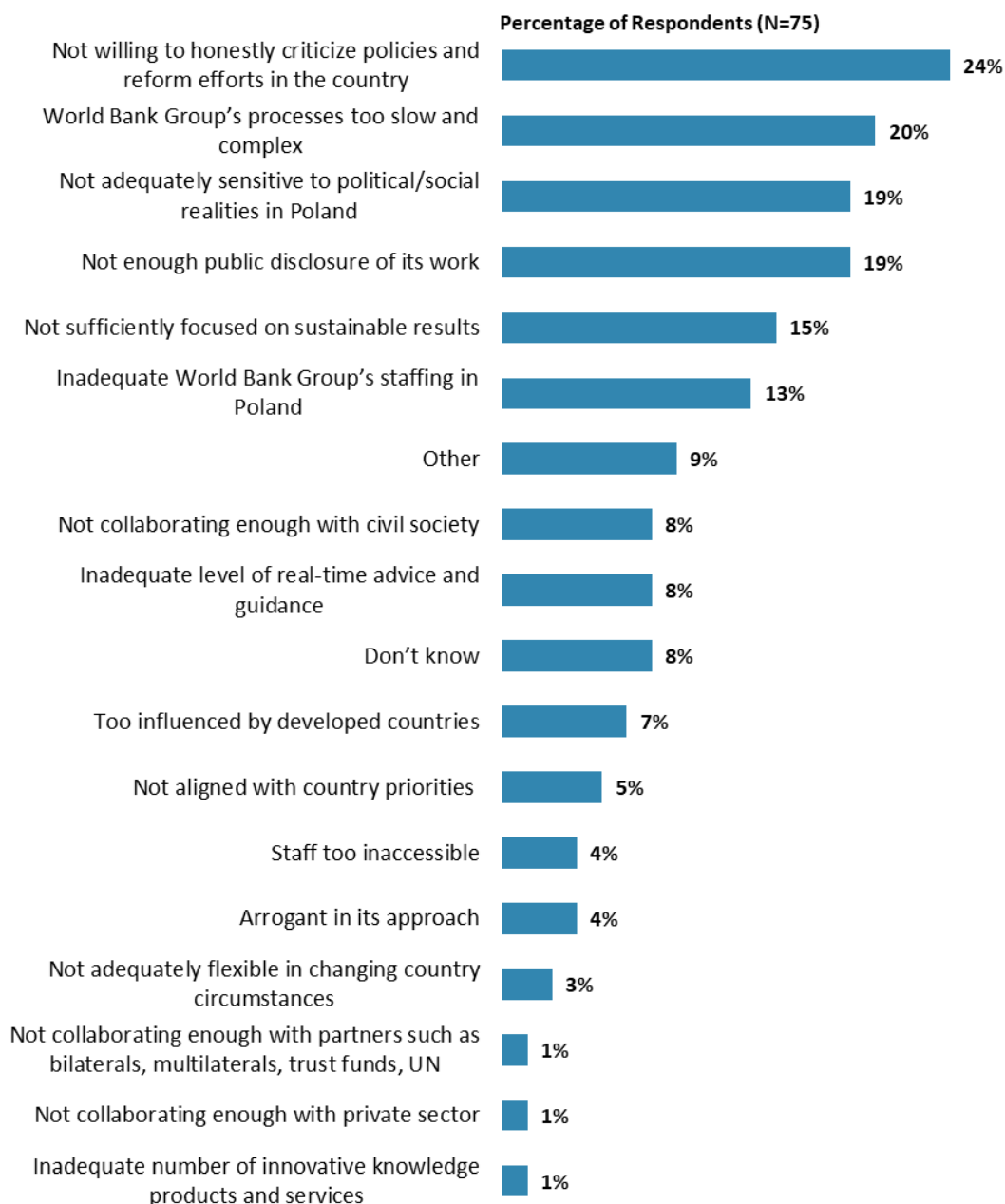
**"When thinking about the World Bank Group's role in Poland, which activity do you VALUE the most? (Choose no more than TWO)"**

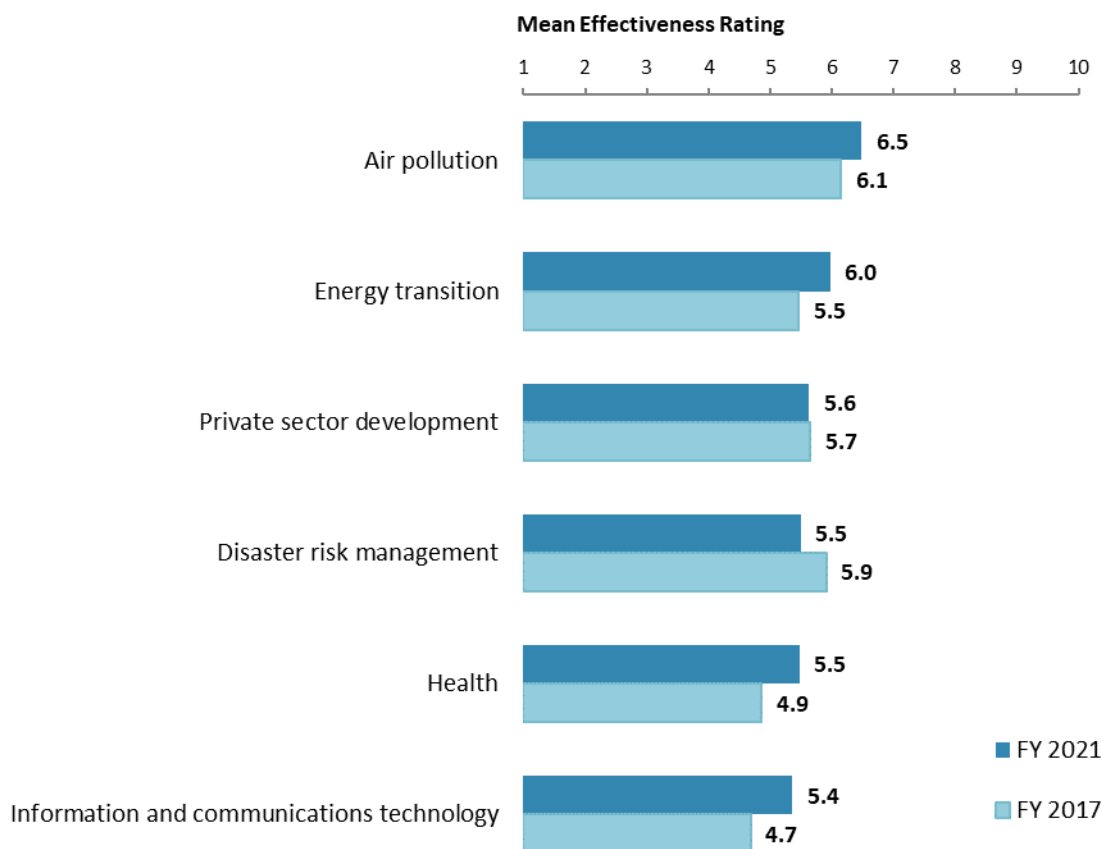


**"Which of the following do you identify as the World Bank Group's greatest WEAKNESSES in its work in Poland? (Choose no more than TWO)"**

### Effectiveness of WBG's Support in Sectoral Areas: Year Comparison<sup>7</sup>



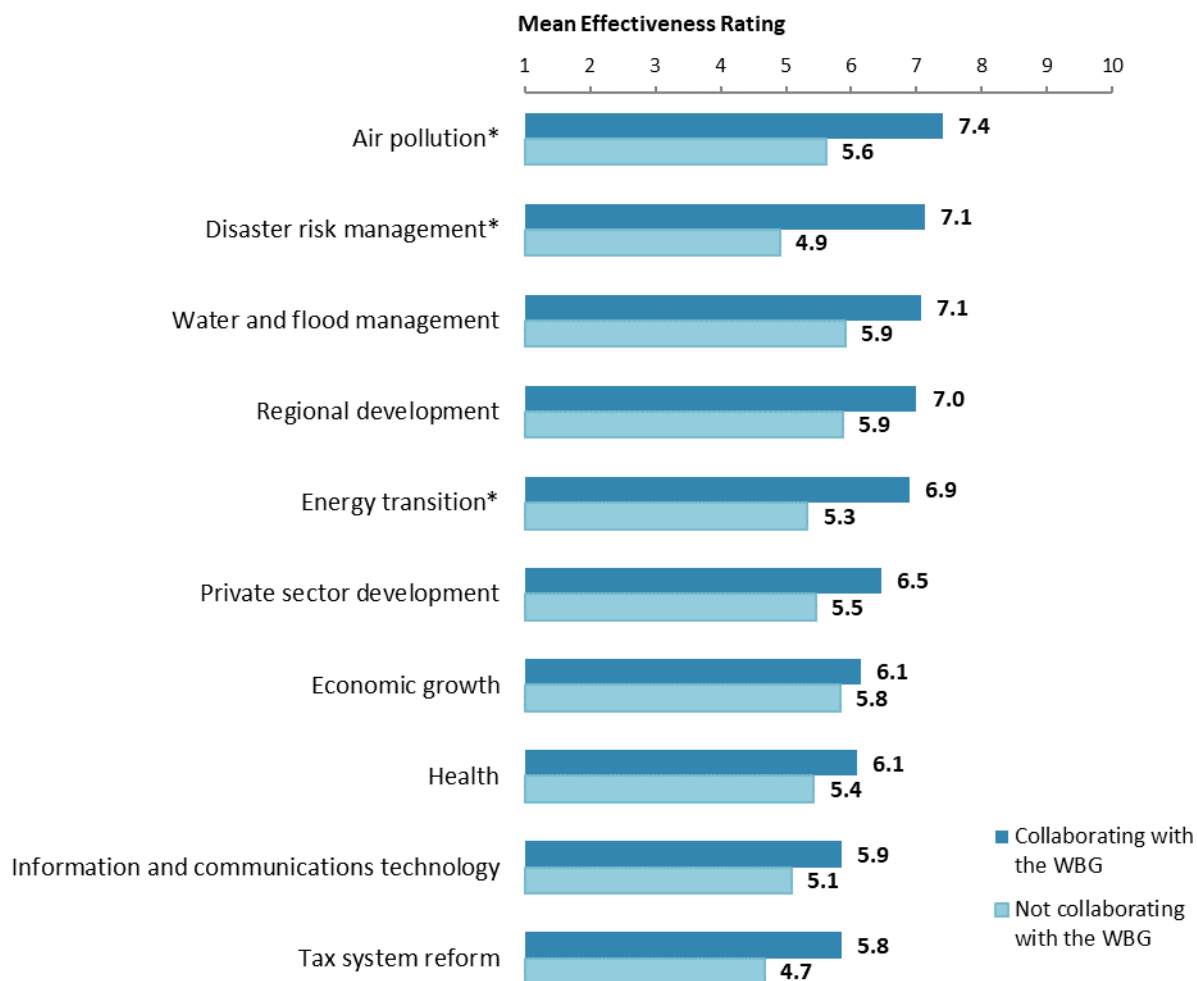
"How EFFECTIVE do you believe the World Bank Group is in terms of the work it does in the following areas of development in Poland?"

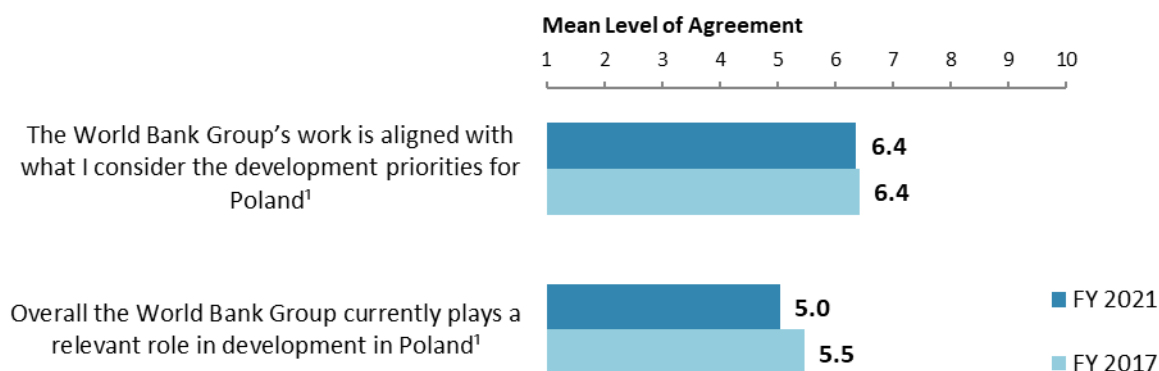

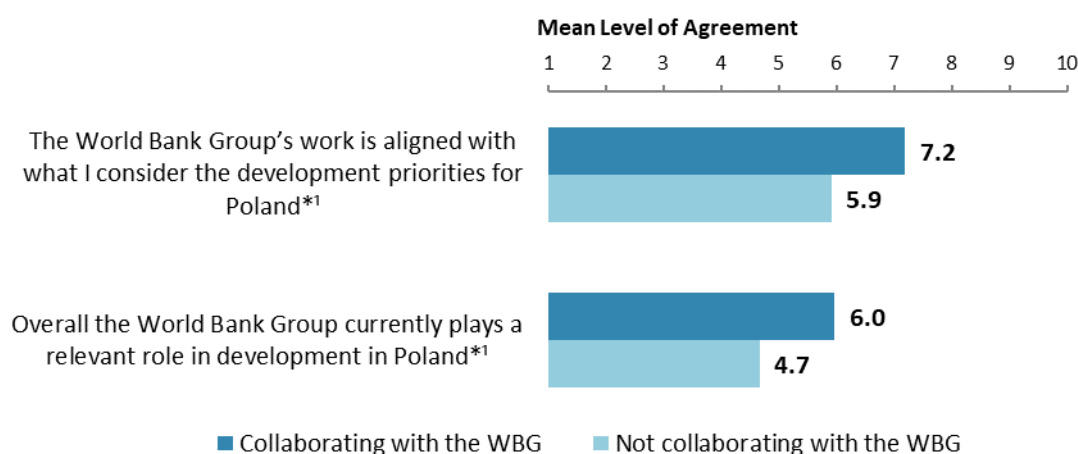

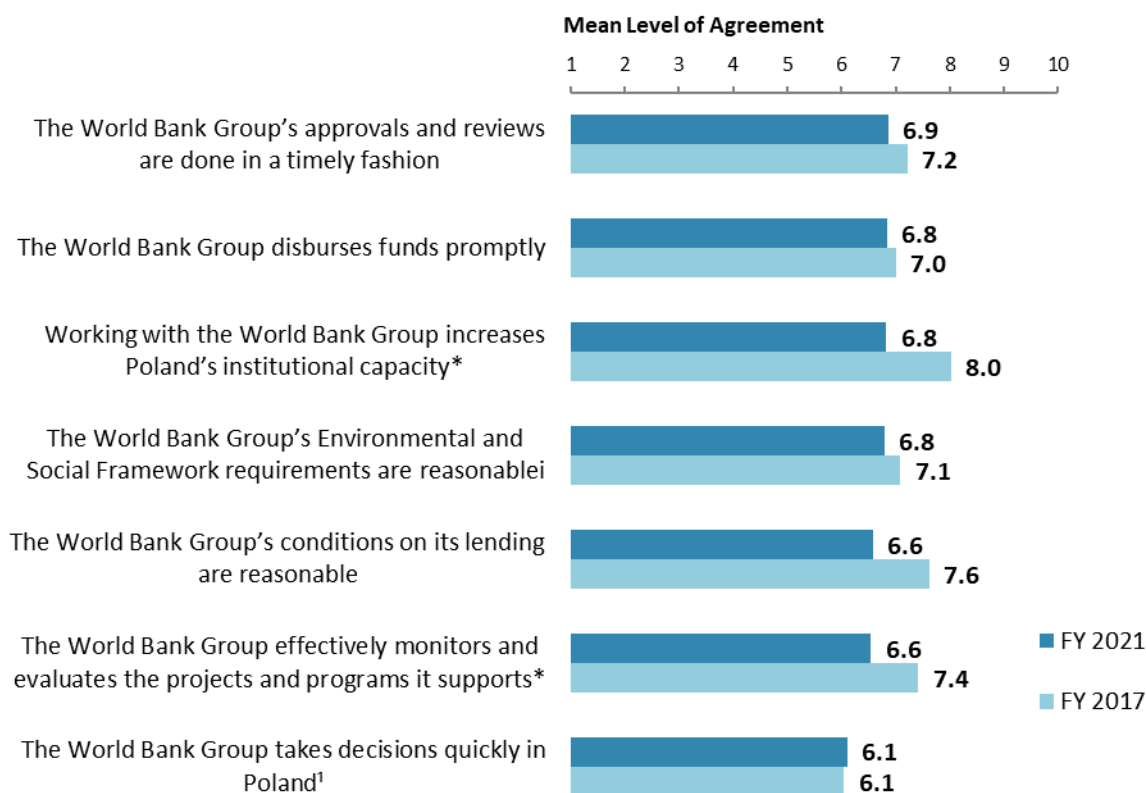

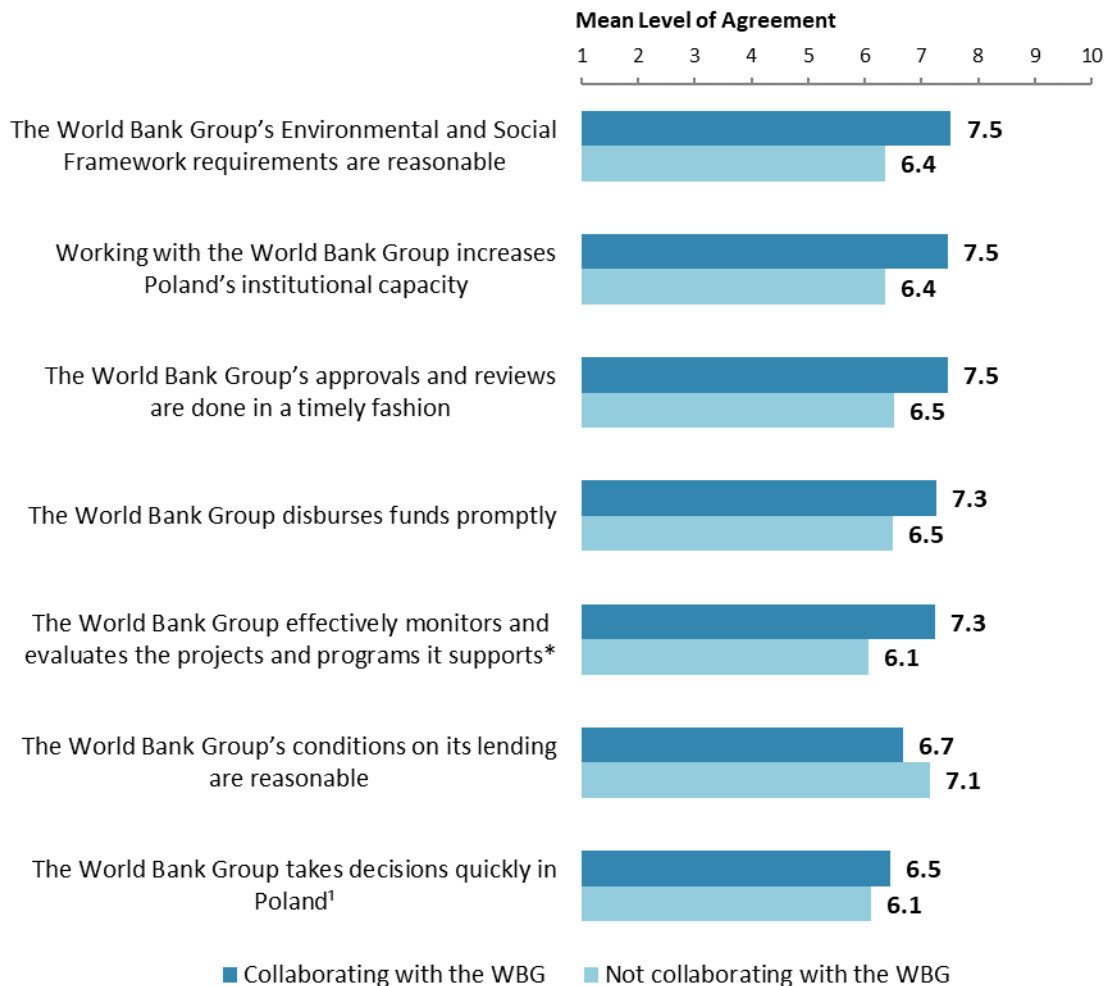

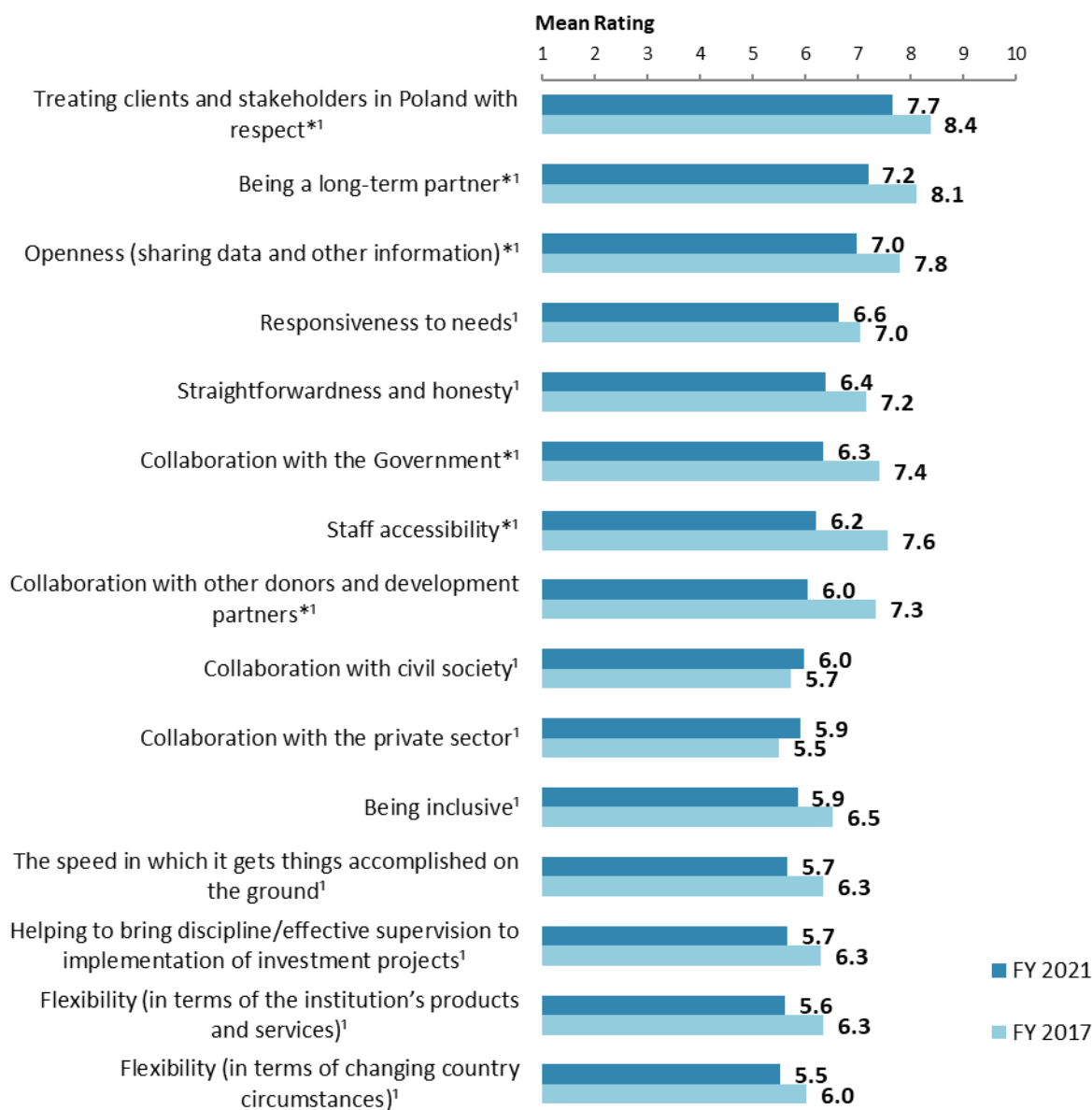

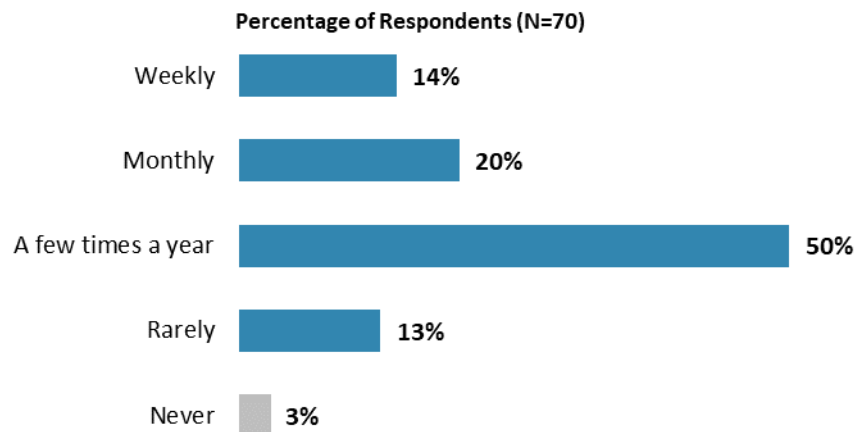

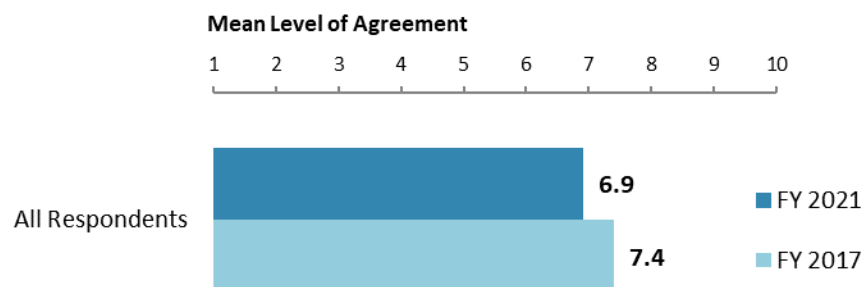

### Meeting Poland's Knowledge Needs<sup>12</sup> (Indicator Question)



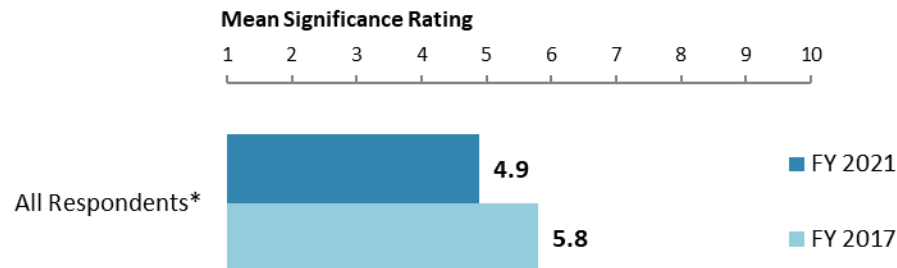

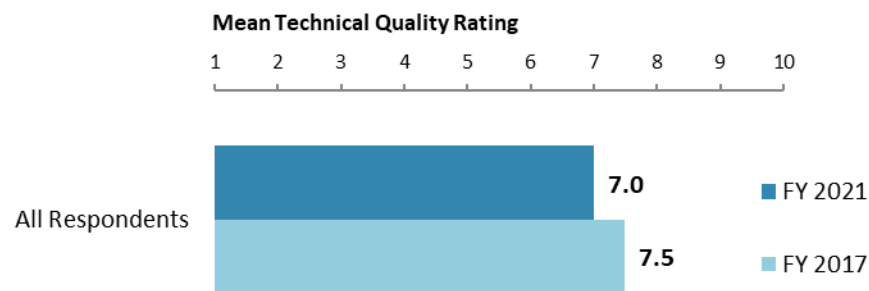


"Overall, how significant a contribution do you believe the World Bank Group's knowledge work and activities make to development results in your country?"

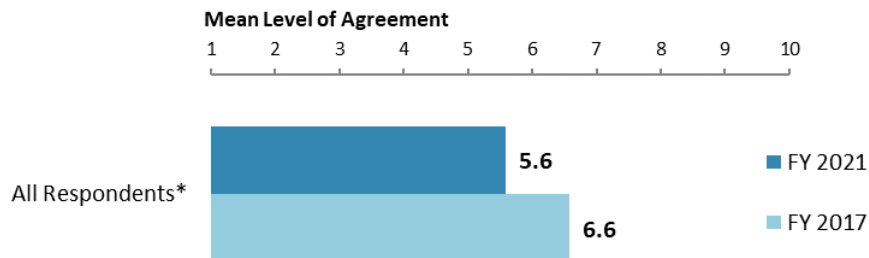

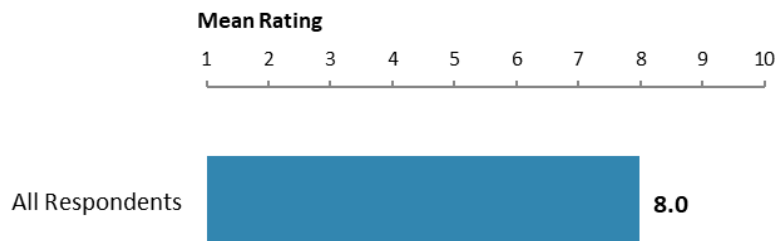

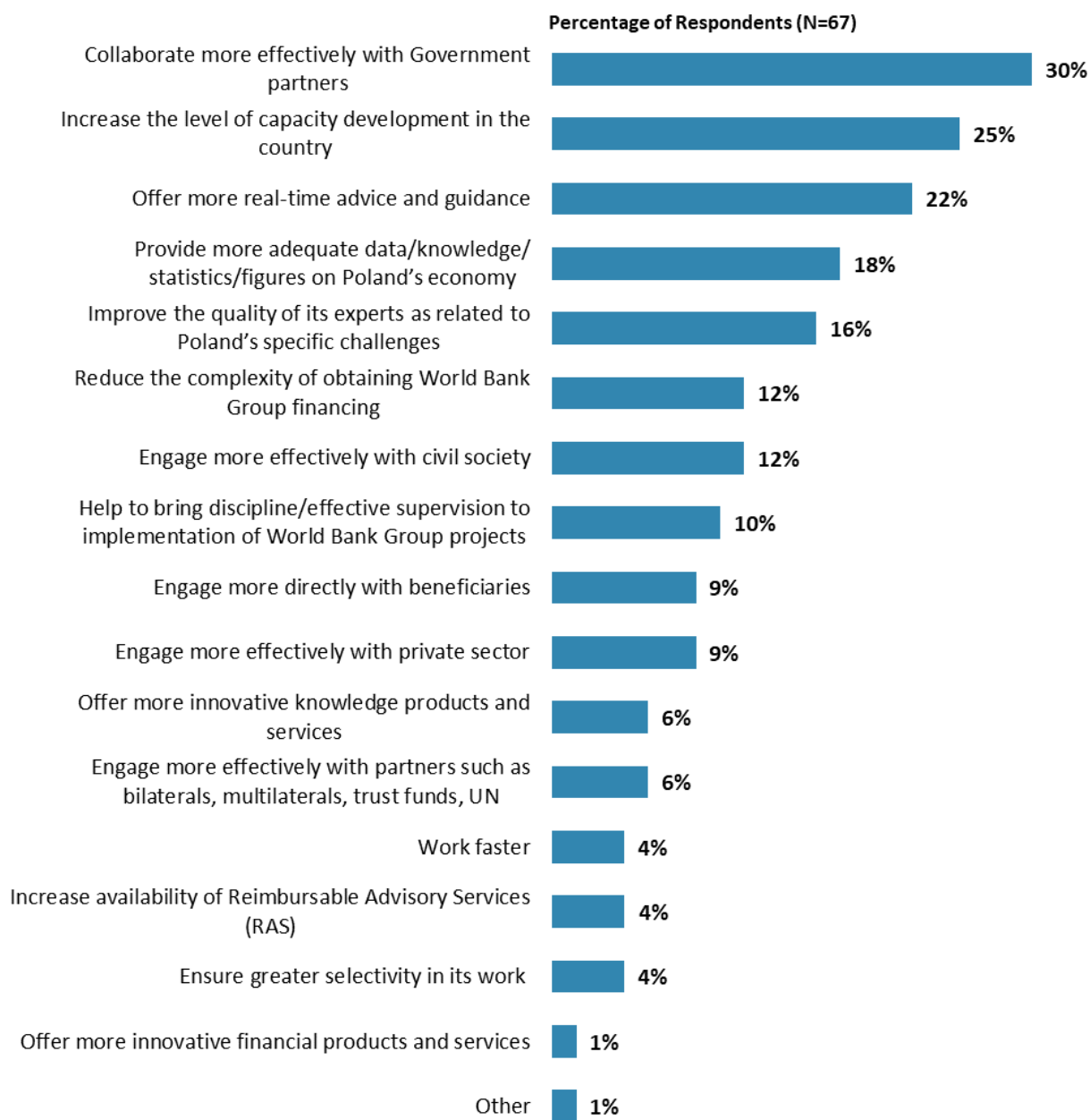

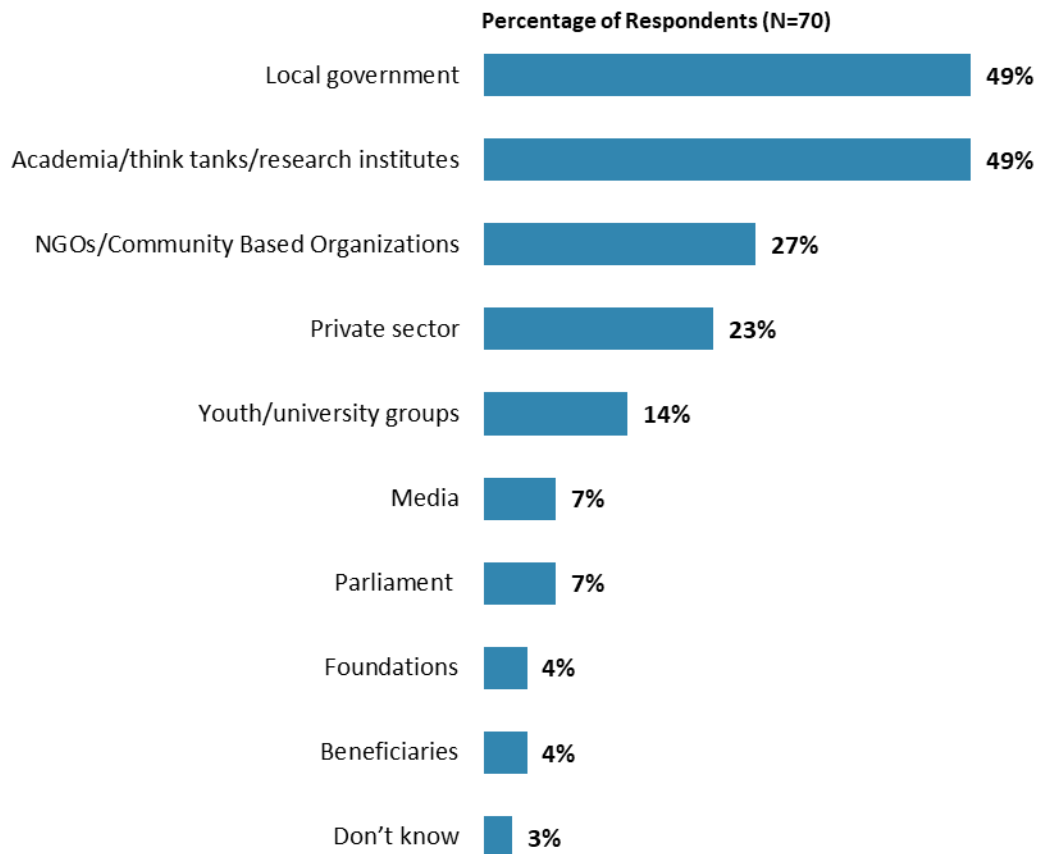
**"Which of the following SHOULD the World Bank Group do to make itself of greater value in Poland? (Choose no more than TWO)"**

"In addition to the regular relations with the national government, which TWO of the following groups should the World Bank Group collaborate with more in your country? (Choose no more than TWO)"

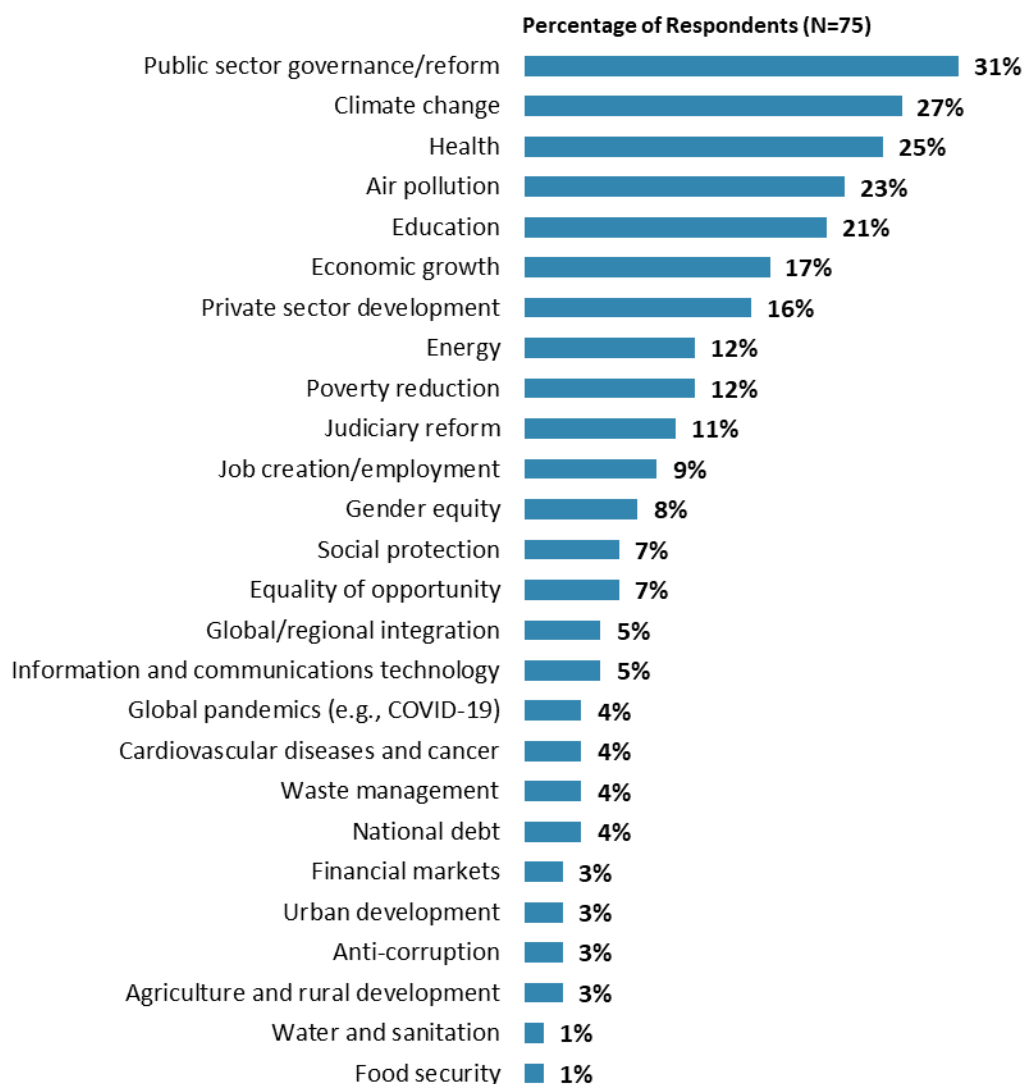

### Where the World Bank Group Should Focus its Resources

- **Year comparison:** Respondents in the previous FY'17 Country Survey indicated that the WBG should focus its resources on “*public sector governance/reform*” (51%), “*economic growth*” (36%), and “*job creation/employment*” (23%). Consistent with the perceived development priorities, this year more respondents selected “*climate change*”, “*health*”, and “*air pollution*” among the top areas of the WBG’s focus, with significant increases compared to FY17 (10%, 15%, and 11% respectively in FY17).

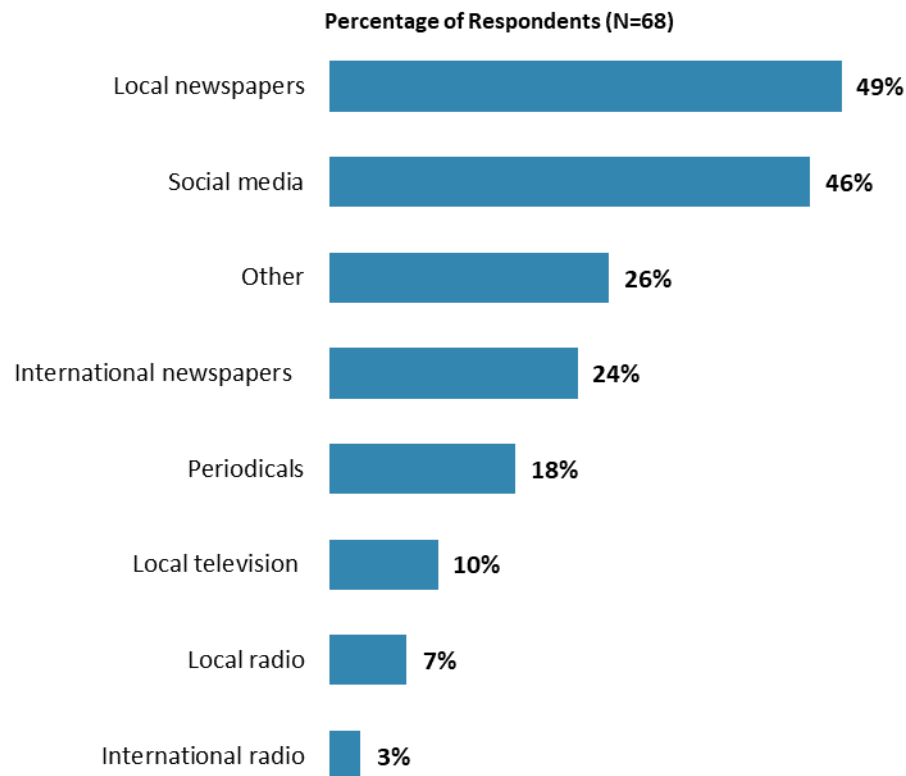

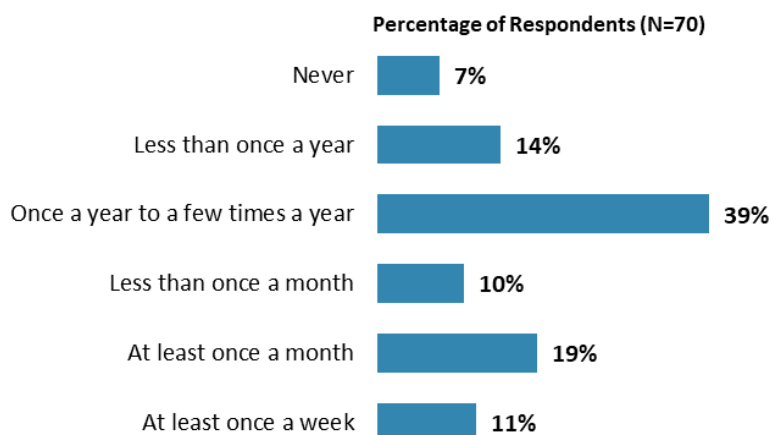

### WBG Interaction Frequency

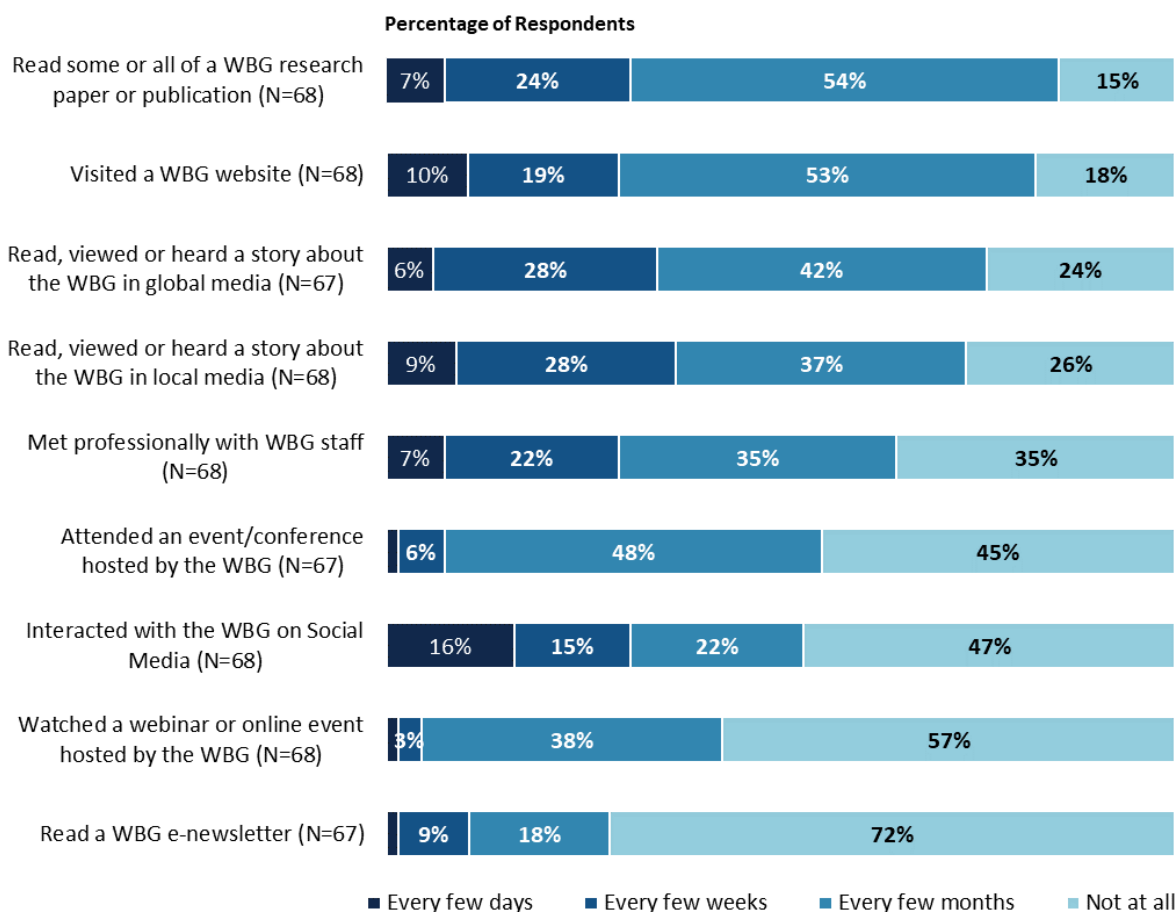


**"How frequently do you interact with the World Bank Group now in Poland?"**
