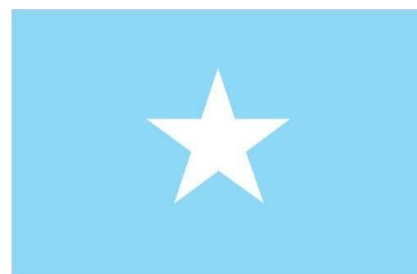

## I. Objectives

This survey was designed to assist the World Bank Group (WBG) in gaining a better understanding of how stakeholders in Somalia perceive the WBG. The survey explored:

- *Overall Context*
- *Overall Attitudes toward the World Bank Group*
- *World Bank Group's Work and Engagement on the Ground*
- *World Bank Group's Support in Development Areas*
- *World Bank Group's Knowledge Work and Activities*
- *The Future Role of the World Bank Group in Somalia*
- *Communication and Information Sharing*
- *Background Information*

## II. Methodology

From October 2020 to February 2021, 200 stakeholders of the WBG in Somalia were invited to provide their opinions on the WBG's work in the country by participating in a Country Opinion Survey. Participants were drawn from the Office of the President, Prime Minister; office of a minister; office of a parliamentarian; ministries/ministerial departments/implementation agencies; project management units (PMUs) overseeing implementation of WBG projects; consultants/contractors working on WBG-supported projects/programs; local governments; independent government institutions; the judicial system; state-owned enterprises; bilateral and multilateral agencies; private sector organizations; the financial sector/private banks; private foundations; NGOs and community based organizations; trade unions; faith-based groups; youth groups; indigenous peoples' groups; academia/research institutes/think tanks; the media; and other organizations.

A total of 164 stakeholders participated in the survey (82% response rate). Respondents completed the questionnaire online via the Qualtrics platform.

Every country that engages in the Country Opinion Survey (COS) must include specific indicator questions that will be aggregated for the World Bank Group's annual Corporate Scorecard. These questions are identified throughout the survey report.

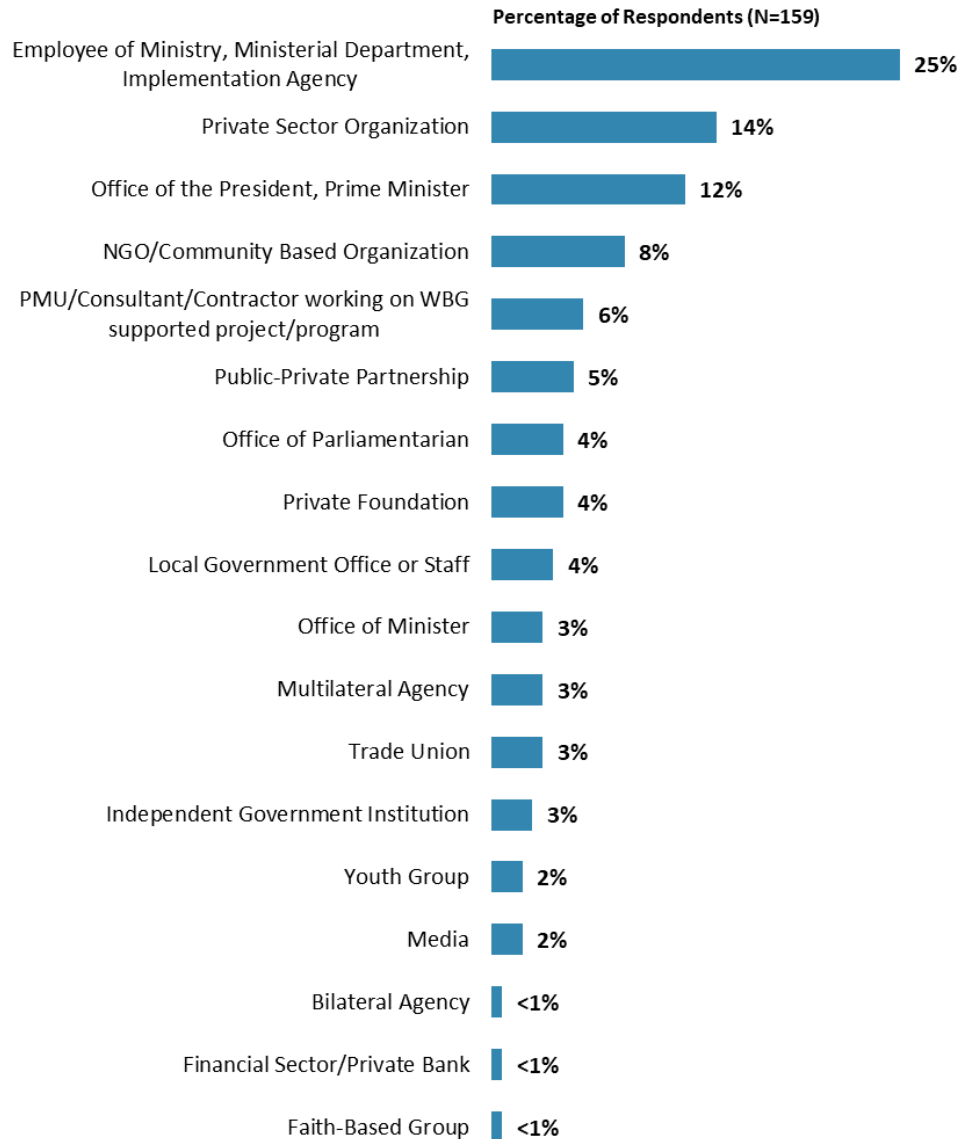

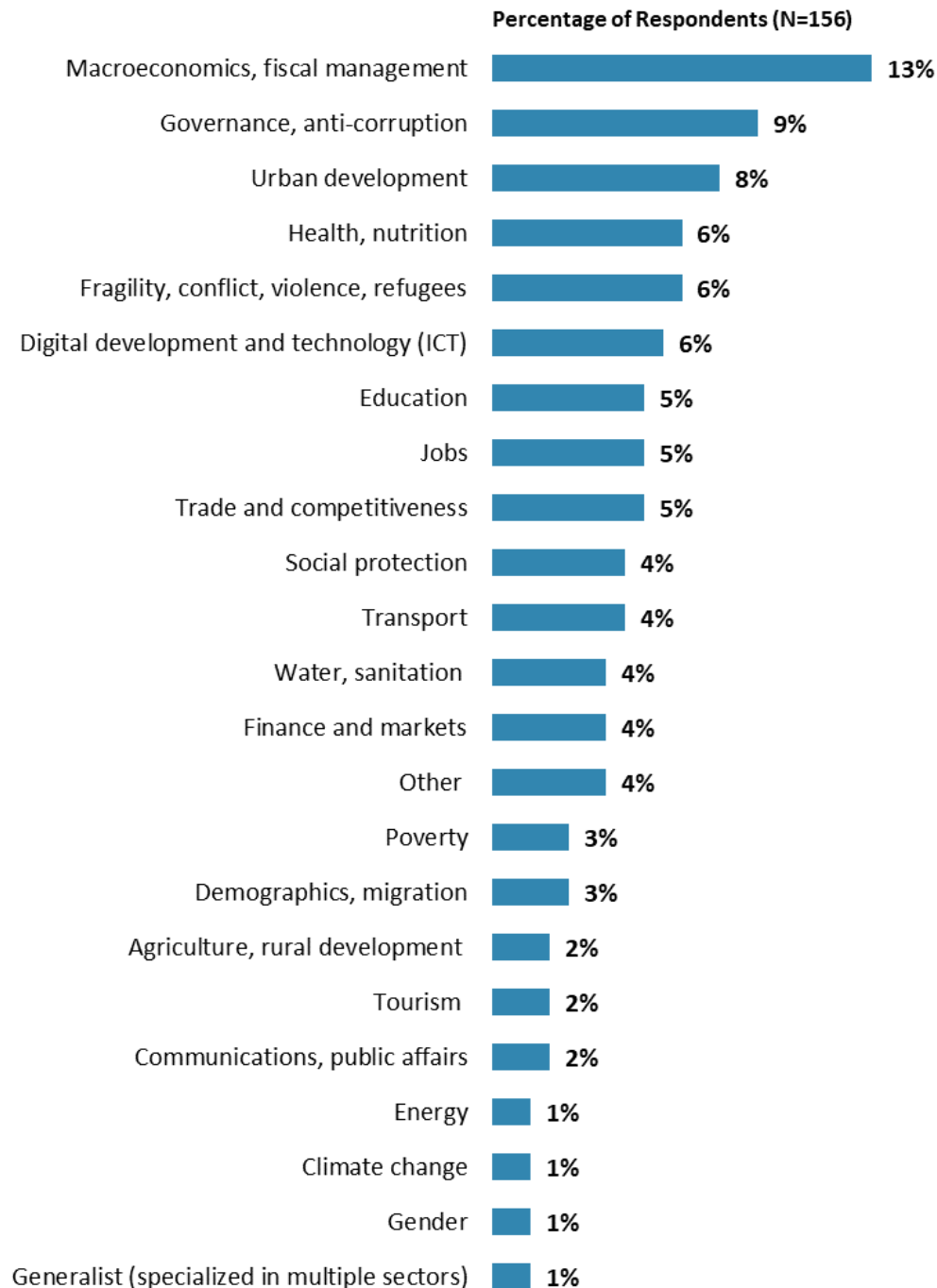
**“Which of the following best describes your current position?”**

<sup>1</sup> Respondents from the office of the President, Prime Minister were combined with respondents from office of a Minister; respondents from PMUs/Consultants/Contractors, the office of a Parliamentarian, local government, and independent government institutions were combined in “Other Government Organizations” category; respondents from public-private partnerships and the financial sector/private banks were combined with respondents from the private sector; and respondents from private foundations, NGO/community based organizations, trade unions, faith-based groups, and youth groups were combined into a “Civil Society” category (CSO). The small number of respondents from bilateral and multilateral agencies were included in the “Other” category. There were no respondents from the judicial system, state-owned enterprises, or academia.

#### Area of Primary Specialization

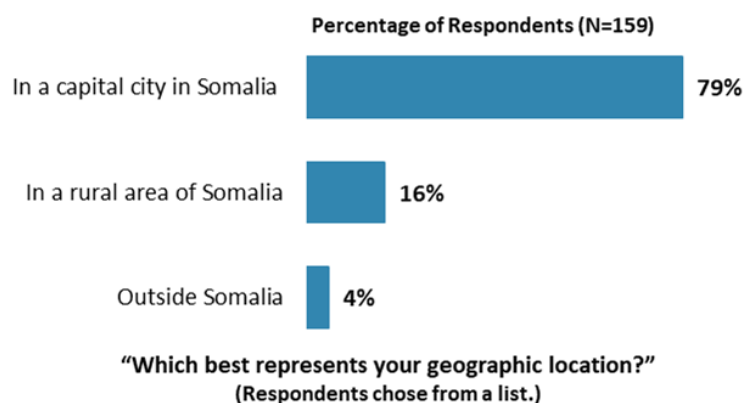

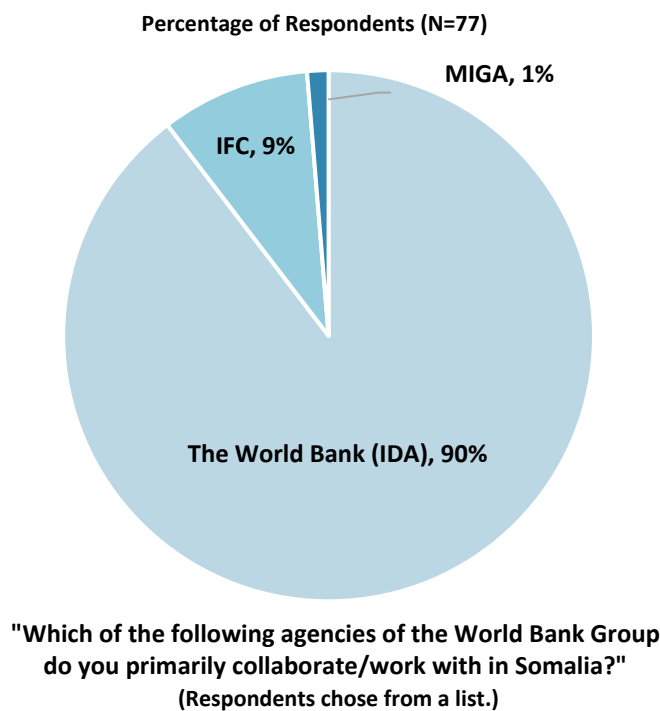

#### Exposure to Agencies within the World Bank Group

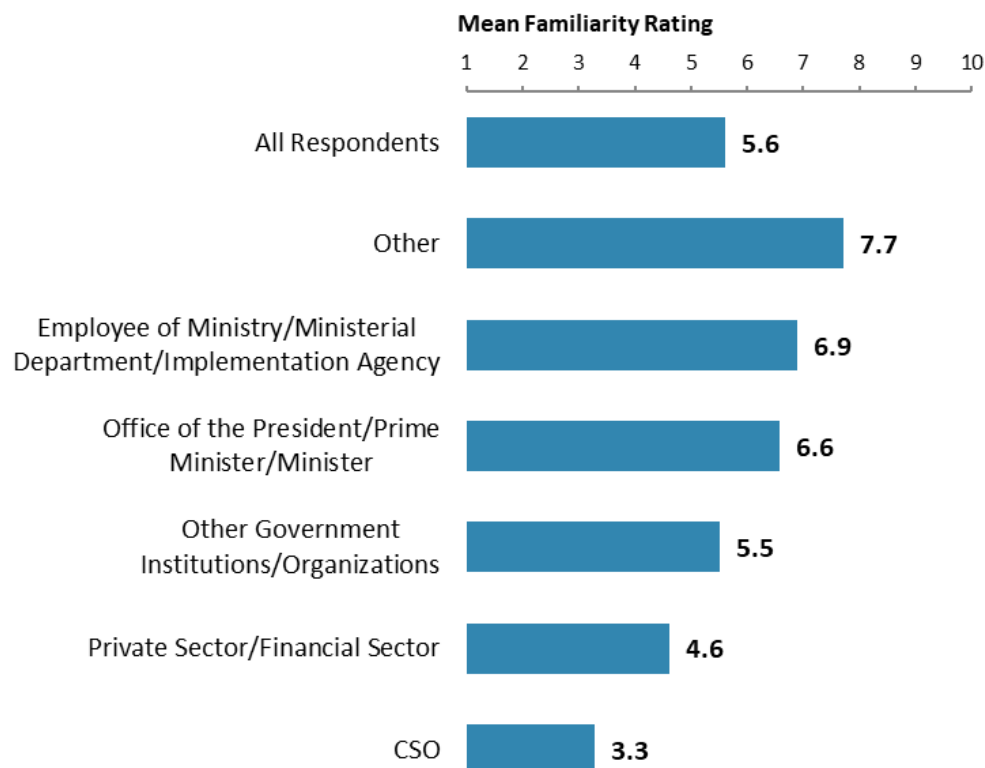




### III. Demographics of the Sample (continued)

#### Familiarity with the World Bank Group

- **Stakeholders:** Respondents from 'other' organizations reported the highest levels of familiarity with the work of the World Bank whereas respondents from CSOs reported significantly lower levels of familiarity.
- **Collaboration:** Respondents who collaborate with the WBG reported significantly higher levels of familiarity with the work of the World Bank (mean familiarity rating of collaborators = 6.5, non-collaborators = 4.9).
- **Impact of familiarity:** Respondents' ratings of familiarity with the WBG were significantly, strongly correlated with their ratings for the WBG's overall effectiveness in Somalia, with their ratings of the extent to which the WBG's work helps to achieve development results, and the extent to which the WBG plays a relevant role in development in Somalia.



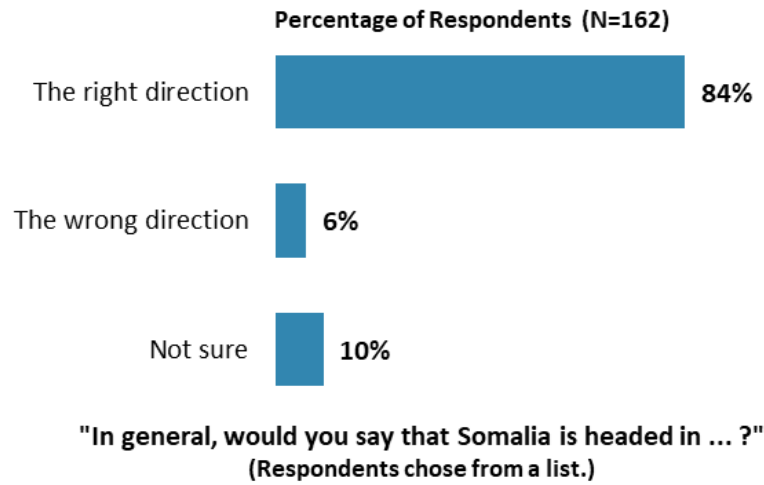
"How familiar are you with the work of the World Bank Group (IDA) in Somalia?"  
(1-"Not familiar at all", 10-"Extremely familiar")



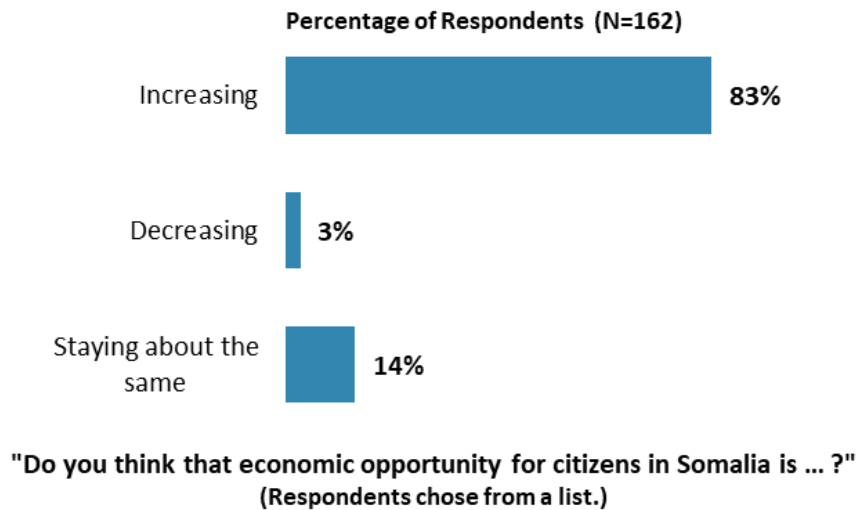

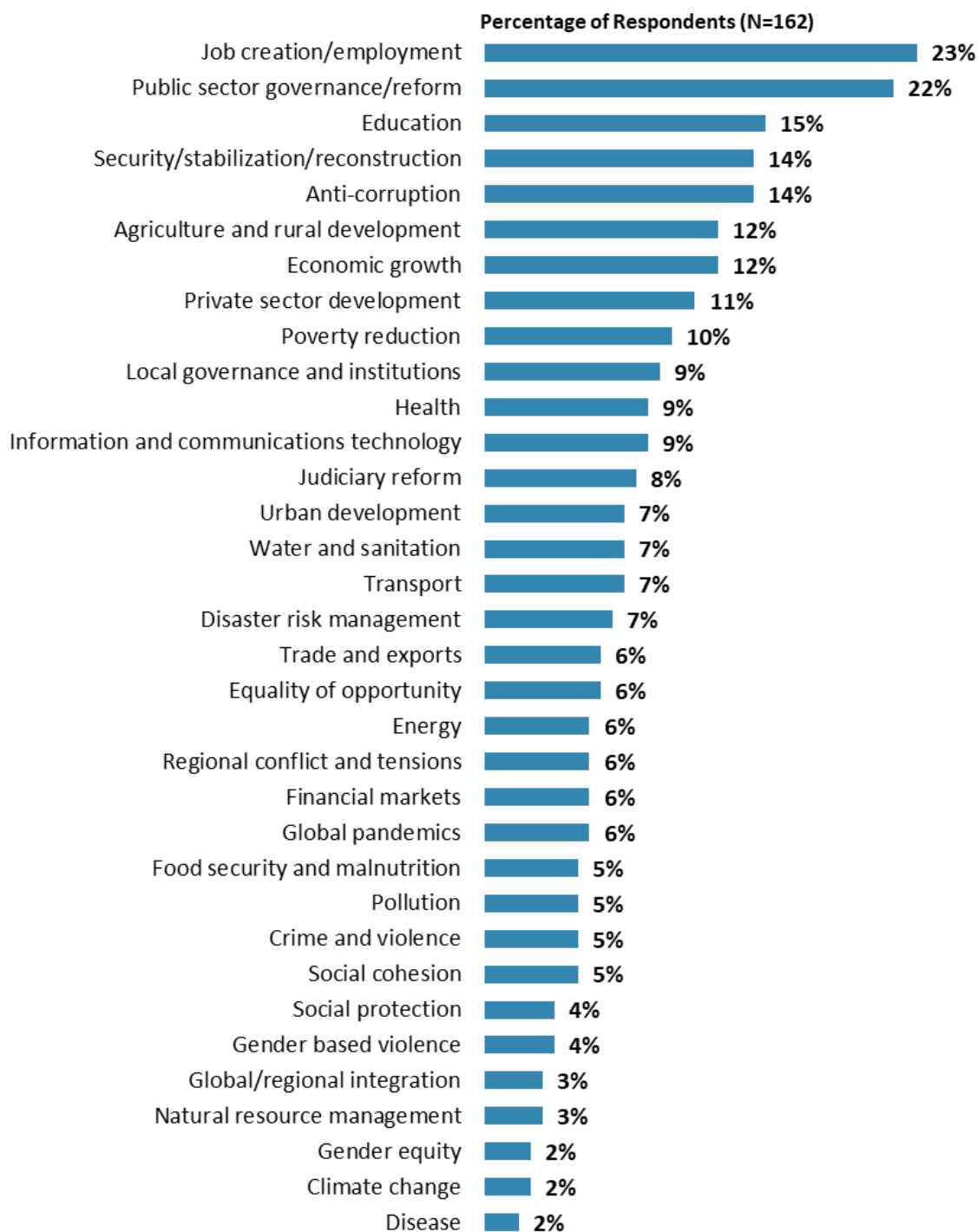

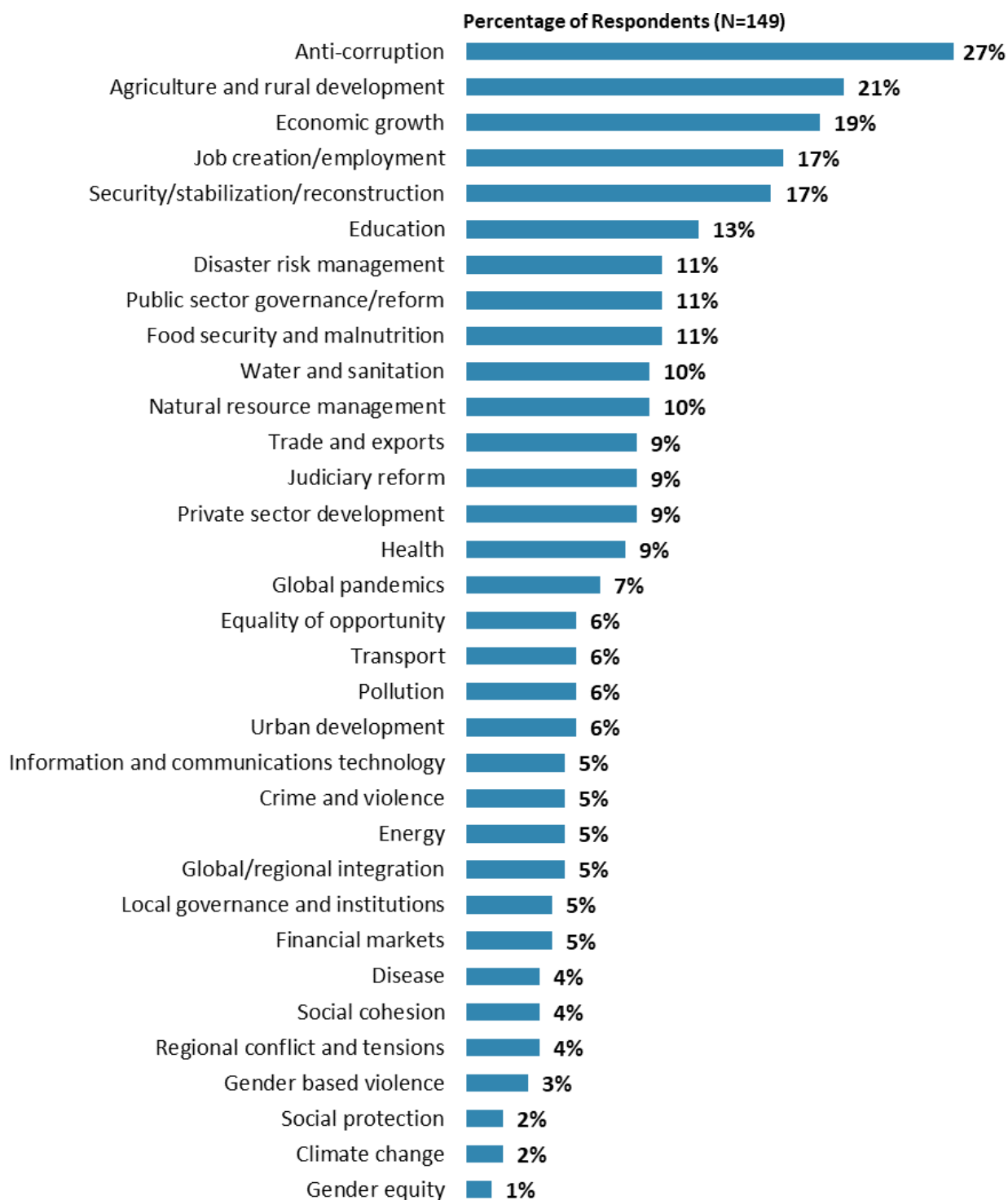

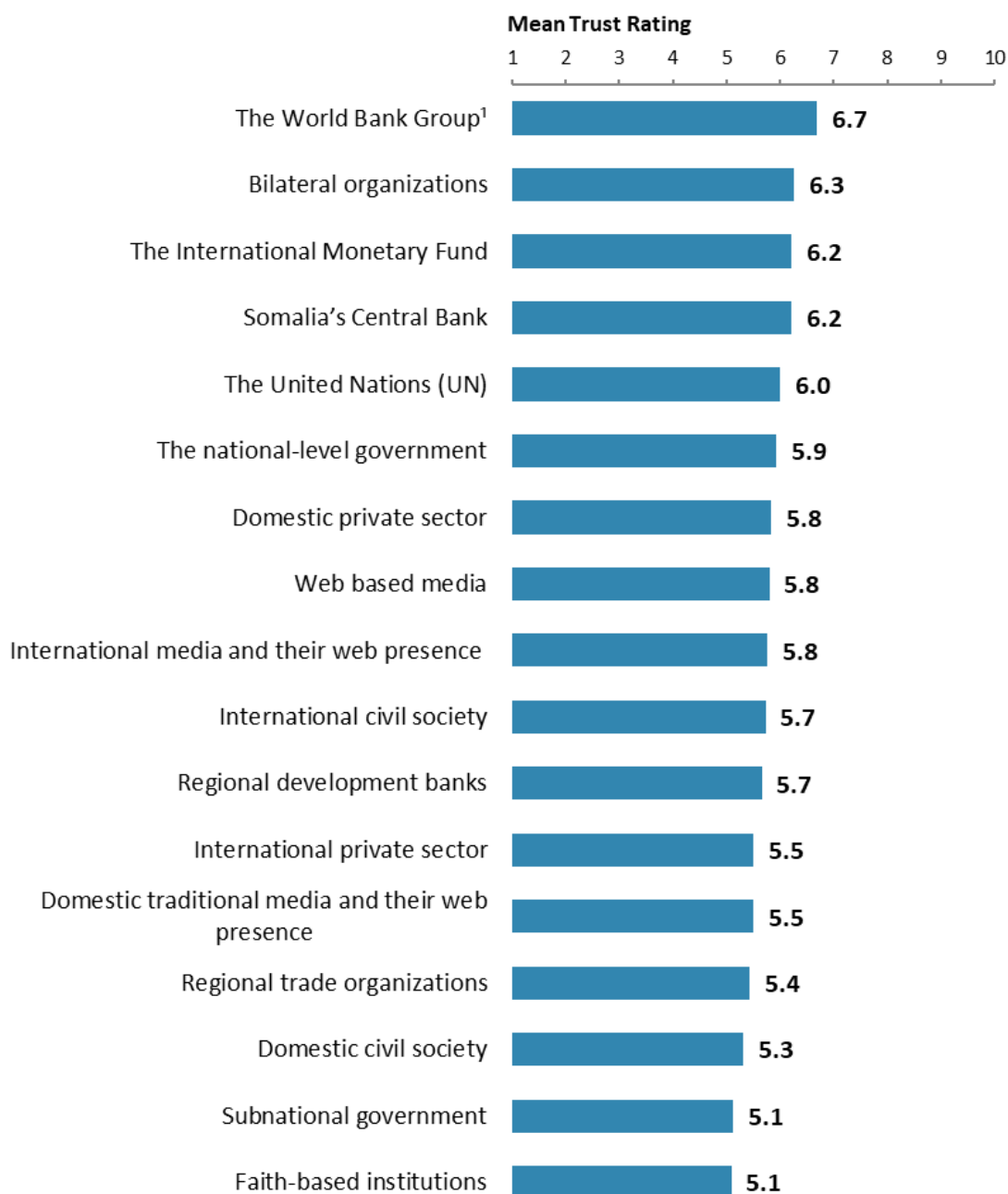

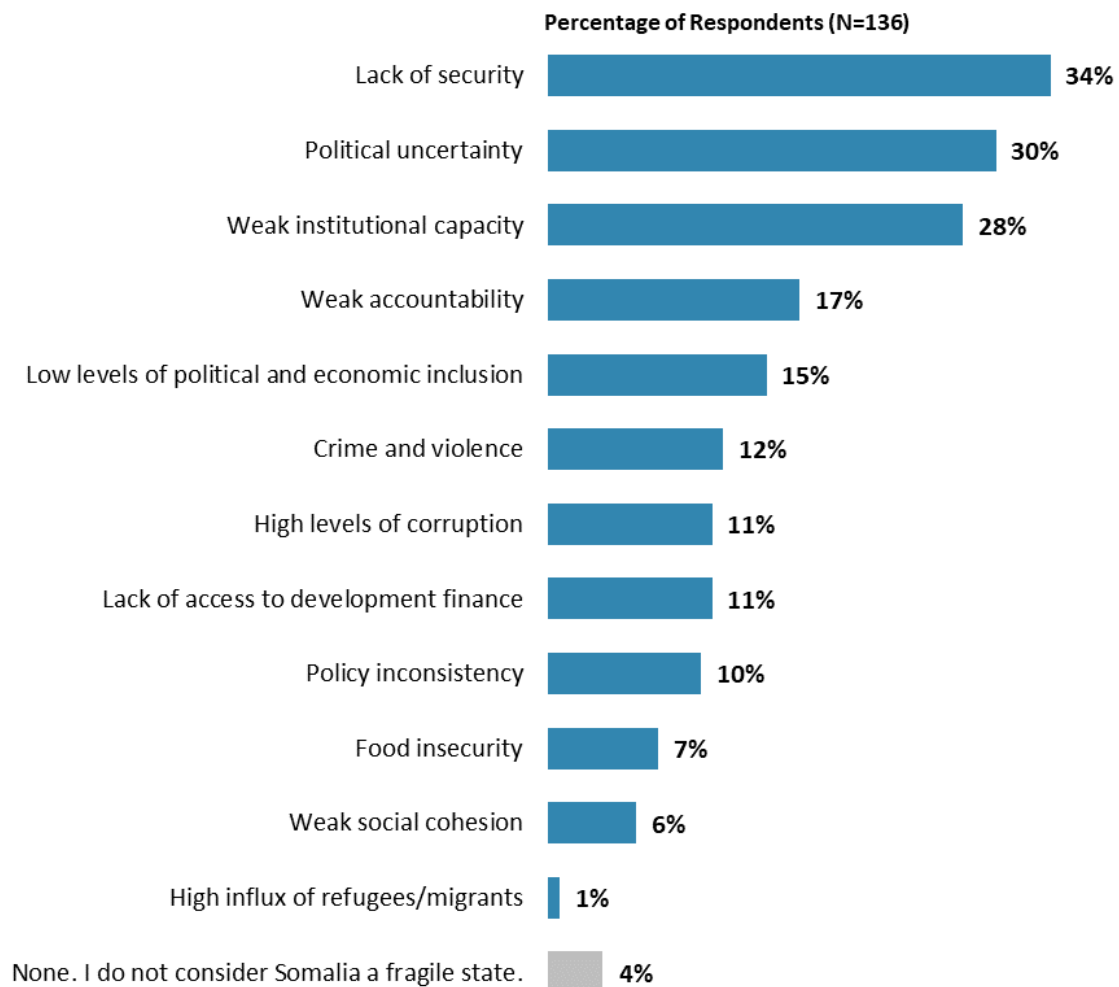

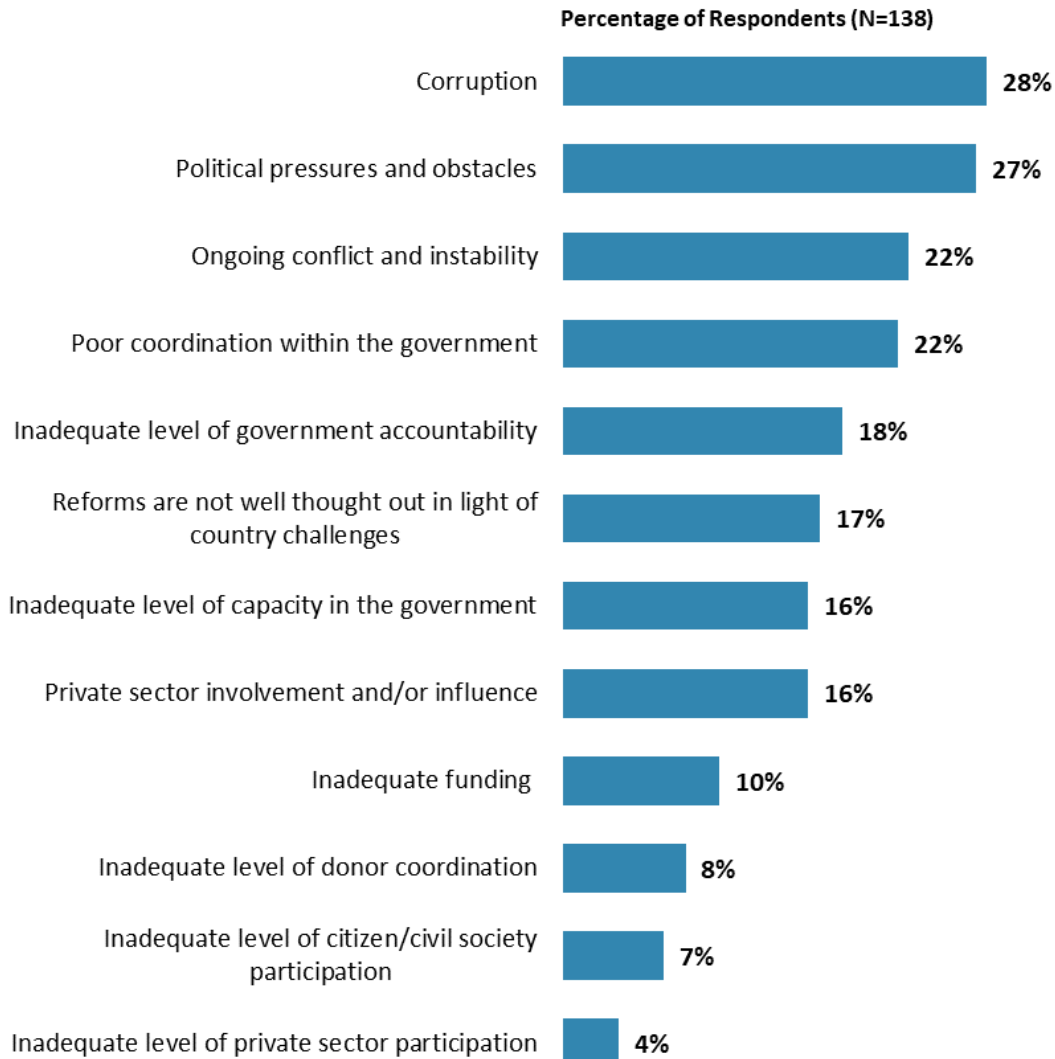


**"When considering the characteristics of a fragile state, please identify which of the following best illustrate fragility in Somalia. (Choose no more than TWO)"**

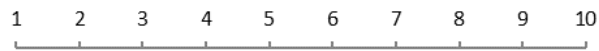

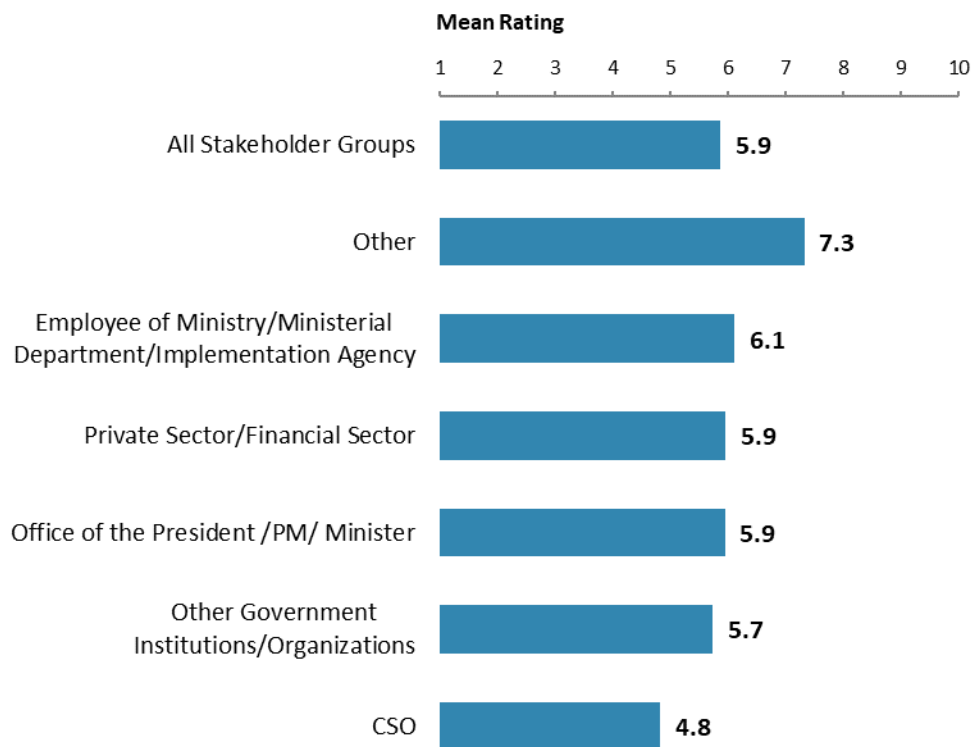




## V. Overall Attitudes toward the World Bank Group (continued)

### Overall Ratings for Indicator Questions by Stakeholder Groups

- **Stakeholders:** Although it did not reach statistical significance, there was a clear pattern in overall stakeholder group responding such that respondents from other organizations had the highest aggregate ratings for the 29 indicator questions and those from CSOs had the lowest.
- **Collaboration:** There was a trend for respondents who collaborate with the WBG to have higher aggregate ratings for the 29 indicator questions whereas respondents who do not collaborate with the WBG to be lower, but it did not reach statistical significance. Ratings for individual indicator questions can be found in Appendix C (page 71).

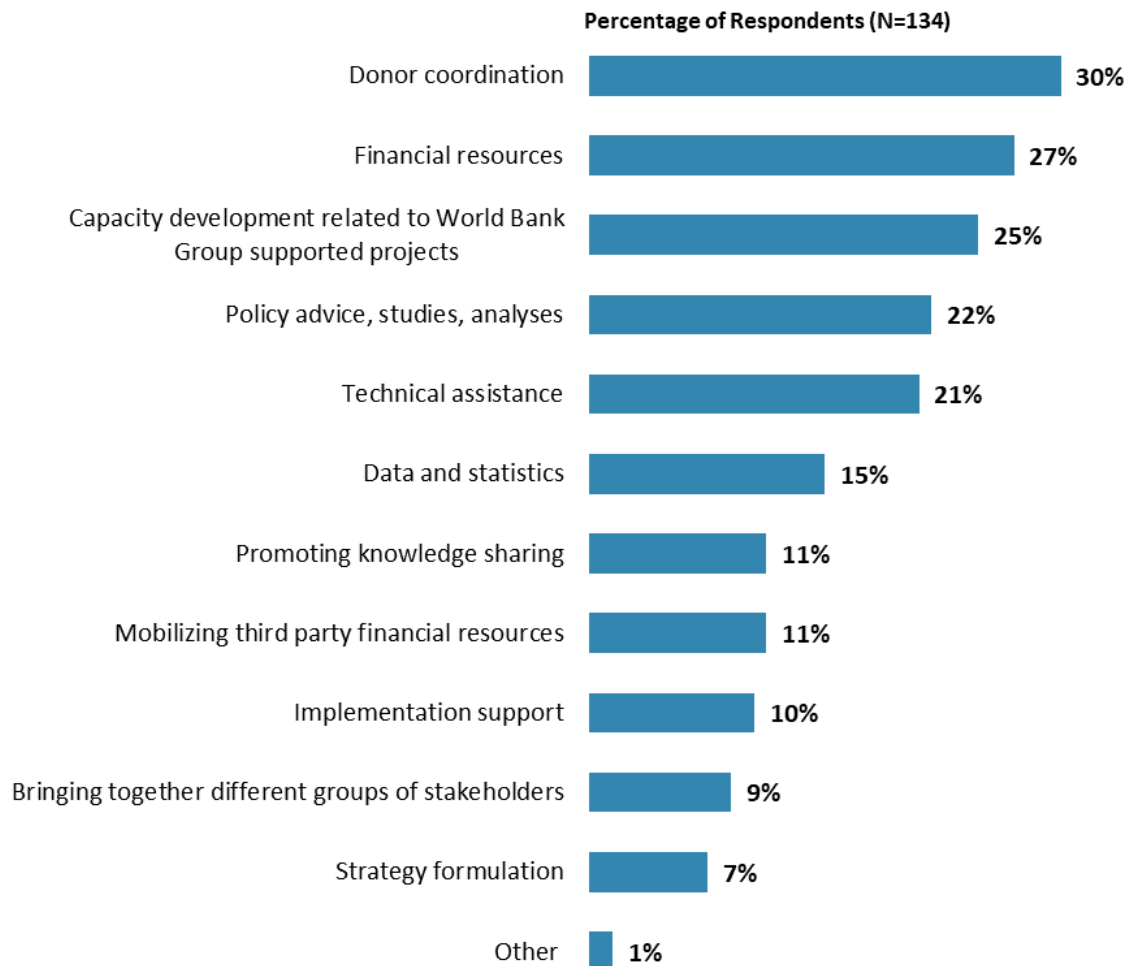


Mean Ratings for All Indicator Questions by Stakeholder Groups on a Scale from 1 to 10

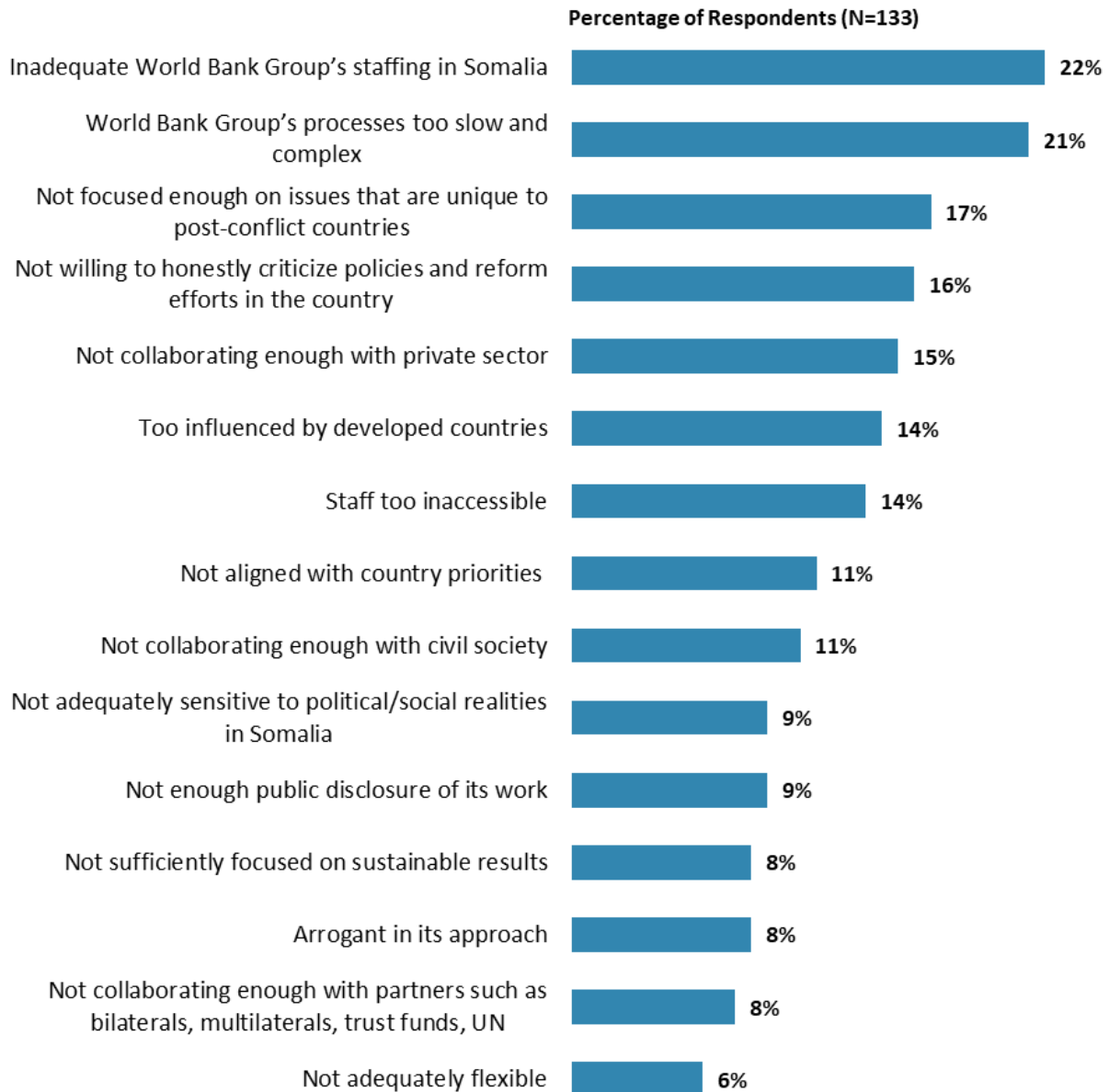


**“When thinking about the World Bank Group’s role in Somalia, which activity do you VALUE the most?

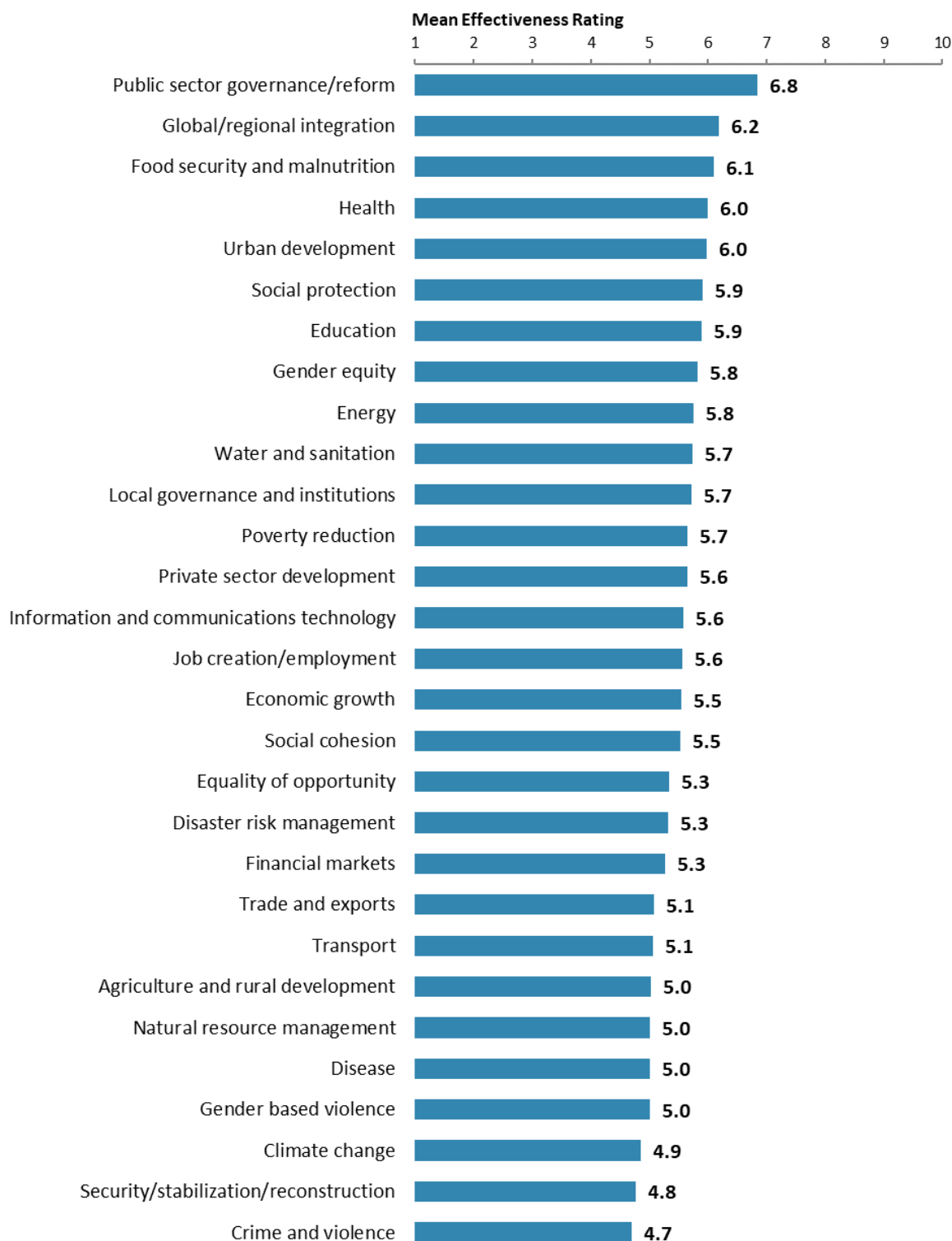

### Effectiveness of WBG's Support in Sectoral Areas

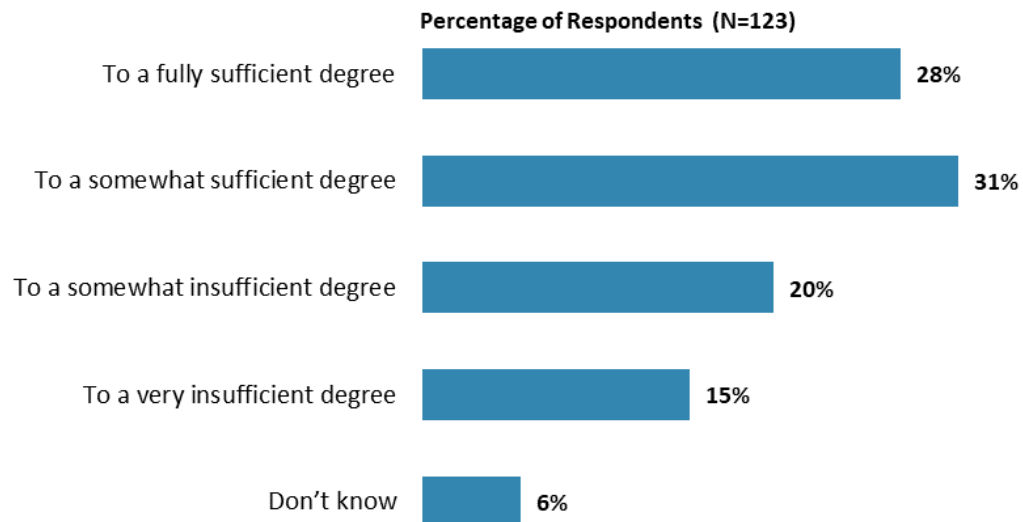

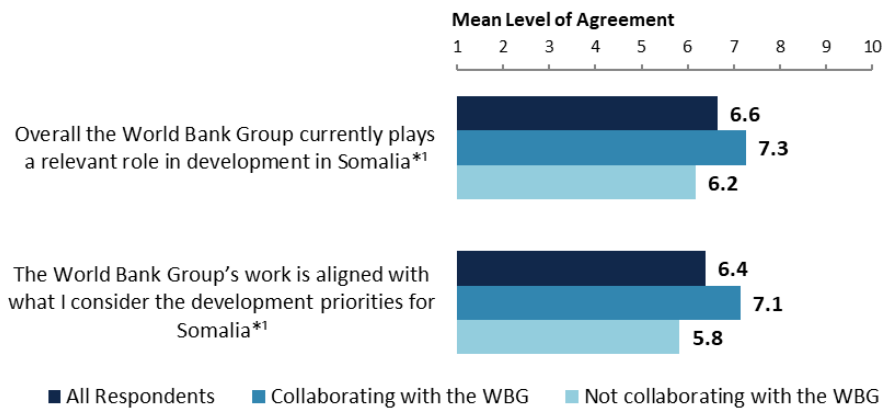


**"To what extent do you believe that the World Bank Group's work and support help the poorest in Somalia?" (Respondents chose from a list.)**

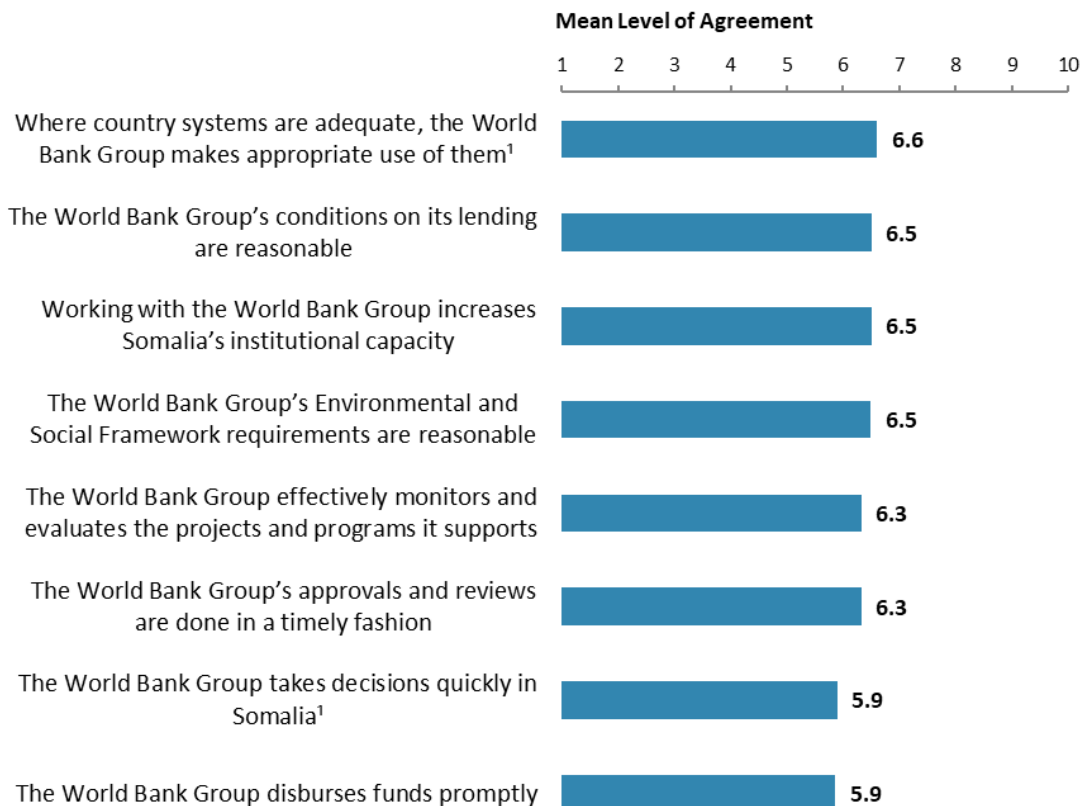
### The World Bank Group's Work in Somalia: Collaboration

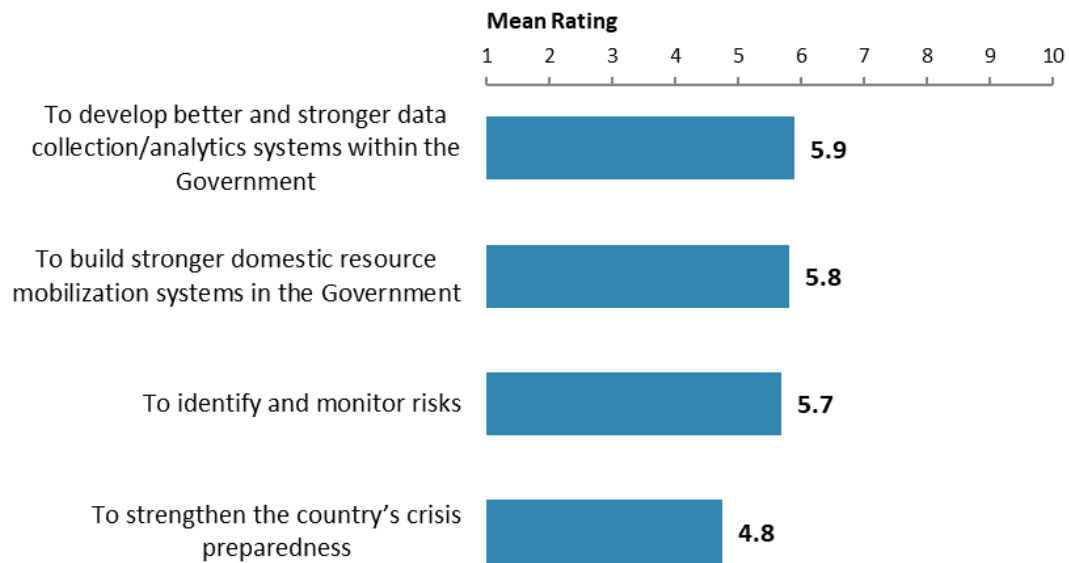

### Effectiveness of WBG's Support



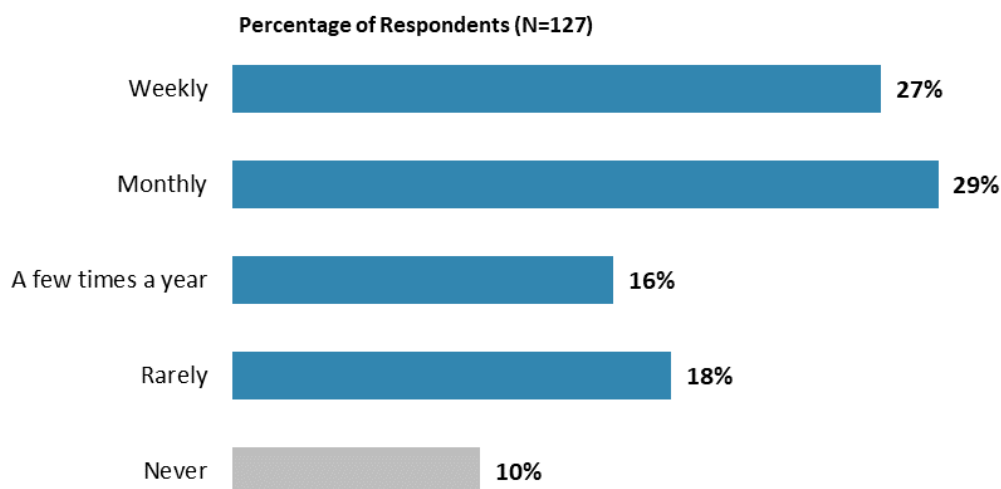
**"How effectively does the World Bank Group support Somalia's efforts ... ?"**

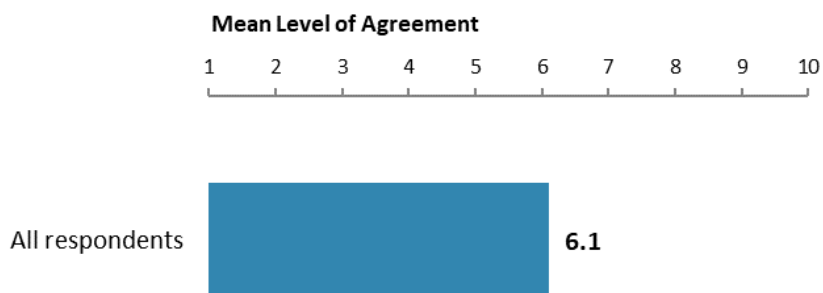

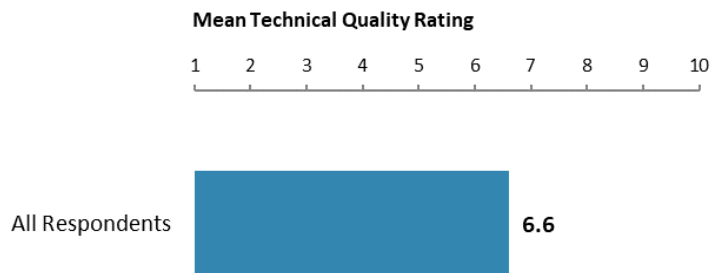

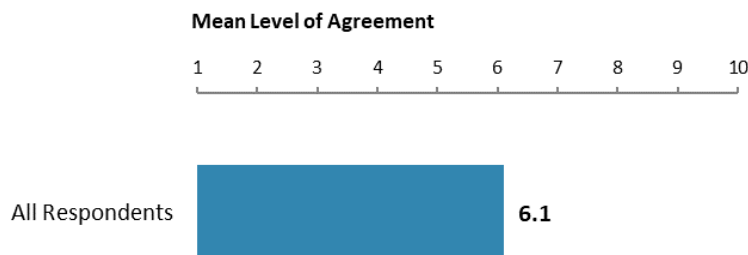
"Overall, how significant a contribution do you believe the World Bank Group's knowledge work and activities make to development results in your country?"

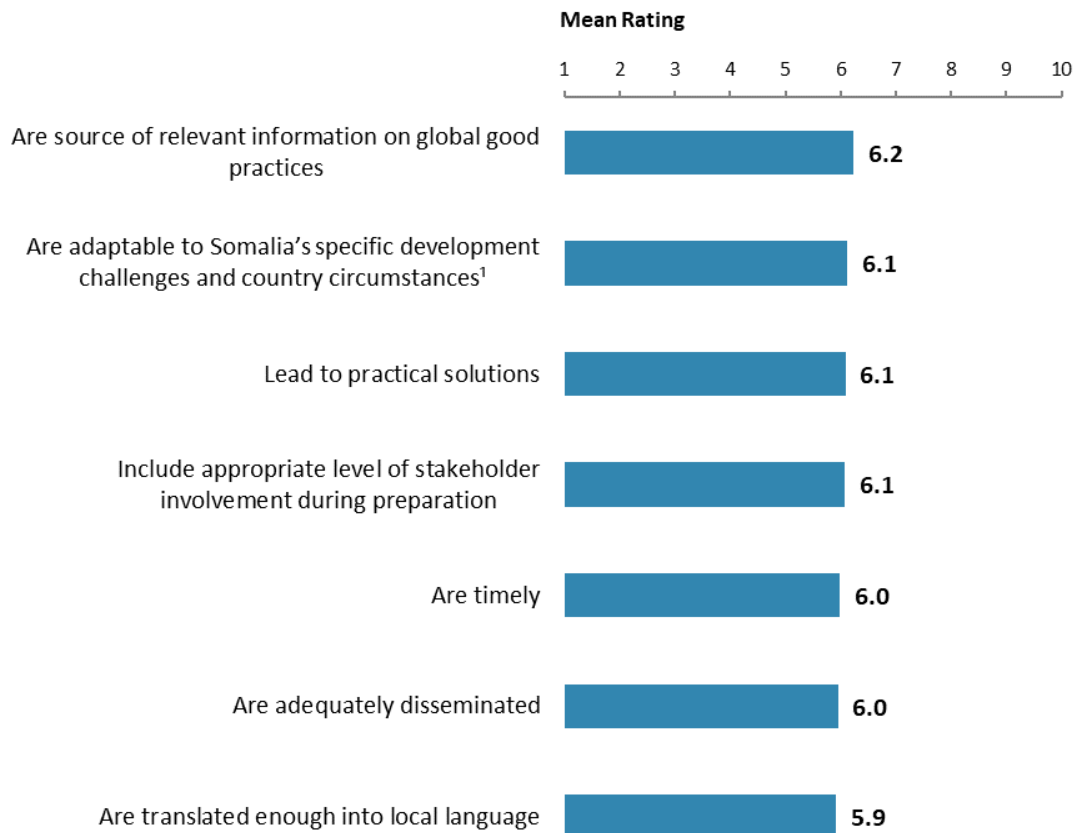

### Qualities of the WBG's Knowledge Work and Activities



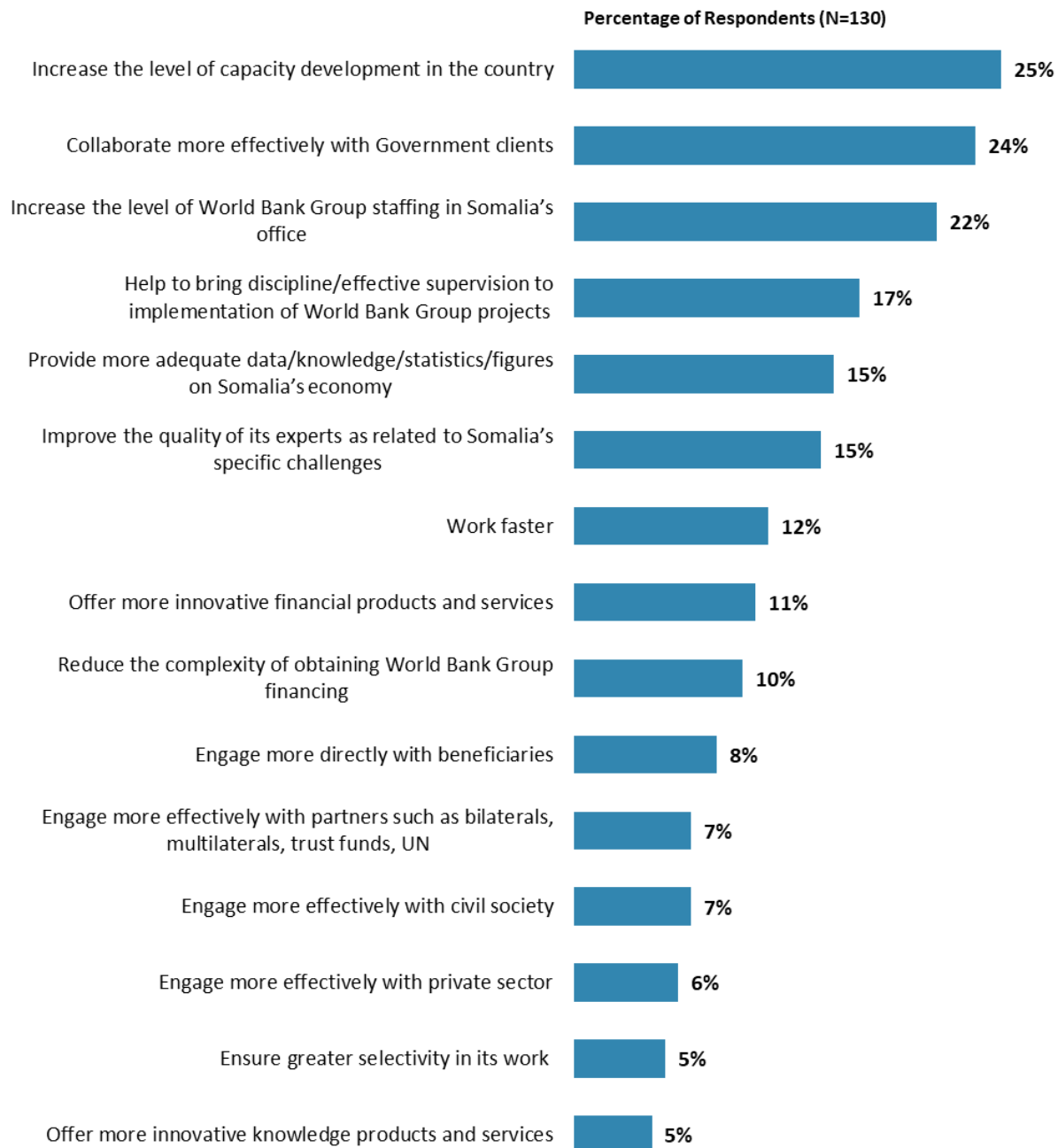

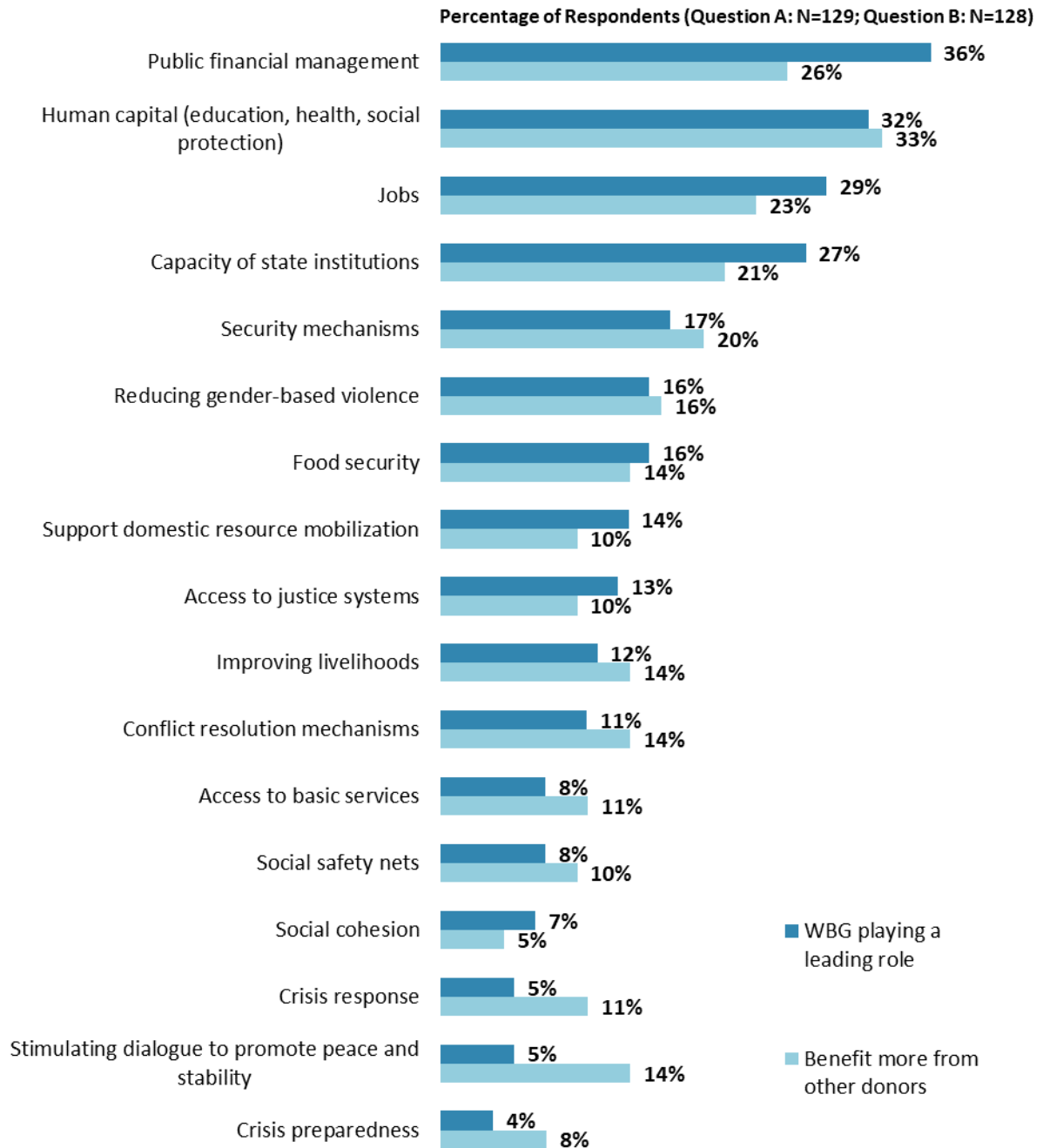


**"Which of the following SHOULD the World Bank Group do to make itself of greater value in Somalia?

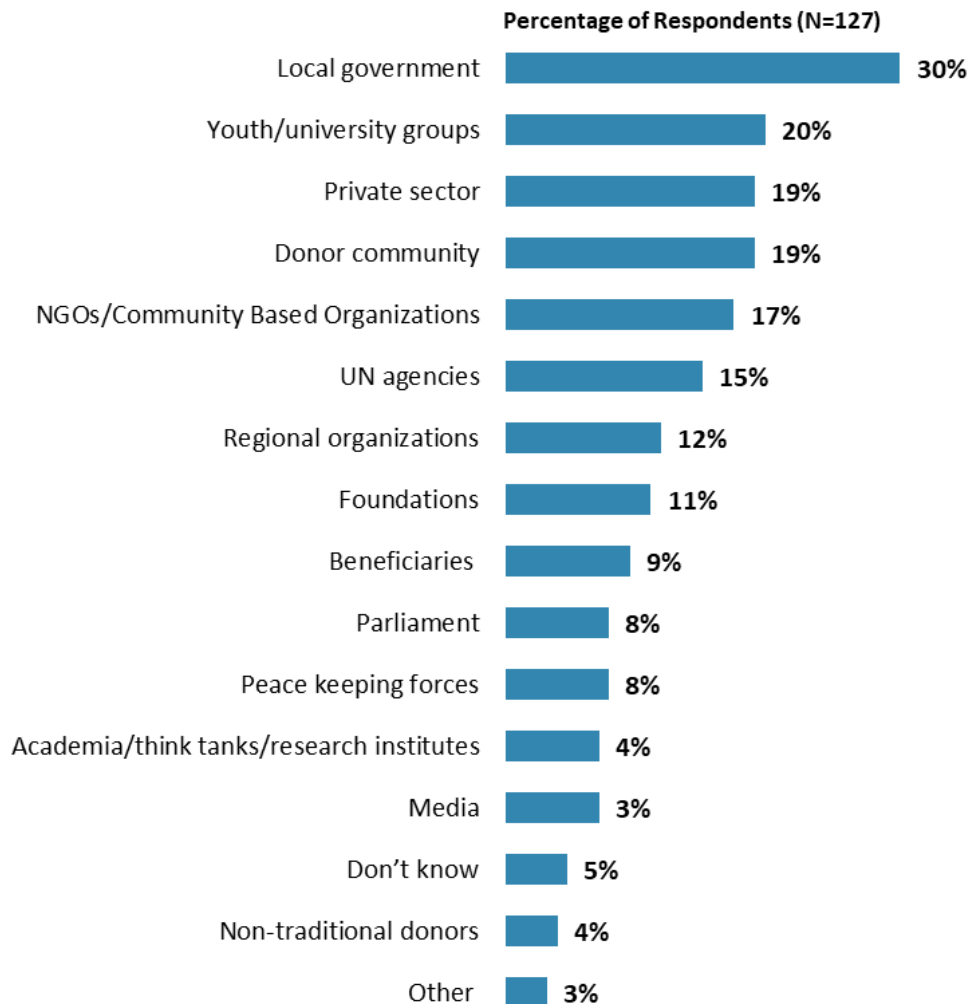

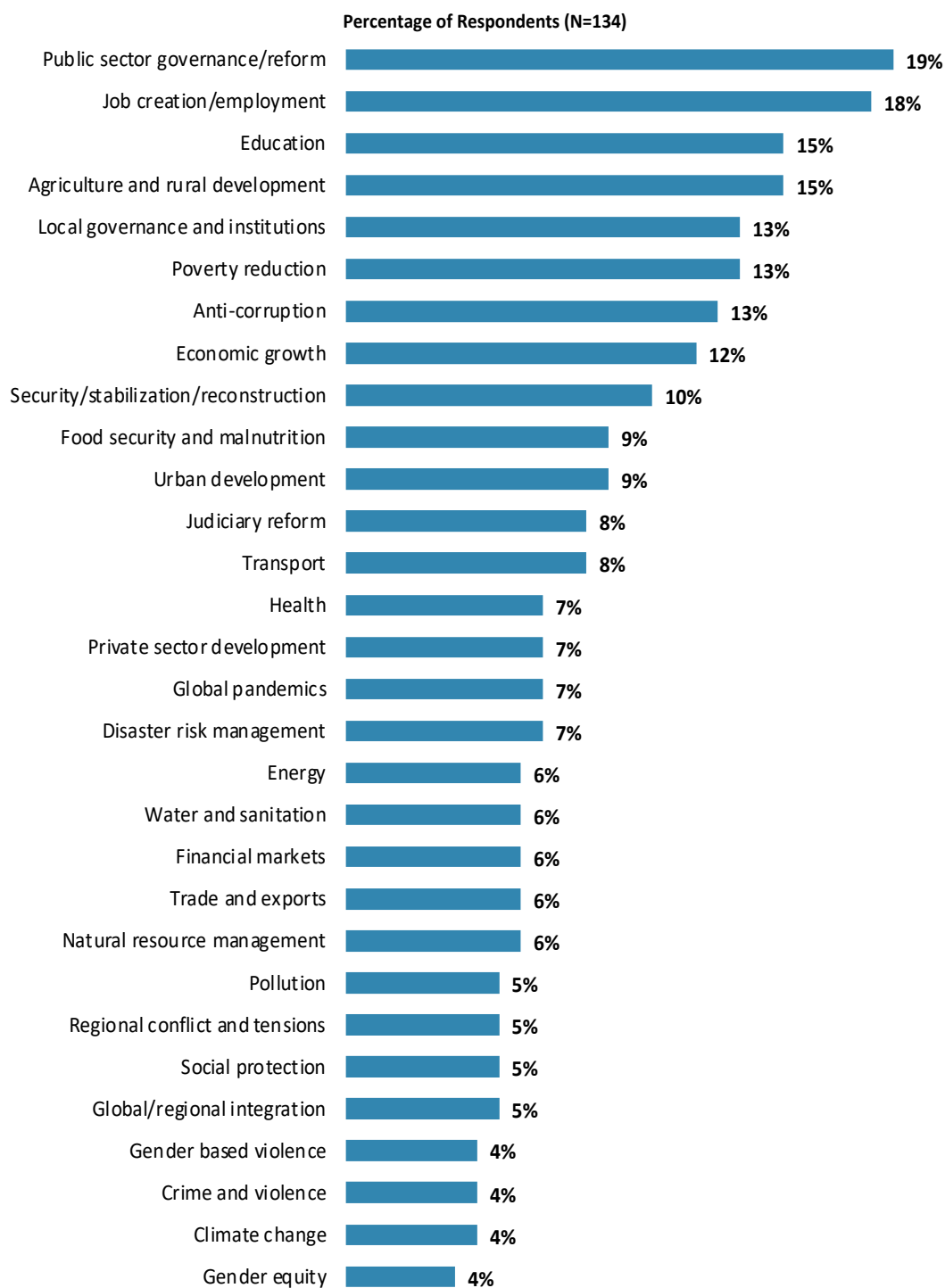

### Where the World Bank Group Should Focus its Resources



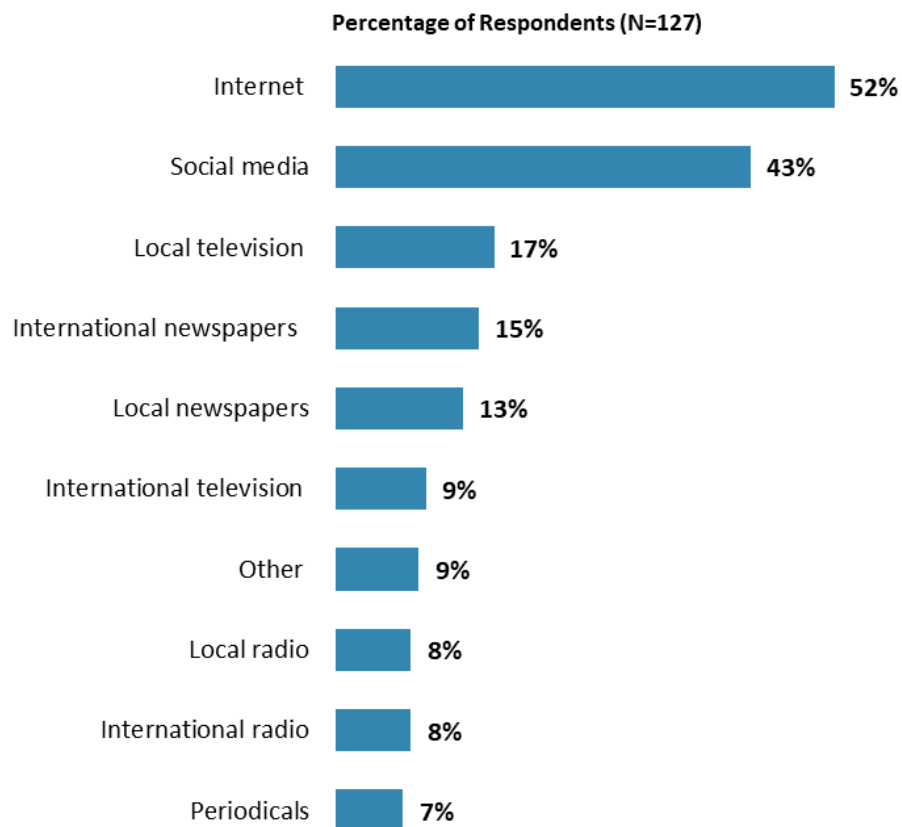

**"How do you get most of your information about economic and social development issues in Somalia? (Choose no more than TWO)" (Respondents chose from a list. Responses combined.)**

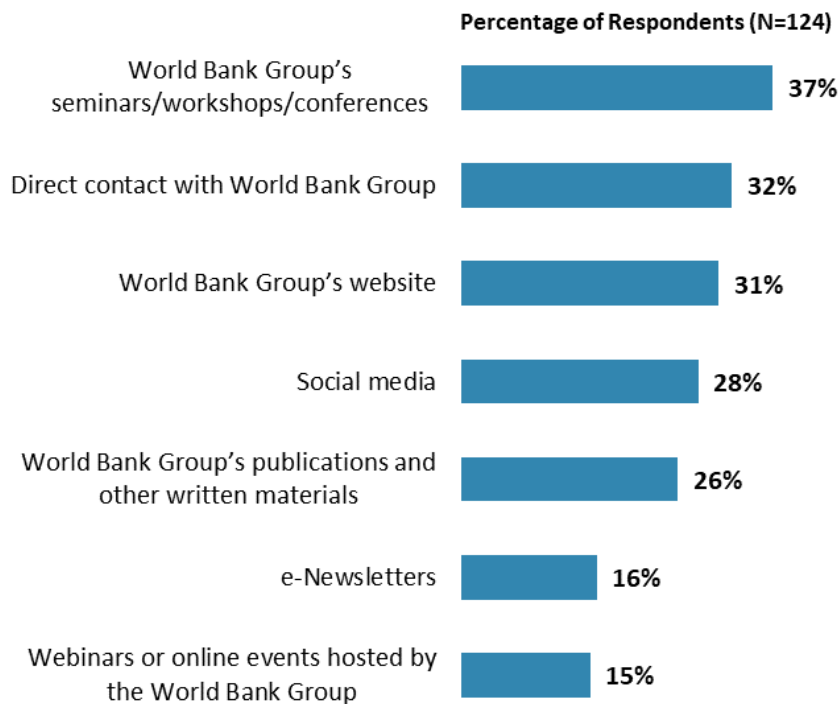

### Preferred Information Sources

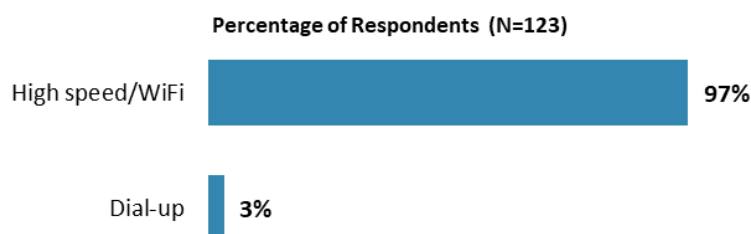


**"How would you prefer to receive information from the World Bank Group?  
(Choose no more than TWO)" (Respondents chose from a list. Responses combined.)**



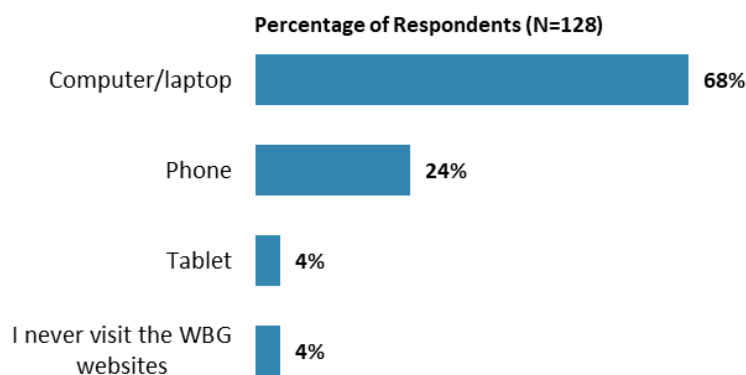

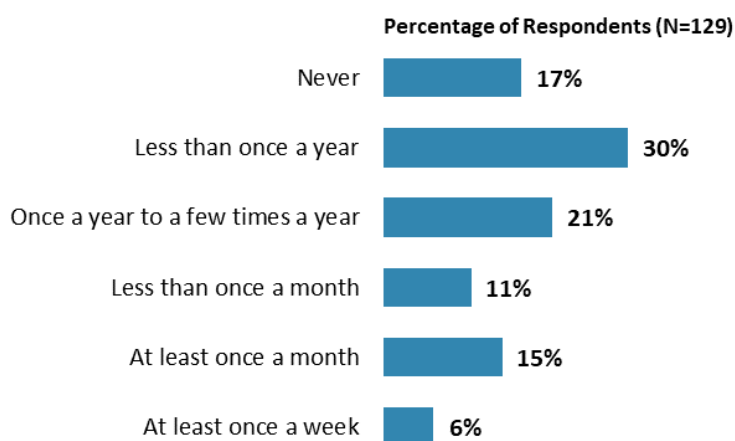
"Which Internet connection do you use primarily when visiting a World Bank Group website?" (Respondents chose from a list.)
