## I. Objectives

This survey was designed to assist the World Bank Group (WBG) in gaining a better understanding of how stakeholders in Sierra Leone perceive the WBG. The survey explored:

- *Overall Context*
- *Overall Attitudes toward the World Bank Group*
- *World Bank Group's Work and Engagement on the Ground*
- *World Bank Group's Support in Development Areas*
- *World Bank Group's Knowledge Work and Activities*
- *The Future Role of the World Bank Group in Sierra Leone*
- *Communication and Information Sharing*
- *Background Information*

## II. Methodology

From March to April 2022, 381 stakeholders of the WBG in Sierra Leone were invited to provide their opinions on the WBG's work in the country by participating in a Country Opinion Survey. Participants were drawn from the Office of the President, Chief Minister; office of a minister; office of a member of the parliament/legislative body; employees of ministries/ministerial departments/implementation agencies; Project Management Units (PMUs) overseeing implementation of WBG projects; consultants/contractors working on WBG-supported projects/programs; local governments; independent government institutions; the judicial system; state-owned enterprises; bilateral and multilateral agencies; private sector organizations; the financial sector/private banks; private foundations; NGOs and community based organizations; professional/trade associations; faith-based groups; youth groups; academia/research institutes/think tanks; the media; and other organizations.

A total of 348 stakeholders participated in the survey (91% response rate). Respondents completed the questionnaire with a representative from the local fielding agency, or they received it via courier and returned accordingly.

Every country that engages in the Country Opinion Survey (COS) must include specific indicator questions that will be aggregated for the World Bank Group's annual Corporate Scorecard. These questions are identified throughout the survey report.

Note that the body of the report presents data on selected questions of the survey questionnaire. Please refer to Appendix A for data on all survey questions. Appendices B and C present data on selected questions. Additional data breakdowns are available upon request.



## II. Methodology (continued)

The results in this year's Country Survey were compared to those in the Country Survey conducted in FY'19 (response rate was 79%, N=396). Comparing responses across Country Surveys reflect changes in attitudes over time, but also changes in respondent samples and changes to the survey instrument itself. To reduce the influence of the latter factor, only those questions with similar response scales/options were analyzed. To reduce the influence of the former, the samples from FY'19 and FY'22 were weighted to have equivalent stakeholder groupings, allowing for more statistically reliable comparisons. Due to this weighting, mean ratings, percentages of respondents, and the total number of respondents in both years are slightly different from those of the original data reported in the FY'19 COS report and the non-weighted data presented in this report.

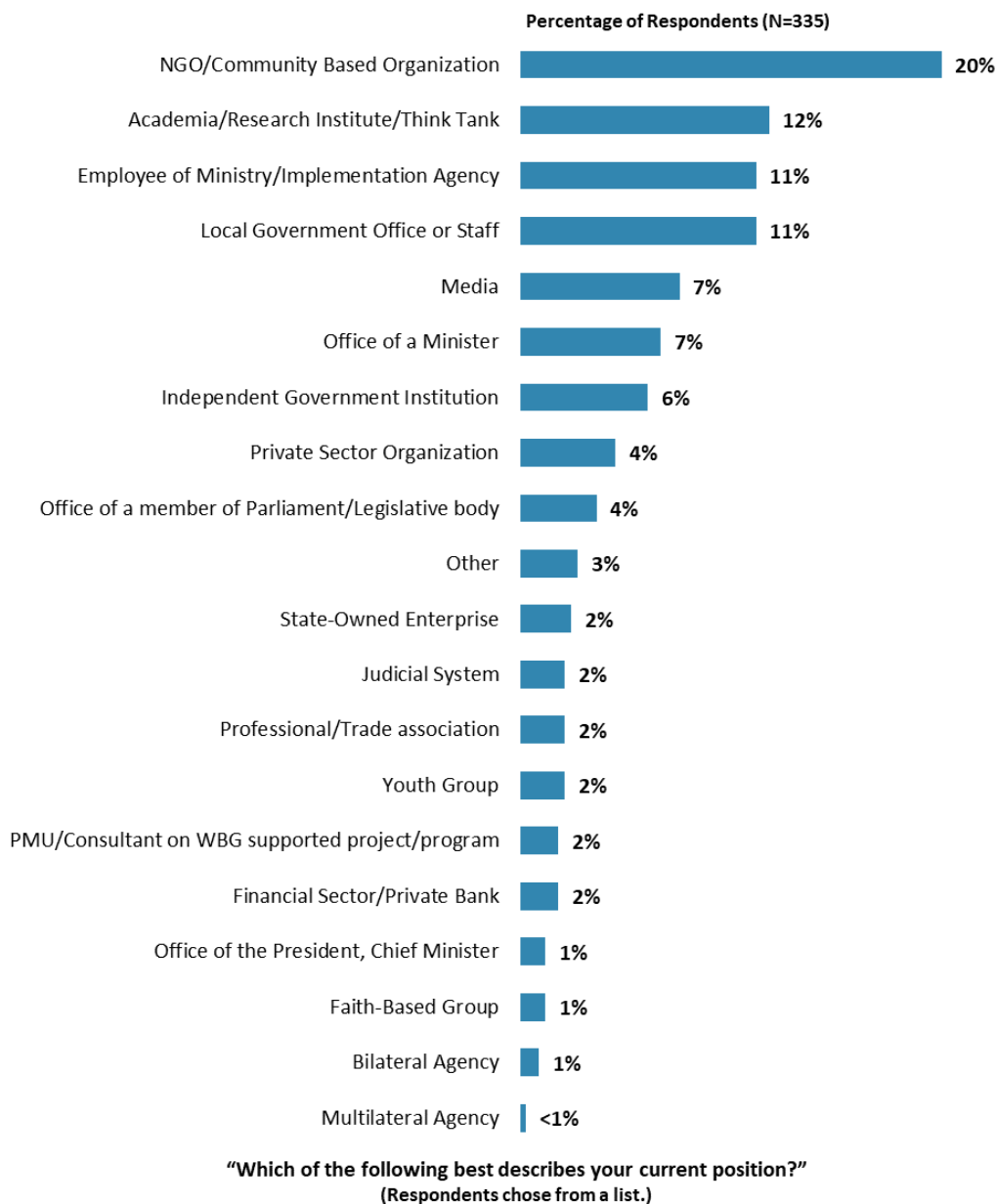

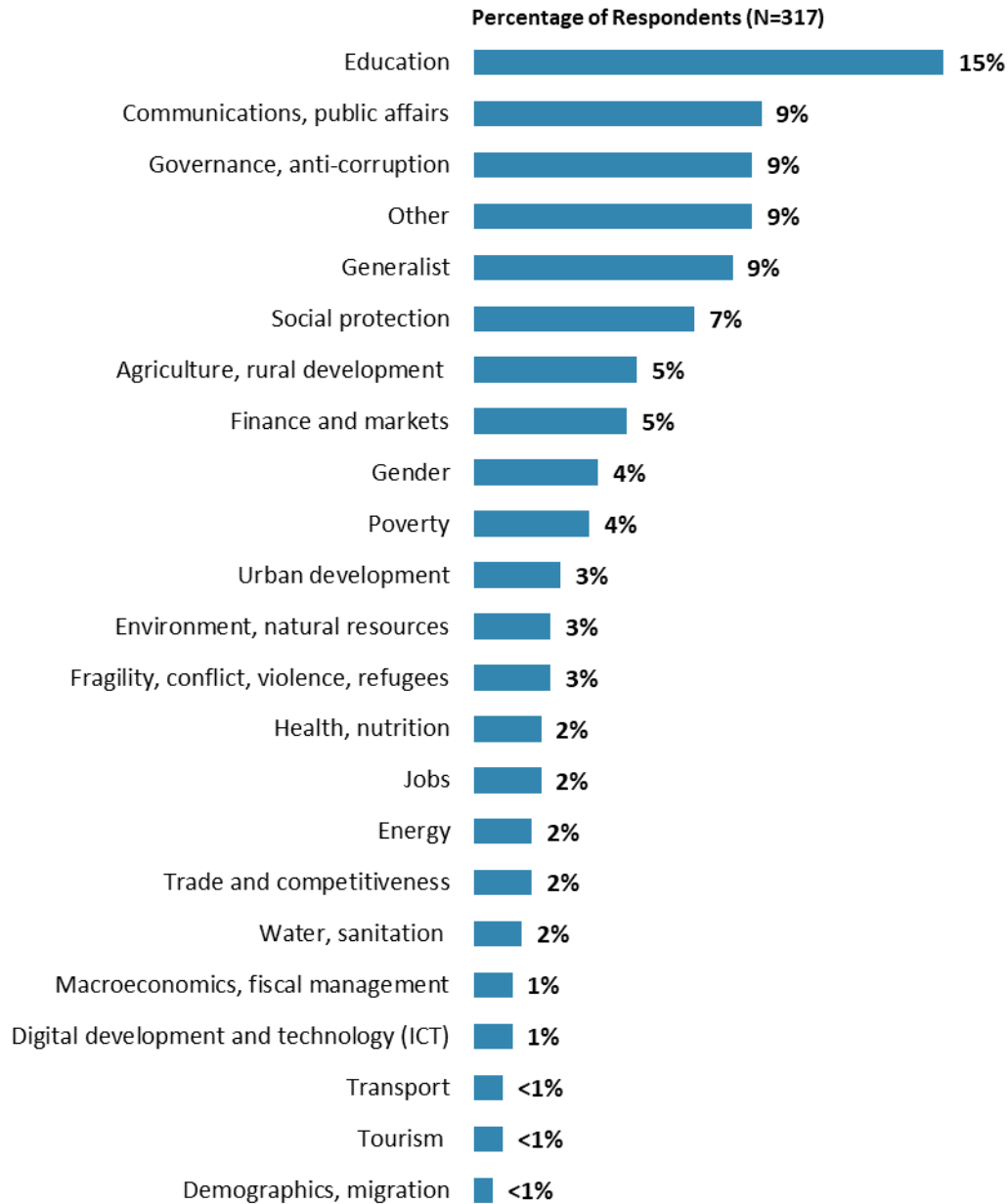

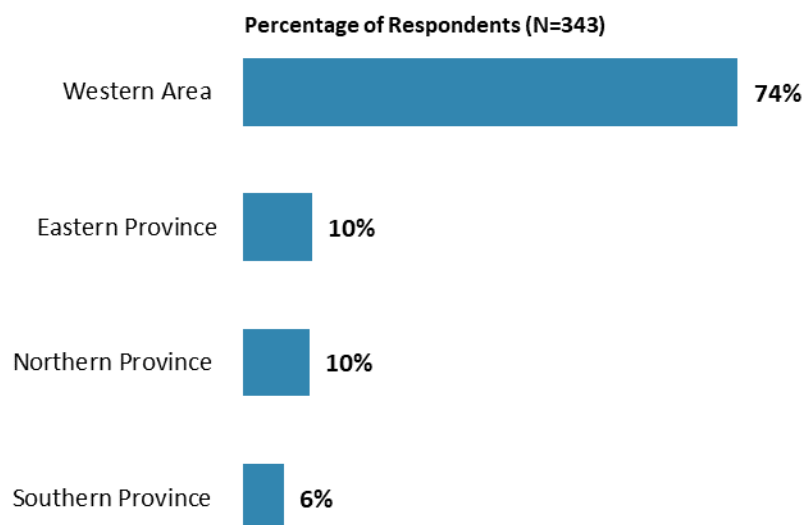

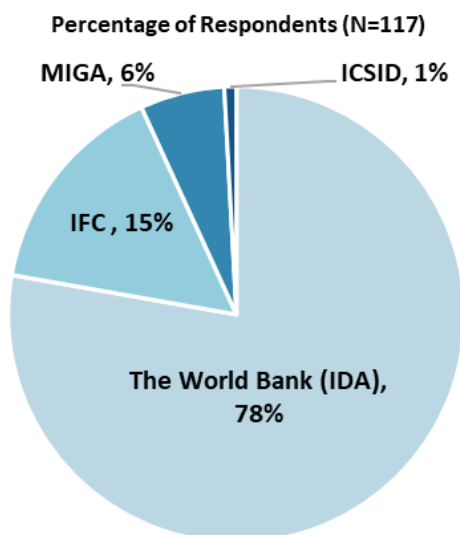

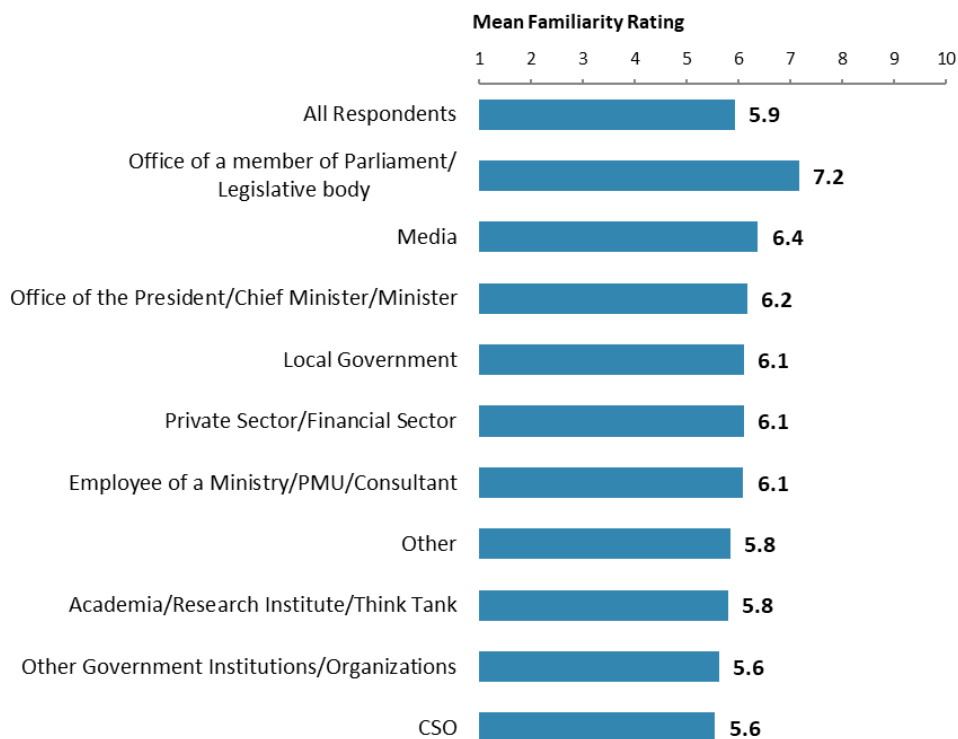




### III. Demographics of the Sample (continued)

#### Familiarity with the World Bank Group

- **Year comparison:** Respondents in this year's Country Survey had statistically similar levels of familiarity with the WBG compared to respondents in the FY'19 Country Survey (weighted mean in FY' 22 = 6.0; weighted mean in FY' 19 = 5.8)<sup>2</sup>.
- **Collaboration:** Respondents who collaborate with the WBG also reported significantly higher levels of familiarity with the work of the World Bank compared to respondents who do not collaborate (mean familiarity of collaborators = 6.7; mean familiarity of non-collaborators = 5.5).
- **Impact of familiarity:** Respondents' ratings of familiarity<sup>3</sup> with the World Bank were significantly, strongly correlated with their ratings for the World Bank's overall effectiveness<sup>4</sup> in Sierra Leone and significantly, moderately correlated with their ratings of the extent to which the WBG's work helps to achieve development results in Sierra Leone and with their agreement that the WBG plays a relevant role in Sierra Leone's development.

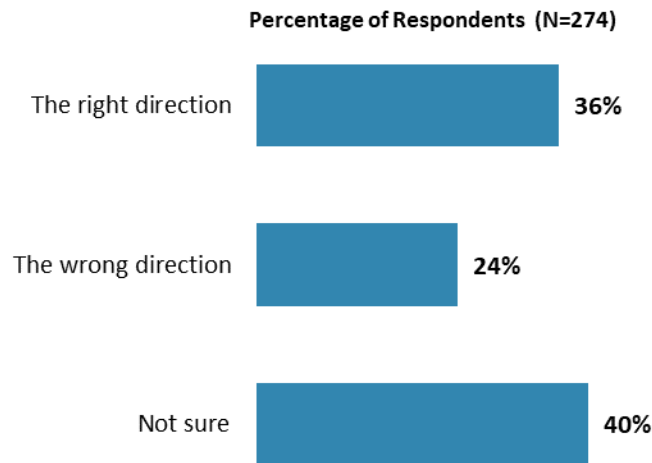

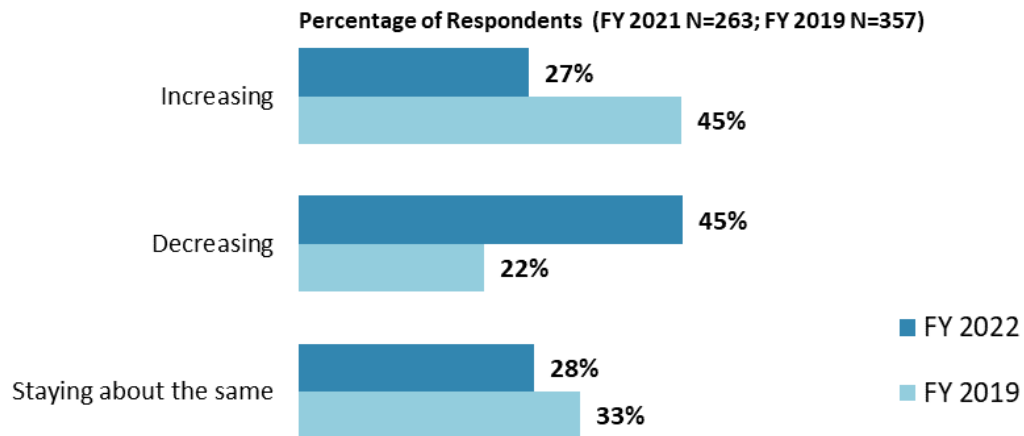

### Perceptions of Economic Opportunity



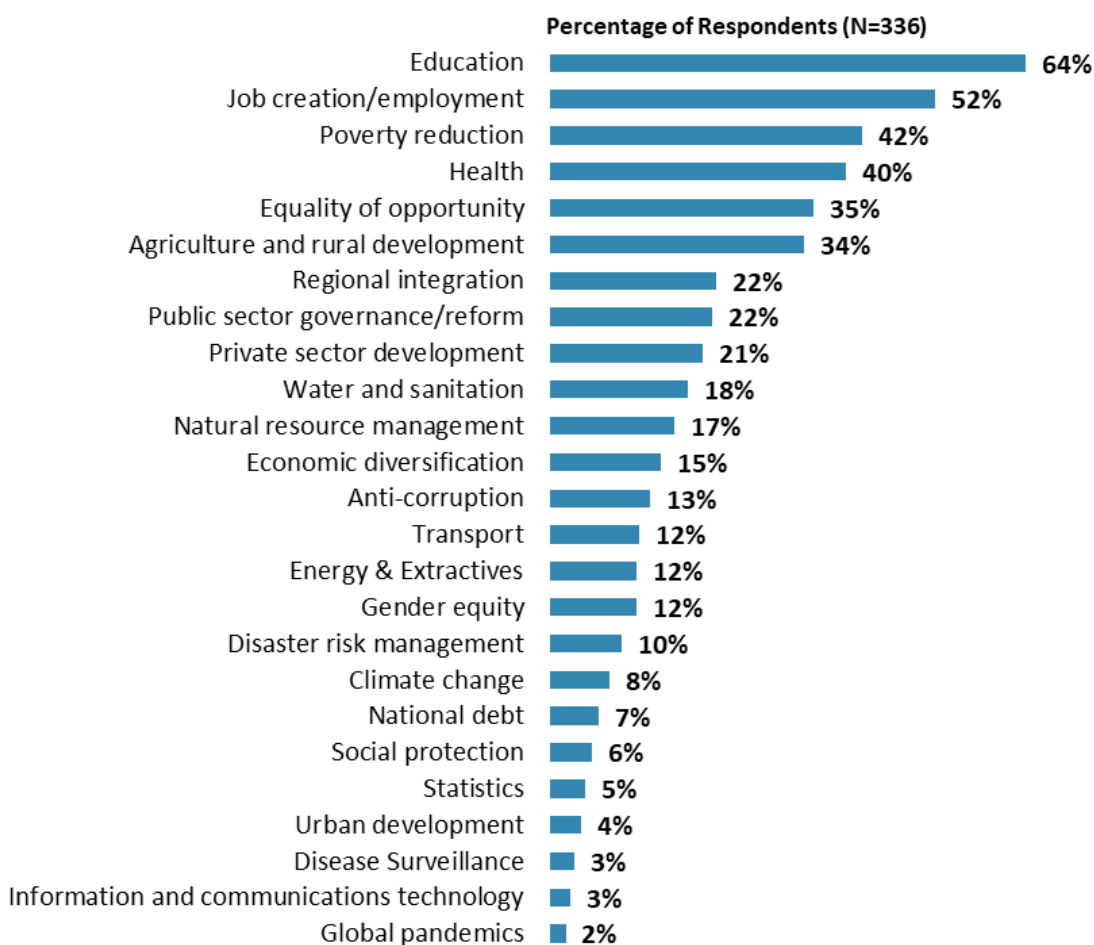
"Do you think that economic opportunity for citizens in Sierra Leone is ... ?\*"

## IV. Overall Context (continued)

### Development Priority

- **Year comparison:** Respondents in the previous FY'19 Country Survey indicated that the most important development priorities in Sierra Leone were “*education*” (59%), “*job creation/employment*” (48%), “*agriculture and rural development*” (32%) “*health*” (30%), and “*food security*” (14%). In FY'22, over one third of the respondents selected “*poverty reduction*” (42%) and “*equality of opportunity*” (35%) among the top development priorities, which was a significant increase compared to FY'19 (7% and 0.5% respectively).

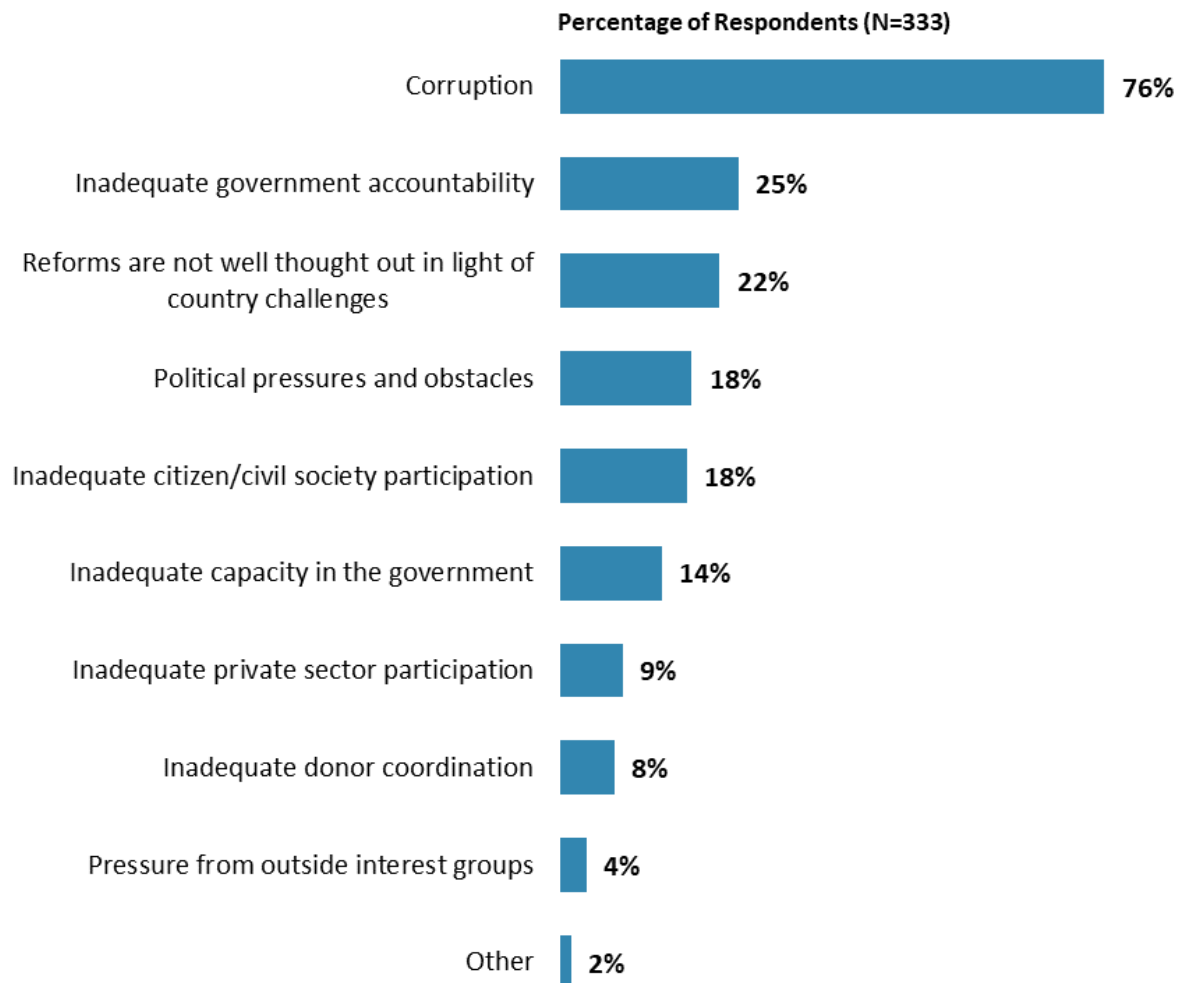

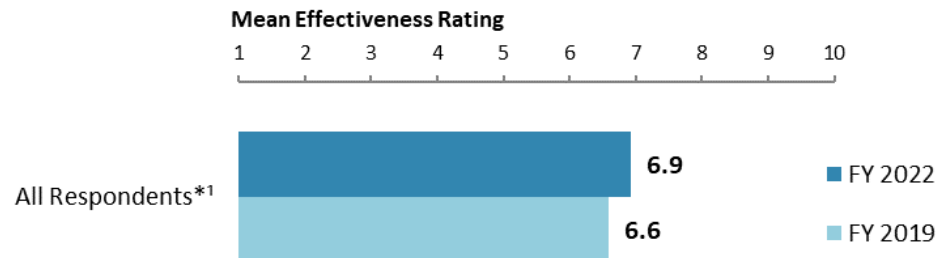


**"When economic and/or social reform efforts fail or are slow to take place in Sierra Leone, which of the following would you attribute this to? (Choose no more than 2)"**

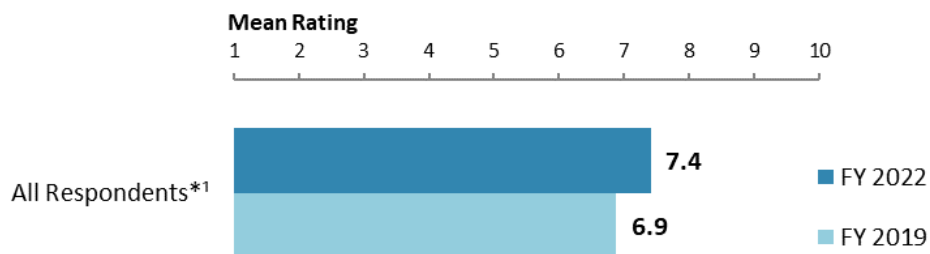

### The World Bank Group's Overall Effectiveness (*Indicator Question*)



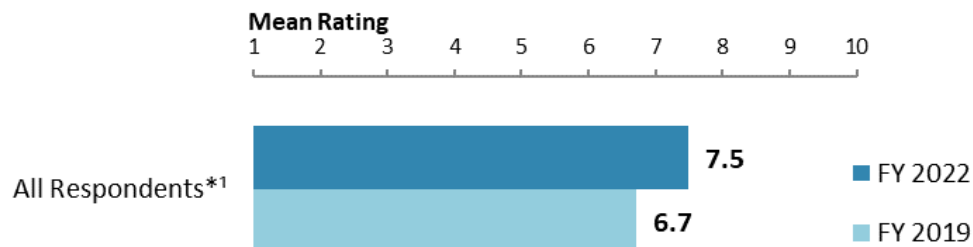

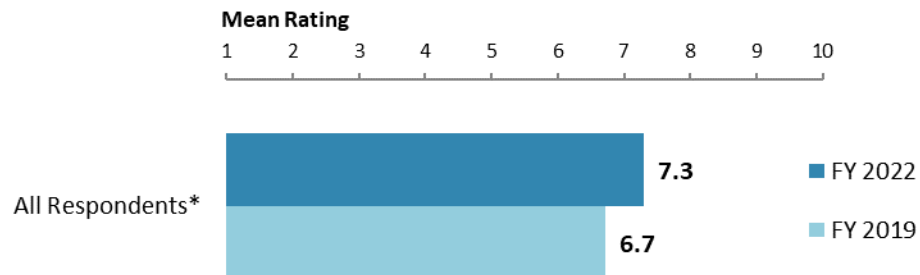


"To what extent does the World Bank Group influence the development agenda in Sierra Leone?" (1-"To no degree at all", 10-"To a very significant degree")

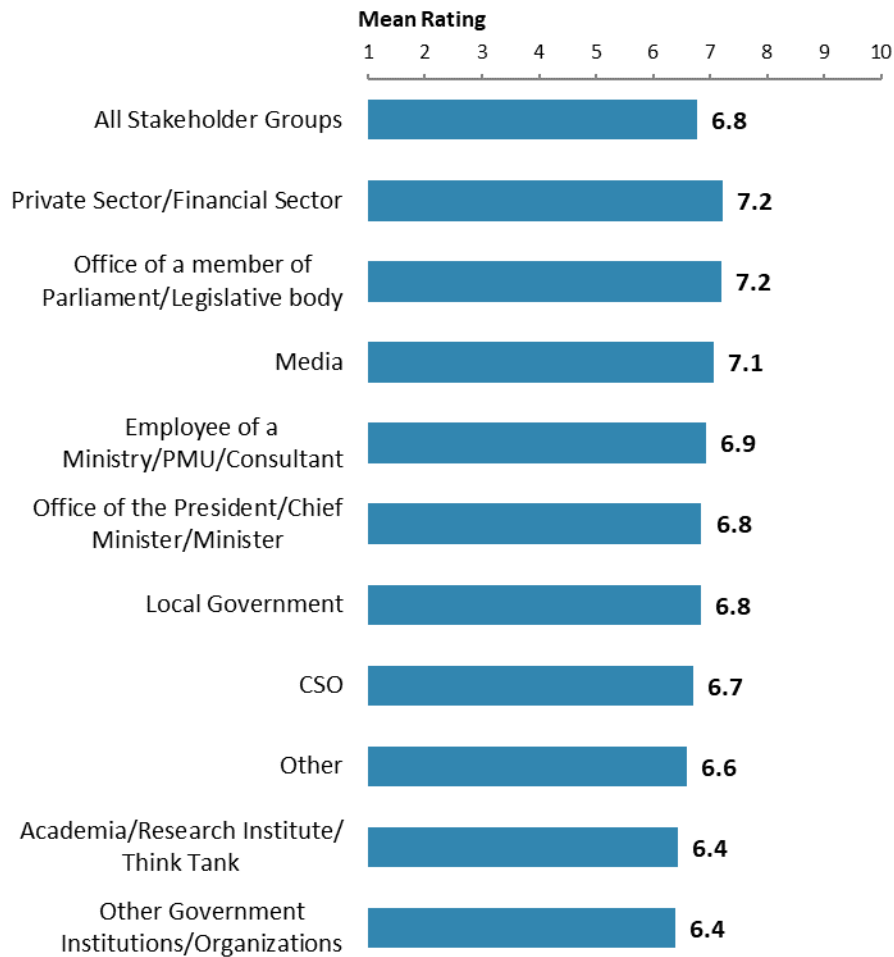

Mean Ratings for All Indicator Questions by Stakeholder Groups on a Scale from 1 to 10

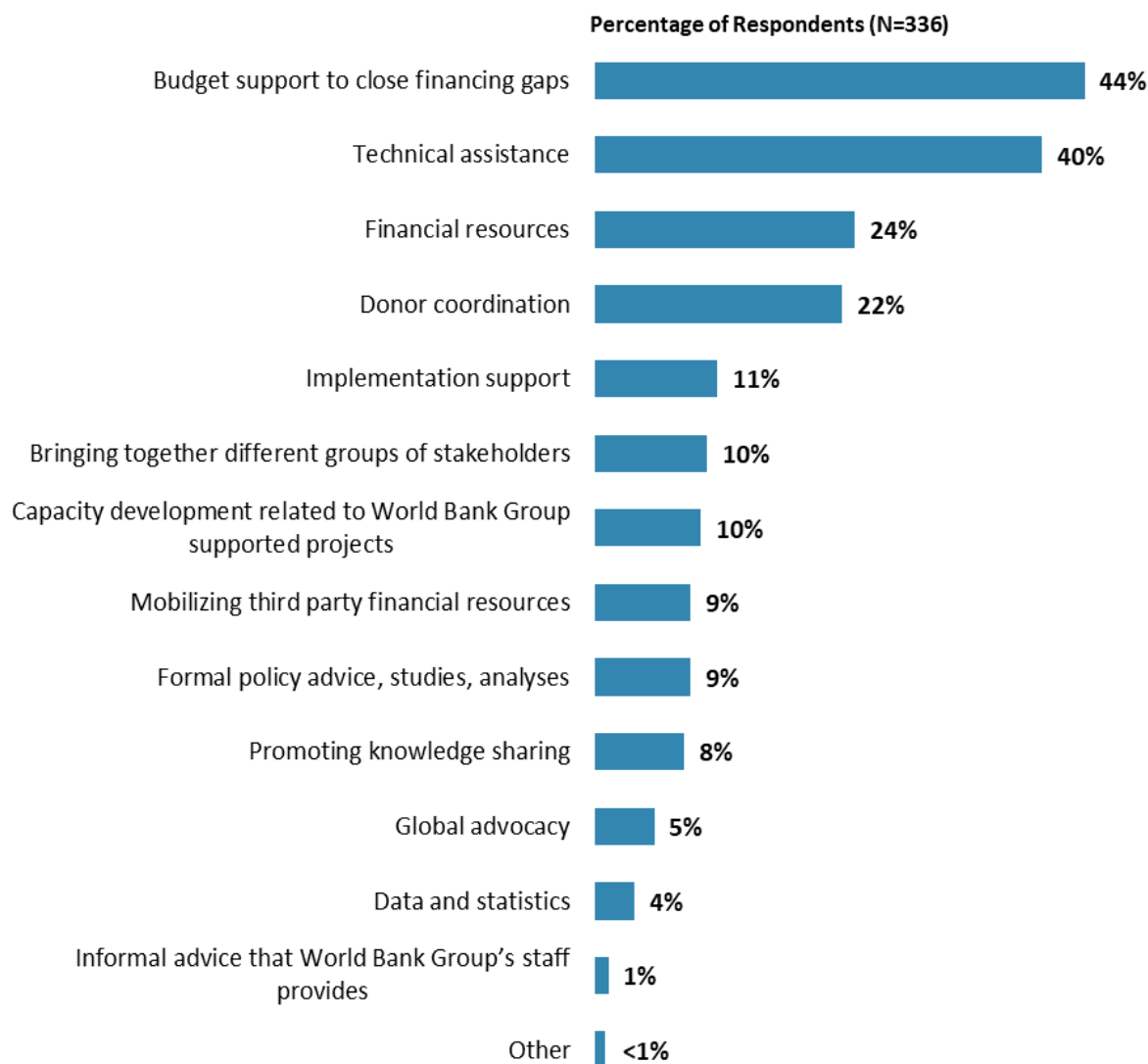

### Greatest Value

- **Year comparison:** Respondents in the previous FY'19 Country Survey indicated that the WBG's greatest values to Sierra Leone were "*technical assistance*" (36%), "*financial resources*" (33%), and "*implementation support*" (24%). In FY'22, one in four respondents selected "*donor coordination*" among the most valuable activities of the WBG (compared to only 11% in FY'19).

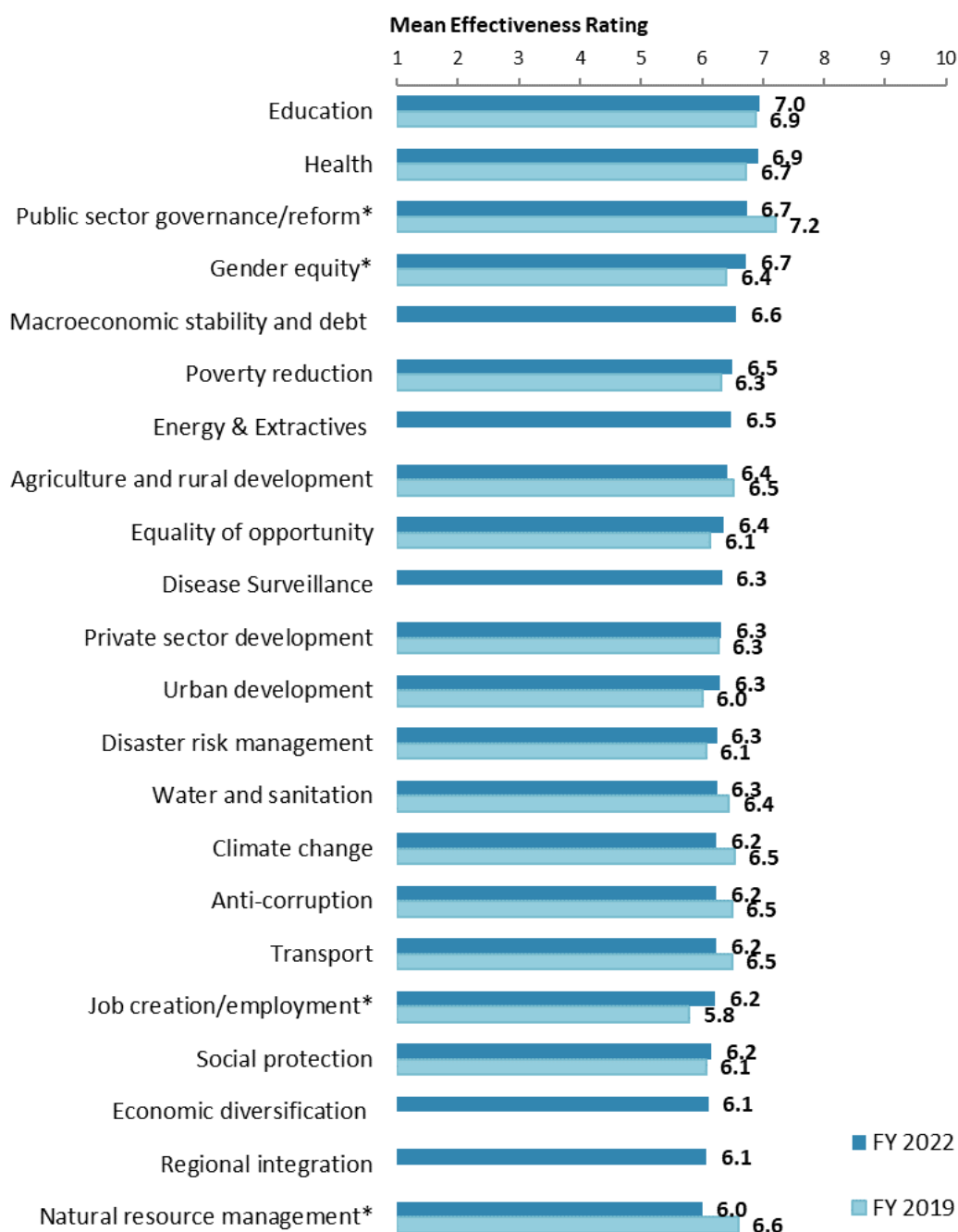


**"When thinking about the World Bank Group's role in Sierra Leone, which activity do you VALUE the most? (Choose no more than 2)"**

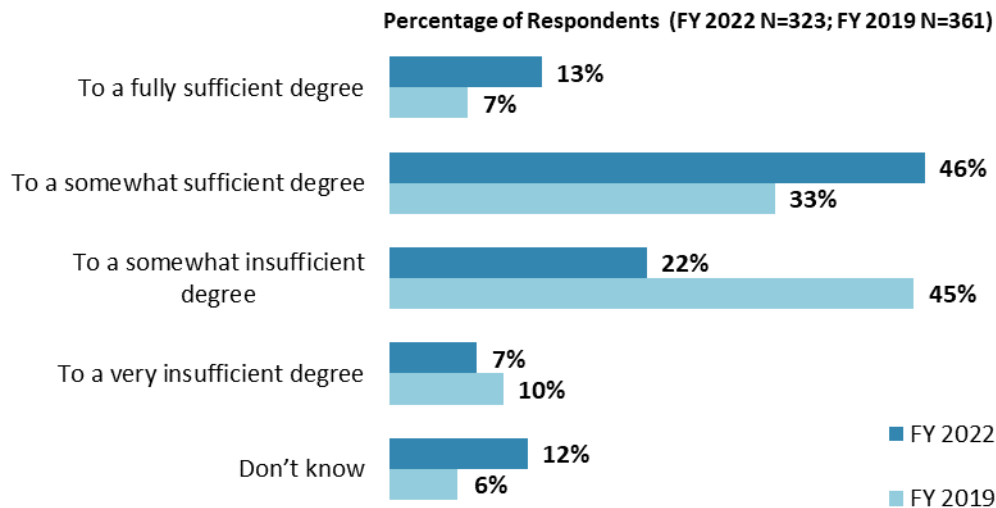

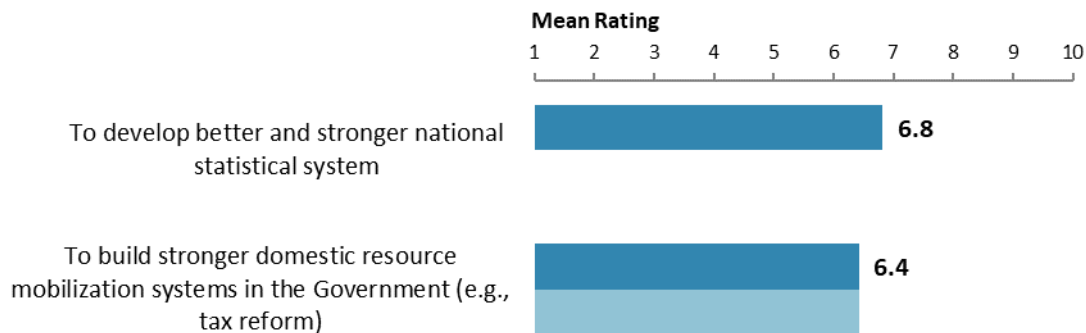
### Helping the Poorest

### Effectiveness of WBG's Support



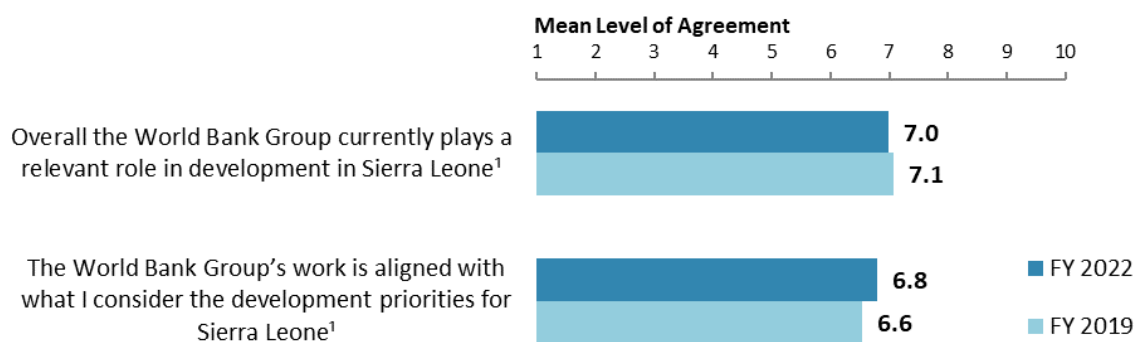
**"How effectively does the World Bank Group support Sierra Leone's efforts ... ?"**

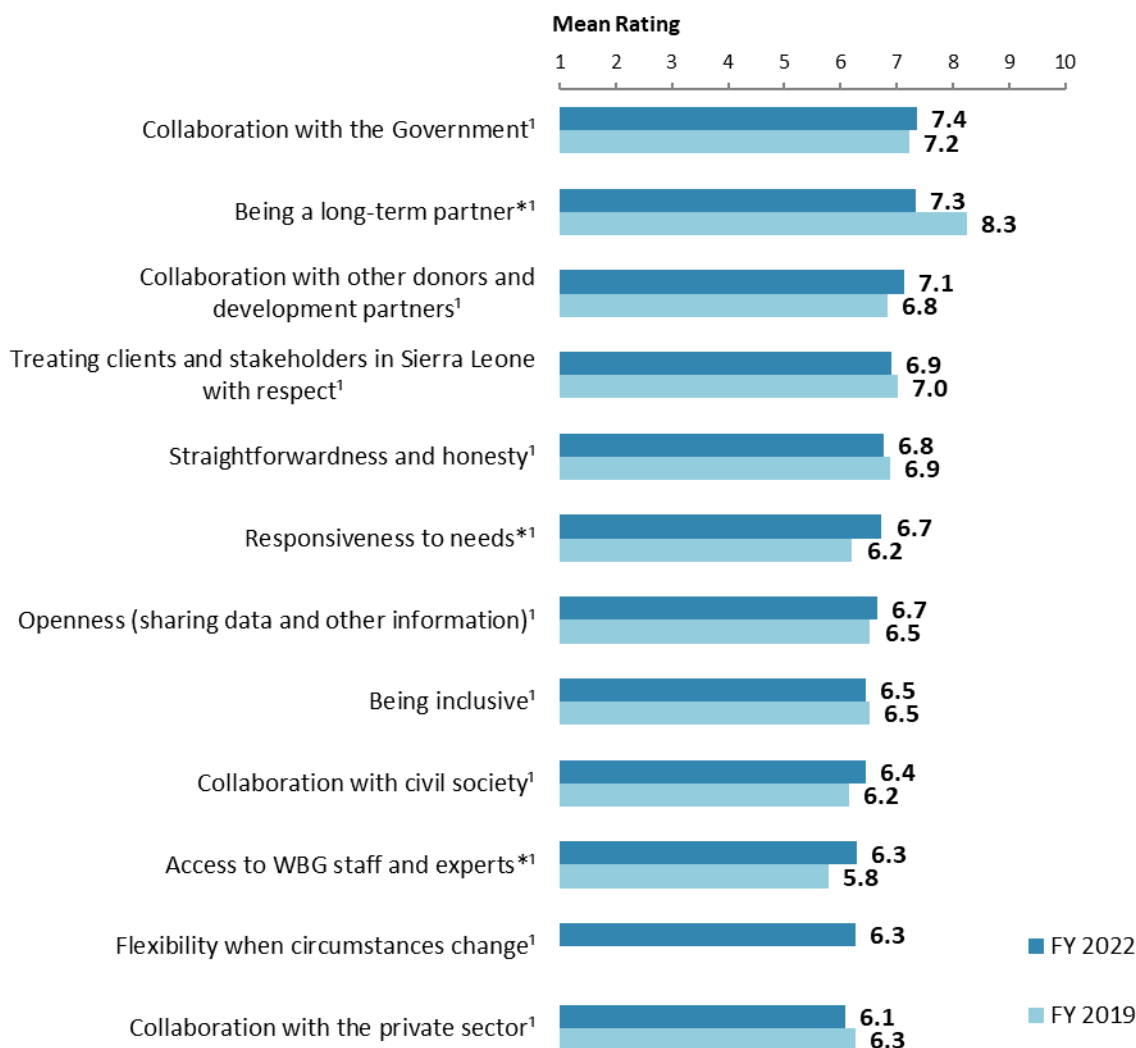

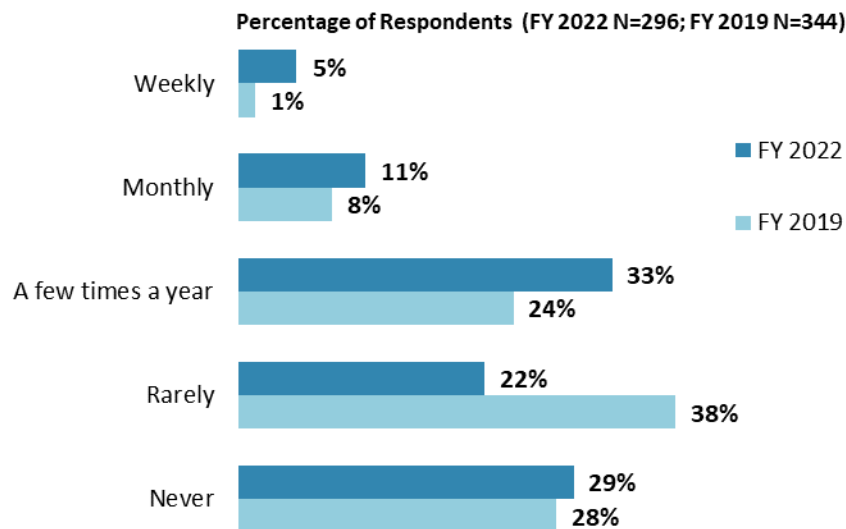

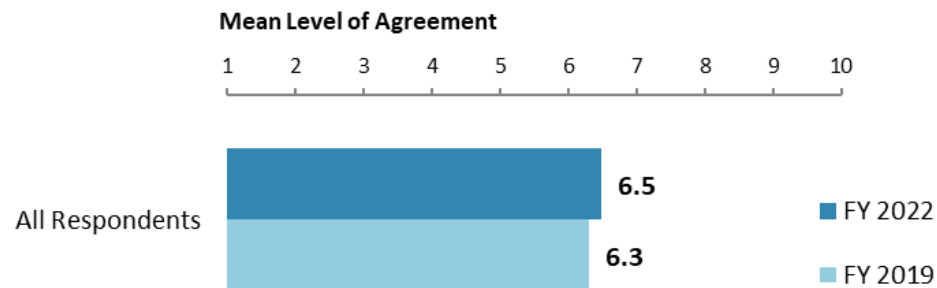

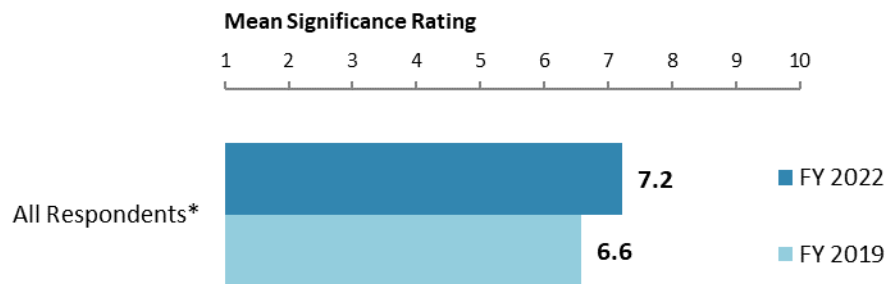

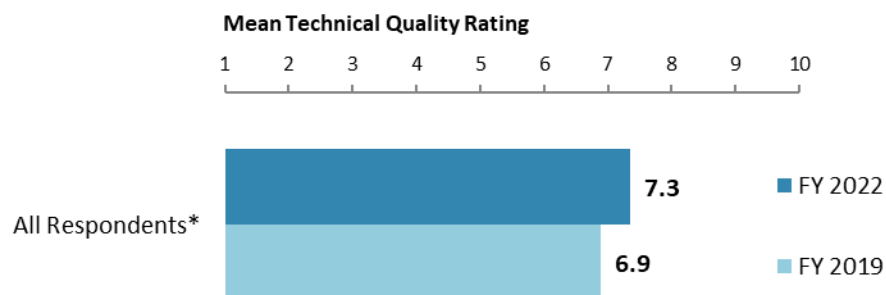
"Overall, how significant a contribution do you believe the World Bank Group's knowledge work and activities make to development results in your country?"

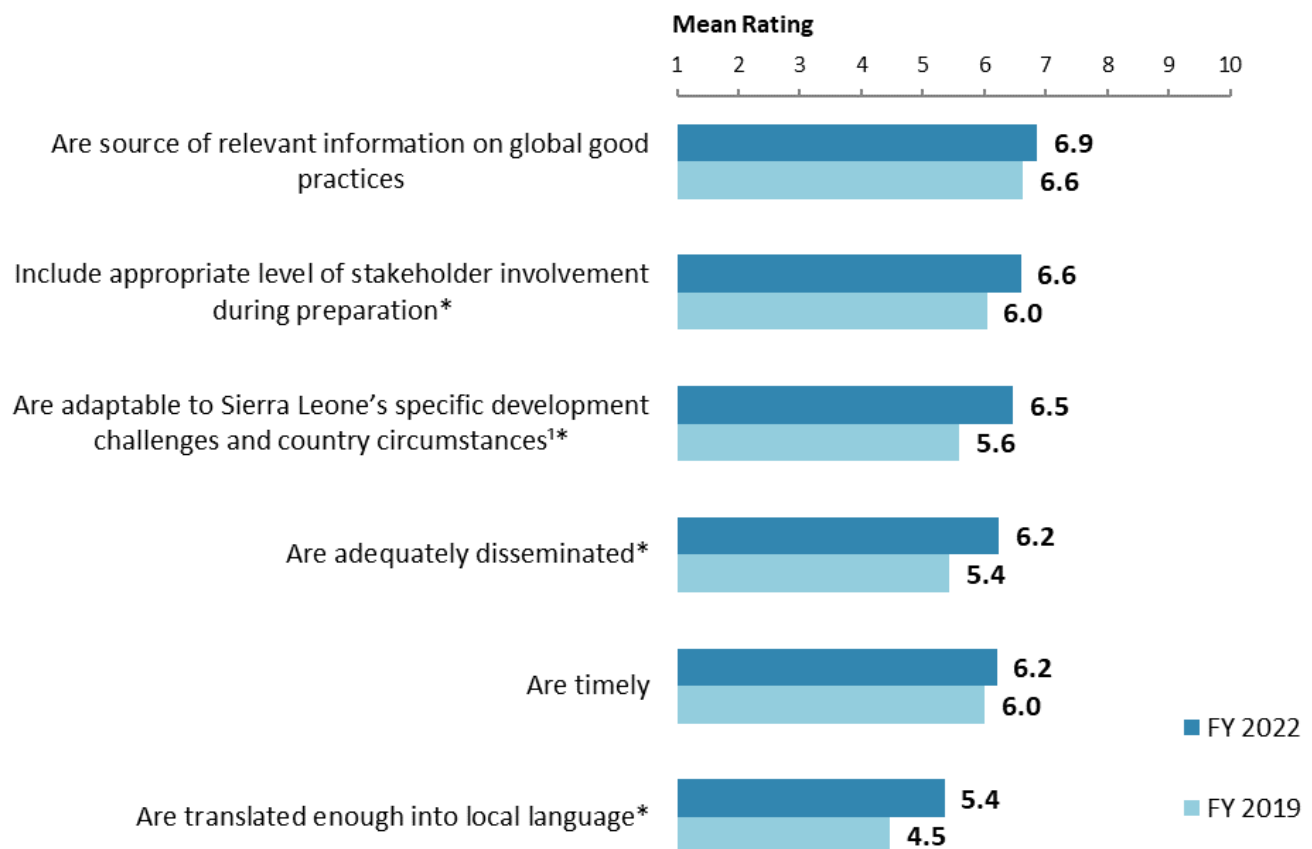

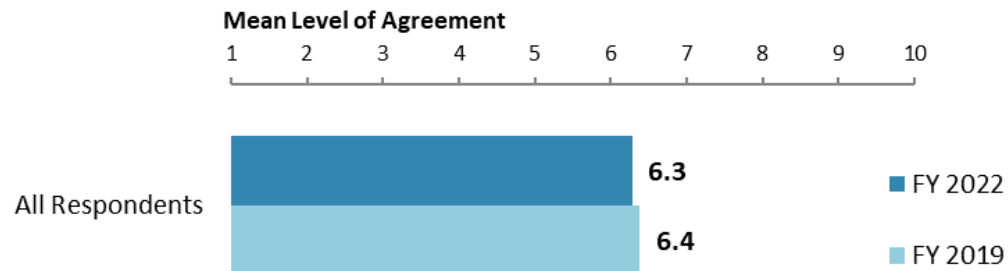

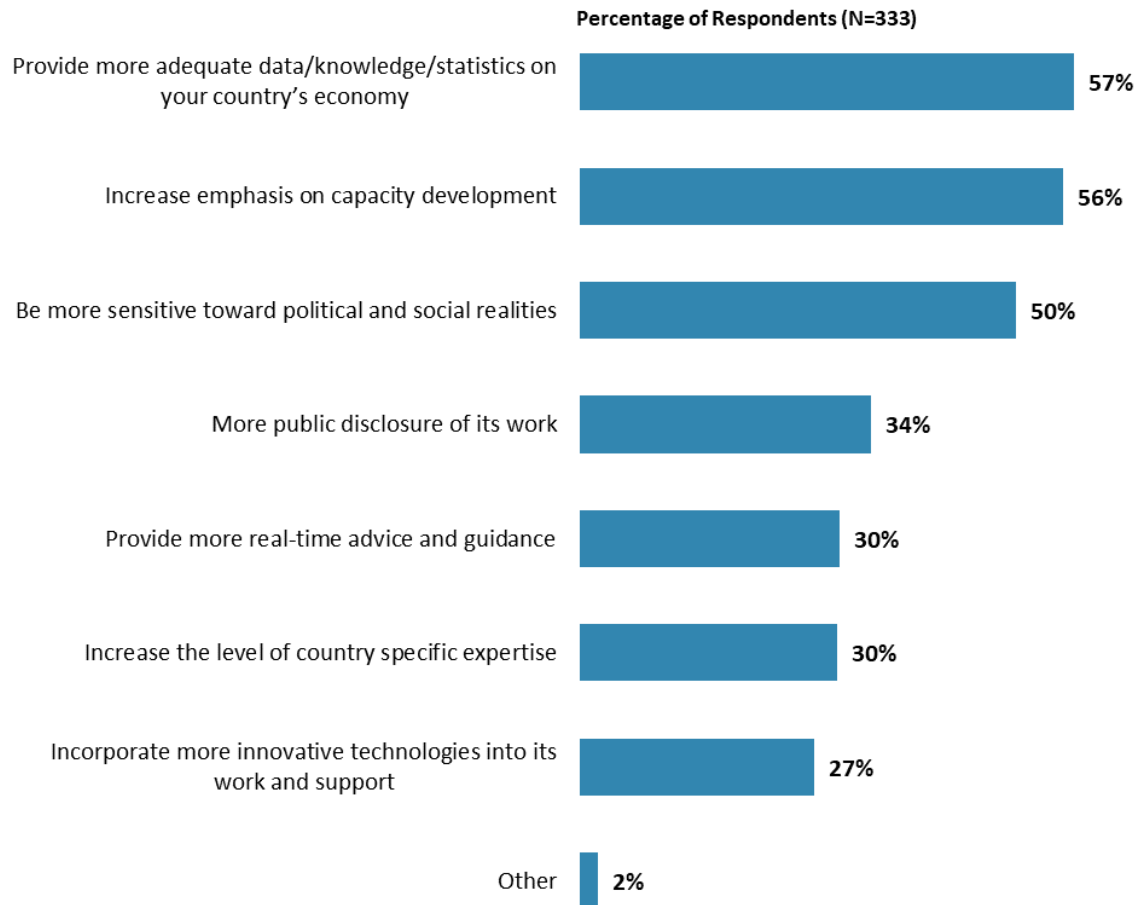

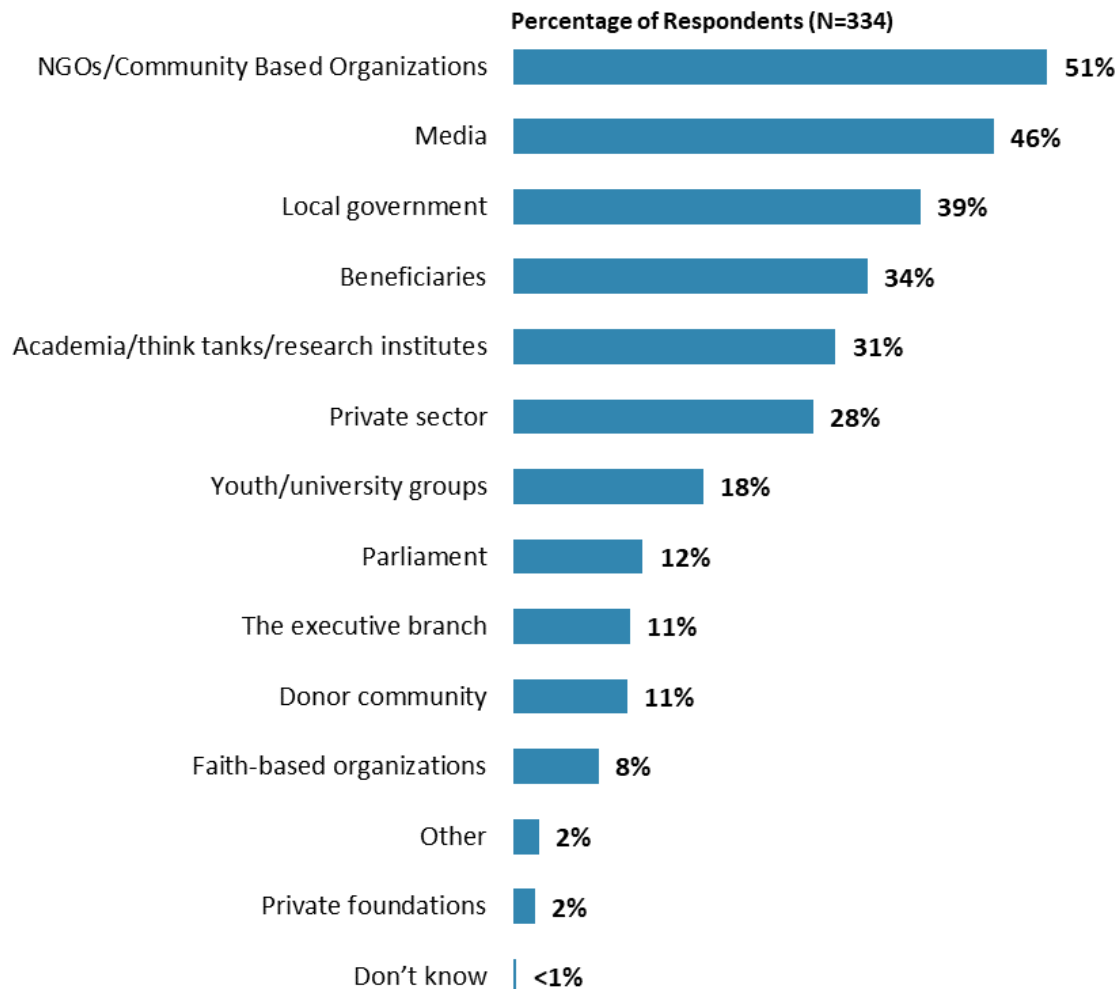

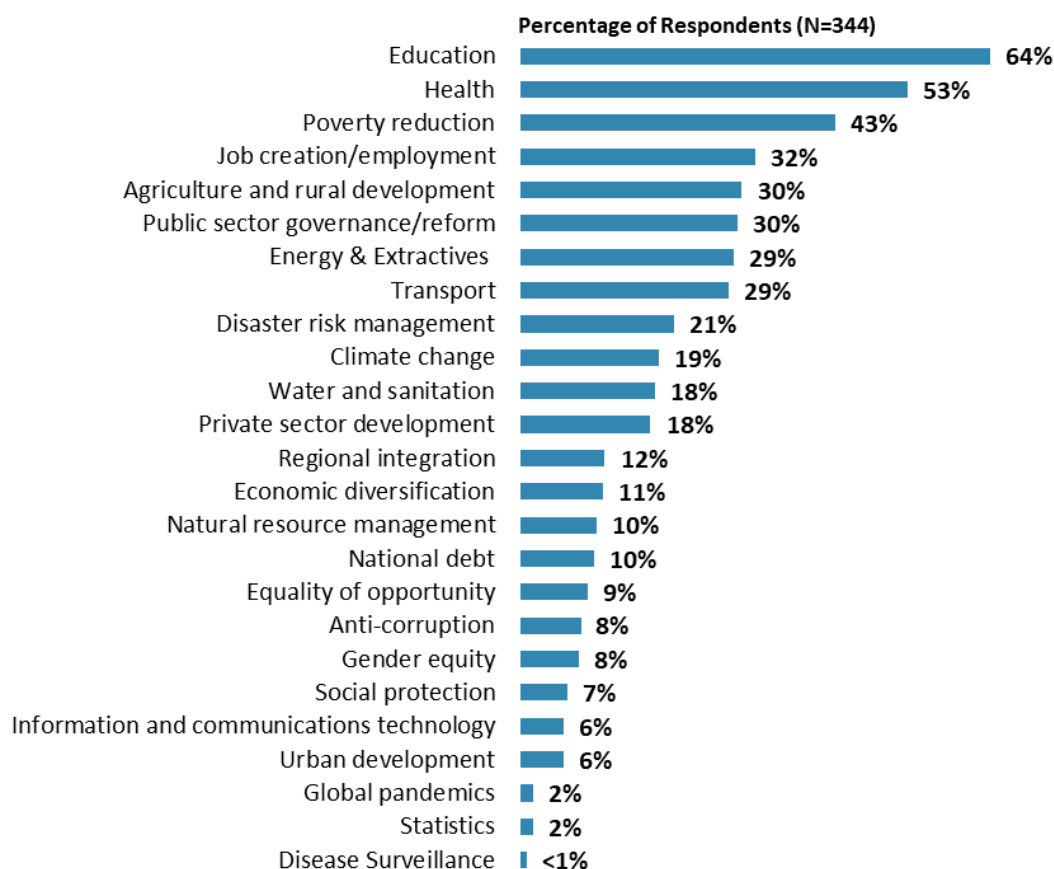
"In addition to its regular relations, which THREE of the following should the World Bank Group collaborate with more in Sierra Leone? (Choose no more than 3)"

## IX. The Future Role of the WBG in Sierra Leone (continued)

### Where the World Bank Group Should Focus its Resources

- **Year comparison:** Respondents in the previous FY'19 Country Survey indicated that the WBG should focus its resources on “*education*” (56%), “*agriculture and rural development*” (42%), “*job creation/employment*” (31%), “*economic growth and diversification*” (22%) and “*food security*” (16%). In FY'22, respondents more frequently selected “*health*” (53%) and “*poverty reduction*” (43%) as the areas where the WBG should focus its resources, a significant increase compared to FY'19 (9%).
- **Specialization:** Respondents who identified their primary specialization of work as “*education*” (16% of the sample) were significantly *more* likely to indicate that the WBG should focus most of its resources on “*education*”, compared to the rest of the respondents (education specialists = 84%; others = 61%).<sup>5</sup>

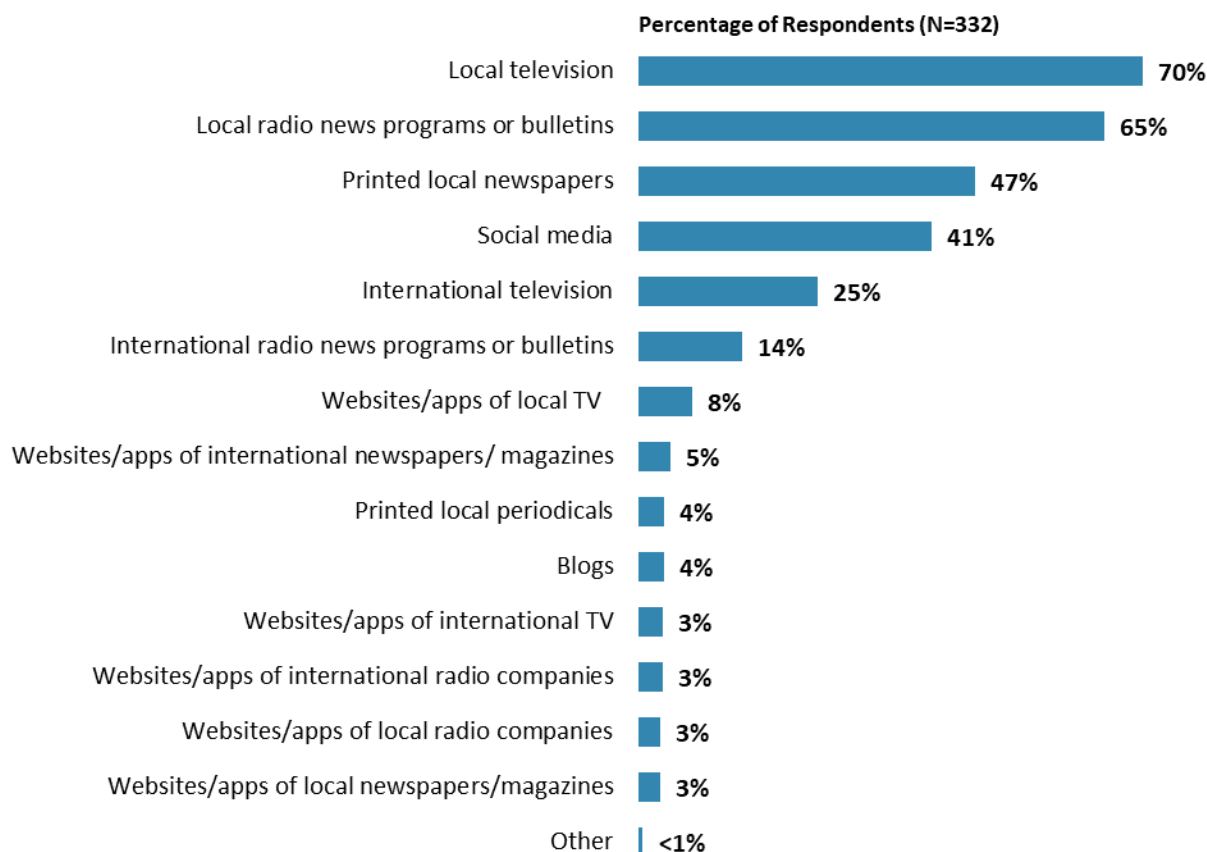

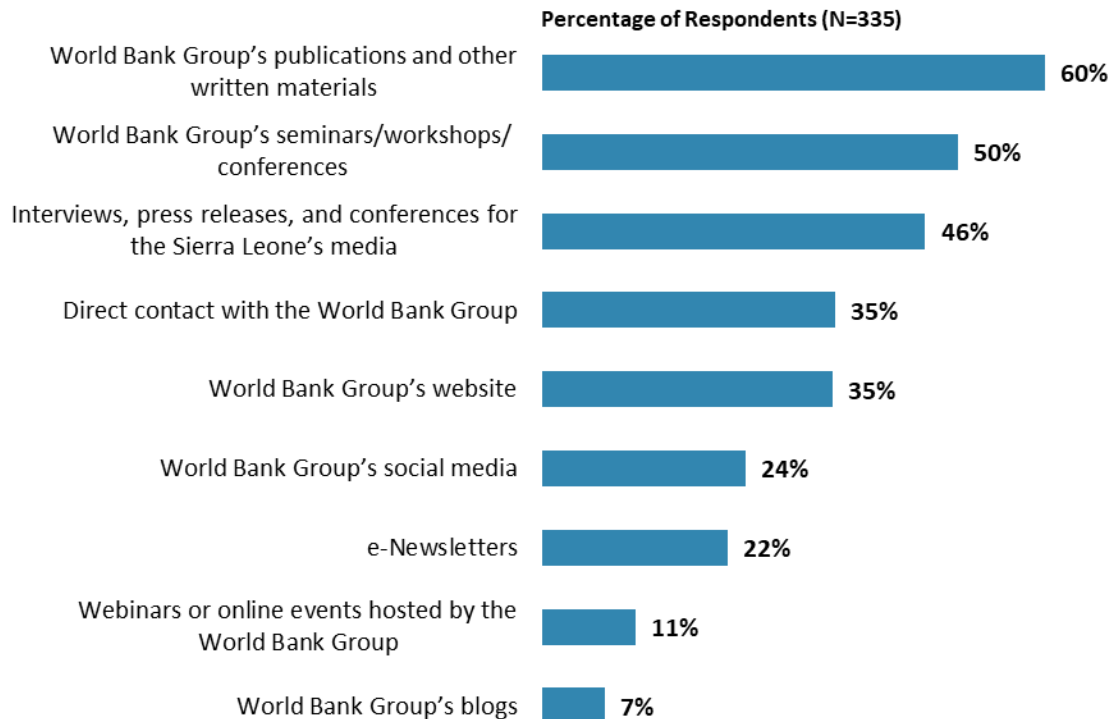


**"Which would you say are your MAIN sources of news about economic and social development issues in Sierra Leone? (Choose no more than 3)"**

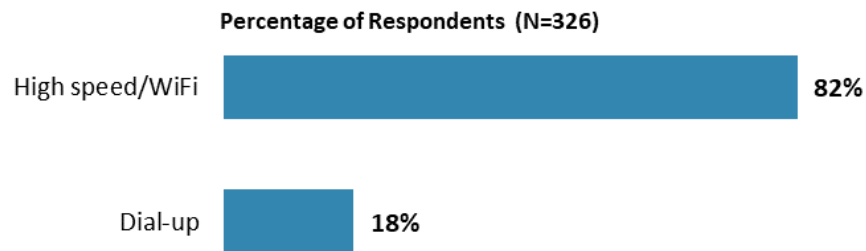


**"How would you prefer to obtain information about the World Bank Group and its work? (Choose no more than 3)"**

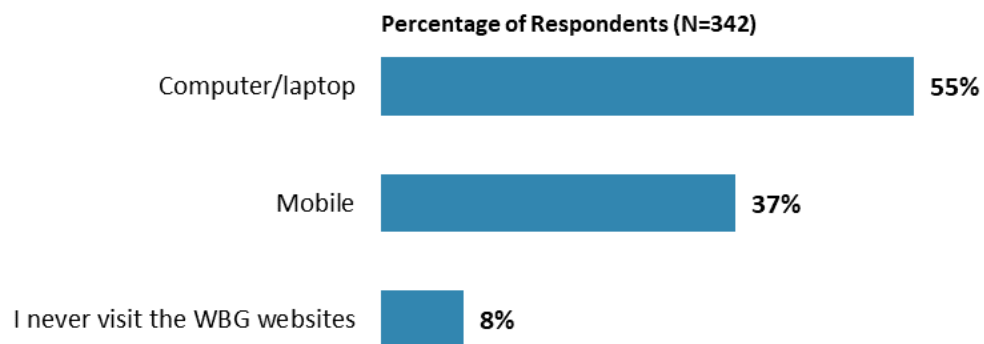
### Internet connection
