# **1. Introduction**

## **1.1 Context**

The Harmonized Survey on Household Living Conditions (EHCVM) is a joint initiative of the UEMOA Commission and the World Bank. It is conducted as part of the Program for the Harmonization and Modernization of Household Living Conditions Surveys within the UEMOA member states (PHMECV).

The Program's objective is to support the UEMOA Commission in strengthening the capacities of its member states to conduct household living conditions surveys that meet harmonized regional standards, and to make the collected microdata accessible to the public. The specific objectives include, among others, producing indicators on poverty and living conditions, and creating harmonized databases that allow for analyses to inform public policies.

The beneficiaries are the eight UEMOA countries: Benin, Burkina Faso, Côte d'Ivoire, Guinea-Bissau, Mali, Niger, Senegal, and Togo. Apart from the PHMECV beneficiary countries, Cameroon, Chad, Guinea, and Congo have also conducted a similar survey using the same methodologies and have participated in various technical works. The first edition of the survey took place in 2018/2019, and the second, which is the subject of this document, in 2021/2022.

The survey includes four components: a household component, a community component, a price component, and a component on non-standard units (NSU).

## **1.2 Partners**

The survey was designed and conducted through a collaboration between the National Institutes of Statistics (INS), the UEMOA Commission, and the World Bank. The BCEAO, BOAD, and AFRISTAT also supported the process.

The INS were at the center of the process in all phases (design, preparation, data collection, data processing, and data analysis).

### **1.3 Funding**

The program is funded by the World Bank through a grant of \$40.5 million to the UEMOA Commission. For Burkina Faso, the funding amounts to \$4.2 million.

### **1.4 Technical Assistance**

The UEMOA Commission and the World Bank provided technical assistance to the INS throughout the project implementation. Technical assistance was provided in the form of missions and regional workshops.

They brought the necessary expertise in coordination to support the harmonization process so that the produced indicators would be comparable. They also supported the modernization process in the collection phases (CAPI) and methodological phases (e.g., the introduction of the panel dimension in the second edition).

### **1.5 Organization of the Document**

This document is designed to provide the necessary information to understand the data from the second edition of the Harmonized Survey on Household Living Conditions (EHCVM 2). It is composed of seven parts. After the introduction, the next section presents the characteristics of the survey. The presentation of survey instruments is covered in section 3, and sampling issues are addressed in section 4. Then, the document describes the organization of the fieldwork in section 5, presents the main results of the data collection in section 6, and describes the databases in section 7.

## **2. Characteristics of the Survey**

The cross-section EHCVM-2 of Burkina Faso is based on a sample of households from a new sampling frame compared to the first edition of EHCVM-1 of BFA 2018/19. The survey took place in two waves, each wave covering half of the sample.

### **2.1 Household and Community Components**

The household and community components of the survey are organized into two waves. Each wave covers half of the cluster sample and half of the household sample. Organizing the work into two waves allows for the consideration of seasonal variations in consumption throughout the year. Each wave of the survey was preceded by a listing phase that identified the households from the first edition. The data collection for the first wave took place in September, October, and November 2021. For the second wave, the collection phase occurred in April, May, and June 2022.

### **2.2 Price Component**

The price component is organized differently, with data collected monthly throughout the entire collection period, including during the break period between the two waves. Price data was collected from November 15, 2021, to July 31, 2022.

### **2.3 NSU Component**

The component related to non-standard units (NSU) allows for the production of factors to convert the non-standard consumption units used in households (piles, bowls, ears) into standard units (kilograms, liters). Information on the NSUs was collected during the 2018/2019 episode, and the produced conversion factors are still valid. Therefore, in principle, it was not necessary to conduct another collection for this component. However, there was a supplementary collection to complete certain missing units. This collection took place in April-May-June 2021.

### 3. Collection Instruments

The survey has four questionnaires: a household questionnaire, a community questionnaire, a price questionnaire, and a questionnaire on non-standard units.

#### 3.1 Household Questionnaire

The household questionnaire is designed to collect information at both the household and individual levels. The sections to be filled out at the household level are as follows: control section, food consumption, food security, non-food expenditures, existence of agricultural enterprises, housing, household assets, monetary transfers, shocks, safety nets, agriculture, livestock, fishing, agricultural equipment, subjective poverty, governance, peace and security. The sections for collecting information at the individual level are: sociodemographic characteristics of household members, education, health, employment, non-employment-related individual income, savings, and characteristics of non-agricultural enterprises. The content of the household questionnaire is detailed below:

- **Cover Page:** The cover page contains information related to the identification and geospatial location of the household. This section also records basic information about the head of the surveyed household.
- **Section 0: Household Identification and Control Information:** This section provides a detailed geographical location of the household. It also records data on the conduct of the interview, including visit dates and the language of the interview.
- **Section 1: Sociodemographic Characteristics of Household Members:** This section concerns all household members. It contains a list of household individuals and provides sociodemographic characteristics such as the relationship to the head of household, age, marital status, religion, residency status, nationality, ethnicity, parental survival, education level, father's and mother's occupation, etc.
- **Section 2: Education (Individuals Aged 3 Years and Older):** This section concerns individuals aged three years and older. It contains variables for literacy, schooling, and the individual's education level. It also provides

information on the individual's journey through the education system, including difficulties encountered and expenses borne.

- **Section 3: General Health:** This section is filled out for all household members. It provides information on major health problems and consultations that household members have had in the 30 days preceding the investigator's visit. It addresses constraints and difficulties regarding the quality and access to health services. The section also examines consultations and health expenses in the last three months and hospitalizations and expenses in the twelve months preceding the survey. This section also deals with disabilities in individuals aged 5 years and older.
- **Section 4: Employment:** The employment section is dedicated to household members aged 5 years and older. It contains three subsections: labor market participation, primary employment, and secondary employment.
  - **Part A: Labor Market Participation (Individuals Aged 5 Years and Older):** This subsection collects information on labor market participation and concerns all individuals aged 5 years and older. It includes the household member's activity schedule and variables that capture their participation in the labor market in the seven days preceding the investigator's visit. It also includes the job search process implemented 30 days before the investigator's visit.
  - **Part B: Primary Employment in the Last 12 Months (Individuals Aged 5 Years and Older):** This part concerns individuals who have worked in the last 12 months and collects information on the characteristics of the primary job. Data collected includes the profession, industry, occupational category, institutional sector, and for employees, salary, and other benefits in kind.
  - **Part C: Secondary Employment in the Last 12 Months (Individuals Aged 5 Years and Older):** This subsection focuses on information related to secondary employment held in the 12 months preceding the investigator's visit, for individuals identified as having one. The information collected is similar to that of the previous section.



- **Section 5: Non-Employment Income in the Last 12 Months (Individuals Aged 15 Years and Older):** This part collects information on non-employment income for all individuals aged 15 years and older. The questionnaire explores pensions and other public transfers, rents, and other financial and property income. Private monetary transfers are not included; they are covered in section 13.
- **Section 6: Savings and Credit (Individuals Aged 15 Years and Older):** This section collects data on access to financial institutions and prepaid services, savings, loans or credits taken, repayments made, and upcoming payment deadlines, for household members aged 15 years and older.
- **Section 7: Food Consumption:** This section collects data on household food consumption. Food consumption has two components: meals taken outside the home by consumption post (breakfast, lunch, dinner, snack) and in-home consumption by consumption item. This section has two main parts:
  - **Part A: Meals Taken Outside the Household in the Last 7 Days:** This part collects information on meals consumed by one or more household members in the seven days preceding the investigator's visit.
  - **Part B: Food Consumption in the Last 7 Days and Purchases in the Last 30 Days:** This part collects information on items consumed in the household in the seven days preceding the investigator's visit. For each item, the section records quantities consumed, acquisition mode (purchase, self-consumption, gift). If the consumed product was purchased in the 30 days preceding the interview, the last purchased quantity and the value of this purchase are also recorded.
- **Section 8: Food Security:** This module contains information on the household's resource capacity to ensure food security for its members, according to the FAO's FIES approach. Basic food security questions are asked for a period of 12 months preceding the interview.
- **Section 9: Retrospective Household Food and Non-Food Expenditures:** This section includes six subsections covering most non-food expenditures, except for mobile phone credit recharges (section 1), education (section 2), health (section 3), and housing (section 11).

- **Part A: Festival and Ceremony Expenses in the Last 12 Months:** This part provides information on expenses incurred during festivals and celebrations such as religious festivals, weddings, funerals, baptisms, etc., organized by the household. The variables cover food, drink, clothing and footwear, hall rentals, etc.
- **Part B: Non-Food Expenses in the Last 7 Days:** This part provides information on non-food expenses as frequent as food expenses, such as cigarettes, kerosene, firewood, fuel, urban transport, newspapers, etc. The main variable recorded is the amount spent.
- **Part C: Non-Food Expenses in the Last 30 Days:** This part provides information on expenses for items such as wine and spirits, domestic gas, domestic staff wages, and other relatively frequent household operating expenses. The main variable recorded is the amount spent.
- **Part D: Non-Food Expenses in the Last 3 Months:** This part provides information on expenses for items such as intercity transport, entertainment costs, postal services, gardening, pet care, etc. The main variable recorded is the amount spent.
- **Part E: Non-Food Expenses in the Last 6 Months:** This part provides information on expenses for clothing and footwear purchased other than during festivals and celebrations. The main variable recorded is the amount spent.
- **Part F: Non-Food Expenses in the Last 12 Months:** This part relates to annual or less frequent expenses such as housing investment, housing repairs, international travel, acquisition of durable goods, etc. The main variable recorded is the amount spent.
- **Section 10: Non-Agricultural Enterprises:** This section concerns non-agricultural enterprises owned by the household.
  - **Part A: Existence of Non-Agricultural Enterprises:** This part records whether the household owns at least one non-agricultural enterprise.
  - **Part B: Characteristics of Non-Agricultural Enterprises:** It collects detailed information on non-agricultural enterprises owned by the household. The section records the enterprise owner, industry,

enterprise age, degree of formalization, variables for calculating accounting aggregates, family labor, and salaried labor.

- **Section 11: Housing Characteristics:** This section concerns household housing characteristics, including the type of material used for the roof, floor, and walls, as well as amenities (electricity, water, sanitation, toilets, etc.). The section also details housing expenses (rent, water bills, electricity bills, fixed telephone bills, etc.).
- **Section 12: Household Assets:** This section provides information on the household's durable goods, including appliances, furniture, means of transportation, etc. The considered goods must be in working condition. For each good, the number owned by the household is recorded. For the most recently acquired good, the age, acquisition value, and replacement cost are recorded.
- **Section 13: Transfers Received by the Household:** This section collects information on transfers received by the household from other households. It provides detailed information on the sender's characteristics, reason for the transfer, transaction channel, and amount received.

***NB: Unlike the first edition, the subsection on transfers issued (13B) was not included.***

- **Section 14: Shocks and Coping Strategies :** This section provides information on the shocks experienced by the household. It contains two parts:
  - **Part A: Covid-19 and Its Impact on Households** This subsection pertains to shocks directly related to the Covid-19 pandemic that emerged in 2020. It examines potential shocks (illness, reduced working hours, decreased transfers, etc.) that occurred within the household. Additionally, it assesses the household's resilience to these shocks.
  - **Part B: Other Shocks and Coping Strategies** These shocks are related to employment, income, health, natural disasters, etc. This section provides detailed information on the consequences of these shocks and any strategies used to mitigate their effects.

- **Section 15: Social Safety Nets** This section provides information on access to social security programs such as food distribution, free healthcare for children and pregnant women. The variables collected include, among others, the nature and frequency of the assistance received, the identity of the beneficiaries within the household, and the difficulties encountered in receiving various types of aid.
- **Section 16: Agriculture** This section relates to agricultural activities carried out within the household related to the 2021/22 agricultural season, from April 1, 2021 to March 31, 2022. It includes four subsections:
  - **Part A: Fields and Plots** This subsection provides information on the characteristics of the plots farmed by the household, including the identity of the farmer, the area of each plot, the crops grown, the mode of occupation, labor, use of inputs, etc.
  - **Part B: Cost of Inputs** This subsection provides information on the cost of inputs used by the household, the quantity used, and the source of supply.
  - **Part C: Crops** This subsection lists the crops grown on the plots farmed by the household. For each of these crops, information about the harvests is collected.
  - **Part D: Use of Production** For each crop, this subsection addresses the use of the production (consumption, sale, storage).
- **Section 17: Livestock:** This section is dedicated to livestock activities carried out within the household. The household may own these animals or raise them for others. For each type of animal, the section captures information on the number of animals owned, the operating expenses incurred, and the amount of sales from livestock products (animals, meat, milk, eggs, and other by-products).
- **Section 18: Fishing:** This section identifies households that engage in fishing. It provides information on the quantities and types of fish caught, operating expenses, income generated, etc.
- **Section 19: Agricultural Equipment:** This section identifies the equipment owned by the household for agricultural, livestock, and fishing activities. For

each piece of equipment, it captures information on its age, acquisition value, and current estimated value according to the household.

- **Section 20: Subjective Poverty, Governance, Peace, and Security** : This section provides information on topics related to monetary poverty and living conditions.
  - **Part A: Subjective Poverty** : This subsection captures households' perceptions of their living standards.
  - **Part B: Governance** This subsection relates to governance issues, including individual freedoms, participation in major decisions, corruption, etc.
  - **Part C: Peace and Security** :This final part addresses security, aiming to evaluate whether people feel safe and if individuals have been victims of aggression.

***NB: Parts B and C of Section 20 were not included in the questionnaire of the first edition.***

### **3.2. Community Questionnaire**

This instrument was used to gather essential information about local communities. It was conducted in the form of focus groups within the village/neighborhood where the cluster is located. It consists of four main sections that collect general data about the community, basic social infrastructure, agricultural activities, and community participation.

- **Coverage**: This section includes geospatial location information of the cluster. It also contains basic information about the surveyed community leader.
- **Section 0: List of Respondents** :This section lists the individuals who provided the information collected about the village/neighborhood. It also collects the following sociodemographic characteristics for these respondents: gender, age, role in the community, number of years living in the community, and level of education.
- **Section 1: General Characteristics of the Neighborhood/Village** This section gathers sociodemographic, economic, geographic, and living condition information at the village/neighborhood level. Information collected includes

- population size, languages spoken, topography, distance to the nearest city, accessibility, associative organization, access to electricity, clean water, and mobile phone networks.
- **Section 2: Existence and Accessibility to Social Services** This section pertains to existing social infrastructure in the village/neighborhood. For each infrastructure, the questionnaire captures information on accessibility in terms of transportation means to reach the infrastructure, travel time from the village/neighborhood to the infrastructure, and issues encountered while using the service.
  - **Section 3: Agriculture** This section provides information on the agricultural activities of the village/neighborhood. It gathers data on the crops cultivated, the existence of agricultural cooperatives, access to agricultural equipment, potential use of improved agricultural techniques, etc.
  - **Section 4: Community Participation** This subsection collects data on citizens' participation in community life and their sense of ownership when it comes to the construction and maintenance of infrastructures such as roads, bridges, schools, health centers, wells, and markets.

### 3.3. Price Questionnaire

- **Coverage:** The coverage includes information regarding the identification and geospatial location of the market. It also records the market name and the number of visits made to the market.
- **Section 1:** Collection of Prices and Weights for Homogeneous Products
- **Section 2:** Collection of Prices for Heterogeneous Products

The price component is designed to collect prices from a sample of markets. Surveys are conducted monthly in selected localities. In each region, there are at least two selected localities (one urban and one rural). Points of sale include markets, shops, supermarkets, etc. The price questionnaire collects prices for both food and non-food consumer goods, using the classification from the household consumption modules.

### 3.4. Questionnaire on Non-Standard Units

- **Coverage:** The coverage includes information regarding the identification and geospatial location of the market. It also records the market name and the number of visits made to the market.
- **Section 0: Control Information:** This section provides information about the geographical location and the market operating days.
- **Section 1: Survey of Weights and Prices of Non-Standard Consumption Units:** For each product-unit-size combination of non-standard units, the product is weighed and the corresponding weight in kilograms is recorded.
- **Section 2: Survey of Weights and Prices of Non-Standard Production Units:** For each product-unit combination, agricultural products are weighed and the corresponding weight in kilograms is recorded.

## 4. Sampling

### 4.1. Household and Community Component

For the cross-sectional survey, the sampling frame consists of a list of all enumeration areas (EA) from the 2019 General Population and Housing Census. At the first stage, 600 EAs are selected proportionally based on their size in terms of the number of households derived from the mapping.

Some EAs, inaccessible due to security reasons, were excluded from the sampling frame before the selection of the 600 sample EAs. However, all strata for analysis (regions) are represented in the sample.

At the second stage, a sample of 7,200 households, which is 12 households per EA, are selected using equal probability systematic sampling in each enumeration area.

## 4.2. Price Survey

The selection of markets was done using a reasoned choice method. In each region, at least two markets are chosen in urban areas as observation points for the prices of homogeneous products. Each market is visited once a week, with three price recordings per product. In rural areas, the largest non-daily market is considered, with three price recordings per product and per visit. The rural market is visited once every 15 days. For each heterogeneous product and per investigator, at least three recordings are made monthly, with one recording per point of sale and per visit.

### 4.3. Non-Standard Units (NSU) Component

The sampling follows the same stratification as in the previous edition. The selection of markets was done through purposive sampling. The localities to be visited are identified to ensure adequate national coverage by area and region. Each area within each region will constitute a stratum. Thus, a total of 45 markets have been selected for this additional data collection.

## **5. Data Collection**

### **5.1. Organization of Fieldwork**

#### **Household and Community Components**

Data collection from households in 2021/2022 was organized in two waves, just like in 2018/2019. The first wave of data collection took place from October 28, 2021, to January 20, 2022, involving 80 field agents, including 60 interviewers and 20 supervisors/team leaders. The second wave of data collection occurred from April 23 to July 21, 2022, involving 72 field agents, including 54 interviewers and 18 supervisors/team leaders. The work was organized to start and finish almost simultaneously across all strata.

For the second edition of the EHCVM, enumeration activities involved 114 agents (38 cartographers and 76 enumerators) for each wave.

#### **Price Component**

The price component began with sampling and identifying points of sale. Agents were then recruited and trained. After the training, data collection started in November 2021 and ended on July 31, 2022, involving a total of 25 data collection agents.

#### **NSU Component**

The survey on non-standard units (NSU) was conducted twice. The first survey took place in October and November 2017 and was intended to be the main NSU survey. However, data processing revealed deficiencies in the conversion factors produced by this NSU survey. It was recommended to conduct a supplementary survey to correct these imperfections. The supplementary survey on non-standard units was conducted from July 27 to September 7, 2021, involving 15 interviewers. The executives from the Division responsible for producing the national harmonized price index (INHPC) acted as supervisors/team leaders.

### **5.2. Collection Method**

The CAPI (Computer-Assisted Personal Interview) technique using the "Survey Solution" (SuSo) software is employed for all components of the data collection.

For the household, community, and NSU components, three levels of control are implemented. First, interviewers perform checks directly integrated into the collection application; then, team leaders review the questionnaires, executing the same checks before validating and transmitting them to headquarters; finally, the headquarters team runs a quality control and rejection program on a set of questionnaires.

For the price component, the first and last levels of control described above are instituted.

## 6. Data Collection Results

As previously indicated, the data were collected in two waves, each wave covering half of the sample. Table 4 provides the distribution of the final sample, showing households (top row) and individuals (bottom row).

Data collected on non-standard units allowed to quantify household consumption and agricultural production. The price data collected contributed to calculating temporal and spatial deflators.

## 7. Databases

### 7.1. Household Databases

The household databases correspond to the data collected using the household questionnaire. In principle, each section of the questionnaire corresponds to a file (in Stata format). The names of the dataset files have three main parts and help create a link between the questionnaire and the Stata databases:

1. The first part of the file name refers to the section of the questionnaire (e.g., s00 for section 0, s01 for section 1, s16a for section 16a, etc.).
2. The second part is "me," which refers to household data (to distinguish it from community data), and it is the same for all household files.
3. The third part refers to the country and year of the survey, for example, bfa2021 refers to data from Burkina Faso, 2021 edition of the survey.

Thus, for example, the file `s00_me_bfa_2021.dta` contains the data for section 0 of Burkina Faso for the 2021/2022 edition of the survey.

Each database contains the variables of the concerned section. The variables are named with the section number and the variable number. For example, `s00q01` corresponds to variable q01 of section s00.

In each file, the variables "grappe" (primary sampling unit) and "menage" (household number) are used to identify the household and to perform matching.

#### Use and Merging of Data

Data from different modules can be easily merged using the unique household identifier "hhid". This variable is constructed from two variables that make up "hhid", which is a combination of codes concerning the enumeration area (variable "grappe") and the household identifier within the enumeration area ("menage").

Similarly to the unique household identifier, each member of the households included in the survey is assigned a unique identification number that can be used to merge

information about a given household member across different datasets. This is the variable "pid" included in the household sociodemographic characteristics module (database s01\_me\_BFA2021). The other datasets have been harmonized to have a variable named "pid" that refers to the respondent of the section, in order to enable merging to import the respondent's personal characteristics from the household sociodemographic characteristics module (s01\_me\_BFA2021).

## 7.2. Community Databases

The community databases correspond to the data collected using the community questionnaire. They are constructed following the same logic as the household databases. In the naming of these databases, the particle "co" is used instead of "me". The identification variable is the cluster.

## 7.3. Auxiliary Databases

There are four main auxiliary databases: Prices, NSU, Survey Weights, and Calories. These databases are briefly described below:

- **Prices:** The price file is named ehcv\_m\_prix\_bfa\_2021. The price file contains variables related to product prices. Data are collected monthly for each stratum (region/residence area). The main variables are as follows:
  - **Region:** The region of the country where the data was collected
  - **Residence Area:** The type of residential area
  - **Year:** The year of data collection
  - **Month:** The month of data collection
  - **Week:** The week number within the month
  - **Product Code (Codpr):** The code of the product being collected
  - **Variety:** The variety of the product within the code (a product can have several varieties)
  - **Unit:** The unit of measurement
  - **Weight:** The weight of the product
  - **Price:** The price of the product according to the weight and unit concerned



- **NSU (Non-Standard Units) :** The NSU consumption file is titled ehcvn\_NSU\_bfa\_2021. This file contains variables related to conversion factors between non-standard units and standard units. The data was collected in 2018 and supplemented in 2021. The main variables are:
  - **Region:** The region of the country where the data was collected

  - **Product Code (Codpr):** The code of the product being collected

  - **Cal:** Caloric value of 100 grams of the product

The household, community, and auxiliary databases are located in a directory (e.g., "datain") with different subdirectories. The analysis databases, which are described below, are in another directory (e.g., "dataout").

## 7.4. Analysis Databases

Four main databases have been created for poverty analysis and other studies: an individual database, a household database, a consumption database, and a database for calculating poverty indicators and conducting other analyses. The do-files used to create these databases are archived and accompany these files. The databases are described below.
