



# Vanuatu STEPS Survey 2011

## Fact Sheet

The STEPS survey of chronic disease risk factors in Vanuatu was carried out from end of July 2011 to end of October 2011. Vanuatu carried out Step 1, Step 2 and Step 3. Socio demographic and behavioural information was collected in Step 1. Physical measurements such as height, weight and blood pressure were collected in Step 2. Biochemical measurements were collected to assess blood glucose and cholesterol levels in Step 3. The STEPS survey in Vanuatu was a population-based survey of adults aged 25-64. A multi-stage cluster sampling design was used to produce representative data for that age range in Vanuatu. A total of 4671 adults participated in the Vanuatu STEPS survey.
