The National Statistics Office (NSO) will conduct the 2008 SOF in October 2008. The SOF is a nationwide survey which is conducted every year as a rider to the October round of the Labor Force Survey (LFS).

The comments and suggestions related to the questionnaire as indicated in your letter dated September 10, 2007 were already incorporated in the attached 2008 SOF questionnaire. 

We would like to reiterate our comments on the 2007 SOF, which states that, "One of the main objectives of the survey is to estimate the number of overseas Filipinos including overseas workers and their socio-economic characteristics. However, the list of tables to be generated pertains only to estimates of overseas Filipino workers and their characteristics. There are no tables pertaining to other overseas Filipinos who are not working. The title of the survey and its objectives should be revised in order to reflect the true nature of data to be collected."
