INCOME AND EXPENDITURE IN SOUTH AFRICA

A comprehensive survey was conducted in October 2000 on the income and expenditure of households in South Africa in order to determine the weights for the CPI. Not only does this survey show the earning and spending capacity of South African households, but also the pattern of household consumption. This survey is conducted every five years.

The survey includes households throughout the country, including the 13 historical metropolitan areas (Cape Peninsula, Port Elizabeth/Uitenhage, East London, Kimberley, Bloemfontein, Free State Goldfields, Durban/Pinetown, Pietermaritzburg, Klerksdorp/Stilfontein/Orkney, Pretoria/Centurion/Akasia, Witwatersrand, Nelspruit/Witbank and Polokwane (Pietersburg)), as well as other urban areas and rural areas.

These tables should be used together with the separate summary report “Earnings and Spending in South Africa”, which gives a written and graphic description of the main findings. This report is available from Statistics South Africa.

NOTES

Purpose of the survey	The main purpose of the survey was to determine the average expenditure patterns of households in different areas of the country. This survey forms the basis for the determination of the “basket” of consumer goods and services used for the calculation of the Consumer Price Index. The survey was conducted in October 2000 and is repeated every five years.
Background	The IES is a five-yearly household survey based on the sample for the rotating panel of the twice yearly Labour force Survey (LFS). It measures the detailed income and expenditure of households. The survey was done by means of an interview with the household head or a responsible adult and the questionnaire was completed by the enumerator during this interview. In cases where the household requested to complete the questionnaire themselves, it was dropped off by the enumerator, and the completed questionnaire was collected at a second visit.
Income	The average, regular and other income in the release are based on the data as recorded. However the income categories in the release are based on an estimated income, which was estimated as follows: If the total recorded expenditure exceeded the total recorded income, or where no income was recorded, the total income was estimated as being equal to the total expenditure.

| Introduction | 1 | This publication contains results of the quinquennial Survey of Income and Expenditure of Households. The objectives of the Income and Expenditure Survey (IES) are to collect comprehensive income and expenditure information about households of South Africa according to the nine provinces, to identify the goods and services bought by a typical household which should be included in the basket of the Consumer Price Index (CPI) and determine the weights of all the items in the CPI. Moreover the information obtained in the survey is of great importance for planning purposes. |
| | 2 | There are numerous ways of collecting information on household income and expenditure. For example, people in selected households may be asked to keep receipts of all their purchases, or keep a diary of all expenditure over a specific time period. Due to the relatively low level of literacy in South Africa, and the associated difficulty of record-keeping for many people, Statistics South Africa (Stats SA) chose the route of utilising face-to-face interviews of households for its October 2000 IES. |
| Survey of Income and Expenditure of Households (IES) | 3 | Stats SA conducts a Survey of Income and Expenditure of Households every five years. This survey is conducted by enumerators visiting a number of households throughout South Africa to obtain details on income and expenditure of households. The information obtained through this survey is weighted according to the Population Census figures in order to represent all households in South Africa. |
| | 4 | Every five years the results from this survey are used to identify the goods and services bought by a typical consumer or household and which should be included in the CPI basket of goods and services used to monitor price changes. |
| | 5 | Furthermore, every five years the results from the Survey of Income and Expenditure of Households are used to determine the weights of the products/groups (indicator products) in the basket. 3 000 PSUs are the constituent elements of the master sample, which is drawn from both urban and non-urban areas, in all nine provinces. Ten dwelling units in each of the 3 000 PSUs have been sampled.

More details on the sampling frame and sampling procedure are given in Stats SA's statistical release P0201.

During listing, domestic quarters (DQ) should generally have been listed separately from the main house on the same plot, even if the DQ is vacant at the time of listing. The DQ would only *not* be listed separately if the occupants of the main house told the lister that they use the DQ for members of their household (e.g. brother, grandmother) who regularly eat with them and are part of the same economic unit.

Usually then, a domestic worker living in a separate domestic quarter is a separate household and will have a separate chance of selection for the survey. This will apply even if the domestic servant has most of her/his meals with the household.

When a domestic worker lives in the same structure as the main household, (e.g. in a spare bedroom), this would not have been noted during listing. The following rules were then applied:

- When the domestic worker is *paid a cash wage* by the main household the domestic worker is a separate household even if they eat together most of the time.
- When the domestic worker is *not paid a formal wage* and is treated very much as part of the main family, shares meals, combined spending, she\he is treated as part of the main household.

Response rate 1 Out of the sample of 30 000 households, 26 265 households completed questionnaires. This results in a response rate of 87,55%.

GLOSSARY**Annual percentage change**

The annual percentage change is the change in the figure of the current year compared with the figure in the previous year expressed as a percentage.

Average annual percentage change

The average annual percentage change is the change in the average figure of one year compared with the average figure of the previous year expressed as a percentage.

Consumer Price Index	The CPI is an economic indicator, which indicates the changes in the prices of consumer goods and services bought by the average household.
CPI weights	The weights are the relevant importance of the indicator product in the CPI. The weight of a product is calculated by dividing the total expenditure by households on that product by the total expenditure on all goods and services by households.
Dwelling unit	Any structure or part of a structure identified during the listing as being lived in by a separate household is a dwelling unit. Any structure or part of a structure which <i>could</i> be lived in by a household is also regarded as a dwelling unit.
Household	<p>A household is defined as a person, or group of persons, who occupy a common dwelling unit (see next definition) for at least four days in a week, and who provide themselves with food and other essentials for living. Basically, they live together as a unit.</p> <p>People who occupy the same dwelling unit, but who do not share food or other essentials are regarded as separate households. For example, people who share a dwelling unit, but who buy food separately and generally provide for themselves separately, are regarded as separate households. By this definition, live-in domestic workers who live in the same structure as their employers are usually separate households.</p> <p>Conversely, a household may occupy more than one structure. If in the one plot or area persons eat together but sleep in separate structures (e.g. a room in a building at the back of the house for single young male members of a family), all these members should still be treated as one household. This arrangement is common in some rural areas where a cluster of huts or rondavels will often make up one dwelling unit</p>
Household head/ acting household head	<p>At Statistics SA we have a clear definition of a household head. Respondents may have a different idea of what 'household head' means, and you must explain to them what Stats SA wants. The head is the person in whose name the dwelling is registered. It may be the person who owns the dwelling, or is responsible for the rent, or gets the dwelling through their work, or through their relationship to the owner. If two or more persons have equal claim to be head of the household, or if people state that they are joint heads or that the household has no head, then choose the eldest as the head.</p> <p>A head of a household must be a member of the household. If the head of the household is an absentee head i.e. he/she does not reside at the dwelling unit for at least 4 nights a week, then choose the spouse of the head. If the spouse is not a household member, choose the oldest resident person as the head.</p>
Indicator products	Indicator products are those products or services that were selected in the basket, which is used to compile the Consumer Price Index.
Inflation rate	Inflation rate is the annual percentage change in the CPI for all items of the relevant month of the current year compared with the CPI for all items of the same month in the previous year expressed as a percentage.
Multiple households	Multiple households occur when there are two or more separate households living at the one selected dwelling unit.
Primary sampling unit (PSU)	A PSU (primary sampling unit) is a geographical area containing 100 households or more in which you will be given dwelling units to interview.

Respondent	The person (or persons) responding in this interview should be a member/members of the household who is/are likely to do the purchases for the household or know the answers to our questions.
Special dwellings	<p>Special dwellings (SDs) are dwellings or structures which are not privately occupied by a household, including institutions such as hospitals, prisons, homes for the aged, disabled, juvenile offenders, boarding schools and some workers hostels. They are sometimes called <i>non-private dwellings</i>. SDs can constitute one complete PSU, but often are contained in mixed PSUs.</p> <p>A dwelling unit is regarded as a special dwelling if it provides communal meals served from a common kitchen. Other facilities such as bathrooms and laundry are also usually shared. Examples are hotels and motels (guests only), hospitals and nursing homes (patients only), prisons and reformatories (inmates only), old age homes (the aged only) and boarding schools (students only).</p> <p>Workers' hostels are sometimes regarded as ordinary dwelling units and sometimes regarded as SDs:</p> <ul style="list-style-type: none"> • Where a structure is used as accommodation for single men or women, it has a communal kitchen and there are <i>five people or fewer</i> living in the structure, then it is a normal private dwelling unit. • Where there are <i>more than five</i> single workers resident, then the structure is a SD. • If a large hostel has separate rooms for families who cater for themselves, then these rooms were listed separately and are to be treated the same as other dwelling units. • If the rooms or dormitories in a large hostel are mostly for single people and they eat in a common dining room, then they are SDs. <p>Some hostels have been partly converted for self-catering families while part of the hostel still serves as centrally catered single hostel. In these cases the self-catering part must be treated as separate dwelling units. The centrally catered part is treated as a SD.</p>
Visitors	By the definition of a household above, visitors must only be included if they spend at least four nights a week and have stayed with the household for at least 30 days prior to the interview.

Users may apply the information as they wish, provided that they acknowledge Stats SA as the source of the basic data wherever they process, apply, utilise, publish or distribute the data: and also that they specify that the relevant application and analysis (where applicable) result from their own processing of data.
