All information provided by you will be used and shared with governmental organizations in an anonymous form for statistical analysis only. Please fill in this questionnaire concerning your daily spending and consumption of food products during one week of the survey. The time you spend to fill in this diary and answer the rest of the questionnaire is compensated with a fixed amount of money.

DEAR HOUSEHOLDERS!

We kindly ask you to carefully fill in the diary for a period of 7 days in accordance with the dates indicated on the cover page (the timeframe for filling in the diary will be specified by interviewer).

The diary has to be filled in by a household member, who disposes of all or major part of the household budget, or by that member who runs the household and is most of all aware of expenses incurred by other household members.

The diary is designed to keep records of spending (purchase) and consumption (eating) of food products, drinks (both alcoholic and non-alcoholic beverages) and tobacco goods only. Products purchased and produced by your household, or received as a gift or pay for the work executed should also be included in the diary. An exemplary list of goods is given on the last page of the diary. Please also write down expenses associated with purchase of nonfoods in questionnaire No.3.

Keeping a diary will allow reducing the time spent by interviewer while conducting an interview in your household.

Please carefully read the basic rules for keeping the diary before you start filling it in.

HOW TO FILL IN THE DIARY:

1. **Please fill in only sections 1 and 3 of the dairy every day** and don't forget specifying expenses associated with purchase and consumption of food products, beverages and tobacco goods both at home and outside your household.
2. Section 2 will be completed by interviewer using a questionnaire method once sections 1 and 3 of the diary have been filled in by a household during a week long period.
3. **Records of expenses should be taken immediately once you come back from the shop or market**; they need to be kept on a daily basis to avoid missing something.
4. Please indicate the date of purchase to avoid duplication of records.
5. Records should be as precise as possible (shortened description of items possible):
Please don't write just "meat", it would be more correct to write "beef fillet", "smoked sheep's ribs", "pork". Please don't write simply "cheese", specify more exactly what kind of cheese it is: soft, hard, processed. Don't write just "bread"; indicate "rye bread", "white bread/wheaten loaf". Please don't write simply "fish", it would be more correct to write "salty herring", "smoked capelin", "fresh pikeperch". Please don't write simply "cereals", you'd rather write "buckwheat", "rolled oats". Please don't write just "sausage", indicate exactly "smoked sausage", "frankfurters". Please don't write "butter", you'd rather write "creamy butter", "refined sunflower oil". Please don't write "milk", indicate "pasteurized milk", "cow milk", "condensed milk".
6. When you buy tinned goods, please indicate their net weight (in grams or kilograms) writing down this information from the package.
7. Self-made preserved food may be indicated in kilograms, grams or liters, milliliters.
8. Number of eggs and tobacco goods (1 pack = 20 pcs.) should be indicated in pieces.
9. Oils, alcoholic and non-alcoholic beverages, milk and other liquid milk products should be indicated in liters, milliliters.
10. If the goods were borrowed, then you should specify their exact weight and amount of purchase.
11. Please do your best to fill in all columns of the diary, except for the codes.

SECTION 1

«Purchase of food products, beverages and tobacco goods»

In **Section 1** of the diary you should write down food products, alcoholic and non-alcoholic beverages and tobacco goods purchased daily within a the 7-day period of the survey. Consumption of these and other products received from other sources will be written down by interviewer in Section 2. All products consumed outside the house should be specified in Section 3 (*Please see the example given on the next page*).

Section 2. TO BE FILLED IN BY INTERVIEWER

This section will include food products and quantity consumed by household members during the period fixed for filling out the diary, which have been purchased within this period and earlier, as well as products produced (processed) or obtained from the personal subsidiary plot; products received as a gift.

INTERVIEWER! Please read loud the list of food products to household members and encircle the quantity consumed by them during the two weeks of the survey. If household members consumed products not included in the list, then ask what products they consumed and write down the name of each product and its quantity in the empty lines of the table.

Since the diary provides for only one source of receipt for each concrete product, then one and the same product received from several sources should be indicated several times, i.e. in concrete list and in empty lines of the section.
