- Goods and services in kind given by employer (p.12-13)
- Goods and services in kind given by other institutions (local government, charity, other household, etc.) (p.14-15)
- Expenditures (Purchased consumption) (p. 17-50)
- Own produced goods (food, beverage, firewood) consumed or given by other households (p. 51-64)
- Own produced goods (food, beverage, firewood) given to other households (65. p.).

Some practical advice to follow:

Please record the stock of cash available at the first day of the month (opening asset) at the first row of page 6.

Cash revenues and incomes should be recorded by types at the time of reception on pages

6-9. (E.g.: salary, sick-pay, old-age pension, scholarship, family allowance, income from sale of property or chattels, loans, savings). If the income is connected to a family member, you should who the person was. (E.g.: salary of husband, salary of wife, scholarship of my son, etc.).

Non-regular incomes should be recorded by items in separate rows. (E.g.: income of temporary job, tip, prize, etc.)

Incomes should be entered in **gross amount**, though reducing items *are recorded on separate page*.

Estimate the value of them and enter the column (HUF).

It is inevitable to record all your **expenditure by volume and by value** day by day right from the first day of diary keeping. In case of purchase of clothing, footwear please record the name of family member the clothing, footwear was purchased for. The detailed record have to be entered on pages 17-50.

The consumption of products of own production are monitored in this survey. The quantity and value of consumed own production and product given free of charge to other household by own production or received similar goods have to be recorded on pages 51-65. Please do not forget the quantities in details. The interviewer will help you to fill the diary on his/her visits..
