- Each household is assigned a unique number which is a consecutive number in a range starting from 1500001 to 1515264.
- The method “non-response correction” has been used instead of substitution of sample households since 2009. If the household survey is can not be carried out due to such reasons as refuse the interview, being not at home, inability to obtain sufficient and accurate answers, inability to complete the survey, the bulletin no of that survey which was not completed does not appear.
