I. Objectives

This survey was designed to assist the World Bank Group (WBG) in gaining a better understanding of how stakeholders in Togo perceive the WBG. The survey explored:

- *General Issues Facing Togo*
- *Overall Attitudes toward the World Bank Group*
- *World Bank Group's Effectiveness and Results*
- *The World Bank Group's Knowledge Work and Activities*
- *Working with the World Bank Group*
- *The Future Role of the World Bank Group in Togo*
- *Communication and Information Sharing*
- *Background Information*

II. Methodology

From May to June 2017, 882 stakeholders of the WBG in Togo were invited to provide their opinions on the WBG's work in the country by participating in a Country Opinion Survey. Participants were drawn from the Office of the President, Prime Minister; office of a minister; office of a parliamentarian; ministries/ministerial departments/implementation agencies; Project Management Units (PMUs) overseeing implementation of WBG projects; consultants/contractors working on WBG-supported projects/programs; local governments; bilateral/multilateral agencies; private sector organizations; private foundations; the financial sector/private banks; NGOs/community based organizations; the media; independent government institutions; trade unions; faith-based groups; youth groups; academia/research institutes/think tanks; the judiciary branch; and other organizations.

A total of 548 stakeholders participated in the survey (62% response rate). Respondents either received the questionnaires via courier and returned it accordingly, or completed the questionnaire with an independent fielding consultant.

Every country that engages in the Country Opinion Survey (COS) must include specific indicator questions that will be aggregated for the World Bank Group's annual Corporate Scorecard. These questions are identified throughout the survey report.


The results in this year's Country Survey were compared to those in the Country Survey conducted in FY'14 (response rate was 54%, N=608). Data were weighted to reach the same stakeholder composition in two years, which allows for year comparisons. Stakeholder groups which were not present in both fiscal years were not included in the comparison. Respondents who belonged to the "other" stakeholder category were not included either. As a result, mean ratings, percentages of respondents, and the total number of respondents in both years are slightly different from those of the original data reported in the FY'14 COS report and the non-weighted data presented in appendices A, B, C, D, and F. III. Demographics of the Sample

Current Position

- For further analyses, respondents from the Office of the President/Prime Minister and the office of a minister were combined; respondents from the financial sector/private banks were combined with those from private sector organizations; respondents from NGOs/community based organizations, private foundations, trade unions, faith-based groups, and youth groups were combined in the “CSO” category; and the small number of respondents from the office of parliamentarian, bilateral/multilateral agencies, independent government institutions, the judiciary branch, and respondents from other organizations were included in the “Other” category.




“Which of the following best describes your current position?” (Respondents chose from a list.)

Area of Primary Specialization






Geographic Locations

Exposure to Agencies within the World Bank Group




"Which of the following agencies of the World Bank Group do you primarily engage with in Togo?" (Respondents chose from a list.)



III. Demographics of the Sample (continued)

Familiarity with the World Bank Group

- **Year comparison:** Respondents in this year's Country Survey and the FY'14 Country Survey had statistically similar levels of familiarity with the WBG (weighted mean in FY'17 = 6.3; weighted mean in FY'14 = 6.4)¹.
- **Stakeholder groups:** Respondents from the PMU/consultants working on WBG projects and the Office of the President/Prime Minister/Minister were significantly more familiar with the WBG than other stakeholder groups.
- Respondents' levels of familiarity with the WBG were significantly, strongly correlated with their ratings of the WBG's overall effectiveness in Togo, and significantly, moderately correlated with the extent to which the WBG plays a relevant role in development in Togo, and the extent to which the WBG contributes to the country's development results.

(1-"Not familiar at all", 10-"Extremely familiar")



IV. General Issues Facing Togo

Headed in the Right Direction²

- **Year comparison:** This year's respondents were significantly less likely to believe that Togo is headed in the right direction compared to respondents in the FY'14 Country Survey.
- **Stakeholder groups:** In this year's Country Survey, respondents from the Office of the President/Prime Minister/Minister and ministries/ministerial departments/implementation agencies were significantly more likely to indicate that Togo is headed in the right direction, while respondents from the media and CSOs were significantly less positive about the prospects of Togo.





Development Priority

- **Year comparison:** Respondents in the previous FY' 14 Country Survey indicated that the most important development priorities in Togo were “*public sector governance/reform*” (51%) and “*agriculture, food security, rural development*” (39%).




"Listed below are a number of development priorities in Togo. Please identify which of the following you consider the most important development priorities in Togo. (Choose no more than THREE)"

What Would Contribute Most to Reducing Poverty

- **Year comparison:** In the previous FY'14 Country Survey, respondents indicated that the greatest contributors to poverty reduction in Togo were “*agriculture, food security, rural development*” (57%), “*job creation/employment*” (42%), and “*public sector governance/reform*” (36%).












"In your view, is climate change a very serious problem, somewhat serious, not too serious, or not a problem in your country?" (Respondents chose from a list.)



V. Overall Attitudes toward the World Bank Group

Attributing Failed/Slow Reform Efforts

- **Year comparison:** Respondents in the previous FY'14 Country Survey most often attributed failed or slow World Bank Group assisted reform efforts to “*inadequate level of citizen/civil society participation*” (51%), “*WBG does not do adequate follow through/follow-up*” (33%), and “*WBG is not sensitive enough to political/social realities on the ground*” (33%).











The World Bank Group Staff's Skills Mix to Tackle Fragility






The World Bank Group Partnering with the Right People on the Ground


“If your projects involved both the World Bank and the IFC, what was your view on the two institutions working together in Togo?” (Respondents chose from a list.)

Overall Ratings for Indicator Questions by Stakeholder Groups

- **Stakeholder groups:** Respondents from the Office of the President/Prime Minister/Minister had the highest mean ratings for the aggregated responses to the twenty-eight COS indicator questions, whereas respondents from the media and academia had significantly lower mean ratings. Responses for individual indicator questions by stakeholder groups can be found in Appendix B (see page 66).
- **Collaboration:** Respondents who collaborate with the WBG had significantly higher mean ratings for the aggregated responses to the twenty-eight COS indicator questions (mean rating = 7.5) compared to respondents who do not collaborate with the WBG (mean rating = 6.4). Responses for individual indicator questions by exposure to the WBG can be found in Appendix F (page 104).




Mean Ratings for All Indicator Questions by Stakeholder Groups on a Scale from 1 to 10

- **Year comparison:** Respondents in the previous FY'14 Country Survey indicated that the World Bank Group's greatest value to Togo was its "*providing financial resources*" (56%) and "*strategy formulation*" (47%).





Greatest Weakness

- **Year comparison:** Respondents in the previous FY'14 Country Survey indicated that the World Bank Group's greatest weaknesses in its work in Togo were being "*its process being too complex*" (25%), "*too influenced by developed countries*" (20%), and "*not adequately sensitive to political/social realities in Togo*" (20%).



Effectiveness of WBG's Support in Sectoral Areas: Year Comparison⁵





VI. Sectoral Effectiveness (continued)

Drivers of Effectiveness

To determine the key drivers of respondents' ratings of the World Bank Group's overall effectiveness and ratings of its ability to help achieve development results in Togo, bivariate correlational analyses were conducted using respondents' ratings of the twenty-four specific areas of effectiveness.

Correlational analyses, however, are not able to tell us exactly what is causing respondents' ratings of the World Bank Group's overall effectiveness or ratings of its ability to help achieve development results. Rather, these analyses tell us that as ratings of effectiveness in one area increase, respondents' ratings of the WBG's overall effectiveness increase, or as ratings of effectiveness in one area increase, ratings of the WBG's ability to help achieve development results increase. Thus, it can be inferred that respondents' perceptions of effectiveness in one specific area are related to, or drive, respondents' perceptions of the WBG's overall effectiveness or perceptions of the WBG's ability to help achieve development results.

- Overall Effectiveness: Those specific areas with the highest Pearson Product-Moment correlations were determined to be the most closely related to perceptions of the WBG's overall effectiveness, suggesting that ratings of effectiveness in those specific areas are drivers of perceptions of the WBG's overall effectiveness in Togo. The areas determined to be key drivers from these analyses were:
 - The WBG's effectiveness at poverty reduction and
 - The WBG's effectiveness at education.

- Achieving Development Results: Those specific areas with the highest Pearson Product-Moment correlations were determined to be the most closely related to perceptions of the WBG's ability to help achieve development results in Togo, suggesting that ratings of effectiveness in those specific areas are drivers of perceptions of the WBG's ability to help achieve development results. The area determined to be key driver from these analyses was:
 - The WBG's effectiveness at poverty reduction;
 - The WBG's effectiveness at education;
 - The WBG's effectiveness at agriculture and rural development; and
 - The WBG's effectiveness at economic growth.








"To what extent do you believe that the World Bank Group's work and support help the poorest in Togo?" (Respondents chose from a list.)

















Frequency of Consulting WBG Knowledge Work and Activities¹⁰




"How frequently do you consult World Bank Group's knowledge work and activities in the work you do?"









Making the World Bank Group of Greater Value

- **Year comparison:** Respondents in the previous FY'14 Country Survey indicated that the World Bank should “*reach out more to groups outside of Government*” (50%), “*reduce the complexity of obtaining Bank financing*” (28%), “*collaborate more effectively with Government clients*” (27%), and “*increase the level of capacity development in the country*” (25%) to make itself of greater value in Togo.

Percentage of Respondents (N=508)






"In addition to the regular relations with the national government, which TWO of the following groups should the World Bank Group collaborate with more in your country?" (Choose no more than TWO)










"How do you get most of your information about economic and social development issues in Togo? (Choose no more than TWO)" (Respondents chose from a list. Responses combined.)




"How would you prefer to receive information from the World Bank Group?
(Choose no more than TWO)" (Respondents chose from a list. Responses combined.)





Face to Face Interaction with the WBG




"How much face to face access would you like to have with the World Bank Group in Togo (i.e., discussions, meetings, conferences, workshops, training, etc.)?"





"Do you have reliable access to the Internet?"




"Which Internet connection do you use primarily when visiting a World Bank Group website?" (Respondents chose from a list.)


