I. Objectives

This survey was designed to assist the World Bank Group (WBG) in gaining a better understanding of how stakeholders in Mongolia perceive the WBG. The survey explored:

- *General Issues Facing Mongolia*
- *Overall Attitudes toward the World Bank Group*
- *World Bank Group's Effectiveness and Results*
- *The World Bank Group's Knowledge Work and Activities*
- *Working with the World Bank Group*
- *The Future Role of the World Bank Group in Mongolia*
- *Communication and Information Sharing*
- *Background Information*

II. Methodology

From March to May 2017, 509 stakeholders of the WBG in Mongolia were invited to provide their opinions on the WBG's work in the country by participating in a country opinion survey. Participants were drawn from the Office of the President, Prime Minister; office of a minister; office of a parliamentarian; ministries/ministerial departments/implementation agencies; Project Management Units (PMUs) overseeing implementation of WBG projects; consultants/contractors working on WBG-supported projects/programs; local governments; bilateral/multilateral agencies; private sector organizations; private foundations; the financial sector/private banks; NGOs/community based organizations; the media; independent government institutions; trade unions; faith-based groups; youth groups; academia/research institutes/think tanks; the judiciary branch; and other organizations. A total of 266 stakeholders participated in the survey (52% response rate).

Some received and returned the questionnaires via courier or email. Some respondents filled out the survey questionnaire on an independent survey platform, Qualtrics. The others filled out the survey with a representative of the independent research firm. Respondents were asked about: general issues facing Mongolia; their overall attitudes toward the WBG; the WBG's effectiveness and results; the WBG's knowledge work and activities; working with the WBG; the WBG's future role in Mongolia; and the WBG's communication and information sharing.

Every country that engages in the Country Opinion Survey (COS) must include specific indicator questions that will be aggregated for the World Bank Group's annual Corporate Scorecard. These questions are identified throughout the survey report.

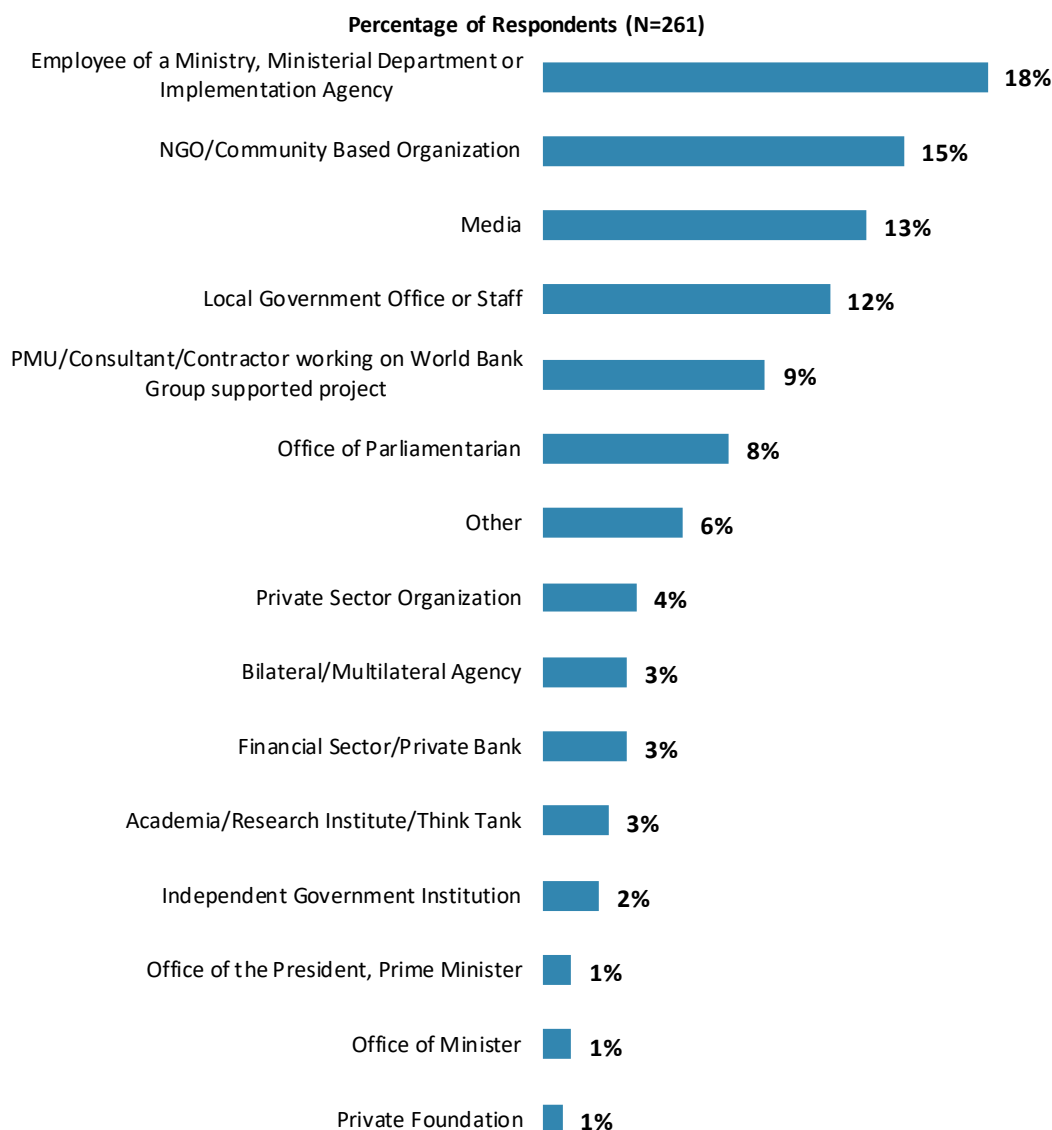
The results in this year's Country Survey were compared to those in the Country Survey conducted in FY'14 (response rate was 69%, N=357). Data were weighted to reach the same stakeholder composition in two years, which allows for year comparisons. Stakeholder groups which were not present in both fiscal years were not included in the comparison. Respondents who belonged to the "other" stakeholder category were not included either. As a result, mean ratings, percentages of respondents, and the total number of respondents in both years are slightly different from those of the original data reported in the FY'14 COS report and the non-weighted data presented in appendices A, B, C, D, and F. For the weighted stakeholder breakdown and year comparison results, please refer to Appendix E (page 90).



III. Demographics of the Sample

Current Position

- For further analyses, respondents from the financial sector/private banks were combined with those from private sector organizations; respondents from NGOs/community based organizations and private foundations were combined in the “CSO” category; and the small number of respondents from the office of the President/Prime Minister/Minister, bilateral/multilateral agencies, independent government institutions, and academia were included in the “Other” category. There were no respondents from trade unions, faith-based groups, youth groups, or the judiciary branch.

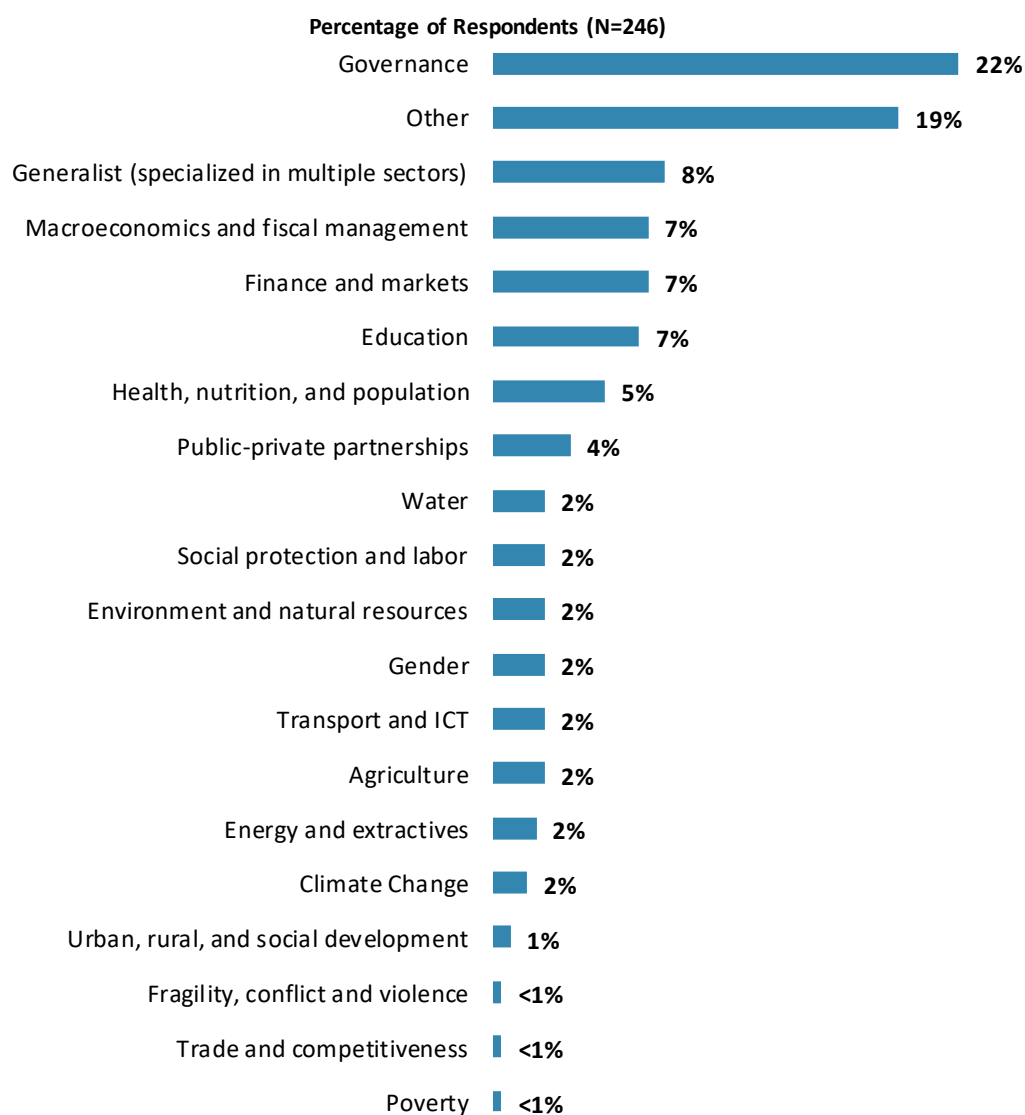


“Which of the following best describes your current position?” (Respondents chose from a list.)

Area of Primary Specialization



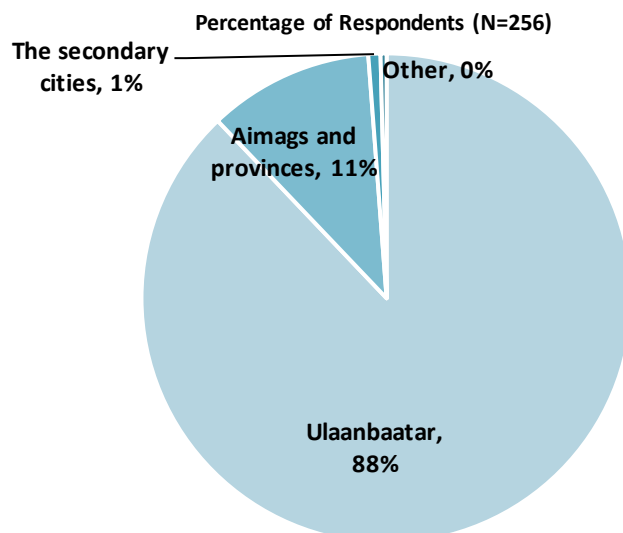

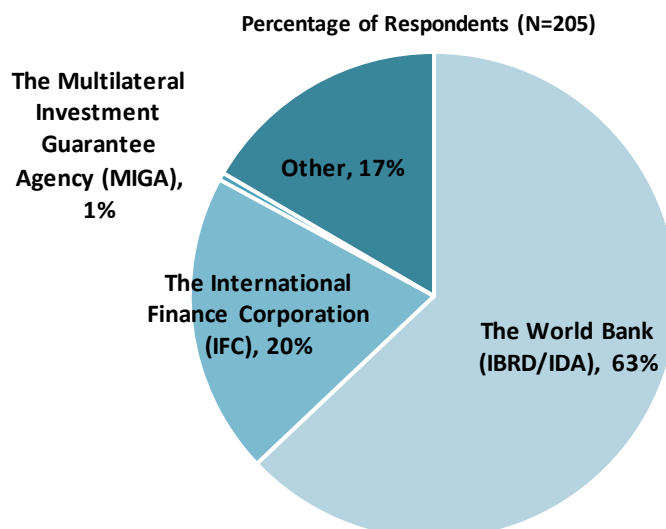

Exposure to Agencies within the World Bank Group



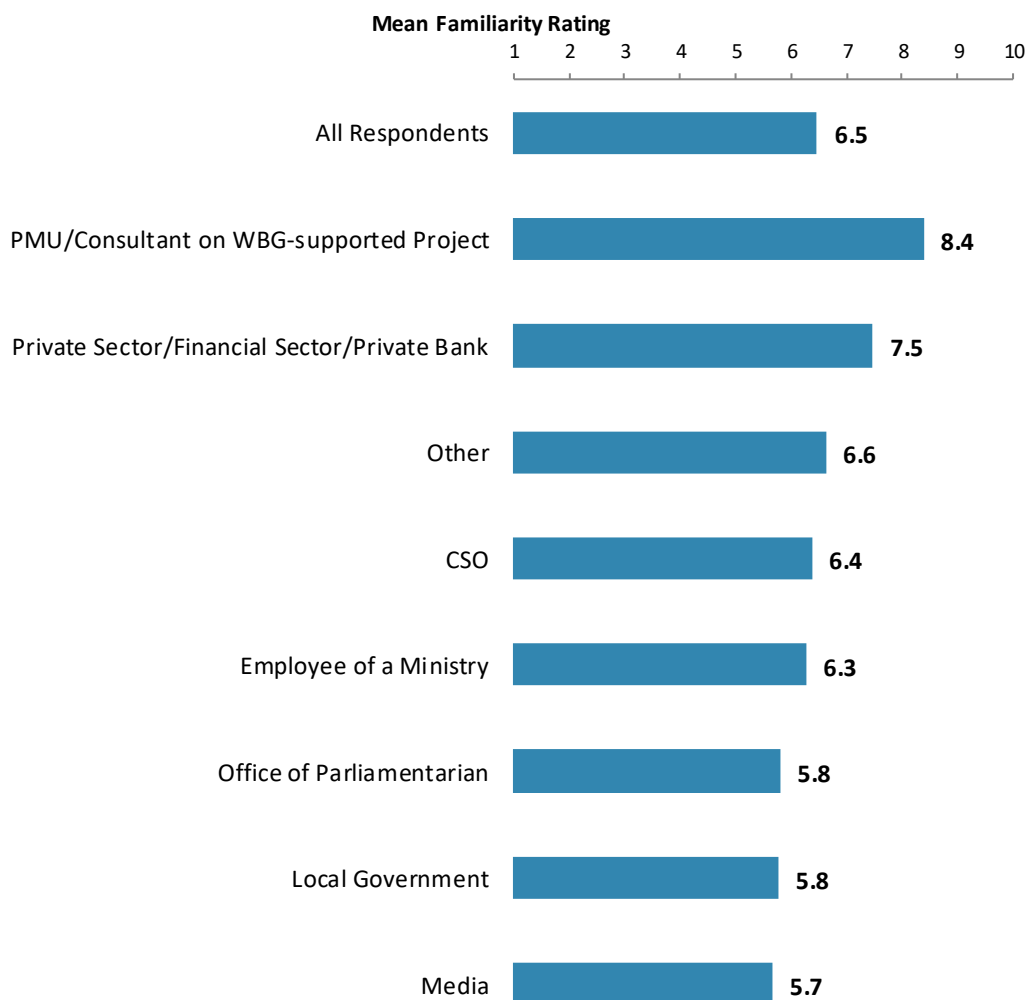
"Which of the following agencies of the World Bank Group do you primarily engage with in Mongolia?" (Respondents chose from a list.)

Familiarity with the World Bank Group

- **Year comparison:** Respondents in this year's Country Survey indicated significantly higher levels of familiarity with the WBG compared to respondents from the FY'14 Country Survey (weighted mean in FY'17 = 6.5; weighted mean in FY'14 = 5.7)¹.
- Respondents' levels of familiarity with the WBG were significantly, strongly correlated with their ratings of the WBG's overall effectiveness in Mongolia, and significantly, moderately correlated with the extent to which the WBG plays a relevant role in development in Mongolia, and the extent to which the WBG contributes to the country's development results.

(1 - "Not familiar at all", 10 - "Extremely familiar")

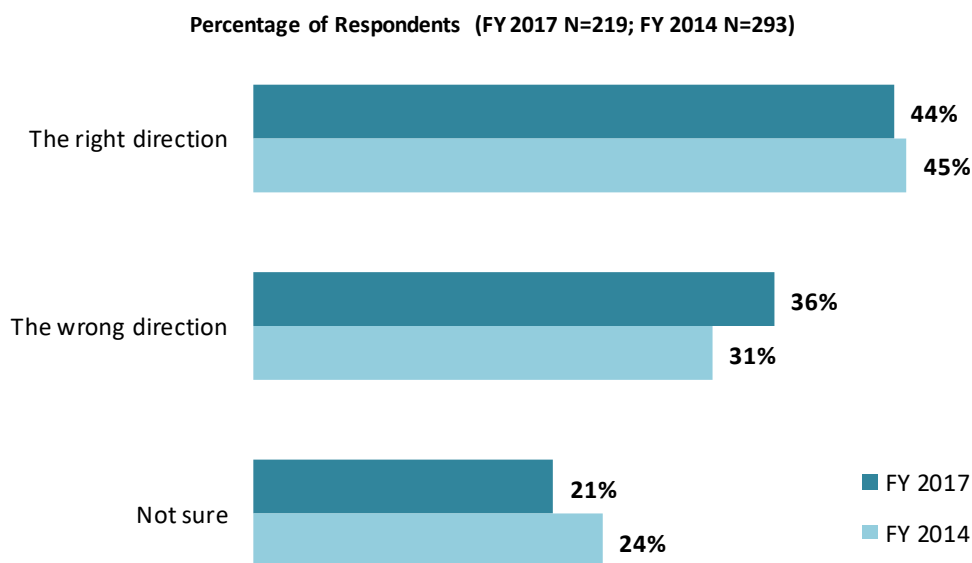

IV. General Issues Facing Mongolia

Headed in the Right Direction²

- **Year comparison:** This year's respondents and the respondents in the FY'14 Country Survey had statistically similar view of the direction Mongolia is headed in.
- **Stakeholder groups:** In this year's Country Survey, respondents from the local governments were significantly more likely to indicate that Mongolia is headed in the right direction, while respondents from the media were significantly less positive about the prospect of Mongolia.

(Respondents chose from a list.) (Note: percentages may not total 100 due to rounding)

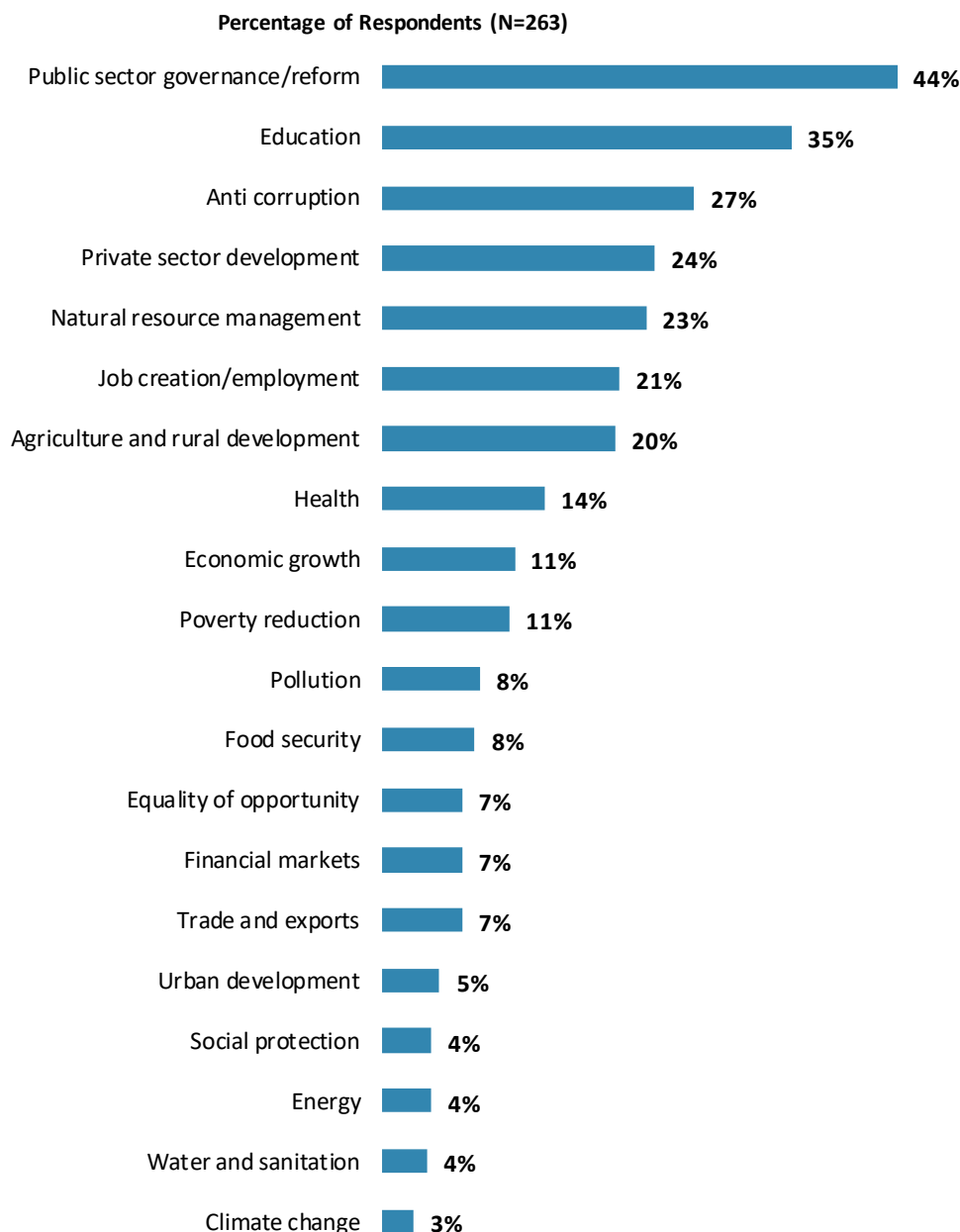

- **Year comparison:** Respondents in the previous FY'14 Country Survey indicated that the most important development priorities in Mongolia were “*public sector governance/reform*” (36%) and “*education*” (33%).



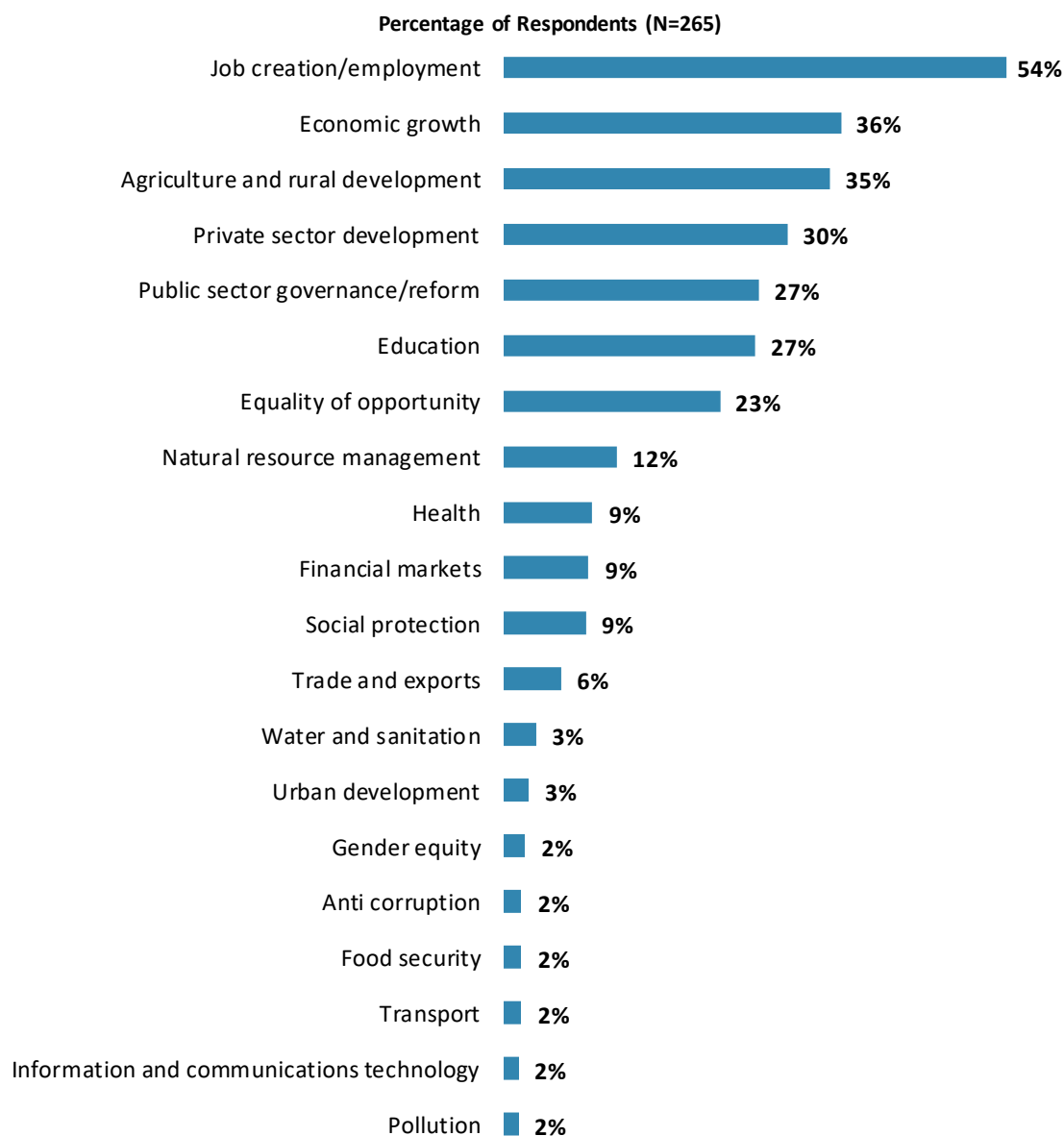

- **Year comparison:** In the previous FY'14 Country Survey, respondents indicated that the greatest contributors to poverty reduction in Mongolia were “*job creation/employment*” (43%), “*domestic private sector development*” (33%), “*education*” (33%), and “*rural development*” (30%).



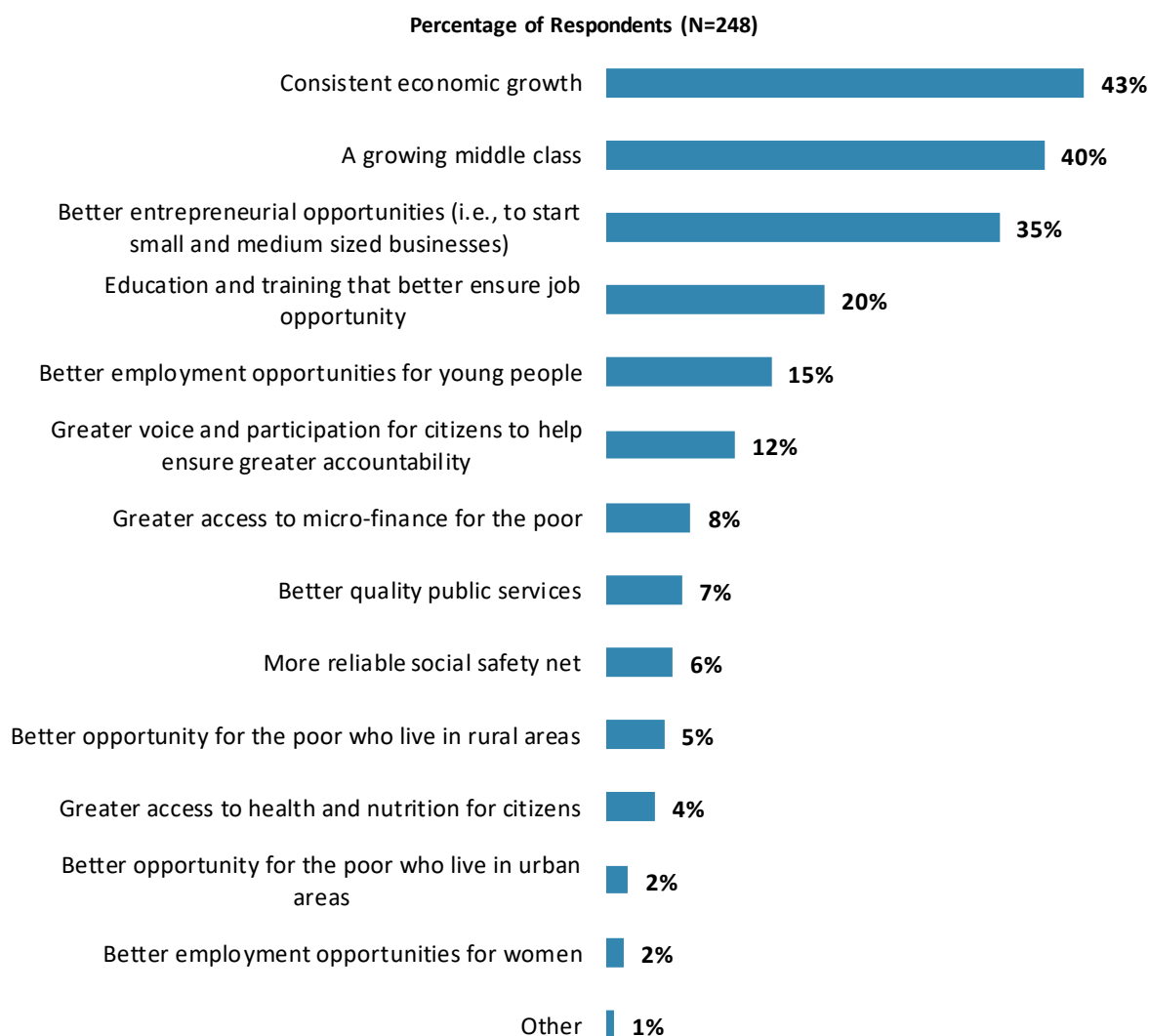

- **Year comparison:** In the previous FY’14 Country Survey, respondents indicated that “shared prosperity” can be best illustrated in Mongolia through “*consistent economic growth*” (30%), “*better entrepreneurial opportunities*” (28%), “*better employment opportunities for young people*” (26%), and “*a growing middle class*” (24%).



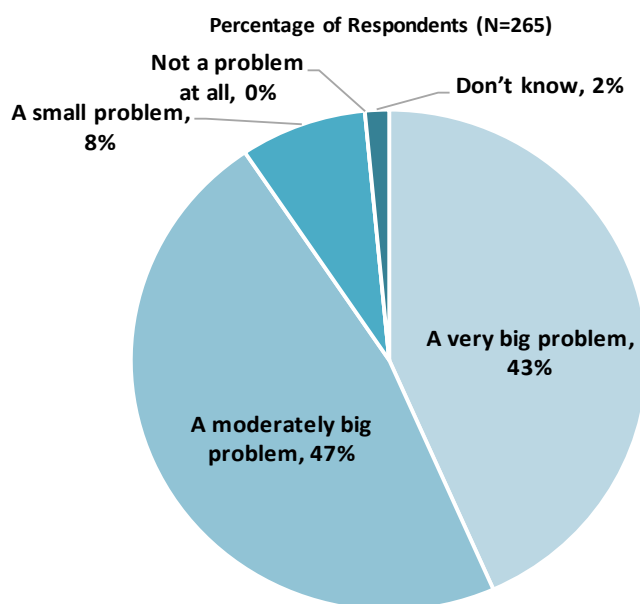

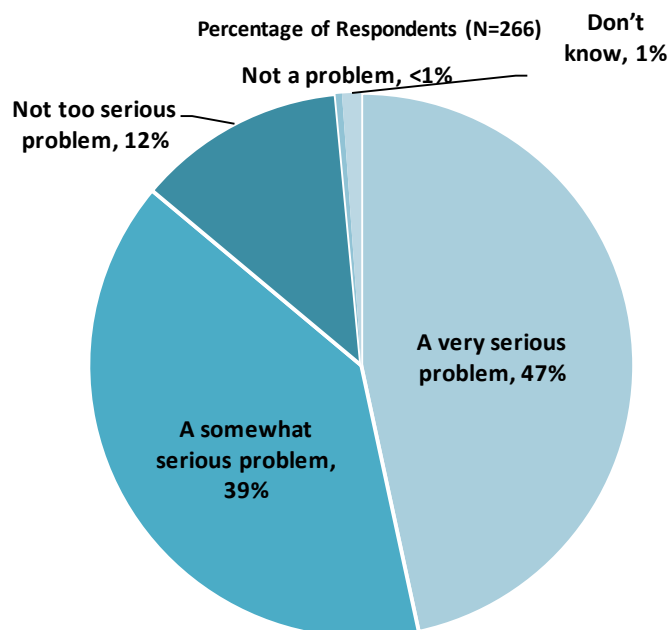

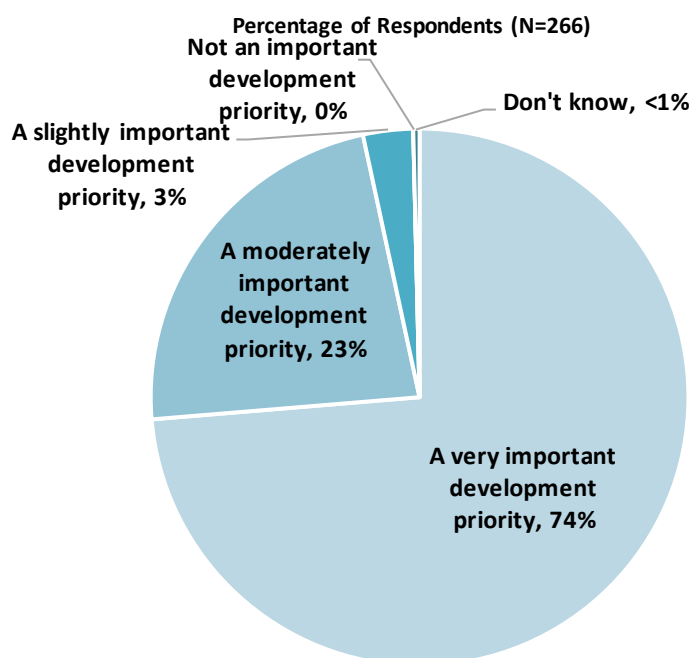


"In your view, is global climate change a very serious problem, somewhat serious, not too serious, or not a problem?" (Respondents chose from a list.)

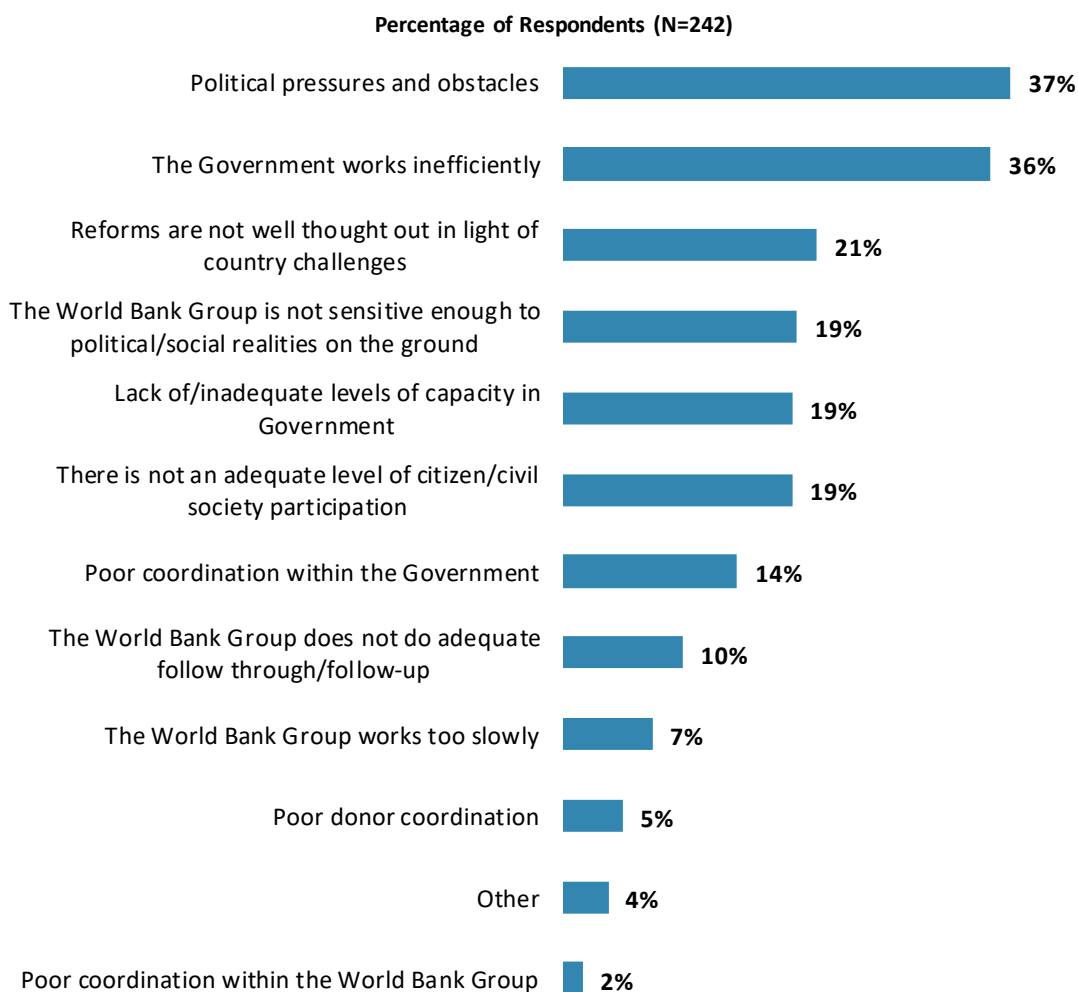

V. Overall Attitudes toward the World Bank Group

Attributing Failed/Slow Reform Efforts

- **Year comparison:** Respondents in the previous FY'14 Country Survey most often attributed failed or slow World Bank Group assisted reform efforts to that *"there is not an adequate level of citizen/civil society participation"* (37%), *"lack of/inadequate levels of capacity in government"* (25%), and *"the government working inefficiently"* (23%).



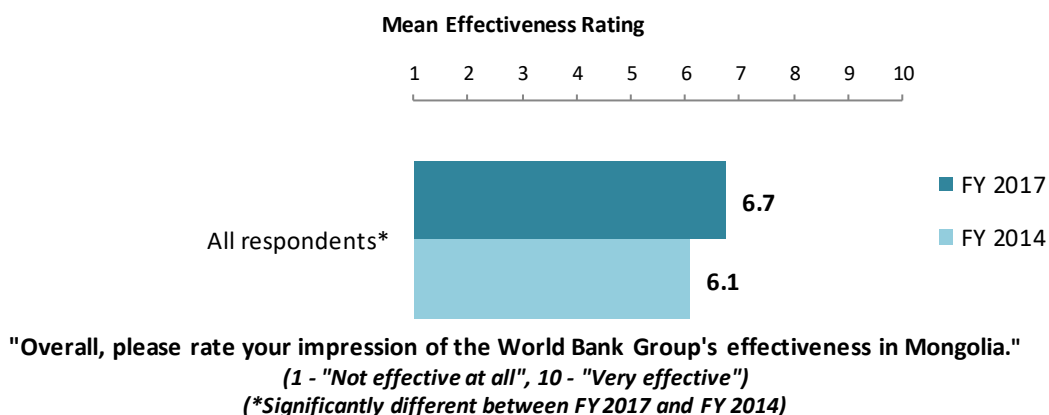
"When World Bank Group assisted reform efforts fail or are slow to take place, which of the following would you attribute this to? (Choose no more than TWO)"

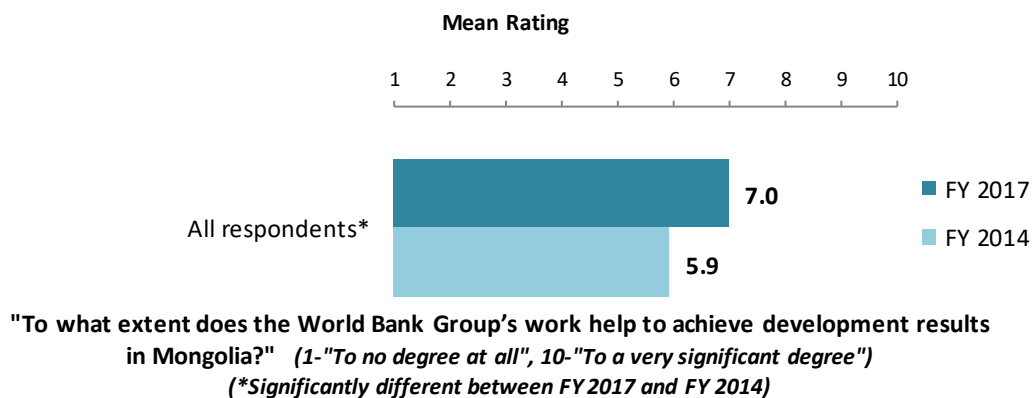

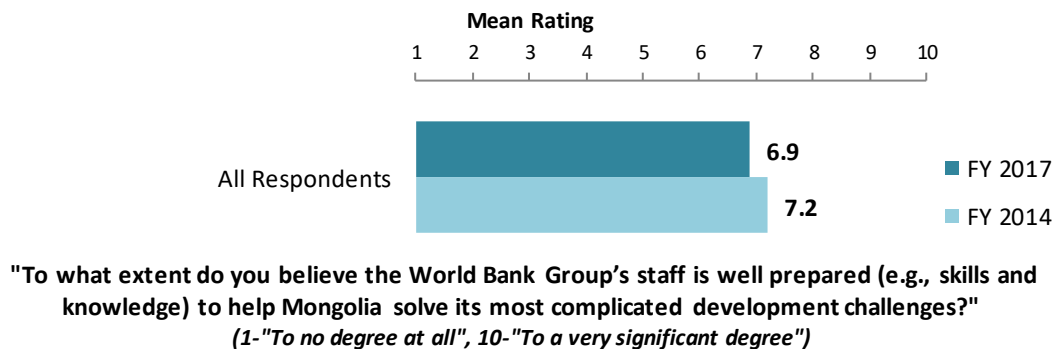

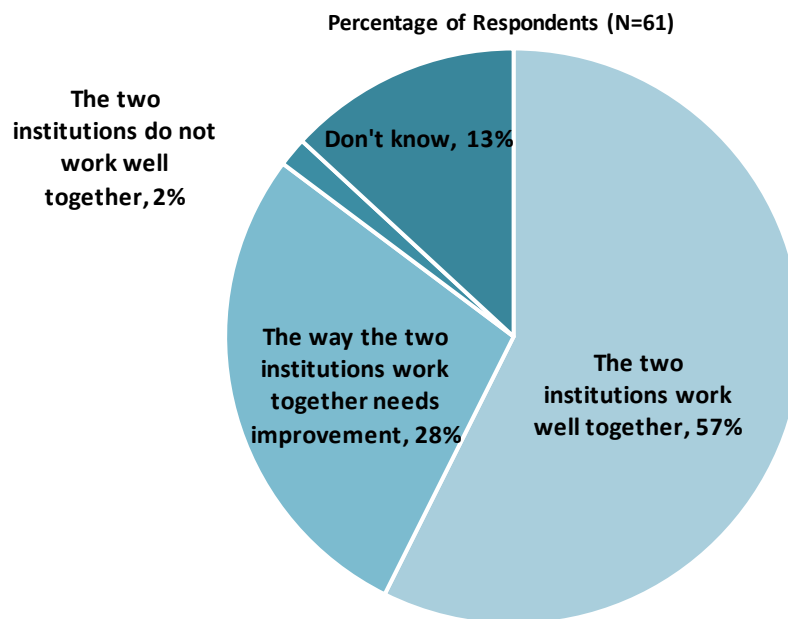

"If your projects involved both the World Bank and the IFC, what was your view on the two institutions working together in Mongolia?" (Respondents chose from a list.)

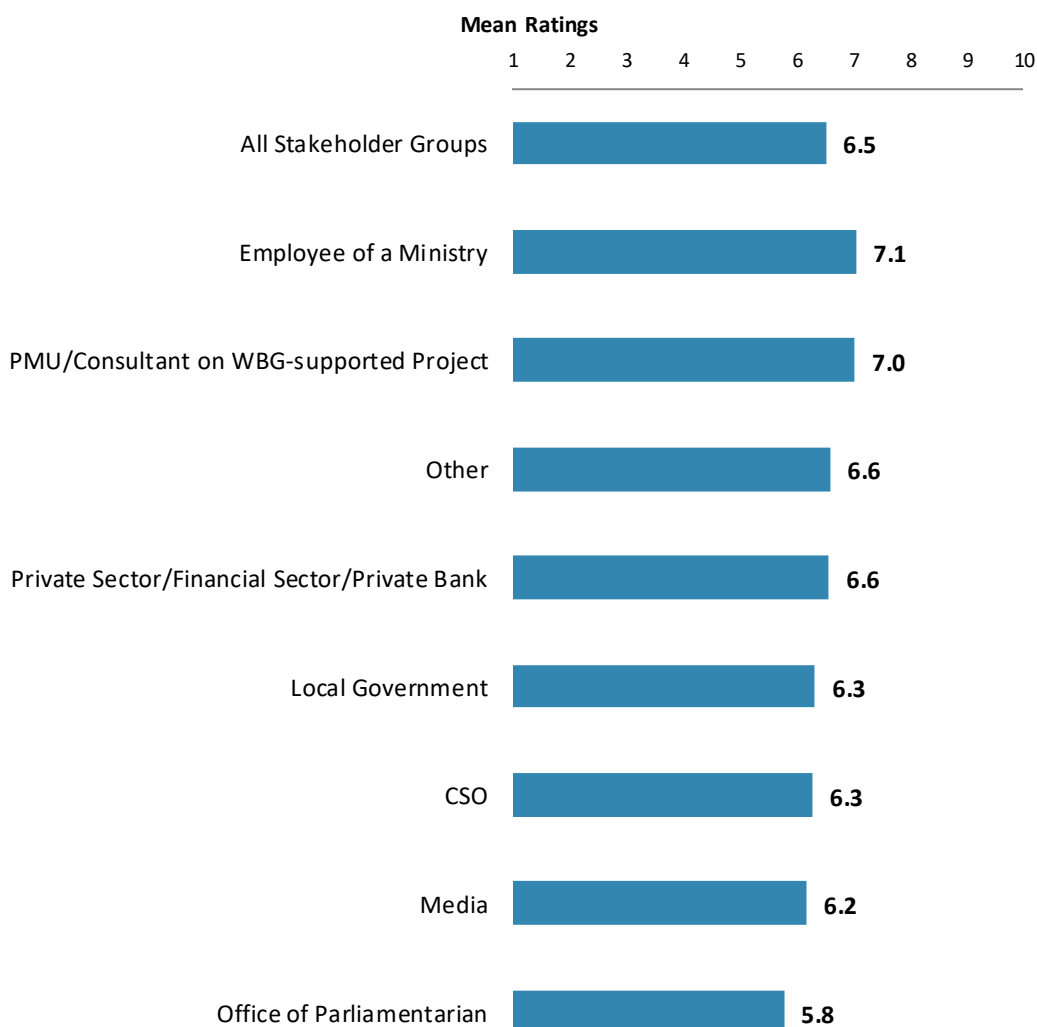

- **Collaboration:** Respondents who collaborated with the WBG gave significantly higher aggregated mean ratings for the twenty-six COS indicator questions, compared to respondents who do not work with the WBG.



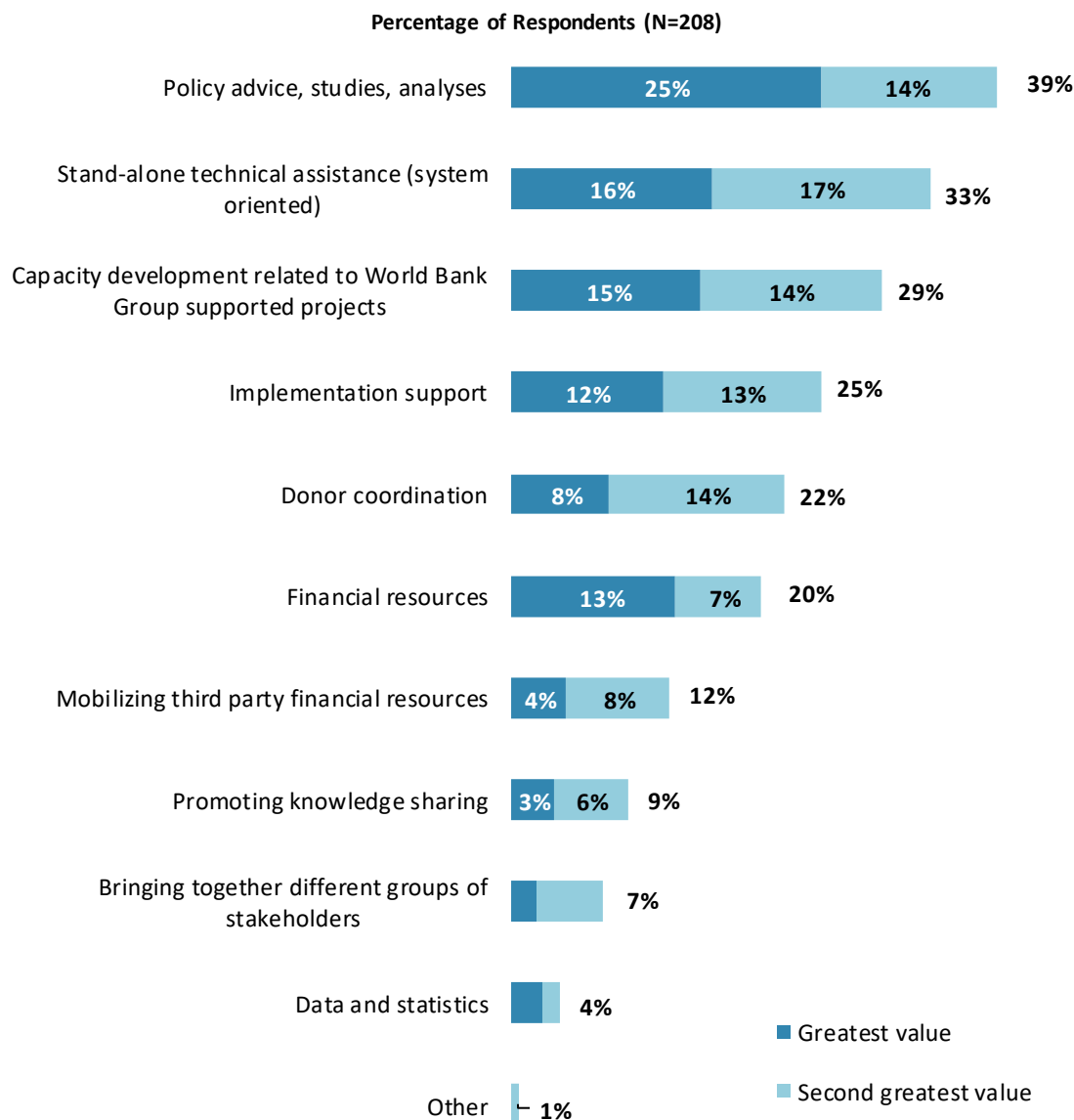
Mean Ratings for All Indicator Questions by Stakeholder Groups on a Scale from 1 to 10

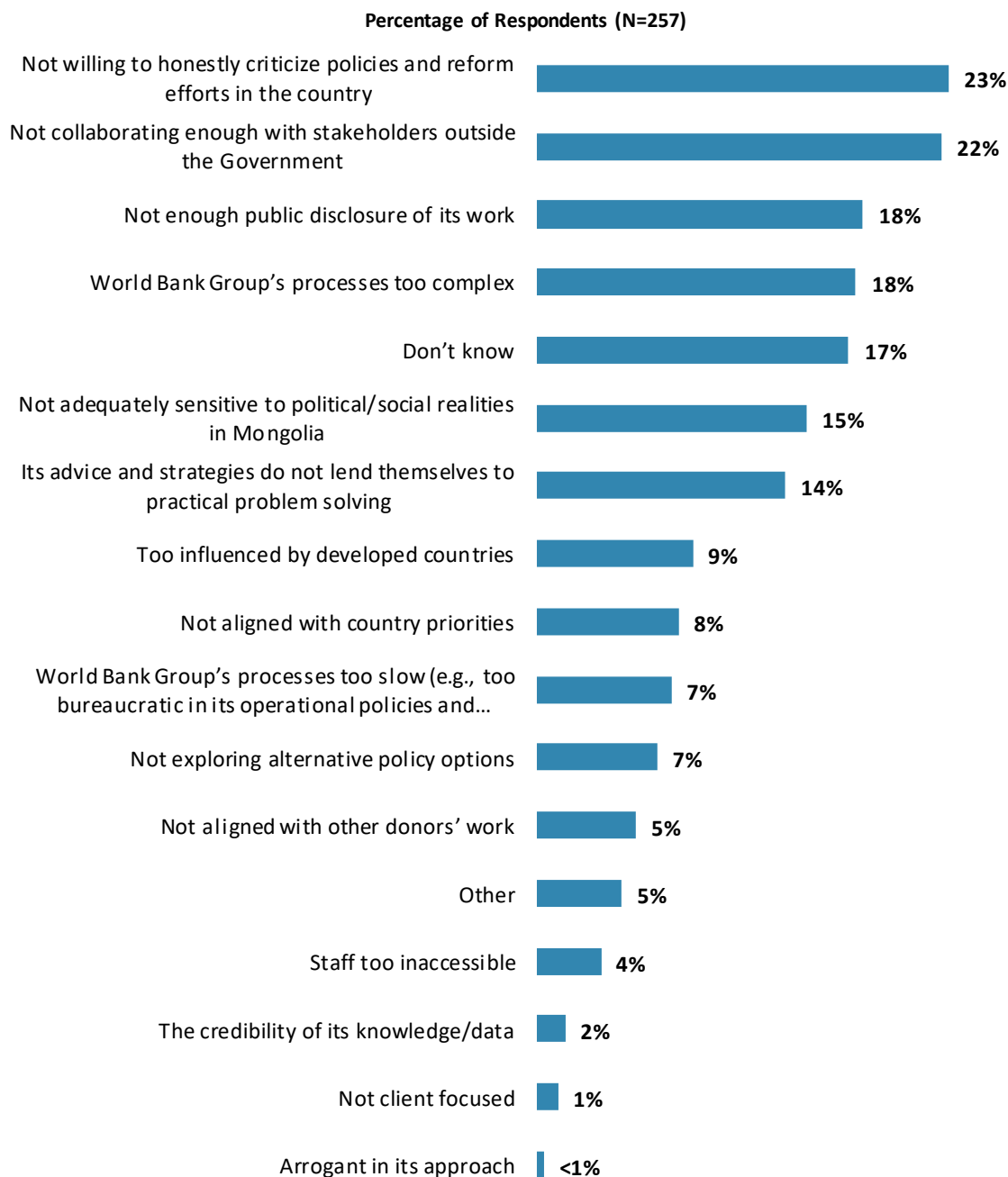
"When thinking about the World Bank Group's role, which activity do you believe is of greatest VALUE and which activity is of second greatest value in Mongolia?"

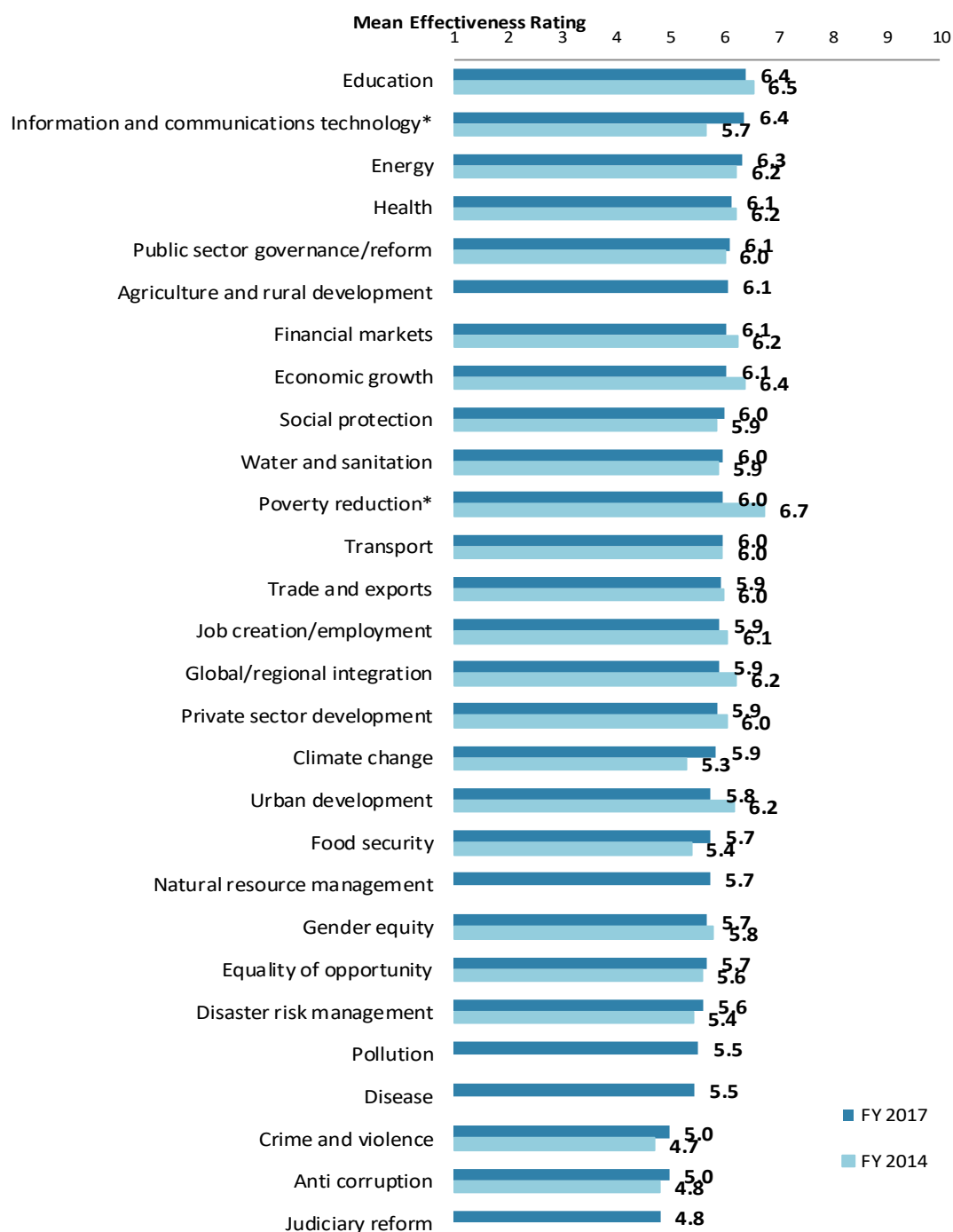

Effectiveness of WBG's Support in Sectoral Areas: Year Comparison⁵



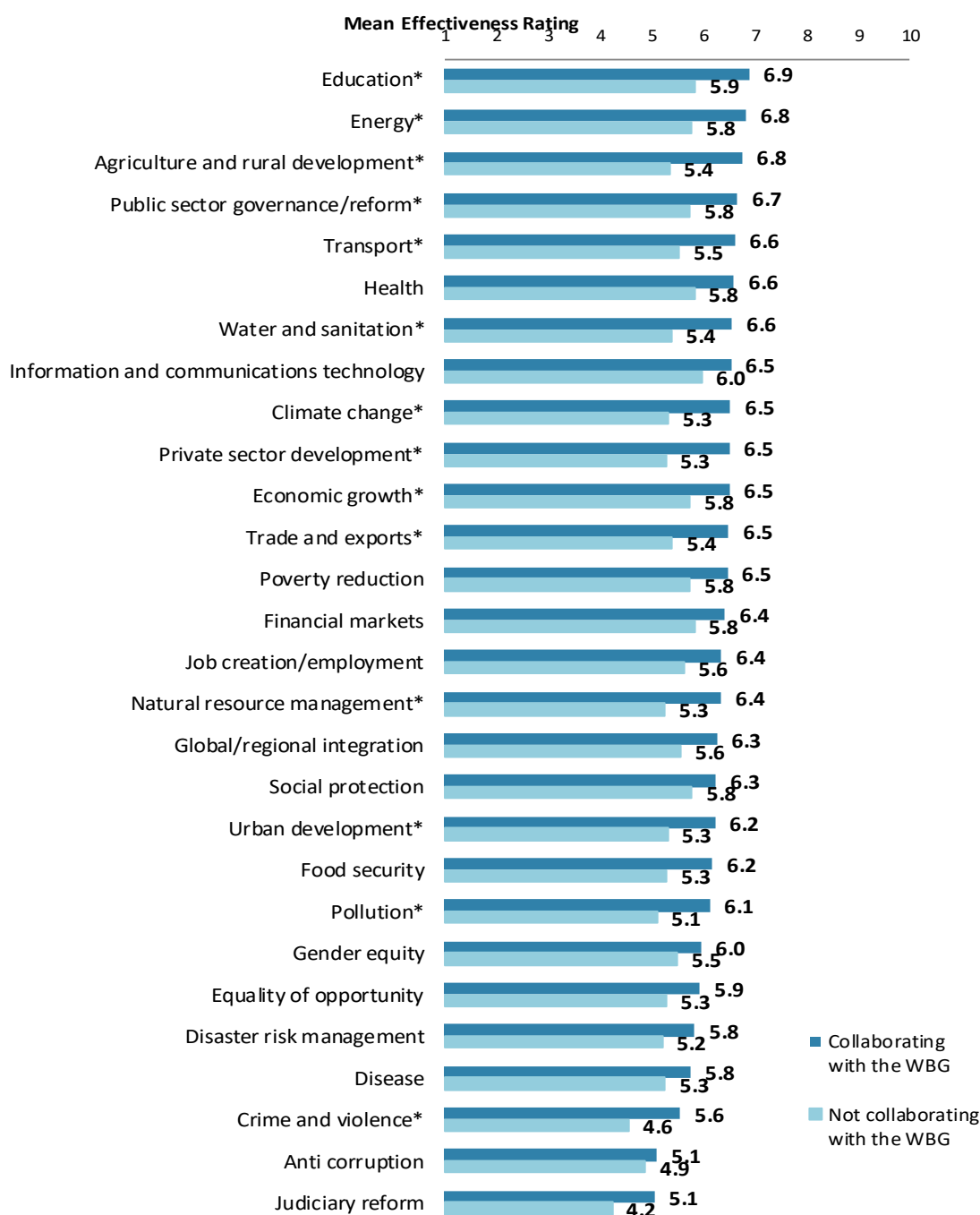

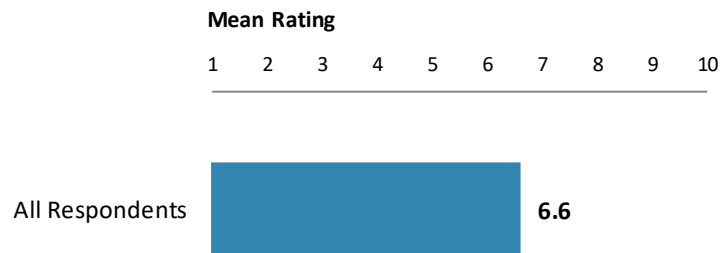

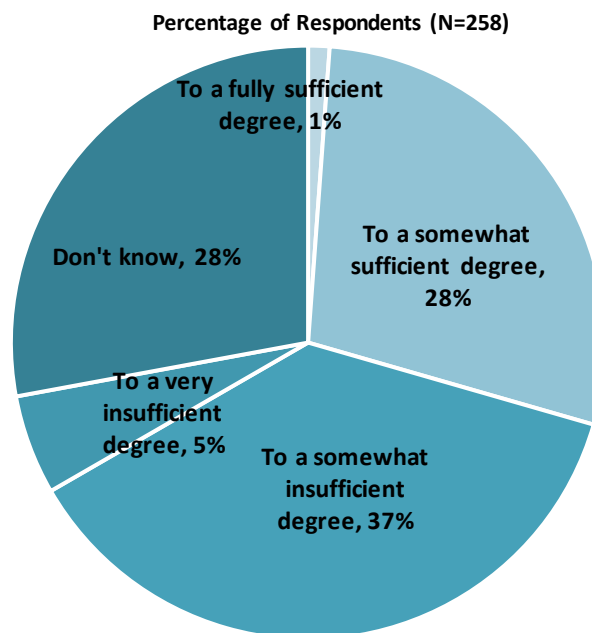

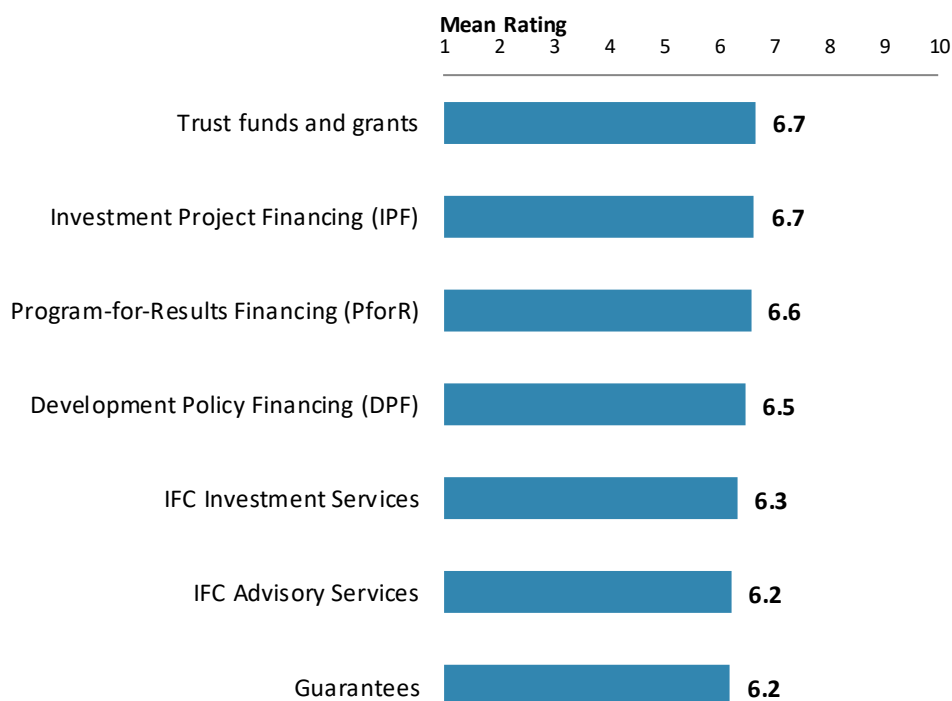


"To what extent do you believe that the World Bank Group's work and support help the poorest in Mongolia?" (Respondents chose from a list.)

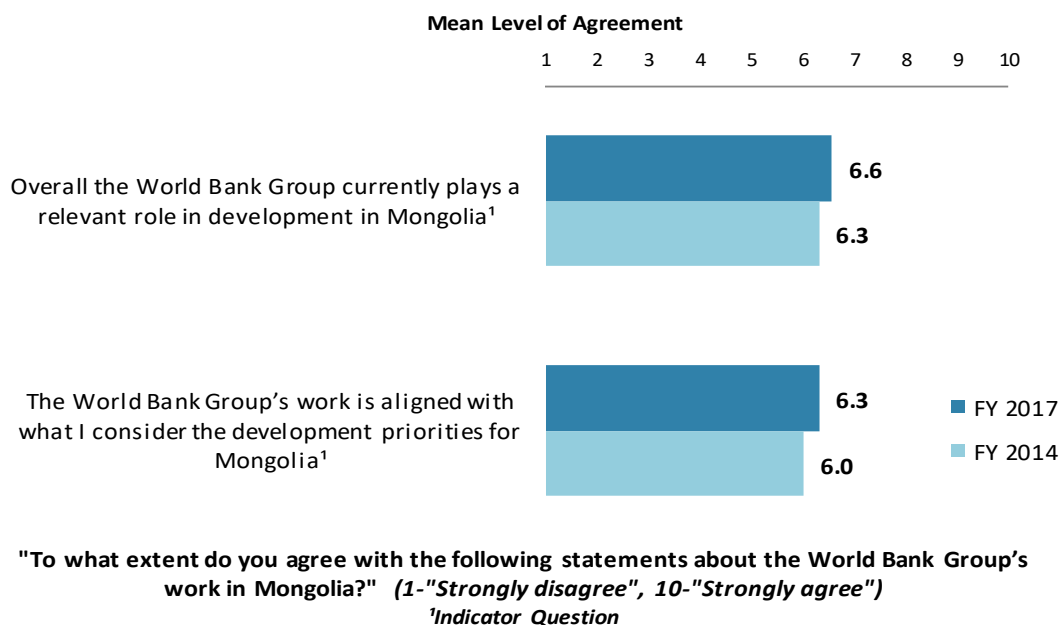


"How EFFECTIVE do you believe the following World Bank Group's instruments are in supporting the Mongolia Government's efforts to reduce poverty?"

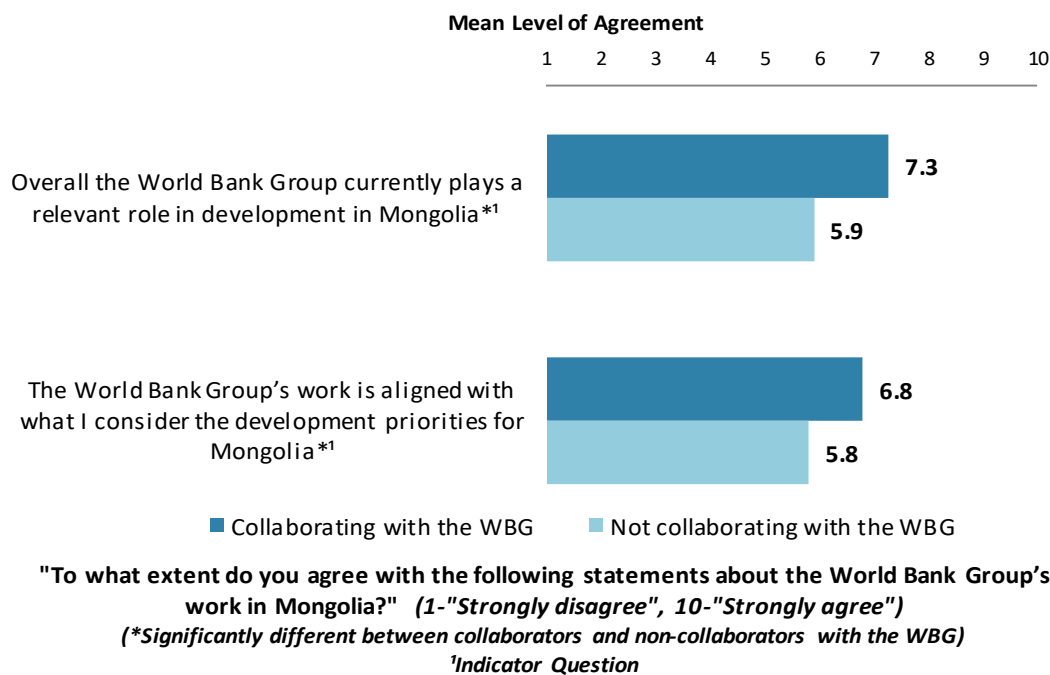

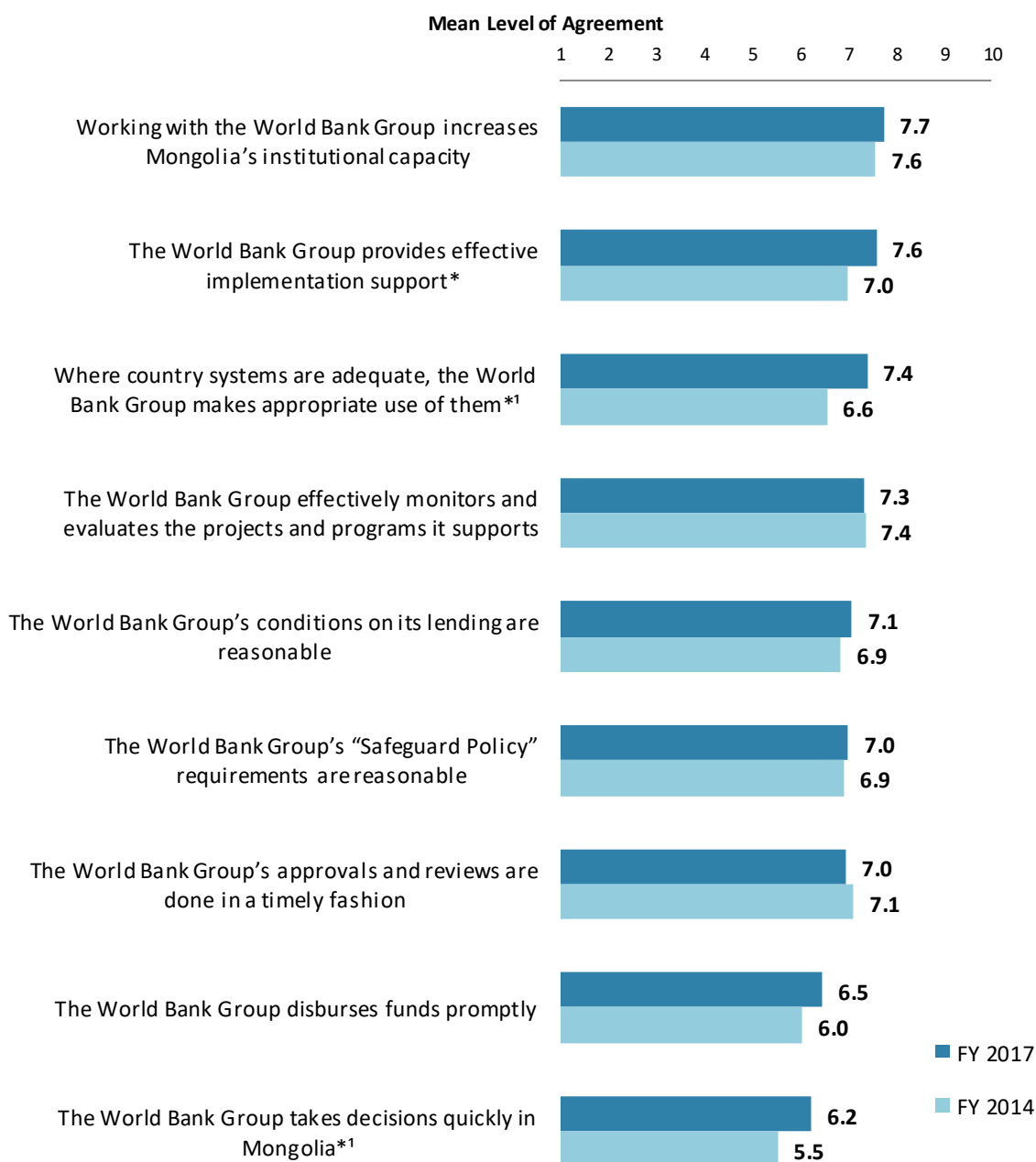

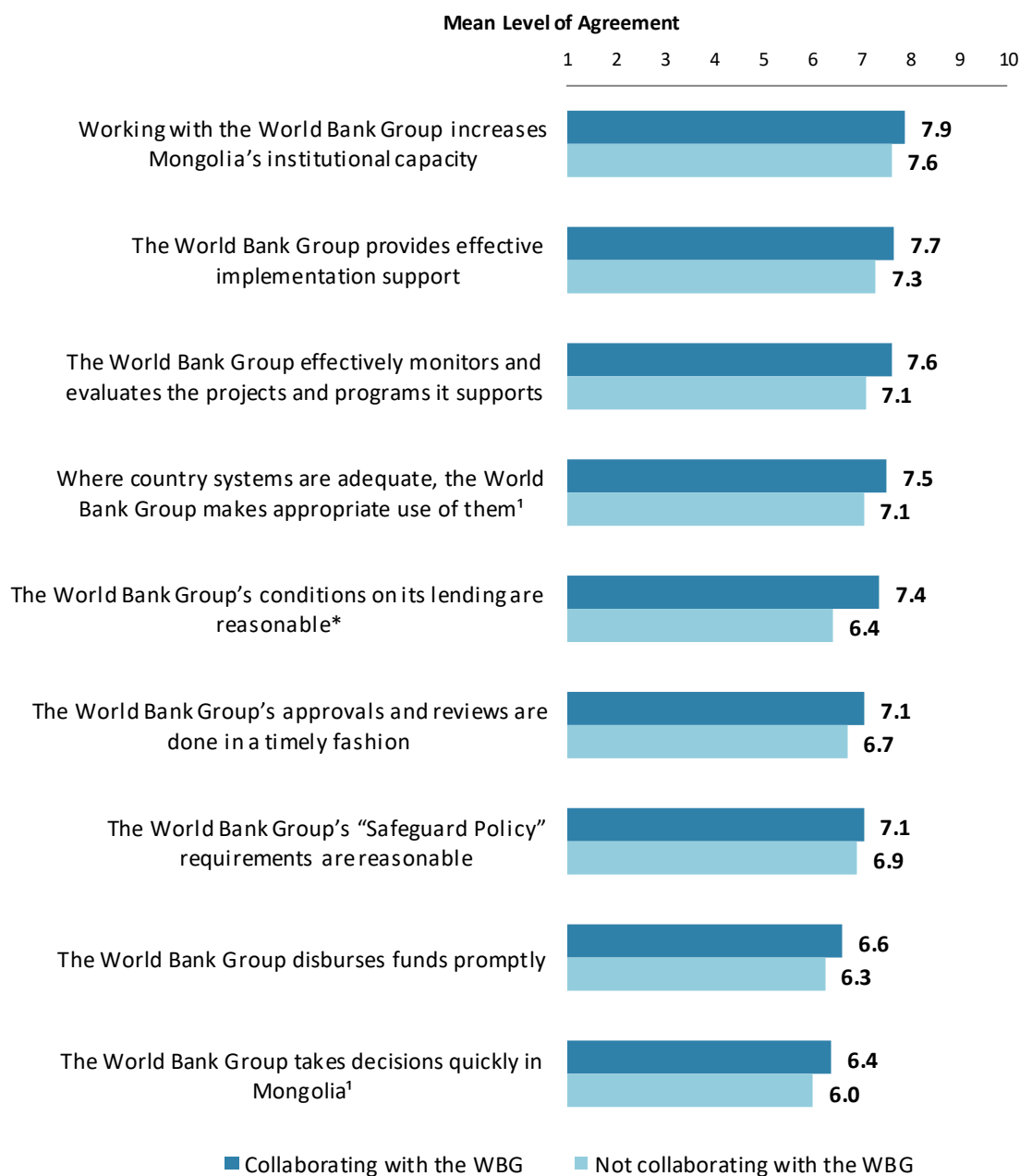

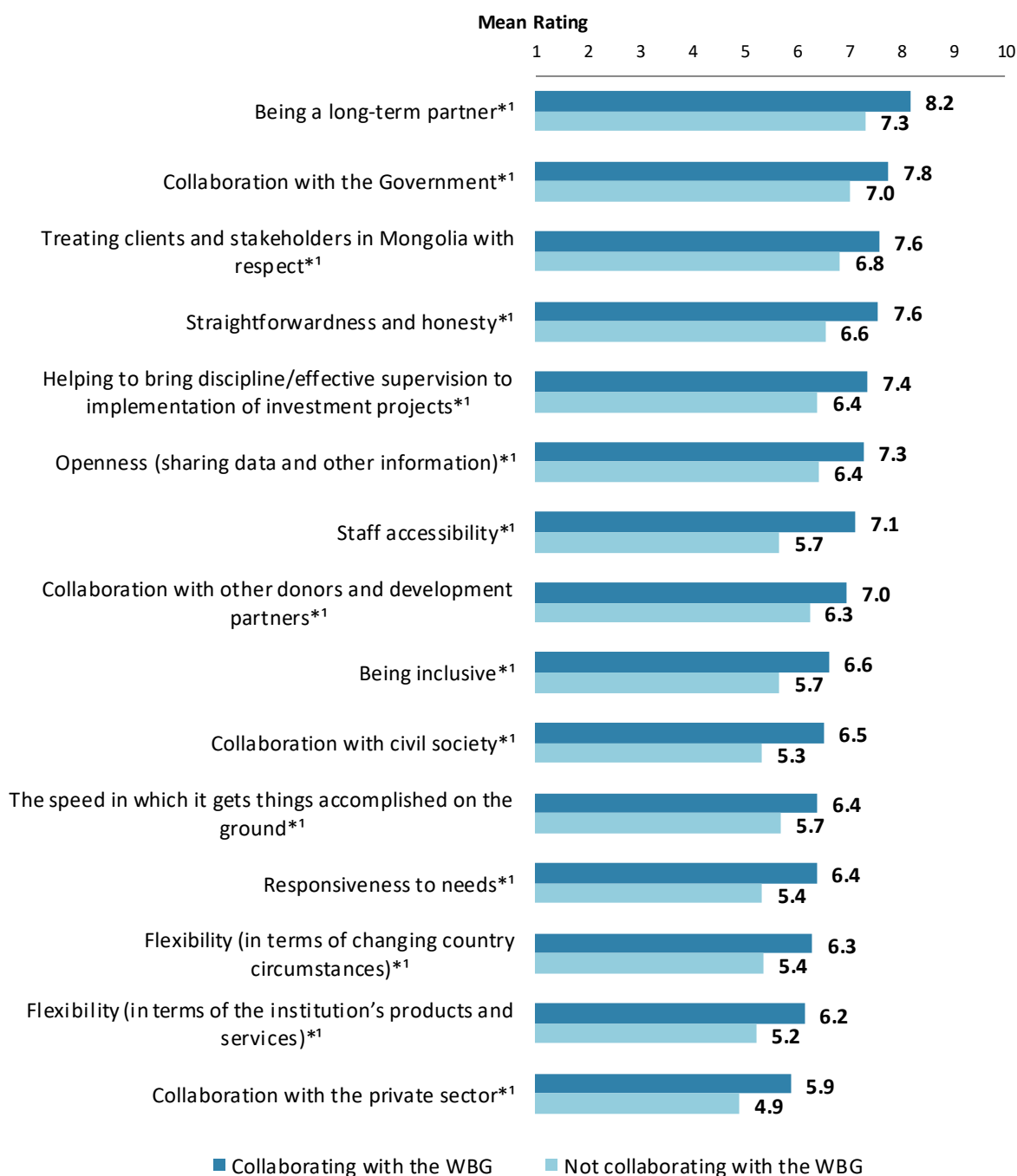

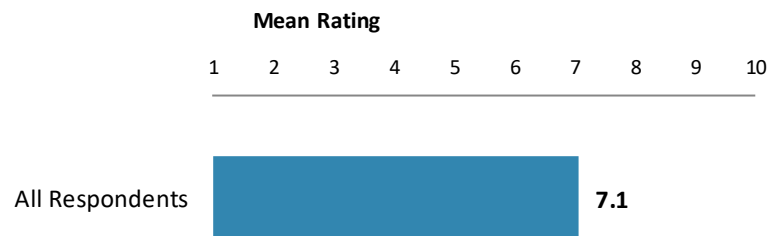

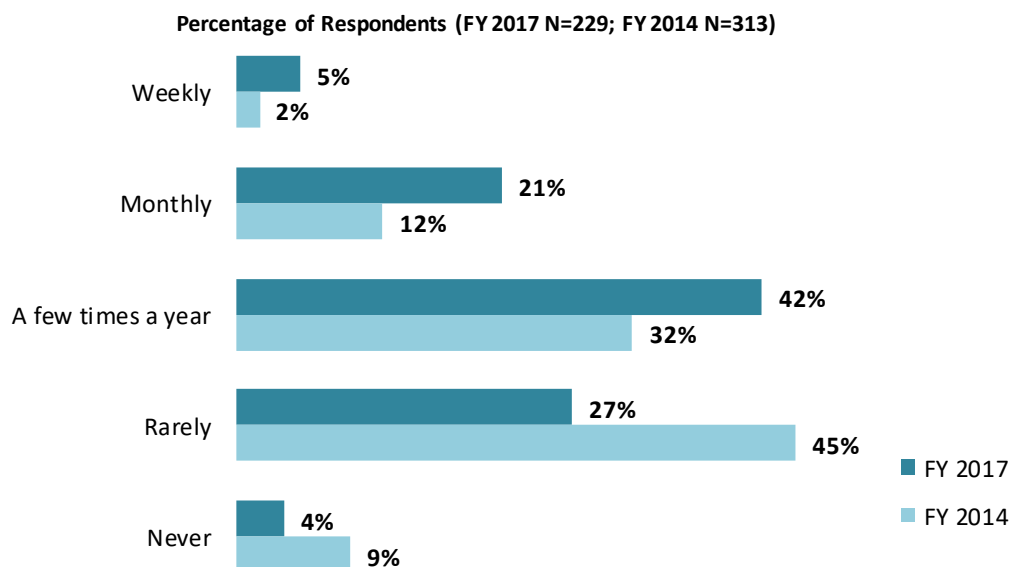
"To what extent do you believe the World Bank Group measures and corrects its work in real time in Mongolia?" (1-"To no degree at all", 10-"To a very significant degree")

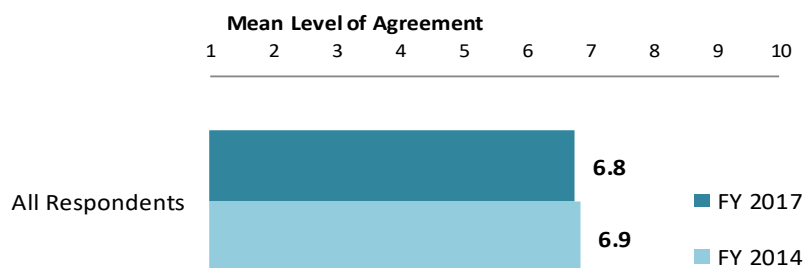
"How frequently do you consult World Bank Group's knowledge work and activities in the work you do?"

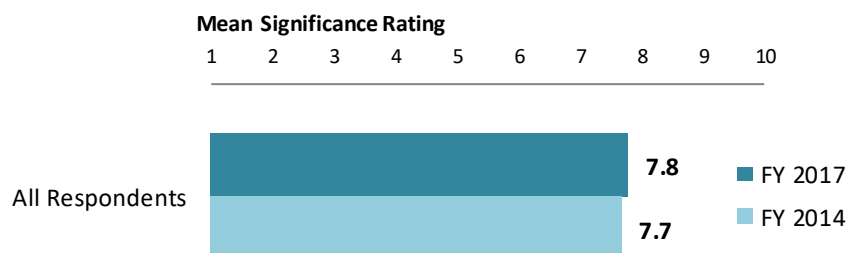

Meeting Mongolia' Knowledge Needs¹¹ (Indicator Question)



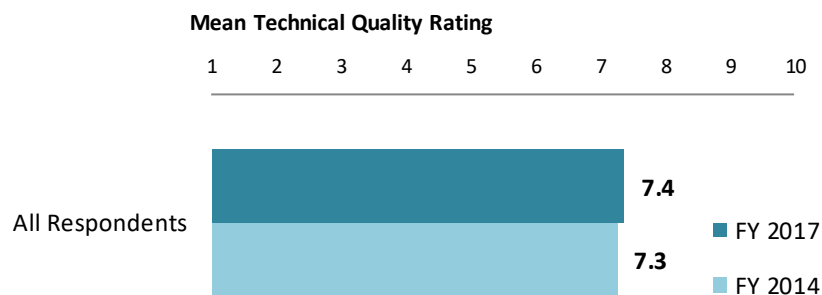

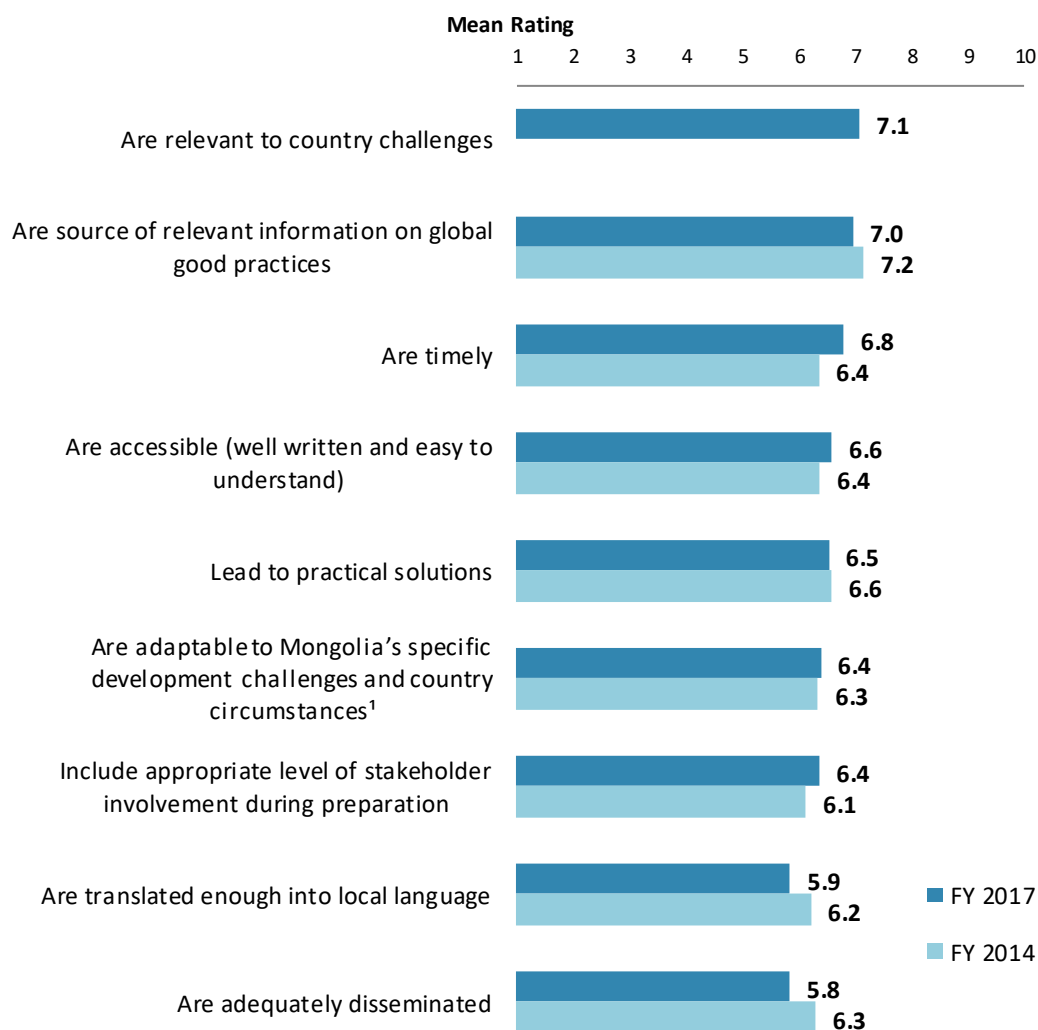

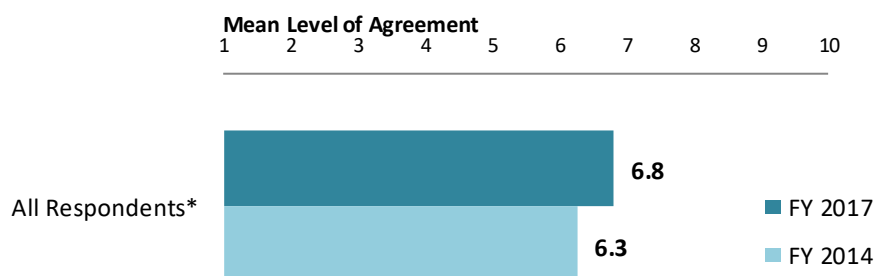

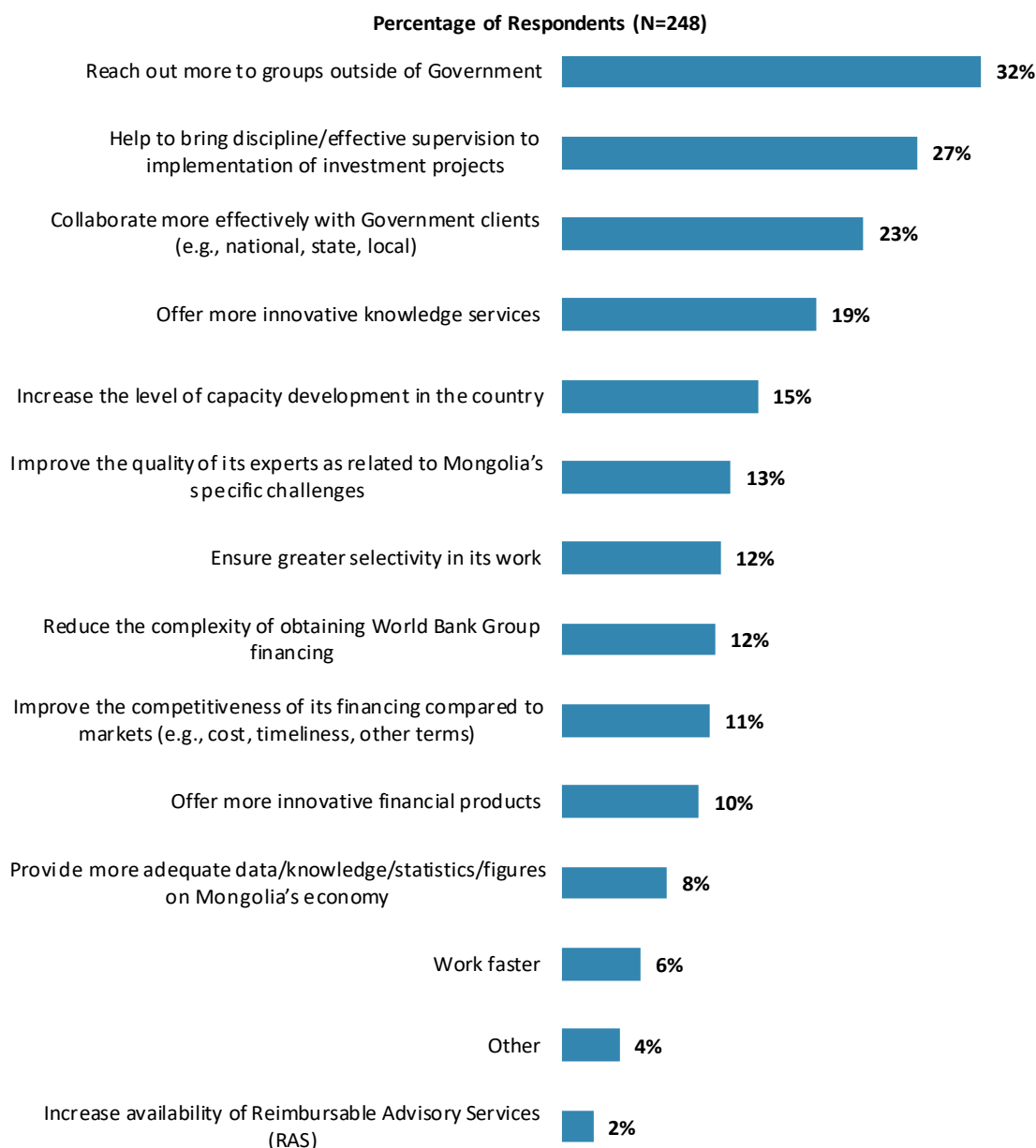

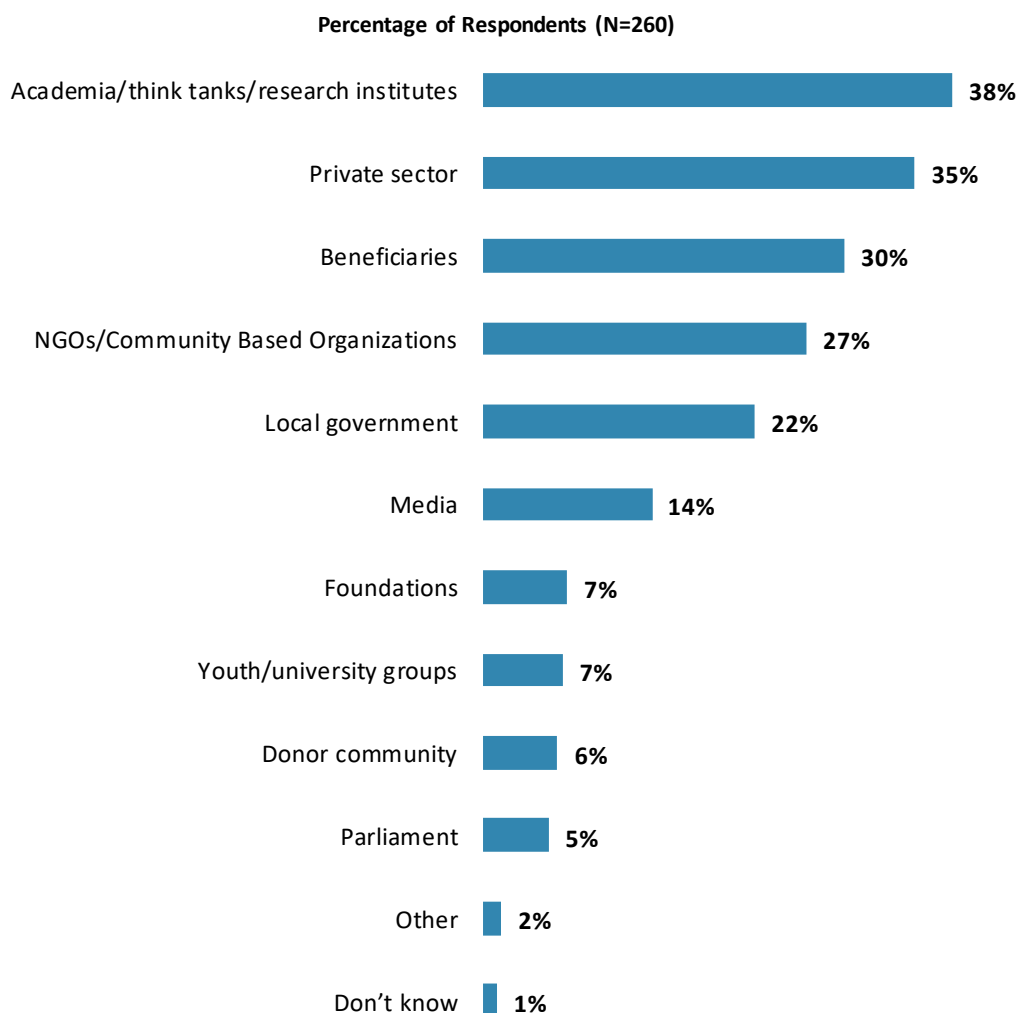

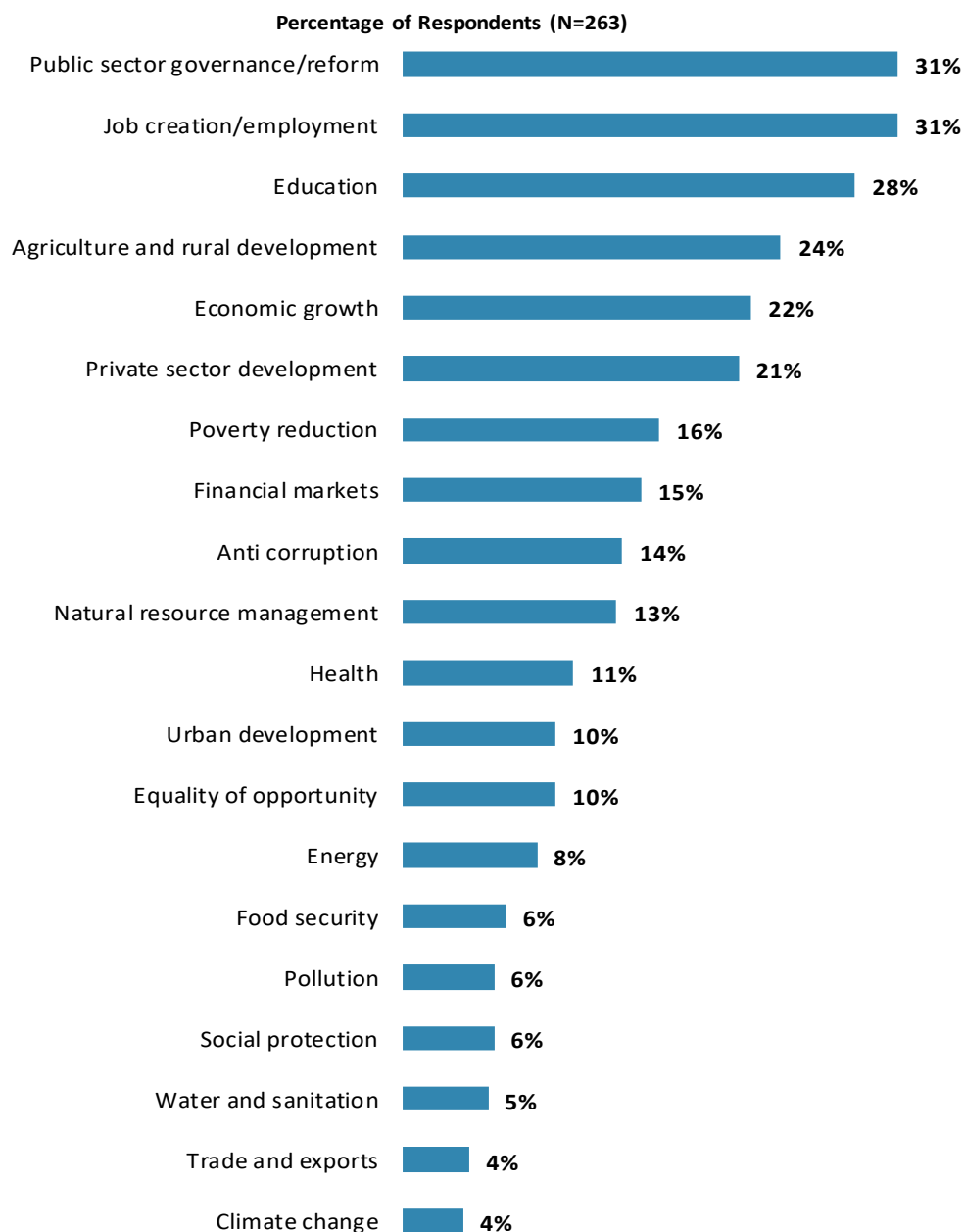
"In addition to the regular relations with the national government, which TWO of the following groups should the World Bank Group collaborate with more in your country?"

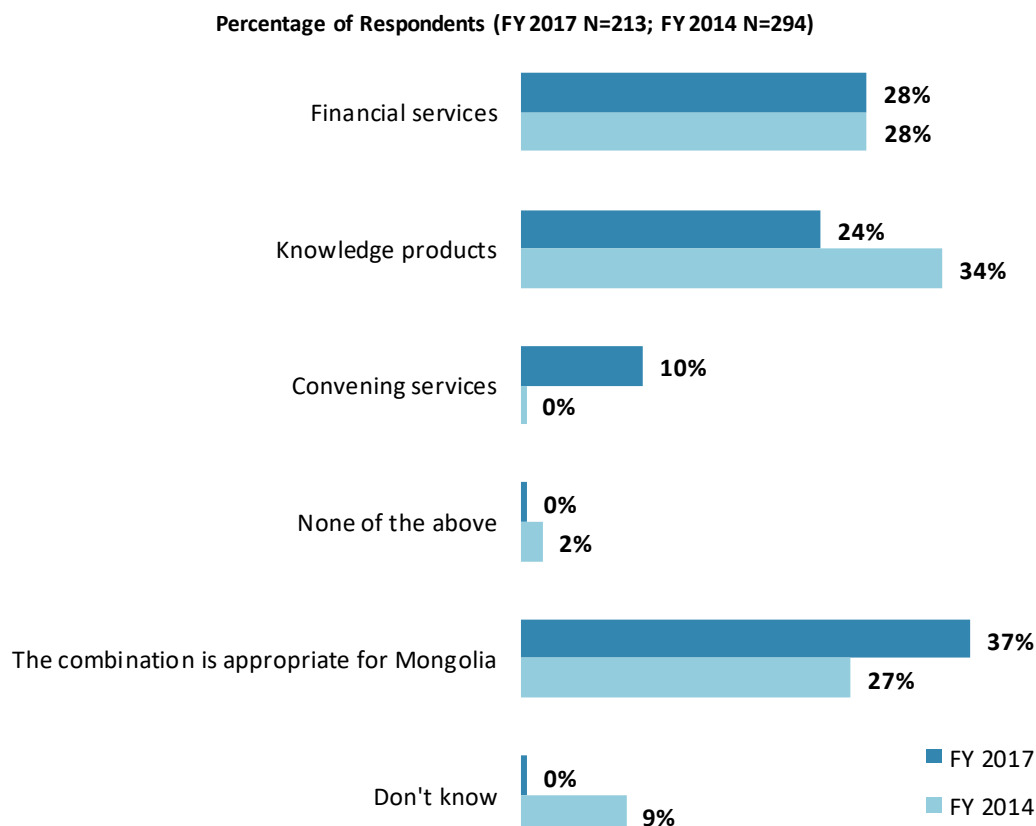

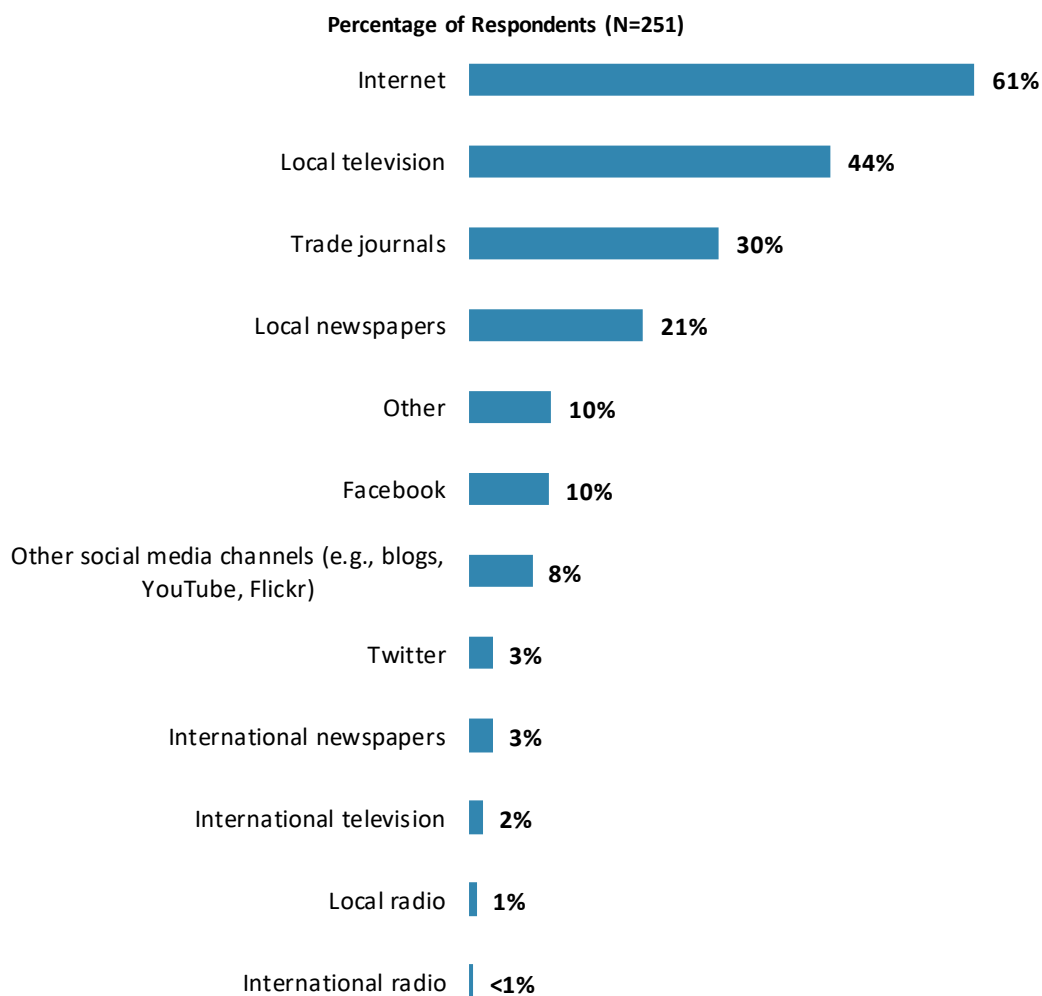

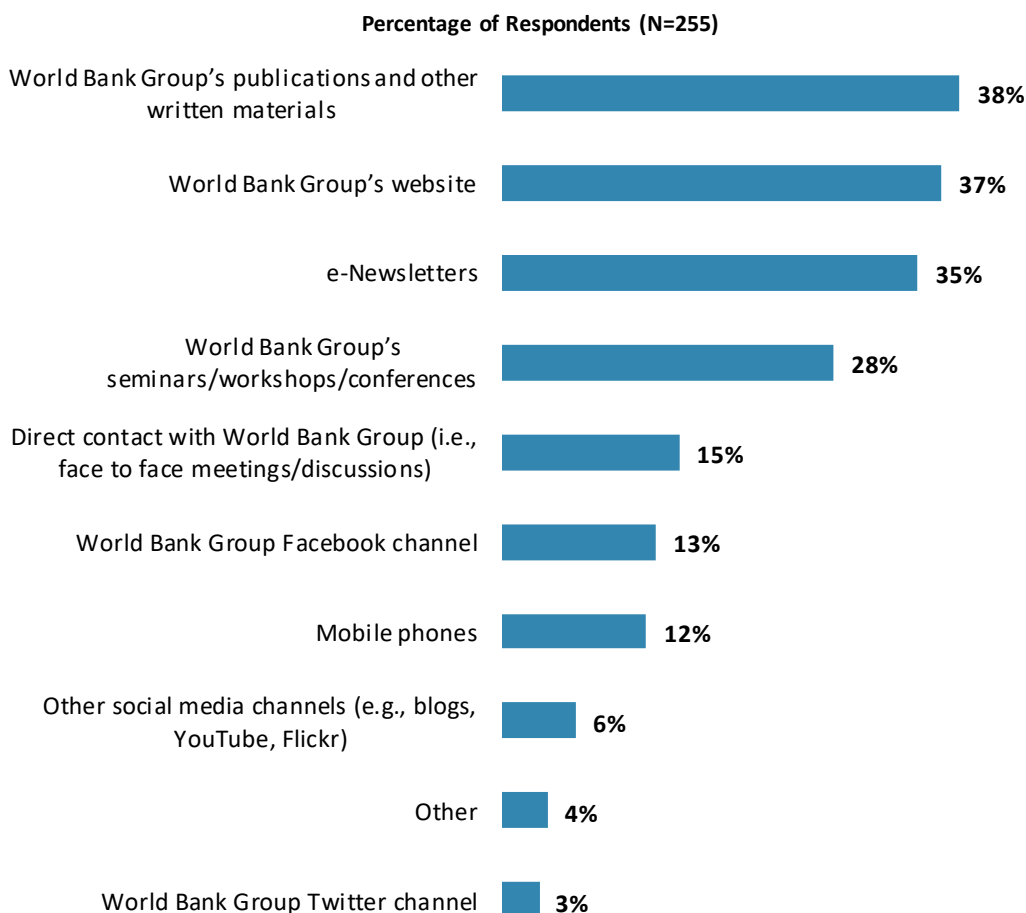
"How do you get most of your information about economic and social development issues in Mongolia? (Choose no more than TWO)" (Respondents chose from a list. Responses combined.)

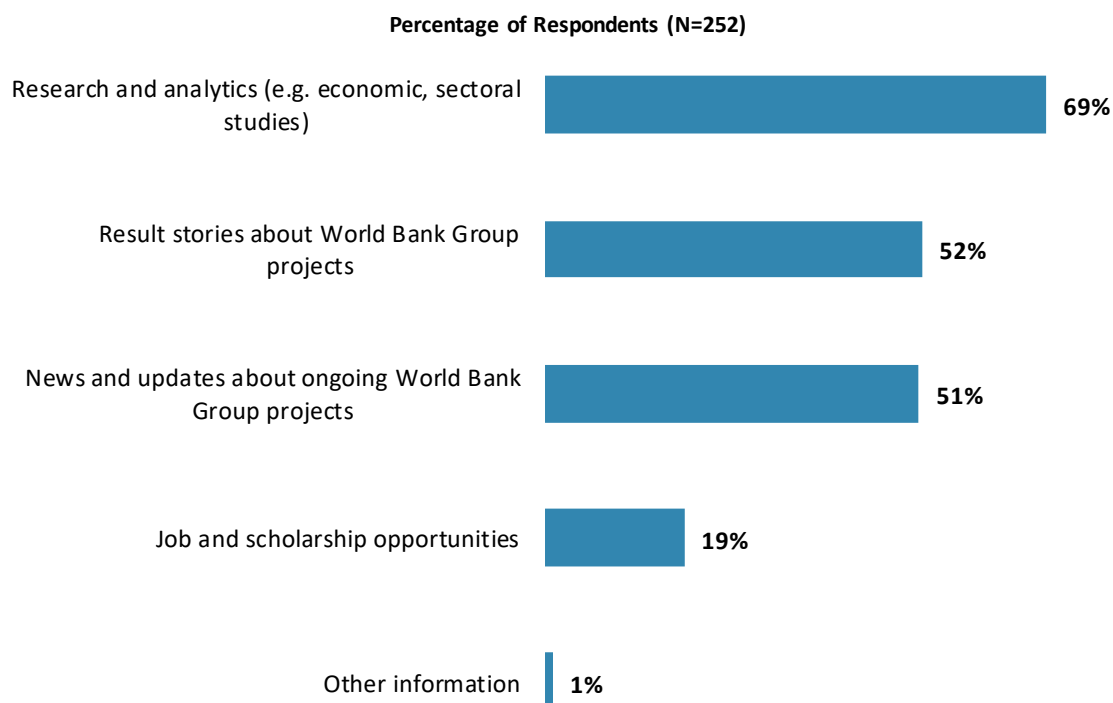
**"How would you prefer to receive information from the World Bank Group?

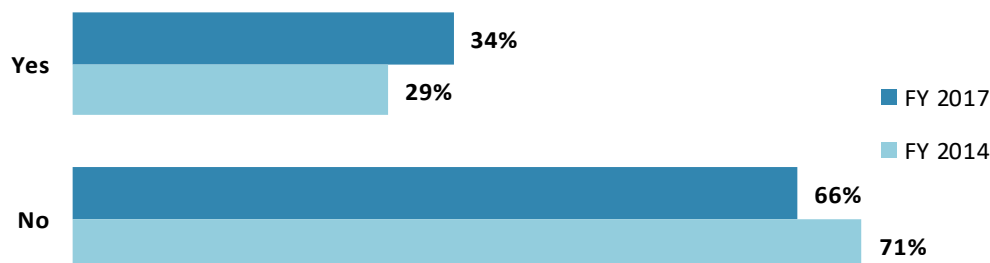
"What types of information would you like to receive more from the World Bank Group? (Choose no more than TWO)" (Respondents chose from a list. Responses combined.)

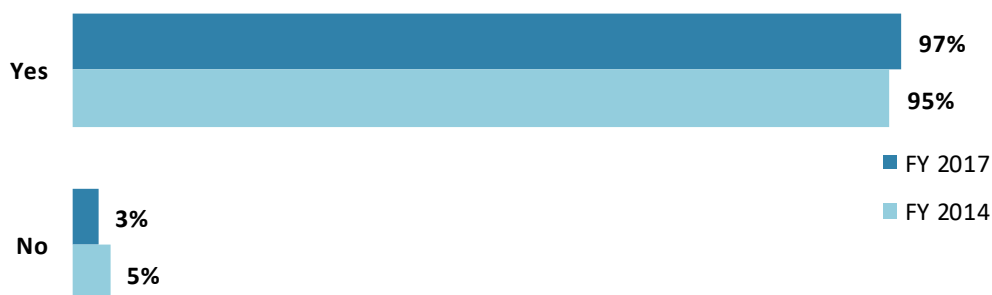
Percentage of Respondents (FY 2017 N=215; FY 2014 N=277)

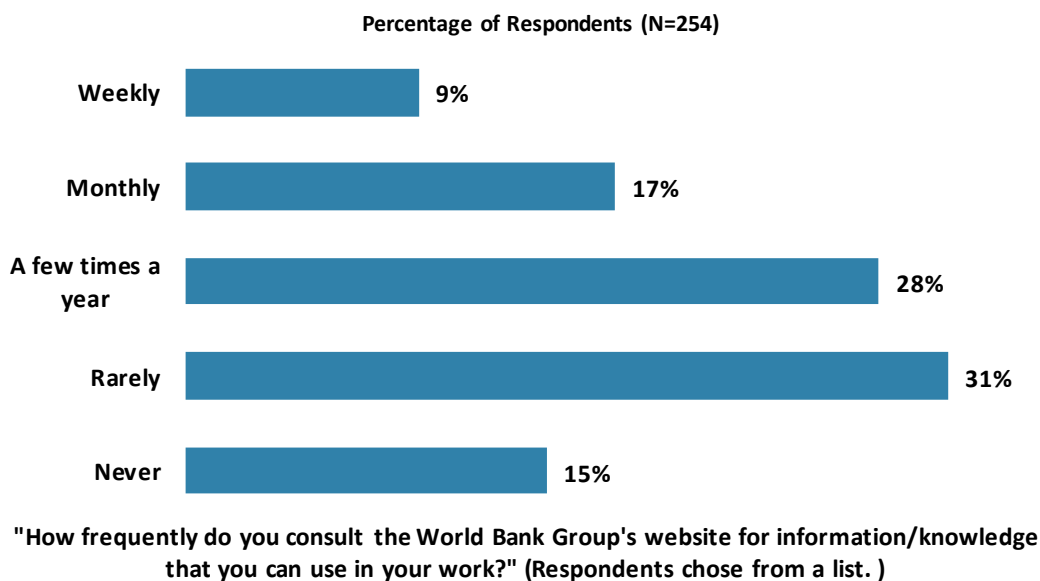

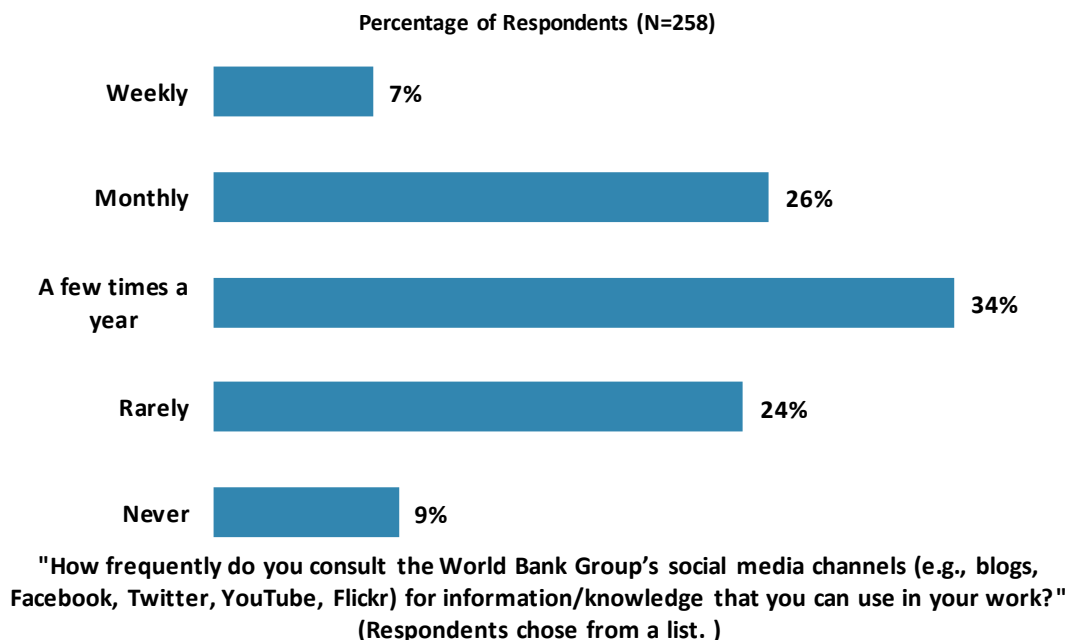
