I. Objectives

This survey was designed to assist the World Bank Group (WBG) in gaining a better understanding of how stakeholders in Timor-Leste perceive the WBG. The survey explored:

- *General Issues Facing Timor-Leste*
- *Overall Attitudes toward the World Bank Group*
- *World Bank Group's Effectiveness and Results*
- *The World Bank Group's Knowledge Work and Activities*
- *Working with the World Bank Group*
- *The Future Role of the World Bank Group in Timor-Leste*
- *Communication and Information Sharing*
- *Background Information*

II. Methodology

From February to April 2017, 203 stakeholders of the WBG in Timor-Leste were invited to provide their opinions on the WBG's work in the country by participating in a Country Opinion Survey (COS). Participants were drawn from the office of the President/Prime Minister, office of a Minister, office of a Parliamentarian, employees of ministries/ministerial departments/implementation agencies, Project Management Units (PMUs) overseeing implementation of WBG projects or consultants/contractors working on WBG-supported projects/programs, local government officials or staff, bilateral/multilateral agencies, private sector organizations, private foundations, the financial sector/private banks, NGOs/community-based organizations (CBOs), the media, independent government institutions, trade unions, faith-based groups, youth groups, academia/research institutes/think tanks, and the judiciary branch.

A total of 101 stakeholders participated in the survey (50% response rate). Respondents received an invitation via email and completed the questionnaire online or completed the questionnaire with a representative of the fielding agency.

Every country that engages in the Country Opinion Survey must include specific indicator questions that will be aggregated for the WBG's annual Corporate Scorecard. These questions are identified throughout the survey report.

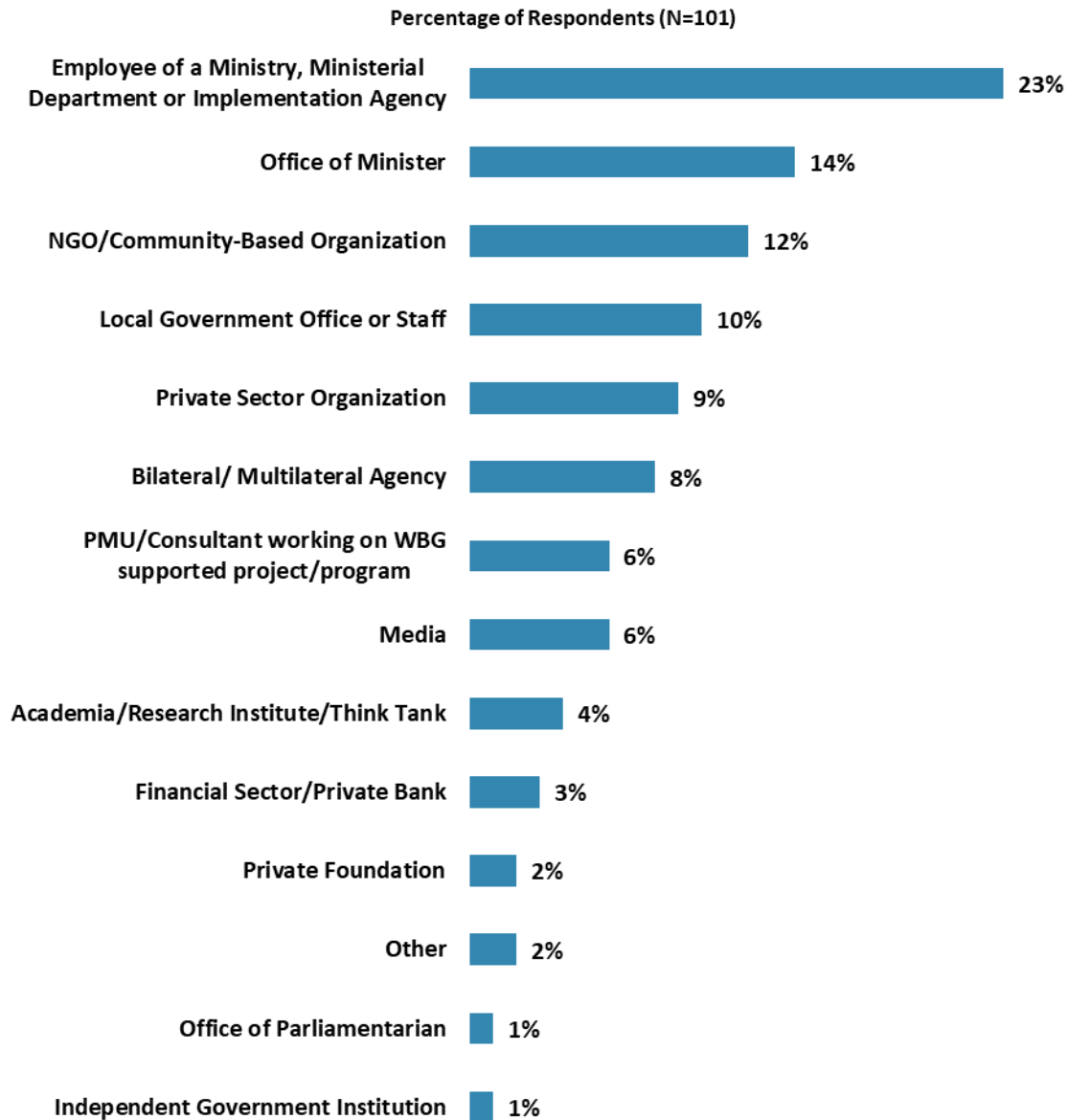
The results of this year's Country Survey were compared to those of the Country Survey conducted in FY '14 (response rate was 74%, N = 163). The data were weighted to reach similar stakeholder compositions across the two survey years, allowing for more statistically reliable comparisons. Note, there were insufficient numbers of respondents from academia in both years to be included in these analyses. Also, stakeholders who identified themselves as "Other" in the stakeholder category options were not included in these comparisons. As a result, mean ratings, percentages of respondents, and the total number of respondents in both years are slightly different from those of the original data reported in the FY '14 COS report and the non-weighted data presented in this report. III. Demographics of the Sample

Current Position

- For all further analyses, the small number of respondents from private foundations were combined with those from NGOs/CBOs and the small number of respondents from the financial sector/private banks were combined with those from the private sector. The few respondents from the office of a Parliamentary, independent government institutions, and academia were included in the “Other” category

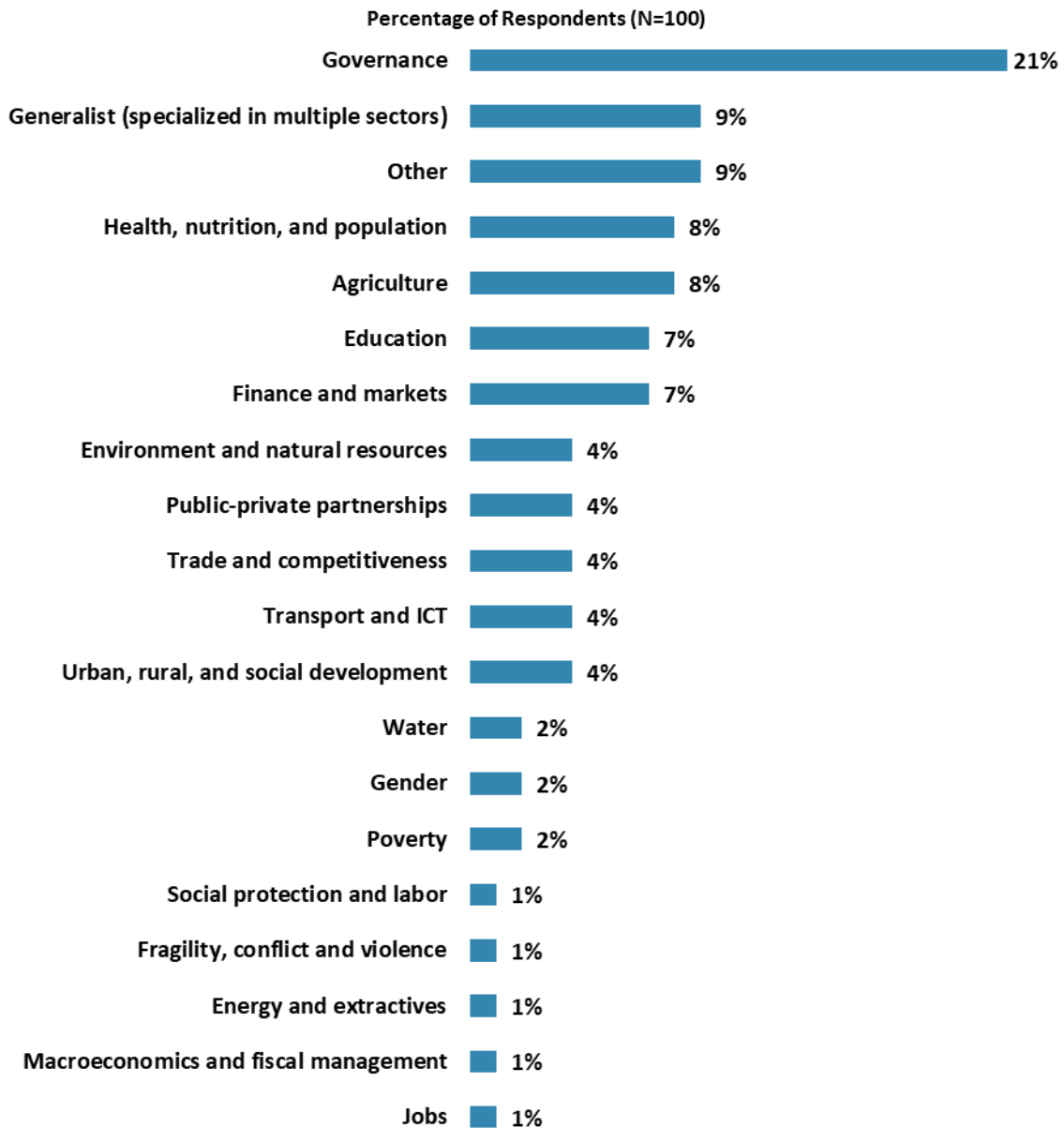


“Which of the following best describes your current position? (Select only ONE response)”

Area of Primary Specialization



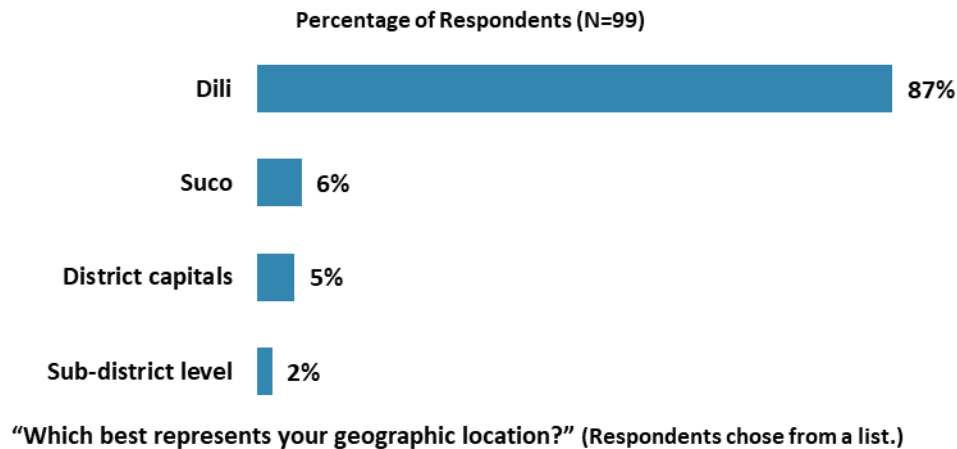

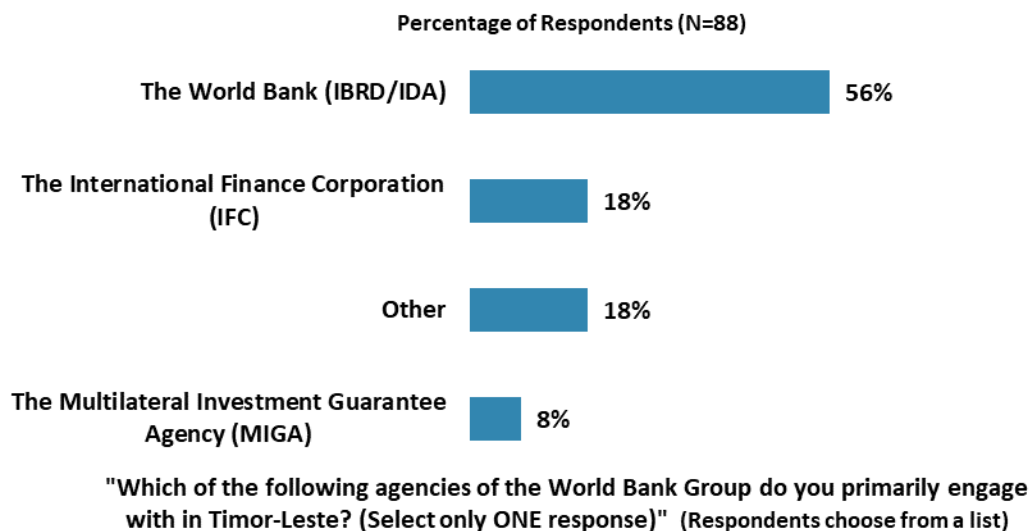

III. Demographics of the Sample (continued)

Familiarity with the World Bank Group

- **Year comparison:** Respondents in this year's Country Survey indicated statistically similar levels of familiarity with the WBG compared to respondents from the FY '14 Country Survey (weighted mean in FY '17 = 5.8; weighted mean in FY '14 = 5.9)¹.
- **Impact of Familiarity:** Respondents' ratings of familiarity with the WBG were strongly, significantly correlated with their ratings of the WBG's overall effectiveness in Timor-Leste, and moderately, significantly correlated with their ratings of the extent to which the WBG's work helps to achieve development results and the extent to which the WBG plays a relevant role in development in Timor-Leste.



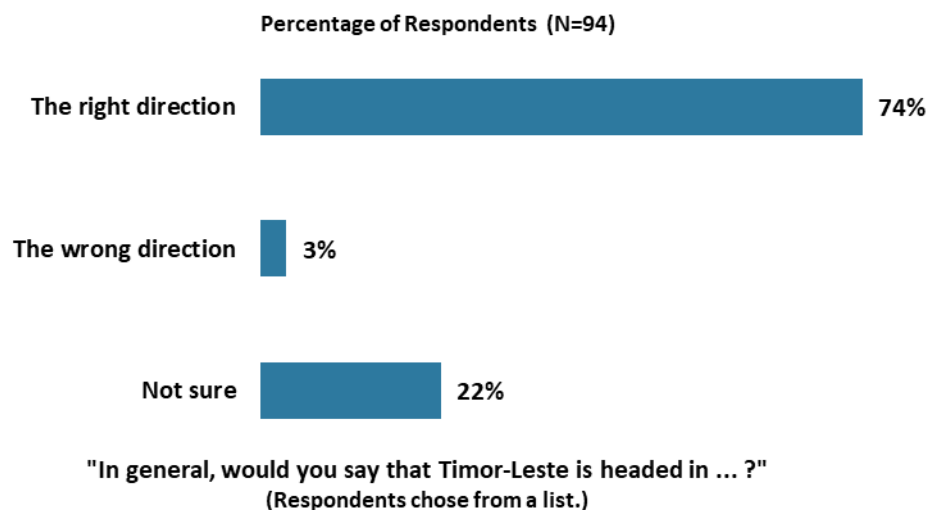
"How familiar are you with the work of the World Bank Group in Timor-Leste?"

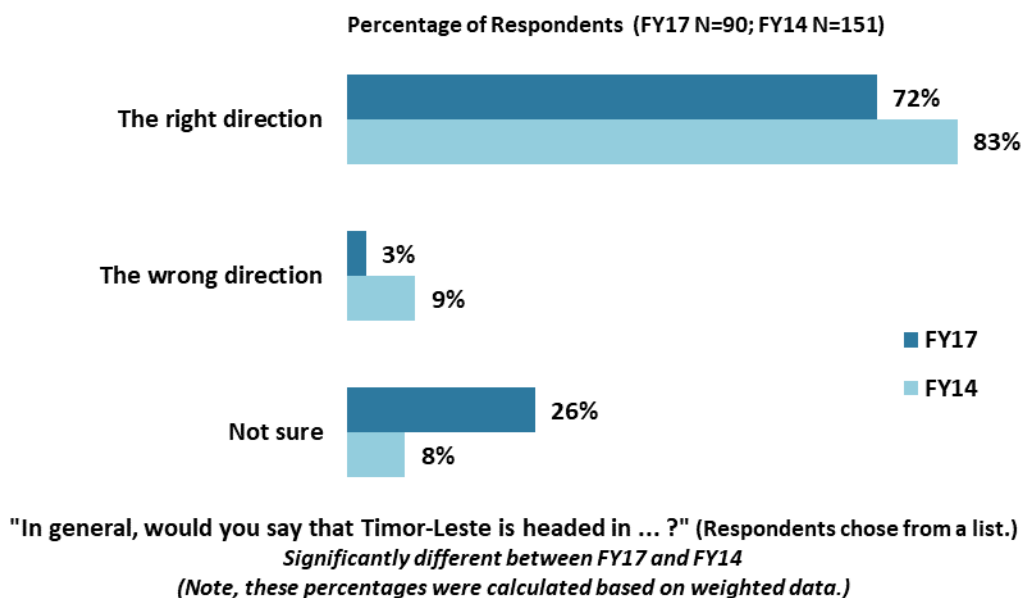

Headed in the Right Direction: Year Comparison²



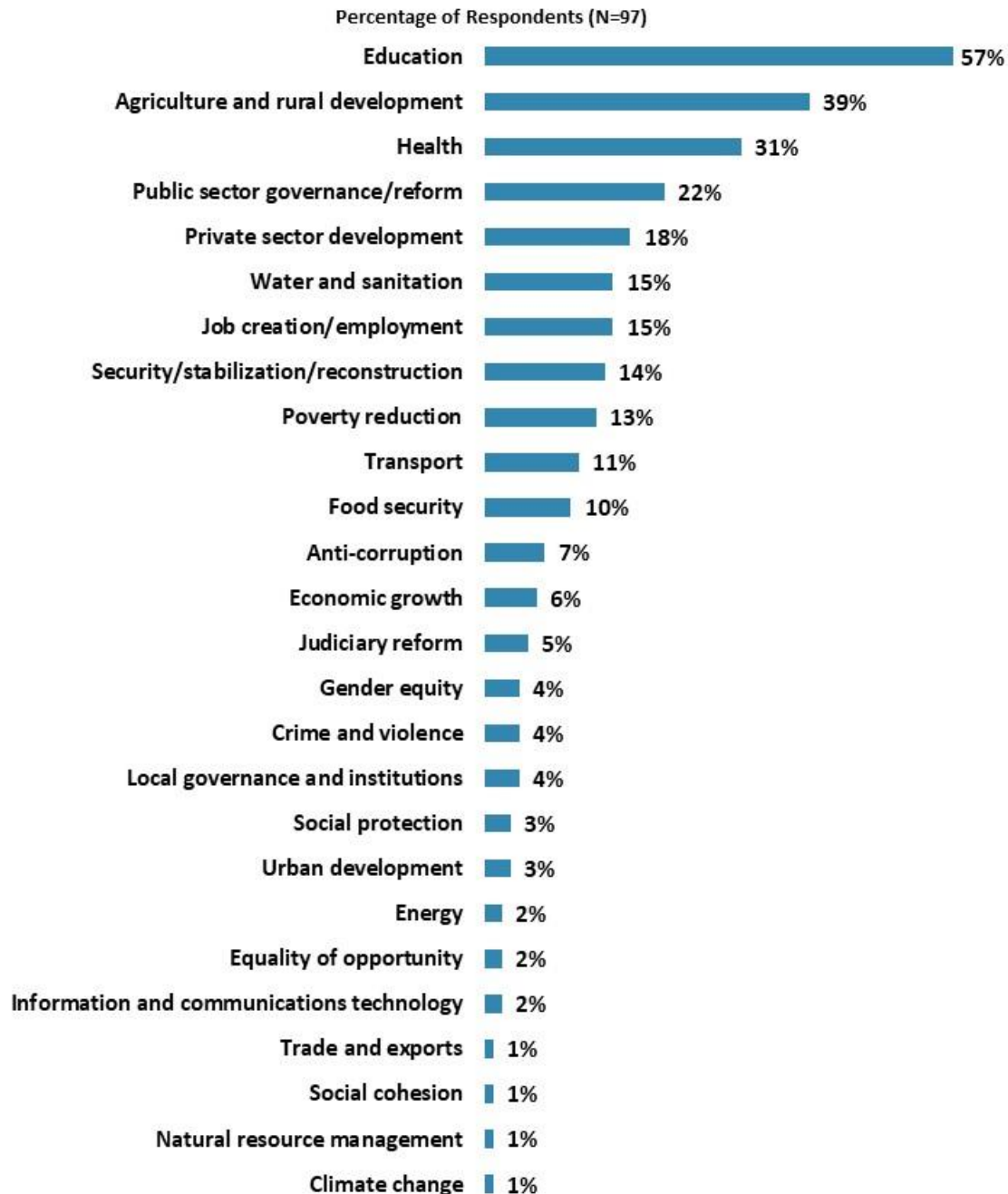

Development Priority

- **Year comparison:** Respondents in the FY '14 Country Survey indicated that the most important development priority in Timor-Leste was education (percentage of respondents = 65%), followed by health (45%), rural and agricultural development (27%), transport (26%), public sector governance (21%), job creation (19%), and security/stabilization/reconstruction (19%).



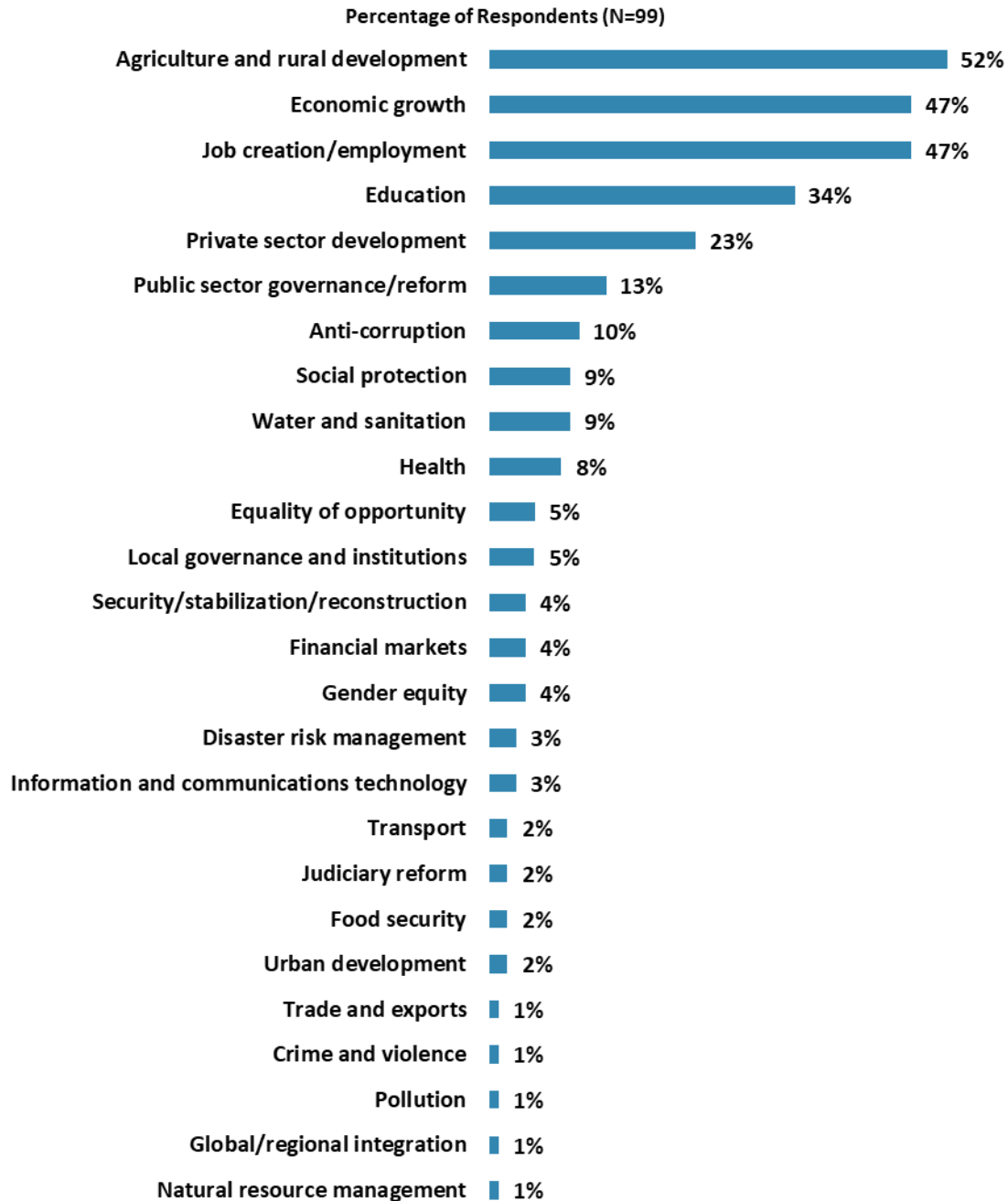

Factors Contributing to Poverty Reduction

- **Year comparison:** Respondents in the FY '14 Country Survey indicated that the areas that would contribute most to poverty reduction in Timor-Leste were rural and agricultural development (percentage of respondents = 48%), education (37%), job creation/ employment (35%), economic growth (35%), and anti-corruption (22%).



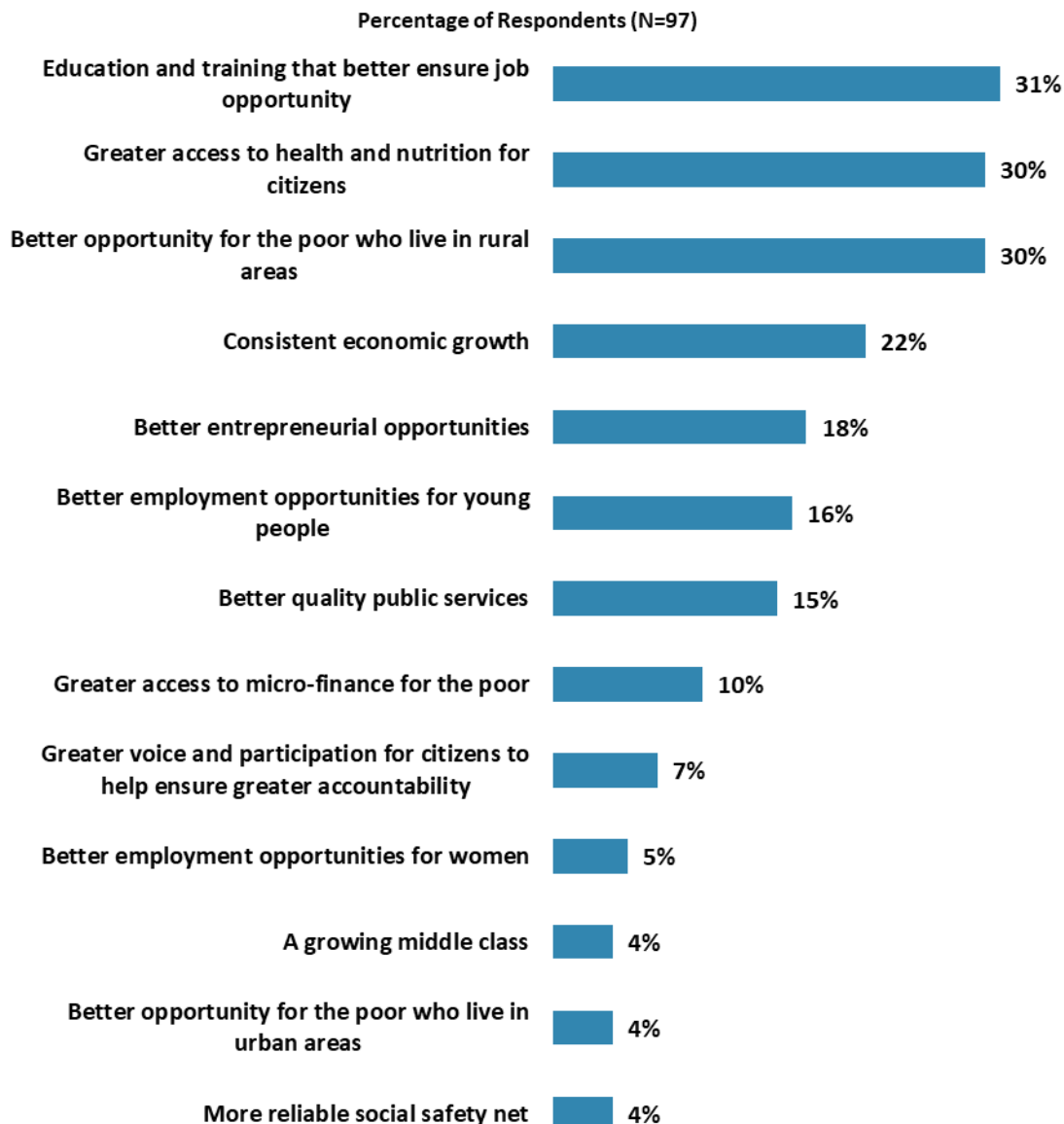

Factors Contributing to “Shared Prosperity”

- **Year comparison:** Respondents in the FY ‘14 Country Survey indicated that shared prosperity in Timor-Leste would be achieved through better employment opportunities for young people (percentage of respondents = 39%), consistent economic growth (27%), better opportunity for the poor who live in rural areas (25%), and education and training that better ensure job opportunity (23%).

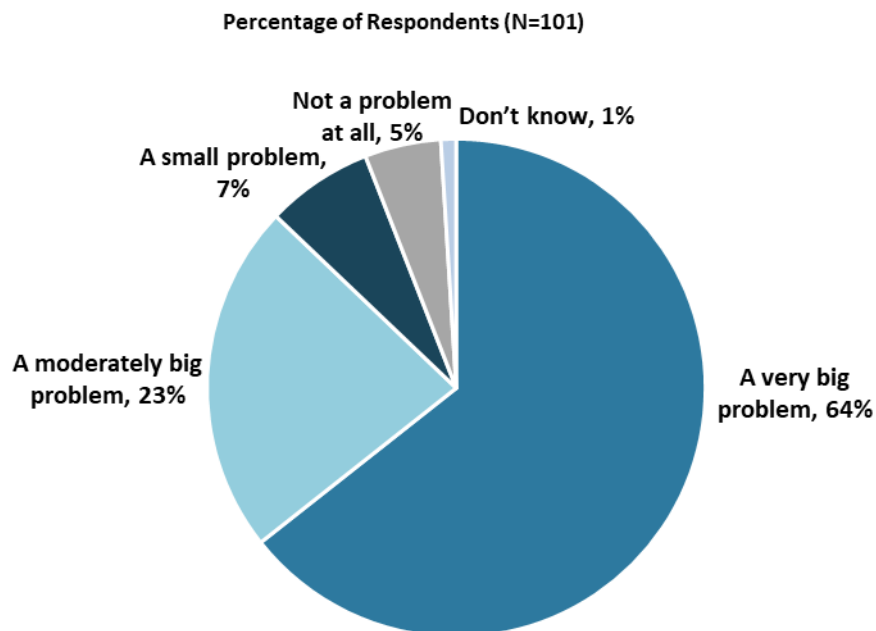

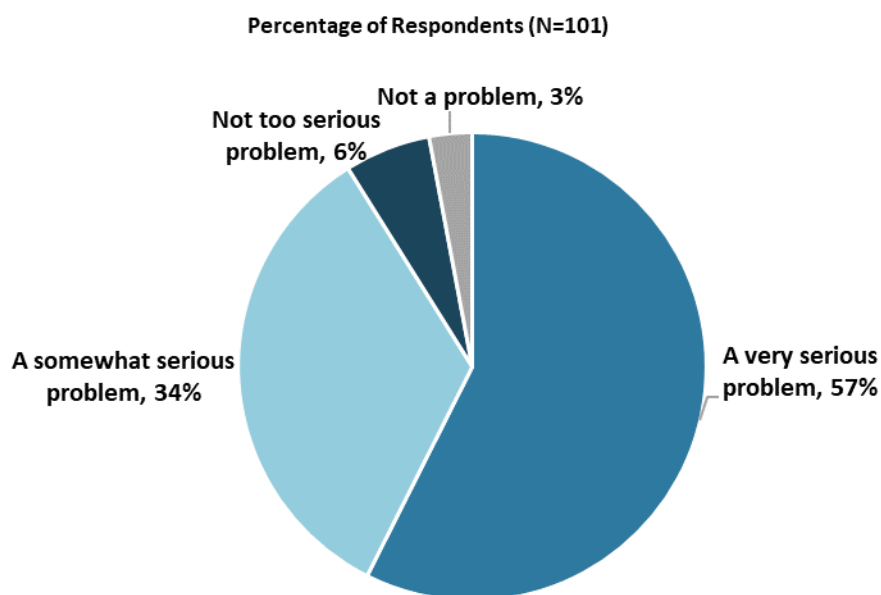

Global Climate Change



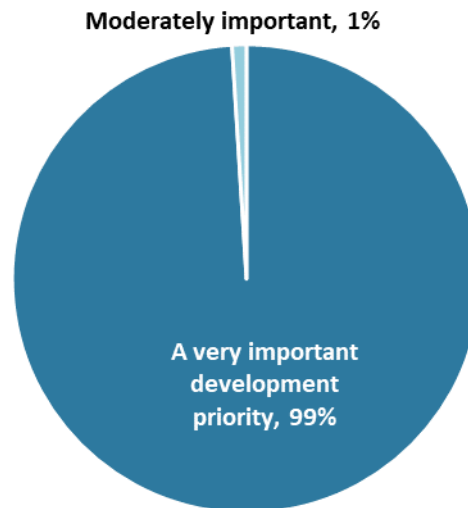

Percentage of Respondents (N=101)



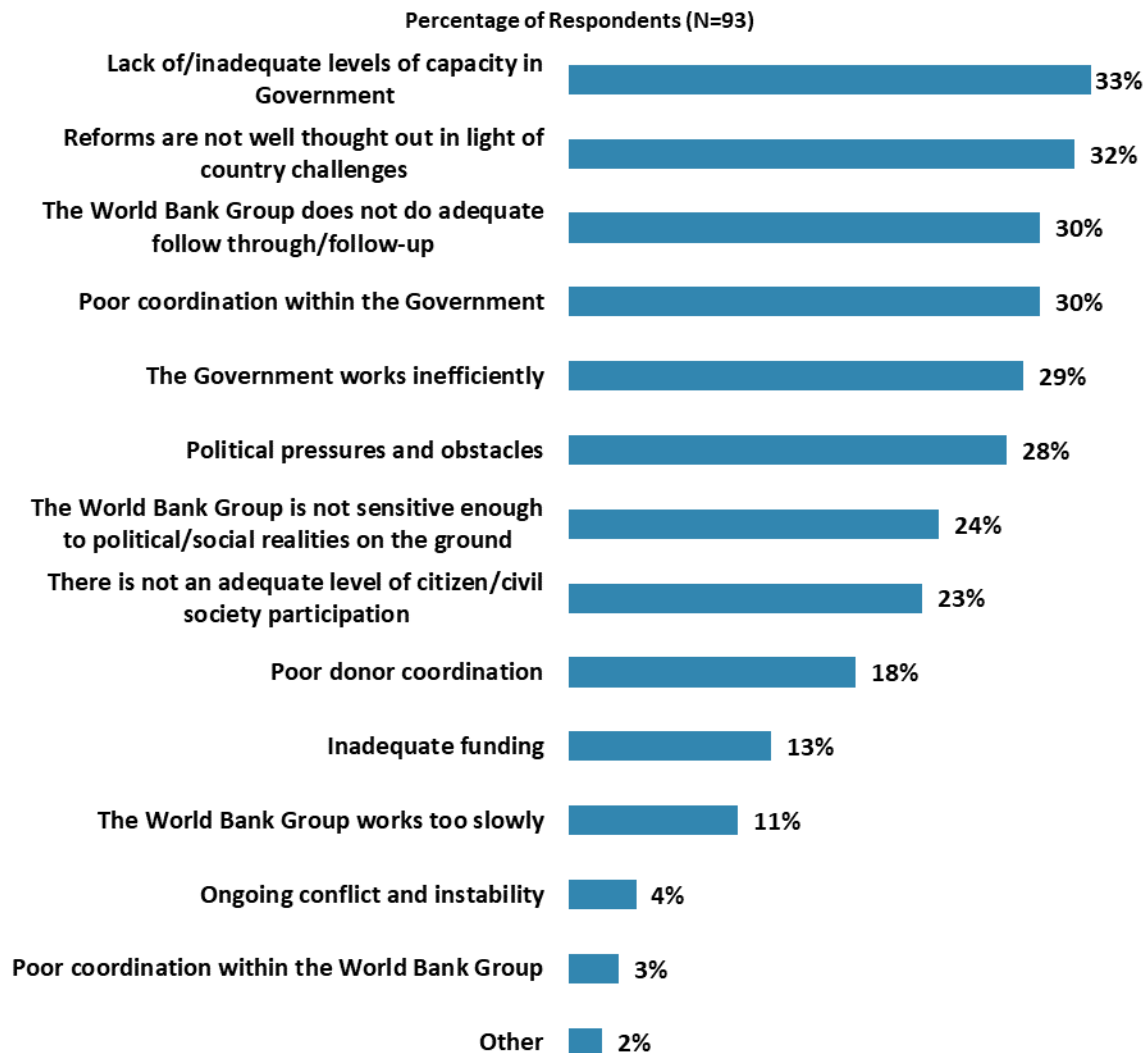

V. Overall Attitudes toward the World Bank Group

Attributing Failed/Slow Reform Efforts

- **Year comparison:** Respondents in the FY '14 Country Survey indicated that they attributed slow or failed WBG-assisted reform efforts to an inadequate level of citizen/civil society participation (percentage of respondents = 48%), the WBG not being sensitive enough to political/social realities on the ground (44%), and the WBG not doing adequate follow through/follow-up (39%).

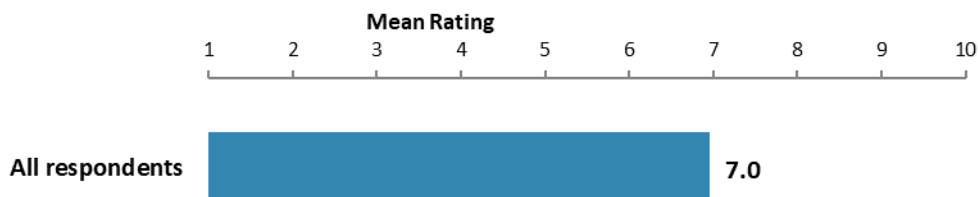
- **Year comparison:** Respondents in this year's Country Survey gave significantly higher ratings for the WBG's effectiveness in Timor-Leste (weighted mean = 6.9) compared to respondents from the FY '14 Country Survey (weighted mean = 6.3)³.

"To what extent does the World Bank Group's work help to achieve development results in Timor-Leste?" (1 - "To no degree at all", 10 - "To a very significant degree")

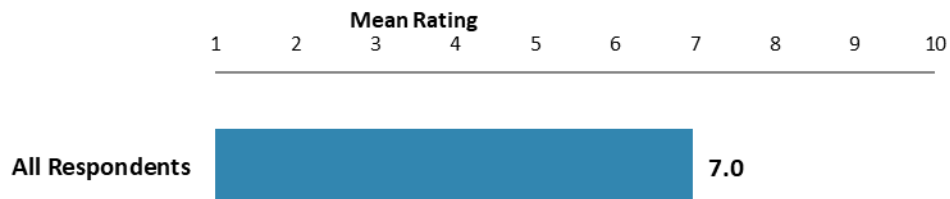

WBG Staff Preparedness

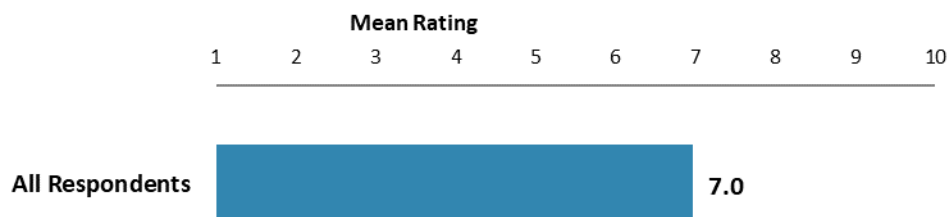
- **Year comparison:** Respondents in this year's Country Survey gave significantly higher ratings for the WBG's staff being well prepared (weighted mean = 7.0) compared to respondents from the FY '14 Country Survey (weighted mean = 6.1)⁴.
- **Collaboration:** Respondents who collaborate with the WBG gave significantly higher ratings for the WBG's staff being well prepared (mean rating = 7.4) compared to respondents who do not collaborate with the WBG (mean rating = 6.5).

Strengthening Existing Country Systems

- **Year comparison:** Respondents in this year's Country Survey gave significantly higher ratings for the WBG helping to build/strengthen existing country systems in Timor-Leste (weighted mean = 6.9) compared to respondents from the FY '14 Country Survey (weighted mean = 6.2)⁴.



"To what extent does the World Bank Group help to build/strengthen existing country systems in Timor-Leste?" (1-"To no degree at all", 10-"To a very significant degree")

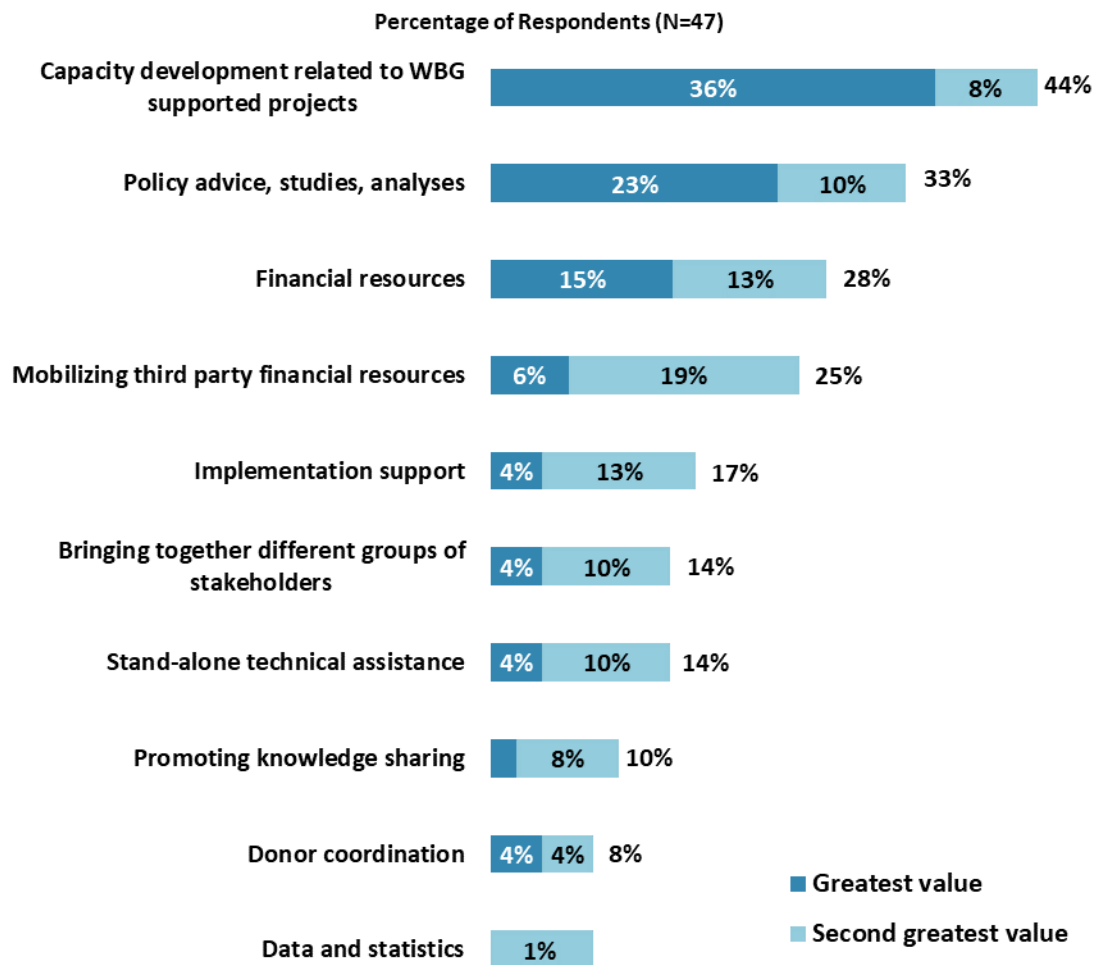

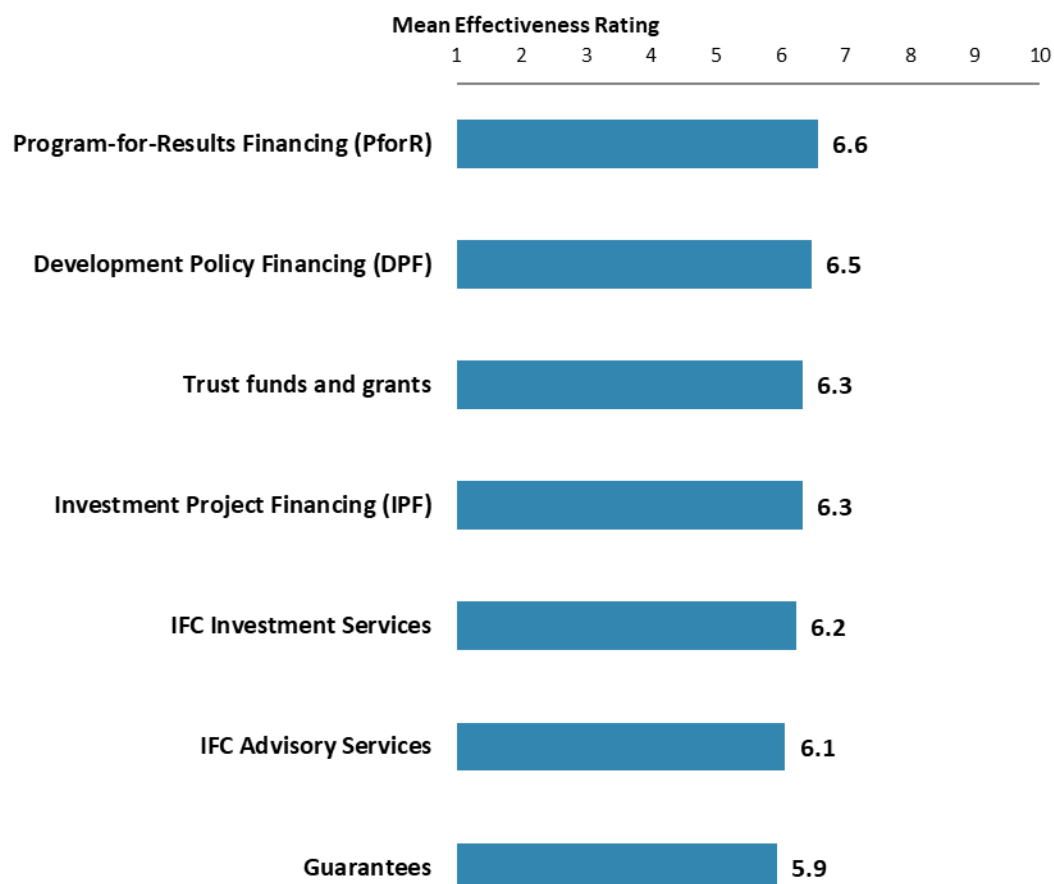

Effectiveness of WBG's Instruments in Reducing Poverty



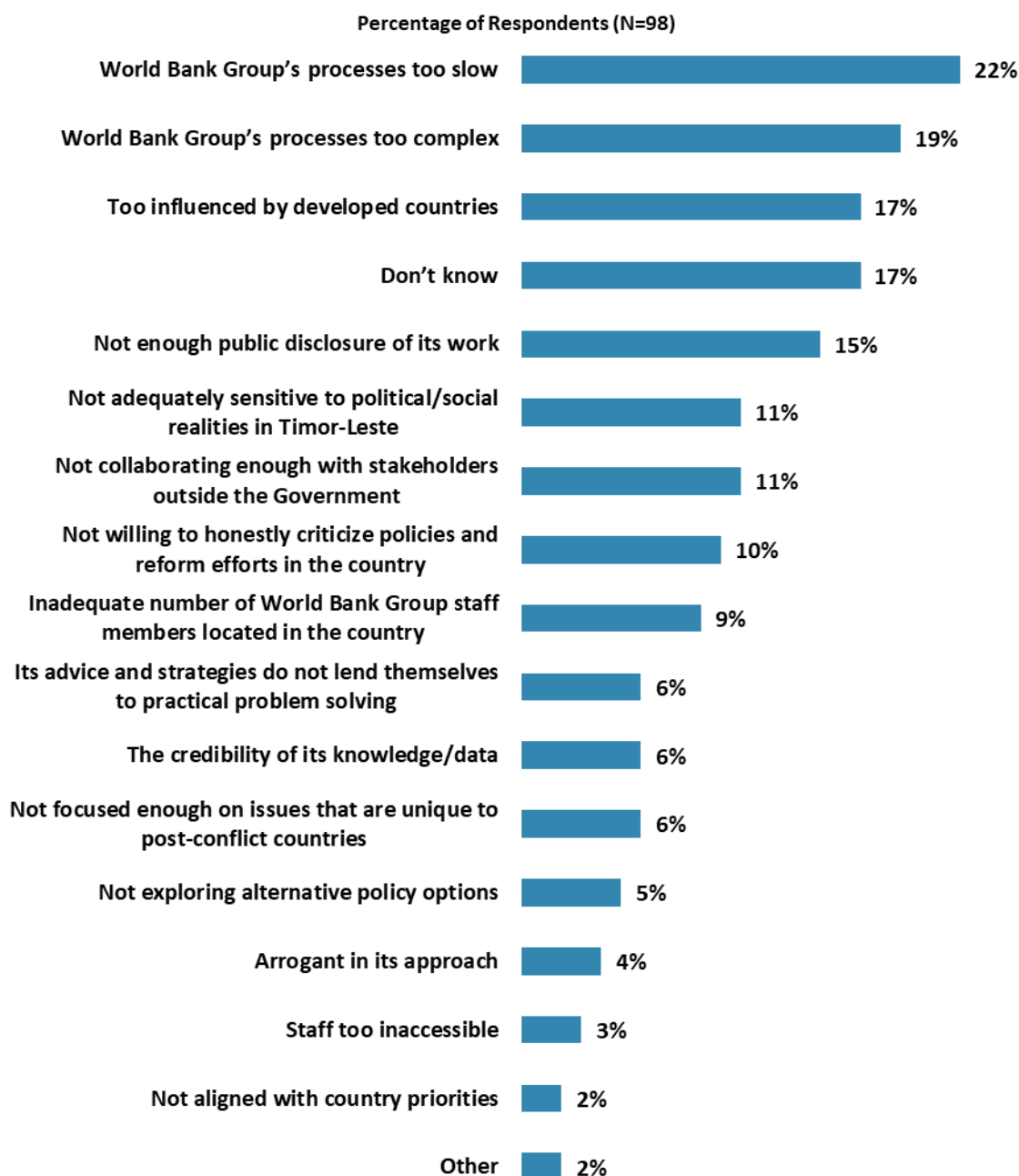

Greatest Weakness

- **Year comparison:** Respondents in the FY '14 Country Survey indicated that the WBG's greatest weakness in its work in Timor-Leste was not enough public disclosure of its work (percentage of respondents = 35%), followed by being too influenced by developed countries (17%) and not being adequately sensitive to political/social realities (16%).



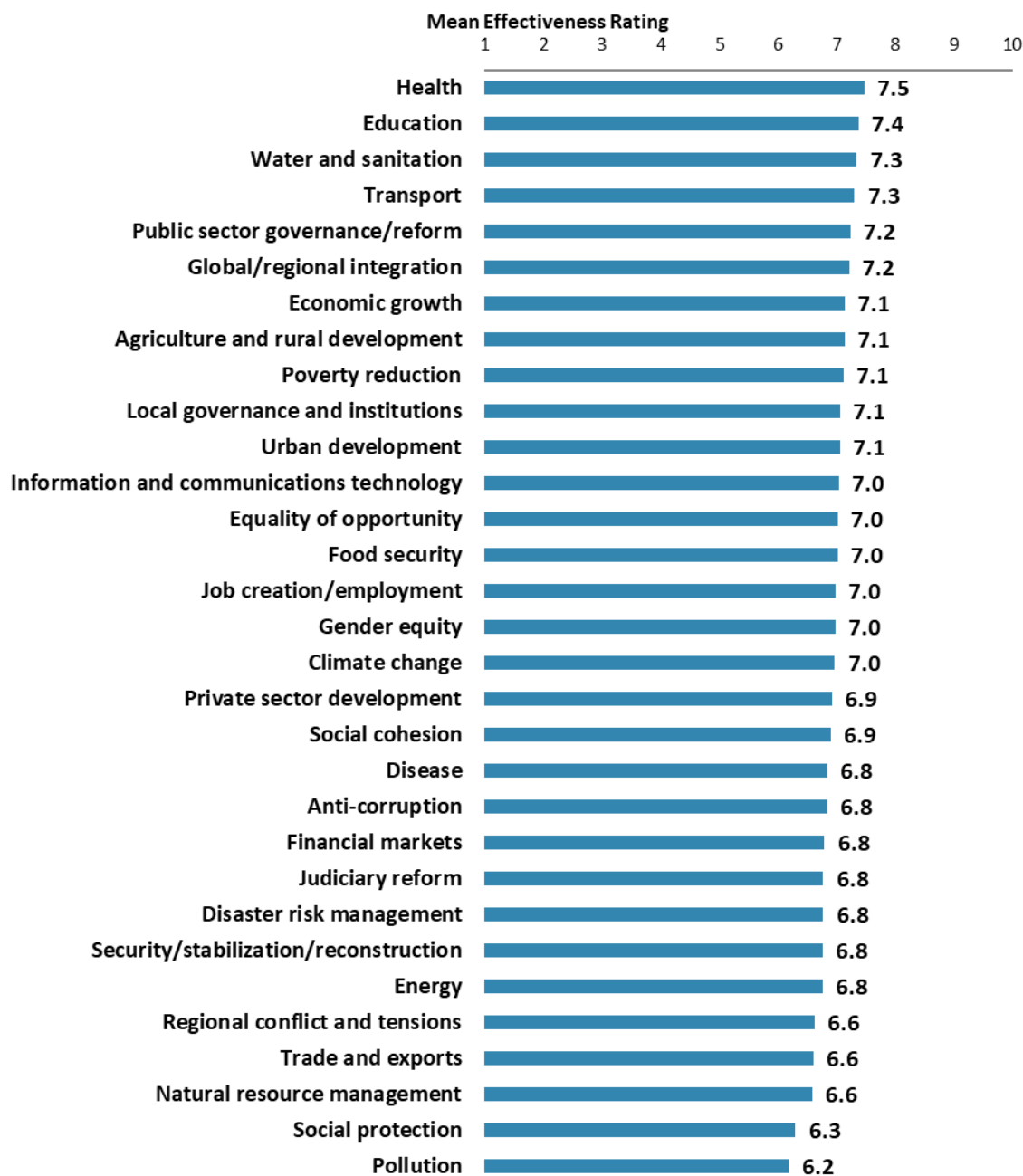

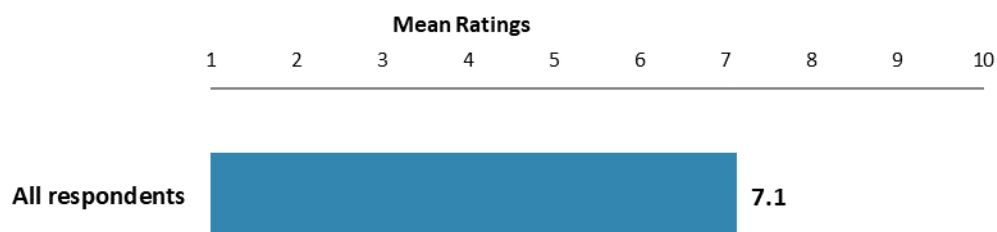

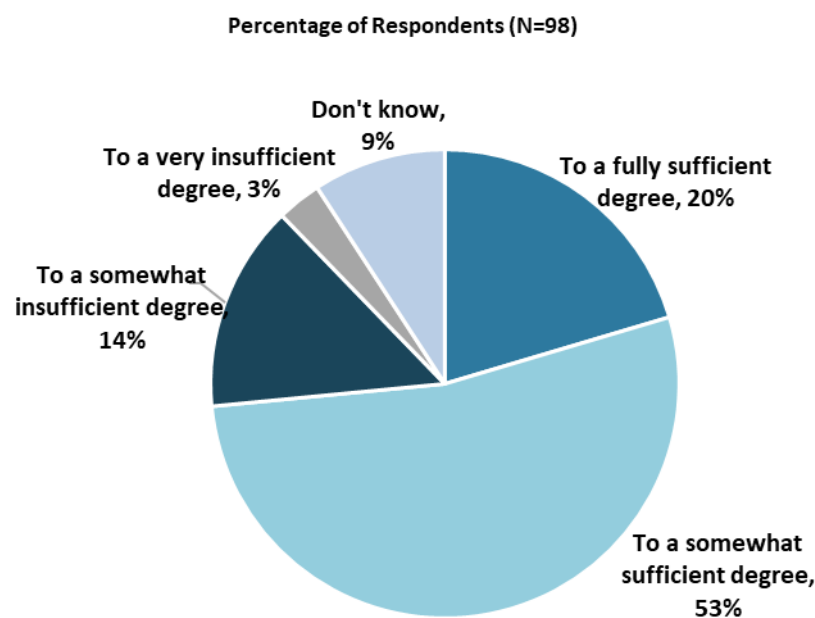

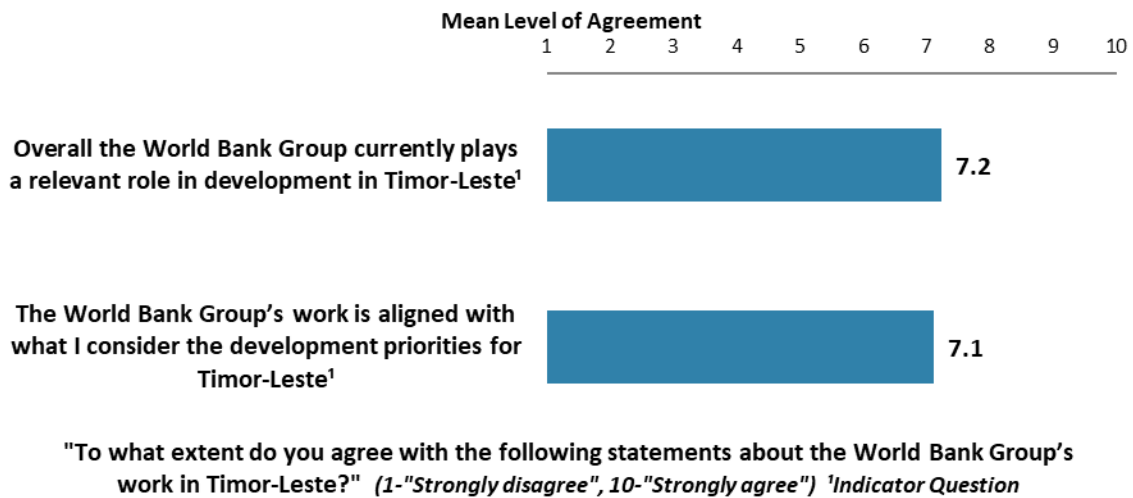
"To what extent do you believe that the World Bank Group's work and support help the poorest in Timor-Leste? (Select only ONE response)" (Respondents chose from a list.)

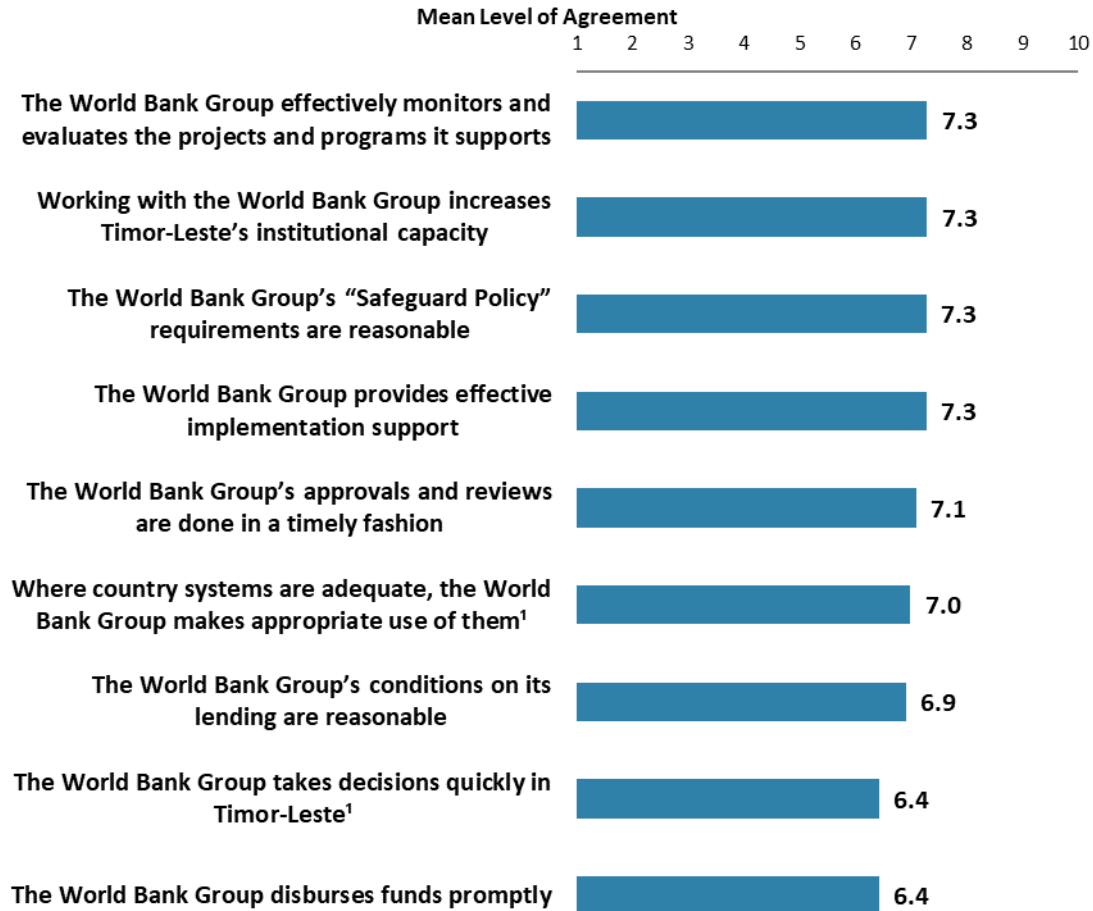

VII. How the World Bank Group Operates (continued)

The WBG as an Effective Development Partner

- **Year comparison:** Respondents in this year's Country Survey gave significantly lower ratings for the WBG's flexibility in terms of changing country circumstances (weighted mean = 6.3) compared to respondents from the FY '14 Country Survey (weighted mean = 7.0)⁵.
- **Stakeholders:** Respondents from PMUs/Consultants on WBG-supported projects gave the highest ratings for the WBG's collaboration with the Government whereas respondents from bilateral/multilateral agencies and the media gave significantly lower ratings.
- **Collaboration:** Respondents who collaborate with the WBG gave significantly higher ratings for the WBG being a long-term partner (mean rating = 8.1) compared to respondents who do not collaborate with the WBG (mean rating = 7.4).

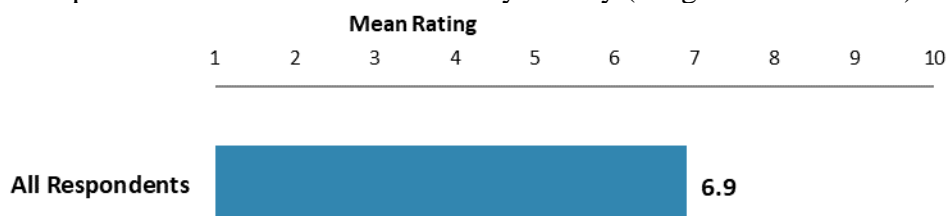

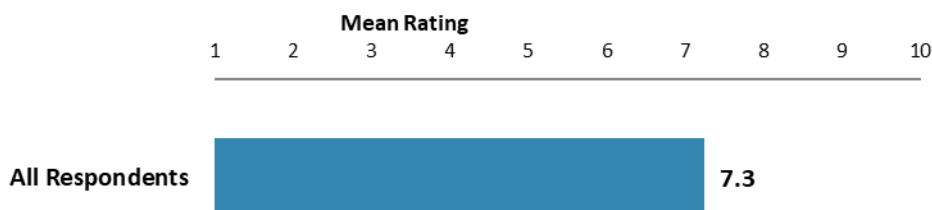

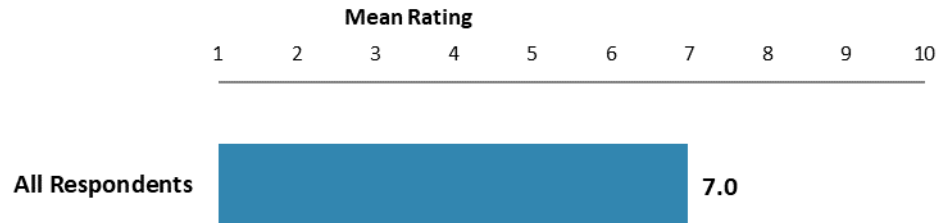

WBG Staffing in Timor-Leste

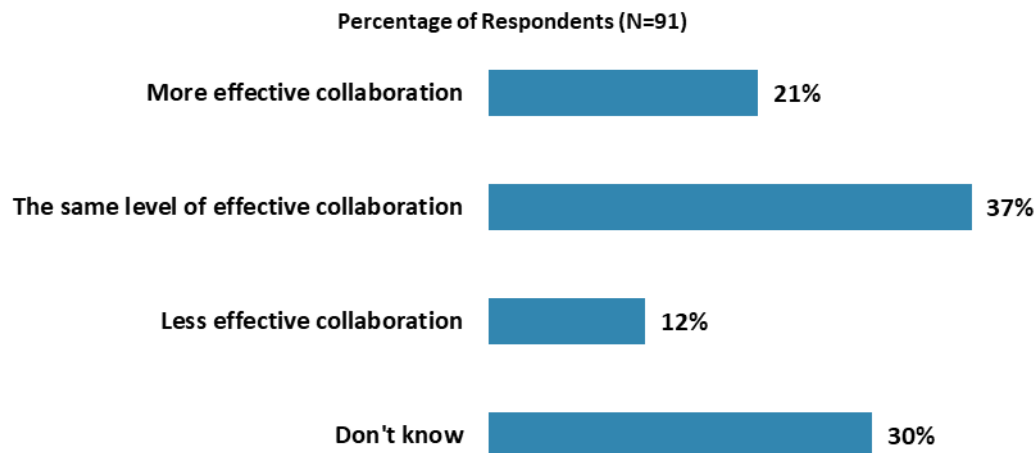
- **Year comparison:** Respondents in this year's Country Survey gave significantly higher ratings that the WBG is adequately staffed in Timor-Leste (weighted mean = 7.0) compared to respondents from the FY '14 Country Survey (weighted mean = 5.6)⁷.

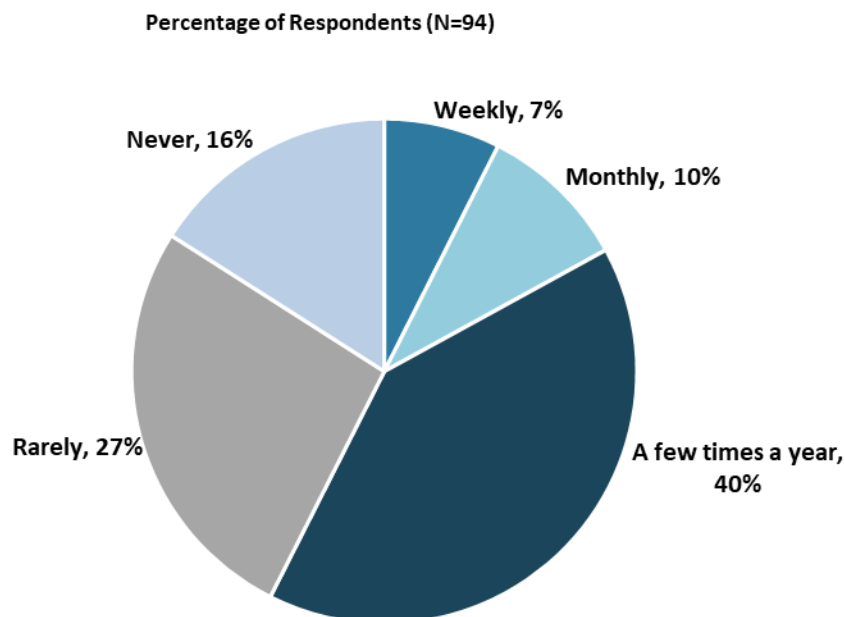
"In the past year, have you seen more, less, or just about the same level of effective collaboration between the UN and the World Bank Group in your country?"

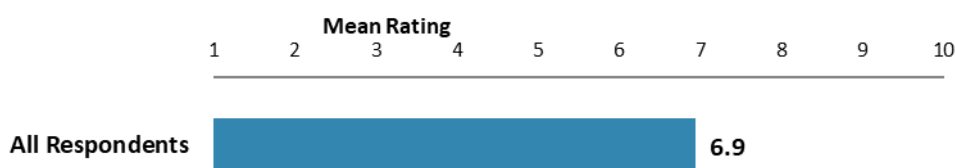
Frequency of Consulting WBG Knowledge Work and Activities

- **Year comparison:** Respondents in this year's Country Survey had statistically similar levels of agreement that the WBG meets Timor-Leste's needs for knowledge services (weighted mean = 7.0) compared to respondents from the FY '14 Country Survey (weighted mean = 7.2)⁸.
- **Locations:** Respondents from Dili had significantly higher levels of agreement that the WBG meets Timor-Leste's needs for knowledge services (mean rating = 7.2) compared to respondents from Other Areas (mean rating = 5.0).

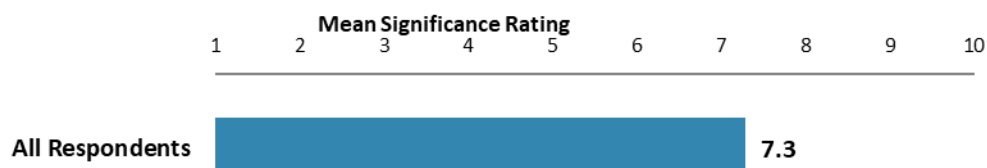

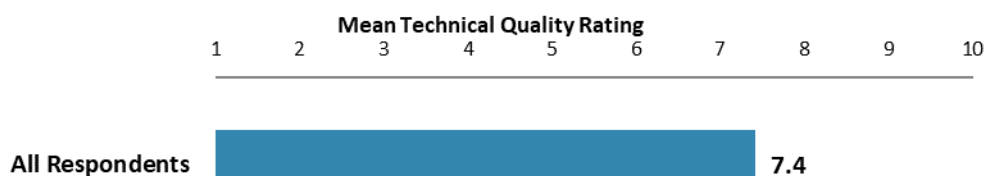
- **Year comparison:** Respondents in this year's Country Survey gave statistically lower ratings for the significance of the contribution of the WBG's knowledge work and activities (weighted mean = 7.2) compared to respondents from the FY '14 Country Survey (weighted mean = 7.9)⁹.
- **Locations:** Respondents from Dili gave significantly higher ratings for the significance of the WBG's knowledge work and activities (mean rating = 7.5) compared to respondents from Other Areas (mean rating = 6.1).

"Overall, how would you rate the technical quality of the World Bank Group's knowledge work and activities?" (1-"Very low technical quality", 10-"Very high technical quality")

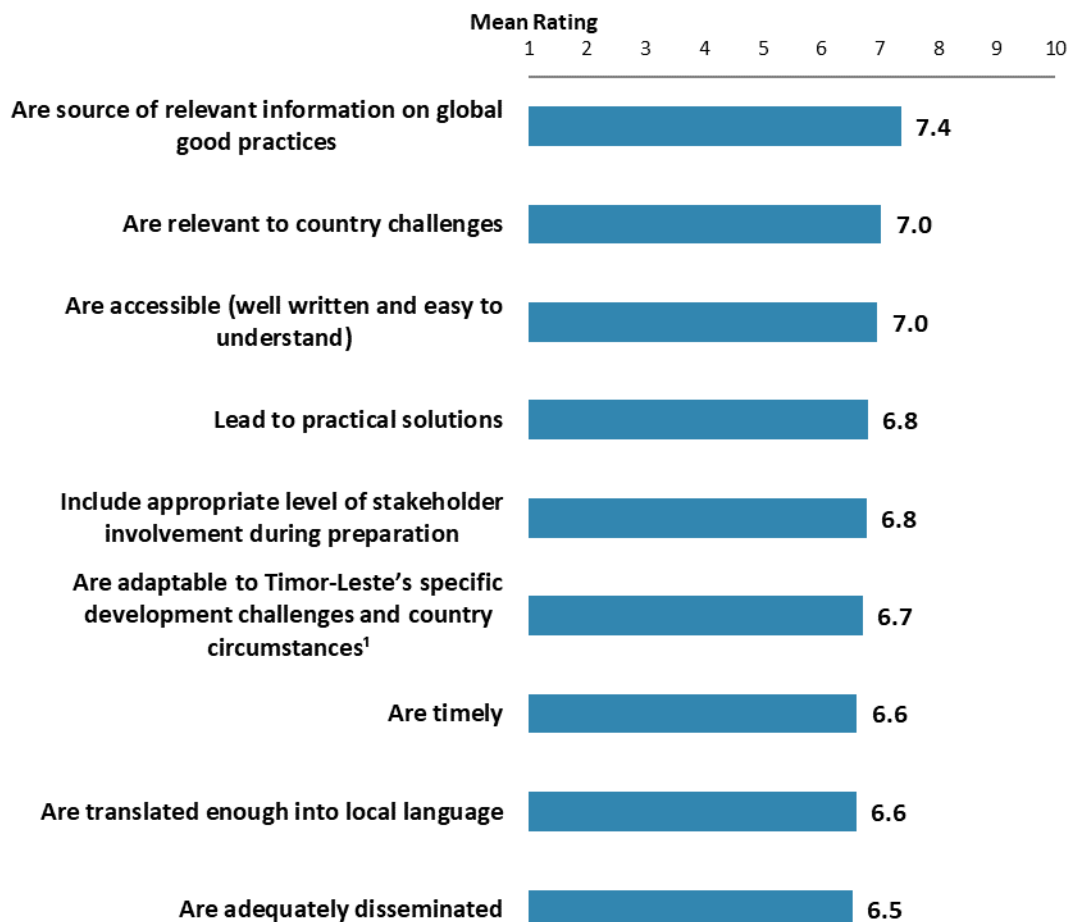

- **Year comparison:** Respondents in this year's Country Survey had statistically similar levels of agreement that the WBG's financial instruments meet Timor-Leste's needs (weighted mean = 6.7) compared to respondents from the FY '14 Country Survey (weighted mean = 6.8)¹⁰.
- **Locations:** Respondents from Dili had significantly higher levels of agreement that the WBG's financial instruments meet Timor-Leste's needs (mean rating = 7.0) compared to respondents from Other Areas (mean rating = 5.2).

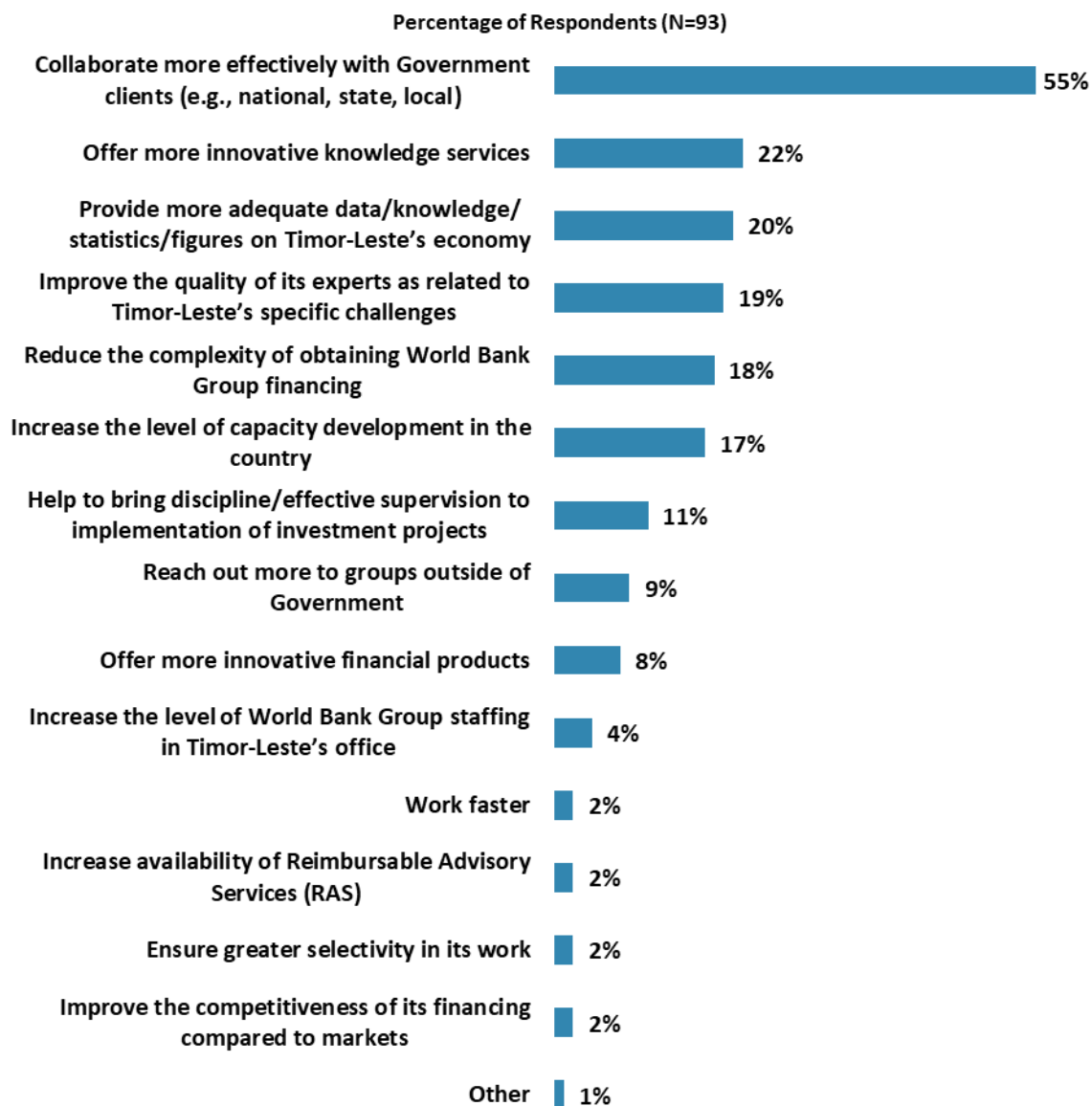

IX. The Future Role of the WBG in Timor-Leste

Making the World Bank Group of Greater Value

- **Year comparison:** Respondents in the FY '14 Country Survey indicated that, to make itself of greater value, the WBG should provide more adequate data/knowledge/statistics/figures on Timor-Leste's economy (percentage of respondents = 41%), collaborate more effectively with Government clients (34%), and increase the level of capacity development (33%).



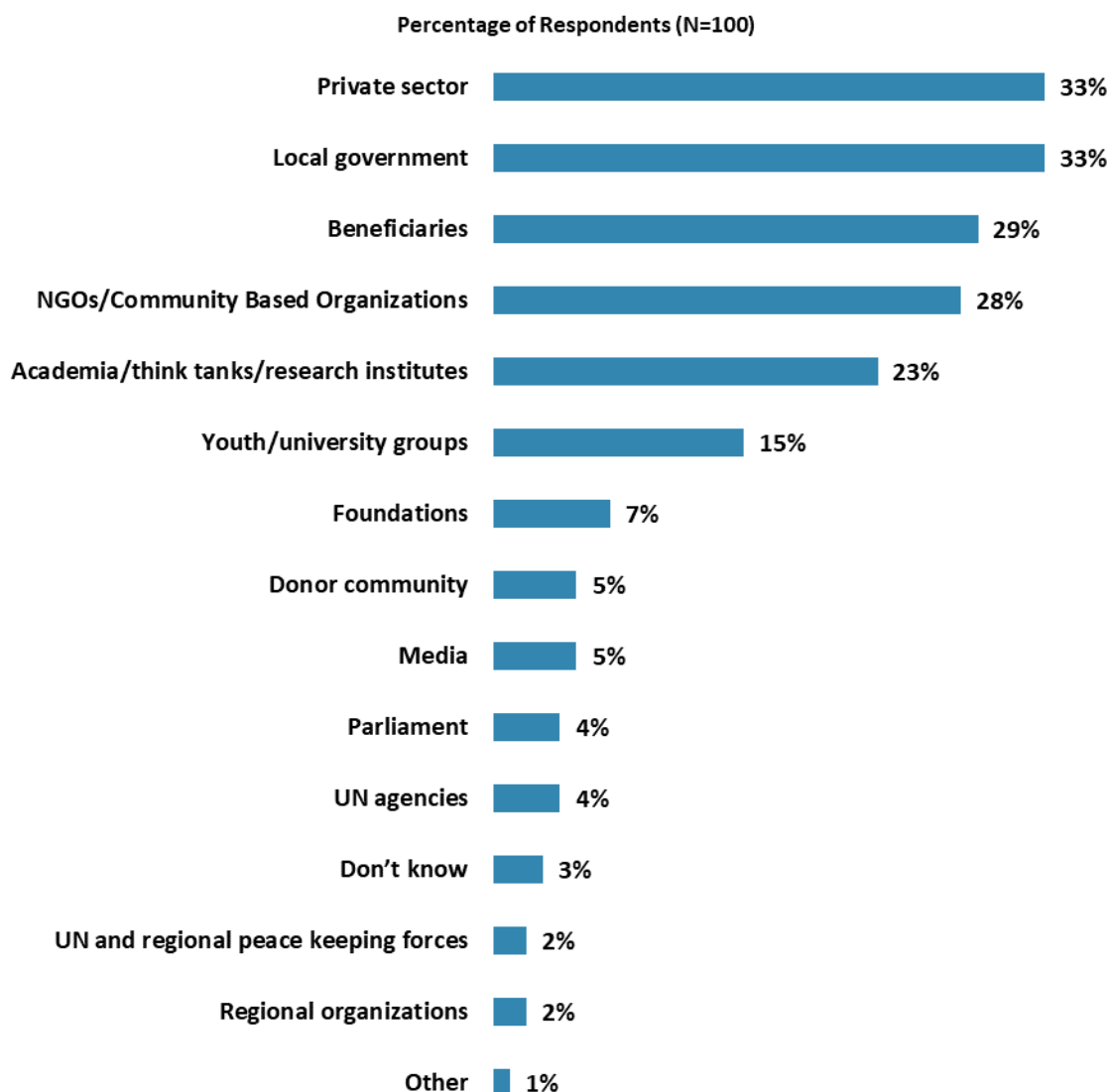

- **Year comparison:** Respondents in the FY '14 Country Survey indicated that, to ensure better development results in Timor-Leste, the WBG should collaborate more with local government (percentage of respondents = 36%) and academia/think tanks/research institutes (35%), followed by development partner community (27%), CBOs/NGOs (24%), and the private sector (22%).



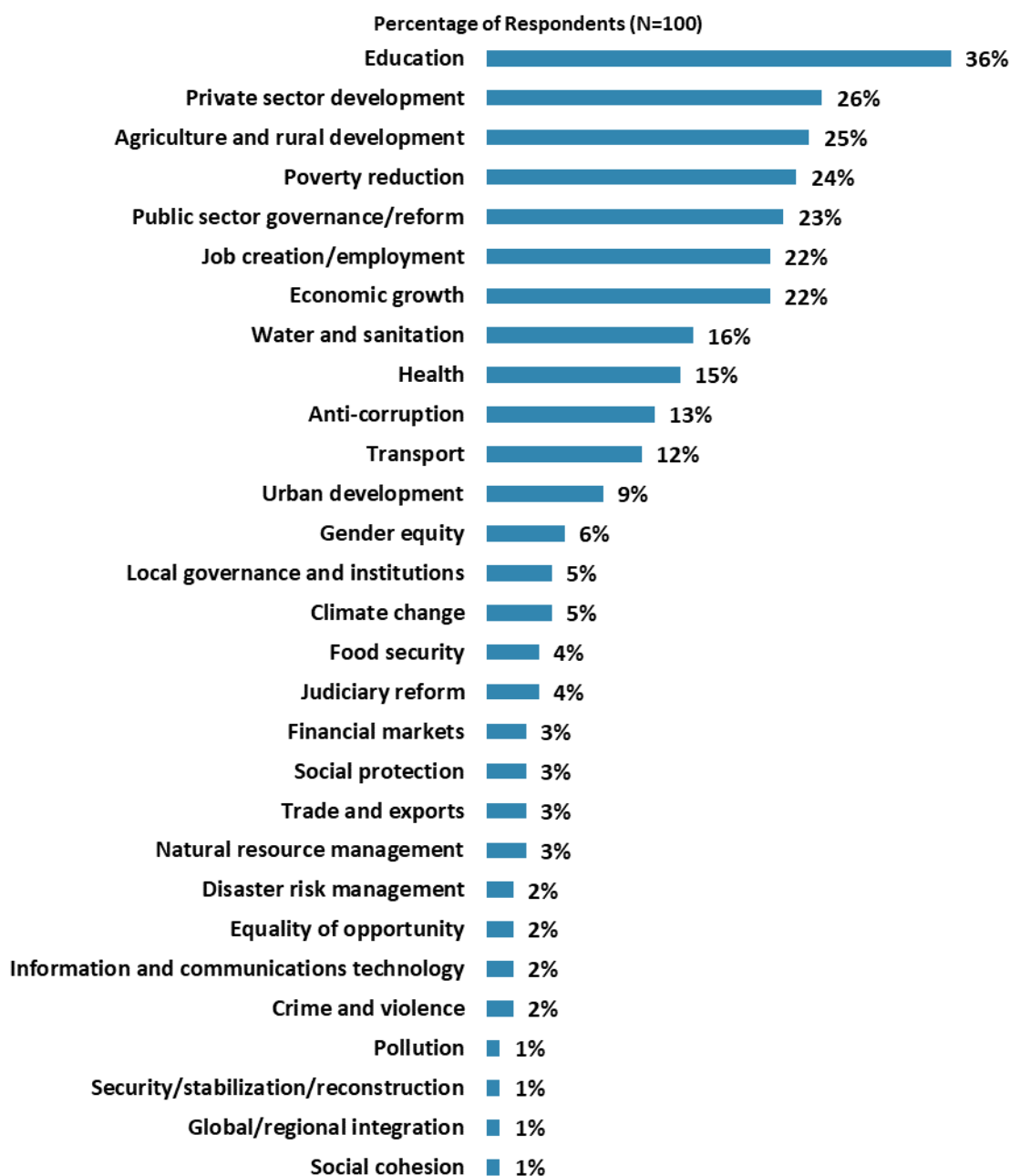

- **Year comparison:** Respondents in the FY '14 Country Survey indicated that the WBG should focus its resources on rural and agricultural development (percentage of respondents = 52%), followed by education (40%), public sector governance/reform (31%), and health (28%).



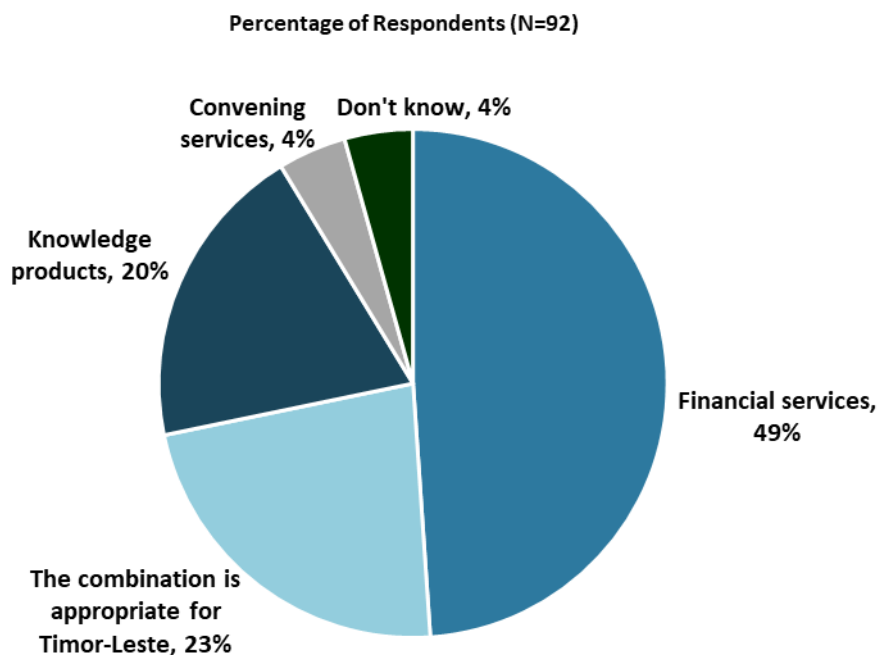

Future Combination of the WBG services

- **Year comparison:** Respondents in the FY '14 Country Survey indicated that the WBG should offer more financial services (percentage of respondents = 30%) and knowledge products (25%) in Timor-Leste. Nearly a quarter of FY '14 respondents indicated that the current combination of services is appropriate for Timor-Leste (24%).



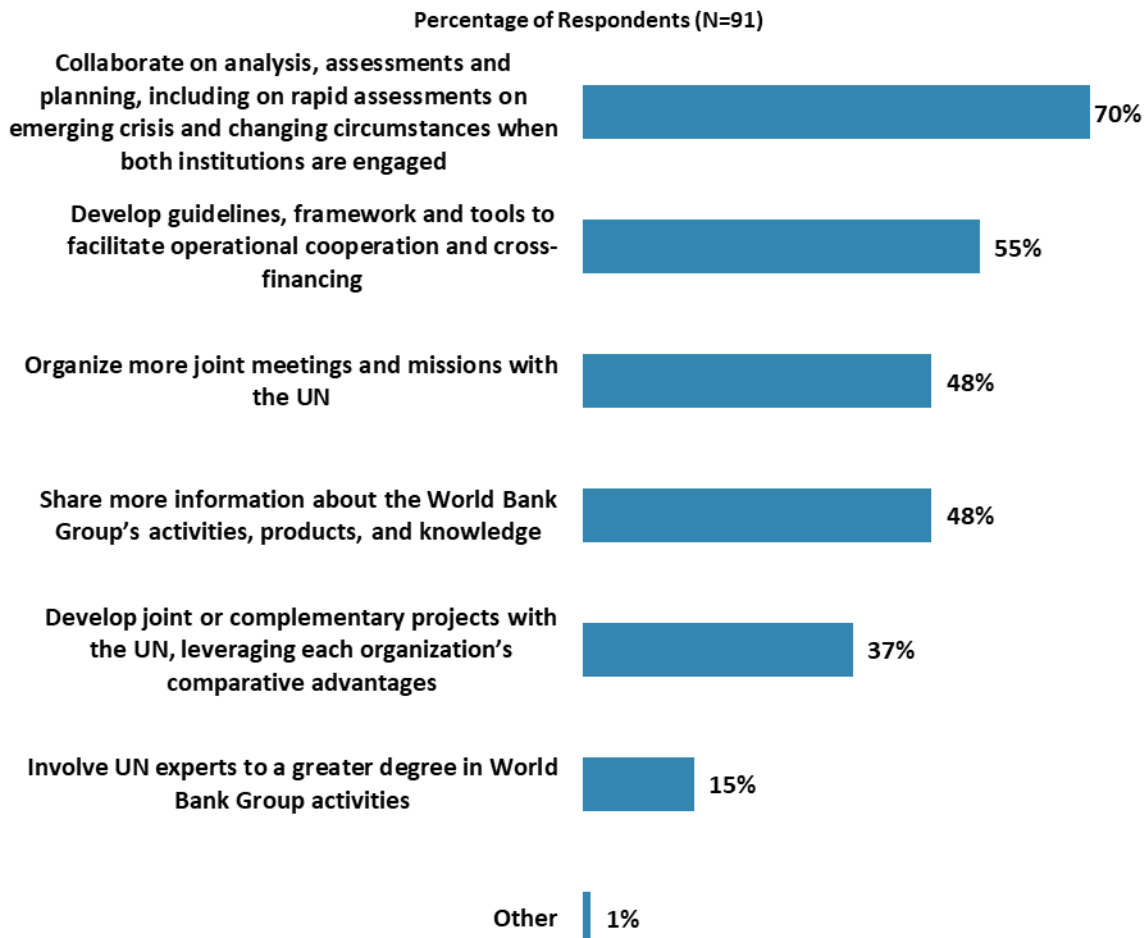

Improving Collaboration with the UN in the Field

- **Year comparison:** Respondents in the FY '14 Country Survey indicated that, to improve collaboration with the UN in the field, the WBG should share more information about the WBG's activities, products, and knowledge (percentage of respondents = 68%) and collaborate on analysis, assessments and planning (63%), followed by developing guidelines, framework, and tools to facilitate operational cooperation and cross-financing (46%) and develop joint or complementary projects with the UN (46%).

WBG Playing a Leading Role

- **Year comparison:** Respondents in the FY '14 Country Survey indicated that it would be most beneficial for the WBG to play a leading role in public financial management (percentage of respondents = 61%) and capacity of state institutions (46%). In contrast, respondents in the FY '14 Country Survey indicated that it would be most beneficial for other donors to play a leading role in access to justice systems (34%), stimulating dialogue to promote peace and stability (33%), access to basic services (32%), public financial management (32%), and social safety nets (31%).

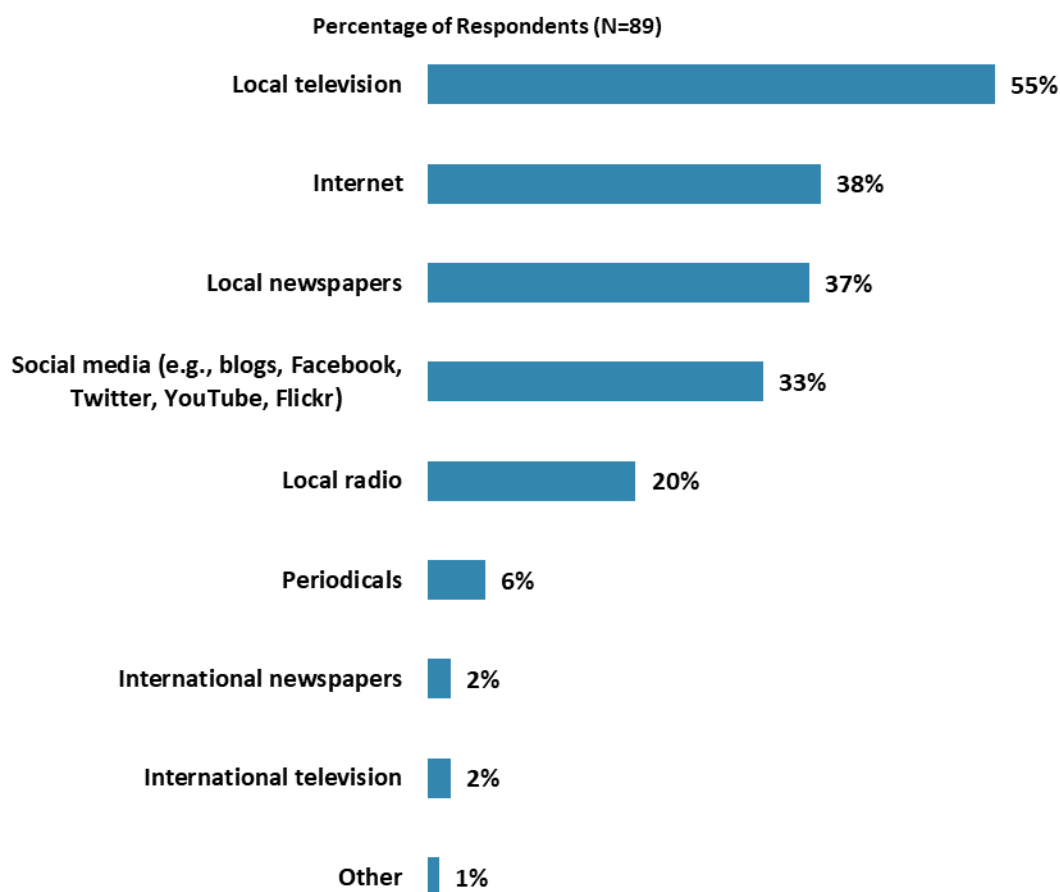

Information Sources

- **Year comparison:** Respondents in the FY '14 Country Survey indicated that they got most of their information about economic and social development issues from local newspapers (percentage of respondents = 53%), local television (47%), and the Internet (37%).



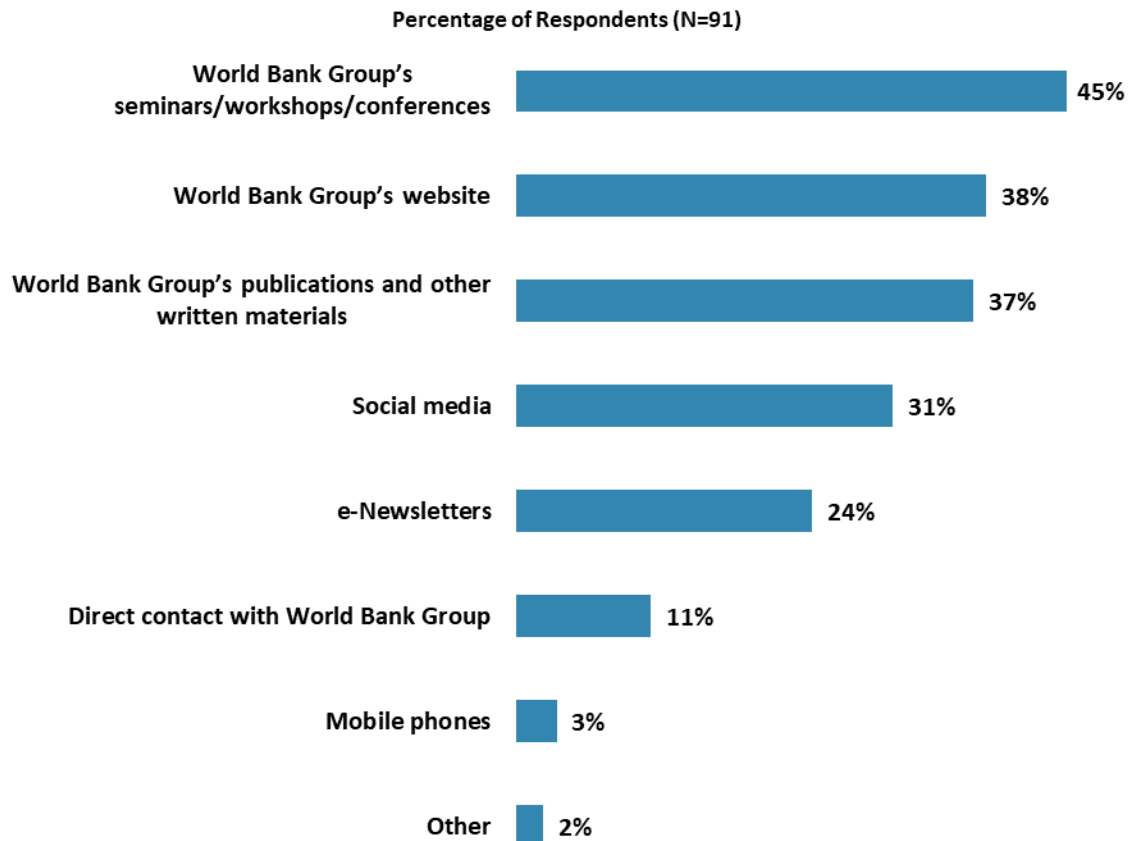
"How do you get most of your information about economic and social development issues in Timor-Leste? (Choose no more than TWO)" (Respondents chose from a list. Responses combined.)

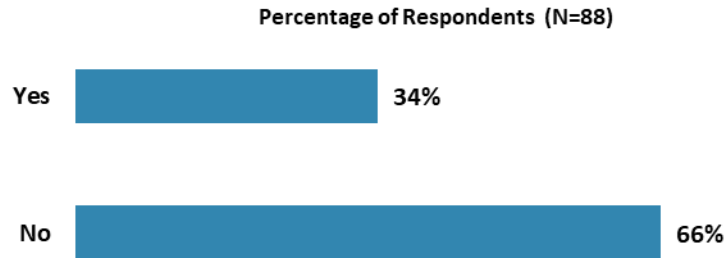
"How would you prefer to receive information from the World Bank Group?

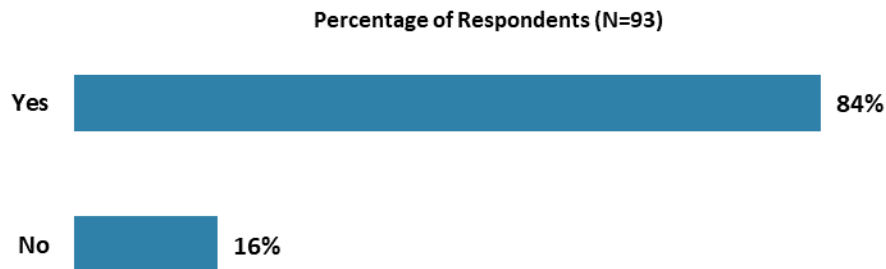

"Do you have reliable access to the Internet?"

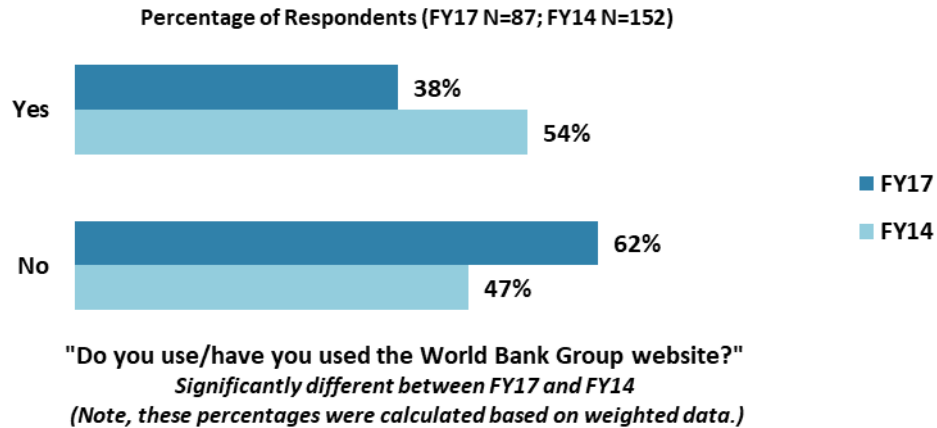

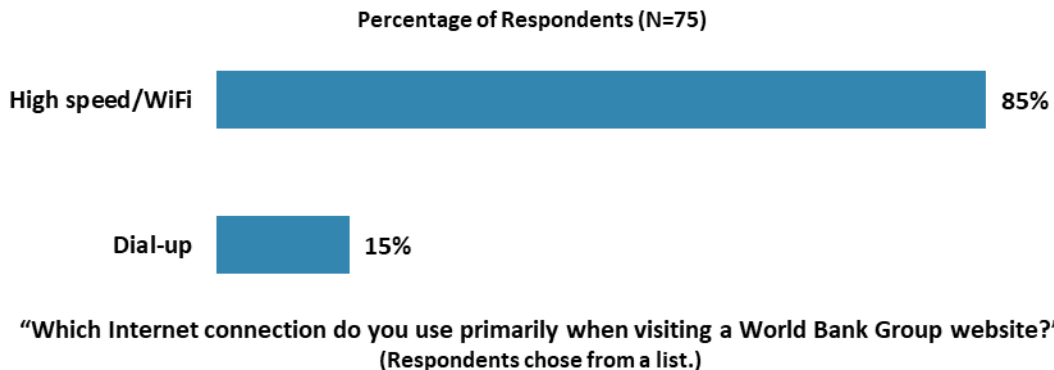

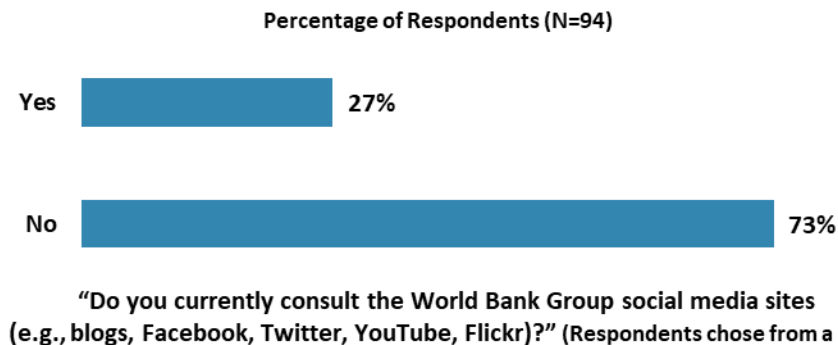
