I. Objectives

This survey was designed to assist the World Bank Group (WBG) in gaining a better understanding of how stakeholders in Haiti perceive the WBG. The survey explored:

- *General Issues Facing Haiti*
- *Overall Attitudes toward the World Bank Group*
- *World Bank Group's Effectiveness and Results*
- *The World Bank Group's Knowledge Work and Activities*
- *Working with the World Bank Group*
- *The Future Role of the World Bank Group in Haiti*
- *Communication and Information Sharing*
- *Background Information*

II. Methodology

From April to July 2018, 473 stakeholders of the WBG in Haiti were invited to provide their opinions on the WBG's work in the country by participating in a Country Opinion Survey. Participants were drawn from the Office of the President, Prime Minister; office of a Minister; office of a Parliamentarian; ministries/ministerial departments/implementation agencies; Project Management Units (PMUs) overseeing implementation of WBG projects; consultants/contractors working on WBG-supported projects/programs; local governments; bilateral and multilateral agencies; private sector organizations; private foundations; the financial sector/private banks; local NGOs and community-based organizations; international NGOs; the media; independent government institutions; trade unions; faith-based groups; youth groups; academia/research institutes/think tanks; the judiciary branch; and other organizations.

A total of 134 stakeholders participated in the survey (28% response rate). Respondents either received and returned the questionnaires via post, completed the questionnaire with a representative from the local fielding agency, or completed the questionnaire via the online survey platform Qualtrics.

Every country that engages in the Country Opinion Survey (COS) must include specific indicator questions that will be aggregated for the World Bank Group's annual Corporate Scorecard. These questions are identified throughout the survey report.

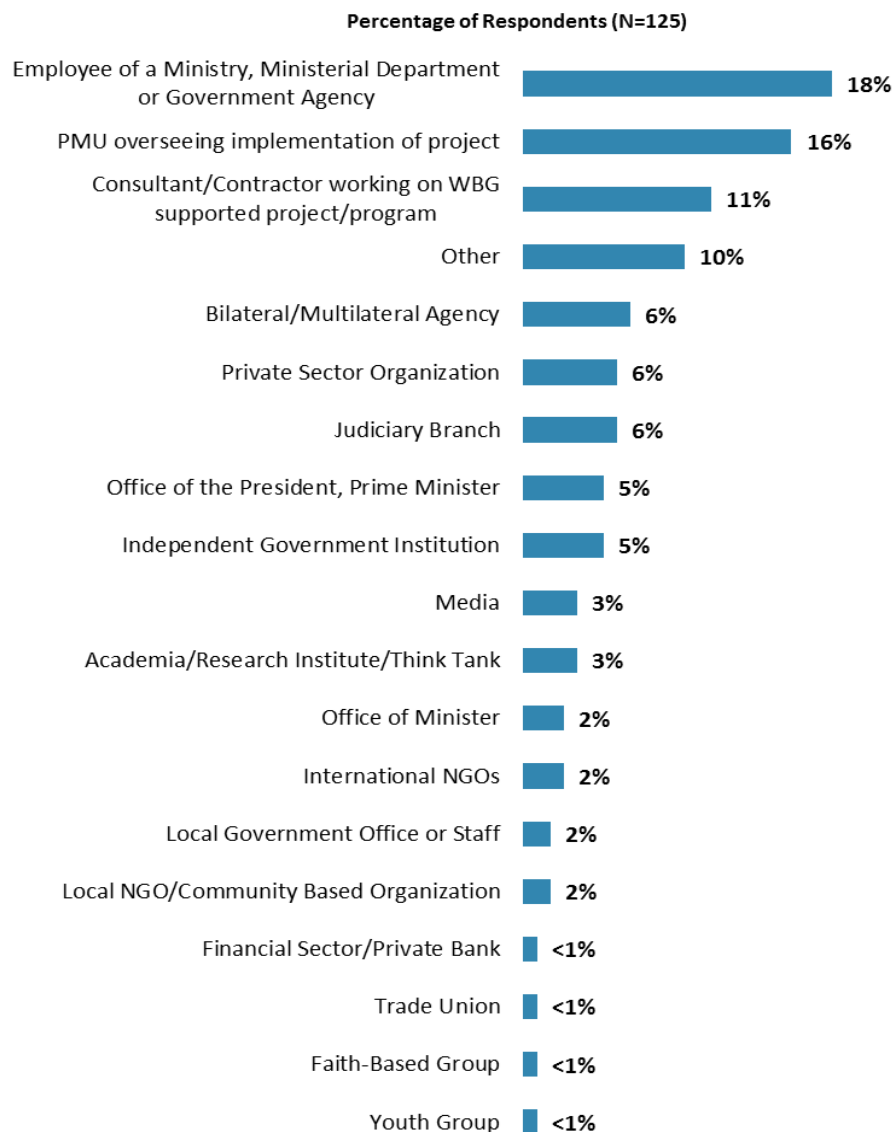
The results in this year's Country Survey were compared to those in the Country Survey conducted in FY'14 (response rate was 50%, N=204). Data were weighted to reach the same stakeholder composition in both years, which allows for year comparisons. Stakeholder groups which were not present in both fiscal years were not included in the comparison. Respondents who belonged to the "other" stakeholder category were not included either. As a result, mean ratings, percentages of respondents, and the total number of respondents in both years are slightly different from those of the original data reported in the FY'14 COS report and the non-weighted data presented in appendices A, B, C, D, and F. III. Demographics of the Sample

Current Position

- For further analyses, respondents from the Office of the President/Prime Minister were combined with respondents from the office of a minister; respondents from PMUs were combined with consultants/contractors working on WBG-supported projects; respondents from the financial sector/private banks were combined with those from private sector organizations; respondents from local NGOs/community based organizations, international NGOs, trade unions, faith-based groups, and youth groups were combined in the “CSO” category; and the small number of respondents from local government, academia/research institutes/think tanks, and the media were included in the “Other” category. There were no respondents from the office of a parliamentarian and private foundations.



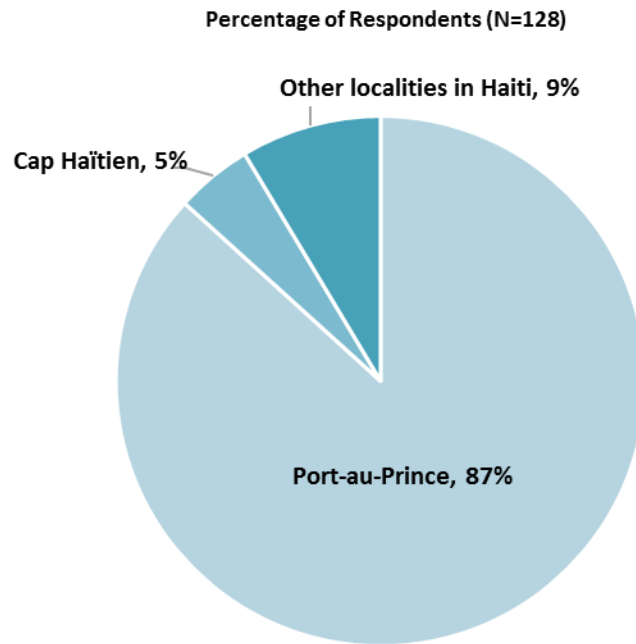
“Which of the following best describes your current position?”

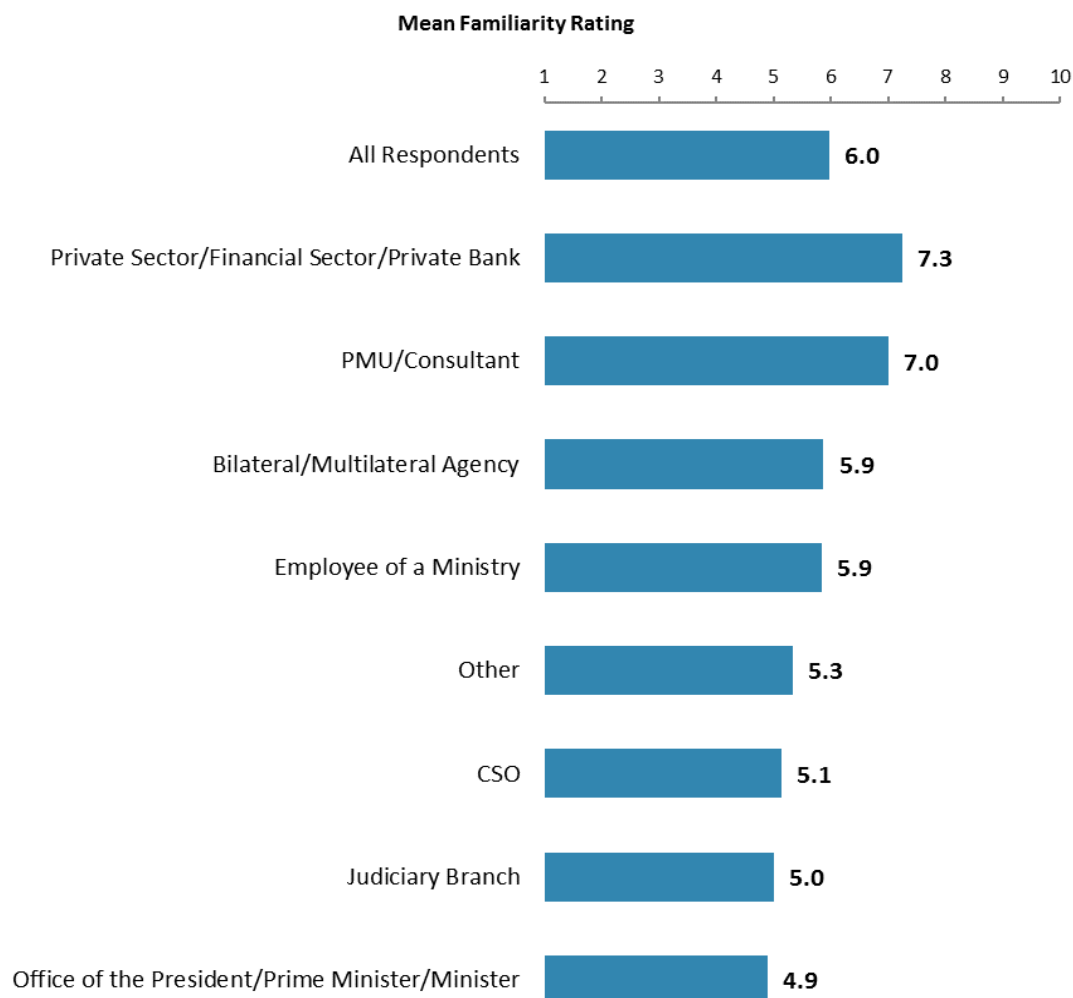
"Which best represents your geographic location?"

Familiarity with the World Bank Group

- **Year comparison:** Respondents in the FY'14 Country Survey had significantly higher levels of familiarity with the WBG than this year's respondents (weighted mean in FY'18 = 6.0; weighted mean in FY'14 = 6.9)¹.
- Respondents' levels of familiarity with the WBG were significantly, strongly correlated with their ratings of the WBG's overall effectiveness in Haiti and the extent to which the WBG plays a relevant role in development in Haiti, and significantly, moderately correlated with their ratings of the extent to which the WBG contributes to the country's development results.

(1-"Not familiar at all", 10-"Extremely familiar")

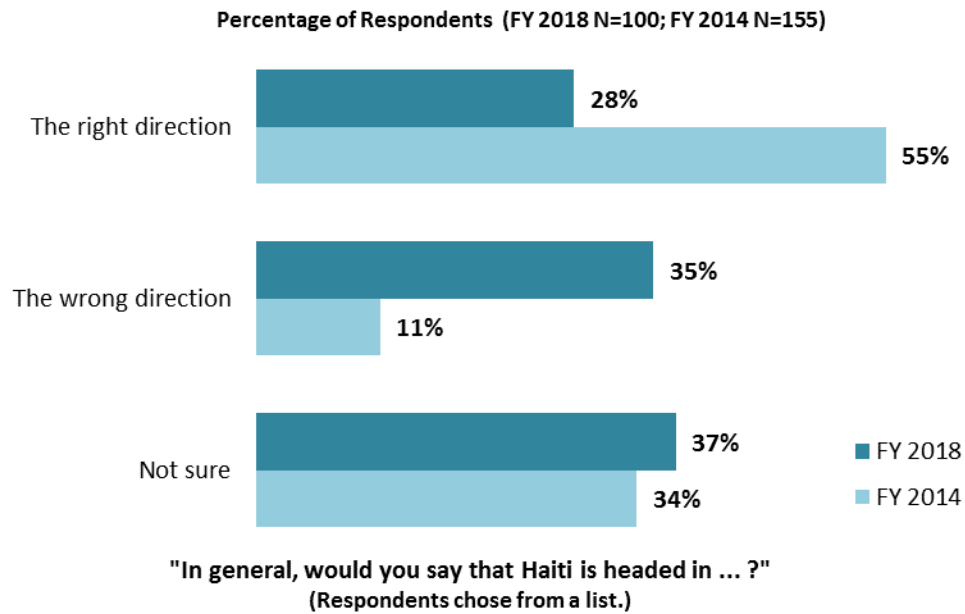

- **Year comparison:** Respondents in this year's Country Survey were significantly less positive about the prospects of Haiti compared to respondents in the FY'14 Country Survey.



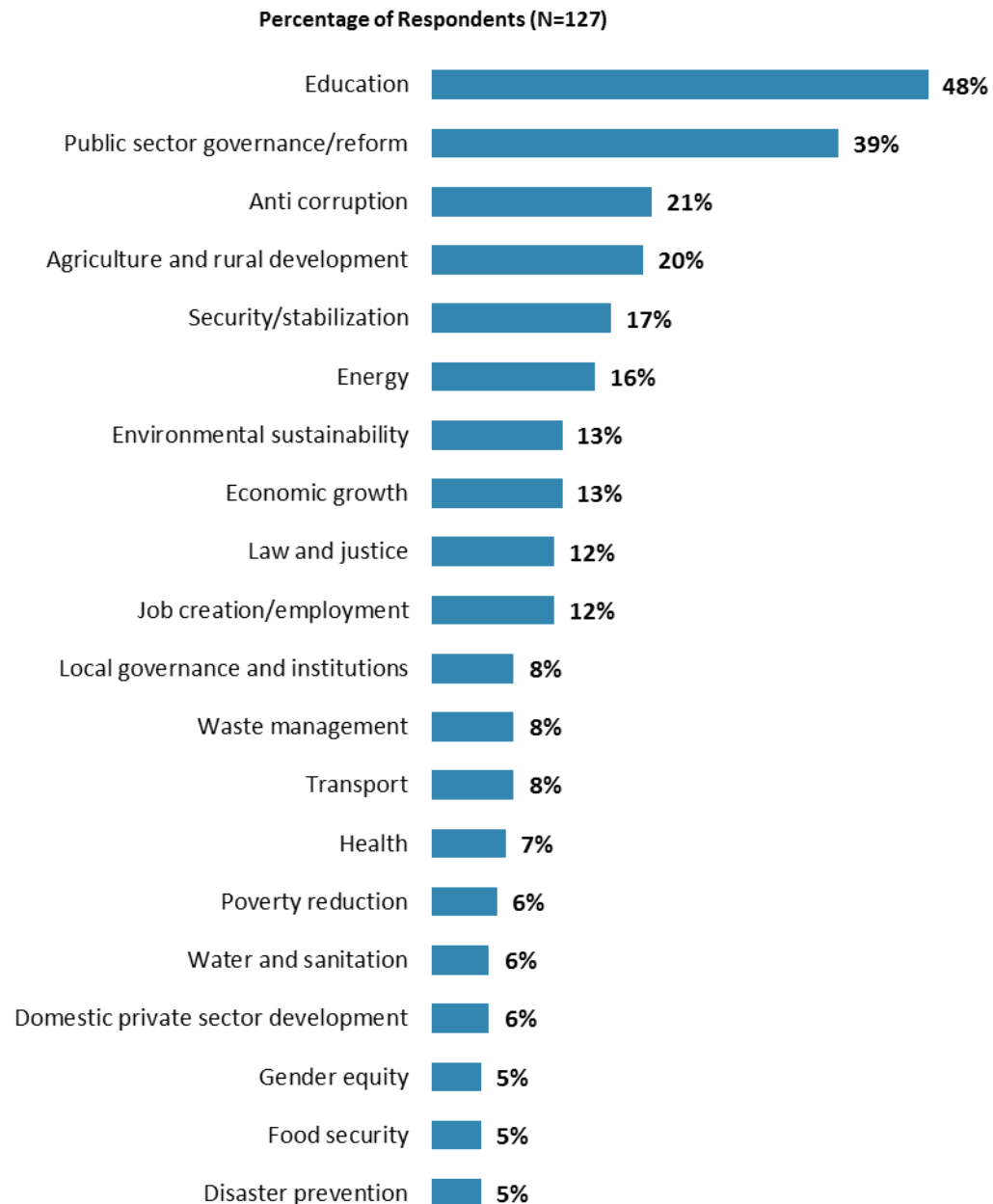

Development Priority

- **Year comparison:** Respondents in the previous FY'14 Country Survey indicated that the most important development priorities in Haiti were “*education*” (66%), “*public sector governance/reform*” (51%), and “*job creation/employment*” (33%).



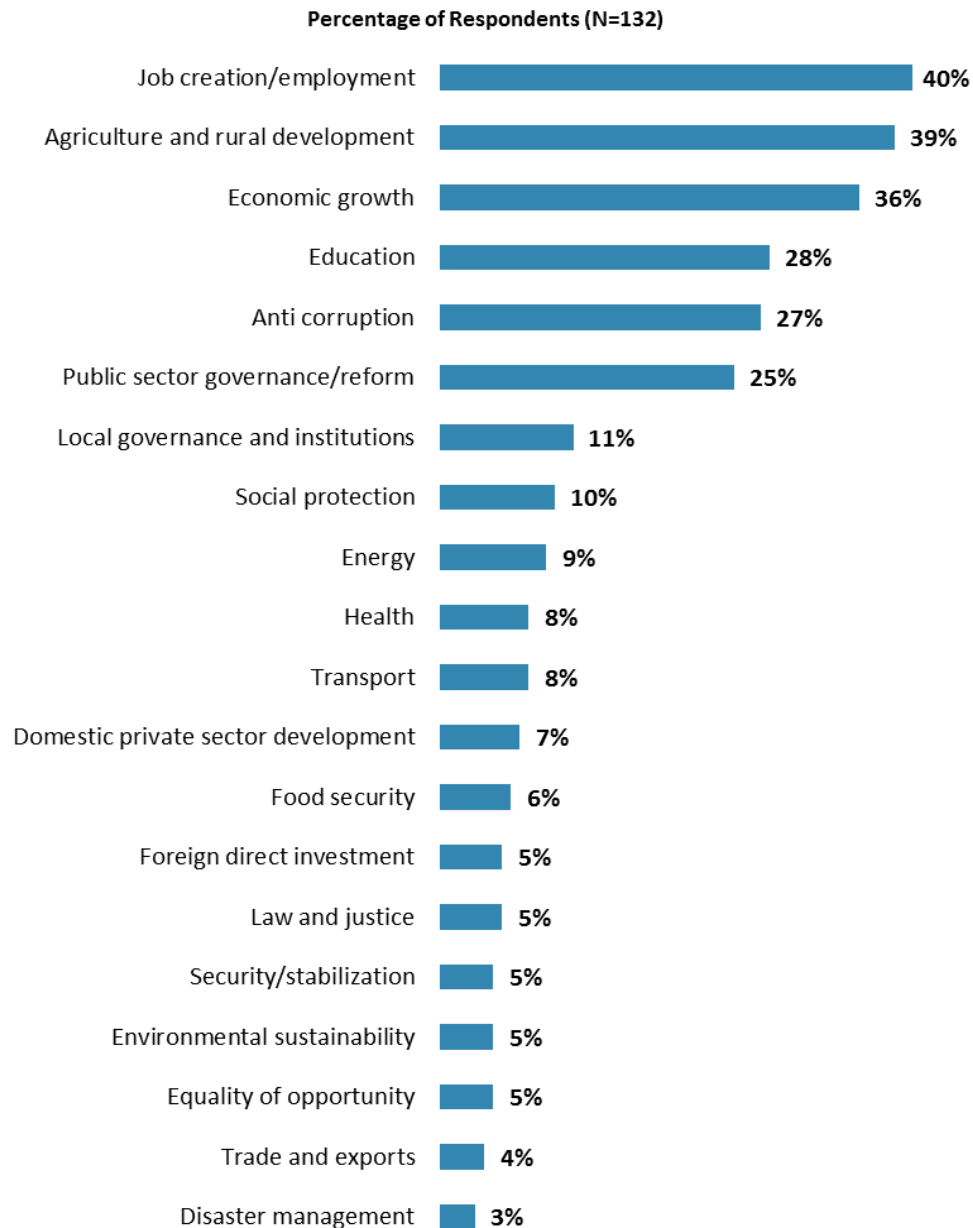

What Would Contribute Most to Reducing Poverty

- **Year comparison:** Respondents in the previous FY'14 Country Survey indicated that the biggest contributors to poverty reduction in Haiti were “*job creation/employment*” (57%), “*education*” (51%), “*economic growth*” (44%), “*rural development*” (39%), “*agricultural development*” (34%), and “*anti-corruption*” (29%).

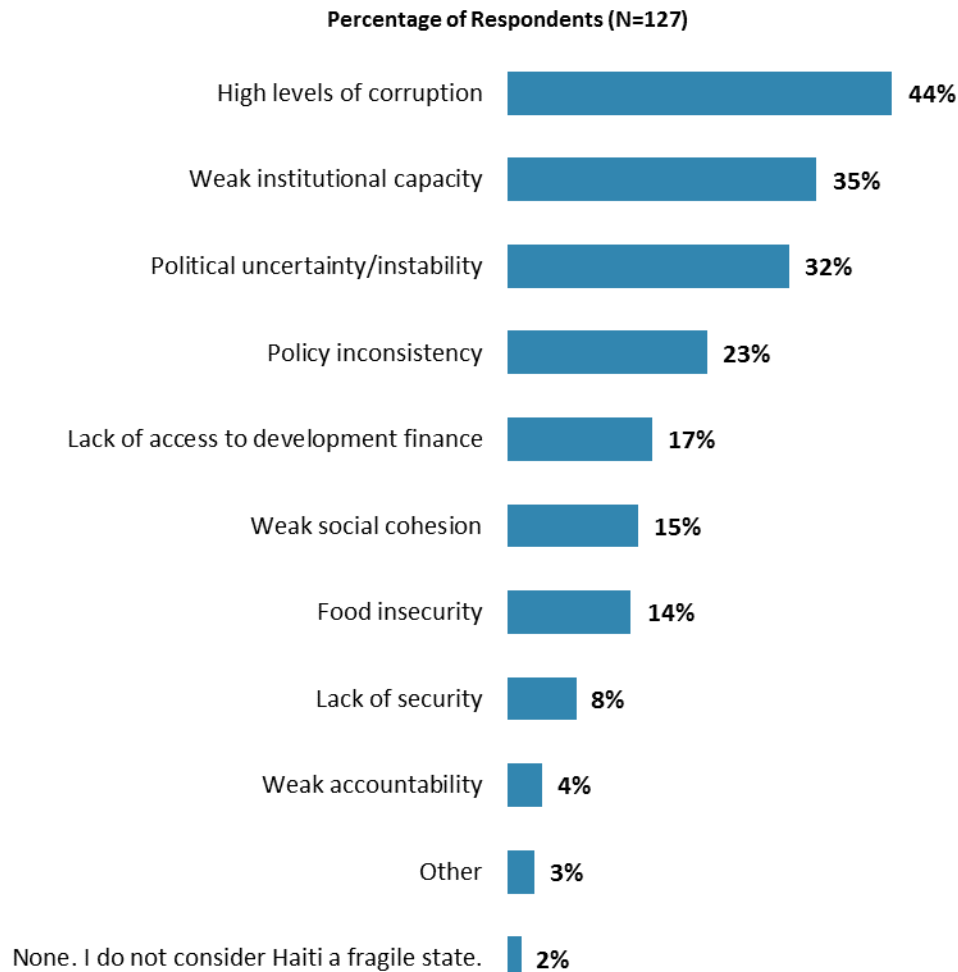

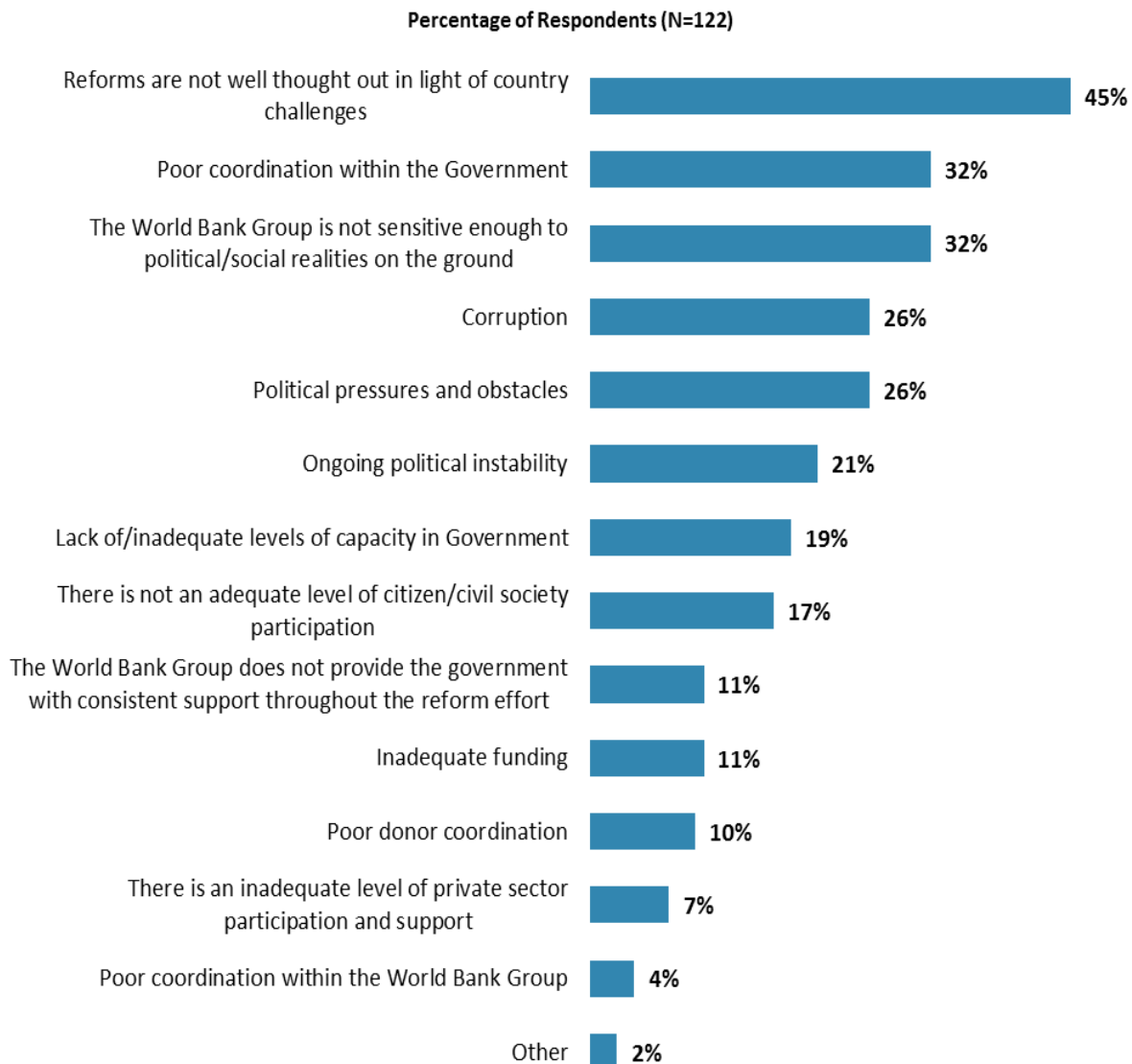

V. Overall Attitudes toward the World Bank Group

Attributing Failed/Slow Reform Efforts

- **Year comparison:** Respondents in the previous FY'14 Country Survey most often attributed failed or slow WBG assisted reform efforts to “*there is not an adequate level of citizen/civil society participation*” (38%), “*lack of/inadequate levels of capacity in Government*” (36%), “*lack of adequate level of decision-making in Government*” (29%), “*the WBG is not sensitive enough to political/social realities on the ground*” (28%), and “*reforms are not well thought out in light of country challenges*” (23%).

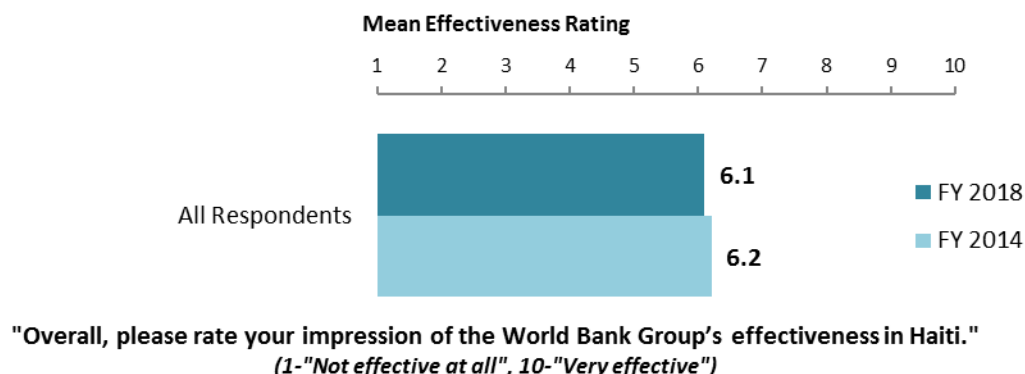

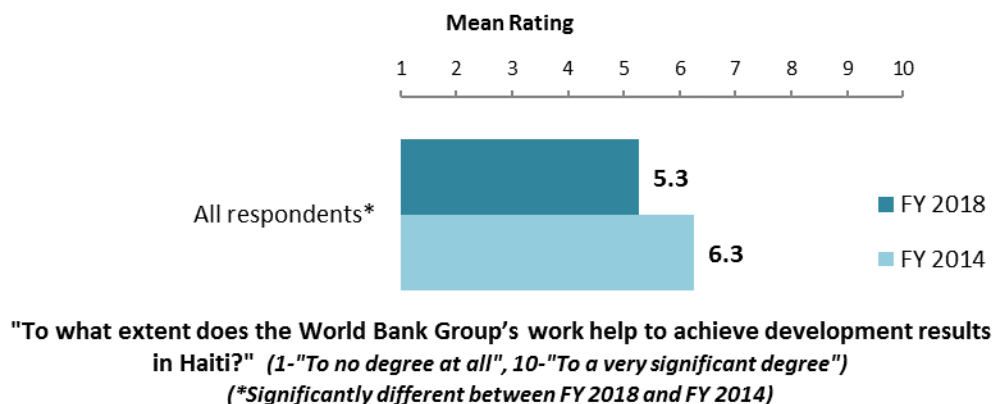

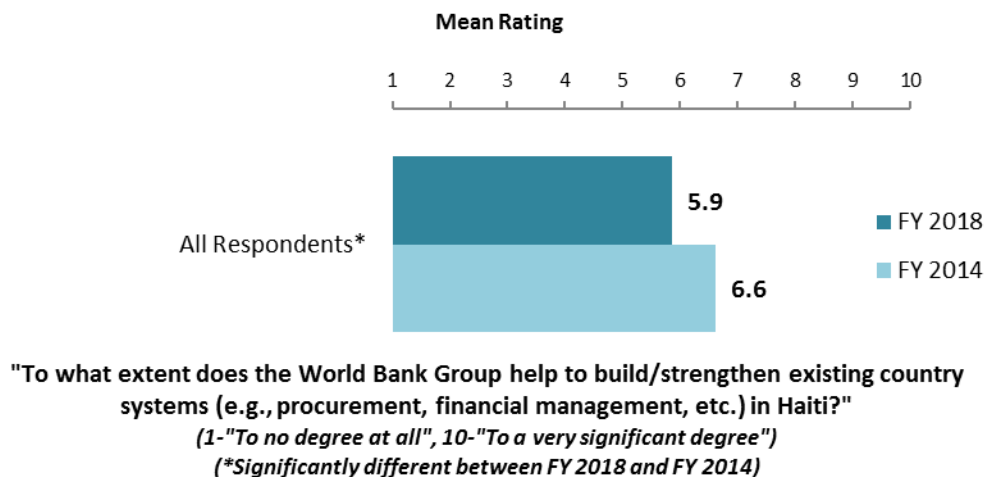
The World Bank Group's Overall Effectiveness³ (Indicator Question)

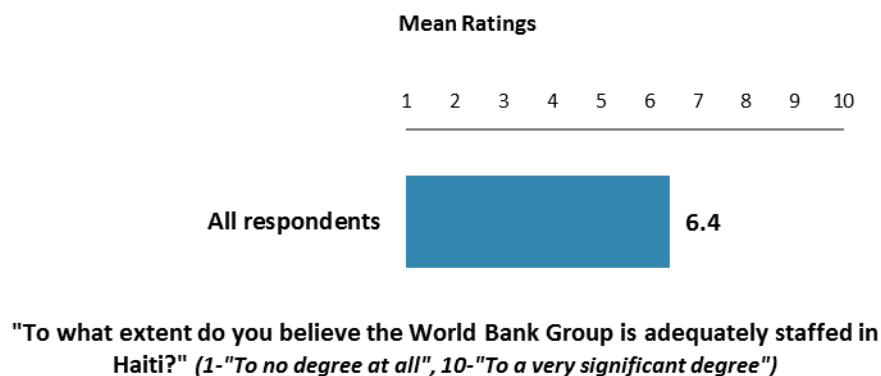

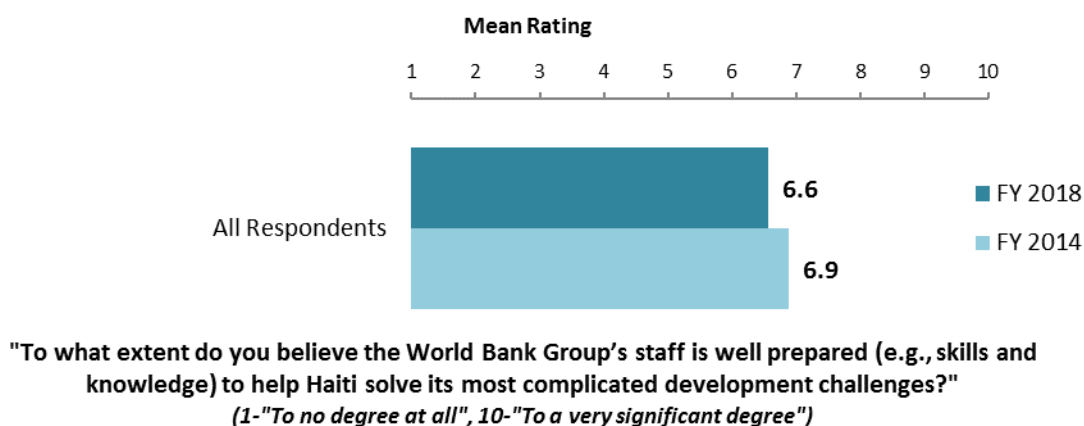

WBG Staff Preparedness⁴



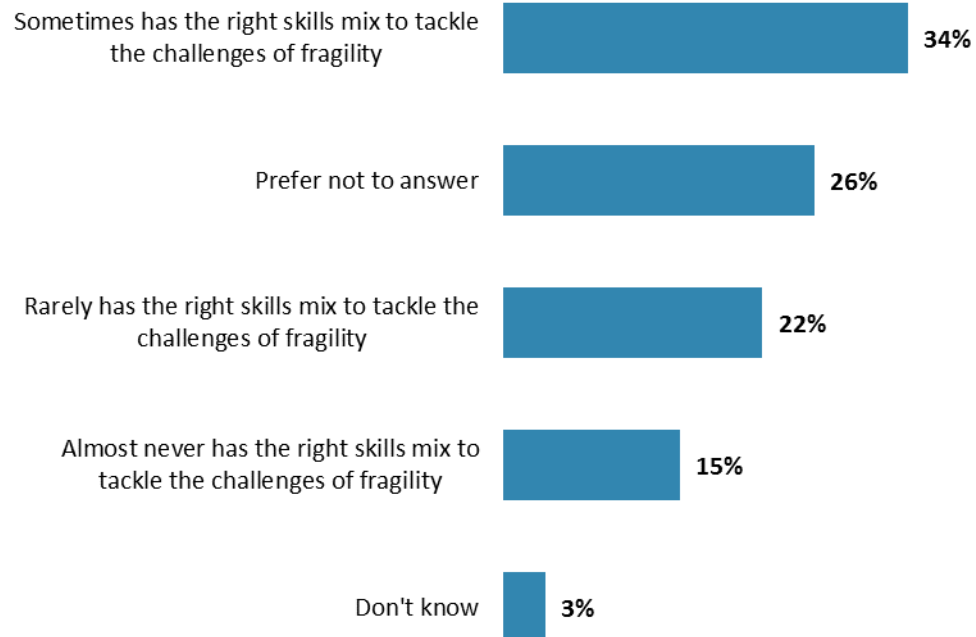

Percentage of Respondents (N=115)

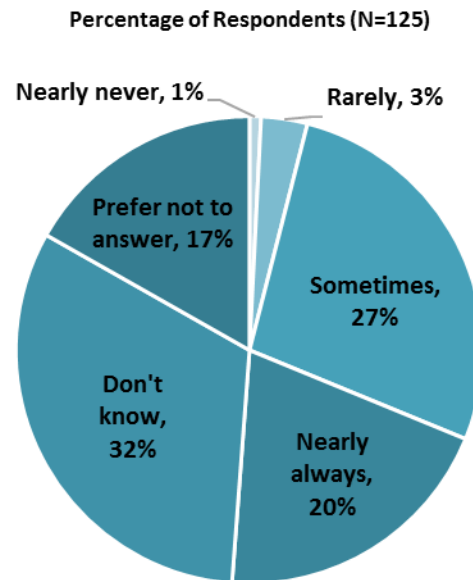


"When working with the World Bank Group on programs, projects and other activities, do you believe that the team ... ?"

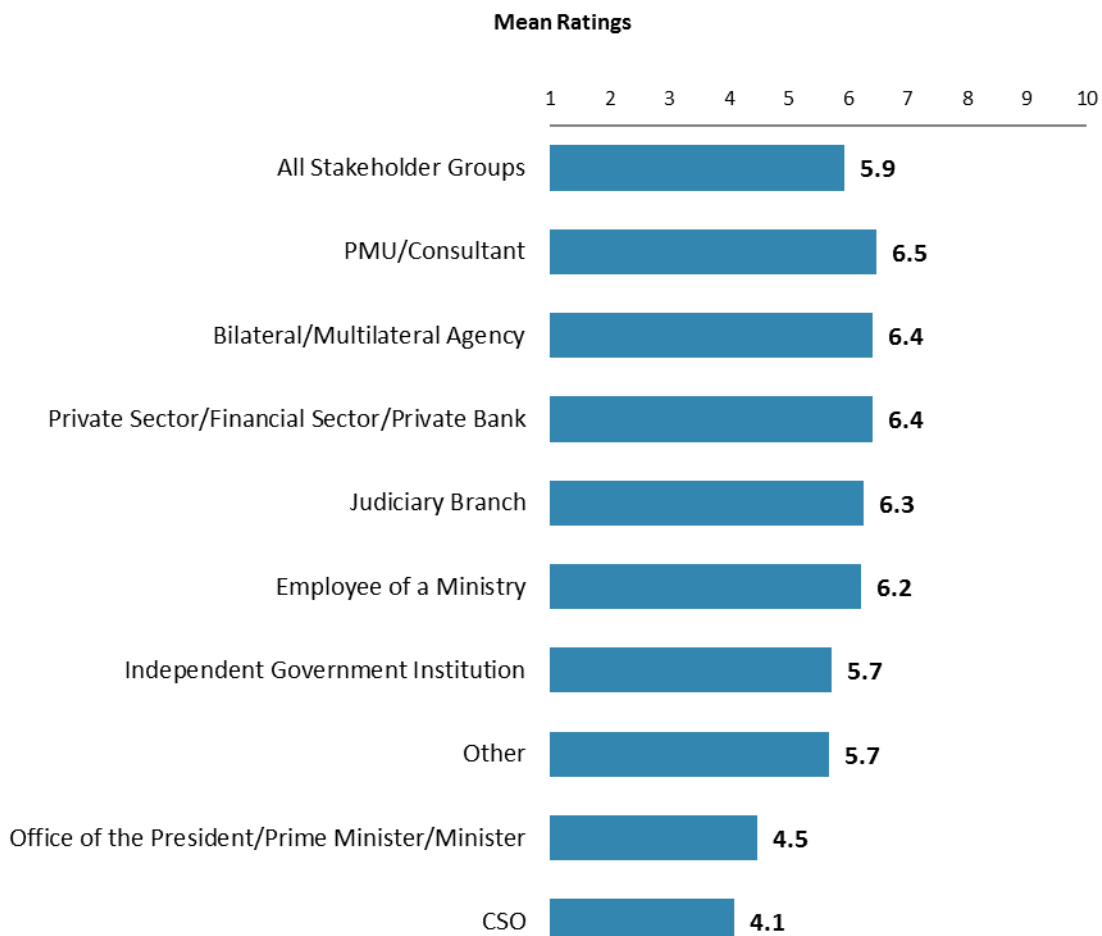
"To what extent does the World Bank Group partner with the right people to support work on the ground in Haiti?" (Respondents chose from a list.)

Overall Ratings for Indicator Questions by Stakeholder Groups

- **Stakeholder groups:** Respondents from PMUs/Consultants/Contractors on WBG-supported projects had the highest mean ratings for the aggregated responses to the twenty-eight COS indicator questions, whereas the respondents from CSOs had significantly lower mean ratings. Responses for individual indicator questions by stakeholder groups can be found in Appendix B (see page 68).
- **Collaboration:** Respondents who collaborate with the WBG had significantly higher mean ratings for the aggregated responses to the twenty-eight COS indicator questions (mean rating = 6.2) compared to respondents who do not collaborate with the WBG (mean rating = 5.4). 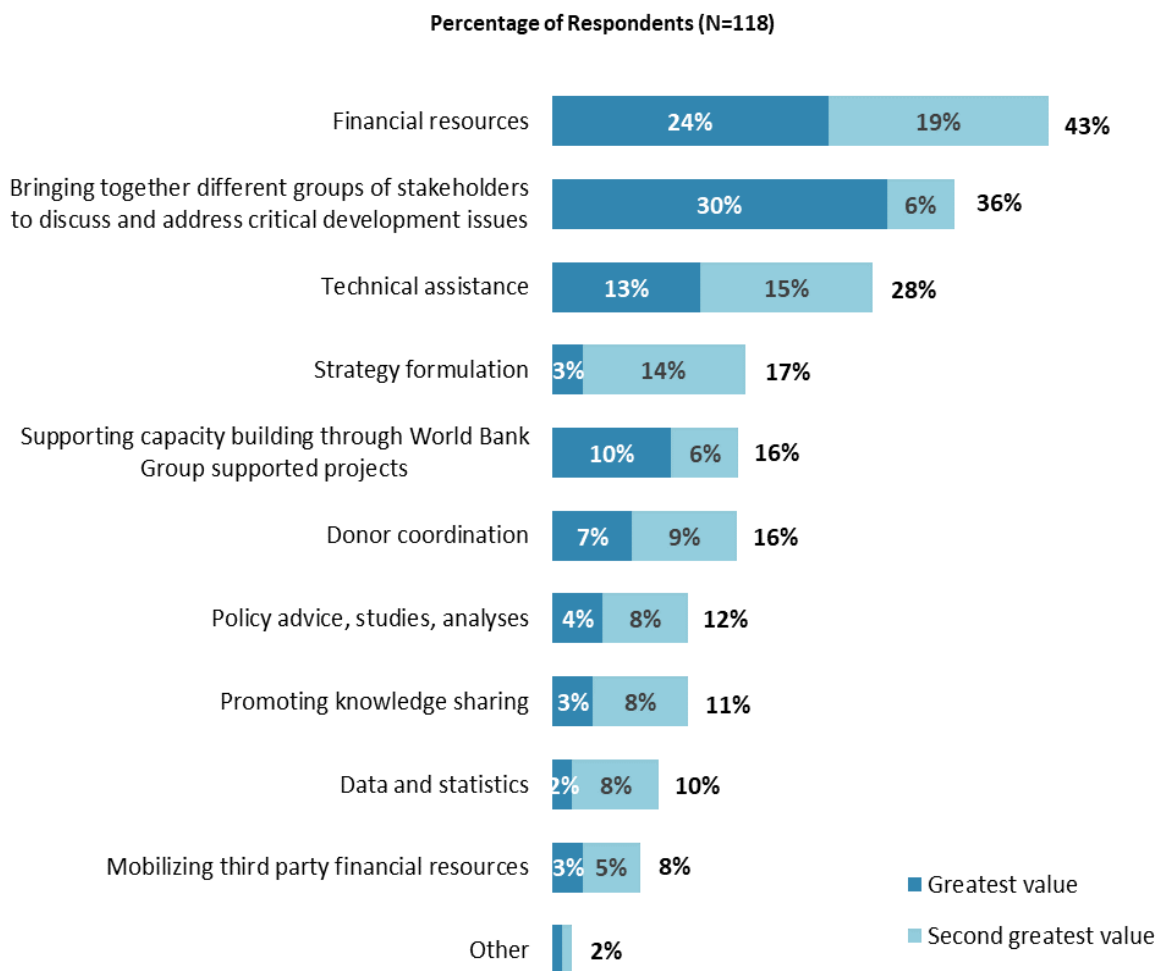
Mean Ratings for All Indicator Questions by Stakeholder Groups on a Scale from 1 to 10

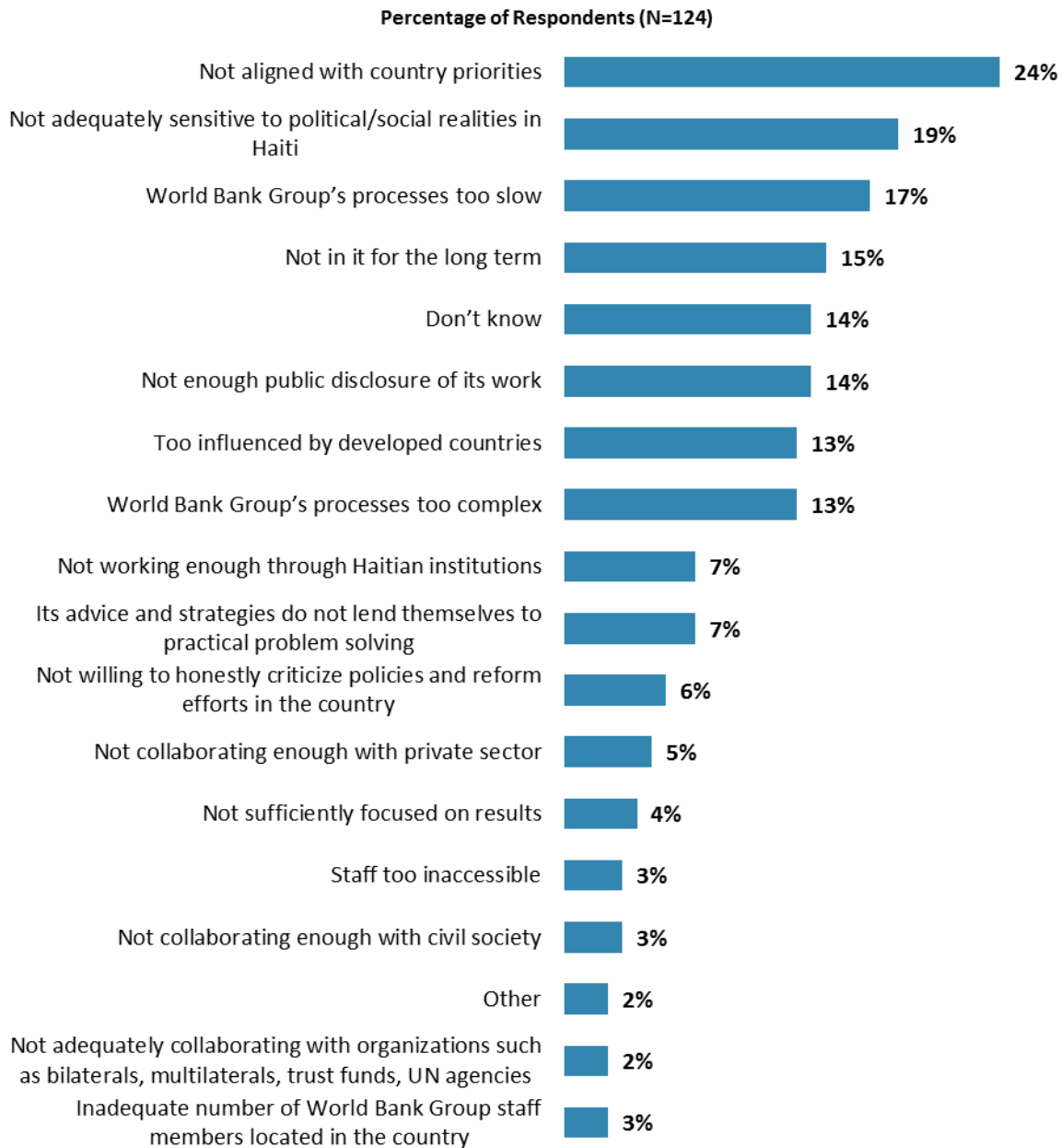

Greatest Weakness

- **Year comparison:** Respondents in the previous FY'14 Country Survey indicated that the WBG's greatest weaknesses in its work in Haiti were "*not adequately sensitive to political/social realities in Haiti*" (18%), "*not enough public disclosure of its work*" (16%), "*not collaborating enough with non-state actors*" (15%), and "*WBG's processes too complex*" (14%).



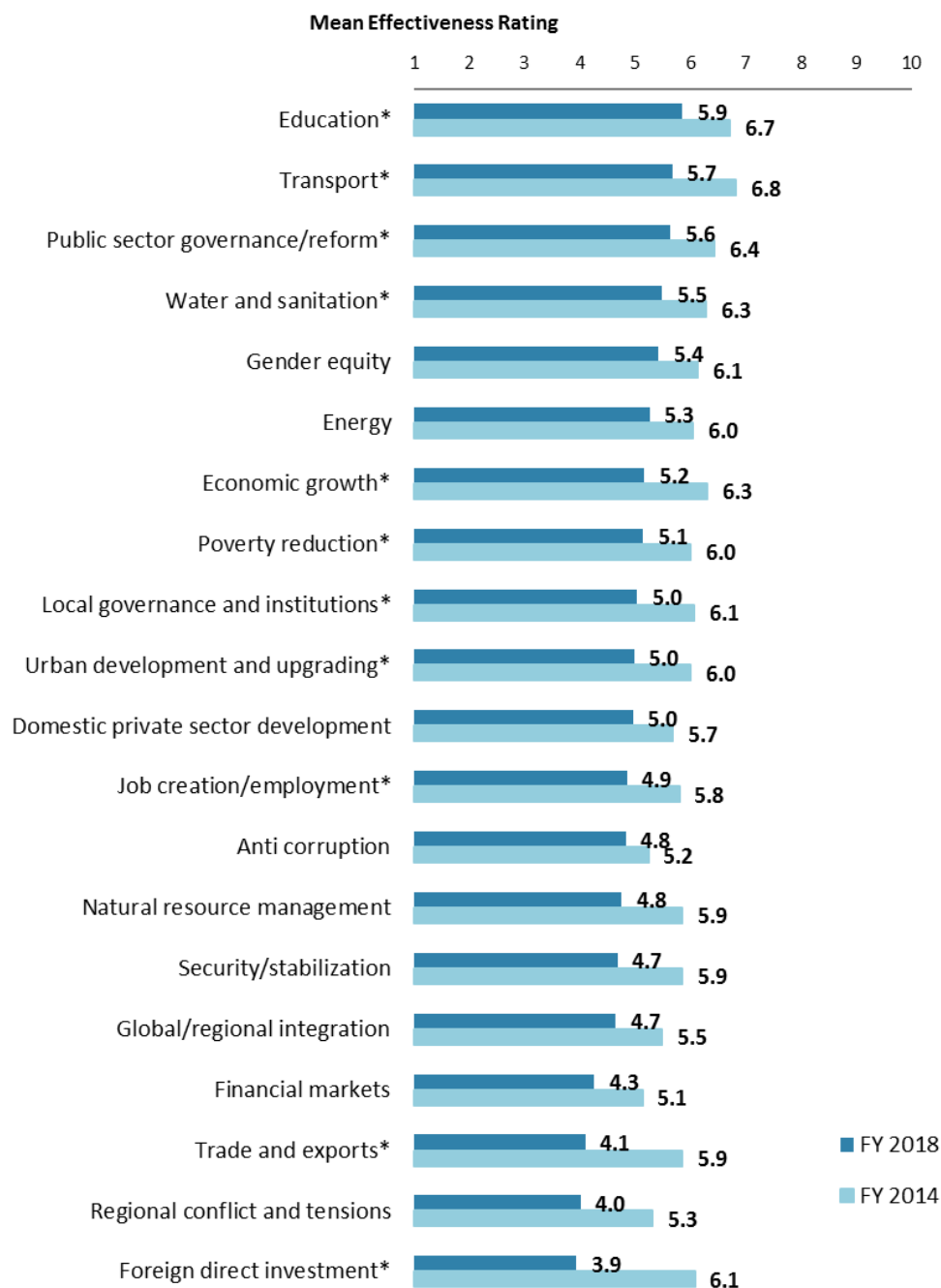
"Which of the following do you identify as the World Bank Group's greatest WEAKNESSES in its work in Haiti? (Choose no more than TWO)"

Effectiveness of WBG's Support in Sectoral Areas: Year Comparison⁵



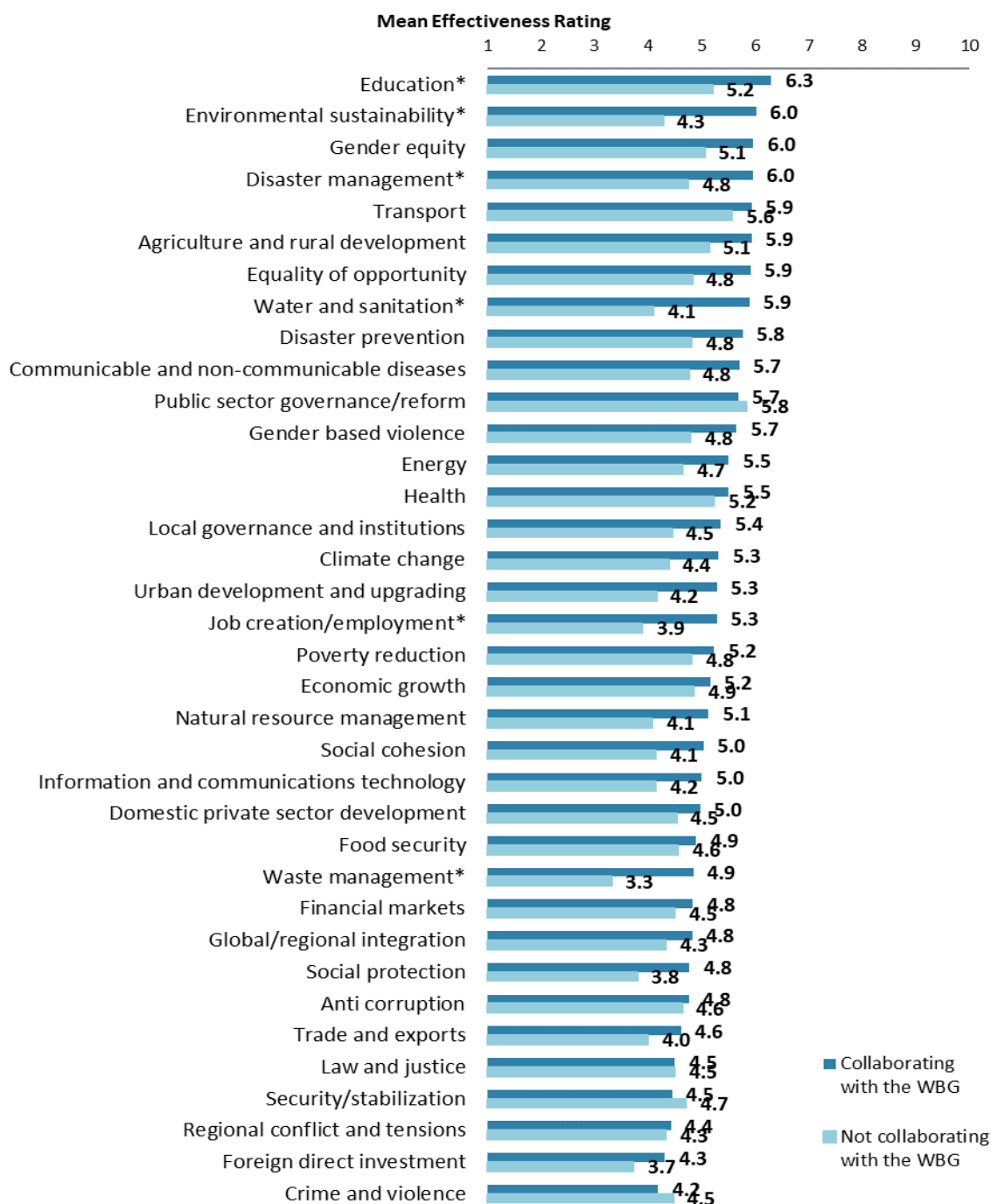

Effectiveness of WBG's Support in Sectoral Areas: Collaboration⁶



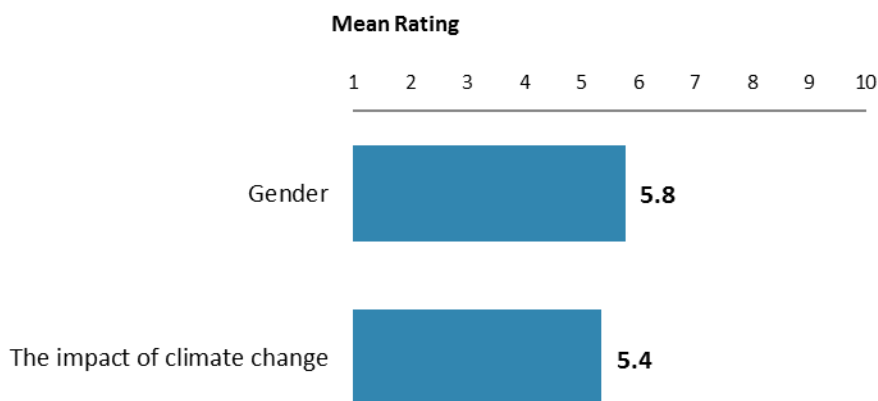

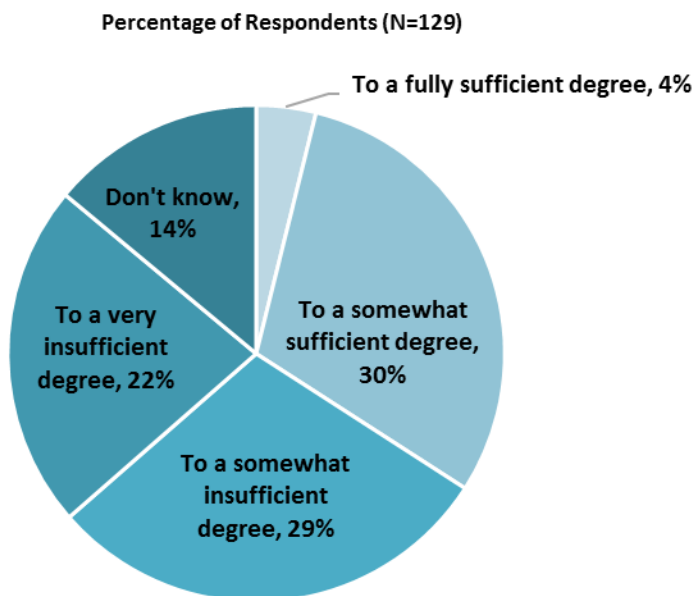

Helping the Poorest

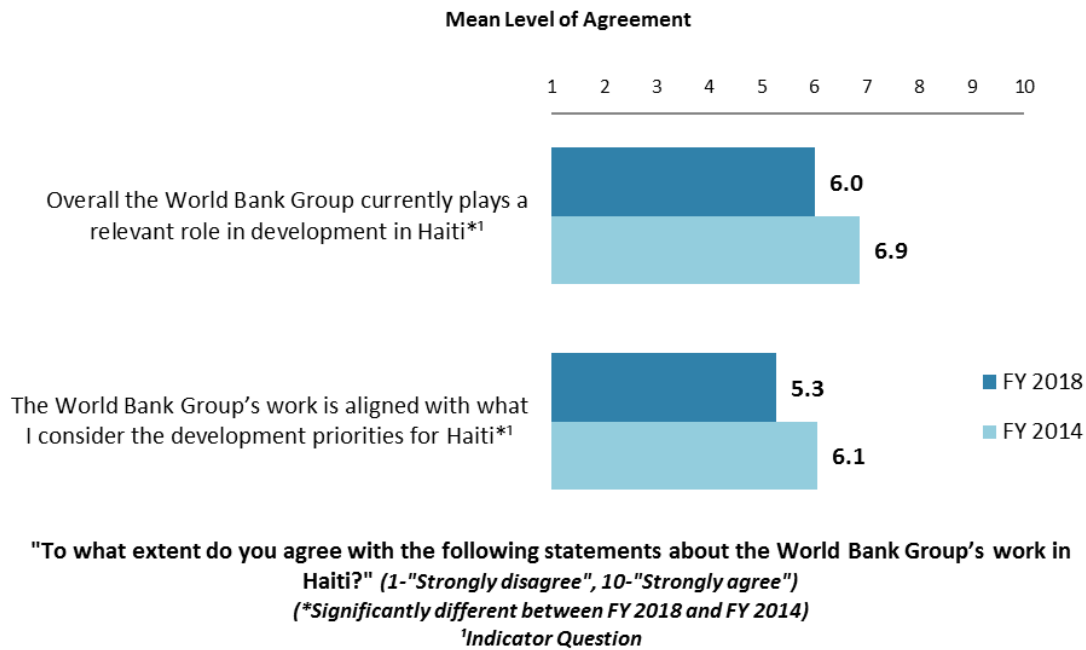


"To what extent do you believe that the World Bank Group's work and support help the poorest (i.e., the bottom 40 percent of the income distribution) in Haiti?"

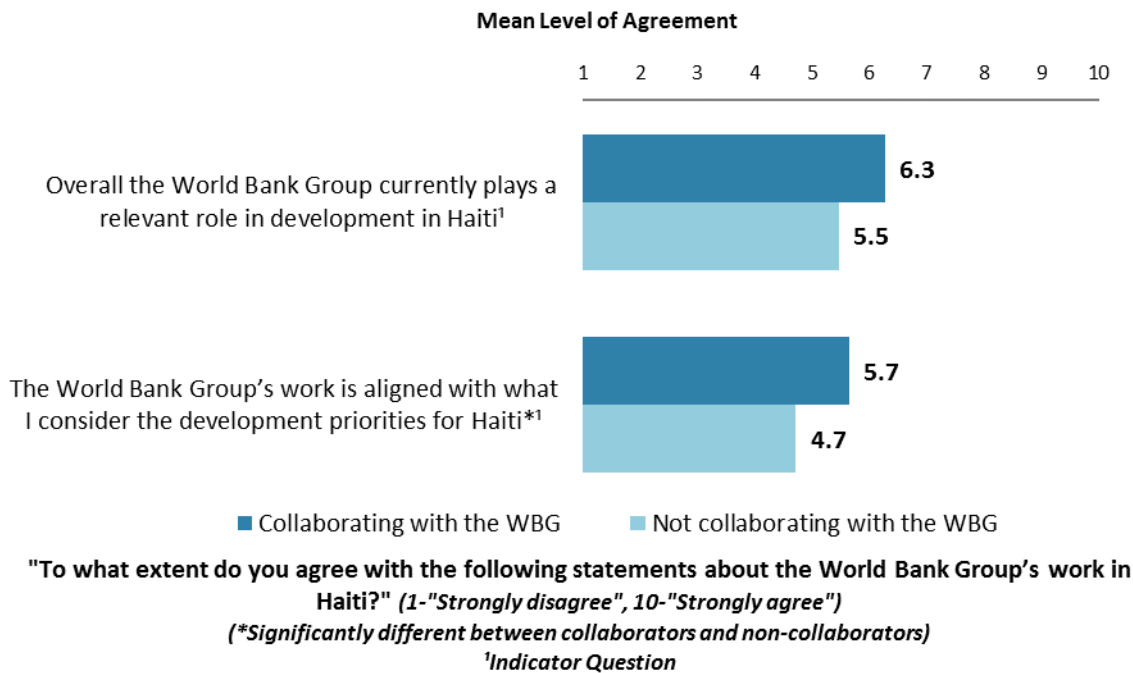

The World Bank Group's Work in Haiti: Collaboration

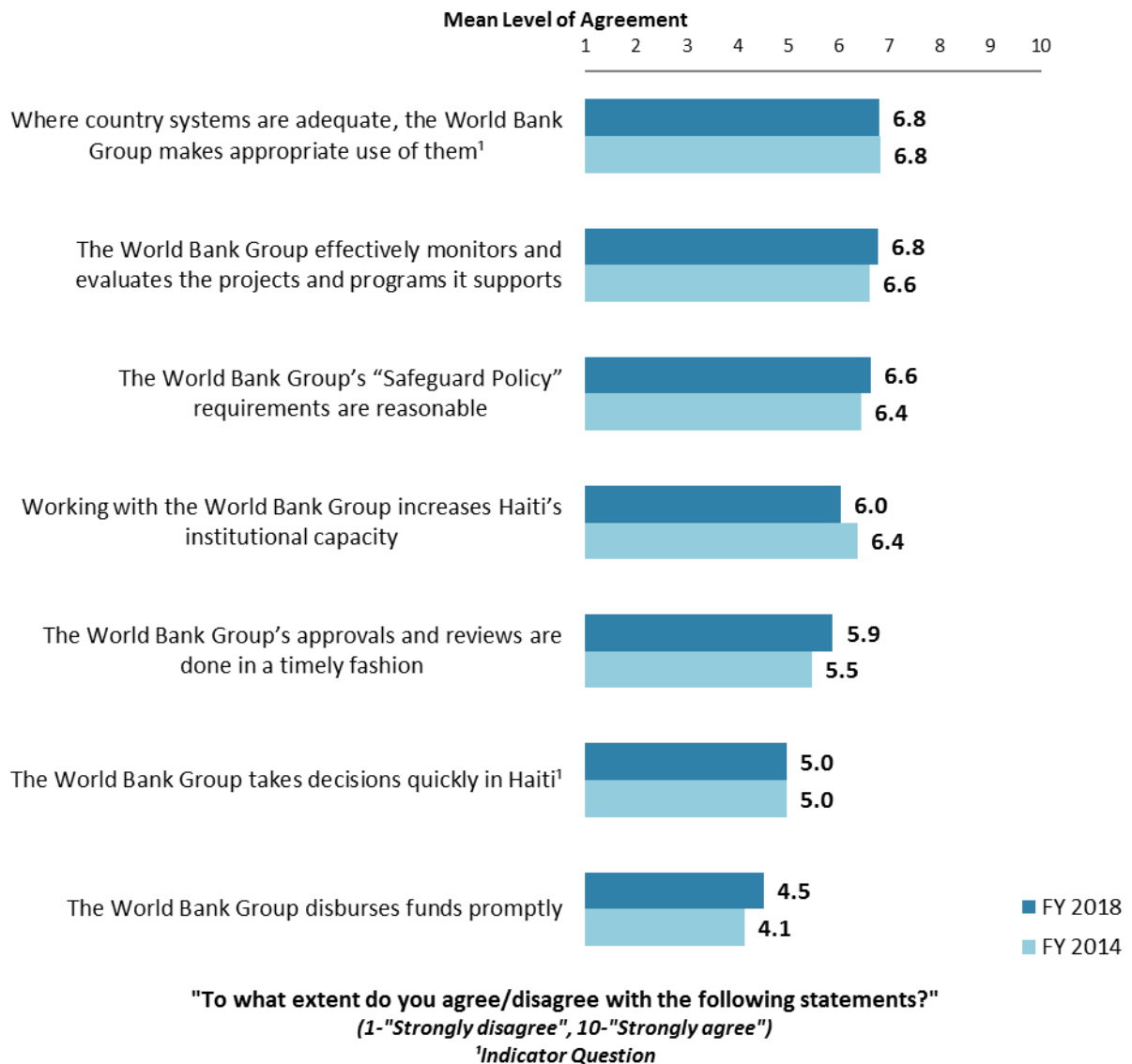

Overall Perceptions: Year Comparison⁸

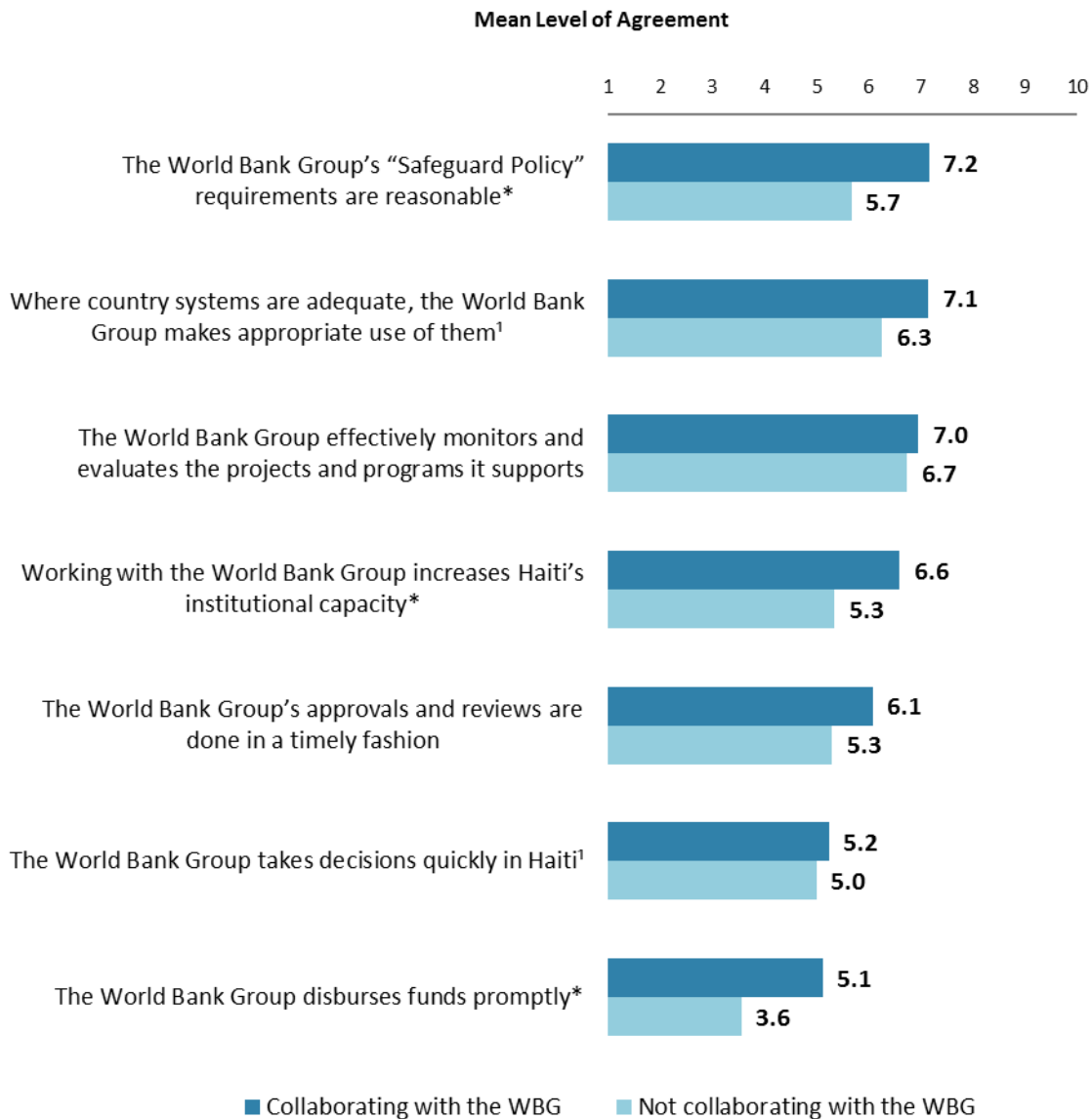

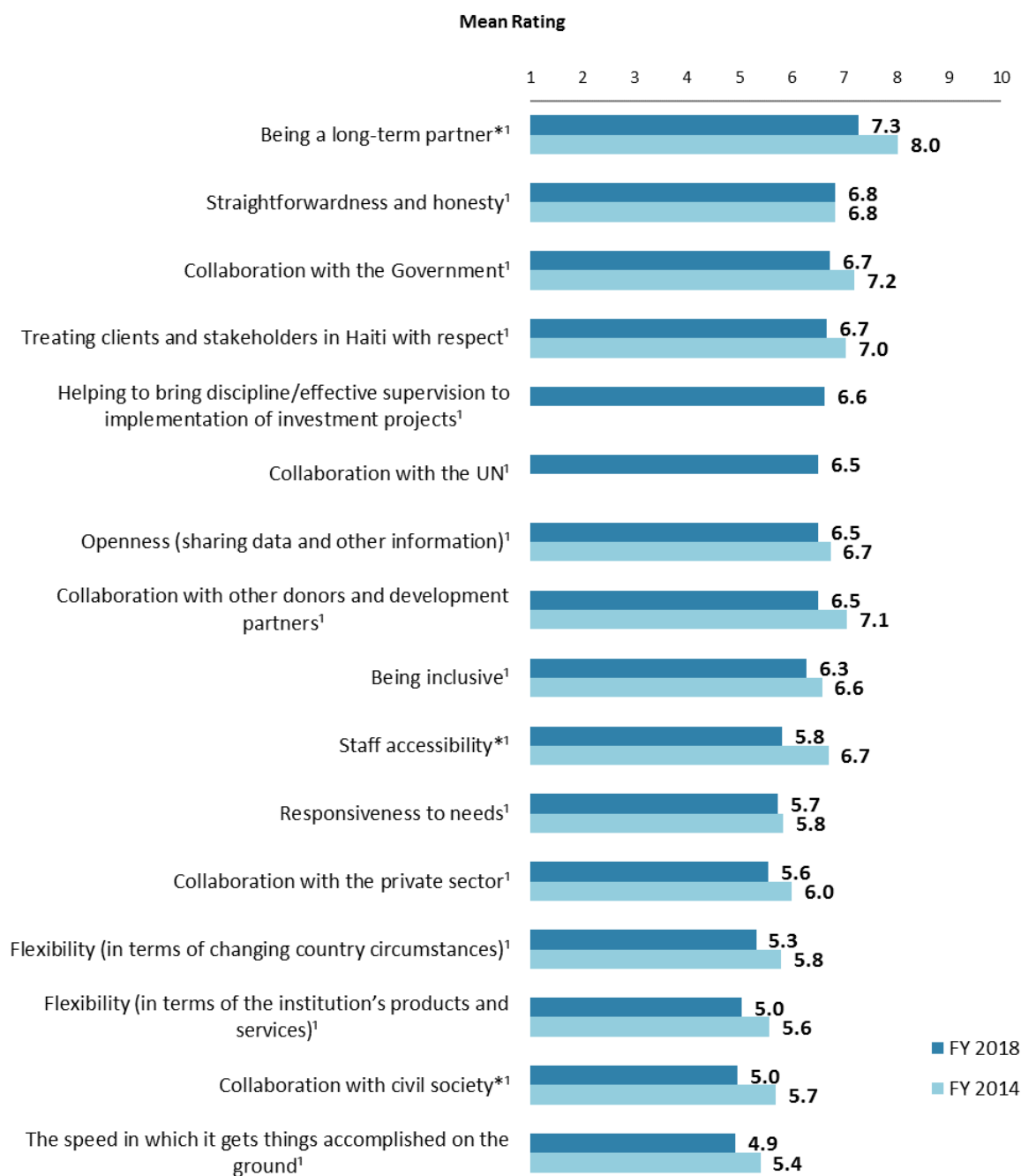

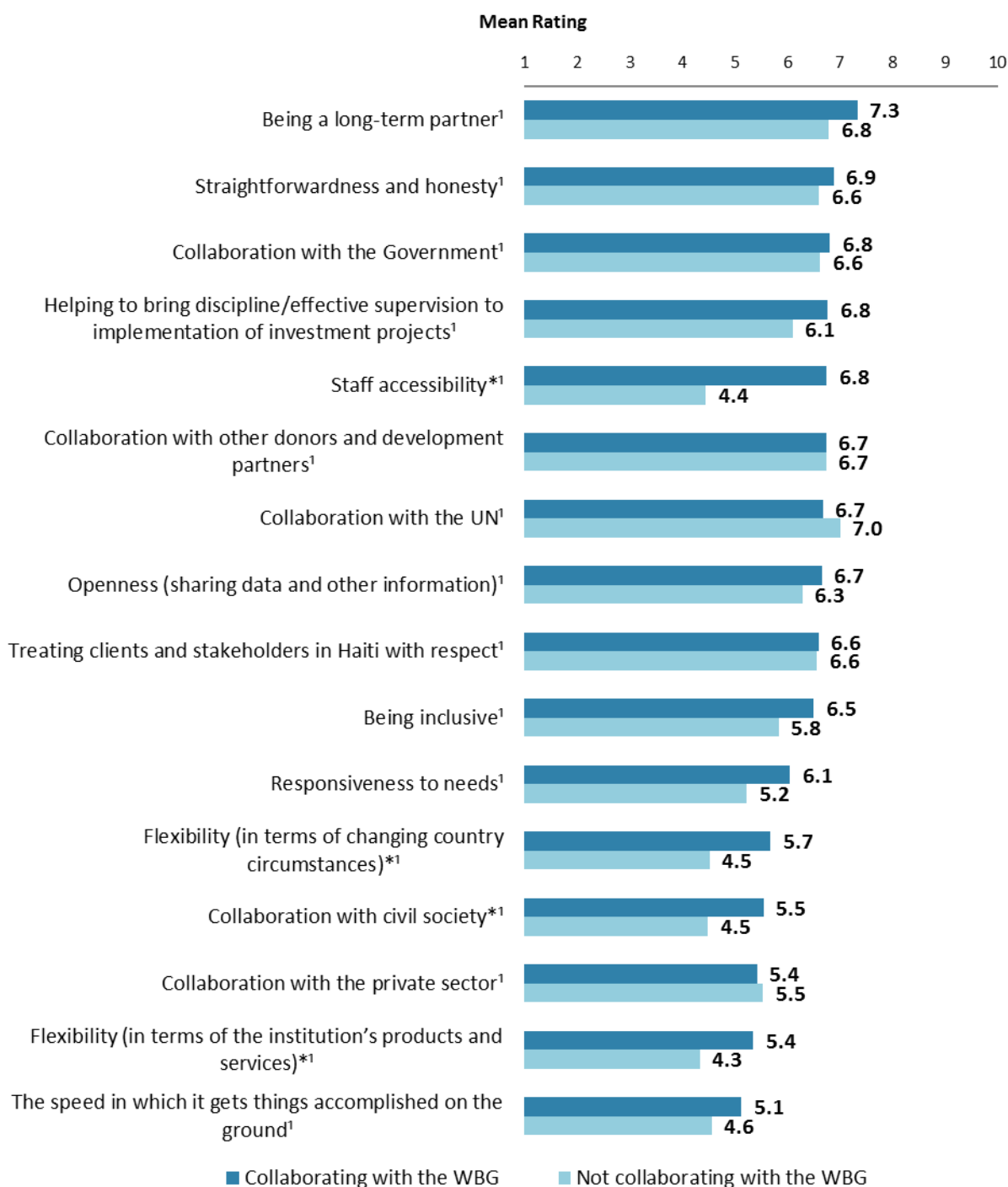

"To what extent is the World Bank Group an effective development partner in Haiti, in terms of each of the following?" (1-"To no degree at all", 10-"To a very significant degree")

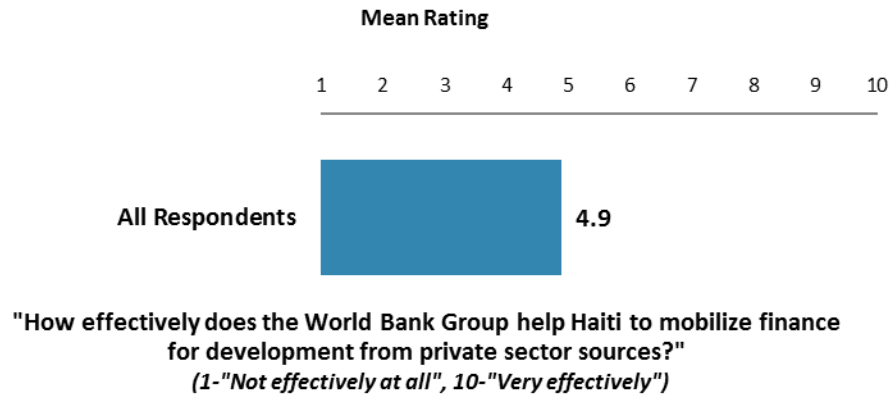

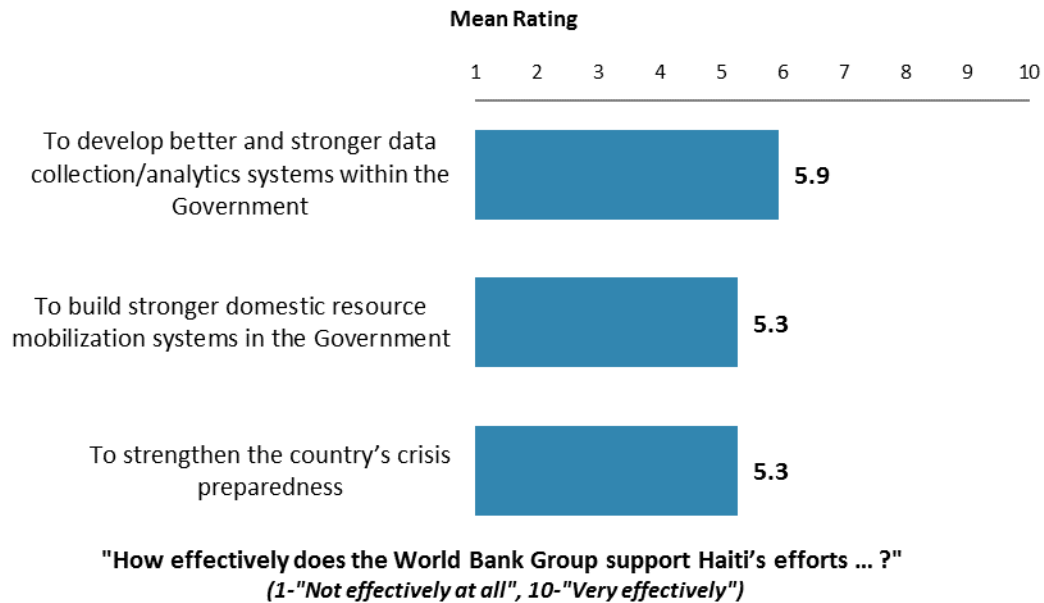

Mobilizing Finance for Development from Private Sector Sources



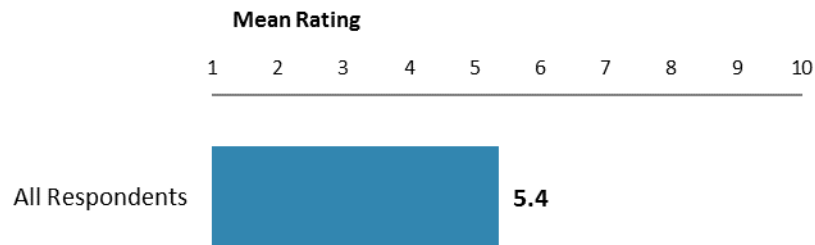

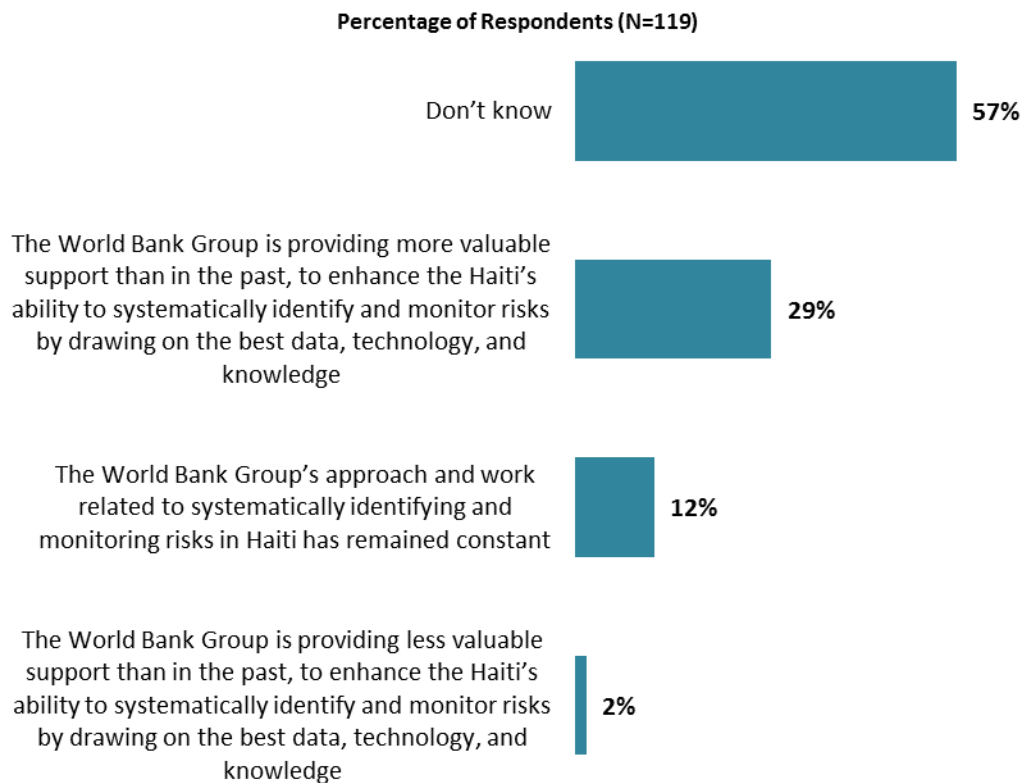

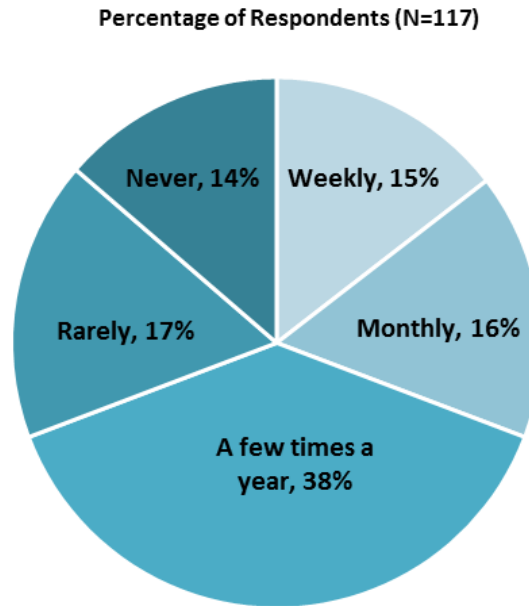


"When considering the World Bank Group's emphasis on risk preparedness and prevention, which of the following statements best describes recent WBG's activities?"

Frequency of Consulting WBG Knowledge Work and Activities

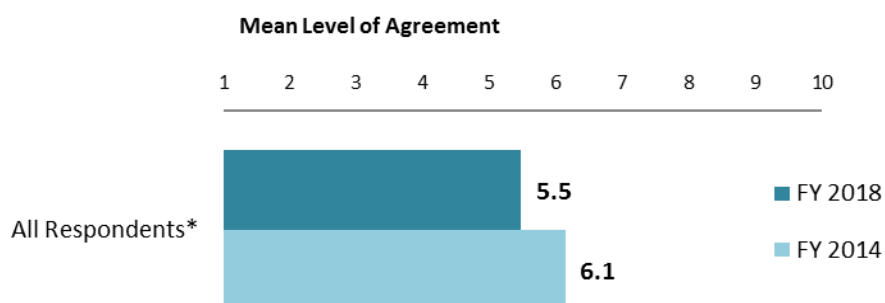


"How frequently do you consult World Bank Group's knowledge work and activities in the work you do?" (Respondents chose from a list.)



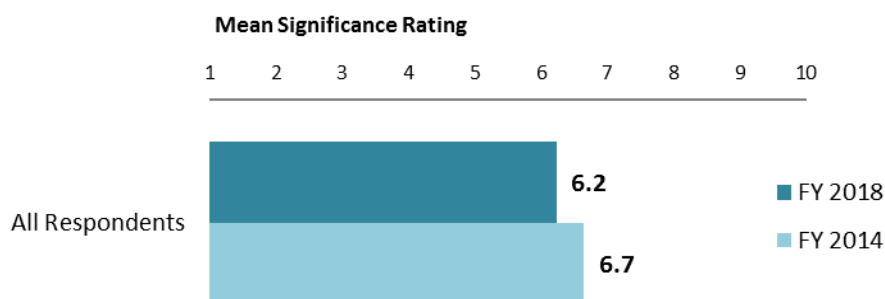

Meeting Haiti's Knowledge Needs¹⁰ (Indicator Question)



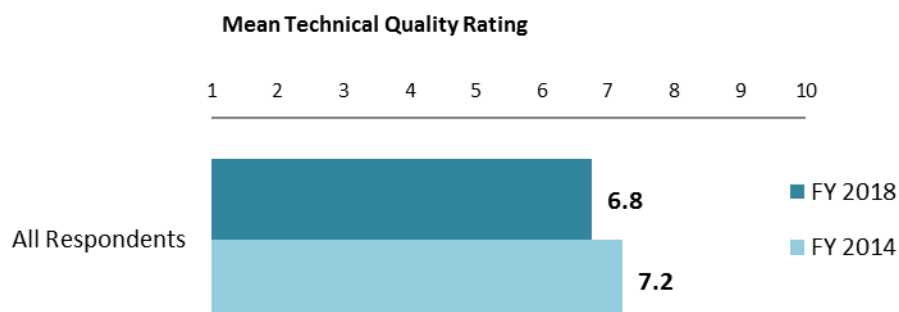

Technical Quality of the WBG's Knowledge Work and Activities (Indicator Question)



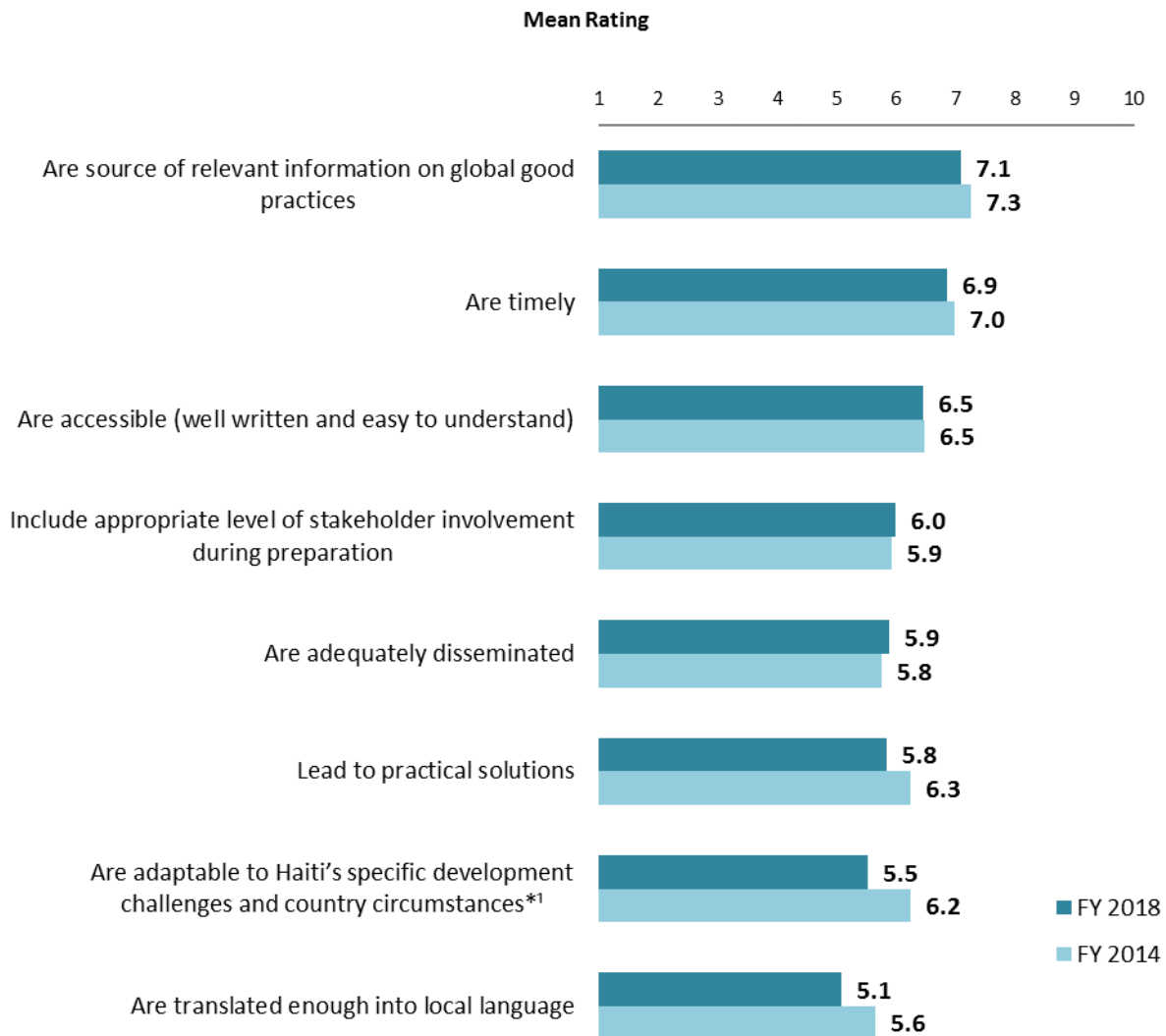

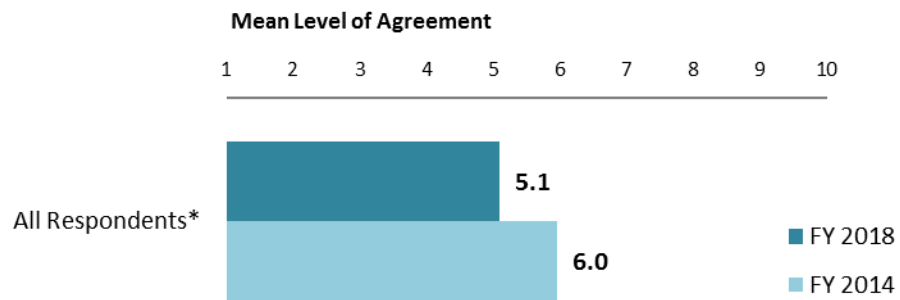

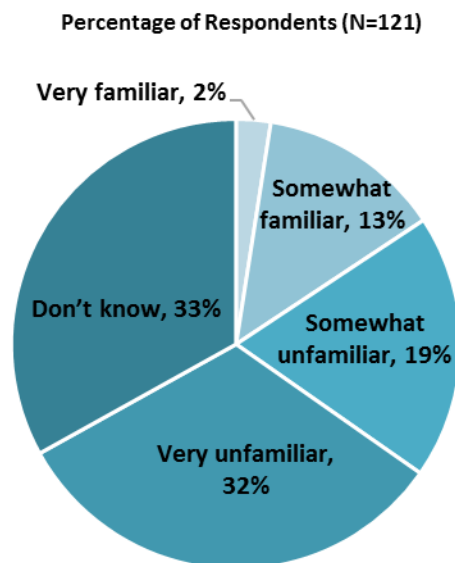

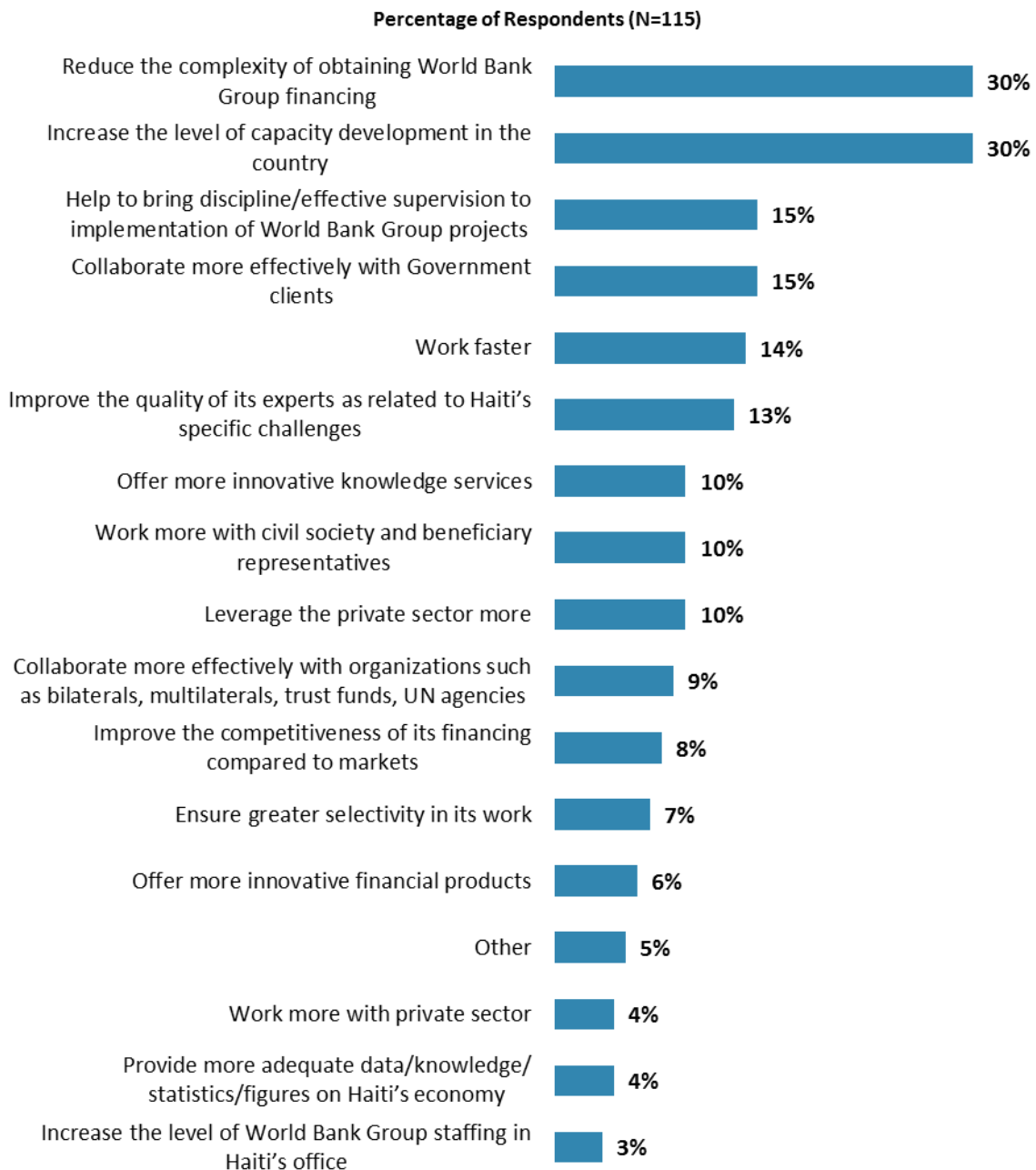

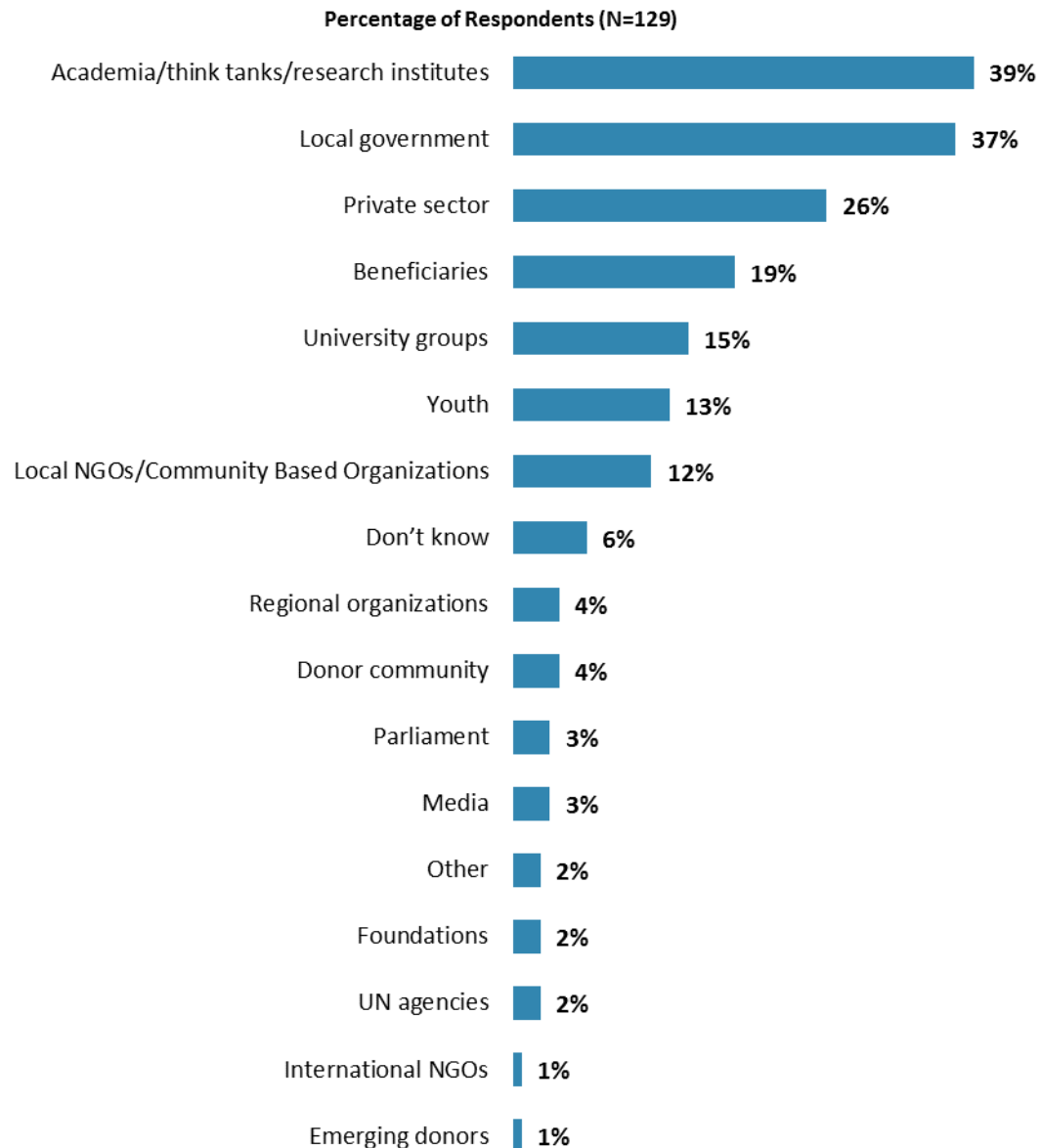

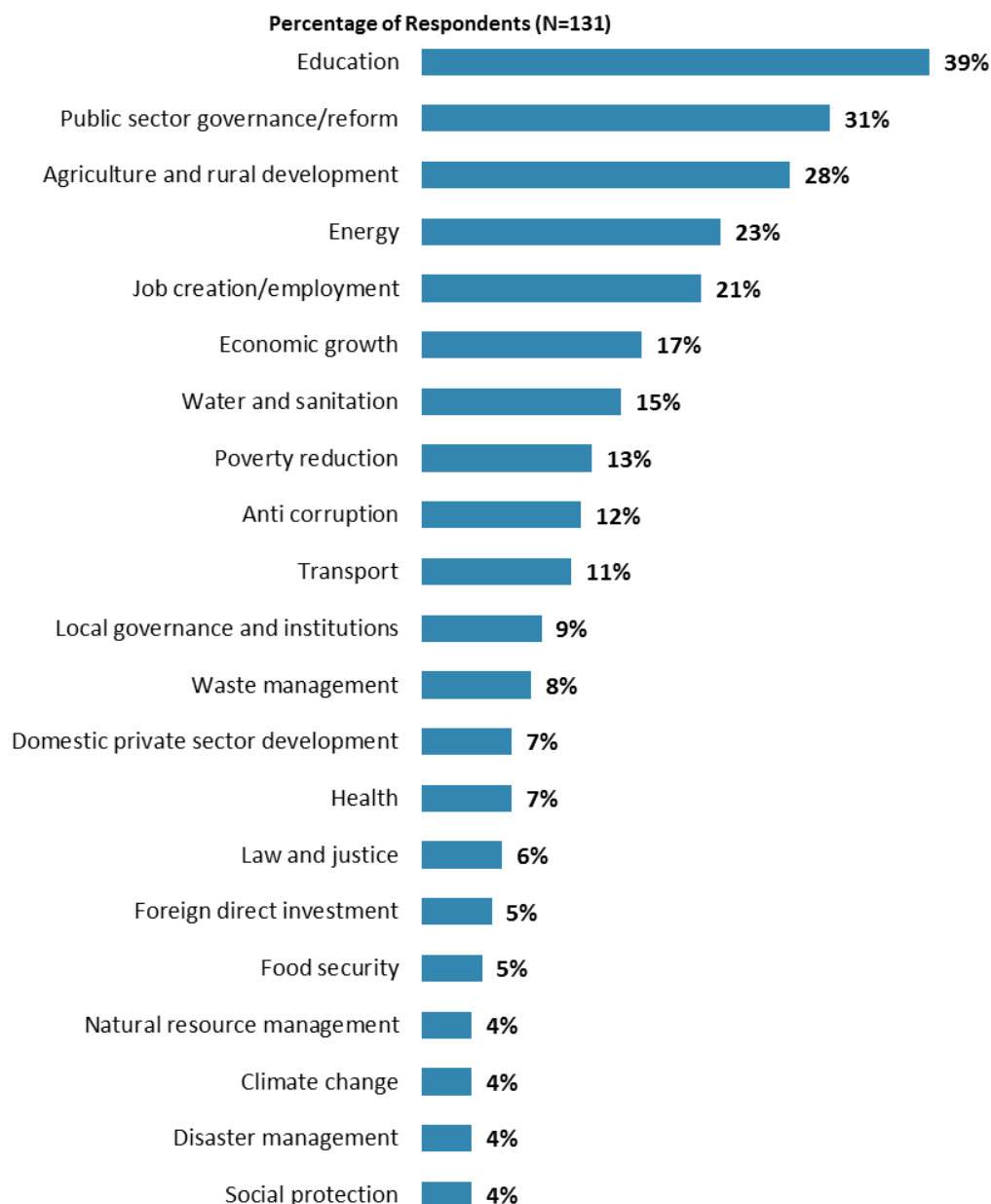
"In addition to the regular relations with the national government, which TWO of the following groups should the World Bank Group collaborate with more in your country?"

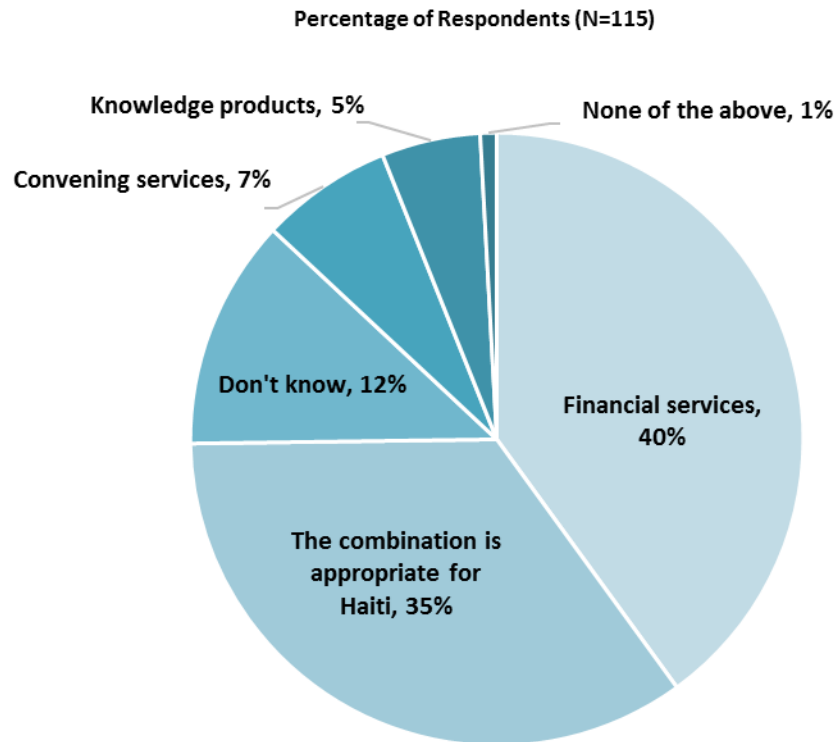

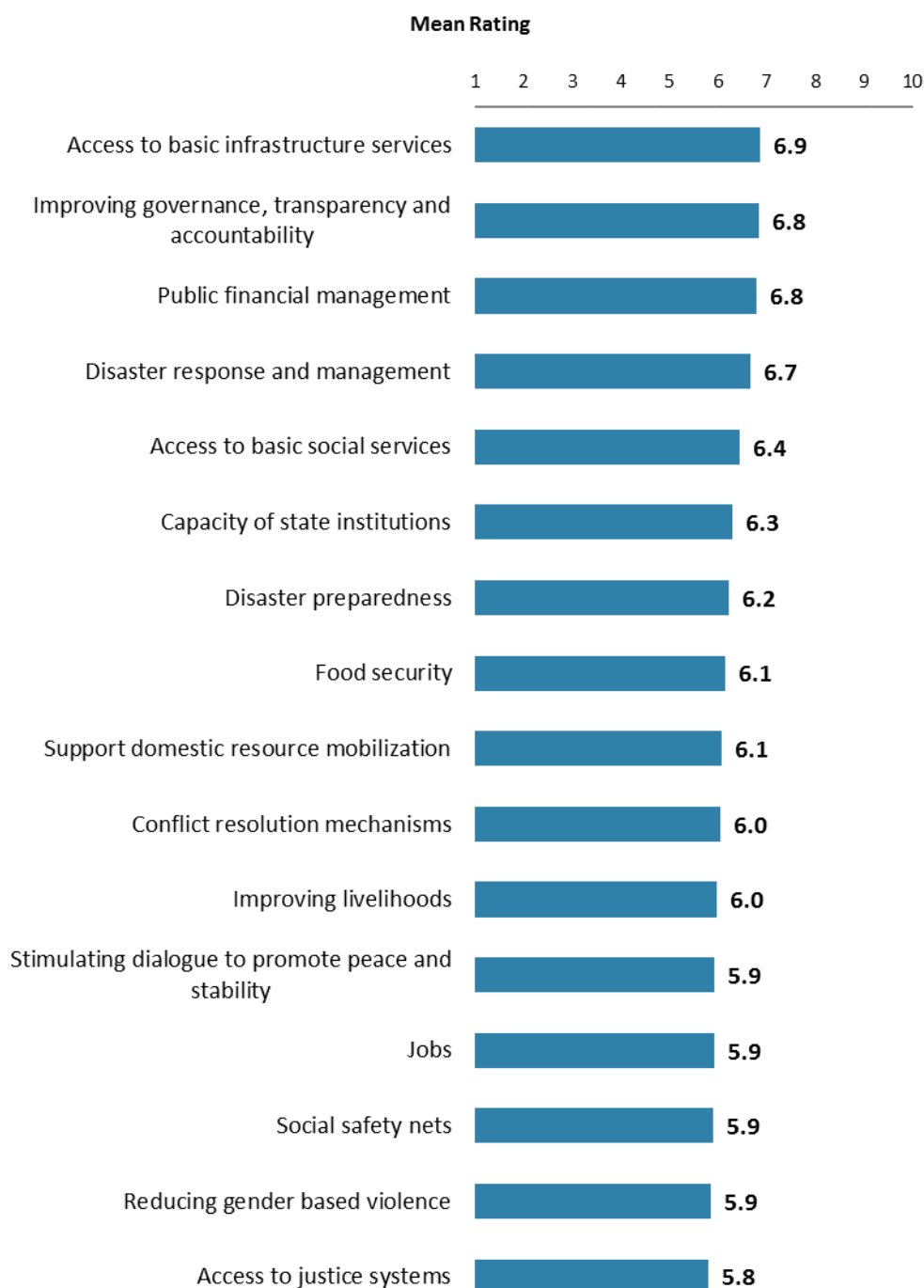

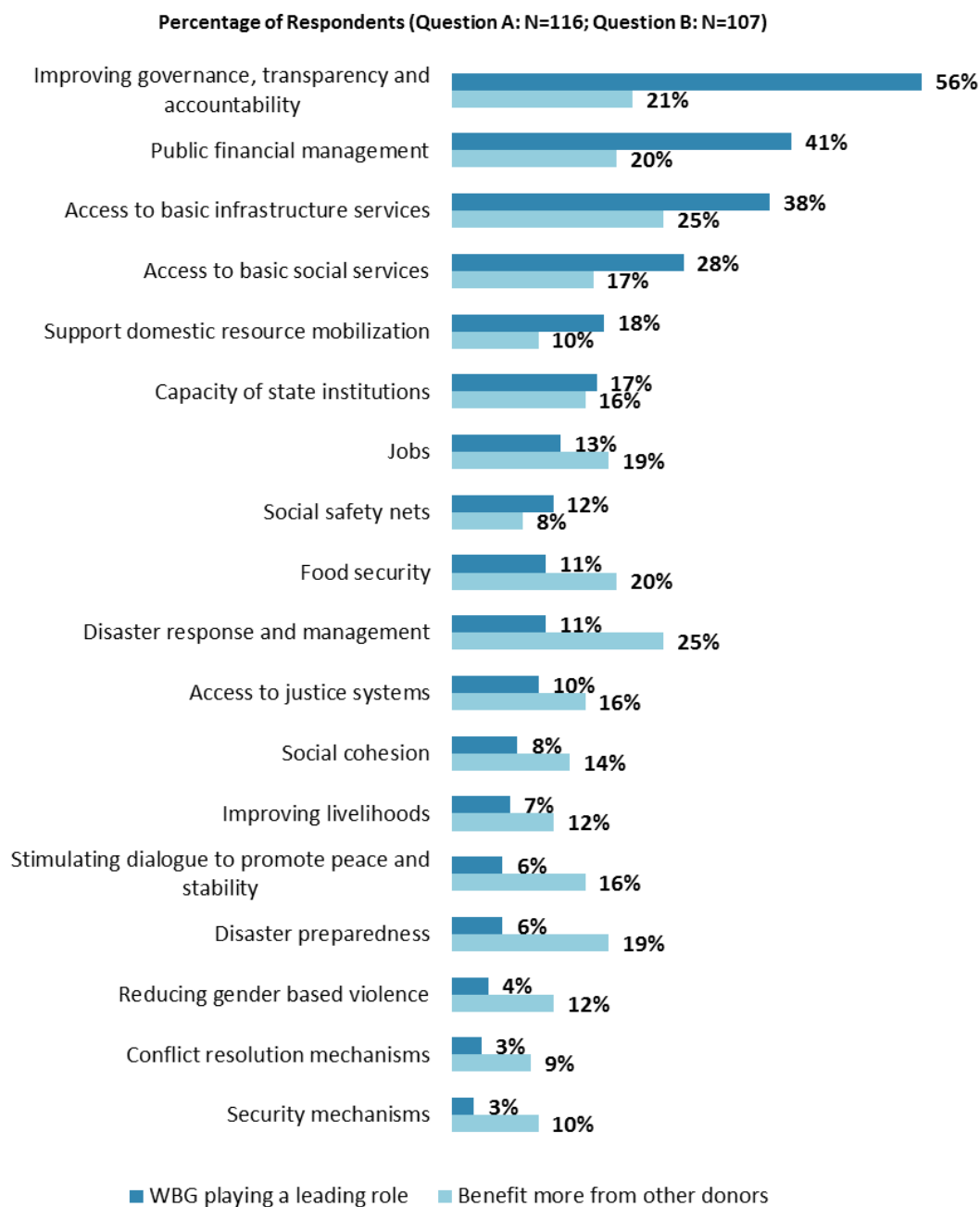

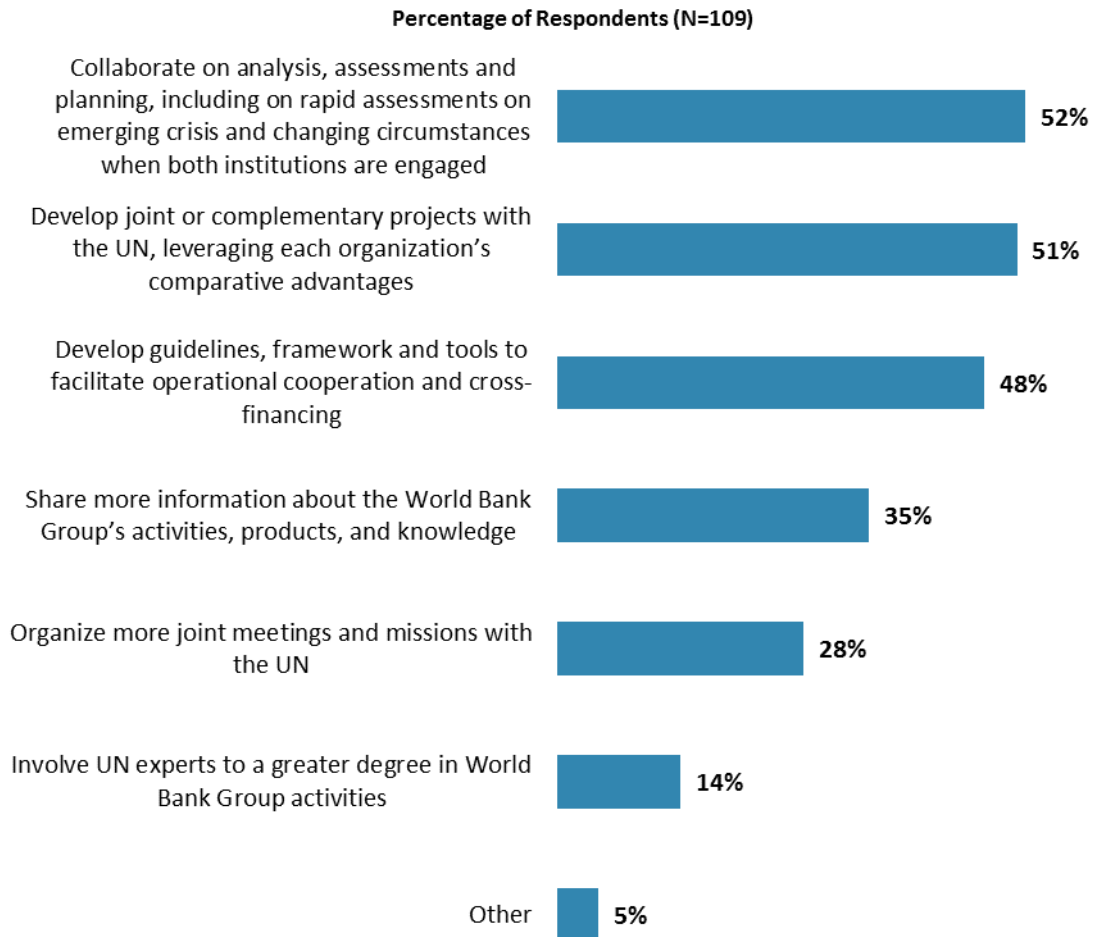

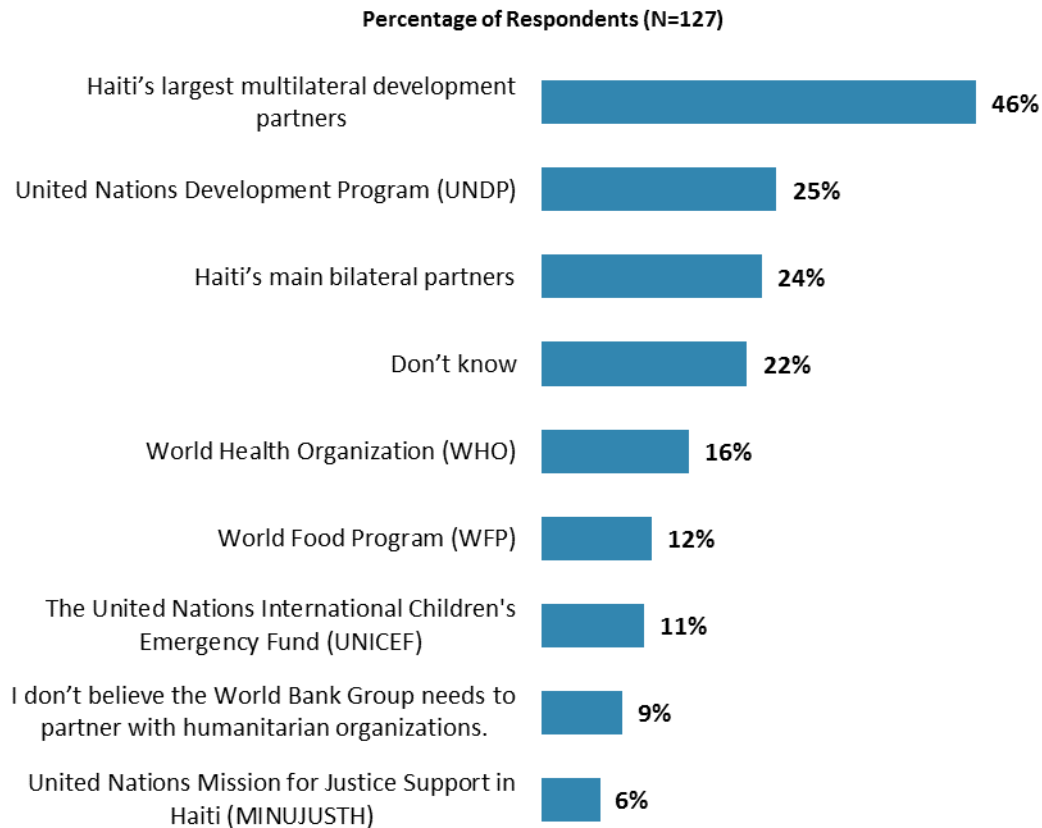

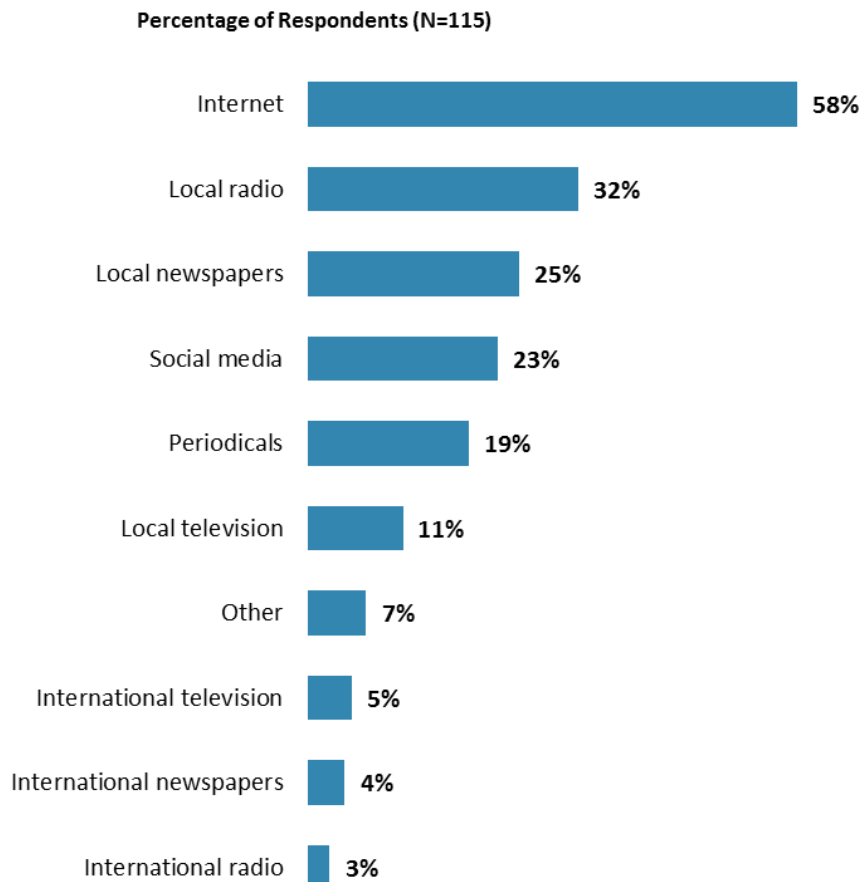

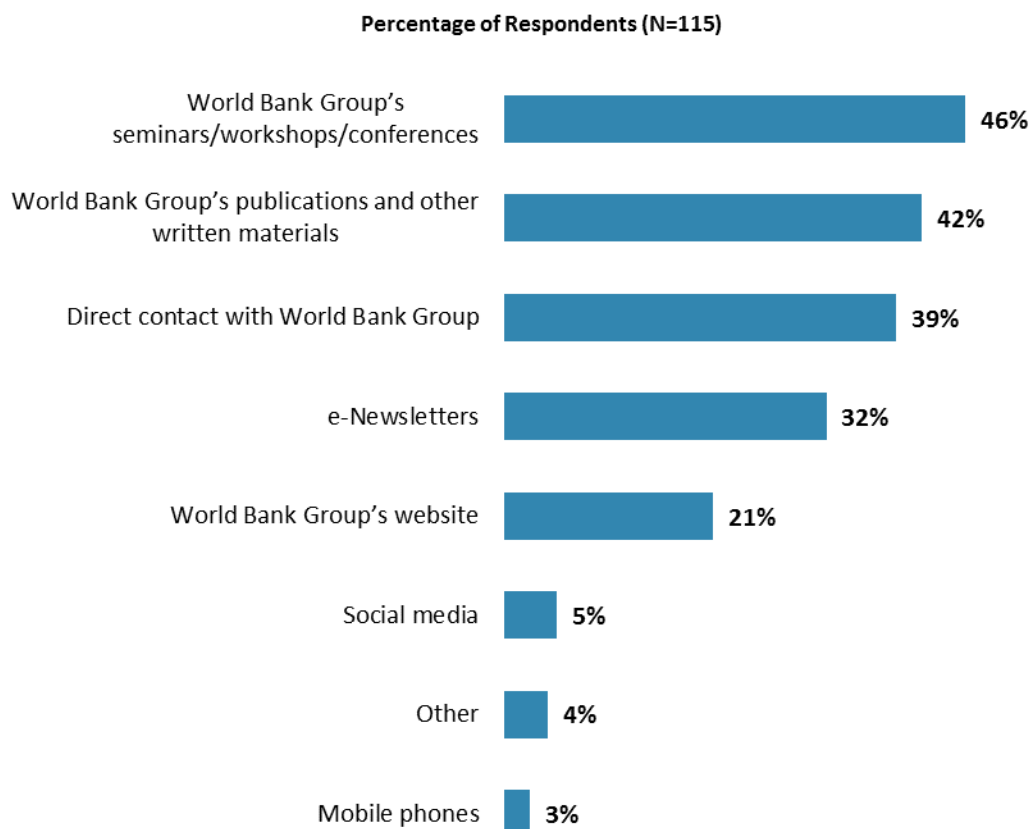
**"How do you get most of your information about economic and social development issues in Haiti?

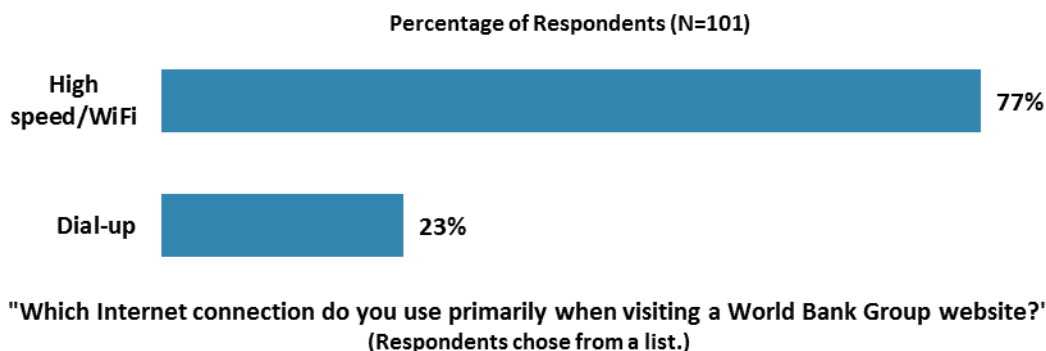
**"How would you prefer to receive information from the World Bank Group?
(Choose no more than TWO)" (Respondents chose from a list. Responses combined.)**



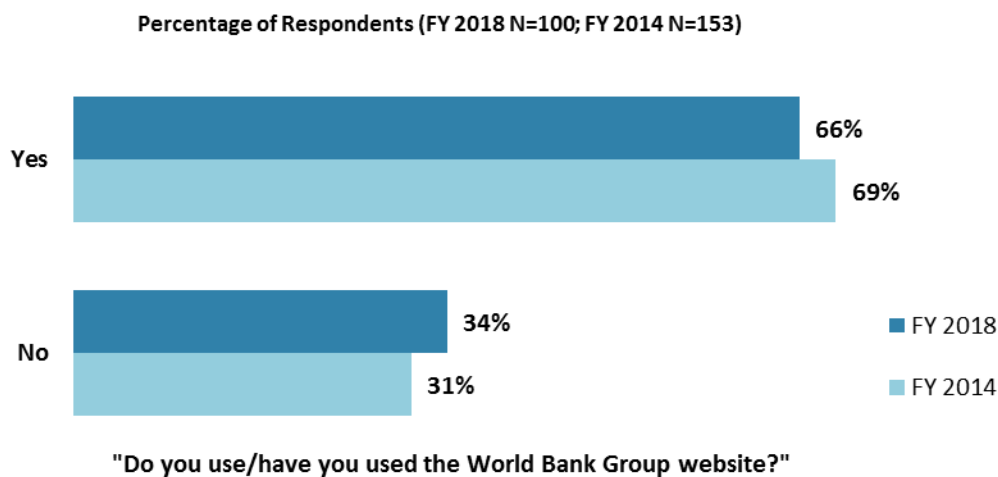

The WBG Website Usage¹³

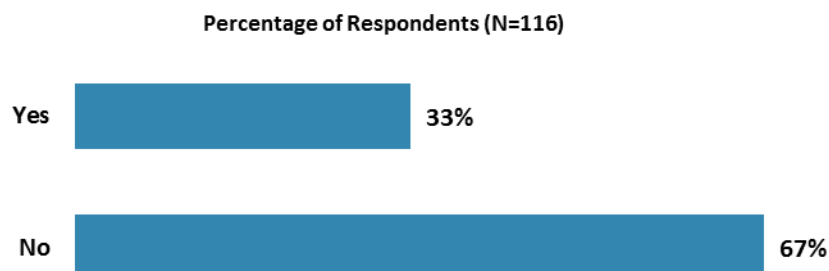

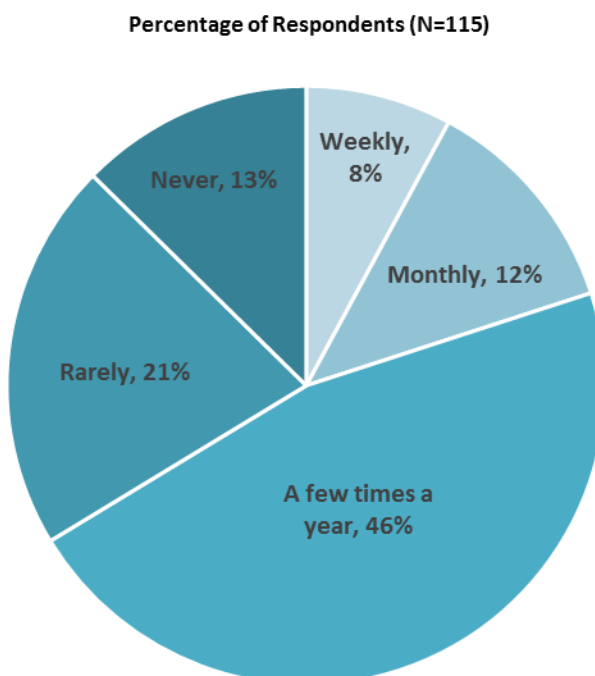
