



Lebanon STEPS Survey 2017

Fact Sheet – Lebanese

The STEPS survey of noncommunicable disease (NCD) risk factors in Lebanon was carried out from February 2017 to April 2017. Lebanon carried out Step 1, Step 2 and Step 3. Socio demographic and behavioural information was collected in Step 1. Physical measurements such as height, weight and blood pressure were collected in Step 2. Biochemical measurements were collected to assess blood glucose and cholesterol levels in Step 3. The survey was a population-based survey of adults aged 18-69. A two-stage cluster sample design was used to produce representative data for that age range in Lebanon. A total of 1899 Lebanese adults participated in the survey. The overall response rate was 65.9%.
