I. Objectives

This survey was designed to assist the World Bank Group (WBG) in gaining a better understanding of how stakeholders in Mexico perceive the WBG. The survey explored:

- *General Issues Facing Mexico*
- *Overall Attitudes toward the World Bank Group*
- *World Bank Group's Effectiveness and Results*
- *The World Bank Group's Knowledge Work and Activities*
- *Working with the World Bank Group*
- *The Future Role of the World Bank Group in Mexico*
- *Communication and Information Sharing*
- *Background Information*

II. Methodology

From April 2016 to June 2016, 488 stakeholders of the WBG in Mexico were invited to provide their opinions on the WBG's work in the country by participating in a country opinion survey. Participants were drawn from the Office of the President/Prime Minister; office of a Secretary; office of Congressman; ministries/ministerial departments; Project Management Units (PMUs) overseeing implementation of WBG projects; consultants/contractors working on WBG-supported projects/ programs; local governments; bilateral/multilateral agencies; private sector organizations; private foundations; the financial sector/private banks; non-profit organizations/community based organizations; the media; independent government institutions; trade unions; faith-based groups; youth groups; academia/research institutes/think tanks; the judiciary branch; and other organizations. A total of 164 stakeholders participated in the survey (34% response rate).

All respondents received and completed the questionnaire online. Respondents were asked about: general issues facing Mexico; their overall attitudes toward the WBG; the WBG's effectiveness and results; the WBG's knowledge work and activities; working with the WBG; the WBG's future role in Mexico; and the WBG's communication and information sharing.

Every country that engages in the Country Opinion Survey must include specific indicator questions that will be aggregated for the World Bank Group's annual Corporate Scorecard. These questions are identified throughout the survey report.


The results in this year's Country Survey were compared to those in the Country Survey conducted in FY'14 (response rate was 48%, N=191). Data were weighted to reach the same stakeholder composition in two years, which allows for year comparisons. Stakeholder groups which were not present in both fiscal years were not included in the comparison. Respondents who belonged to the "other" stakeholder category were not included either. As a result, means of the FY'16 data and the total number of respondents in both years are slightly different from those of the original data reported in appendices A, B, C, and D. III. Demographics of the Sample

Current Position

- For further analyses, respondents from the Office of the President and the Office of Secretary were combined. Respondents from the financial sector/private banks were combined with those from private sector organizations. Respondents from private foundations and NGOs/CBOs were combined into the “CSO” category. Few respondents from bilateral/multilateral agencies and other organizations were included in the “Other” category. There were no respondents from the office of Congressman, media, trade unions, faith-based groups, youth groups, or the judiciary branch.




“Which of the following best describes your current position?” (Respondents chose from a list.)

Area of Primary Specialization






Geographic locations

Exposure to Agencies within the World Bank Group




"Which of the following agencies of the World Bank Group do you primarily engage with in Mexico?" (Respondents chose from a list.)

III. Demographics of the Sample (continued)

Familiarity with the World Bank Group

- **Year comparison:** Respondents in this year's country survey and the FY'14 country survey had statistically similar levels of familiarity with the WBG (weighted mean in FY'16 = 7.9; weighted mean in FY'14 = 7.6)¹.
- In this year's survey, respondents from CSOs and academia were significantly less familiar with the WBG than other stakeholder groups.
- Respondents' levels of familiarity with the WBG were significantly, strongly correlated with their ratings of the WBG's overall effectiveness in Mexico, and the extent to which the WBG plays a relevant role in development in Mexico, and significantly, moderately correlated with the extent to which the WBG helps to achieve development results in the country.

(1 - "Not familiar at all", 10 - "Extremely familiar")



Familiarity with the World Bank Group and Other Development Banks

- **Year comparison:** Stakeholders in both FY'14 and FY'16 have statistically similar levels of familiarity with the World Bank Group and the Inter-American Development Bank.
- This year's stakeholders in Mexico were significantly more familiar with the WBG than the Latin American Development Bank and the Inter-American Development Bank.




"How familiar are you with the work of these organizations in Mexico?"

- **Year comparison:** This year's respondents were significantly less likely to say that Mexico is headed in the right direction compared to respondents in the FY14 Country Survey.





Development Priority

- **Year comparison:** Respondents in the previous FY'14 Country Survey indicated that the most important development priorities in Mexico were “*access and quality of education*” (52%), “*reducing crime and violence*” (36%), and “*upgrading infrastructure projects*” (31%).





What Would Contribute Most to Reducing Poverty

- **Year comparison:** In the previous FY'14 Country Survey, respondents indicated that the greatest contributors to poverty reduction in Mexico were “*access and quality of education*” (77%) and “*increased skilled labor market participation*” (39%).






Gap between the Rich and the Poor




V. Overall Attitudes toward the World Bank Group

As noted in the “Methodology” section, the indicator questions referred to throughout the survey report are questions that are asked in every country that engages in the Country Opinion Survey. These will be aggregated for the World Bank Group’s annual Corporate Scorecard.

The Effectiveness of the World Bank Group and Other Development Banks³ (Indicator Question)

- **Year comparison:** Respondents in the FY’14 and FY’16 Country Surveys gave statistically similar ratings for the effectiveness of the WBG and the IDB.
- In FY16, stakeholders gave significantly higher ratings for the WBG’s effectiveness than the effectiveness of the Latin American Development Bank, and statistically similar ratings for the effectiveness of the Inter-American Development Bank.




**"Overall, please rate your impression of the World Bank Group's effectiveness in Mexico."






“If your projects involved both the World Bank and the IFC, what was your view on the two institutions working together in Mexico?” (Respondents chose from a list.)

Overall Ratings for Indicator Questions by Stakeholder Groups⁵

- **Stakeholder groups:** respondents from CSO and academia/research institutes/think tanks gave statistically lower overall ratings for the indicator questions than other stakeholder groups.
- **Collaboration:** respondents who collaborate with the WBG had significantly higher overall ratings for the twenty six indicator questions than respondents who do not collaborate with the WBG (means =8.0 and 6.6 respectively).




Mean Ratings for All Indicator Questions by Stakeholder Groups on a Scale from 1 to 10




"When thinking about the World Bank Group's role, which activity do you believe is of greatest VALUE and which activity is of second greatest value in Mexico?"


“Which World Bank Group's instruments do you believe are the MOST effective in reducing poverty in Mexico? (Choose no more than TWO)”





VI. Sectoral Effectiveness (continued)

Drivers of Effectiveness

To determine the key drivers of respondents' ratings of the World Bank Group's overall effectiveness and ratings of its ability to help achieve development results in Mexico, bivariate correlational analyses were conducted using respondents' ratings of the thirty specific areas of effectiveness.

Correlational analyses, however, are not able to tell us exactly what is causing respondents' ratings of the World Bank Group's overall effectiveness or ratings of its ability to help achieve development results. Rather, these analyses tell us that as ratings of effectiveness in one area increase, respondents' ratings of the WBG's overall effectiveness increase, or as ratings of effectiveness in one area increase, ratings of the WBG's ability to help achieve development results increase. Thus, it can be inferred that respondents' perceptions of effectiveness in one specific area are related to, or drive, respondents' perceptions of the WBG's overall effectiveness or perceptions of the WBG's ability to help achieve development results.


- Overall Effectiveness: Those specific areas with the highest Pearson Product-Moment correlations were determined to be the most closely related to perceptions of the WBG's overall effectiveness, suggesting that ratings of effectiveness in those specific areas are drivers of perceptions of the WBG's overall effectiveness in Mexico. The areas determined to be key drivers from these analyses were:
 - The WBG's effectiveness at education;
 - The WBG's effectiveness at health; and
 - The WBG's effectiveness at energy.

- Achieving Development Results: Those specific areas with the highest Pearson Product-Moment correlations were determined to be the most closely related to perceptions of the WBG's ability to help achieve development results in Mexico, suggesting that ratings of effectiveness in those specific areas are drivers of perceptions of the WBG's ability to help achieve development results. The areas determined to be key drivers from these analyses were:
 - The WBG's effectiveness at education;
 - The WBG's effectiveness at rural development; and
 - The WBG's effectiveness at health.








"To what extent do you believe that the World Bank Group's work and support help the poorest in Mexico?" (Respondents chose from a list.)












"To what extent do you agree/disagree with the following statements?"









Meeting Mexico’s Knowledge Needs¹¹ (Indicator Question)







Qualities of the WBG's Knowledge Work and Activities¹²














"How do you get most of your information about economic and social development issues in Mexico? (Choose no more than TWO)" (Respondents chose from a list. Responses combined.)




"How would you prefer to receive information from the World Bank Group?
(Choose no more than TWO)" (Respondents chose from a list. Responses combined.)





The WBG Website Usage




"Do you use/have you used the World Bank Group website?"
