

## I. Objectives

This survey was designed to assist the World Bank Group (WBG) in gaining a better understanding of how stakeholders in Eswatini perceive the WBG. The survey explored:

- *General Issues Facing Eswatini*
- *Overall Attitudes toward the World Bank Group*
- *World Bank Group's Effectiveness and Results*
- *The World Bank Group's Knowledge Work and Activities*
- *Working with the World Bank Group*
- *The Future Role of the World Bank Group in Eswatini*
- *Communication and Information Sharing*
- *Background Information*

## II. Methodology

From February to July 2018, 218 stakeholders of the WBG in Eswatini were invited to provide their opinions on the WBG's work in the country by participating in a Country Opinion Survey. Participants were drawn from the Office of the President, Prime Minister; office of a minister; office of a parliamentarian; ministries/ministerial departments/implementation agencies; Project Management Units (PMUs) overseeing implementation of WBG projects; consultants/contractors working on WBG supported projects/programs; local government; bilateral and multilateral agencies; private sector organizations; private foundations; the financial sector/private banks; NGOs and community based organizations; the media; independent government institutions; trade unions; faith-based groups; youth groups; academia/research institutes/think tanks; the judiciary branch; and other organizations.

A total of 160 stakeholders participated in the survey (73% response rate). Respondents either completed questionnaires with a representative from the local fielding agency, or they received the questionnaire via courier or email and returned it accordingly.

Every country that engages in the Country Opinion Survey (COS) must include specific indicator questions that will be aggregated for the World Bank Group's annual Corporate Scorecard. These questions are identified throughout the survey report.

The results in this year's Country Survey were compared to those in the Country Survey conducted in FY'14 (response rate was 47%, N=142). Data were weighted to reach the same stakeholder composition in two years, which allows for year comparisons. Stakeholder groups which were not present in both fiscal years were not included in the comparison. Respondents who belonged to the "other" stakeholder category were not included either. As a result, mean ratings, percentages of respondents, and the total number of respondents in both years are slightly different from those of the original data reported in the FY'14 COS report and the non-weighted data presented in appendices A, B, C, D and F. 

### III. Demographics of the Sample

#### Current Position

- For further analyses, employees of ministries/ministerial departments/implementation agencies were combined with respondents from PMUs, and consultants working on WBG projects; respondents from the financial sector/private banks were combined with those from private sector organizations; respondents from NGOs/community-based organizations, faith-based groups, and youth groups were combined in the “CSO” category; and the small number of respondents from the office of a minister, office of a parliamentarian, bilateral and multilateral agencies, the media, independent government institutions, academia/research institutes/think tanks, and the judiciary branch were included in the “Other” category. There were no respondents from the Office of the President/Prime Minister, private foundations, and trade unions.




“Which of the following best describes your current position?”

#### Area of Primary Specialization







"Which of the following agencies of the World Bank Group do you primarily engage with in Eswatini?" (Respondents chose from a list.)



### III. Demographics of the Sample (continued)

#### Familiarity with the World Bank Group

- **Year comparison:** Respondents in this year's Country Survey and the FY'14 Country Survey had statistically similar levels of familiarity with the WBG (weighted mean in FY'18 = 5.5; weighted mean in FY'14 = 6.1)<sup>1</sup>.
- Respondents' levels of familiarity with the WBG were significantly, strongly correlated with their ratings of the WBG's overall effectiveness in Eswatini, and significantly, moderately correlated with their ratings of the extent to which the WBG contributes to the country's development results.




**"How familiar are you with the work of the World Bank Group in Eswatini?"**

### Headed in the Right Direction<sup>2</sup>





## IV. General Issues Facing Eswatini (continued)

### Development Priority

- **Year comparison:** Respondents in the previous FY'14 Country Survey indicated that the most important development priorities in Eswatini were “*education*” (37%), “*public sector governance/reform*” (34%), “*poverty reduction*” (34%), and “*health*” (28%).
- **Specialization:** Respondents who identified their primary specialization of work as “*health, nutrition, and population*” (19% of the sample) were significantly *more* likely to indicate that “*health*” was the most important development priority in Eswatini compared to the rest of respondents in other areas of work (health specialists = 53%; others = 26%).



- **Year comparison:** Respondents in the previous FY'14 Country Survey indicated that the biggest contributors to poverty reduction in Eswatini were “*economic growth*” (41%) and “*job creation/employment*” (41%).





- **Year comparison:** Respondents in the previous FY’14 Country Survey indicated that shared prosperity in Eswatini can be best achieved through “*better entrepreneurial opportunities*” (32%) and “*greater voice and participation for citizens to help ensure greater accountability*” (30%).





### Attributing Failed/Slow Reform Efforts

- **Year comparison:** Respondents in the previous FY'14 Country Survey most often attributed failed or slow WBG assisted reform efforts to that “*there is not an adequate level of citizen/civil society participation*” (35%) and to the “*lack of/inadequate levels of capacity in Government*” (35%).









## V. Overall Attitudes toward the World Bank Group (continued)

### Overall Ratings for Indicator Questions by Stakeholder Groups

- **Stakeholder groups:** Respondents from local government had the highest mean ratings for the aggregated responses to the twenty-six COS indicator questions, whereas respondents from the private sector/financial sector/private banks had significantly lower mean ratings. Responses for individual indicator questions by stakeholder groups can be found in Appendix B (page 56).
- **Collaboration:** Respondents who collaborate with the WBG had significantly higher mean ratings for the aggregated responses to the twenty-six COS indicator questions (mean rating = 7.4) compared to respondents who do not collaborate with the WBG (mean rating = 6.0). Responses for individual indicator questions by exposure to the WBG can be found in Appendix F (page 97).




Mean Ratings for All Indicator Questions by Stakeholder Groups on a Scale from 1 to 10

### Greatest Value

- **Year comparison:** Respondents in the previous FY'14 Country Survey indicated that the WBG's greatest values to Eswatini were its "*policy advice, studies, analyses*" (48%), "*financial resources*" (44%), "*technical assistance*" (42%), and "*capacity development*" (32%).




**"When thinking about the World Bank Group's role, which activity do you believe is of greatest VALUE and which activity is of second greatest value in Eswatini?"**




**"Which of the following do you identify as the World Bank Group's greatest WEAKNESSES in its work in Eswatini? (Choose no more than TWO)"**

### Effectiveness of WBG’s Support in Sectoral Areas: Year Comparison<sup>5</sup>










**"To what extent do you believe that the World Bank Group's work and support help the poorest in Eswatini?" (Respondents chose from a list.)**


















"How frequently do you consult World Bank Group's knowledge work and activities in the work you do?" (Respondents chose from a list.)














"In addition to the regular relations with the national government, which TWO of the following groups should the World Bank Group collaborate with more in your country? (Choose no more than TWO)"






**"How do you get most of your information about economic and social development issues in Eswatini? (Choose no more than TWO)"**


"How would you prefer to receive information from the World Bank Group?  
(Choose no more than TWO)" (Respondents chose from a list. Responses combined.)






### Use of the WBG's Social Media Channels
