HOUSEHOLD DEMOGRAPHIC CARD

Interviewee! After completing the control card (see overleaf) please ask the following questions and write down answers:

1. Please advise how many people do inhabit here?
 2. Please name everybody who inhabit here and specify their family relationships, dates of birth, sex and marital status.
- Interviewee! Please register all members of the household, i.e. people living under one roof, having one household and feeding together. Usually these people are relatives.*
3. Are there other members of the family who usually live with you but now are temporary out, for example, due to the military service, treatment in hospital or students?
Yes – please write down their names in column 9 and put a relevant two-digits code (status + reason)
No – continue interview
 4. During the last visit in January (April, July, October) the composition of your household was the following
- Interviewee! Please read out all names from the control card.*
5. Have the composition changed since that time?
Yes - →6
No – continue interview
 6. Please explain what changes occurred?
- Interviewee! If new household members appear, ask question 2 and write down corresponding codes to columns 10-13. If household members left the household, please put corresponding codes to corresponding columns 10-13.*

Codes of family relations with the head of the household

- 01 - spouse
- 02 – son / daughter
- 03 – mother/father
- 04 – parents-in-law
- 05 – brother / sister
- 06 - your spouse's brothers / sisters
- 07 – children-in-law
- 08 - grandparents
- 09 – your spouse's grandparents
- 10 - grandchildren
- 11 – other relatives not mentioned above
- 12 – others not having relative relations

Codes of reasons for the household demographic change

Status the household demographic change	Reasons for being absent
1. permanently out	1 - birth
2. permanently in	2 - death
3. temporary out	3 – work
4. temporary in	4 - marriage
	5 – divorce
	6 – studying
	7 – military service
	8 – other (hospital, prison, etc.)

Temporary out (in) assumes absence (presence) for the period exceeding 2 months within the surveyed quarter.

Birth will always have a code 21; death will always have a code 12.
