## I. Objectives

This survey was designed to assist the World Bank Group (WBG) in gaining a better understanding of how stakeholders in Timor-Leste perceive the WBG. The survey explored:

- *Overall Context*
- *Overall Attitudes toward the World Bank Group*
- *World Bank Group's Work and Engagement on the Ground*
- *World Bank Group's Support in Development Areas*
- *World Bank Group's Knowledge Work and Activities*
- *The Future Role of the World Bank Group in Timor-Leste*
- *Communication and Information Sharing*
- *Background Information*

## II. Methodology

From July to September 2020, 210 stakeholders of the WBG in Timor-Leste were invited to provide their opinions on the WBG's work in the country by participating in a Country Opinion Survey. Participants were drawn from the Office of the President, Prime Minister; office of a minister; office of a parliamentarian; ministries/ministerial departments/implementation agencies; Project Management Units (PMUs) overseeing implementation of WBG projects; consultants/ contractors working on WBG-supported projects/programs; local governments; independent government institutions; the judiciary system; state-owned enterprises; bilateral and multilateral agencies; private sector organizations; the financial sector/private banks; private foundations; NGOs and community based organizations; trade unions; faith-based groups; youth groups; academia/research institutes/think tanks; the media; and other organizations.

A total of 107 stakeholders participated in the survey (51% response rate). Respondents received the questionnaire via courier or via email and returned it accordingly, or they filled out the questionnaire via the online survey platform Qualtrics.

Every country that engages in the Country Opinion Survey (COS) must include specific indicator questions that will be aggregated for the World Bank Group's annual Corporate Scorecard. These questions are identified throughout the survey report.

The results in this year's Country Survey were compared to those in the Country Survey conducted in FY'17 (response rate was 50%, N=101). Data were weighted to reach the same stakeholder composition in two years, which allows for year comparisons. Stakeholder groups which were not present in both fiscal years were not included in the comparison. Respondents who belonged to the "other" stakeholder category were not included either. As a result, mean ratings, percentages of respondents, and the total number of respondents in both years are slightly different from those of the original data reported in the FY'17 COS report and the non-weighted data presented in appendices A, B, C and E. For the weighted stakeholder breakdown and year comparison results, please refer to Appendix D (page 78).




**“Which of the following best describes your current position?”**




#### Geographic Locations



### III. Demographics of the Sample (continued)

#### Familiarity with the World Bank Group

- **Year comparison:** Respondents in this year's Country Survey had statistically similar levels of familiarity with the WBG compared to respondents in the FY'17 Country Survey (weighted mean in FY'20 = 6.6; weighted mean in FY'17 = 6.0)<sup>2</sup>.
- **Impact of familiarity:** Respondents' ratings of familiarity with the WBG were significantly, strongly correlated with their agreement that the WBG plays a relevant role in Timor-Leste's development, with their ratings for the WBG's overall effectiveness in Timor-Leste, and with the ratings of the extent to which the WBG's work helps to achieve development results in Timor-Leste.




**"How familiar are you with the work of the World Bank Group in Timor-Leste?" (1-"Not familiar at all", 10-"Extremely familiar")**



### Perceptions of Economic Opportunity



### Perceptions of Improvement and Decline in Specific Areas





## IV. Overall Context (continued)

### Development Priority

- **Year comparison:** Respondents in the previous FY'17 Country Survey indicated that the most important development priorities in Timor-Leste were “*education*” (57%), “*agriculture and rural development*” (39%), “*health*” (31%), “*public sector governance/reform*” (22%), and “*private sector development*” (18%).
- “*Water and sanitation*” emerged among the top three development priorities, with 31% of respondents selecting this option in FY'20, up from 15% in FY'17.
- **Specialization:** Respondents who identified their primary specialization of work as “*health, nutrition*” (11% of the sample) were significantly *more* likely to indicate that “*health*” was the most important development priority in Timor-Leste, compared to the rest of respondents in other areas of work (health specialists = 92%; others = 27%).<sup>4</sup>



## IV. Overall Context (continued)

### What Would Contribute Most to Reducing Poverty

- **Year comparison:** Respondents in the previous FY'17 Country Survey indicated that the biggest contributors to poverty reduction in Timor-Leste were “*agriculture and rural development*” (52%), “*economic growth*” (47%), “*job creation/employment*” (47%), “*education*” (34%), and “*private sector development*” (23%).
- **Specialization:** Respondents who identified their primary specialization of work as “*health, nutrition*” (11% of the sample) were significantly *more* likely to indicate that “*health*” would contribute the most to poverty reduction in Timor-Leste compared to the rest of respondents in other areas of work (health specialists = 42%; others = 9%).<sup>5</sup>










**"To what extent do you trust domestic private sector to engage in public service delivery in Timor-Leste?"**







### Overall Ratings for Indicator Questions by Stakeholder Groups




Mean Ratings for All Indicator Questions by Stakeholder Groups on a Scale from 1 to 10


**"When thinking about the World Bank Group's role in Timor-Leste, which activity do you VALUE the most? (Choose no more than TWO)"**




**"Which of the following do you identify as the World Bank Group's greatest WEAKNESSES in its work in Timor-Leste? (Choose no more than TWO)"**

### Effectiveness of WBG’s Support in Sectoral Areas: Year Comparison<sup>8</sup>









### The WBG’s Human Capital Investment















### Effectiveness of WBG's Support for Management of Crisis Related Risks






"How frequently do you consult World Bank Group's knowledge work and activities in the work you do?"










**"Which of the following SHOULD the World Bank Group do to make itself of greater value in Timor-Leste? (Choose no more than TWO)"**


**"In addition to the regular relations with the national government, which TWO of the following groups should the World Bank Group collaborate with more in your country? (Choose no more than TWO)"**

- **Year comparison:** Respondents in the previous FY'17 Country Survey indicated that the WBG should focus its resources on “*education*” (36%), “*private sector development*” (26%), “*agriculture and rural development*” (25%), “*poverty reduction*” (24%), “*public sector governance/reform*” (23%), “*job creation/employment*” (22%), and “*economic growth*” (22%).
- **Specialization:** Respondents who identified their primary specialization of work as “*health, nutrition*” (11% of the sample) were significantly *more* likely to indicate that the WBG should focus most of its resources on “*health,*” compared to the rest of respondents in other areas of work (health specialists = 45%; others = 19%).<sup>16</sup>




**"How do you get most of your information about economic and social development issues in Timor-Leste? (Choose no more than TWO)"**


**"How would you prefer to receive information from the World Bank Group?



### WBG Interaction Frequency




"How frequently do you interact with the World Bank Group now in Timor-Leste?"
