Executive Summary

The PCBS is pleased to release the main findings of the Economic Survey Series for the year 2007. As in the previous rounds, this release covers the main economic activities practiced in the Palestinian Territory, including: Industry, Construction, Internal trade, Transport and Communications, and Services activities. It should be mentioned that this release represents the main findings of the surveys for the Remaining West Bank and Gaza Strip, excluding that part of Jerusalem governorate which was annexed after the Israeli occupation in 1967.

During the year 2007, the number of enterprises in economic activities was 92,589 enterprises, This number was distributed as follows:

• Industrial activities	14,508
• Construction activities	566
• Internal trade activities	54,677
• Services activities	21,797
• Transport, storage and communications activities	1,041

In the year 2007, the number of persons engaged in economic activities was 239,157 workers, This number was distributed as follows:

• Industrial activities	61,690
• Construction activities	5,359
• Internal trade activities	99,680
• Services activities	64,323
• Transport, storage and communications activities	8,105

On the other side, the main findings of the surveys show that the value of the output was US\$ 3,995.5 million. This value was distributed as follows:

• Industrial activities	1,808.3
• Construction activities	186.1
• Internal trade activities	934.3
• Services activities	612.7
• Transport, storage and communications activities	454.1

Regarding to the other economic indicators, the survey results indicate that the gross value added amount to US\$ 2,355.9 million. This value was distributed as follows:

Chapter One

Introduction

National statistical offices in most countries place heavy emphasis on constructing sound databases for all activities within economic activities. PCBS initiated the economic surveys series in the reference year 1994. These series include surveys on the industry, services, internal trade, construction-contractors, and transport and storage sectors. The sampling frame for the different economic surveys was based on the findings of the Establishment Census 2007 conducted by PCBS.

1.1 Objectives

The objectives of the survey were to obtain data on:

1. Number of enterprises and persons engaged in economic activities by activity.
2. Value of output, intermediate consumption and stocks.
3. Value added components.
4. Payments and transfers.
5. Assets and capital formation.
6. Contribution of the surveyed activities to the GDP and other national accounts variables.

1.2 Report Structure

The report is divided into five chapters as follows:

- **Chapter One:** Comprises an introduction to the economic survey including survey' program, objectives, and report structure.
- **Chapter Two:** Defines the main concepts and terms used in the report with a brief description for each of them.
- **Chapter Three:** Presents the most prominent findings of the economics survey.
- **Chapter Four:** Discusses the methodology of the fieldwork in terms of questionnaire, sample, fieldwork data collection activities, and office operations. In addition, it discusses data processing and tabulation.
- **Chapter Five:** Addresses the quality of the data and findings through discussing the main remarks on the fieldwork as well as comments and remarks on the tables.
- **Statistical Tables:** All tables included in this report represent on three level : Remaining West Bank and Gaza Strip, Remaining West Bank, and tables of Gaza Strip.

Chapter Two

Concepts and Definitions

This chapter presents the definitions of the concepts used in the preparation of the survey tools on which data collection and processing are based. These concepts and their definitions are based on international recommendations in the fields of economic statistics and national accounts while taking into account the particular aspects of the Palestinian Territory.

Persons Engaged:

Males and females working in the enterprise including owners, self-employed, unpaid family members, or waged workers who receive their compensations in cash or in kind during a specific reference period. However, this term does not include trainees or those on assignments outside the enterprises or in long unpaid leaves.

Compensations of Employees:

Compensations of employees include salaries, wages, and other cash or in-kind benefits during the survey period.

Production:

Production refers to the value of goods and services produced in a certain period as a result of a main or secondary productive activity. This includes fixed assets produced for the use of the enterprise. Henceforth, production = Value of production from main activity plus Value of production from secondary activity plus Value of own capital formation of enterprises.

Production was calculated according to the market value, which represents the producer price plus value added tax on produced goods and services.

Intermediate Consumption:

It refers to the value of production inputs, i.e., inputs used in the production of goods and services. Henceforth, intermediate consumption = value of raw material plus other production expenses.

Value Added

It refers to production minus intermediate consumption.

Principal Economic Activity:

The principal economic activity is the activity that contributes to the largest value added in enterprises practicing more than one activity.

Operating surplus: Value added minus (compensation of employees plus net taxes on production minus subsidies and custom fees plus depreciation).

Gross Fixed Capital Formation: It is measured by value of acquisitions less disposals of new or existing fixed assets.

The Remaining West Bank: The West Bank excluding those parts of Jerusalem which were annexed by Israel in 1967.

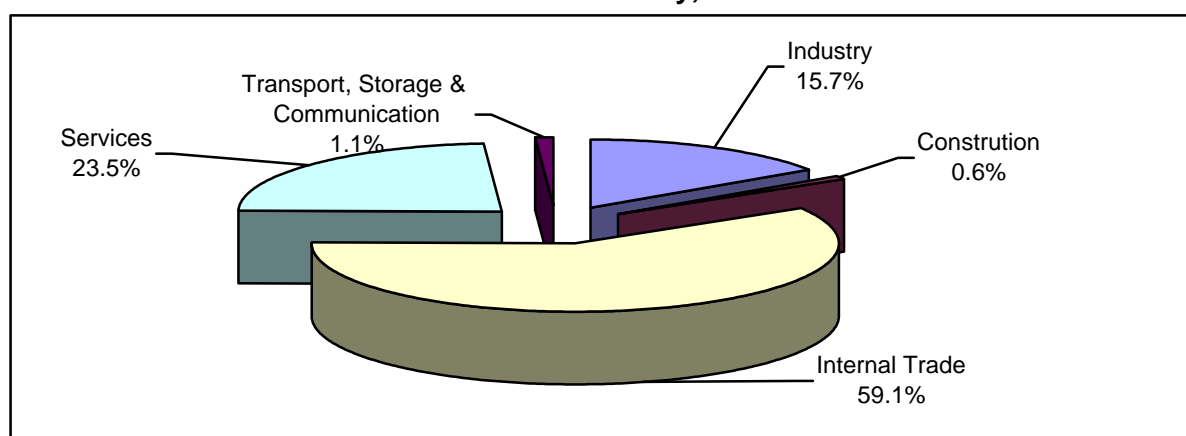
Main Findings

The prominent findings of the Economic Surveys for 2007 in Remaining West Bank and Gaza Strip are as follows:

3.1 Number of Enterprises:

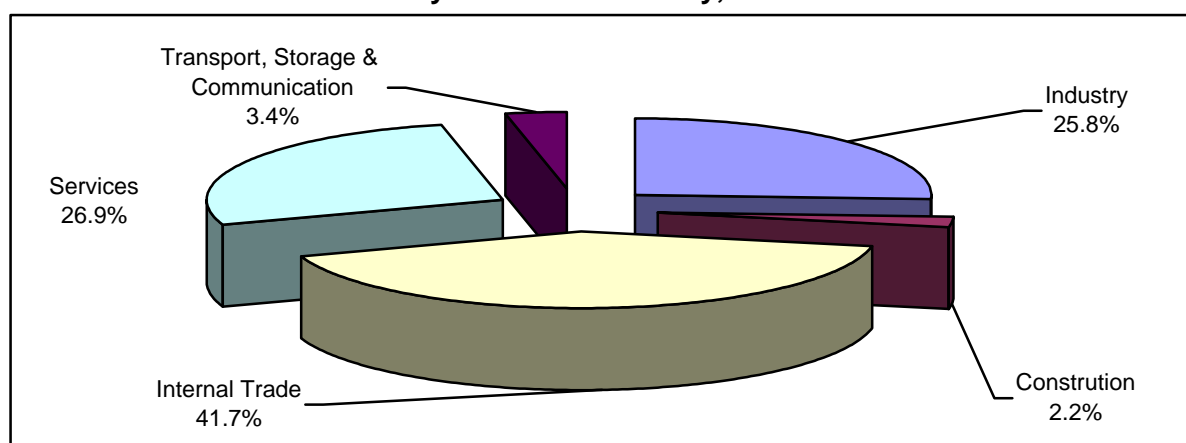
Figure (1): Distribution of Enterprises in Remaining West Bank and Gaza Strip by Economic Activity, 2007

The surveys' results show that there were 92,589 operating enterprises during 2007 in the covered activities, in the Palestinian economy. This number was distributed as follows: industrial activities, 15.7%, construction activities, 0.6%, internal trade activities, 59.1%, services activities, 23.5%, and transport, storage and communications activities, 1.1%, Figure (1) shows these results:

3.2 Number of Persons Engaged:

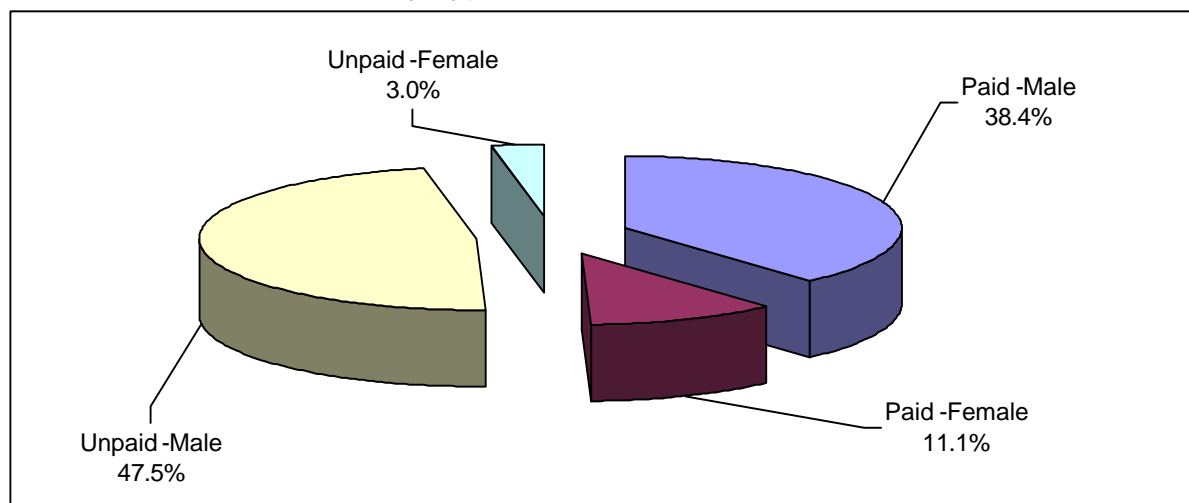
The number of persons engaged in all covered economic activities is 239,157 workers. This number was distributed as follows: industrial activity, 25.8%; construction activities, 2.2%; internal trade activities, 41.7%; services activities, 26.9%; and transport, storage and communications activities, 3.4%. Figure (2) shows these results:

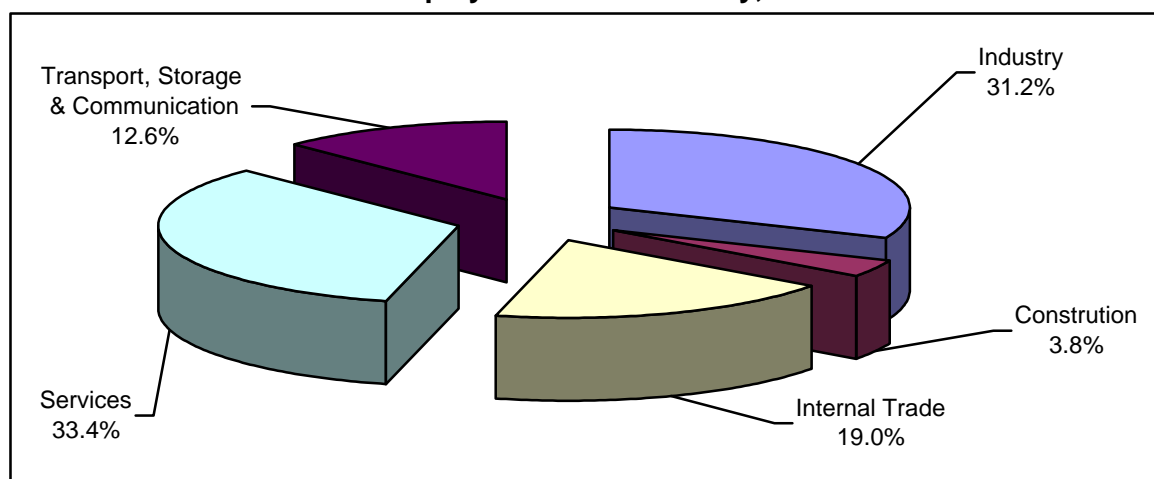
Figure (3): Distribution of Persons Engaged in Remaining West Bank and Gaza Strip by Type of Work and Sex, 2007

On the other hand, the results indicate that paid employees (male) represent 38.4% of the total number of employees, and paid employees (female) represent 11.1%. Meanwhile unpaid employment (male) are 47.5%, and unpaid employment (female) represent 3.0%. Figure (3) shows these results by sex and type of work:

3.3 Compensations of Employees:

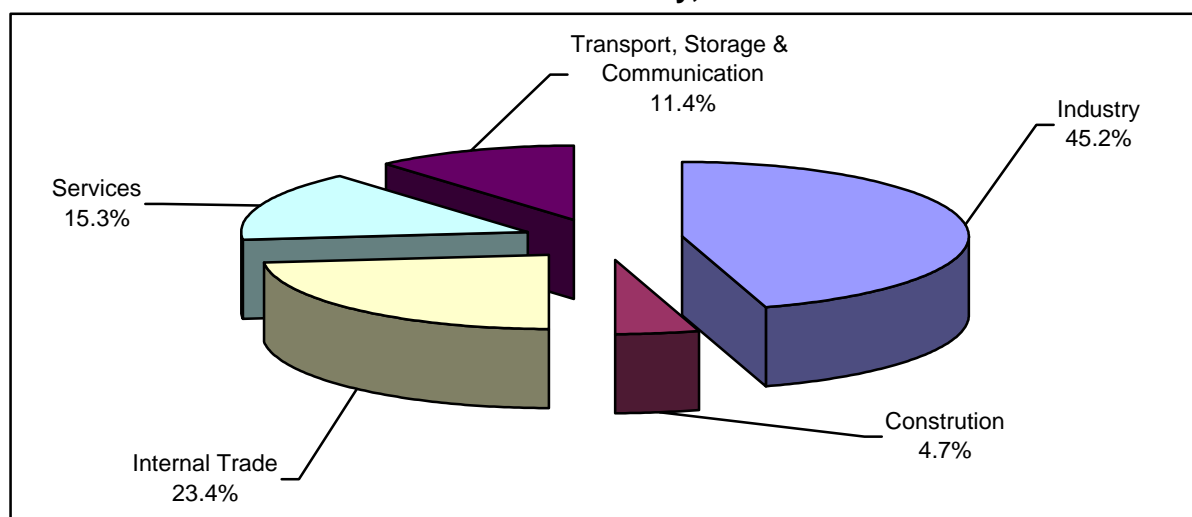
Figure (4): Distribution of Compensations of Employees in Remaining West Bank and Gaza Strip by Economic Activity, 2007

The results indicate that the value of compensations of employees during 2007 in Remaining West Bank and Gaza Strip was US\$ 612.5 million. This value was distributed by economic activity as follows: industrial activities, 31.2%; construction activities, 3.8%; internal trade activities, 19.0%; services activities, 33.4%; and transport, storage and communications activities, 12.6%. Figure (4) shows results by economic activity:

3.4 Output:

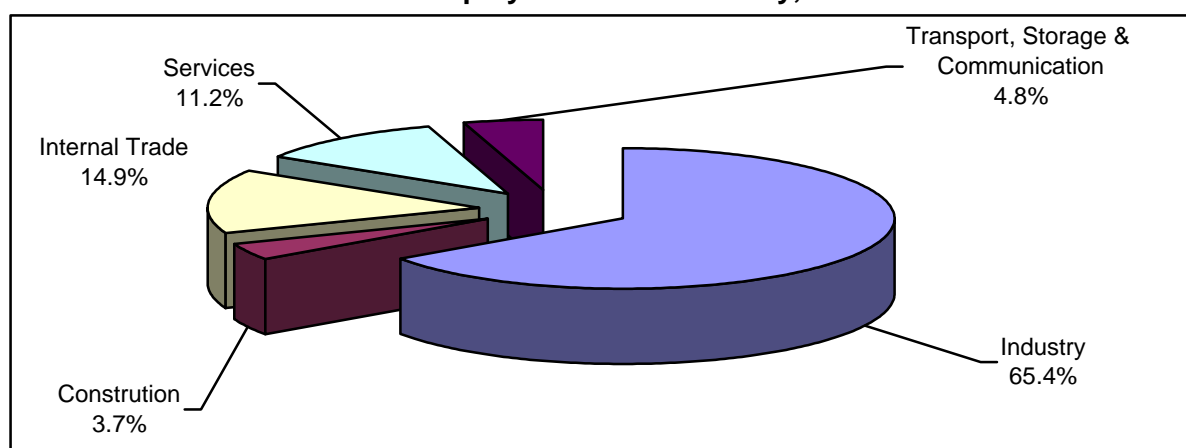
Figure (5): Distribution of Output in Remaining West Bank and Gaza Strip by Economic Activity, 2007

The results indicate that the value of output in Remaining West Bank and Gaza Strip was US\$ 3,995.5 million. This value was distributed by economic activity as follows: industrial activities, 45.2%; construction activities, 4.7%; internal trade activities 23.4%; services activities, 15.3 %; and transport, storage and communications activities, 11.4%. Figure (5) represents results by economic activity:

3.5 Intermediate Consumption:

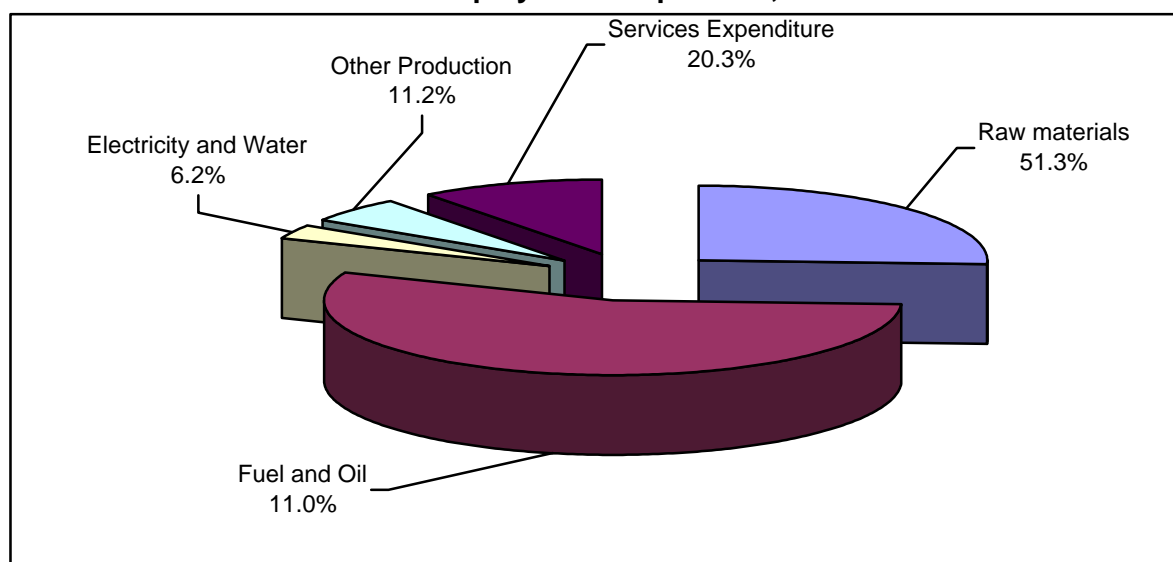
The surveys' results show that the value of intermediate consumption in Remaining West Bank and Gaza Strip was US\$ 1,639.6 million. This value was distributed by economic activity as follows: industrial activities, 65.4%; construction activities, 3.7%; internal trade activities, 14.9%; services activities, 11.2%; and transport, storage and communications activities, 4.8%. Figure (6) shows results by economic activity:

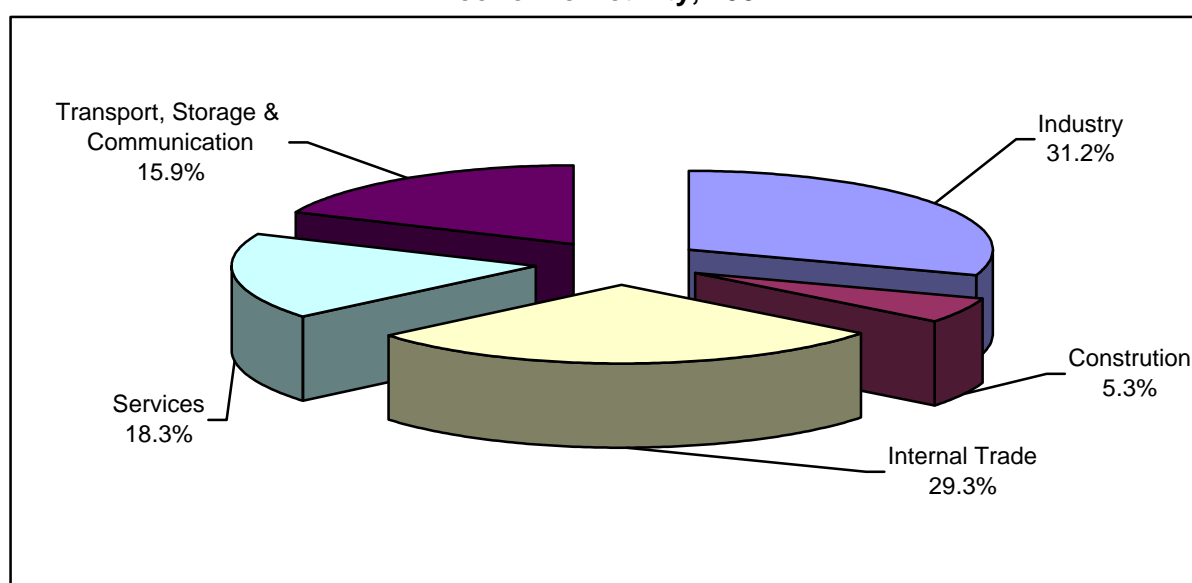
Figure (7): Distribution of Intermediate Consumption in Remaining West Bank and Gaza Strip by its Components, 2007

On the other side, the results indicate that the value of intermediate consumption was distributed by its components as follows: raw materials, 51.3%; fuel and oil, 11.0%; electricity and water, 6.2%; other production inputs, 11.2%; and services expenditure, 20.3%. Figure (7) shows the results by components of Intermediate Consumption:

3.6 Value Added:

The surveys' results indicate that the value added in Remaining West Bank and Gaza Strip was US\$ 2,355.8 million. This value was distributed by economic activity as follows: industrial activities, 31.2%; constructions activities, 5.3%; internal trade activities, 29.3%; services activities, 18.3%; and transport, storage and communications activities, 15.9%. Figure (8) shows results by economic activity:

Methodology

4.1 Questionnaire: All of the economic surveys series use the same questionnaire except for a few special characteristics for each survey. The design of the 2007 questionnaire takes into account the major economic variables pertaining to the examined phenomenon, and the needs of compiling the National Accounts for Palestine.

Due to the political conditions in Gaza Strip, there was a very brief model of the questionnaire, in order to collect basic data required for national accounts and without any details.

4.2 Coverage and Sampling:

4.2.1 Coverage:

The thirteen rounds of the Economic Survey Series were executed depending on the Establishment Census 2007. The economic surveys series covers activities in accordance with (ISIC-3):

- Industry: (C, D, E)
- Construction: (F)
- Internal Trade: (G)
- Services: (H, K, M, N, O)
- Transport, Storage and Communication: (I)

4.2.2 Sample Design:

The sample of the economic surveys series is a single-stage stratified random-systematic sample in which the enterprise constitutes the primary sampling unit (PSU). Three levels of strata were used to draw up an efficient representative sample (i.e., economic activity, size of employment and geographical levels). The sample size amounted to (8,220) establishments out of the (99,390) establishments comprising the survey frame.

4.2.3 The Implementation Stage:

This phase includes fieldwork operations, data processing and tabulation:

- Fieldwork operations: They are initiated after the training and recruitment of qualified interviewers, who are responsible for data collection from the field.
- Data processing and tabulation: This part includes:
 - Developing a data entry program and training of operators
 - Organizing data entry processes
 - Post-data entry editing
 - Tabulation

Chapter Five

Data Quality

5.1 Accuracy of the Data:

5.1.1. Statistical Errors:

The findings of the survey are affected by statistical errors due to using a sampling in conducting the survey for the units of the target population. This increases the chances of having variances from the actual values we expect to obtain from the data had we conducted the survey using comprehensive enumeration.. The variance of the key goods in the survey was computed and dissemination was carried out on the level of the Remaining West Bank and Gaza Strip for reasons related to sample design and computation of the variance of the different indicators.

The preceding table shows the variation of the most distinct variables, where it indicates institutions with activities that have been drawn from the sample for the rest of the West Bank and Gaza Strip, which is the activities of industry, internal trade and services. Construction activities and transport, storage and communications have no variation because of a comprehensive survey.

5.1.2. Non-Statistical Errors

These types of errors could appear on one or all the survey stages that include data collection and data entry:

Response rate values:

- Number of enterprises (according to survey results) reached to 92,589 enterprise, which is different from the number of enterprises on the frame that used to draw the survey's sample, and this difference refers to over-coverage situations that reached to 9.5% in the actual survey results.
- Sample size was 8,325 enterprises (including economic activity change) in the Remaining West Bank and Gaza Strip.
- Non-response rate: 10.7%.
- Over coverage rate %9.5.
- Response rate: 89.3%.

Response errors: these types of errors are related to, responders, fieldworkers, and data entry personnel. To avoid mistakes and reduce the impact there has been a series of actions that would enhance the accuracy of the data through a process of data collection from the field and the data processing.

Fieldwork

- Selection of specialized fieldwork team of economic background; the team was trained theoretically and practically on the survey questionnaire.
- The main fieldwork team was selected according to the training course.
- Field work visits by both fieldwork and project management staff for monitoring and following up data collection process and progress of work. There was an average of two visits for each governorate. About 95% of completed questionnaires was reviewed and corrected if needed; comments and notes were directed to the team accordingly.
- Different levels of supervision and monitoring took place according to the following division:
 - Fieldworkers
 - Fieldworkers supervisors
 - Fieldwork coordinator. (Each of them has responsibilities in monitoring)
- Project management receive a daily progress report about completeness and response.
- Conducting a refresher training course during the stage of data collection for emphasizing the main issues of training and answering questions of fieldworkers about issues faced in the field.
- Some institutions were visited by the researchers again to confirm the accuracy of the data that was given to researchers and that was called the interview. These institutions were selected randomly by withdrawing a random sample of 10% of the original sample of the survey, and then the data were compared with data from series surveys.

5.2 Data processing:

For insuring quality and consistency of data, a set of measures was taken into account for strengthening accuracy of data as follows:

- Preparing a data entry program before data collection for checking readiness of the program for data entry.
- A set of validation rules were applied on the program for checking consistency of data.
- Efficiency of the program was checked through pre-testing by entering a few questionnaires, including incorrect information, for checking its efficiency in capturing these information.
- Well trained data keyers were selected and trained for the main data entry.
- Weekly or biweekly data files were received by project management for checking accuracy and consistency, notes of correction are provided for data entry management for correction.

5.3 Notes on Data:

1. Differences of results of certain indicators that can be noticed are due to approximation.
2. Note that there are some economic activities to reduce second ISIC has been collecting data with the previous activity, due to maintain the confidentiality of data provided by the law of statistics for 2000.
3. Financial data was collected by NIS, US \$ and JD, but it was converted and published in US \$.
